FIG. 1 is a perspective front view of a handset keypad showing our new design;

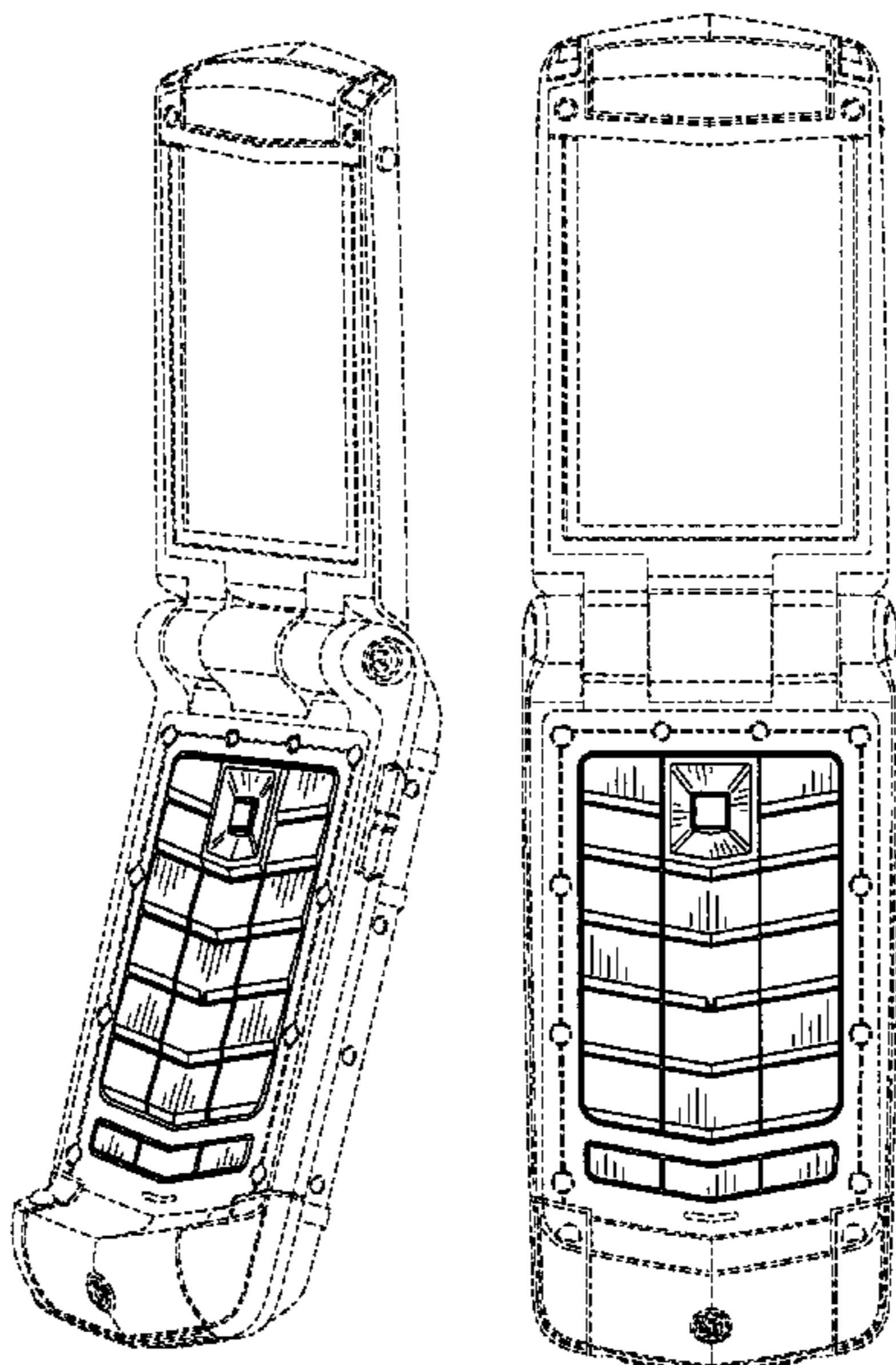
FIG. 2 is a front view thereof;

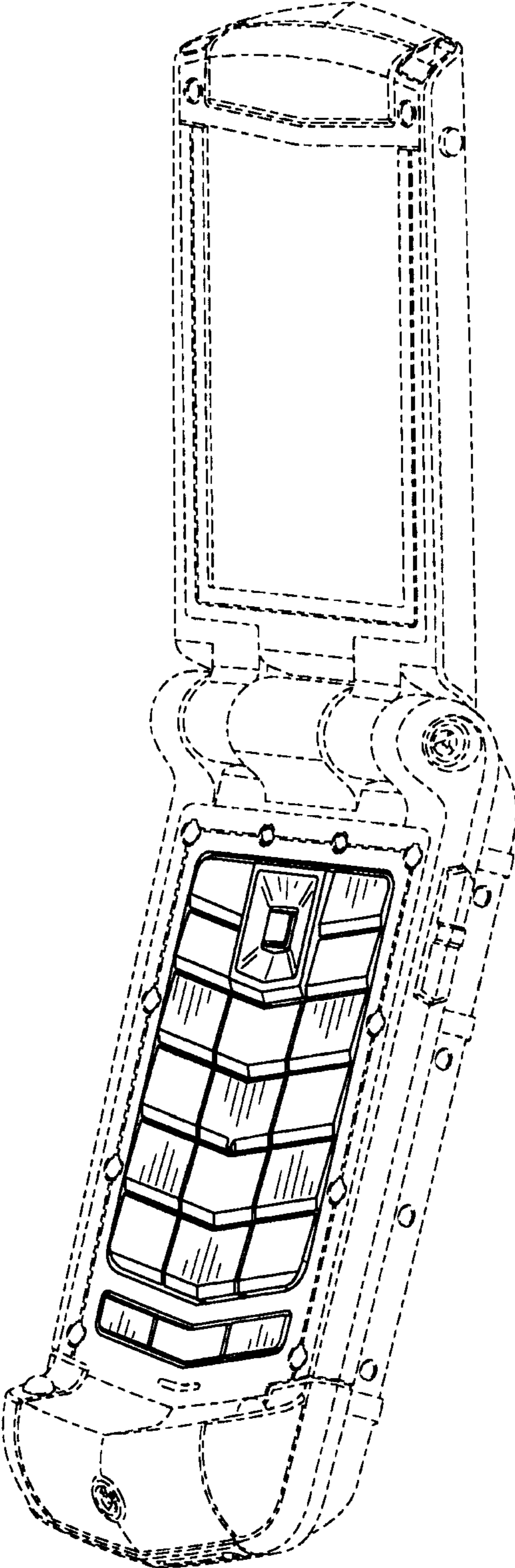

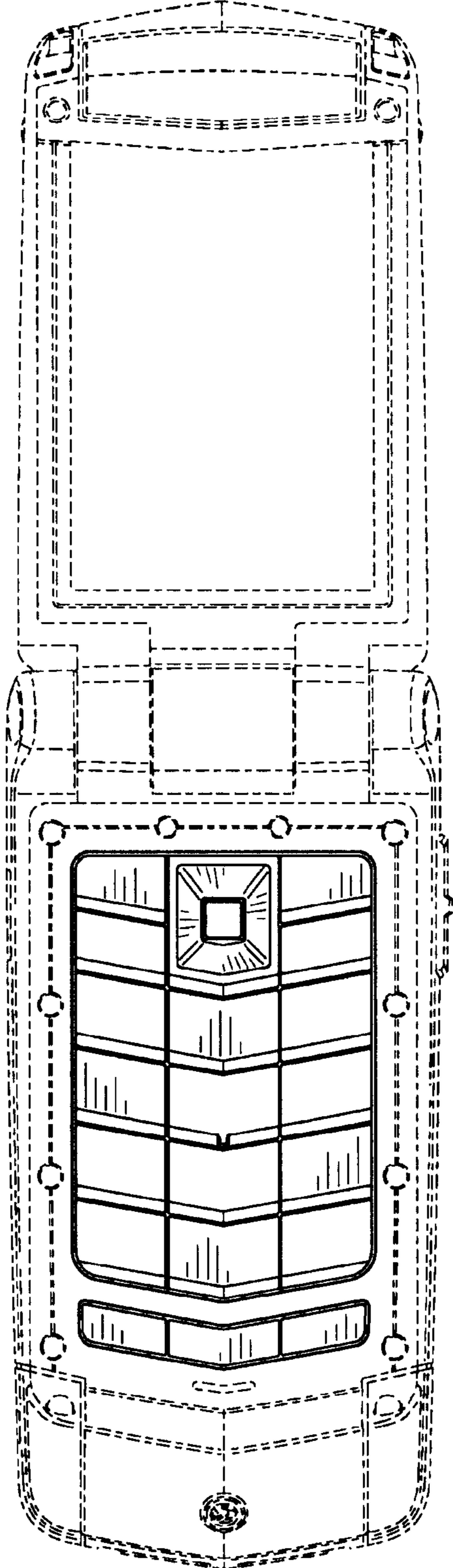

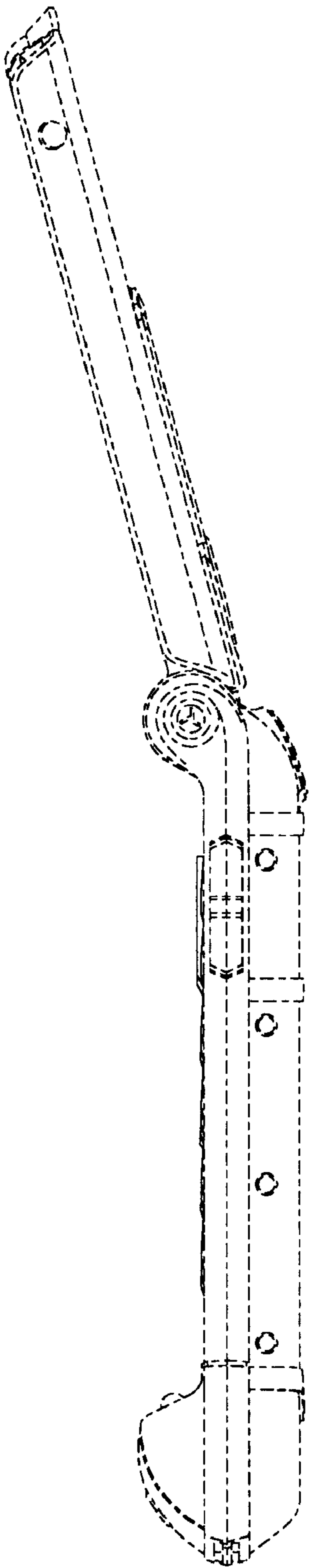

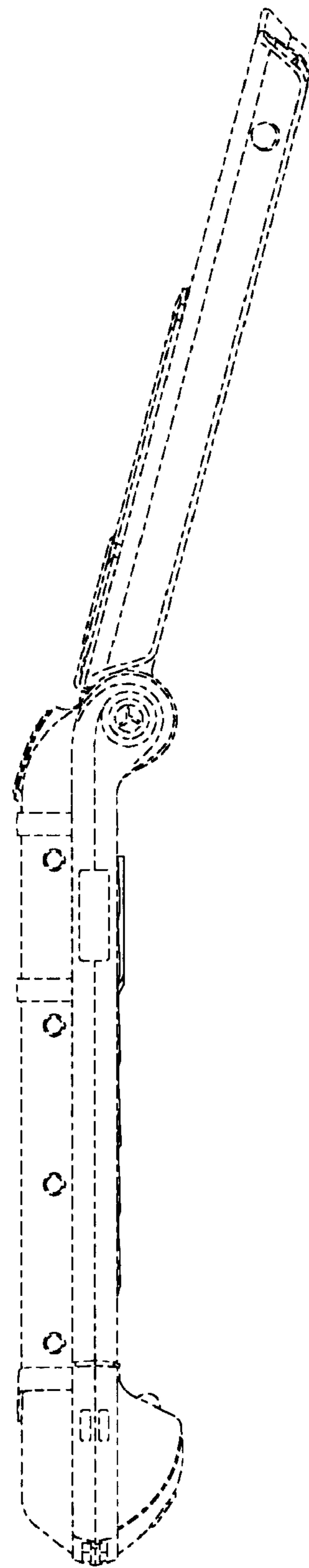
