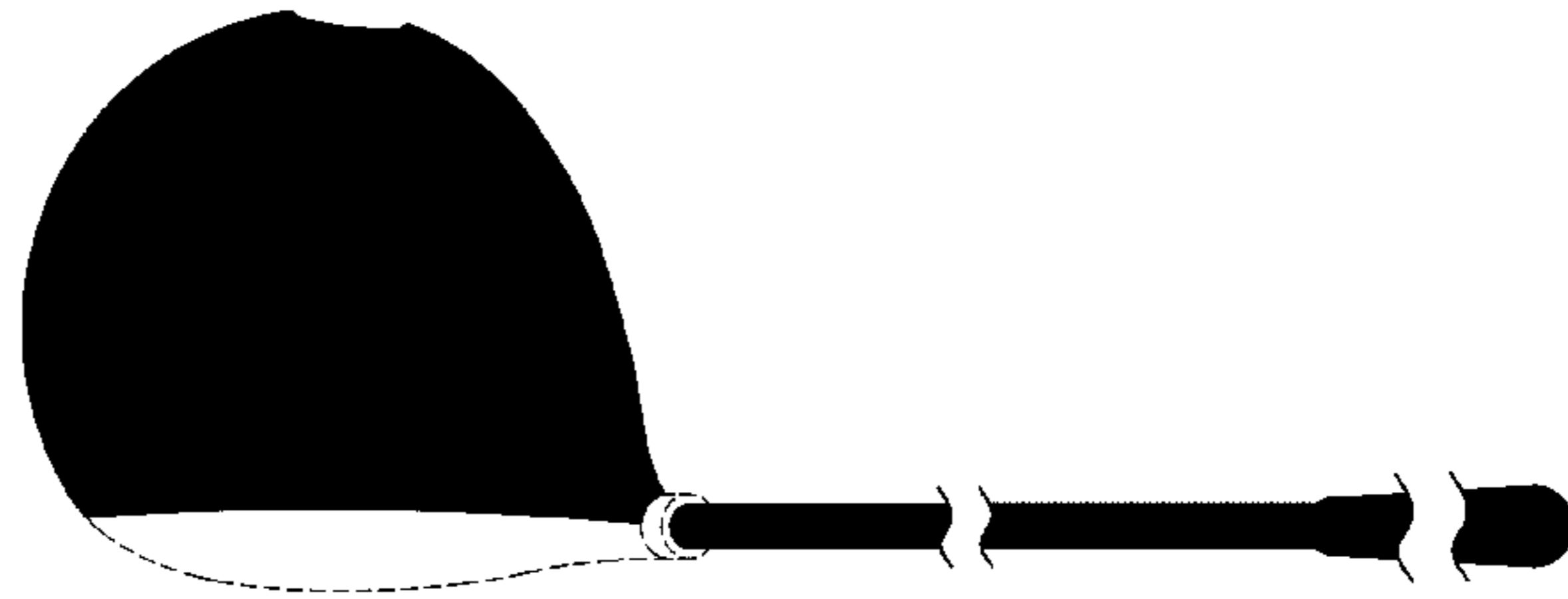
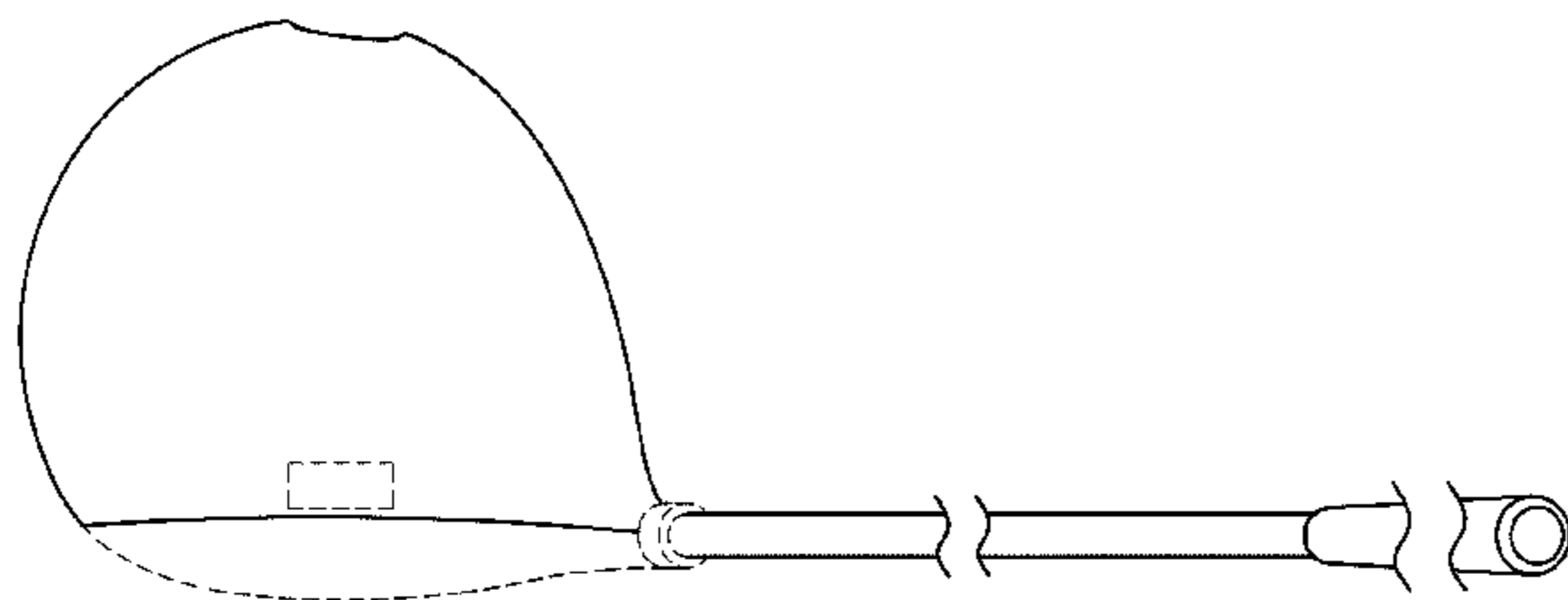

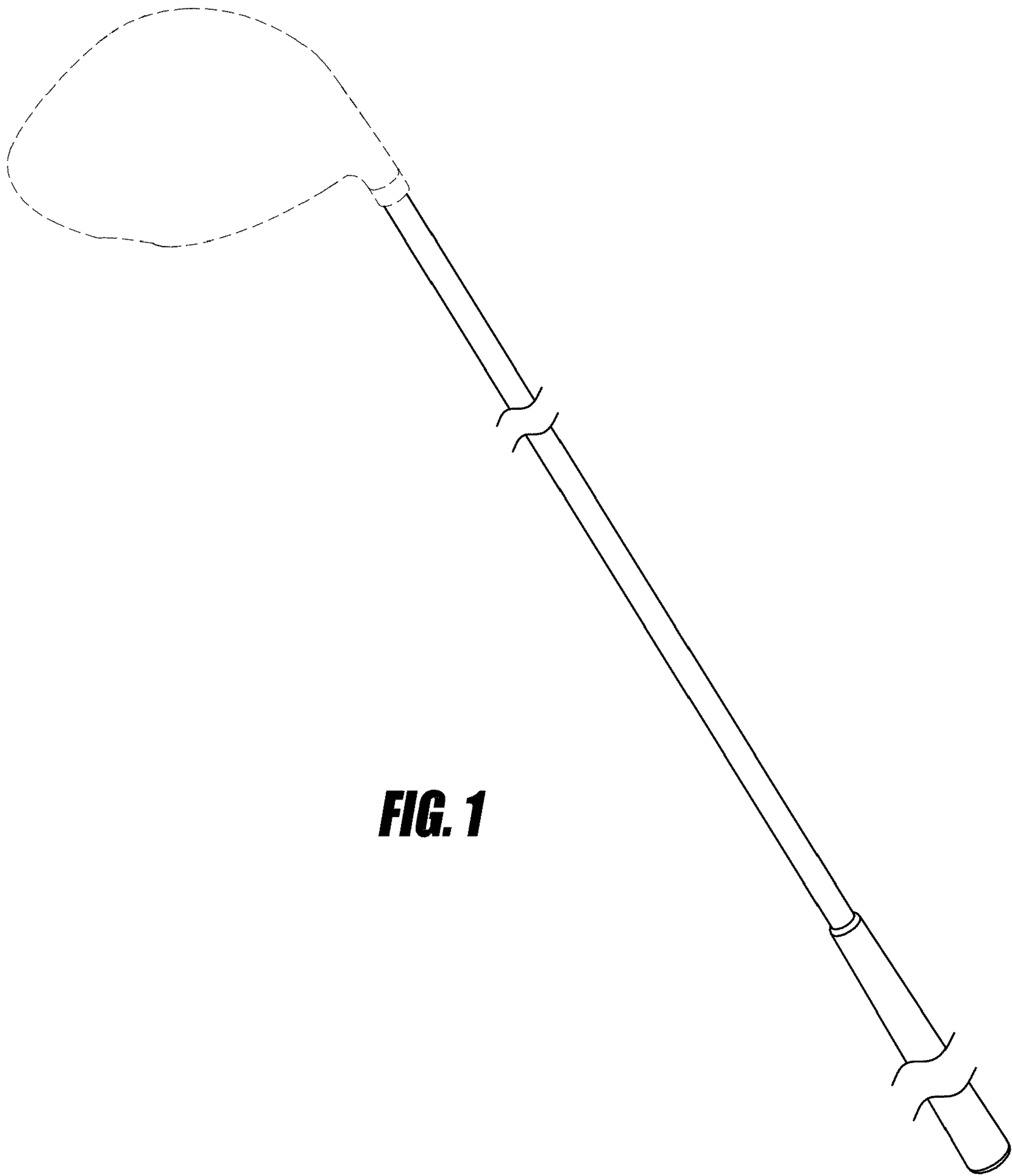

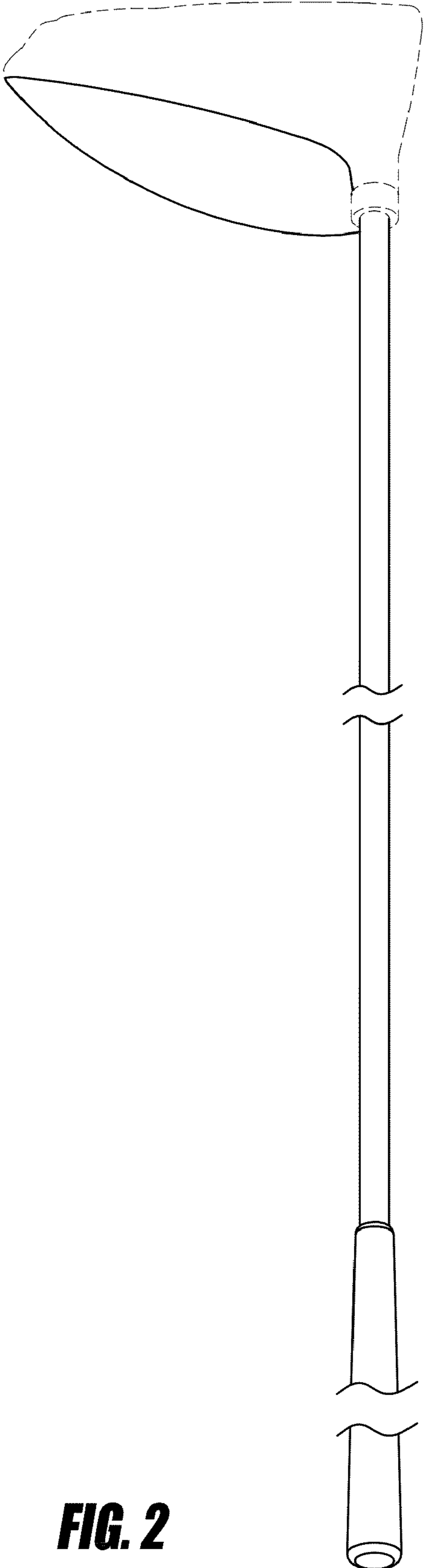
FIG. 29 is a bottom side view of a golf club embodying our new design.

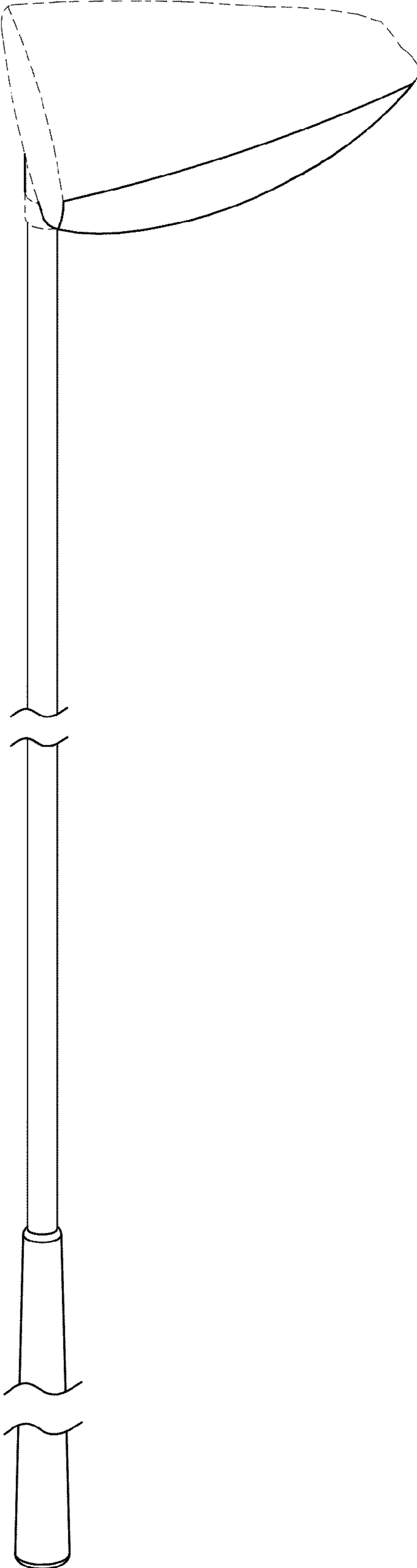

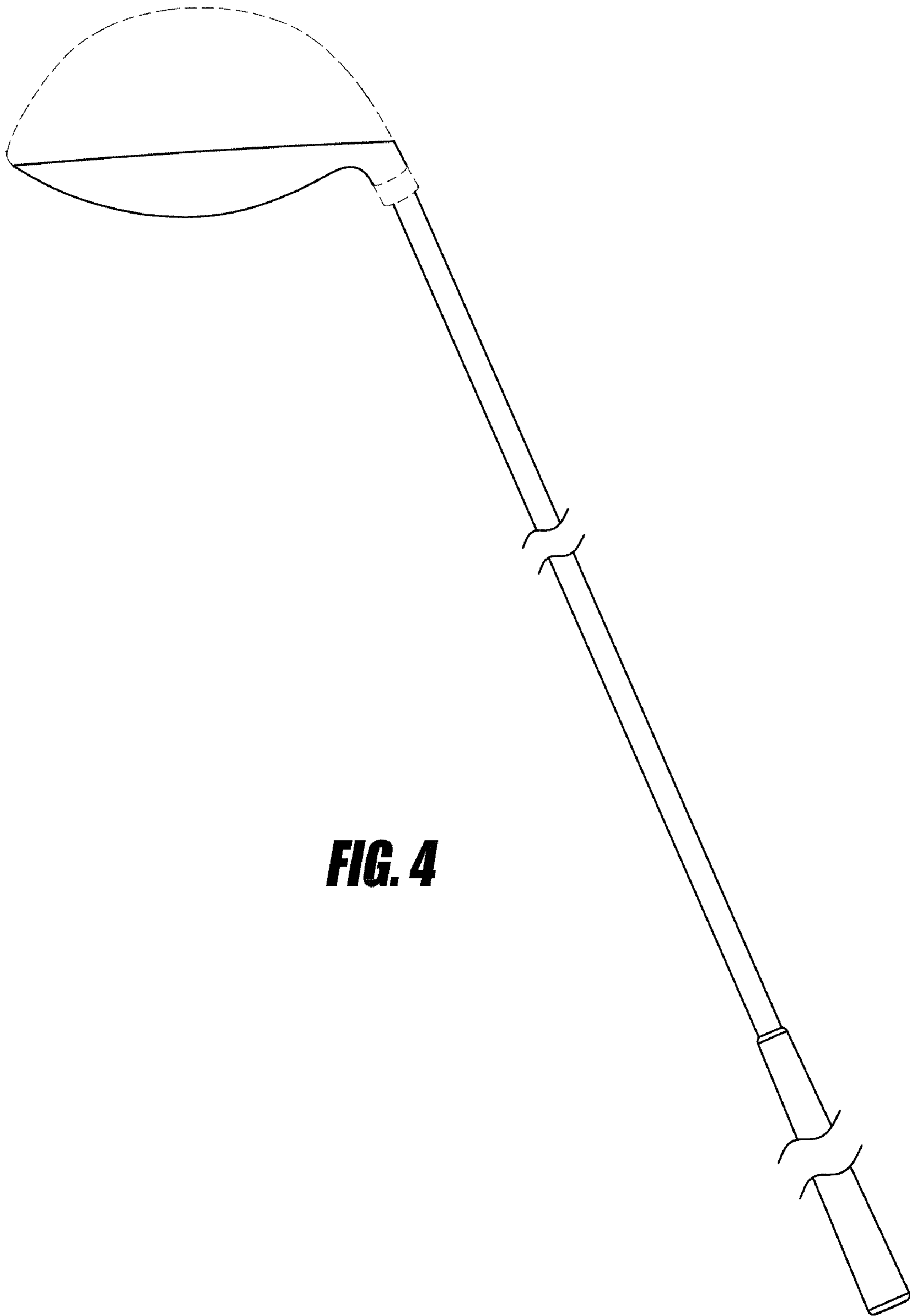

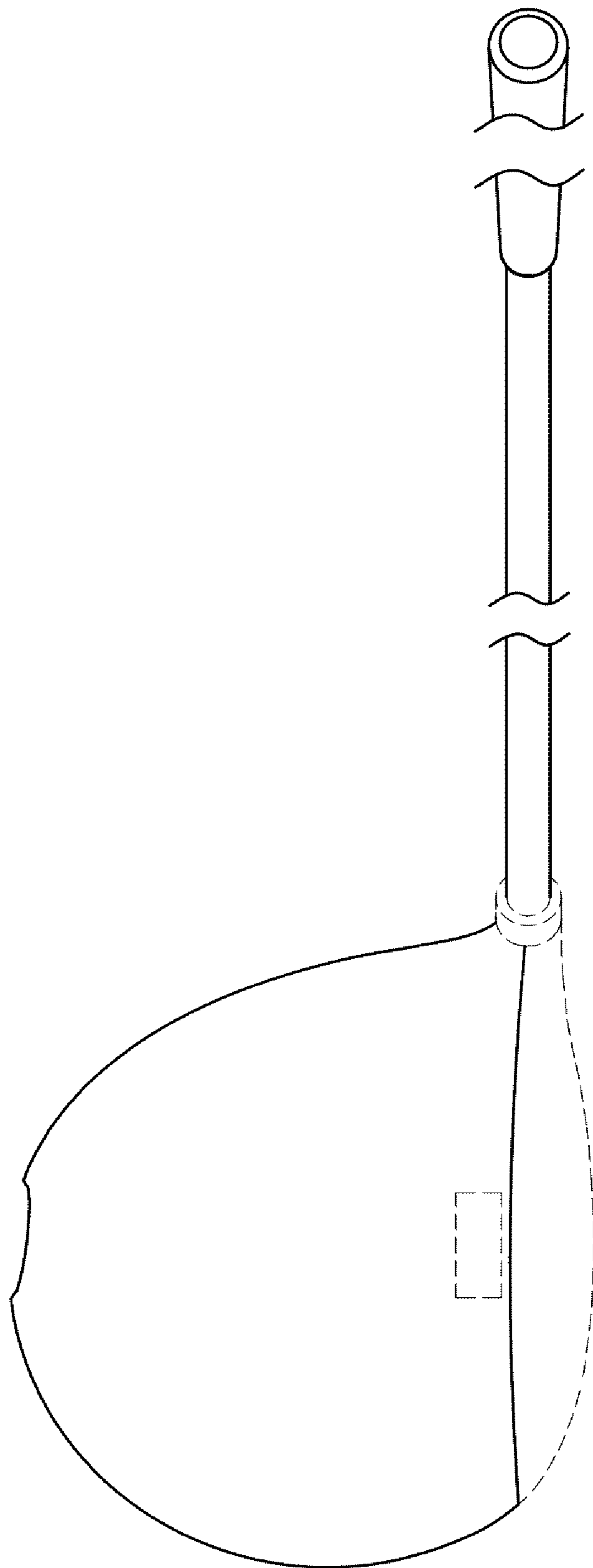

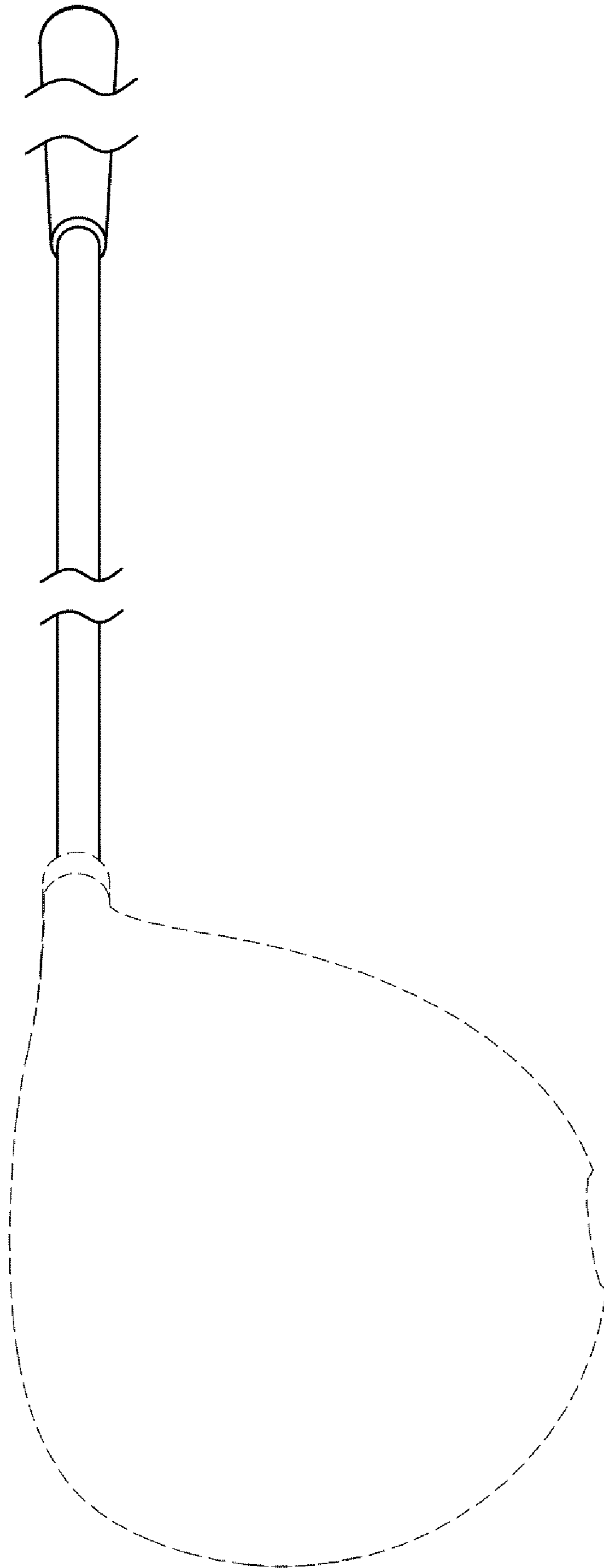

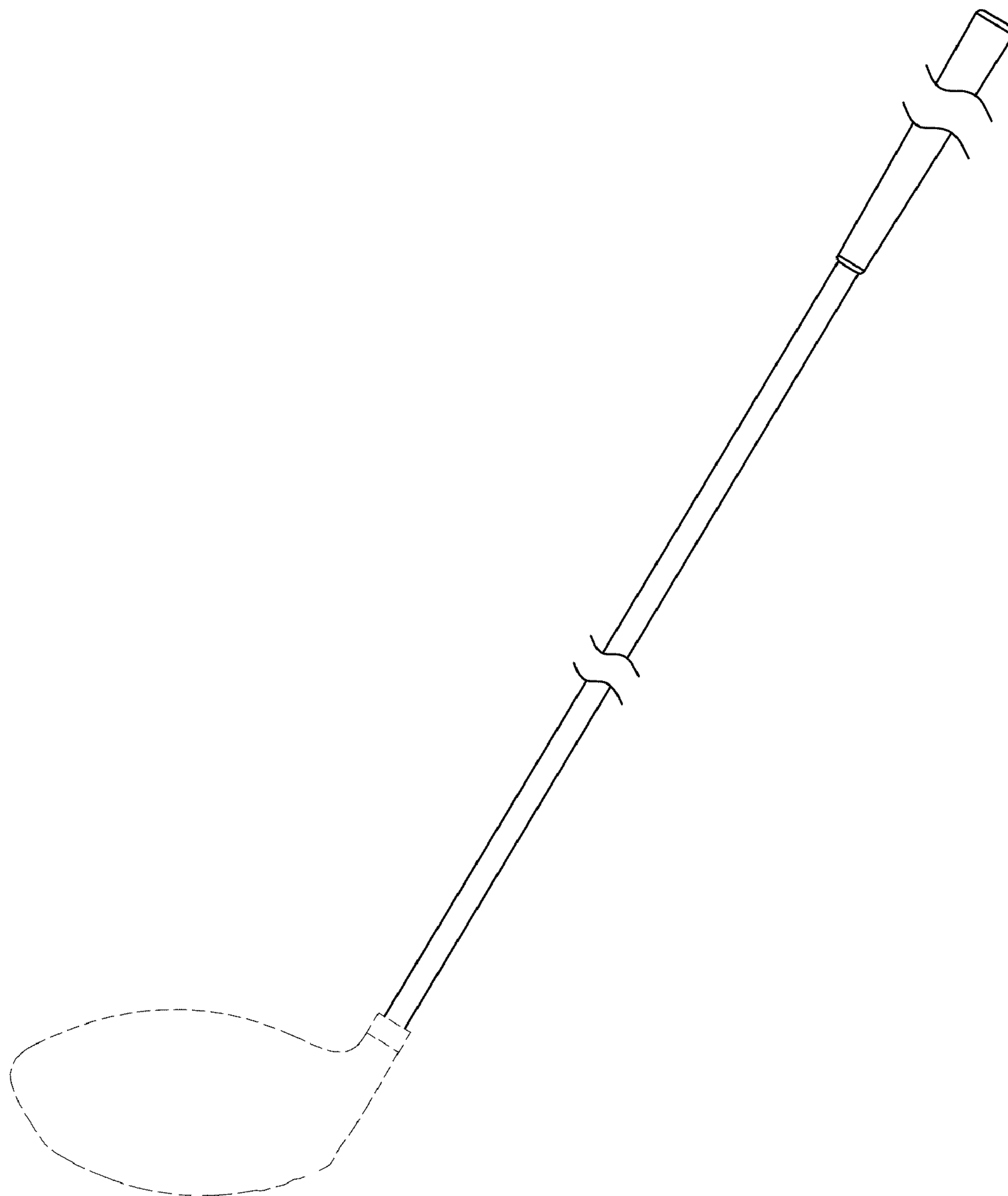

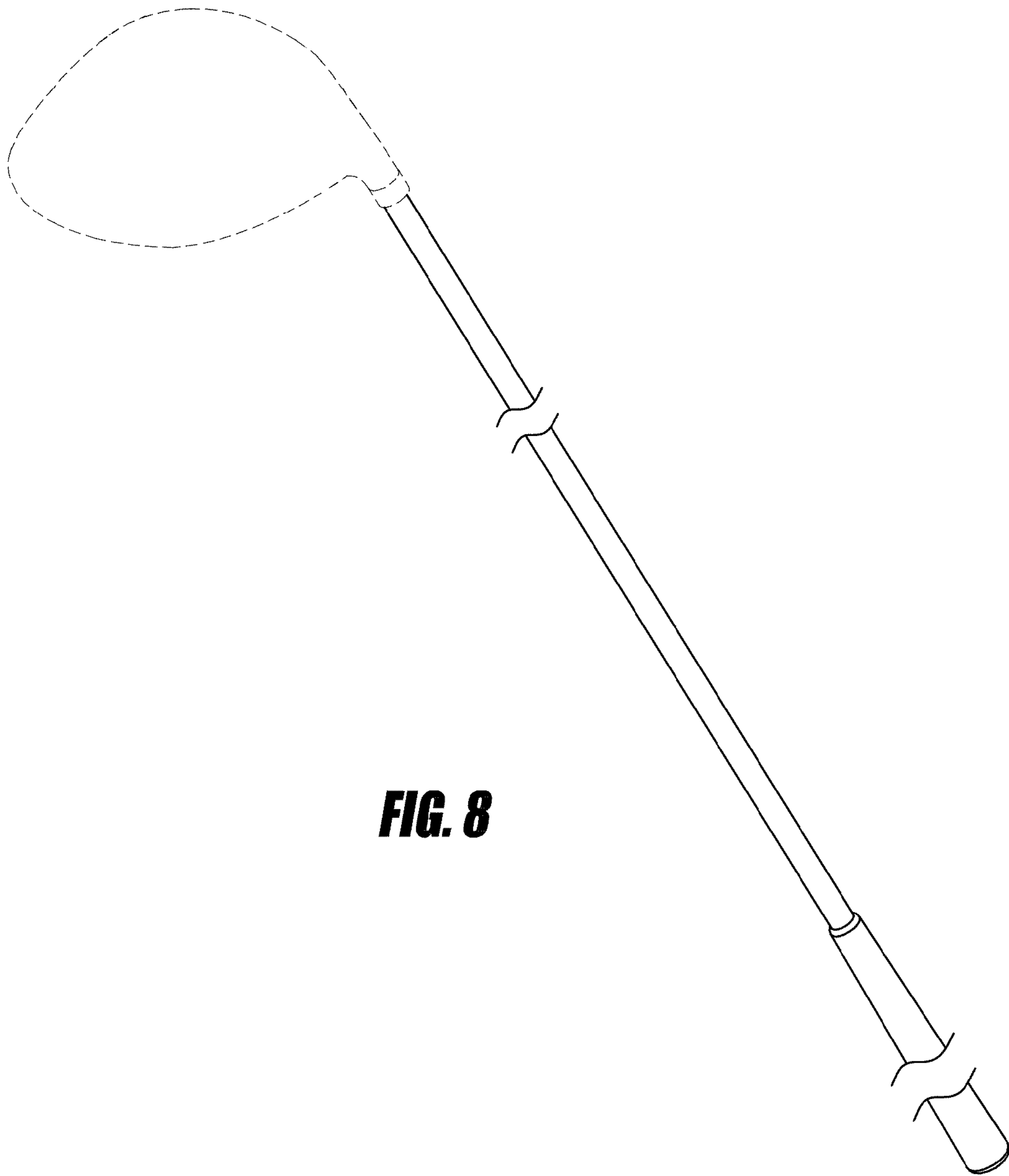

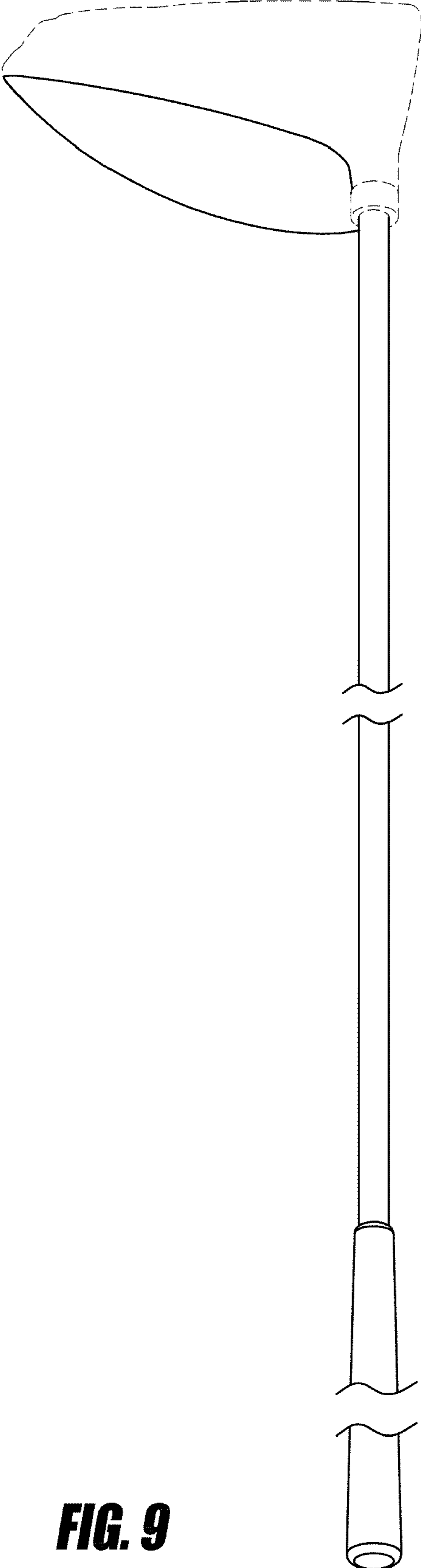




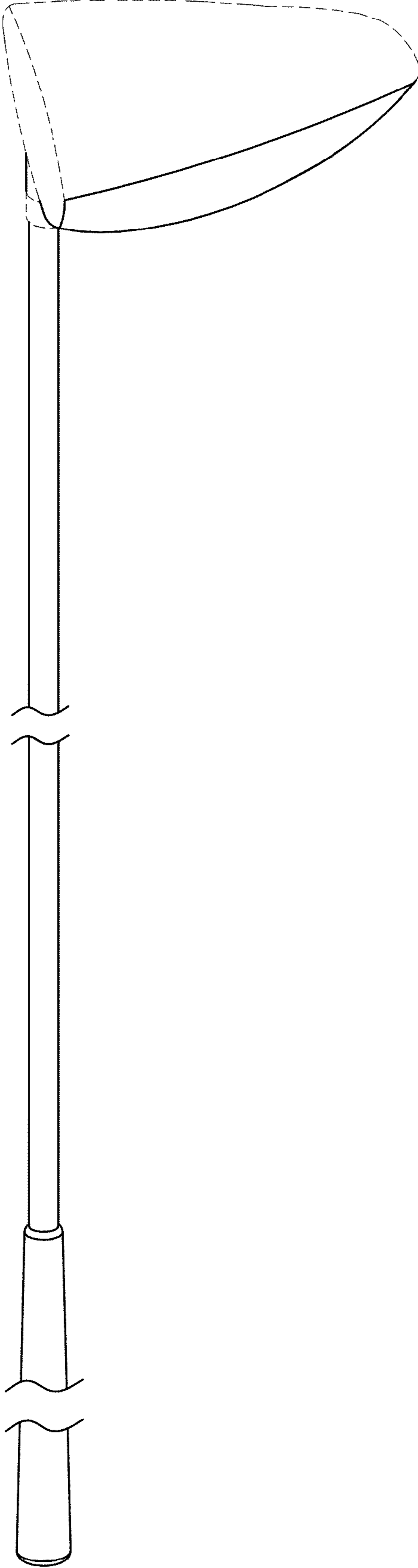

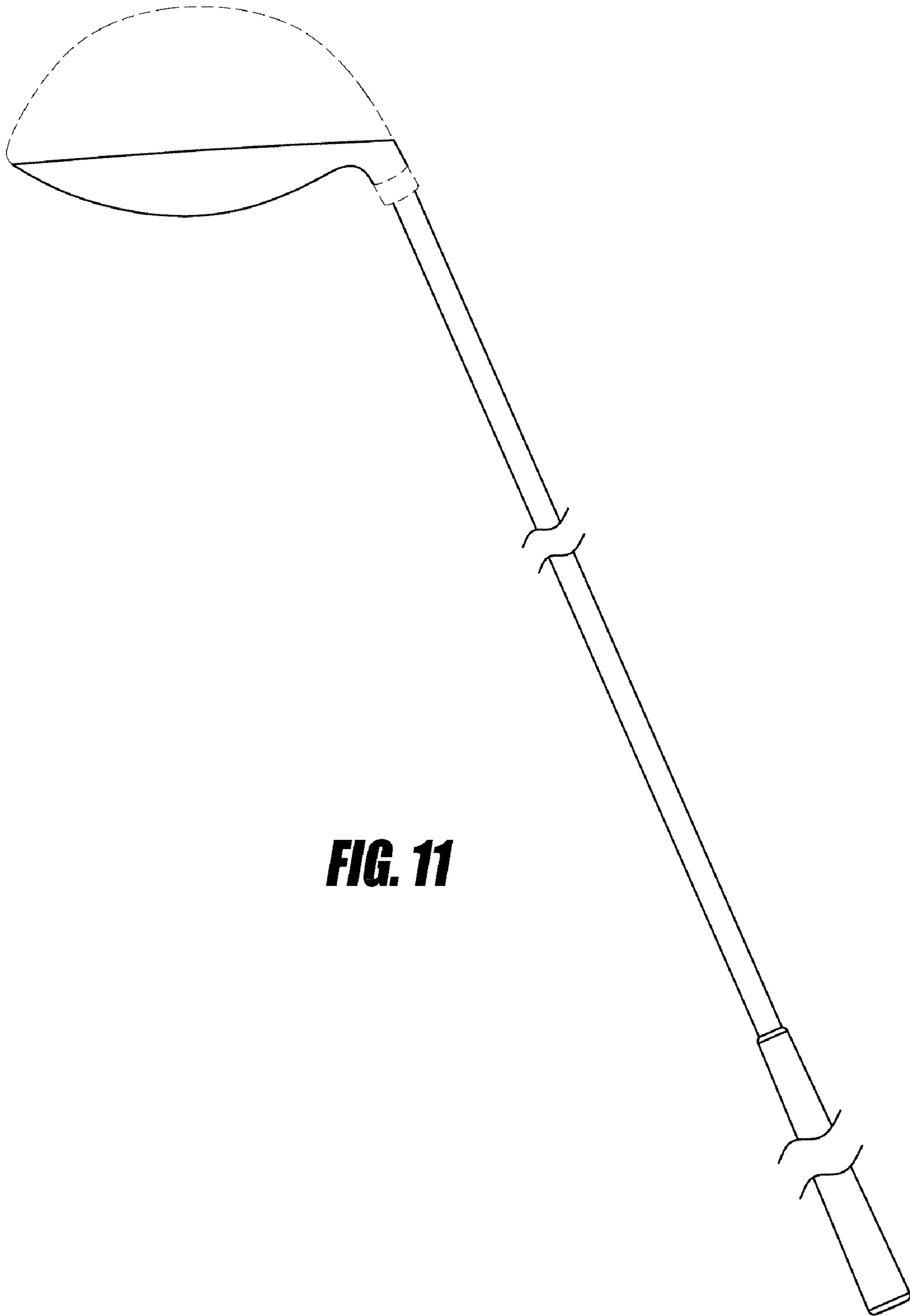

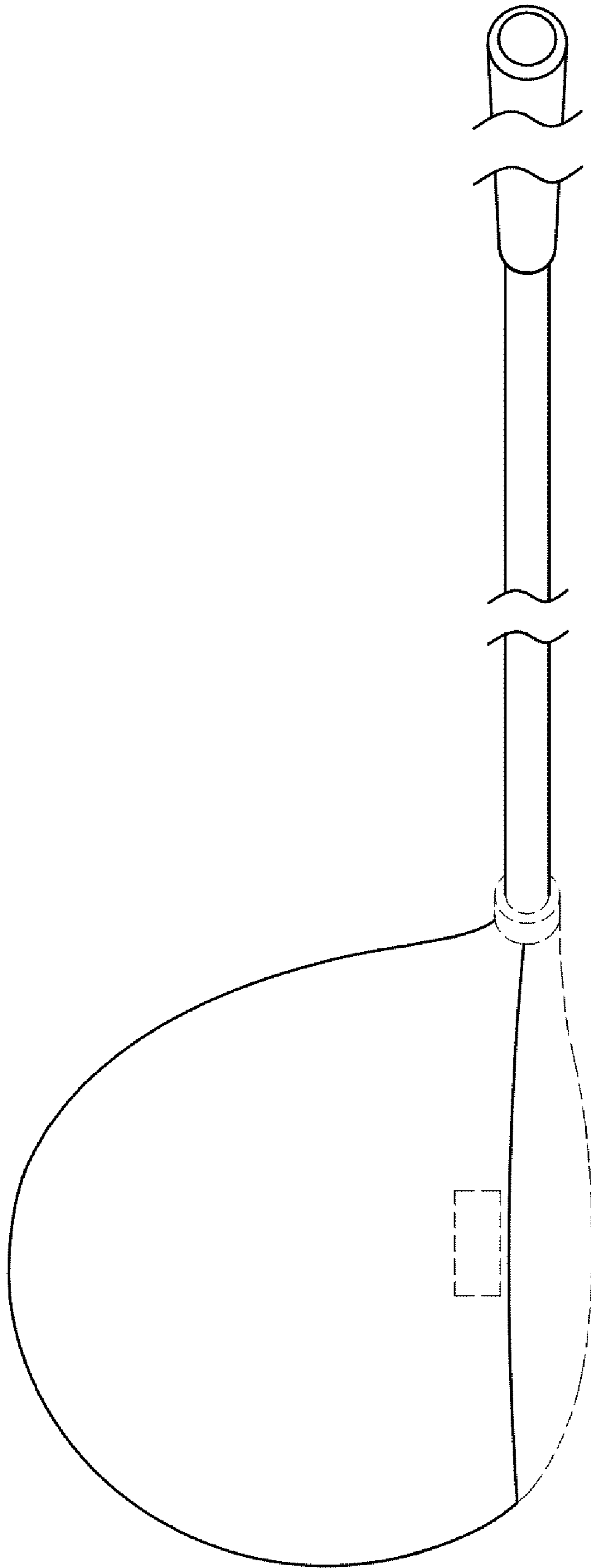

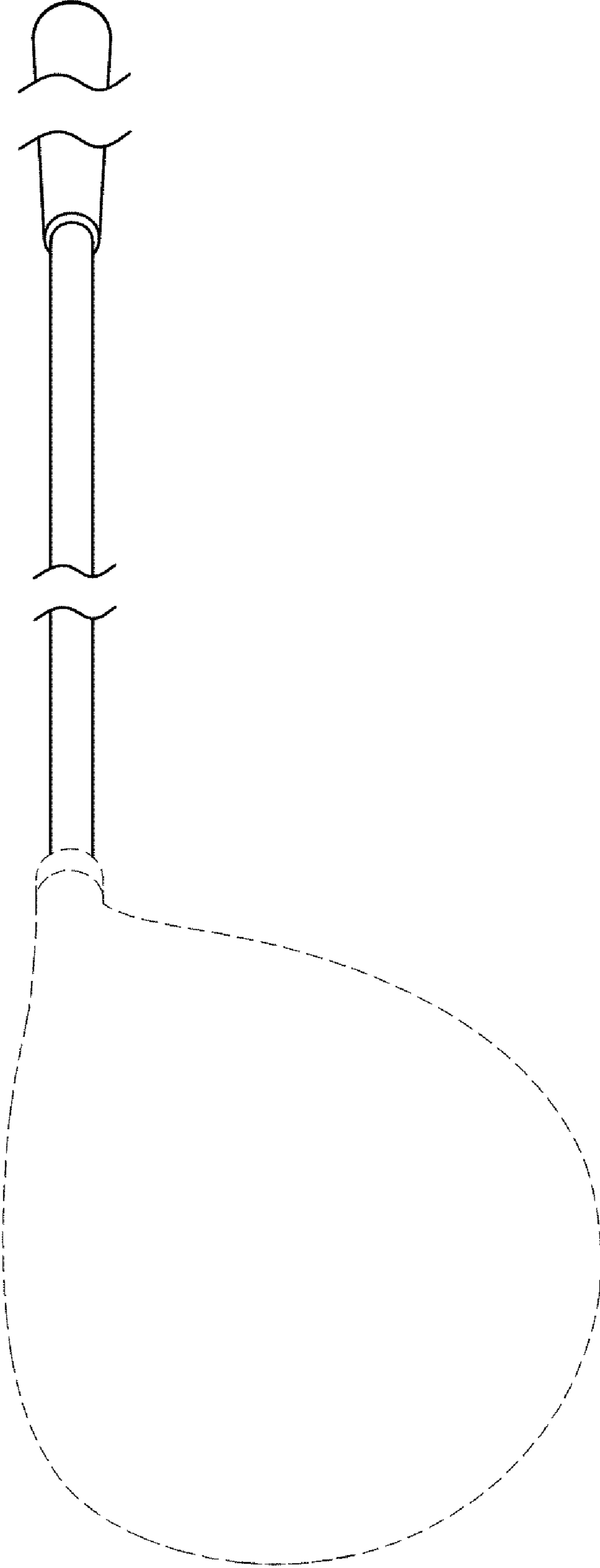

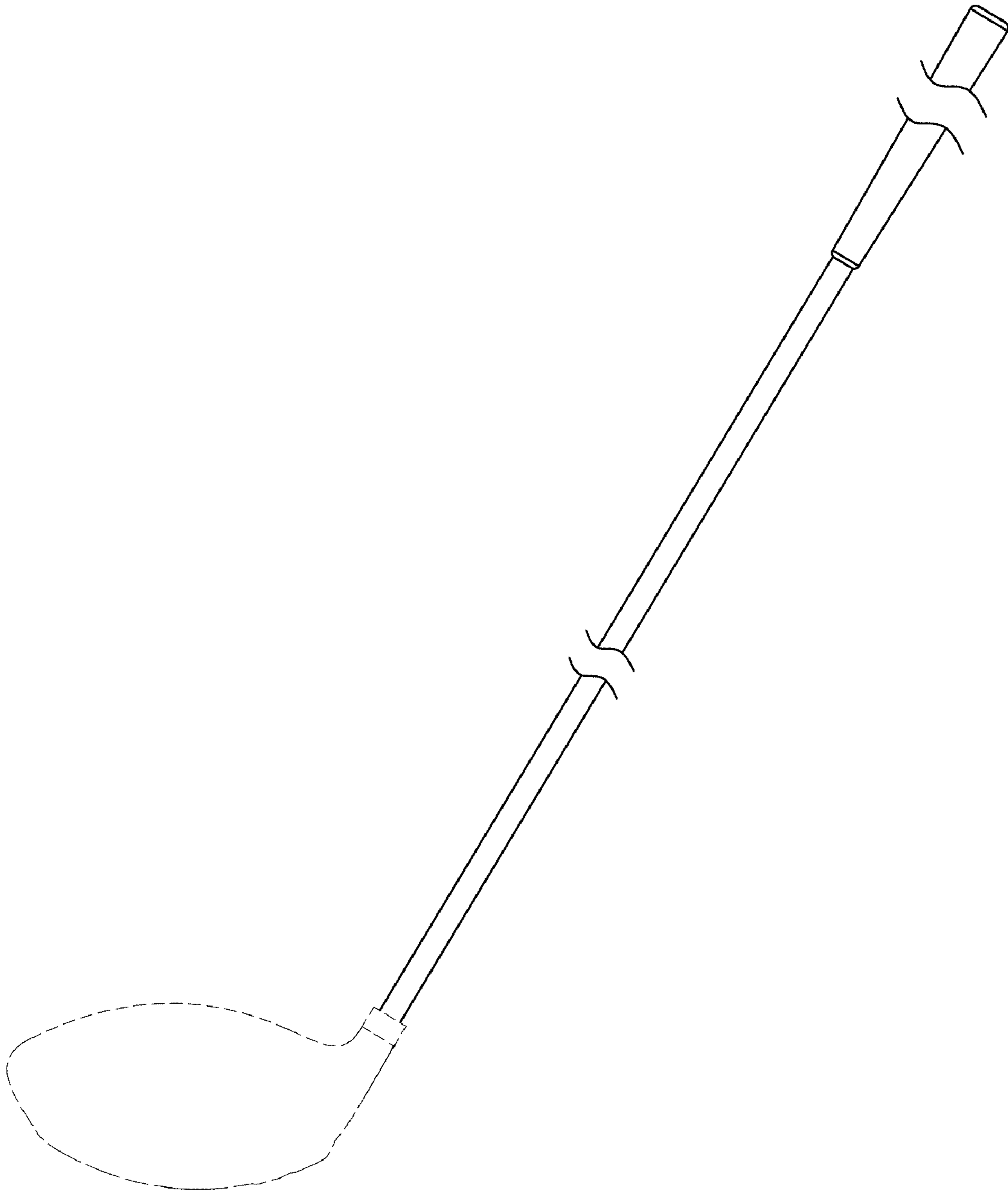

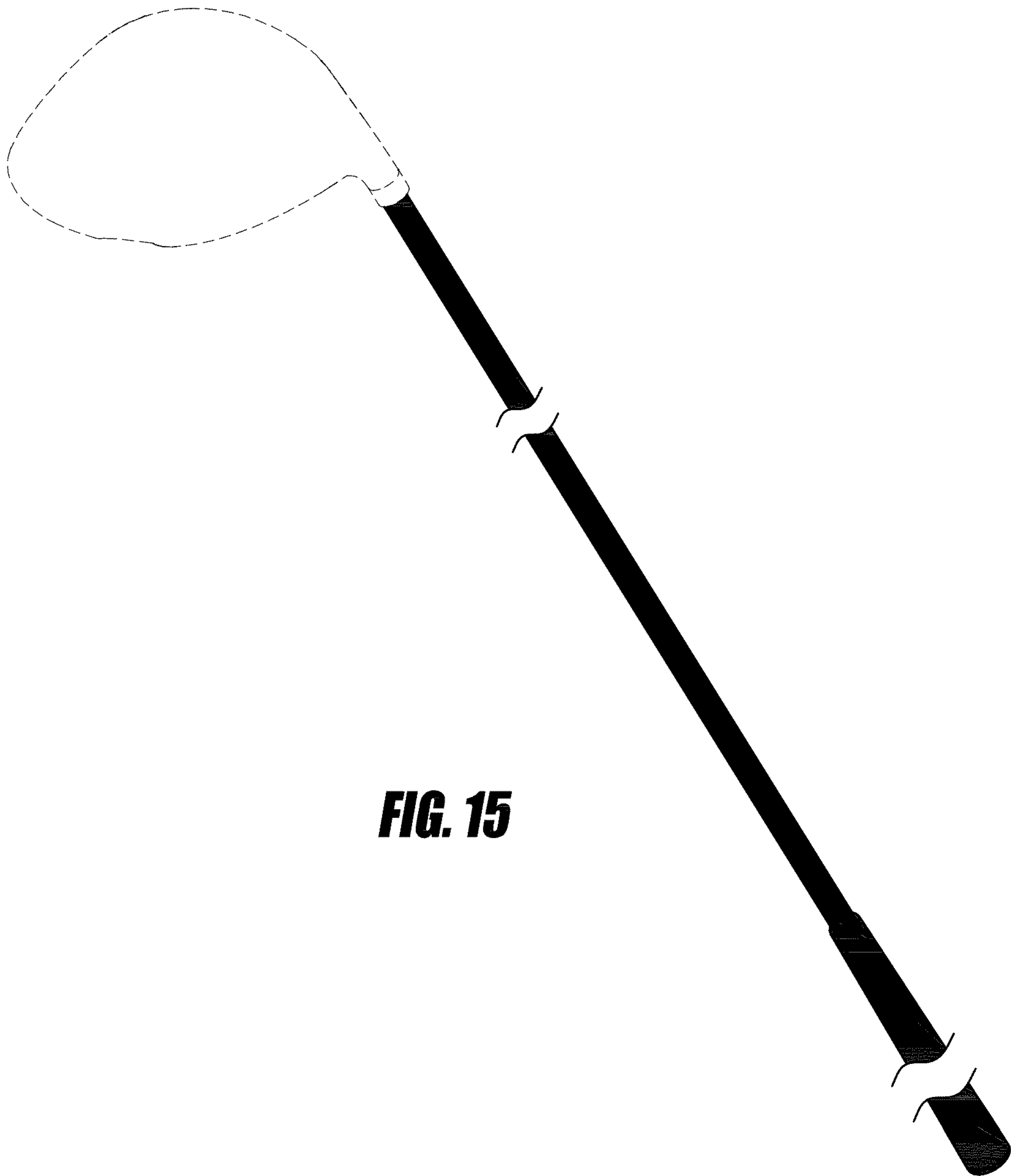

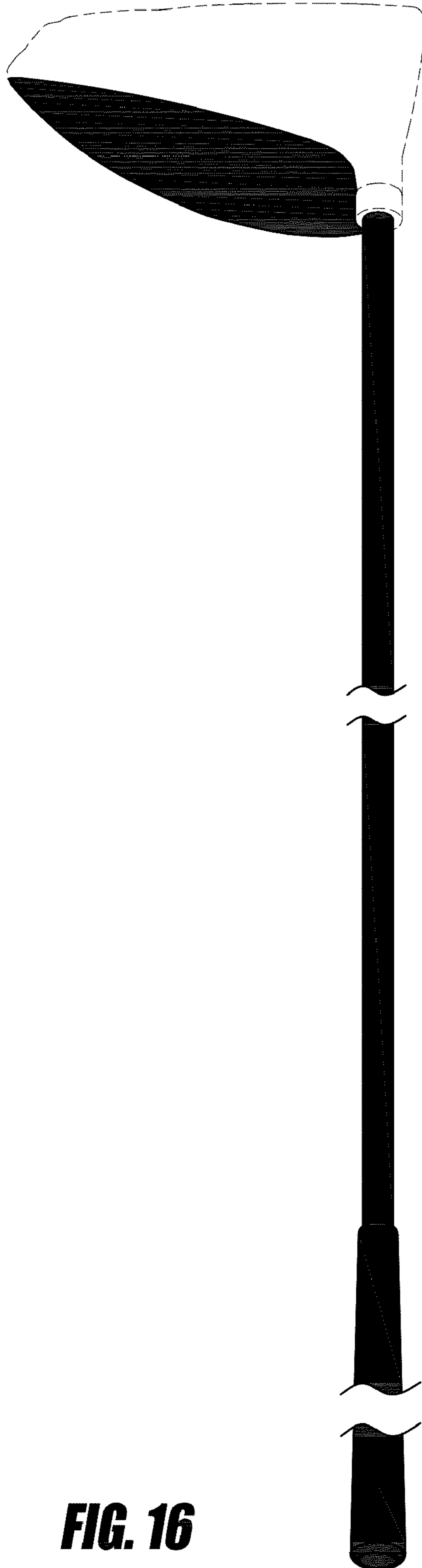




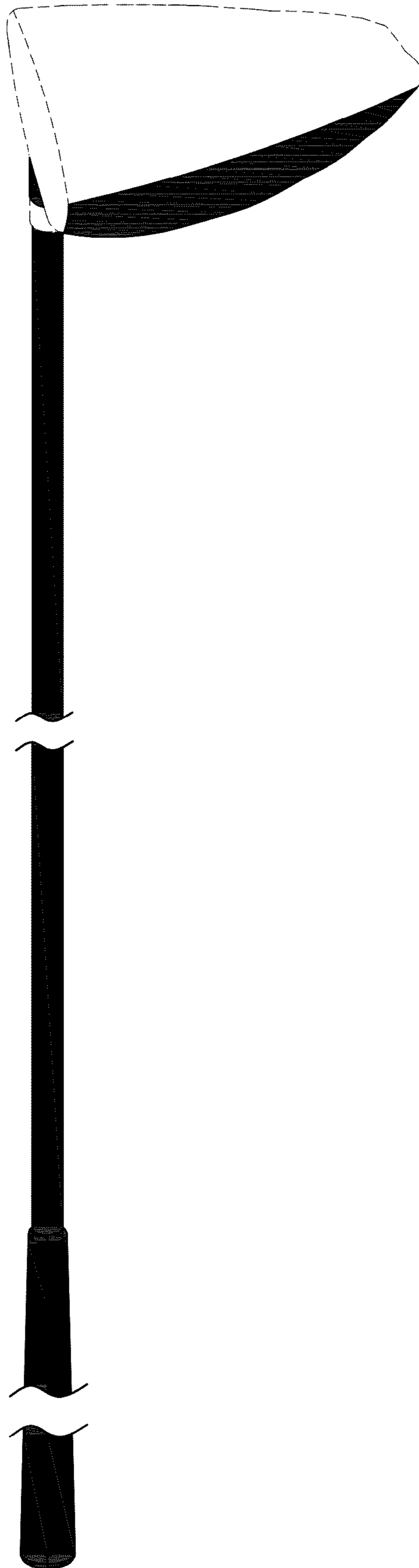

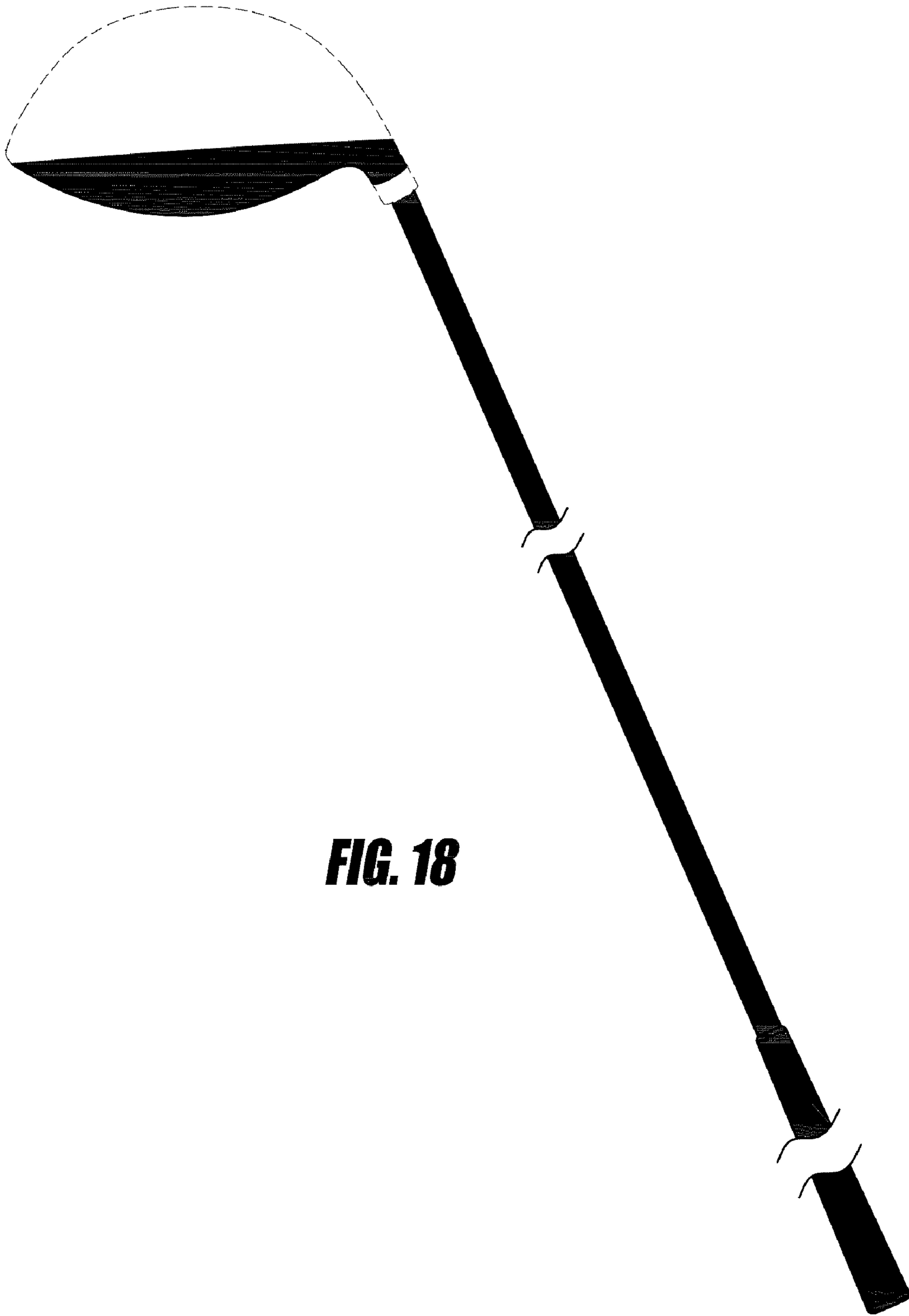

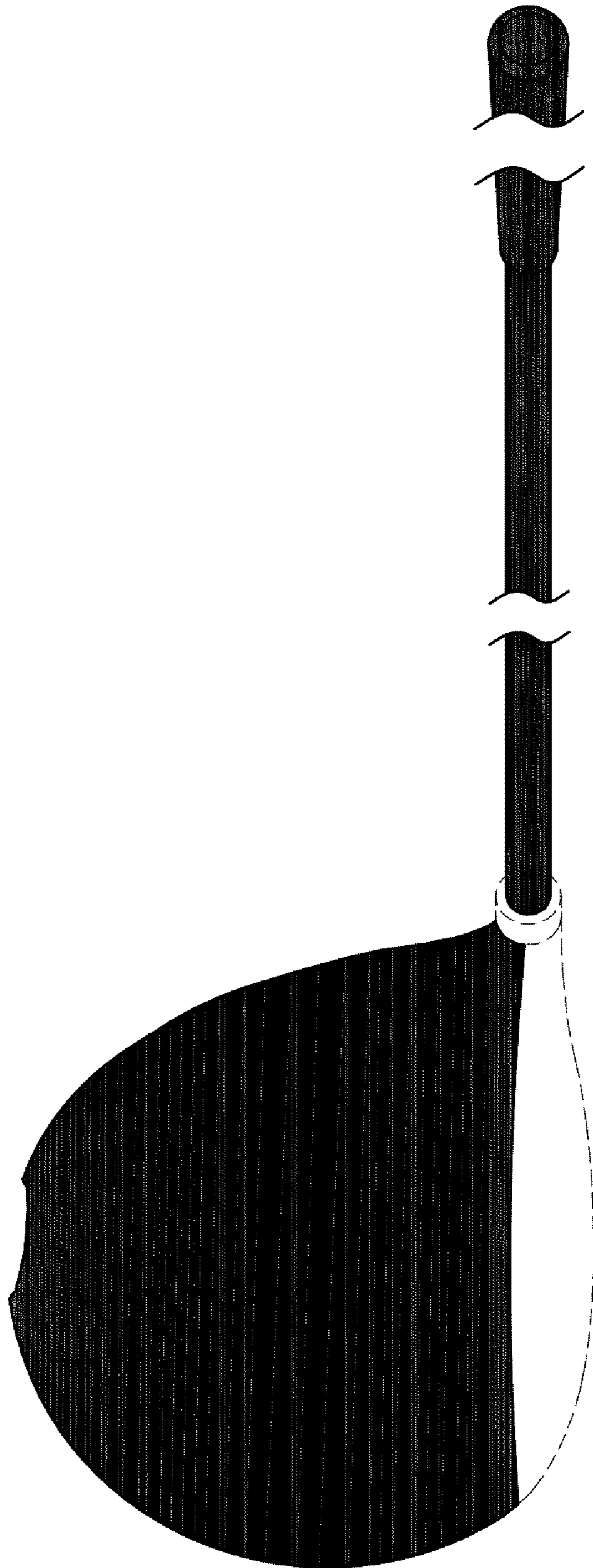

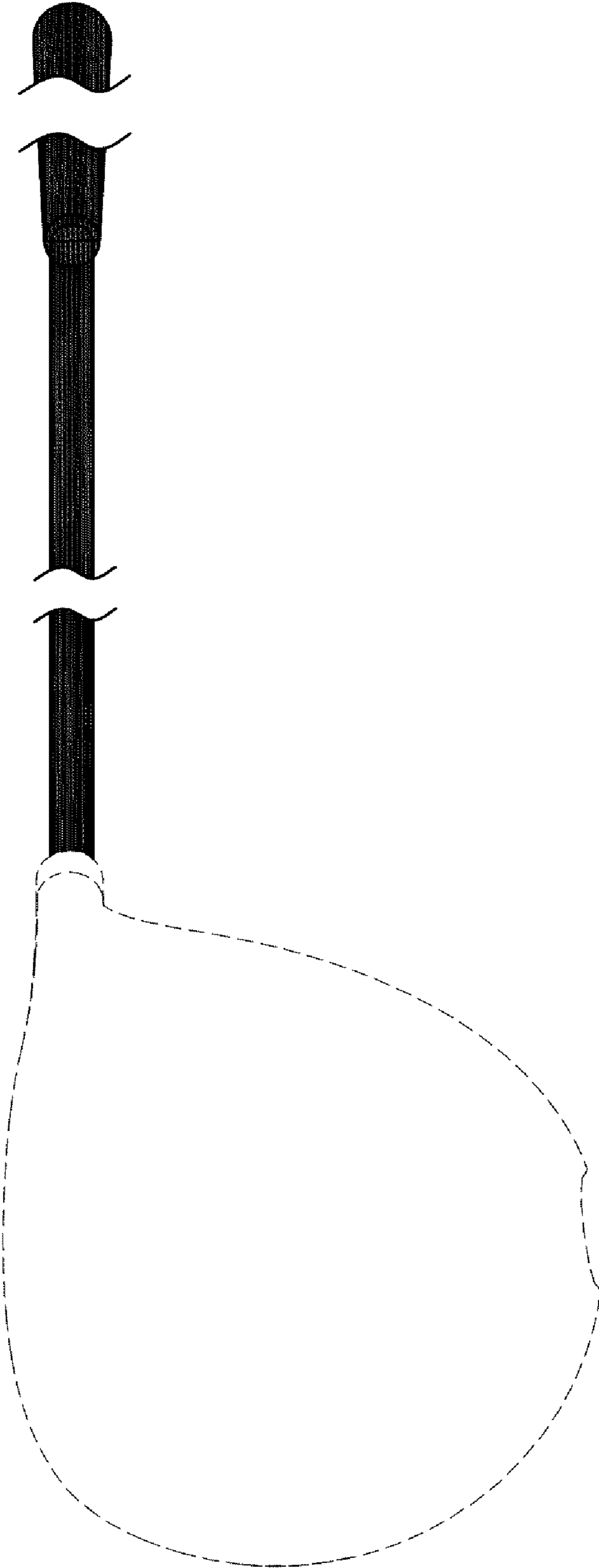

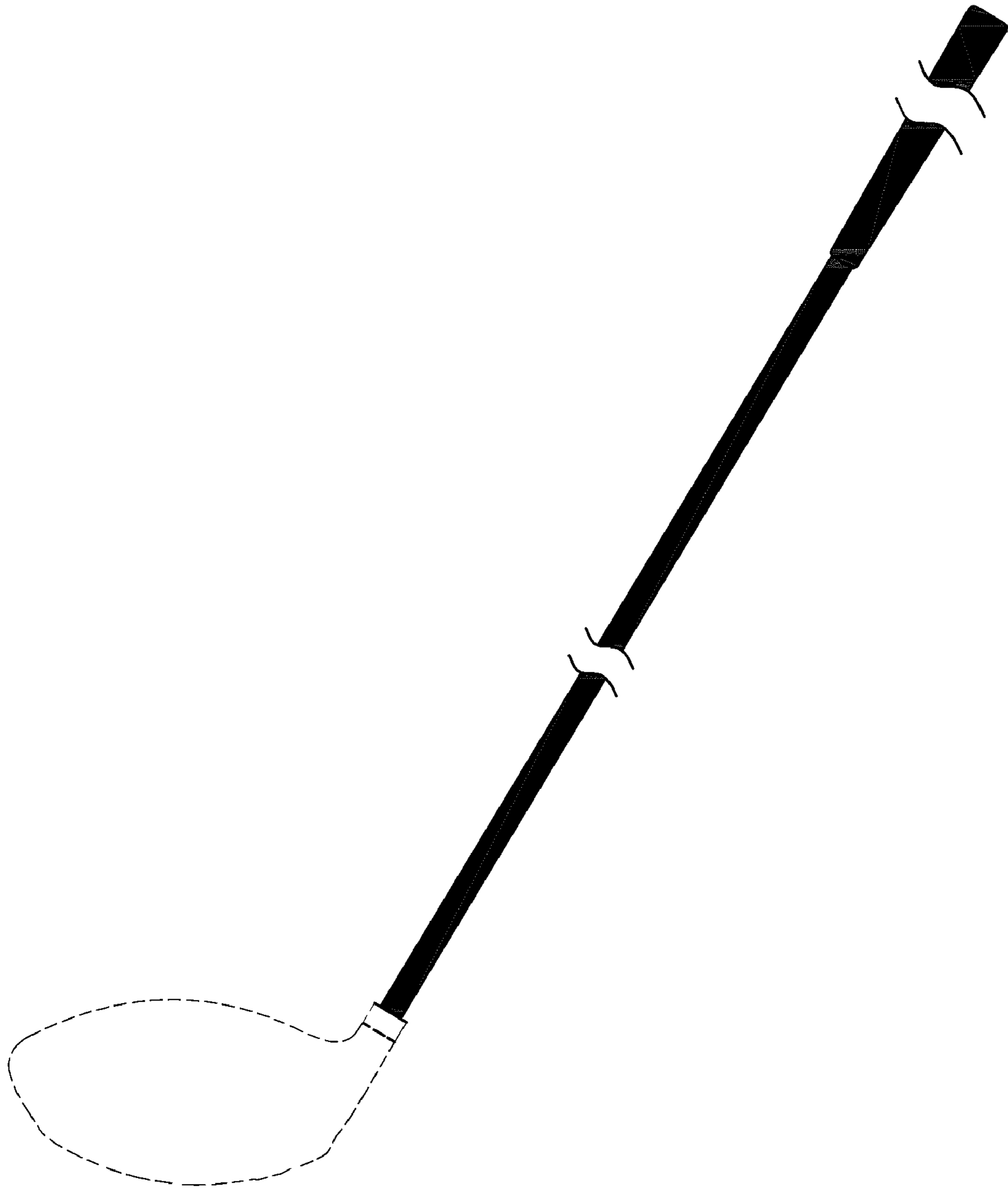

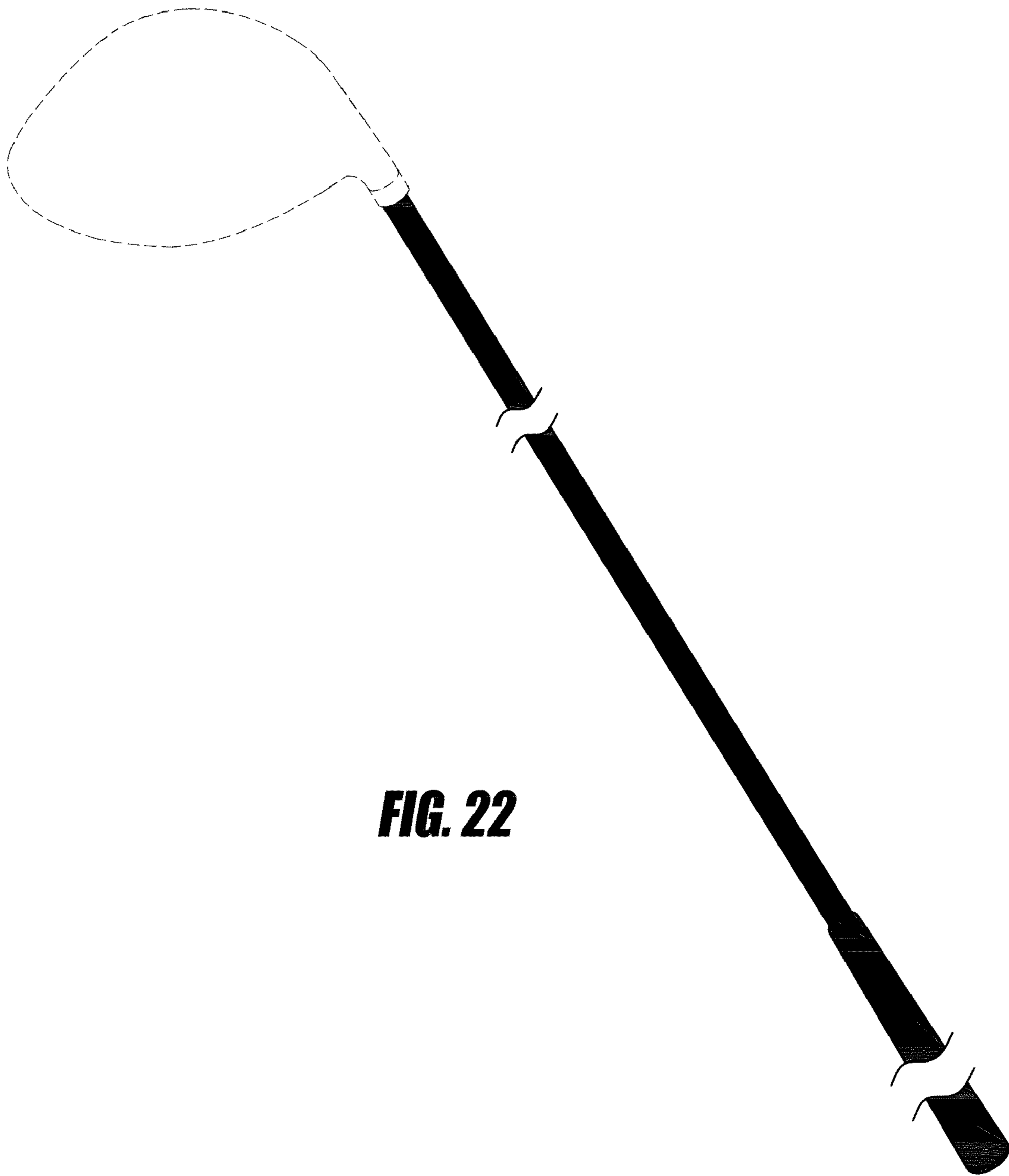

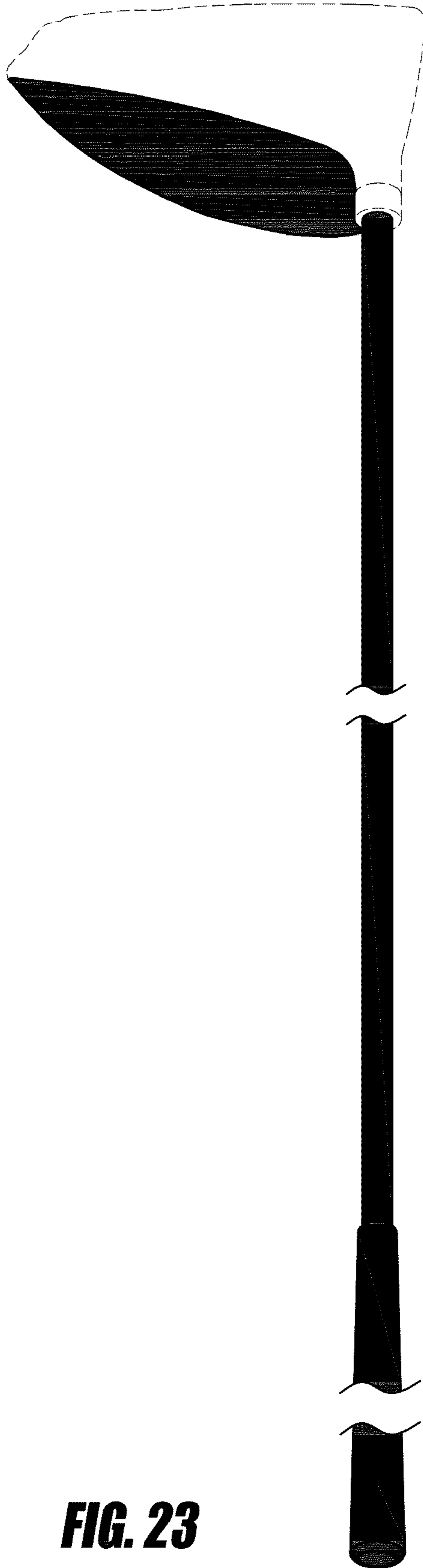




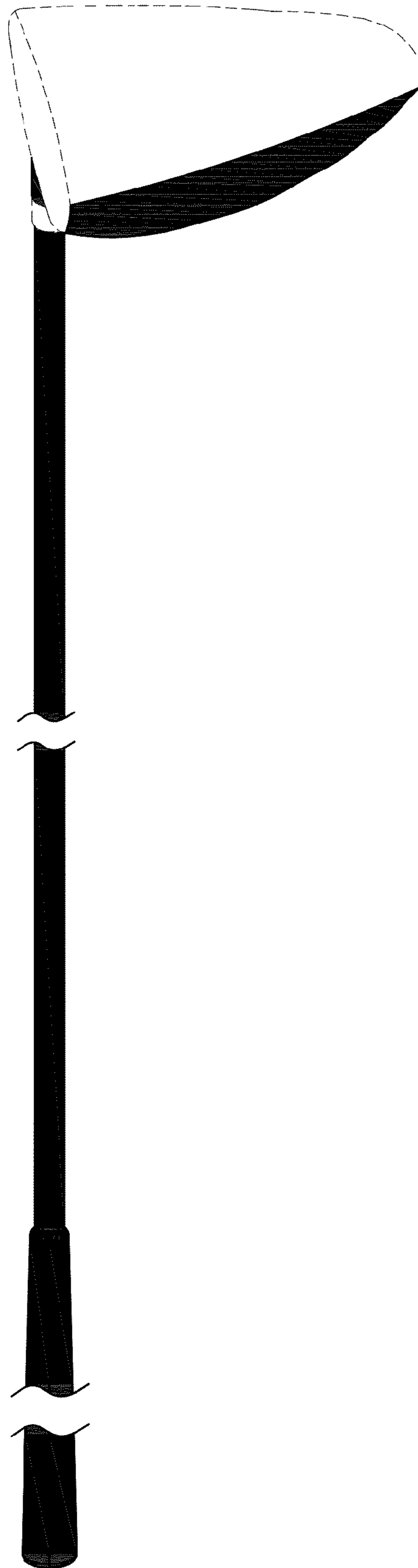

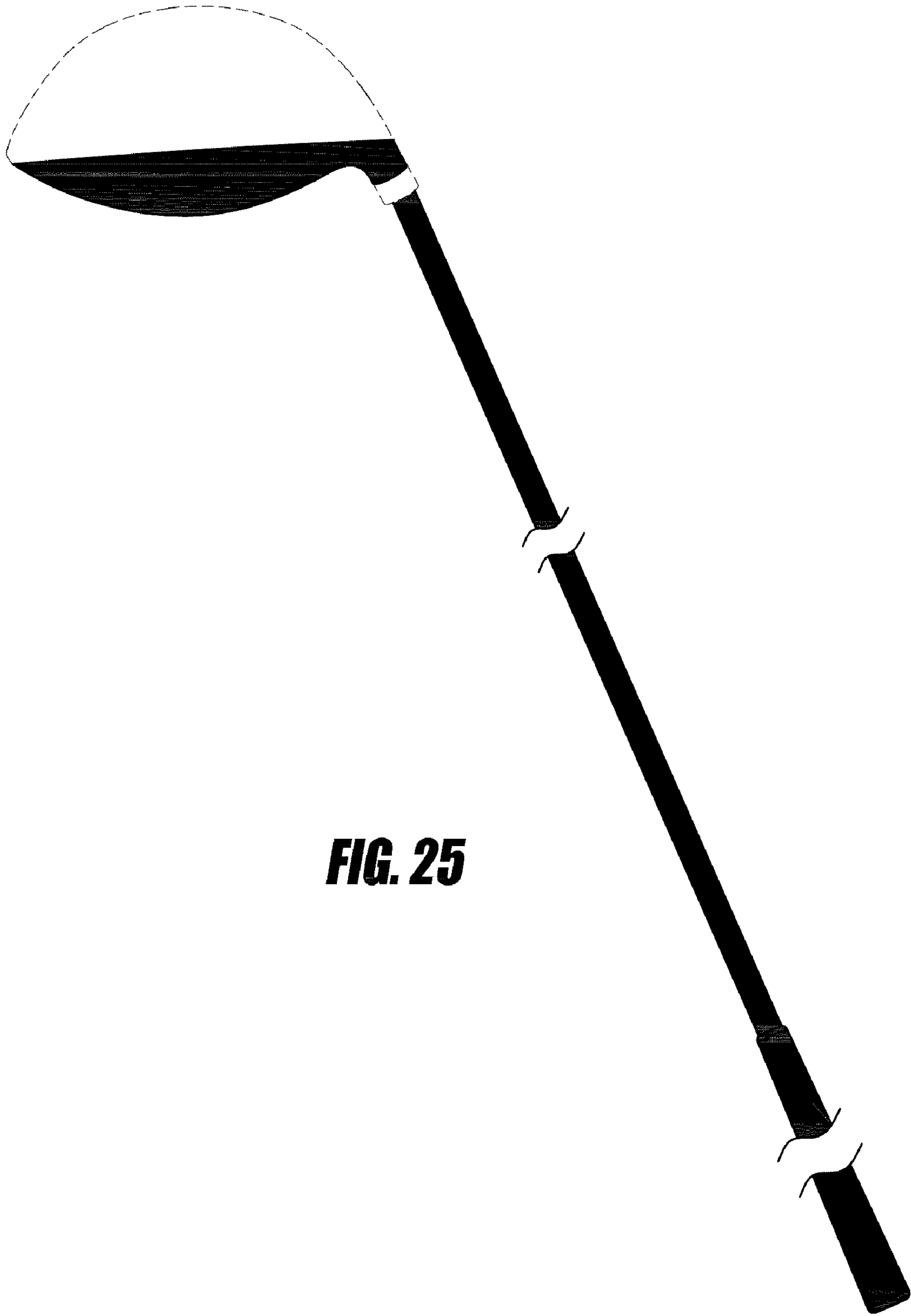

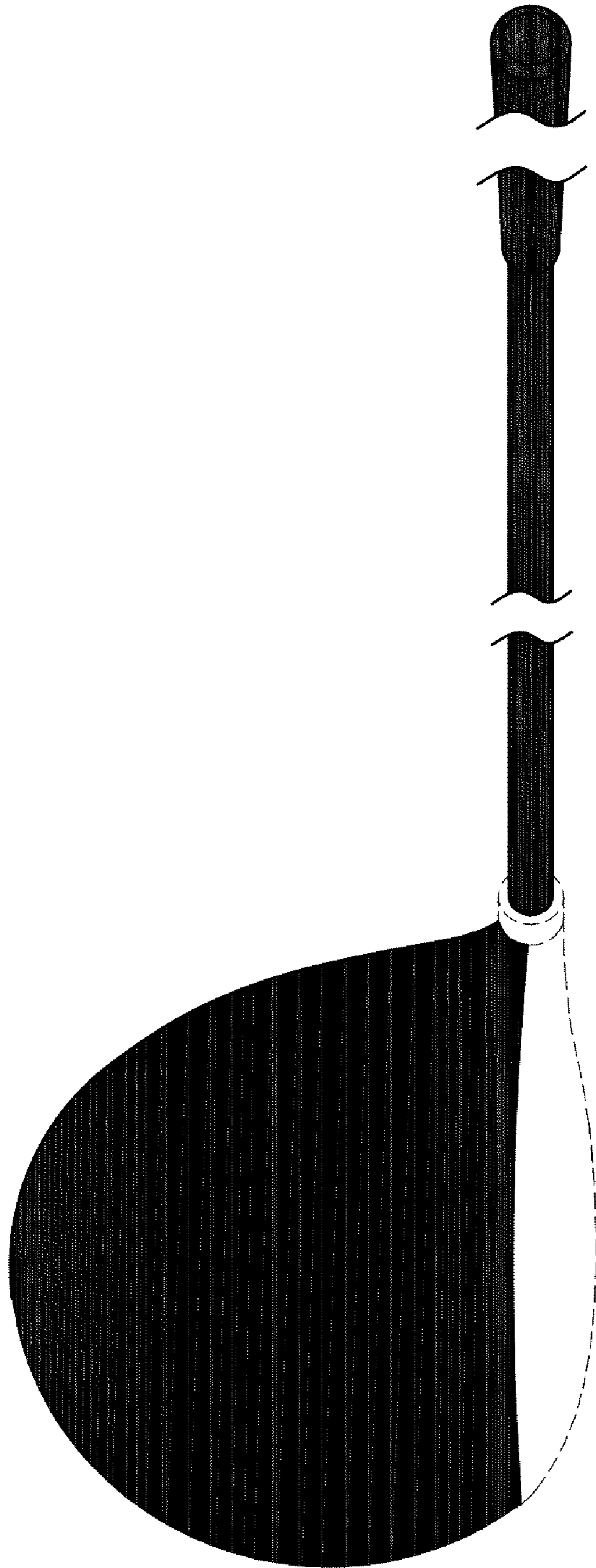

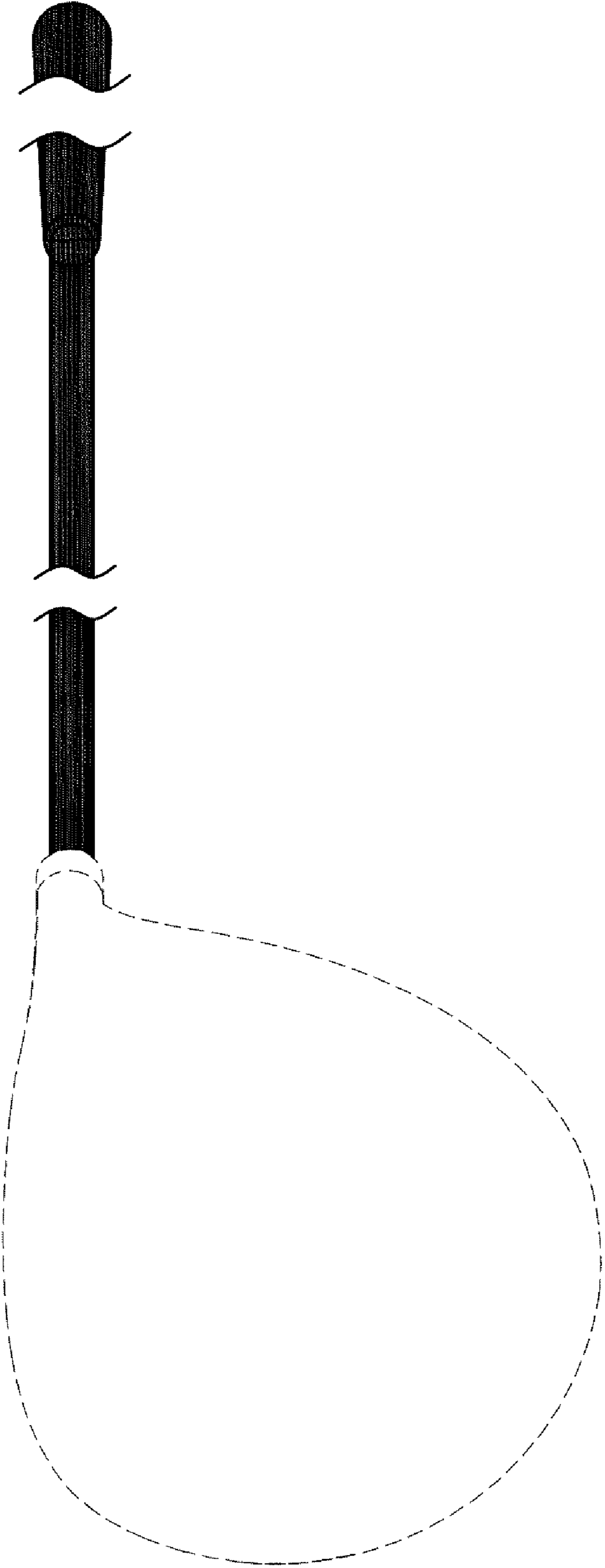

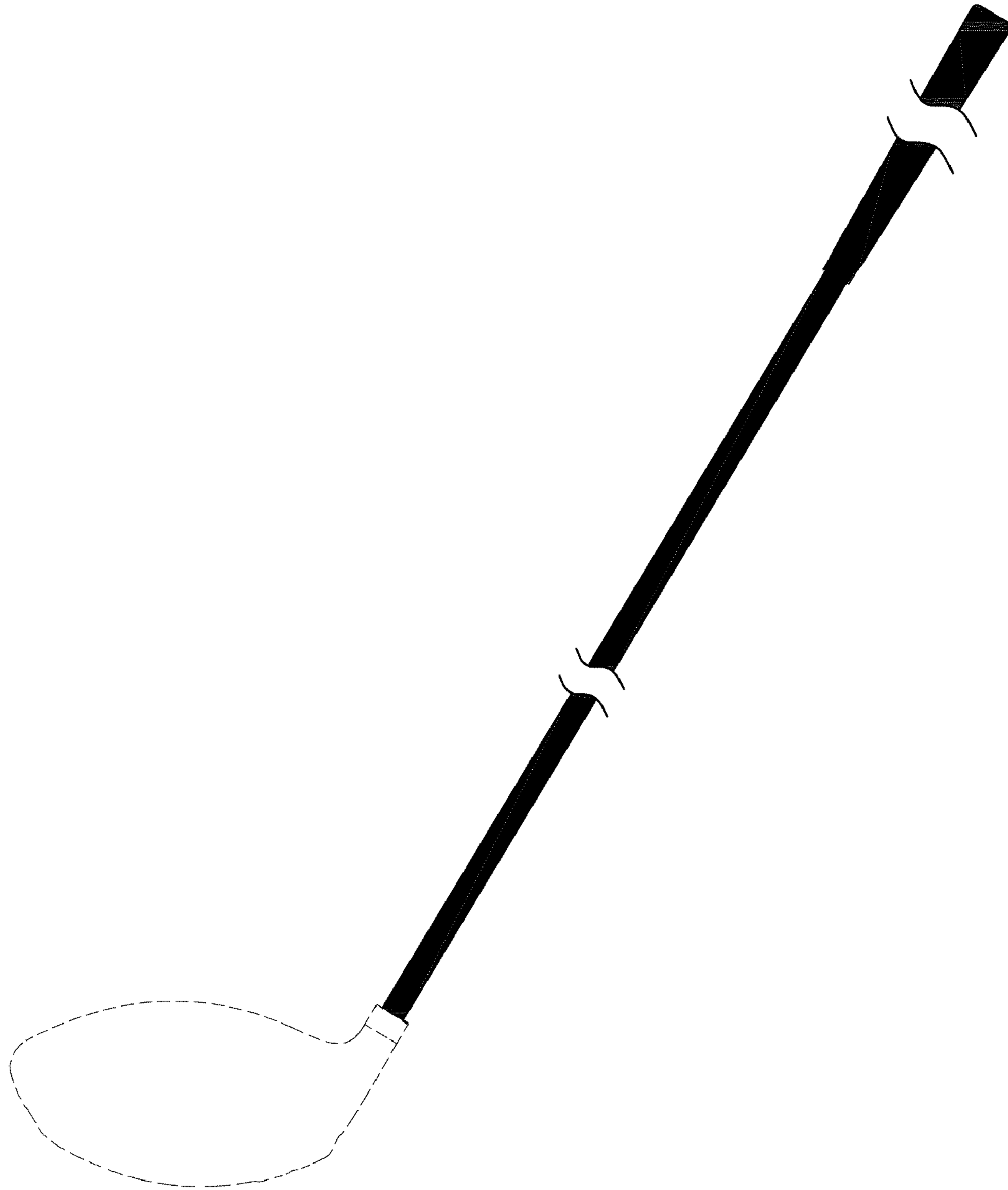

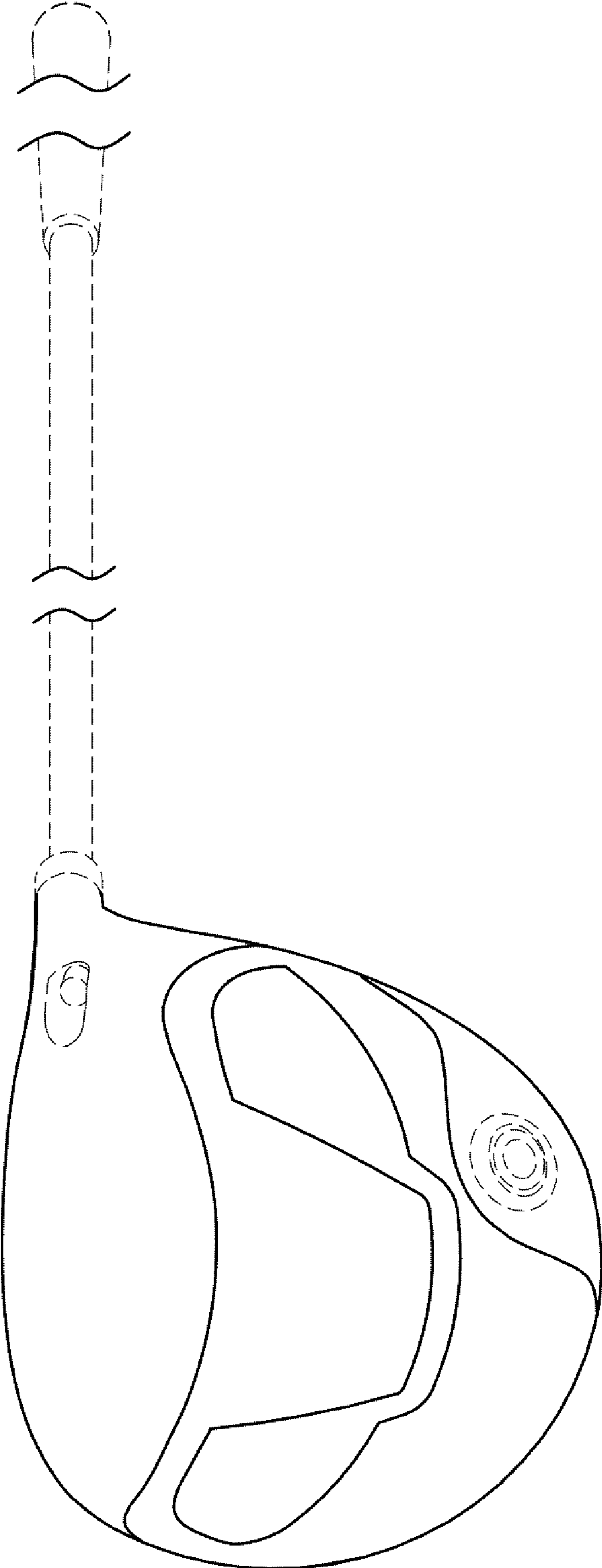
