(57) **CLAIM**

The ornamental design for a holder for cleaning golf balls, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a holder for cleaning golf balls showing our new design;
 FIG. 2 is a right side elevational view of the design shown in FIG. 1;
 FIG. 3 is a left side elevational view of the design shown in FIG. 1;
 FIG. 4 is a front elevational view of the design shown in FIG. 1;
 FIG. 5 is a rear elevational view of the design shown in FIG. 1;
 FIG. 6 is a top plan view, showing a gate of the holder for cleaning golf balls in an open configuration; and,
 FIG. 7 is a top plan view, showing a gate of the holder in a closed configuration.
 The broken line showing of golf balls is included for the purpose of illustrating and forms no part of the claimed design.
