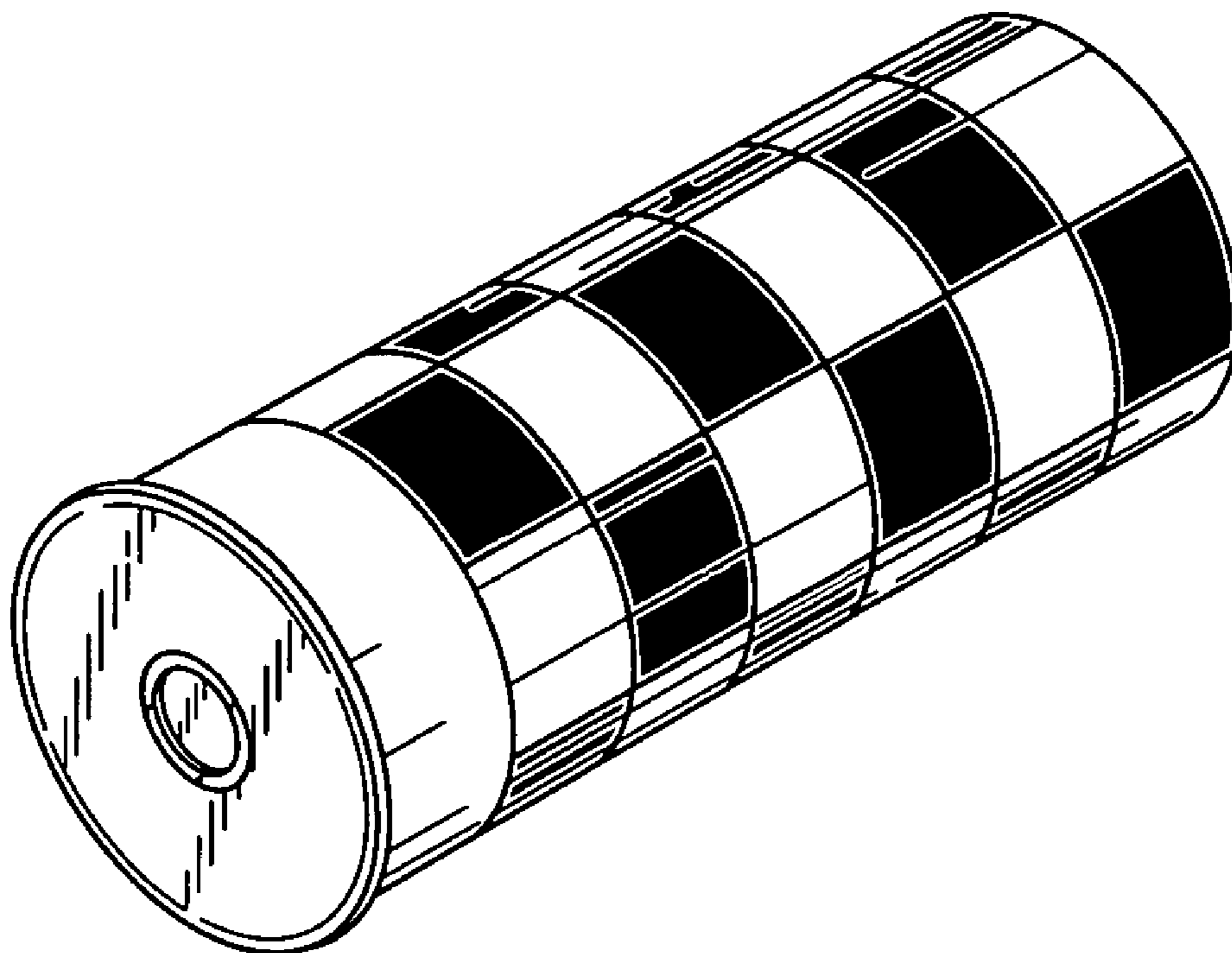
(57) **CLAIM**  
The ornamental design for a shotgun shell casing, as shown and described.

**DESCRIPTION**

Reference is made to U.S. Design patent application Ser. No. 29/370,642 filed on Aug. 14, 2010, by the same inventor. FIG. 1 is a perspective view of the shotgun shell casing. FIG. 2 is a front view of the shotgun shell casing. FIG. 3 is a rear view of the shotgun shell casing. FIG. 4 is a right side view of the shotgun shell casing. FIG. 5 is a left side view of the shotgun shell casing. FIG. 6 is a bottom view of the shotgun shell casing; and, FIG. 7 is a top view of the shotgun shell casing. The gray tones areas of the shotgun shell casing in all views represents areas of high visibility. The broken line showing of portions of the shotgun shell casing in FIG. 6 forms no part of the claimed design.

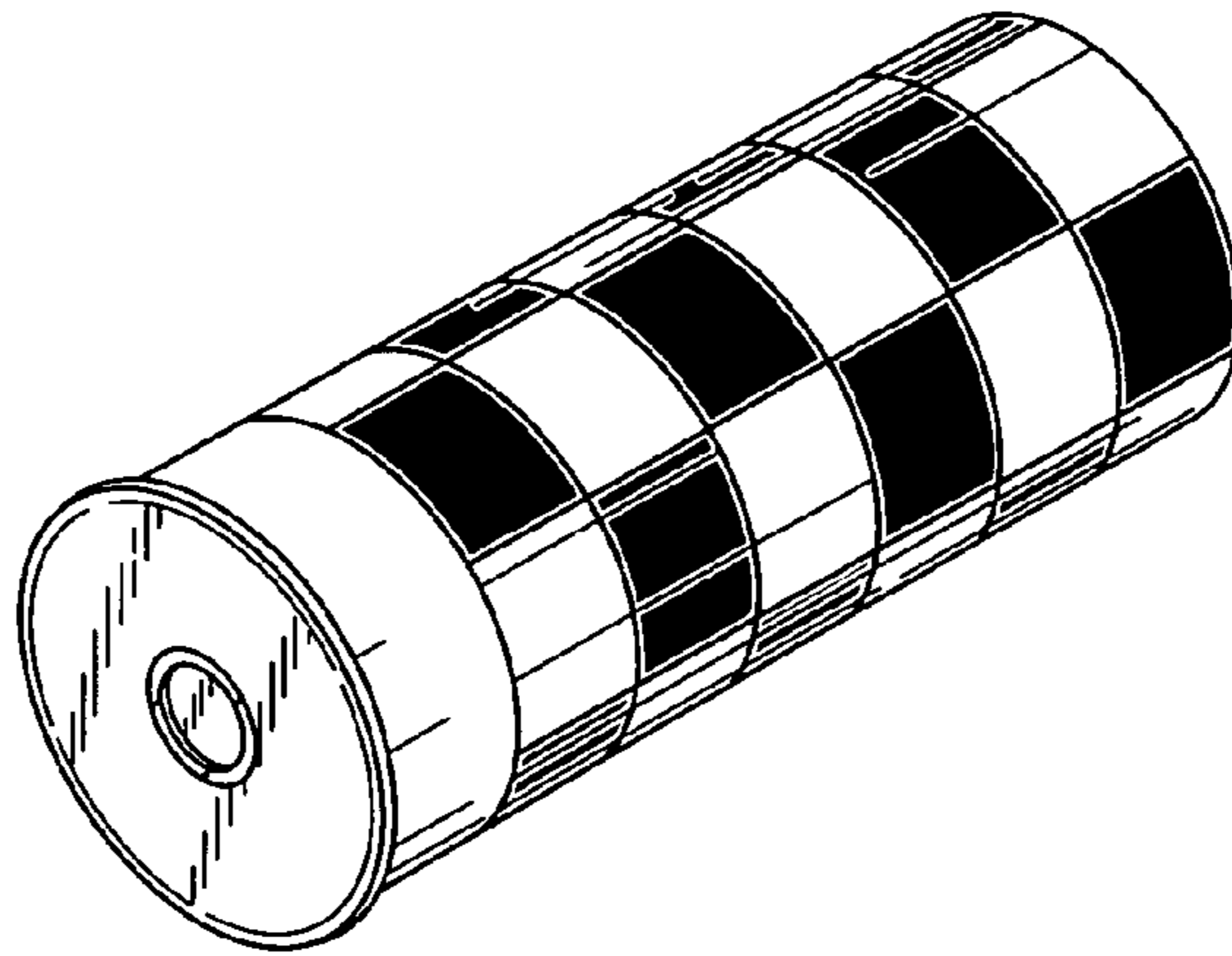

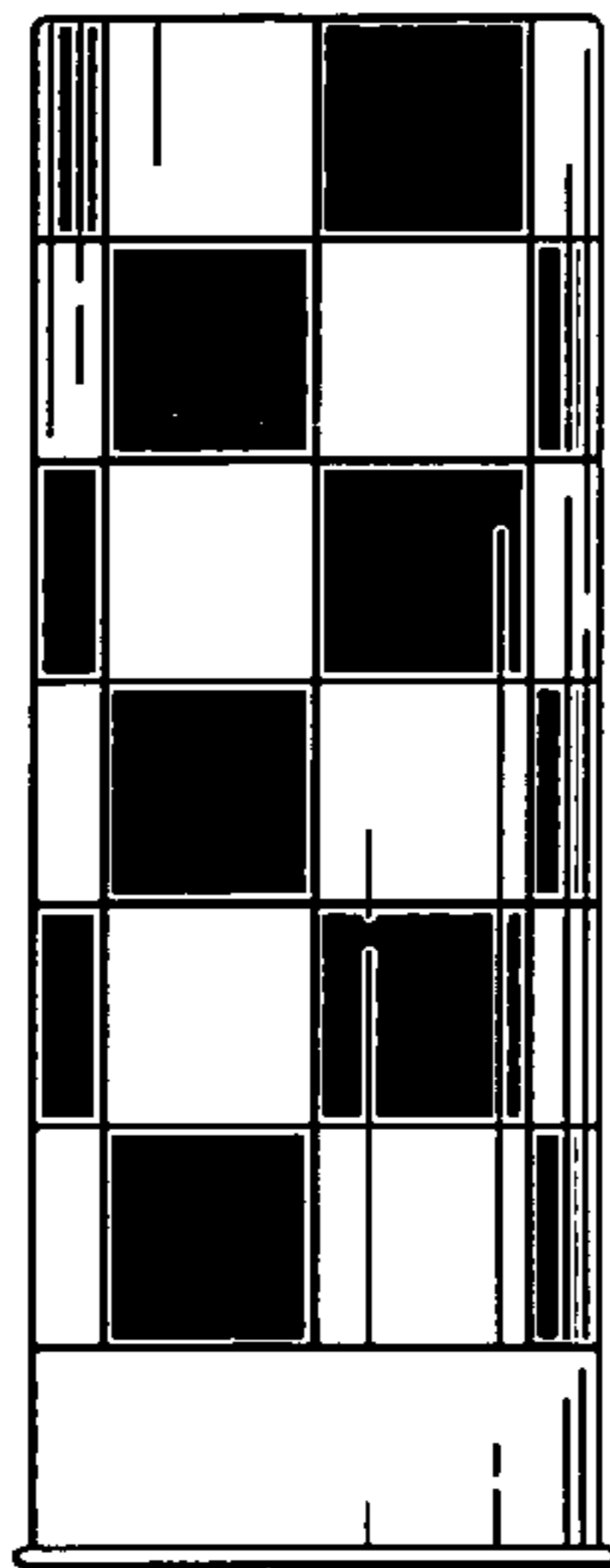

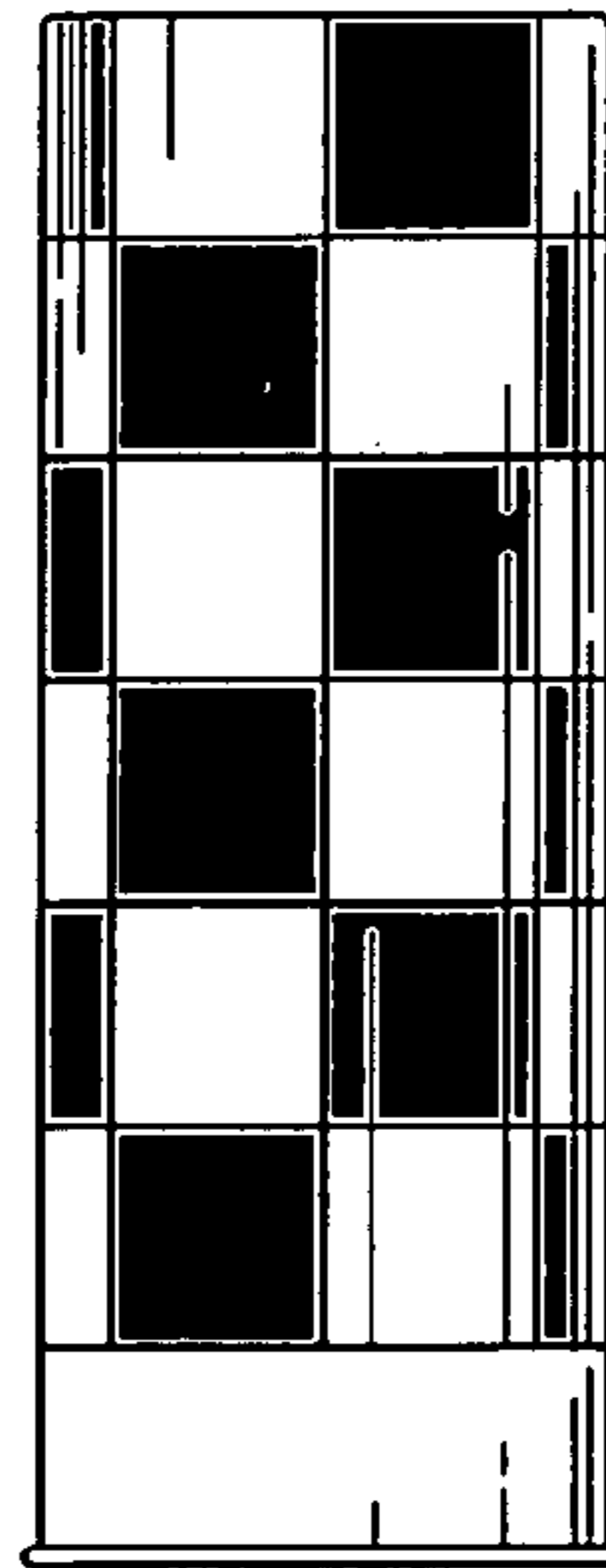

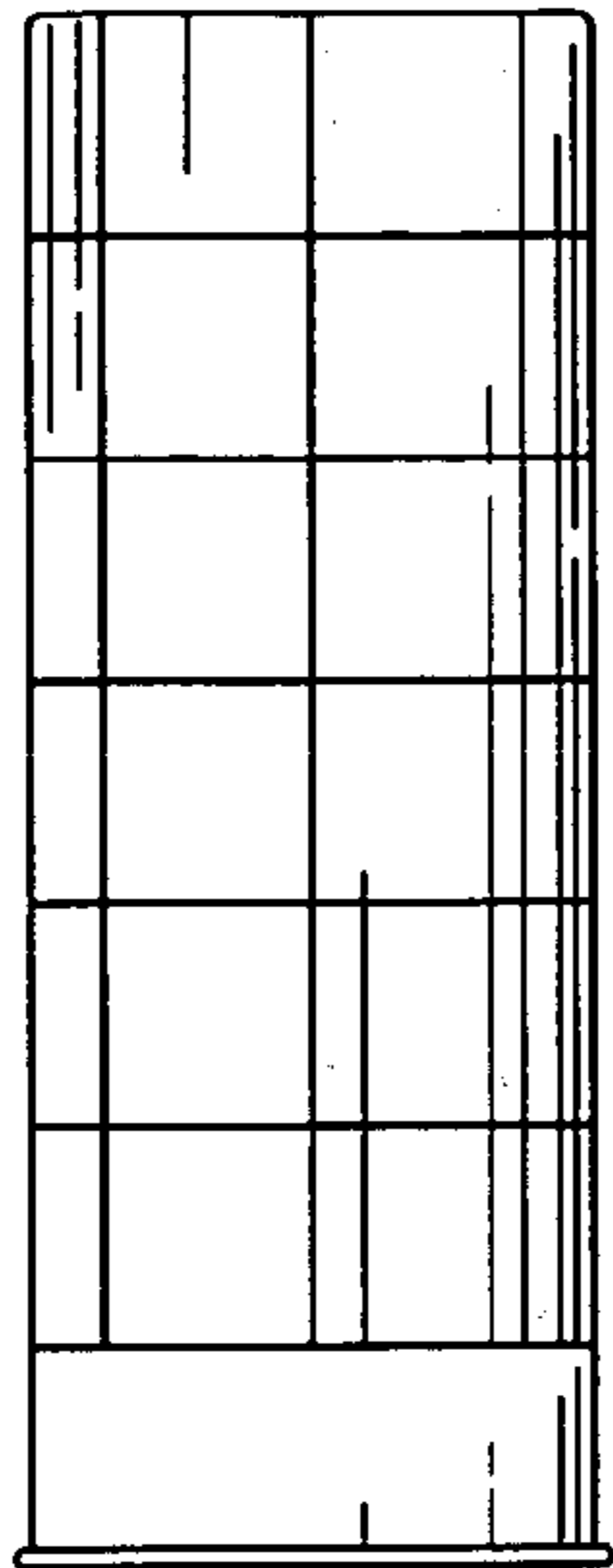

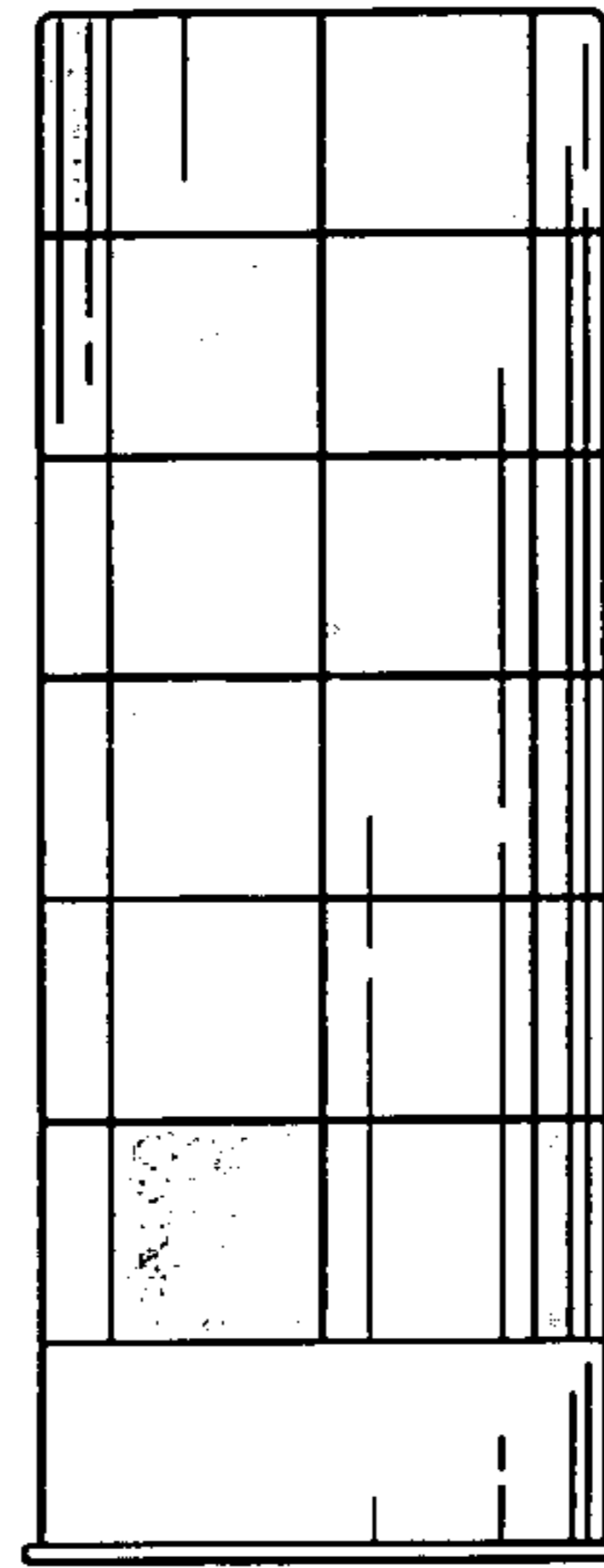

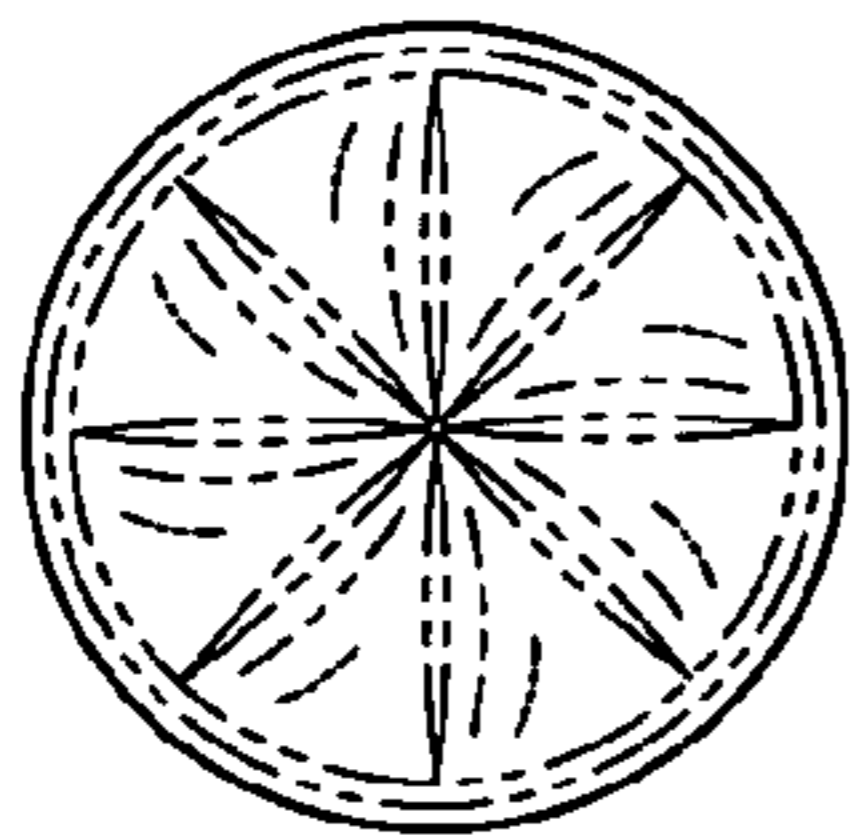

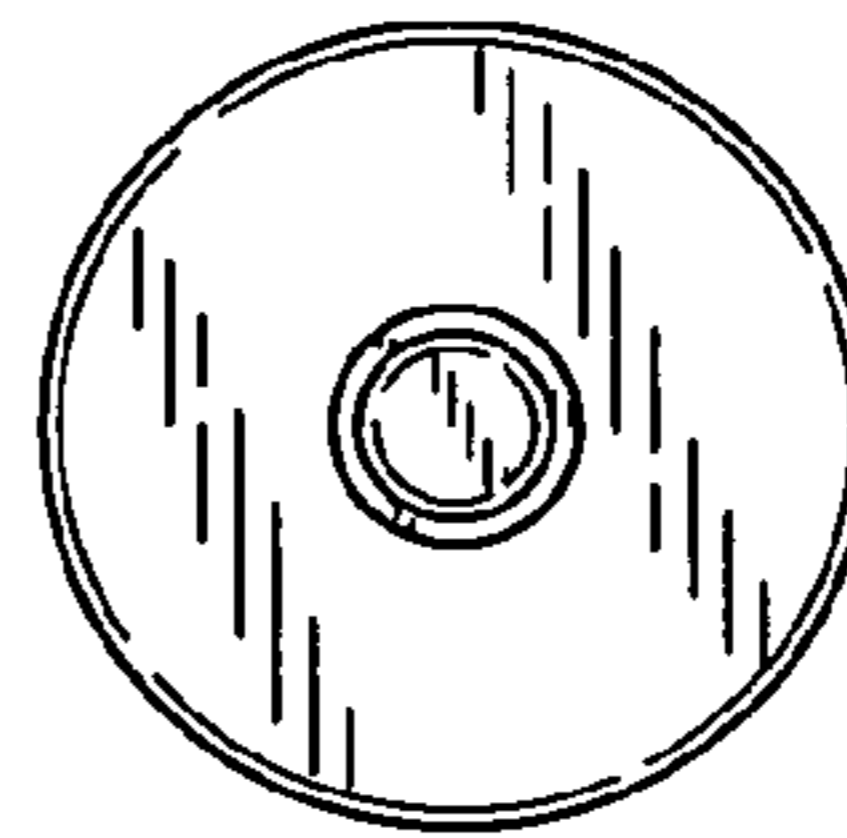
