FIG. 7 is a perspective view of the unlocked valve body, showing our new design.

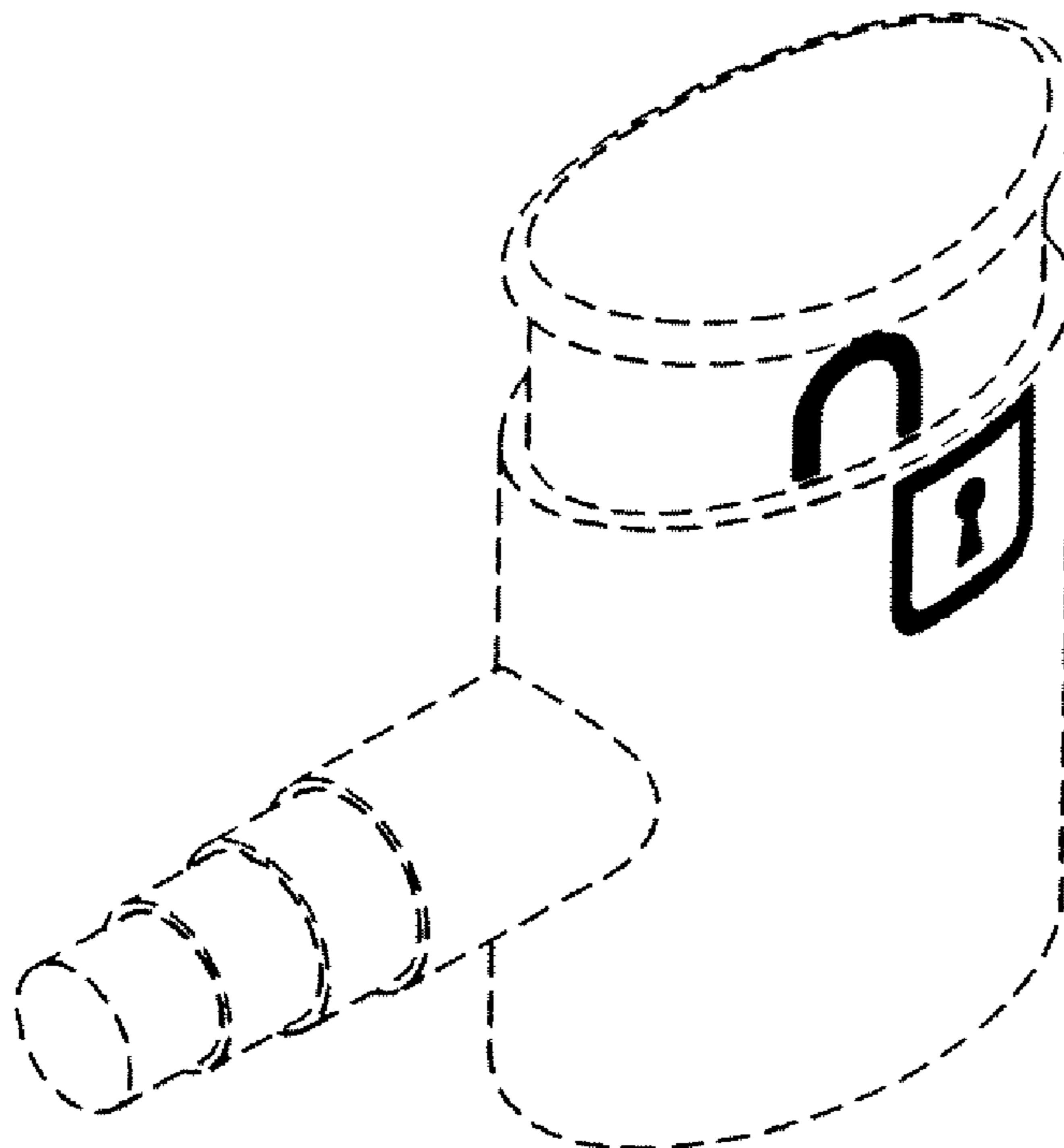

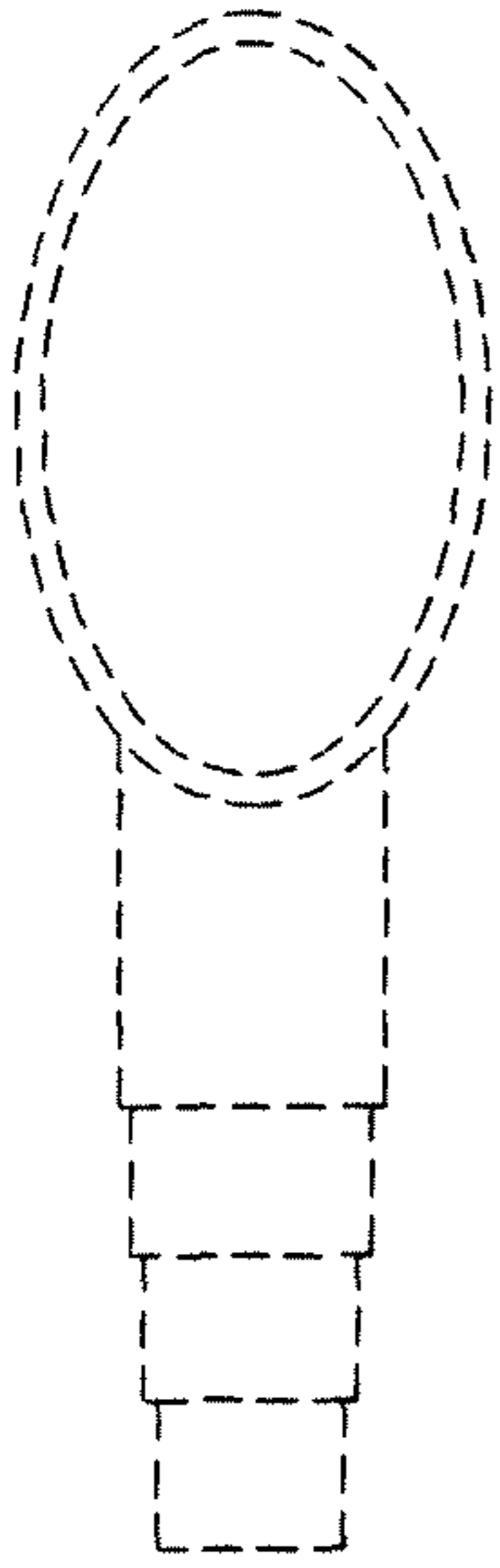

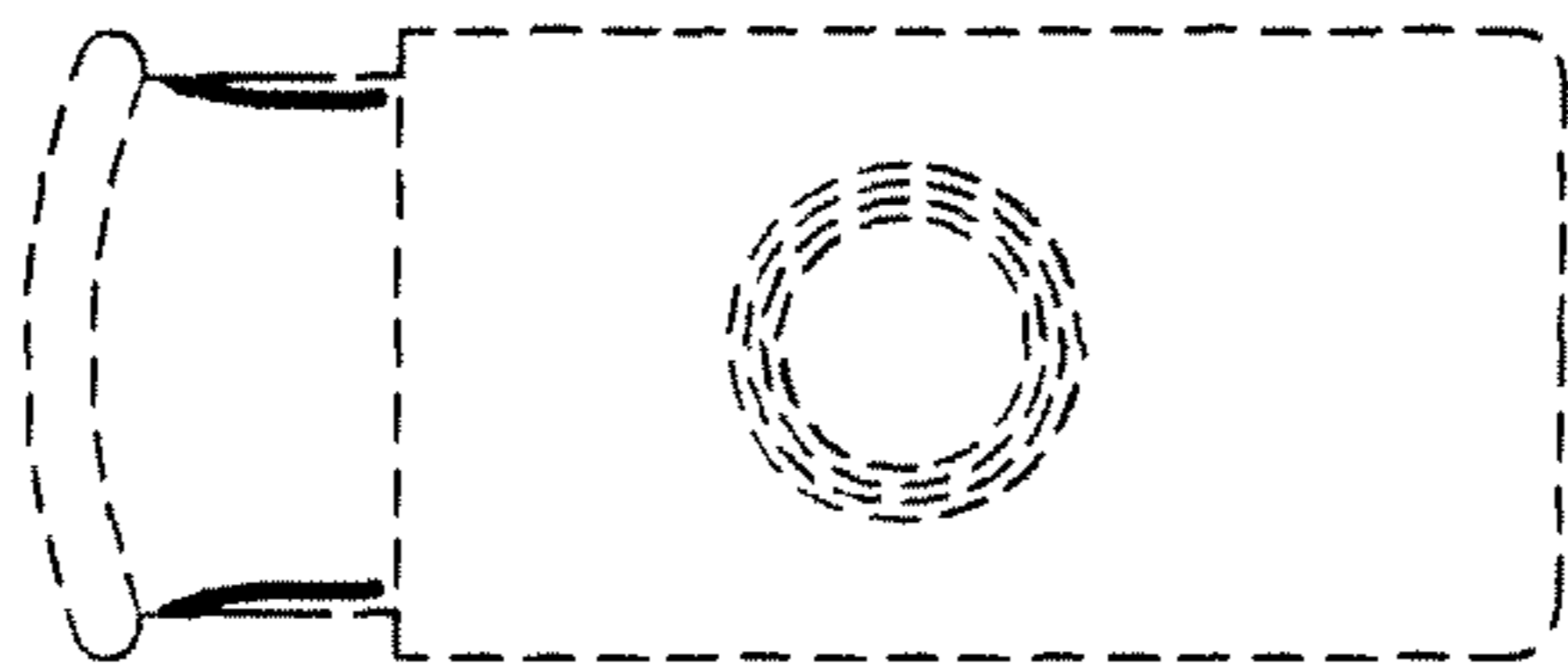

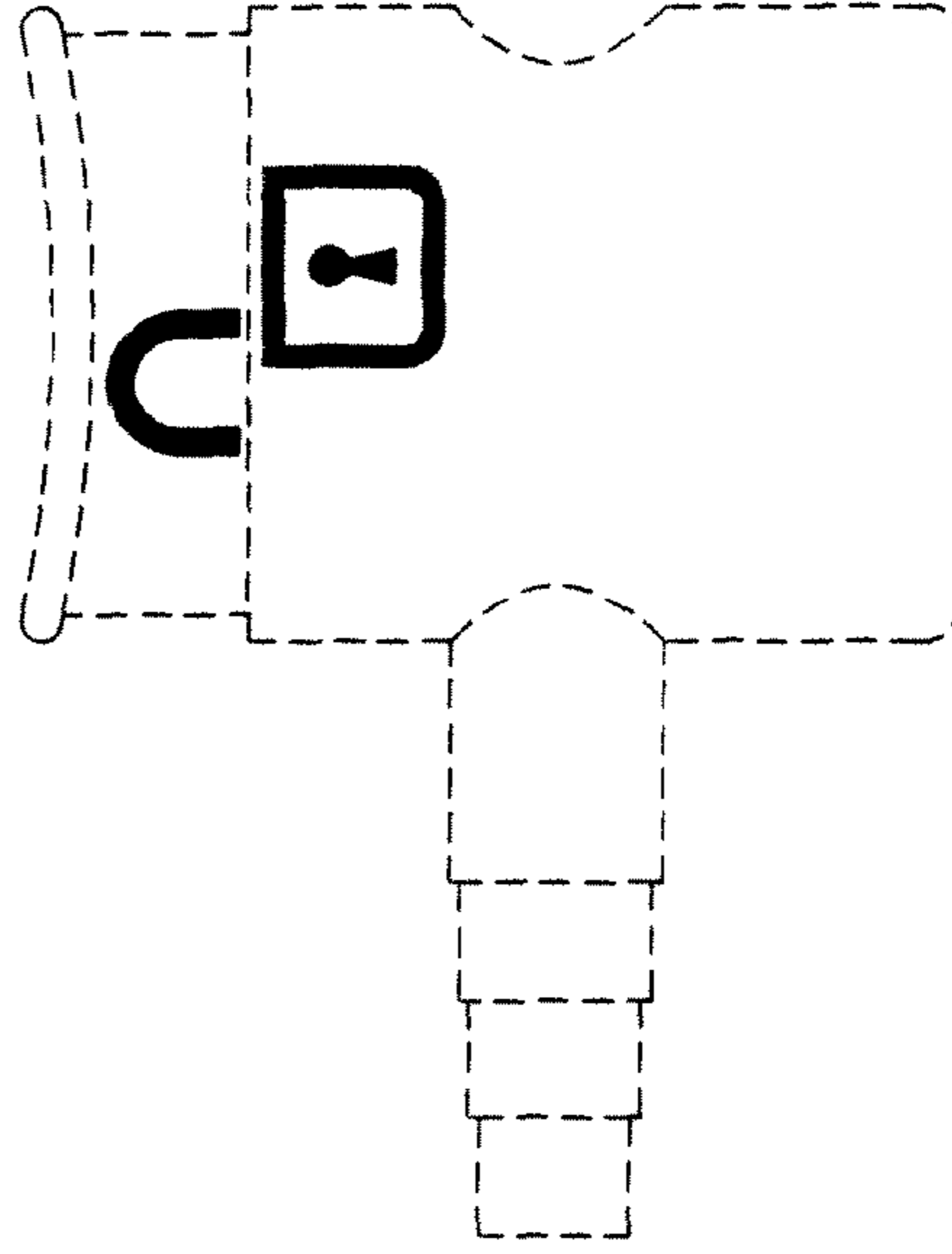

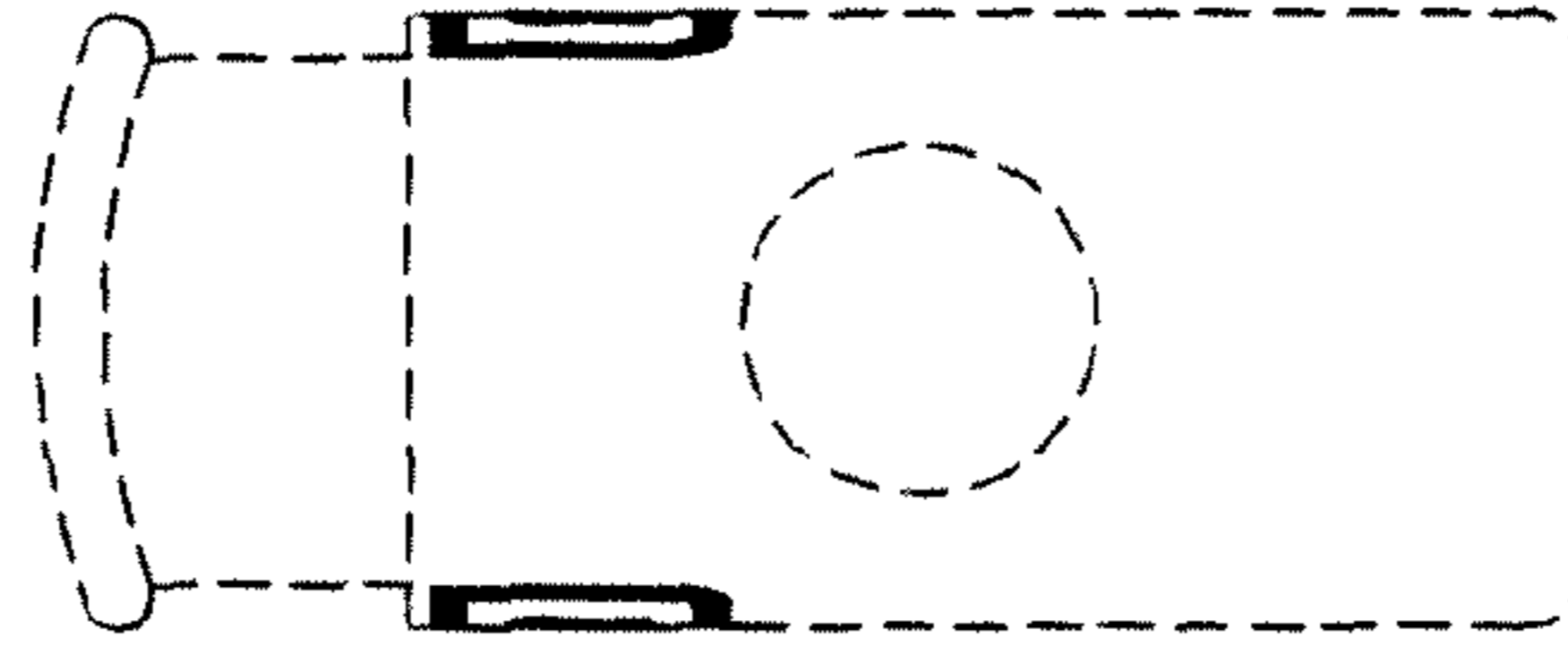

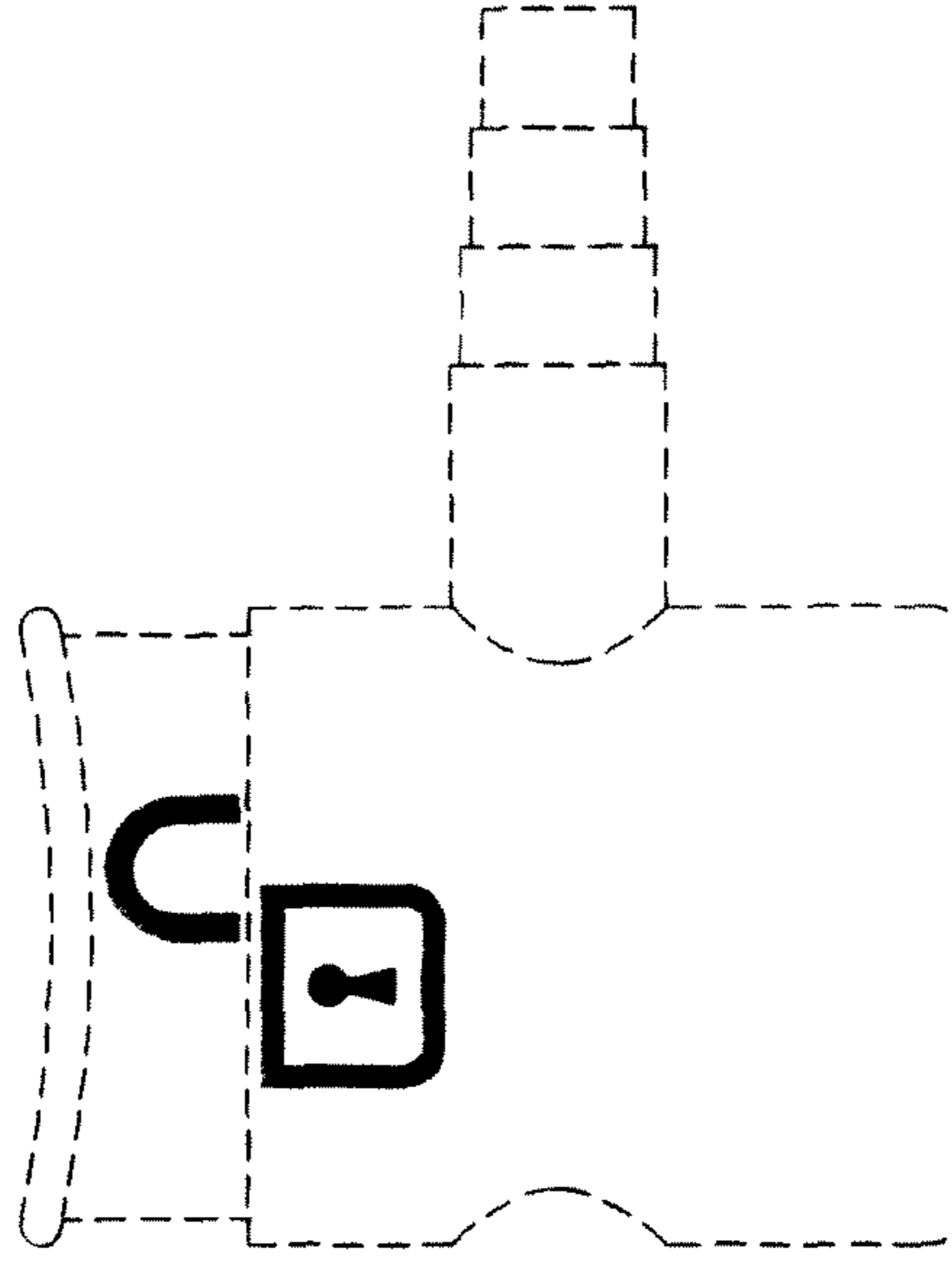

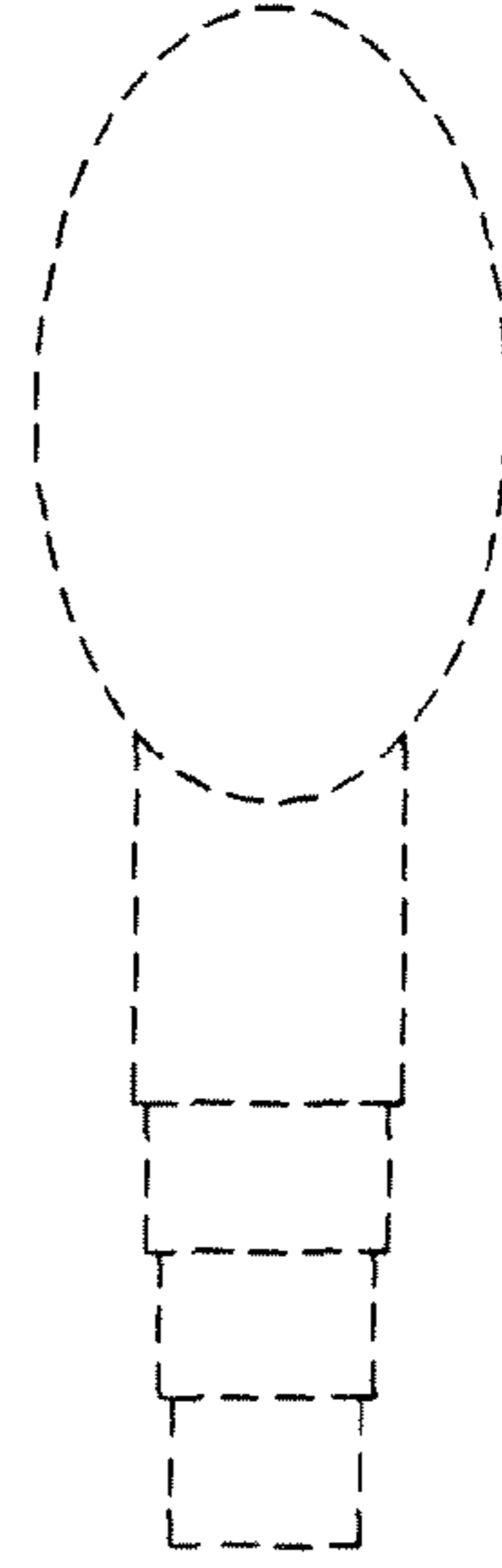

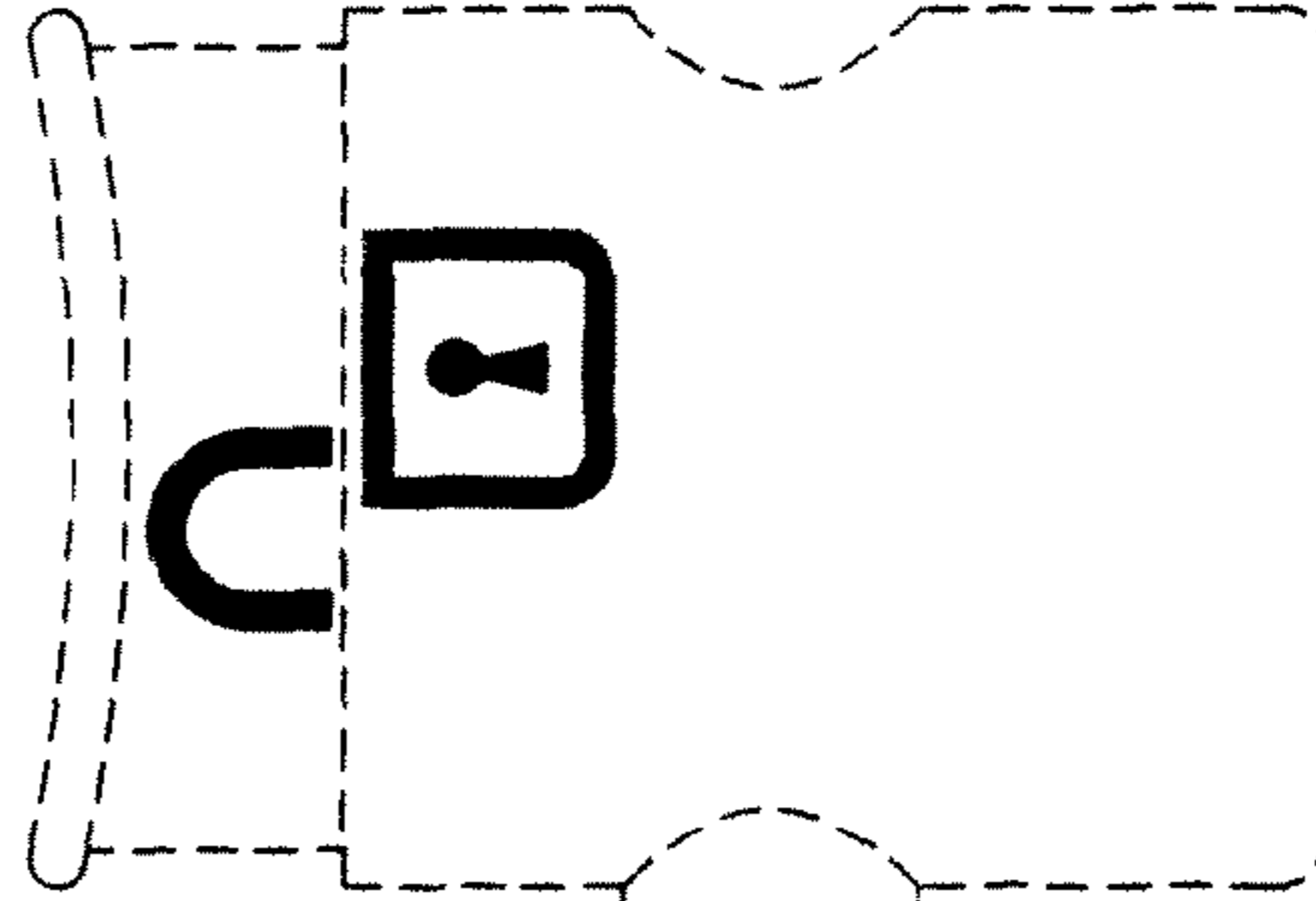

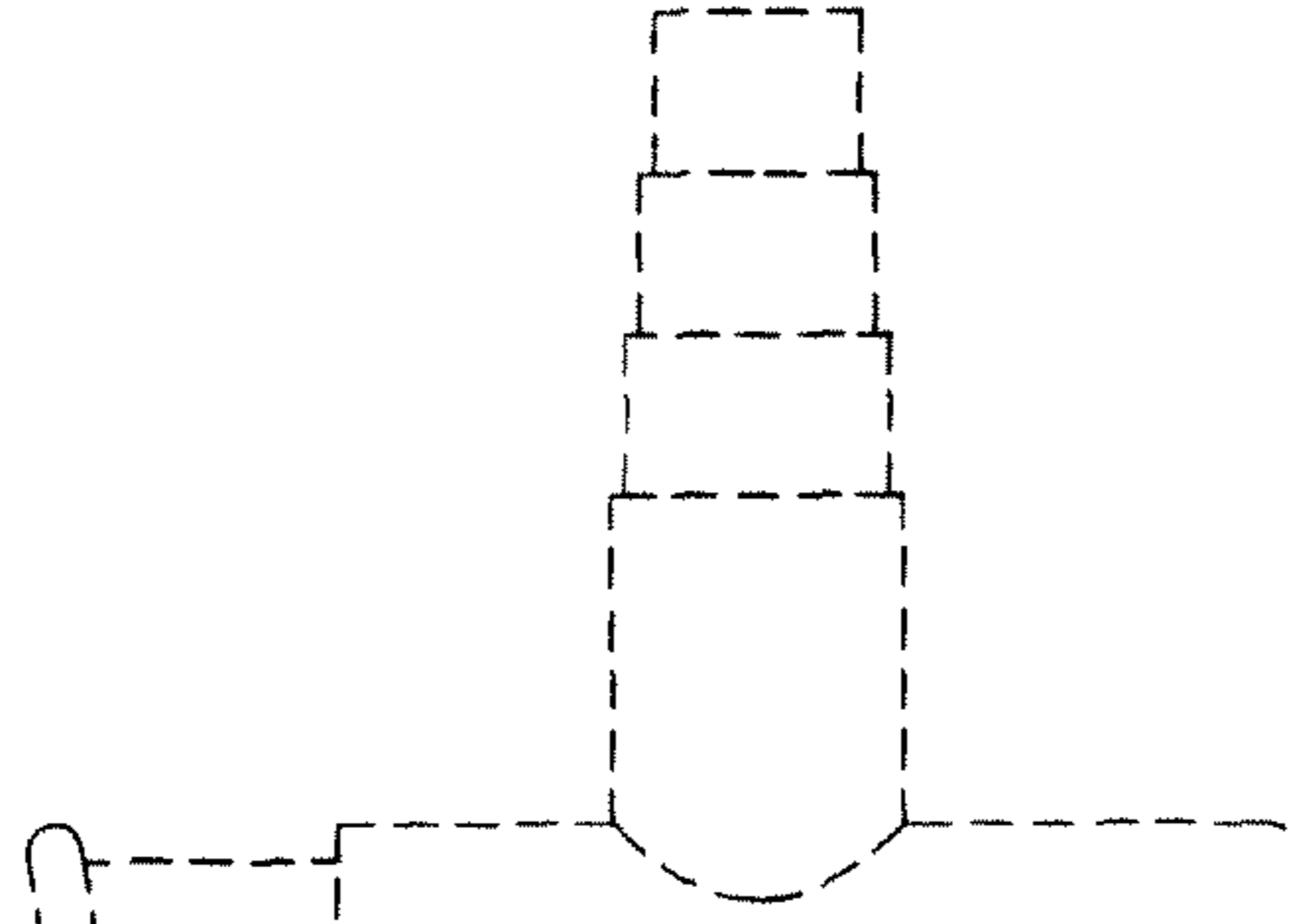

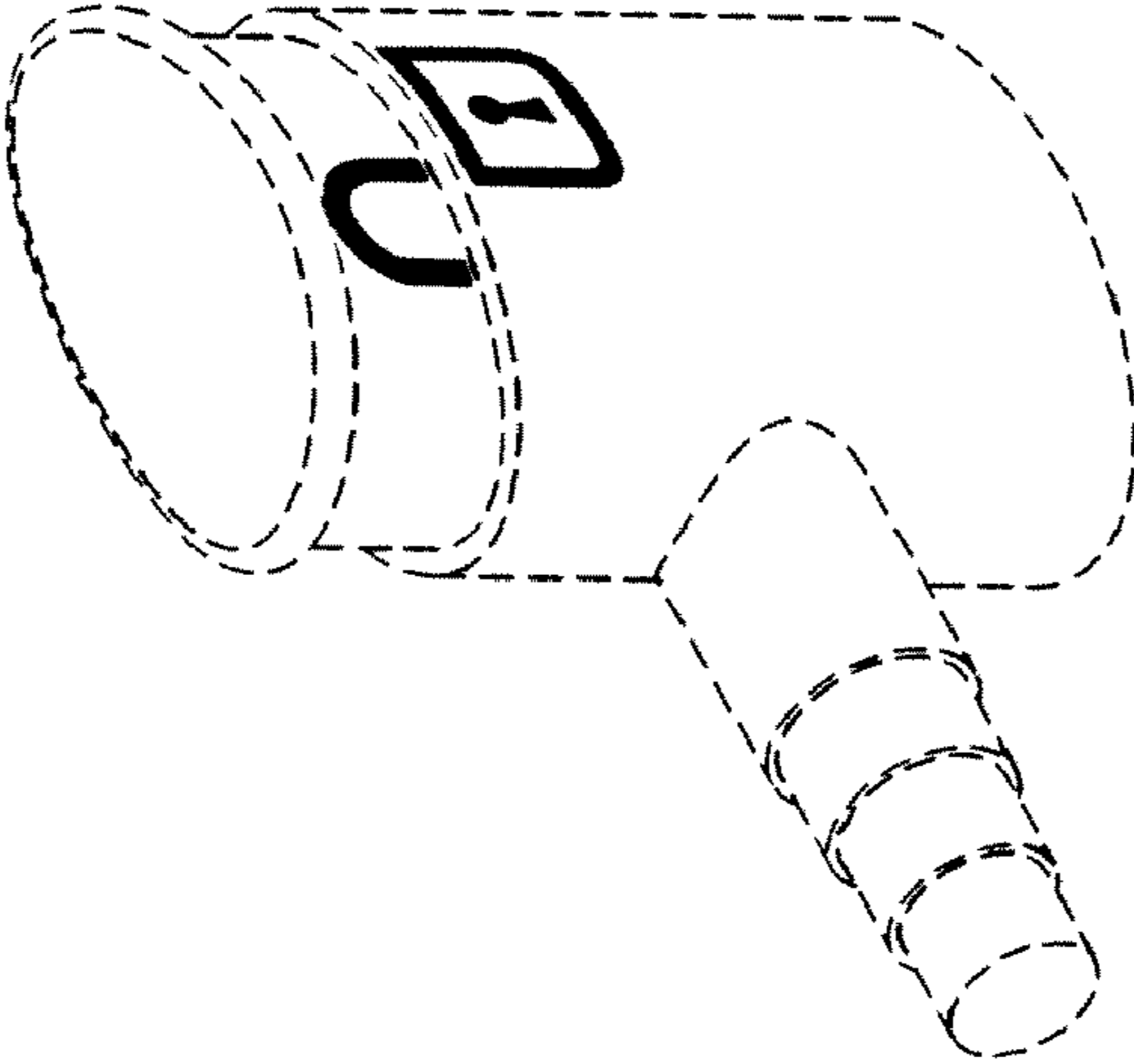
