FIG. 2 is a first side view thereof;

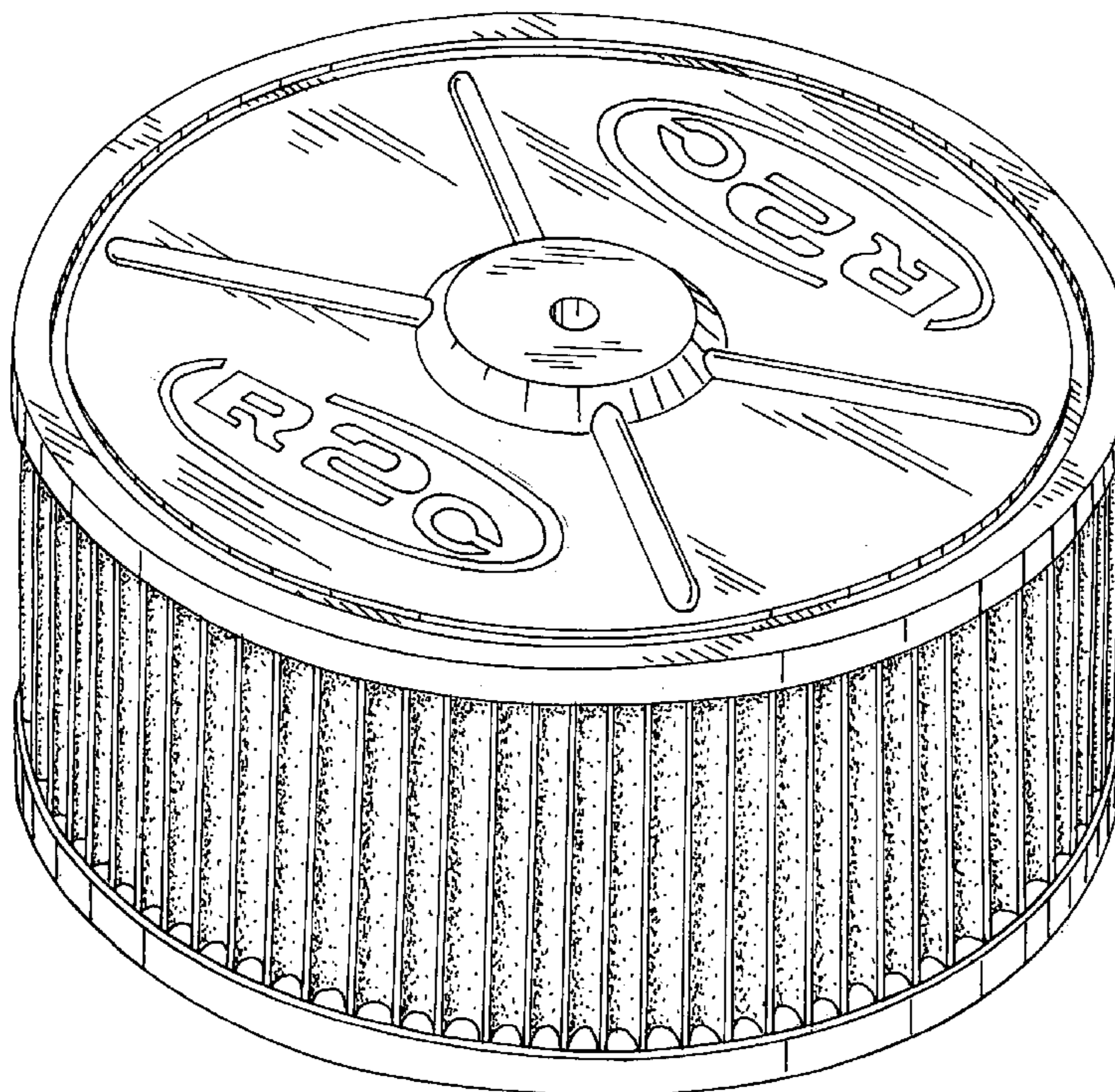
FIG. 3 is a second side view thereof;

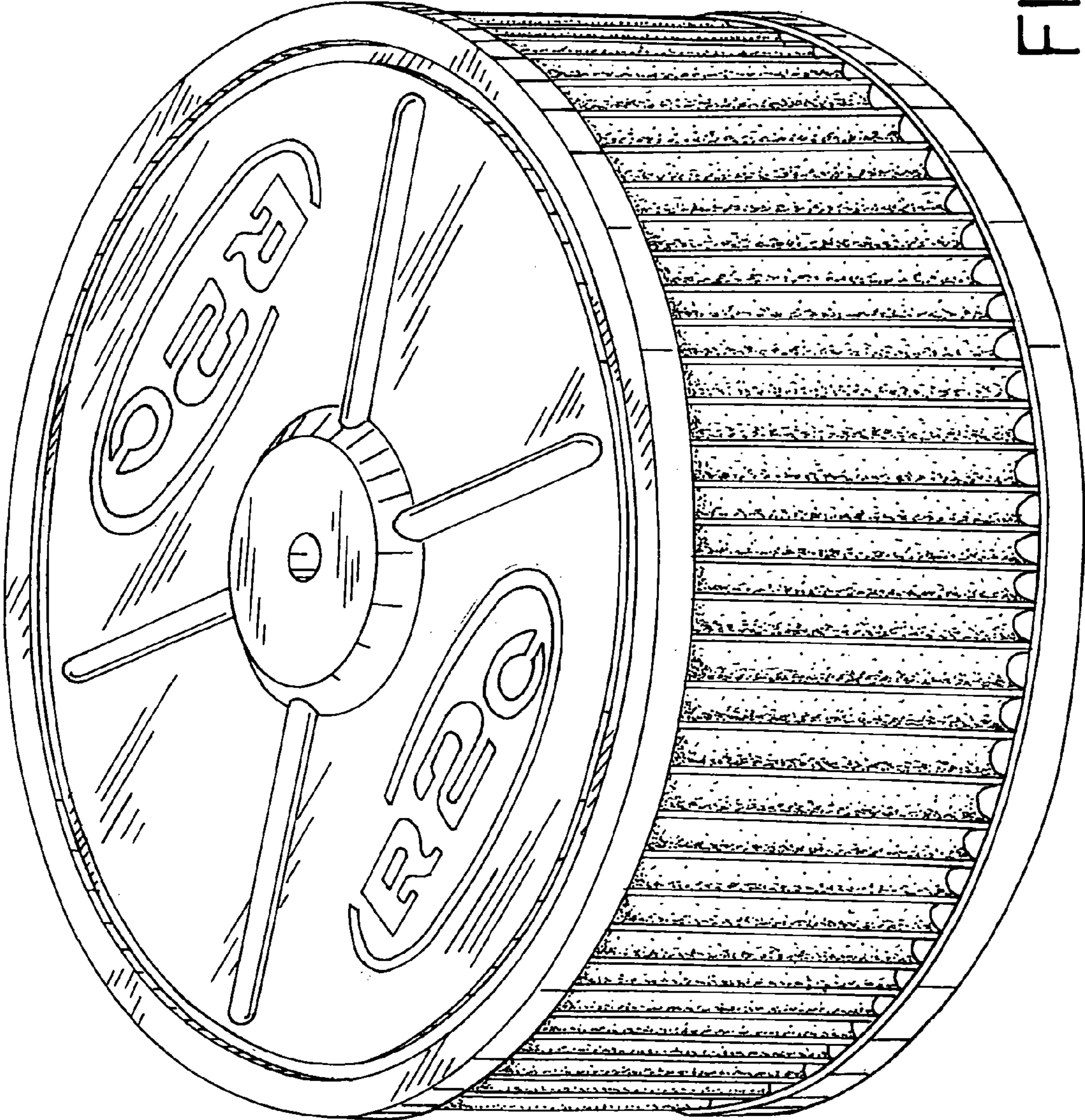

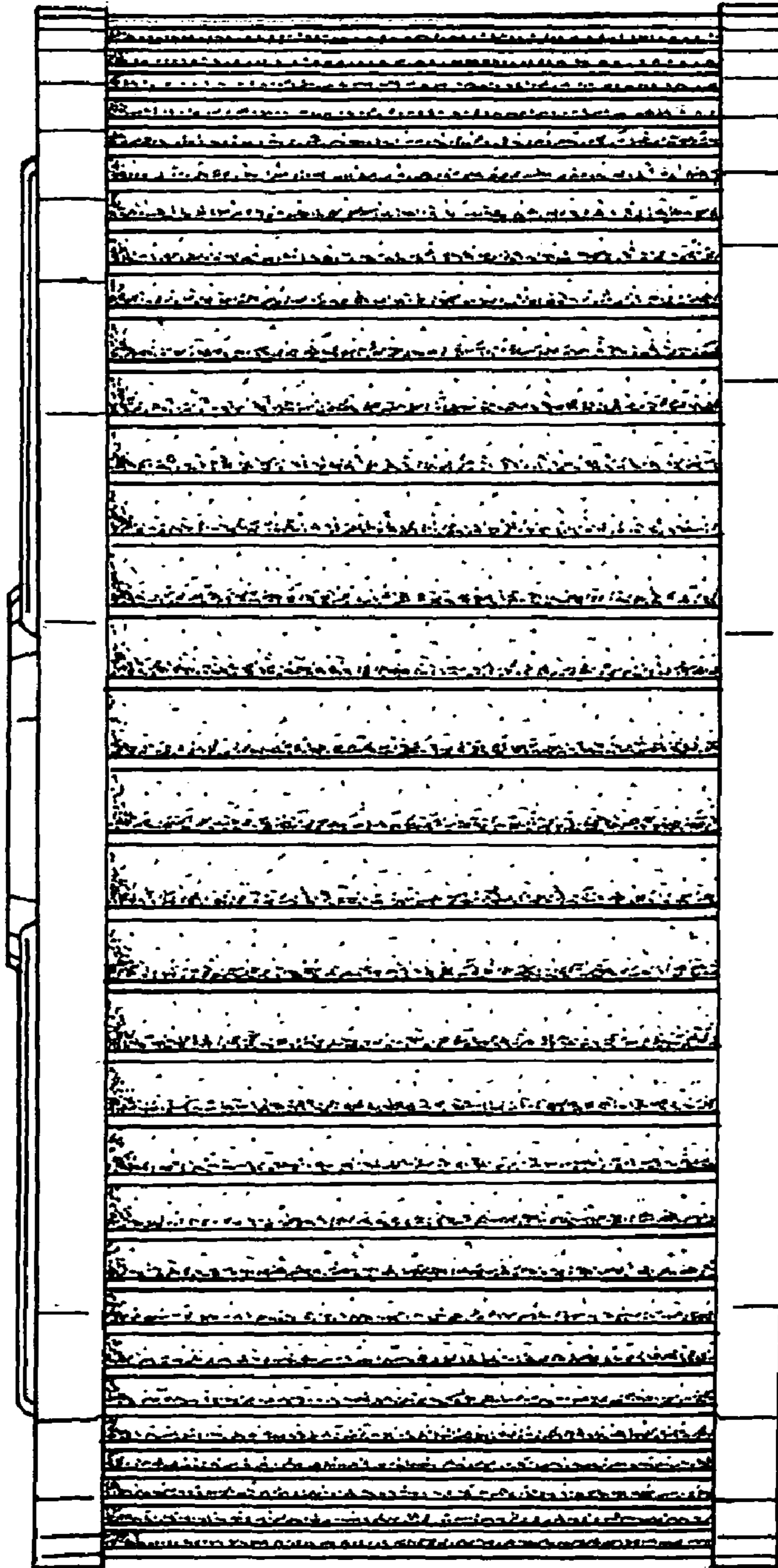

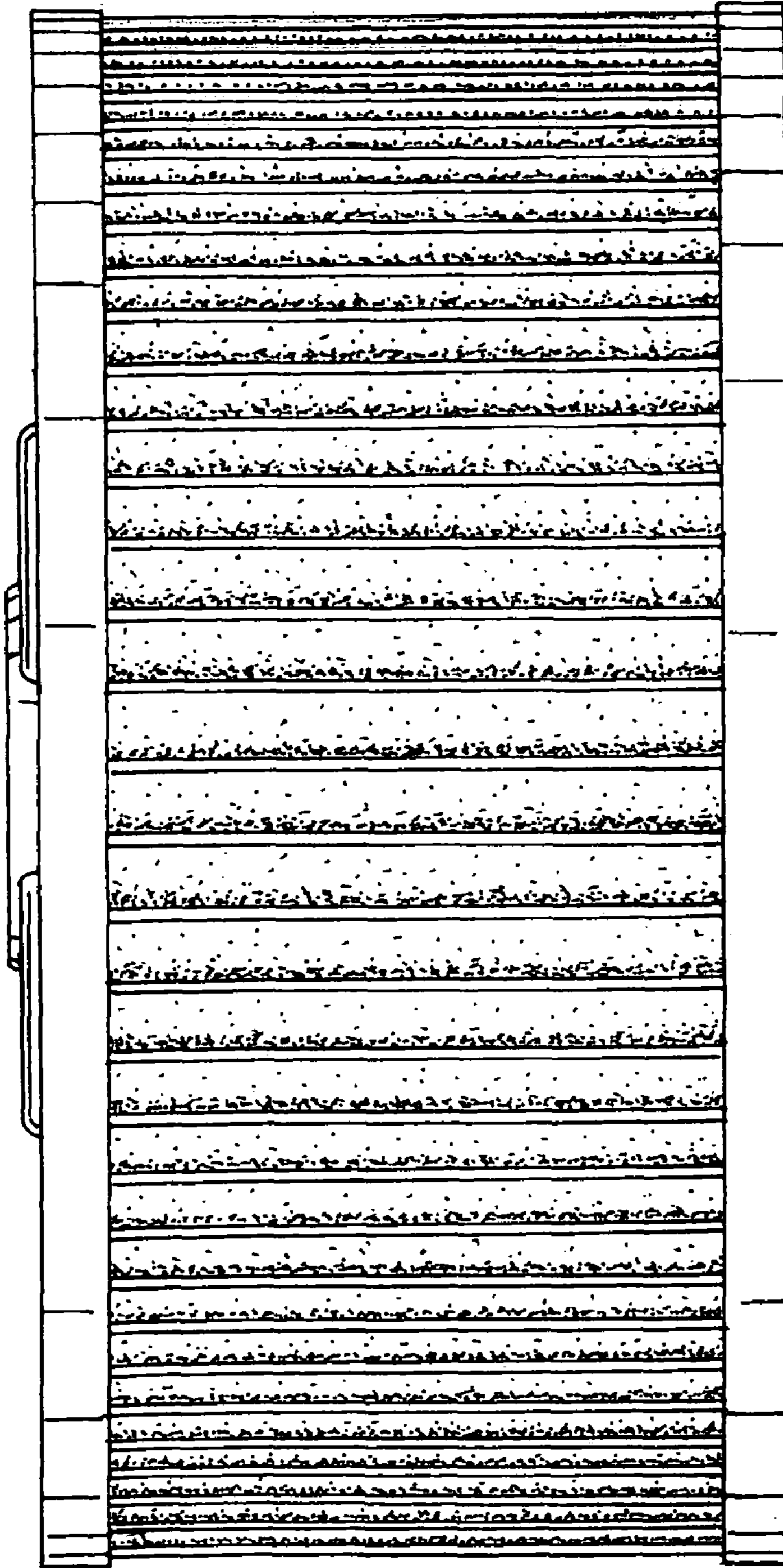

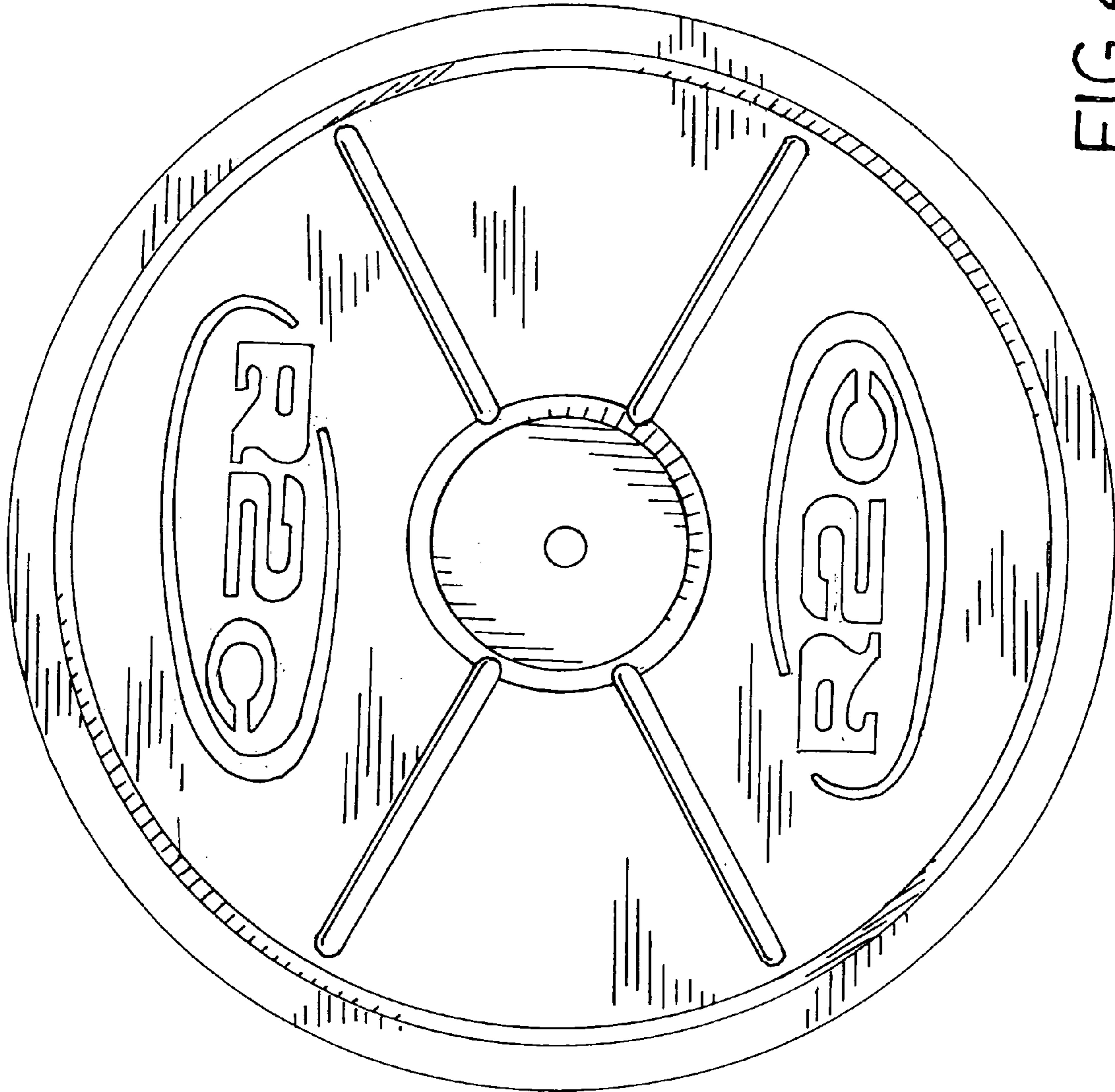

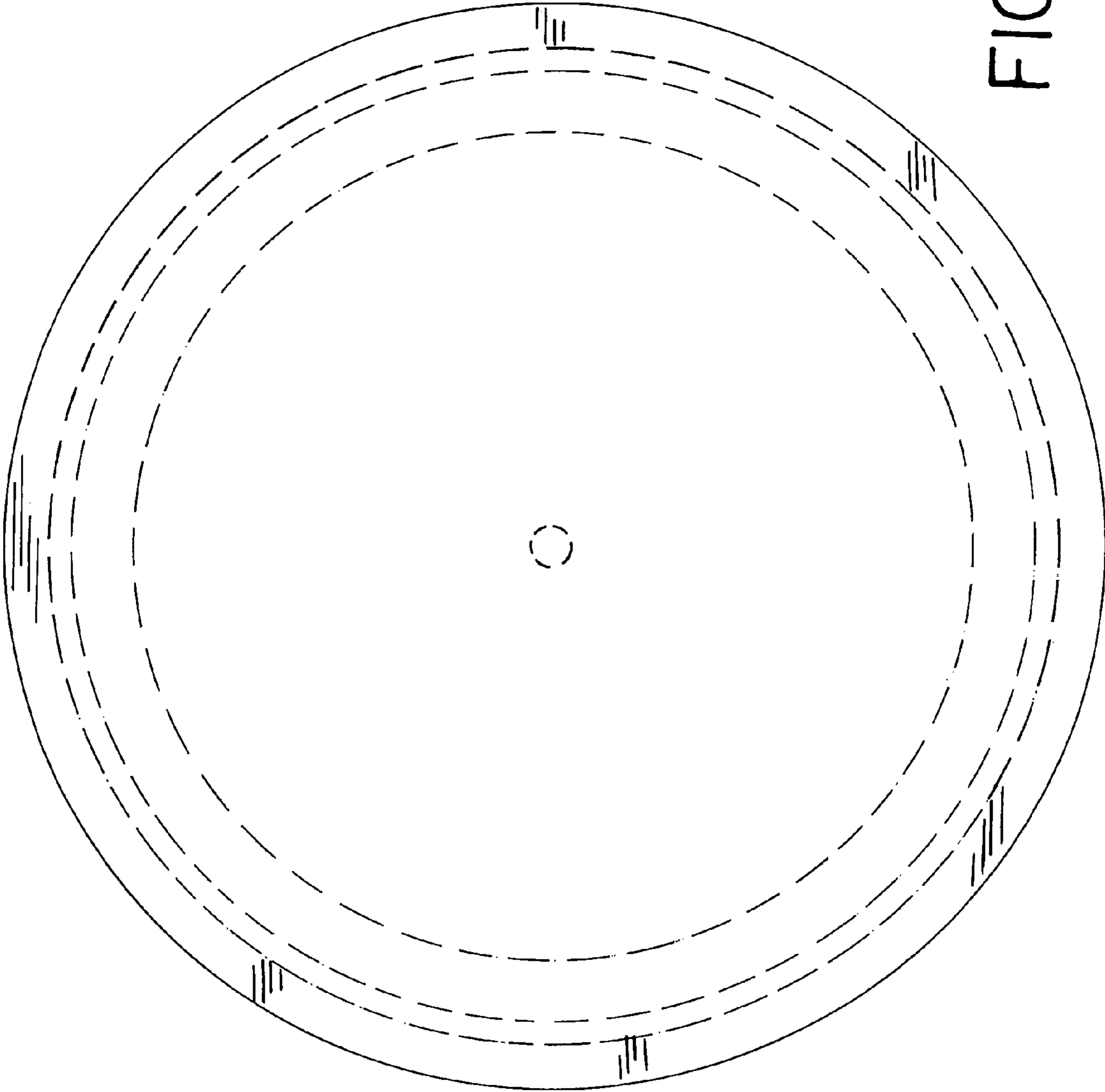
