DESCRIPTION

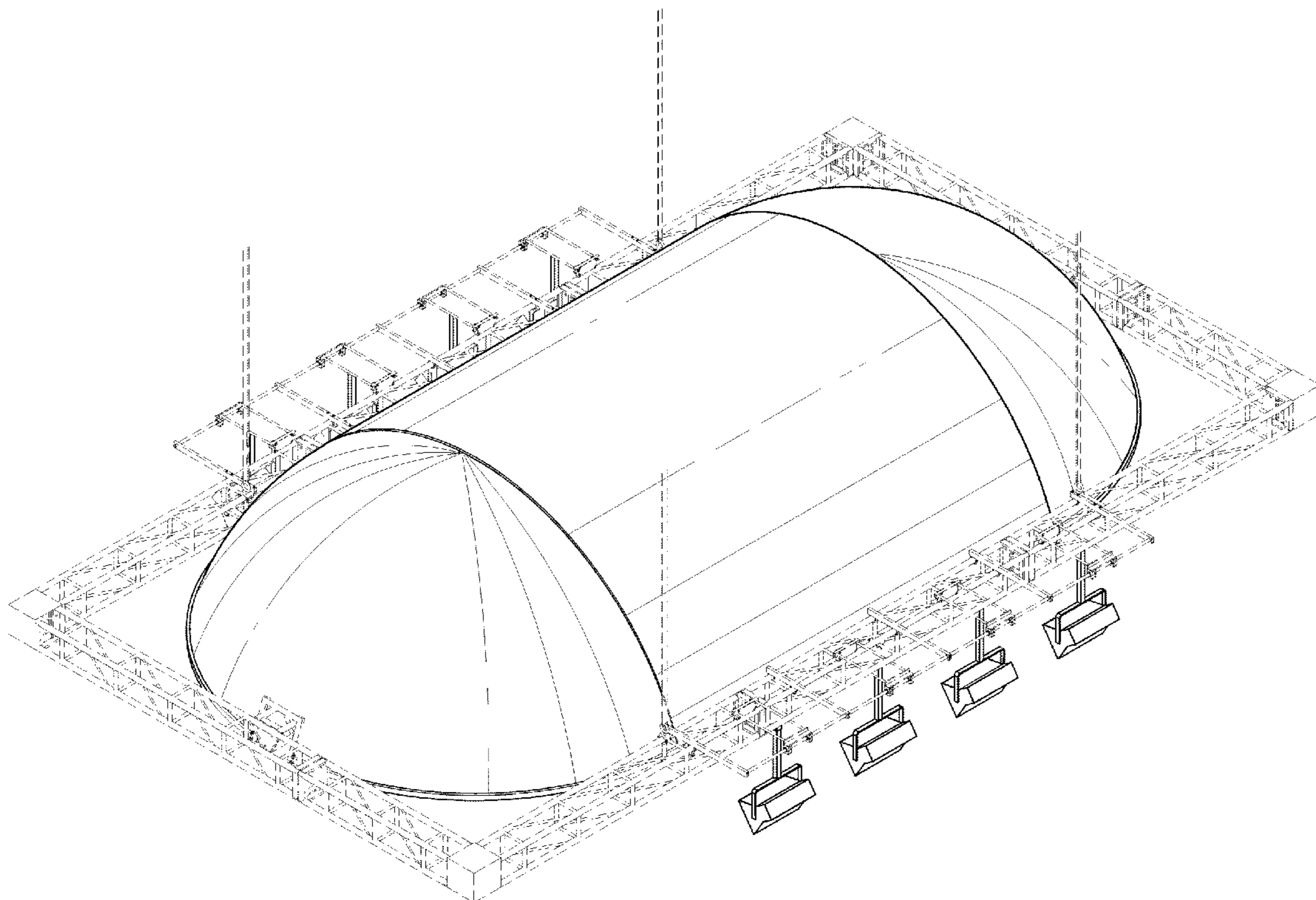
FIG. 1 is a perspective view of dome lighting assembly showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right side view thereof, the left side being a mirror image;
FIG. 5 is a front view thereof, the rear view being a mirror image;
FIG. 6 is a front sectional view taken along line 6-6 in FIG. 2; and,
FIG. 7 is a side sectional view taken along line 7-7 in FIG. 3.

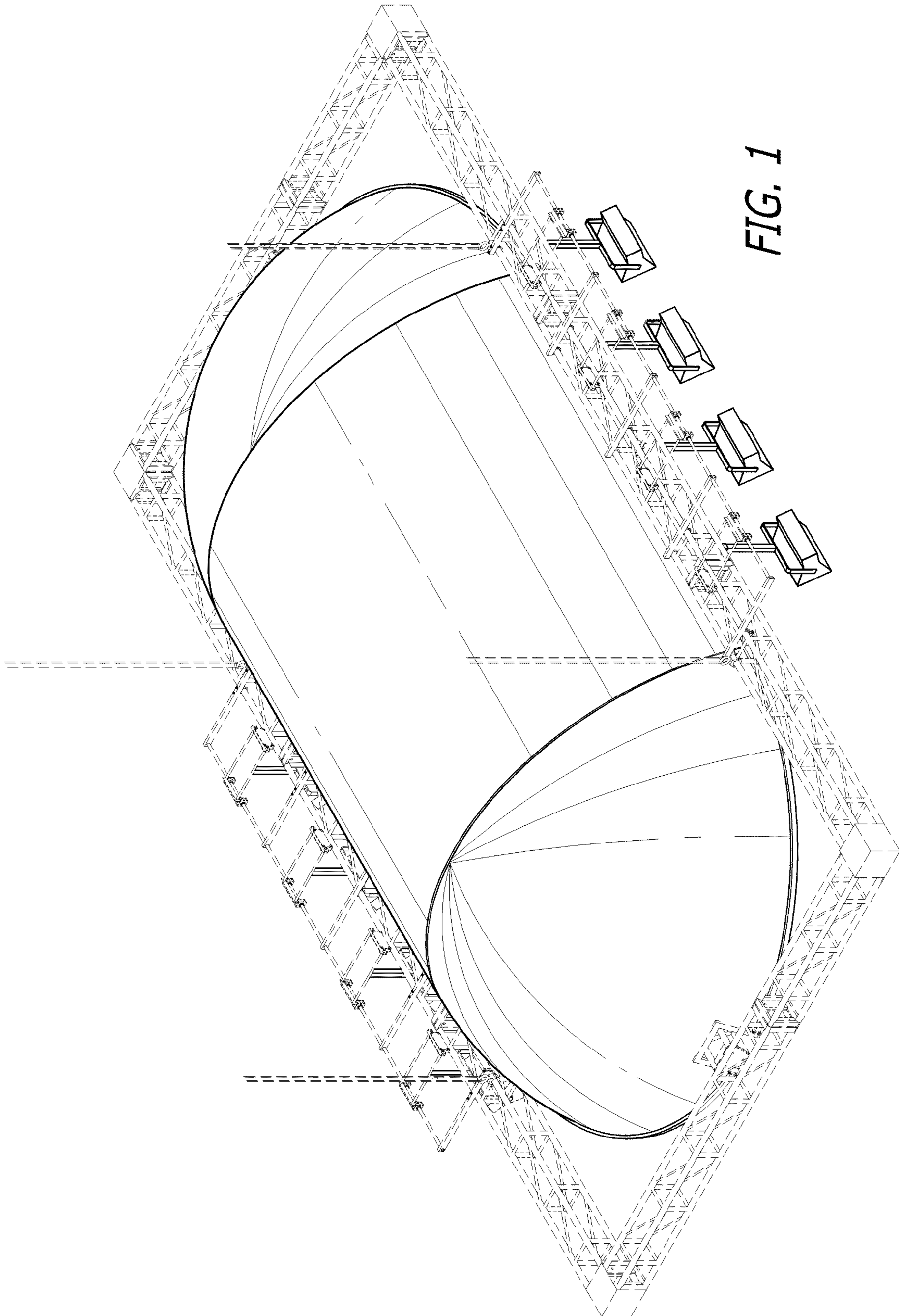

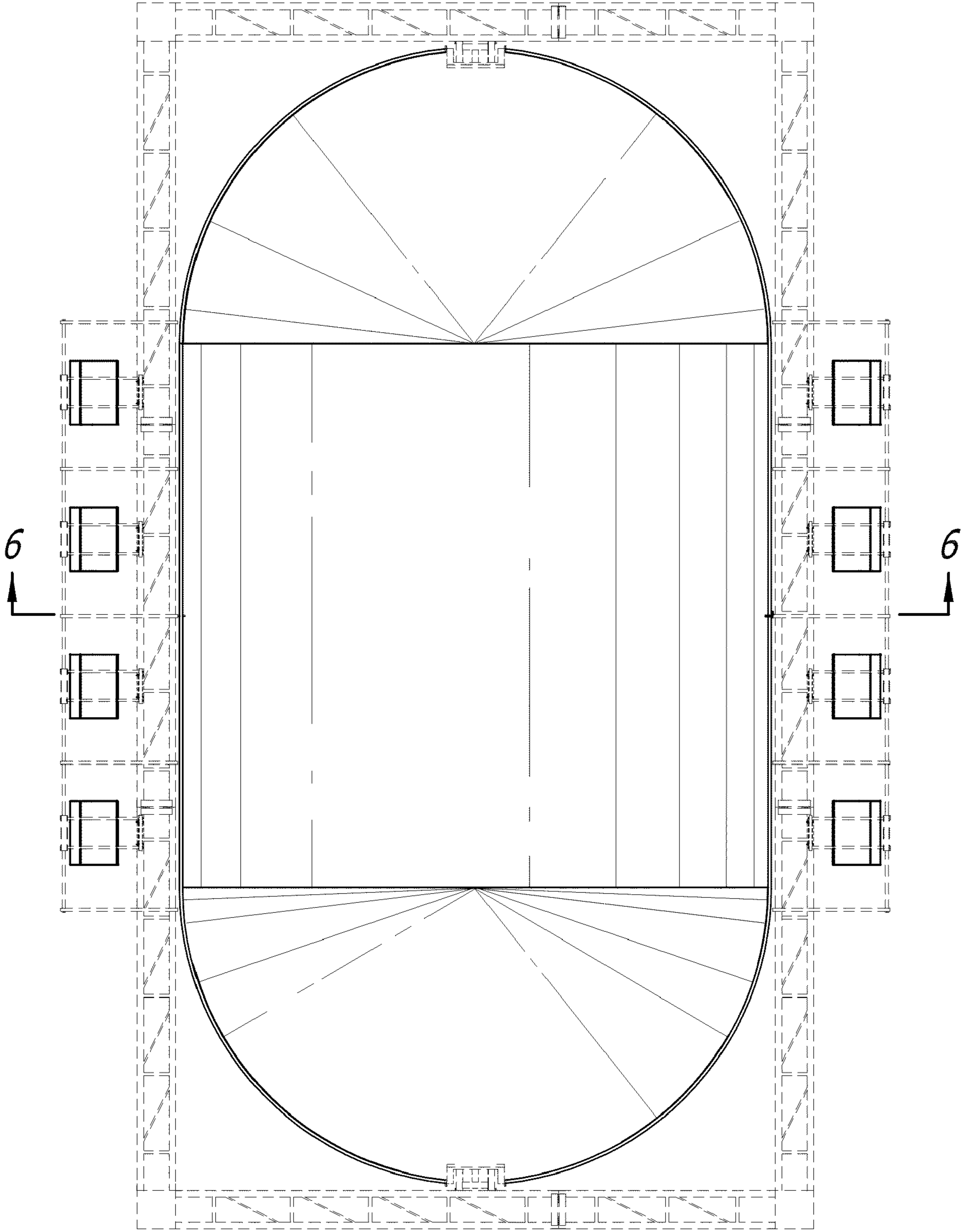

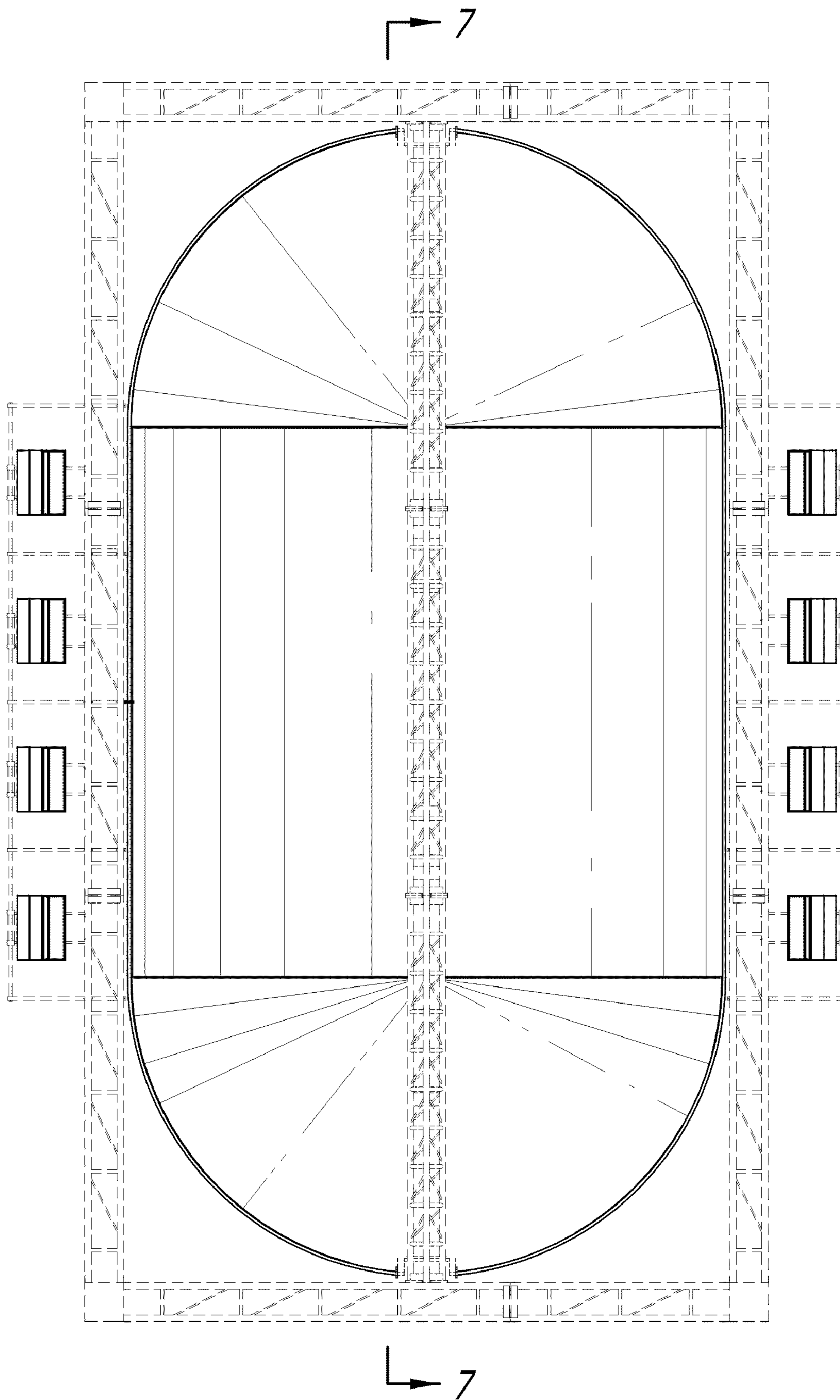

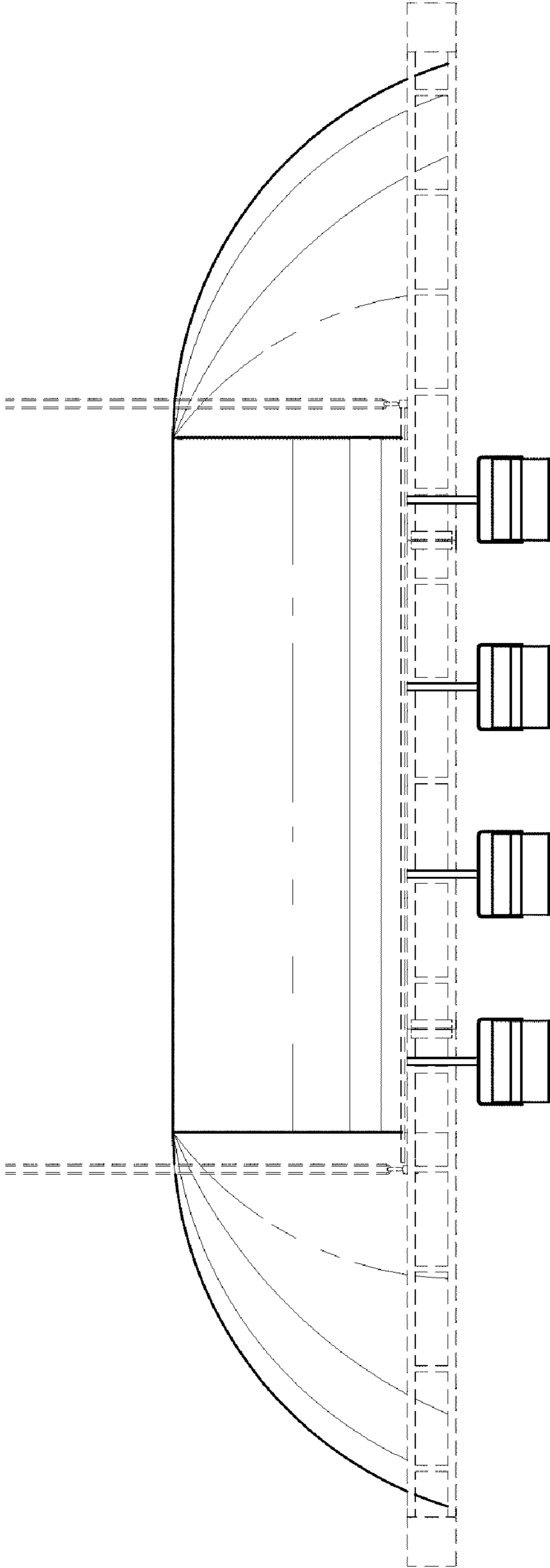

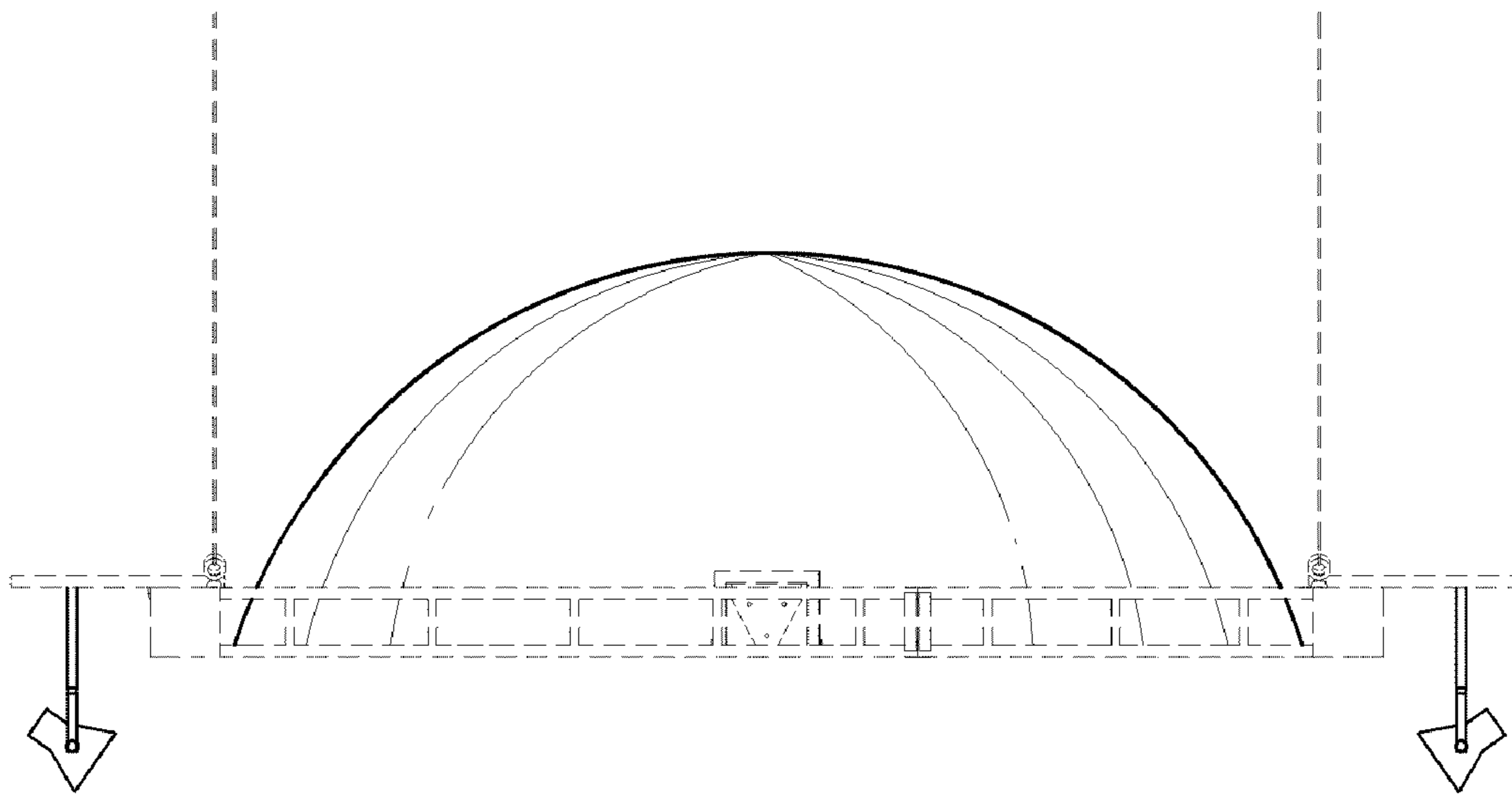

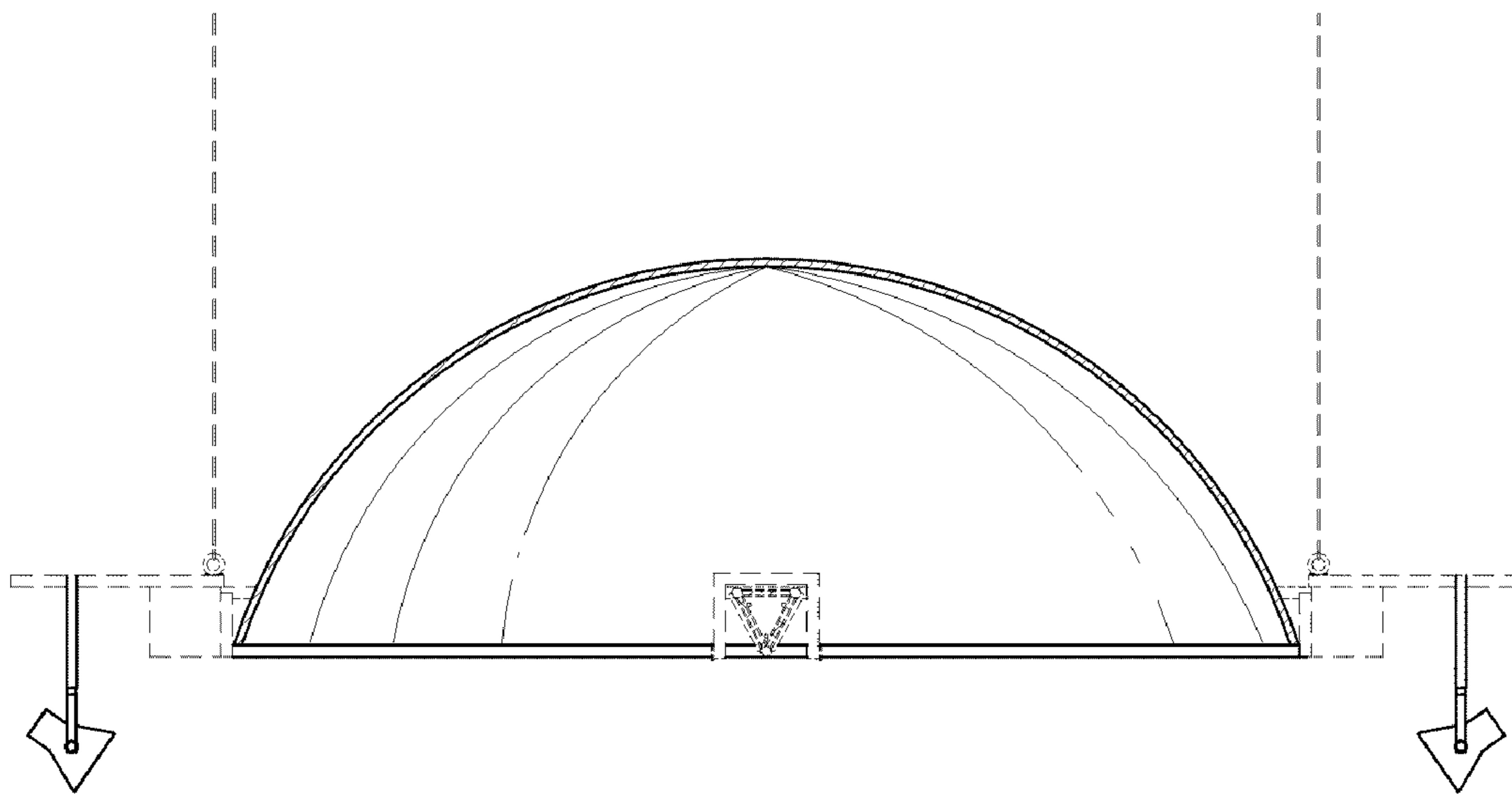

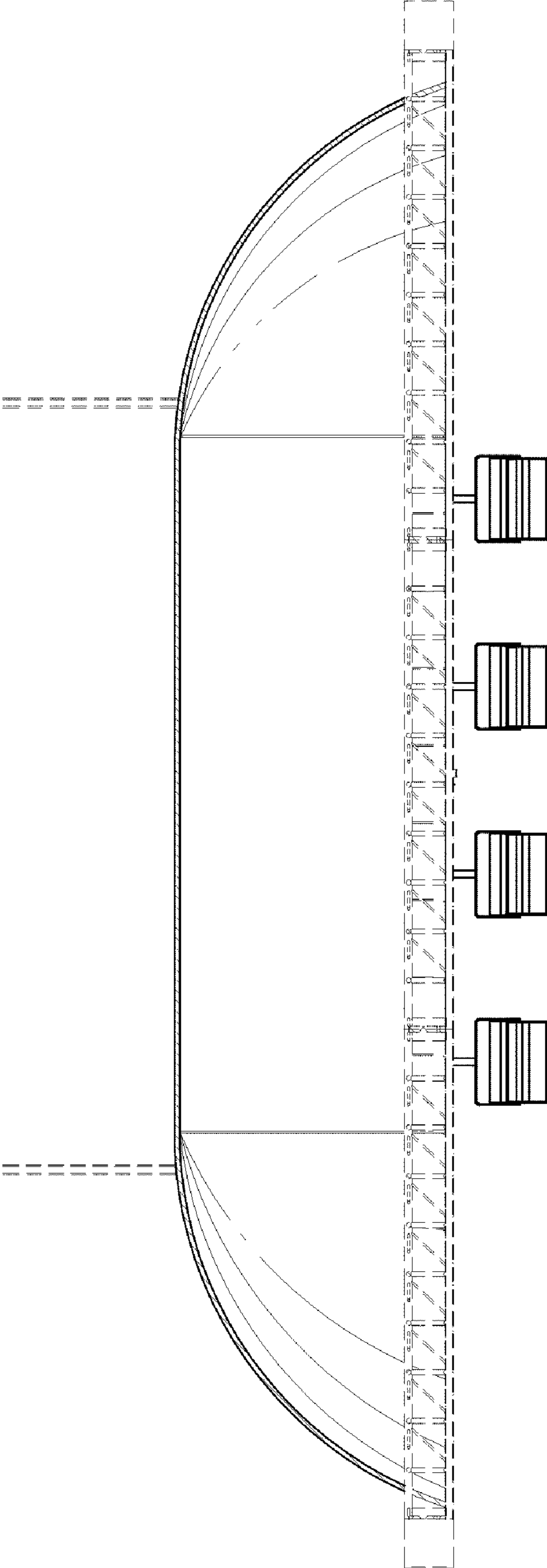
