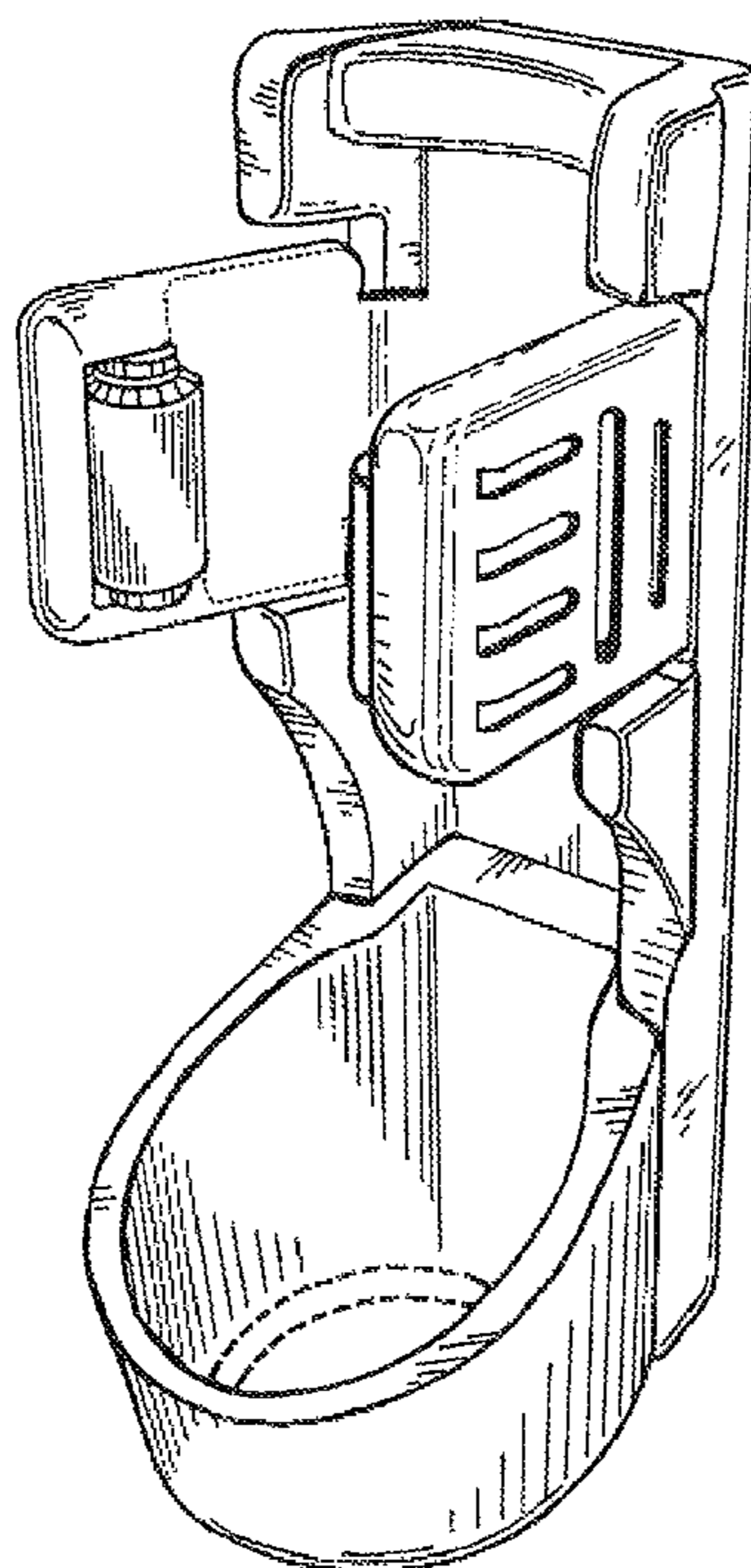
(57) **CLAIM**

The ornamental design for a holder for a flashlight or the like,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a holder for  
a flashlight or the like showing our new design;  
FIG. 2 is an enlarged front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof with the right side  
being a mirror image thereof; and,  
FIG. 5 is a top plan view thereof.  
The sections shown in broken lines show environmental  
structure only and form no part of the claimed design.  
The bottom view is not shown and forms no part of the  
claimed design.

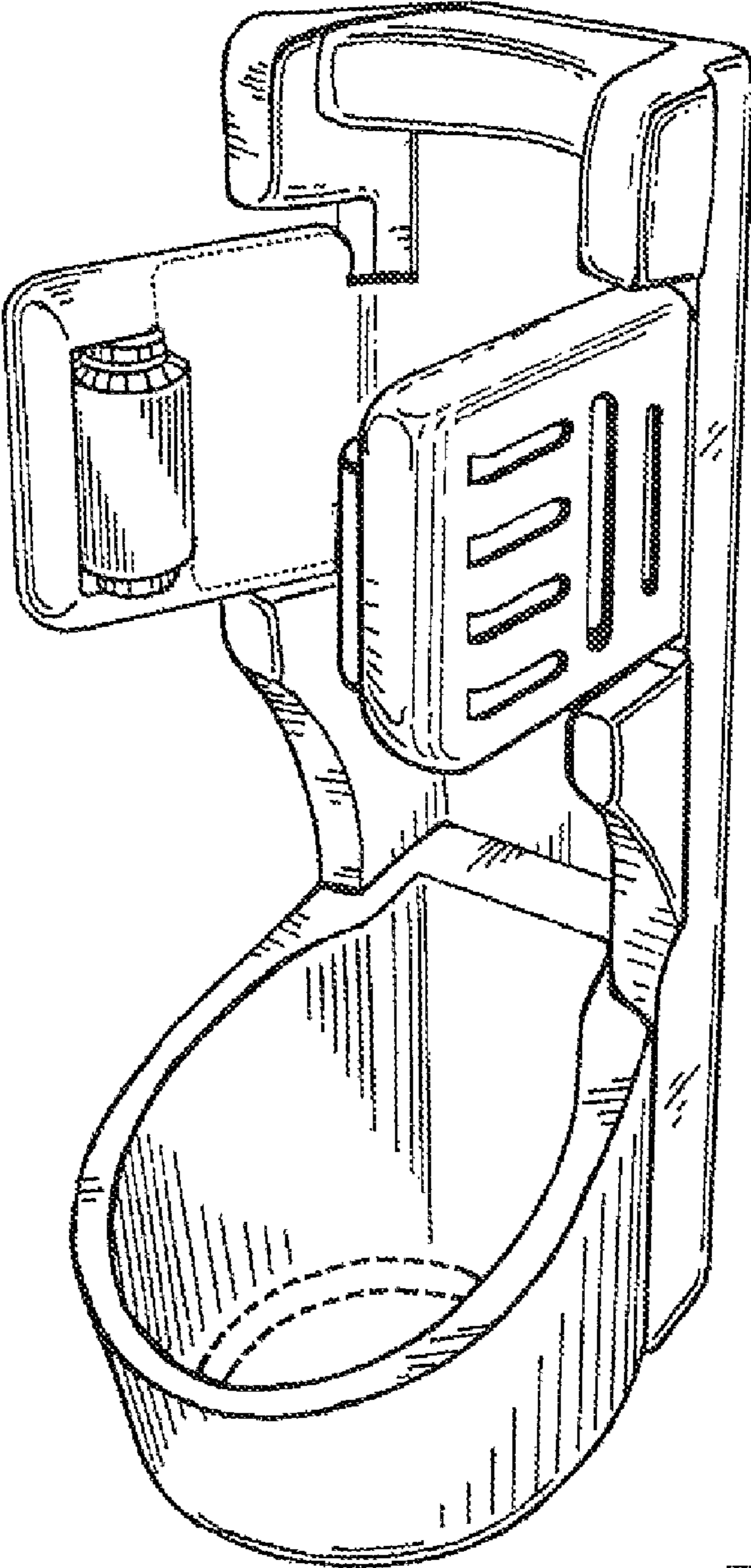

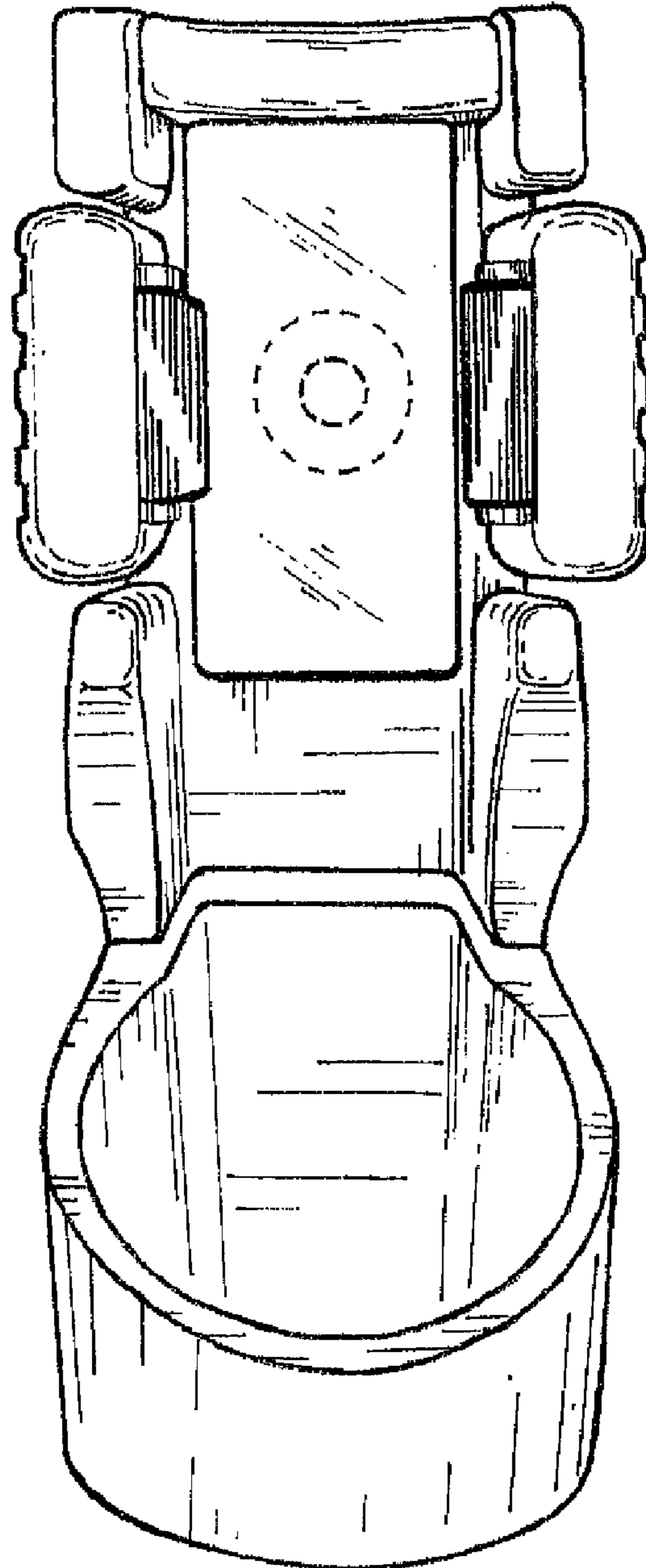

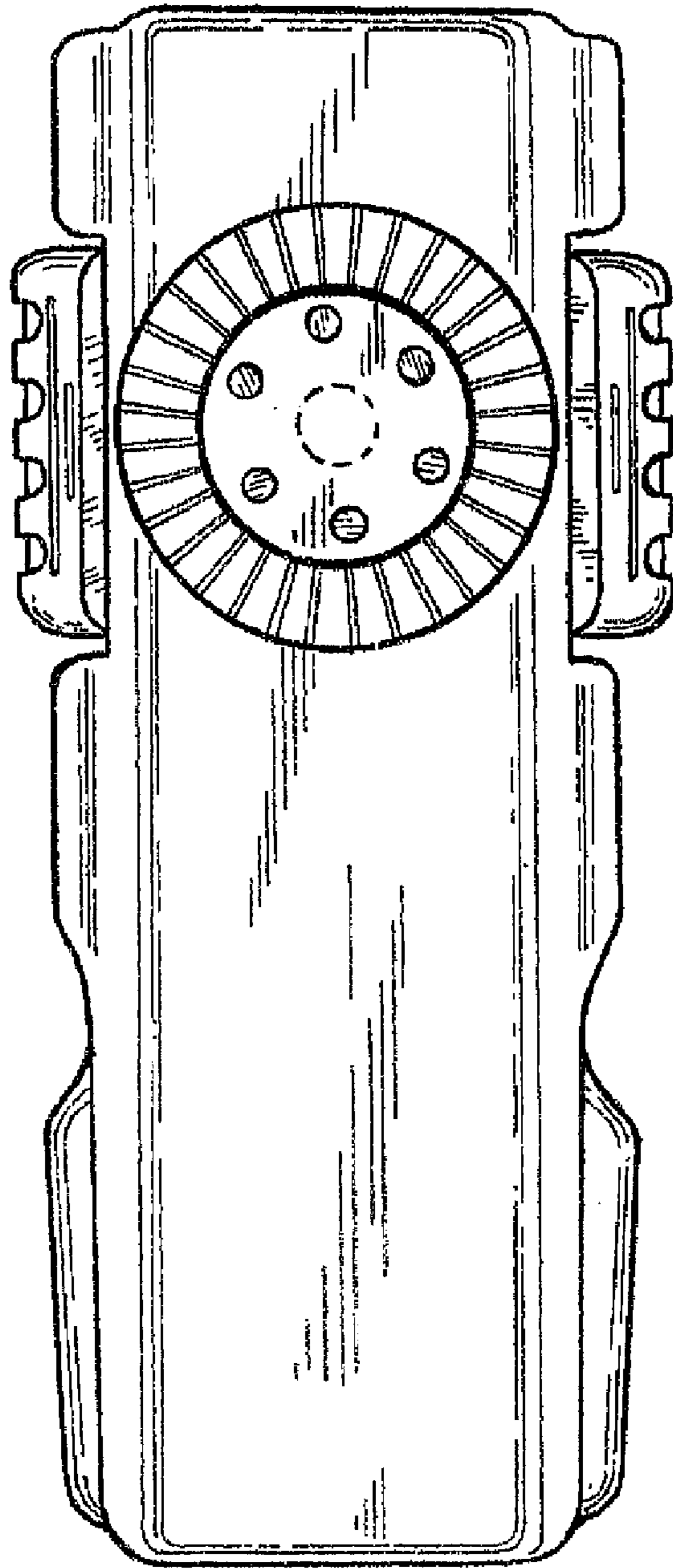

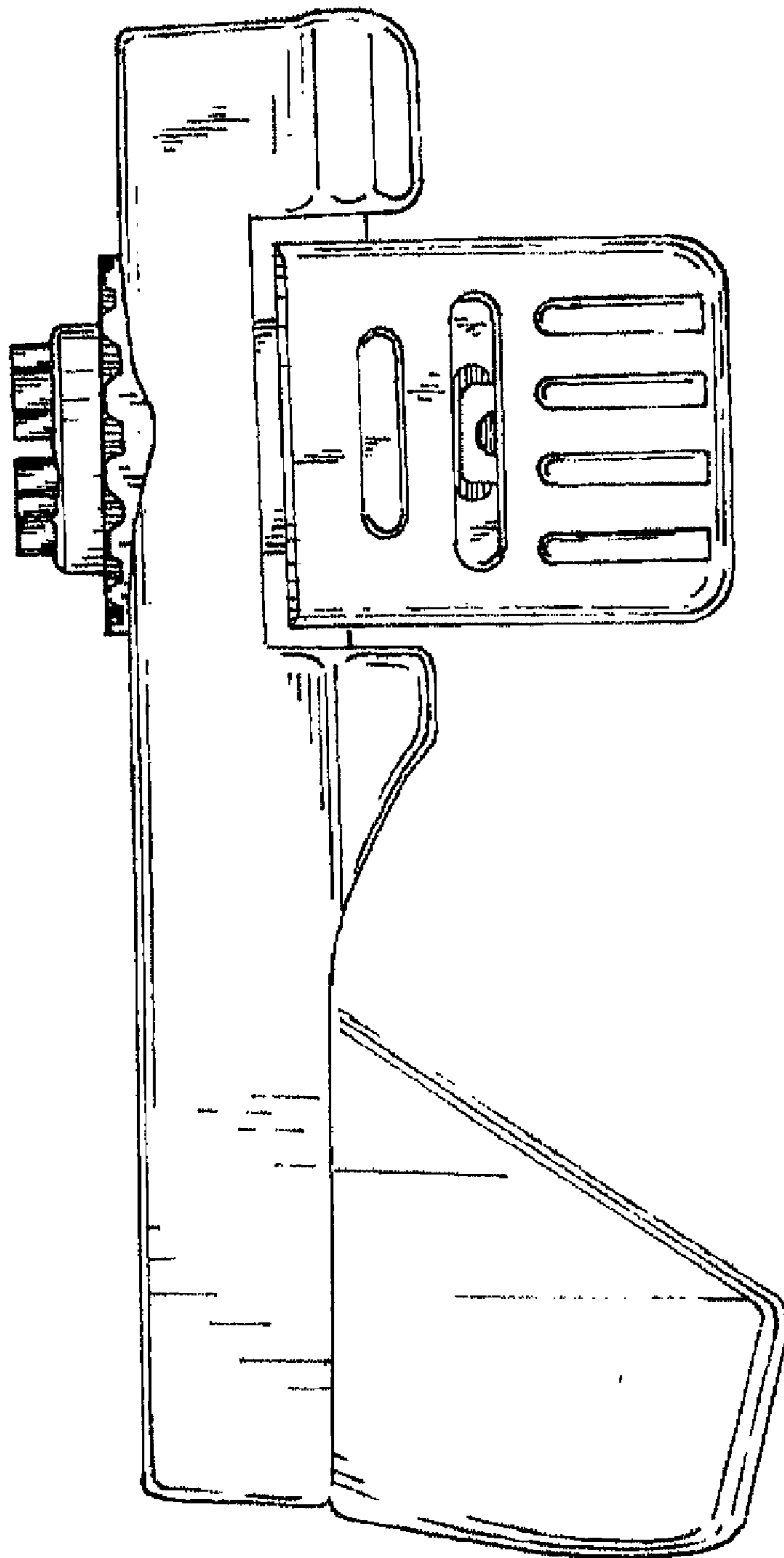

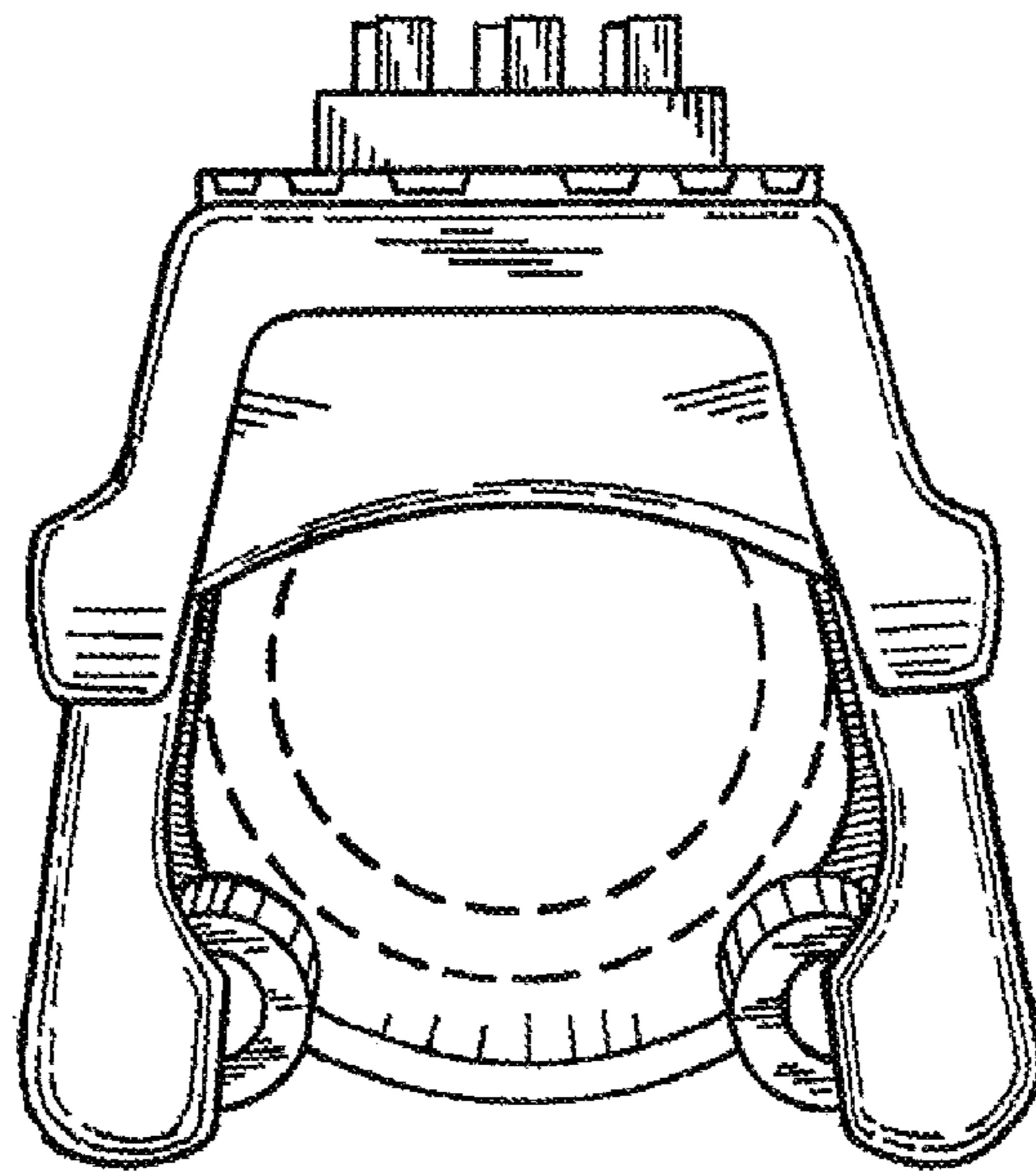
