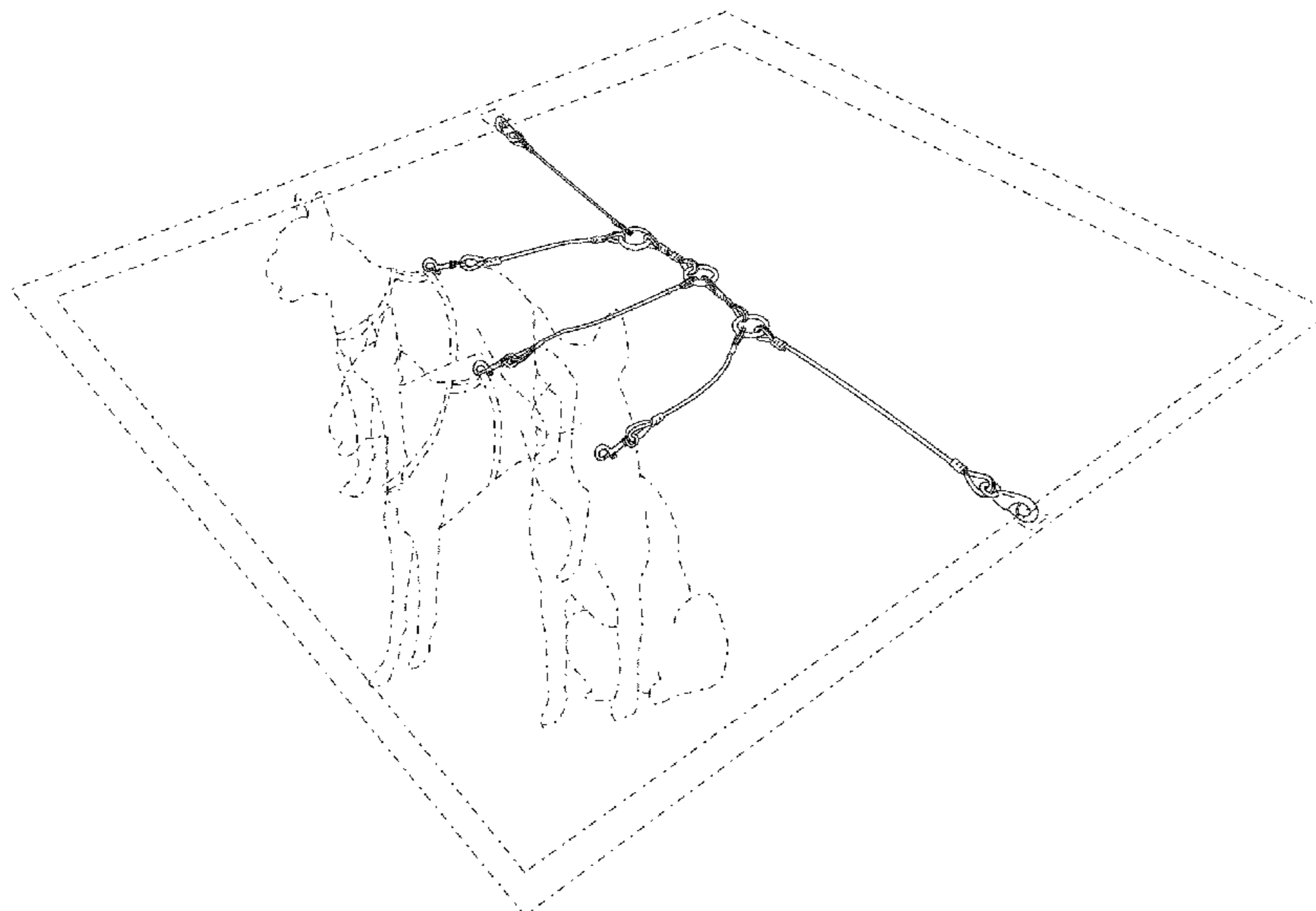
(57) **CLAIM**
The ornamental design for a cable dog harness, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of my new design for a cable dog harness;
 FIG. 2 is a top plan view of my new design for a cable dog harness;
 FIG. 3 is a bottom plan view of my new design for a cable dog harness;
 FIG. 4 is a rear elevation section view of my new design for a cable dog harness;
 FIG. 5 is a rear elevation section view, a continuation from FIG. 4, of my new design for a cable dog harness;
 FIG. 6 is a front elevation view of my new design for a cable dog harness;
 FIG. 7 is a front elevation section view, a continuation from FIG. 6, of my new design for a cable dog harness; and,
 FIG. 8 is a right side elevation view of my new design for a cable dog harness, the left side elevation view being a mirror image thereof.

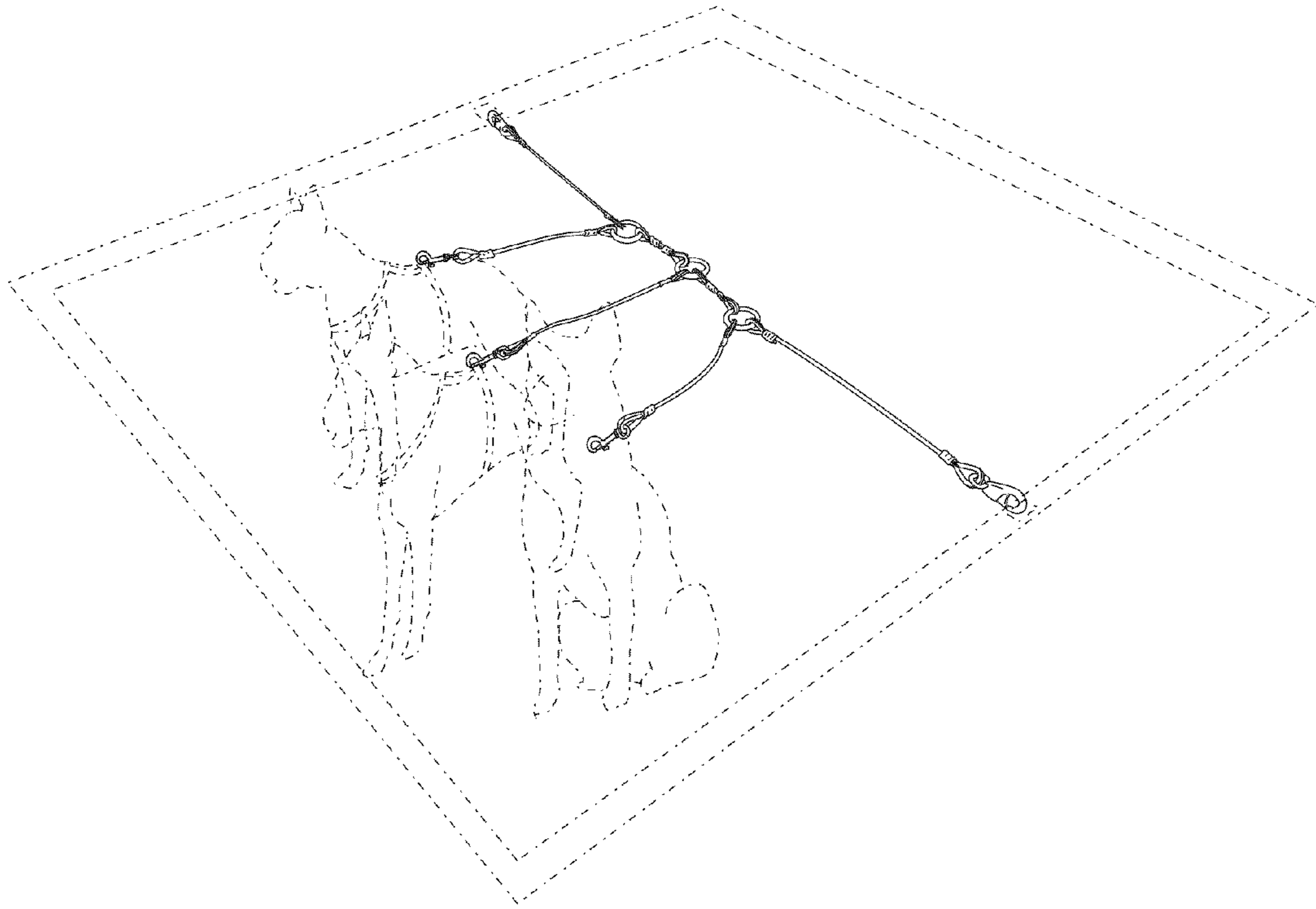

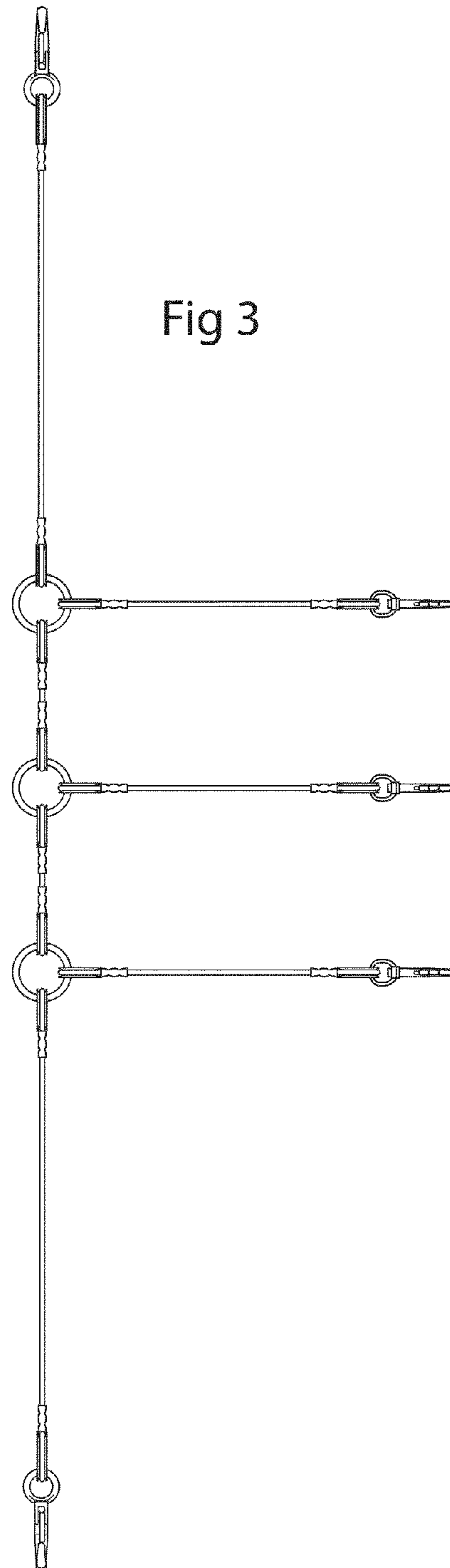
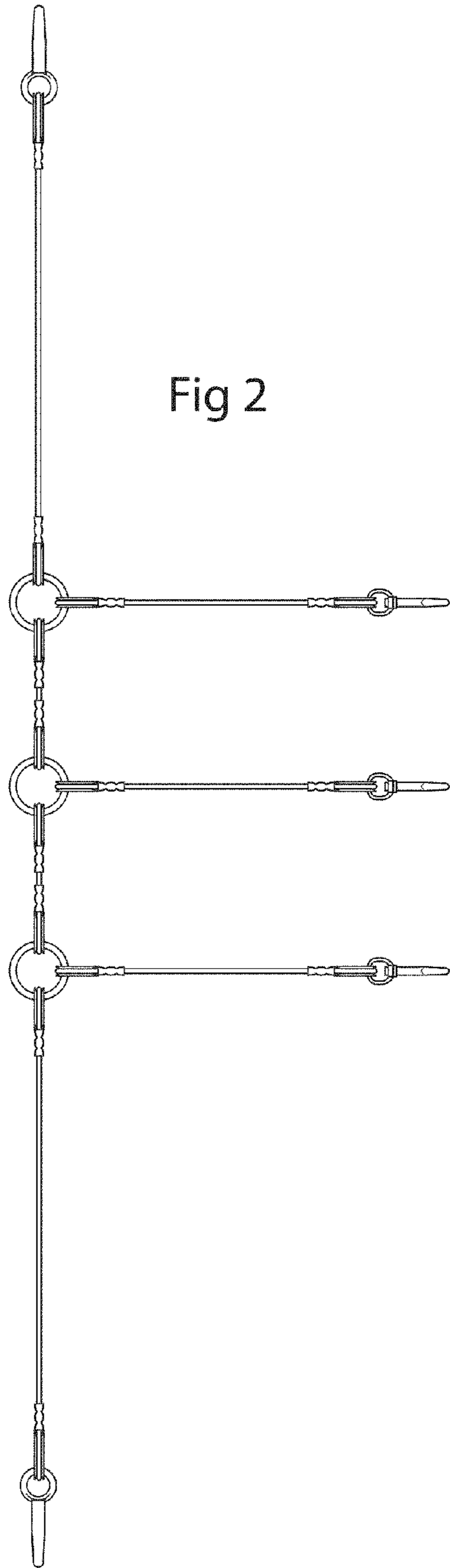

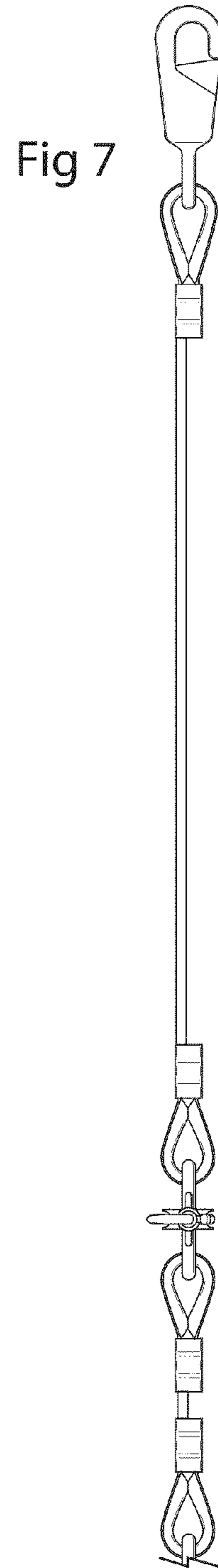
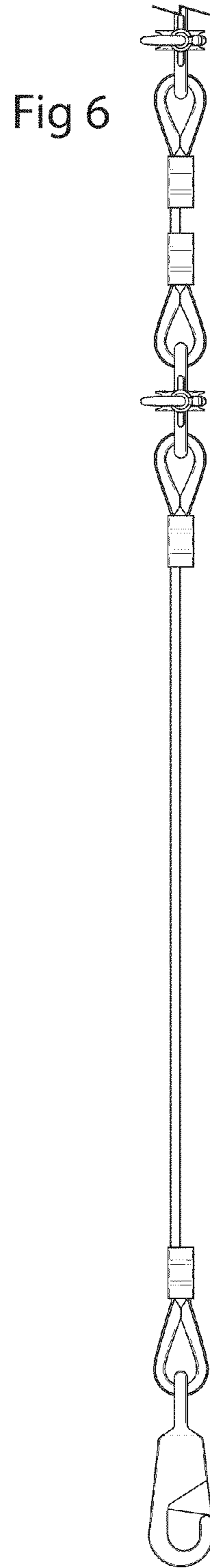
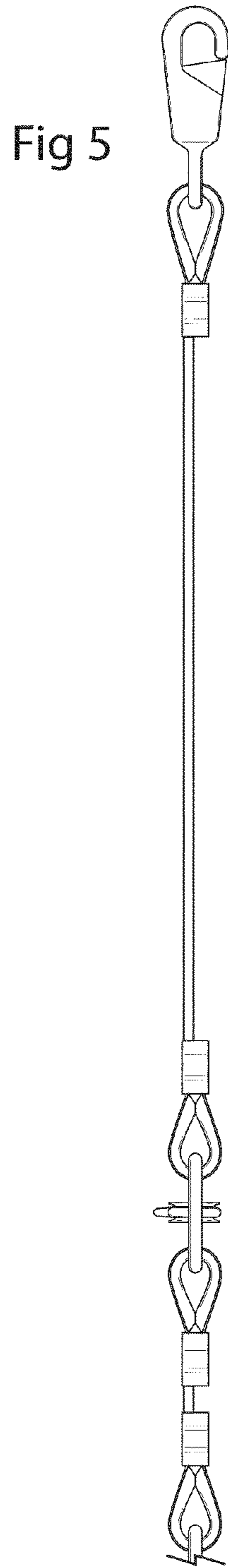
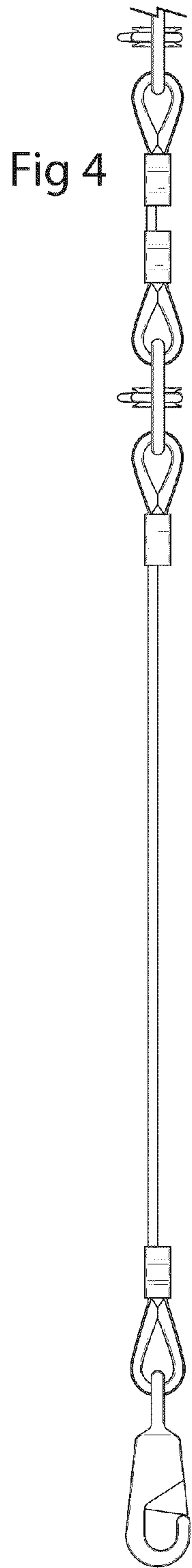

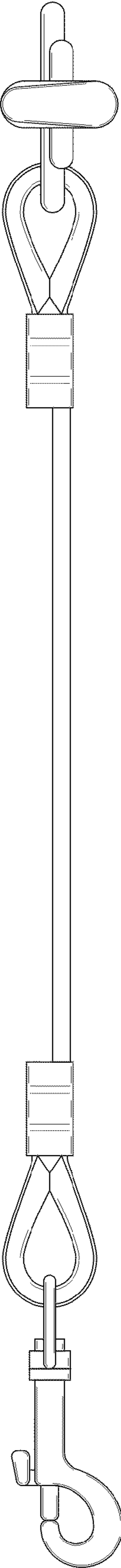
