I claim the ornamental design for a handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an inventive handle with a lid and a handle shown in broken lines.

FIG. 2 is another perspective view of the handle of FIG. 1.

FIG. 3 is a front view of the handle of FIG. 1, which is identical to the opposite side.

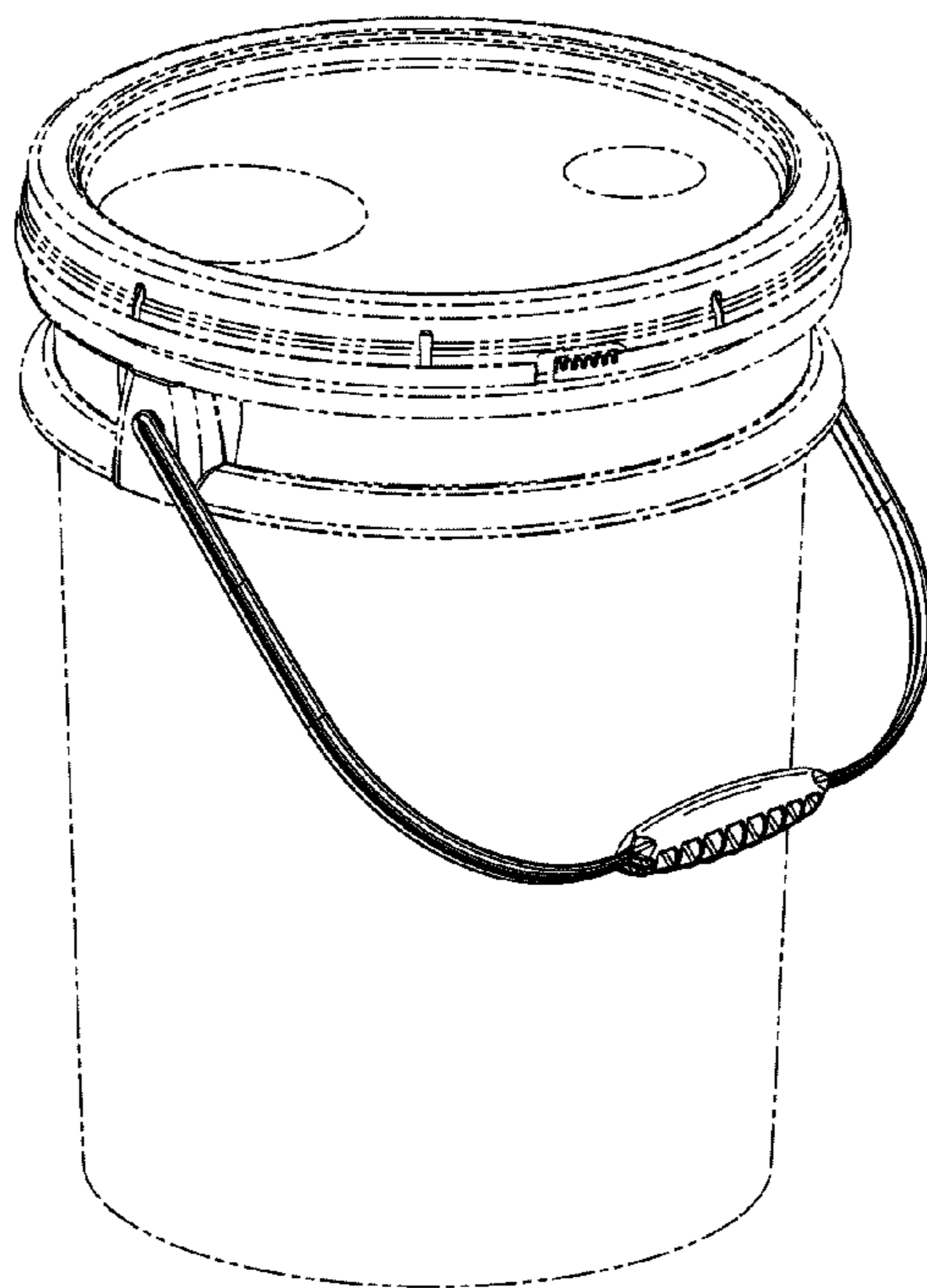
FIG. 4 is a top view of the handle of FIG. 1.

FIG. 5 is a side view of the handle of FIG. 1, which is identical to the opposite side; and,

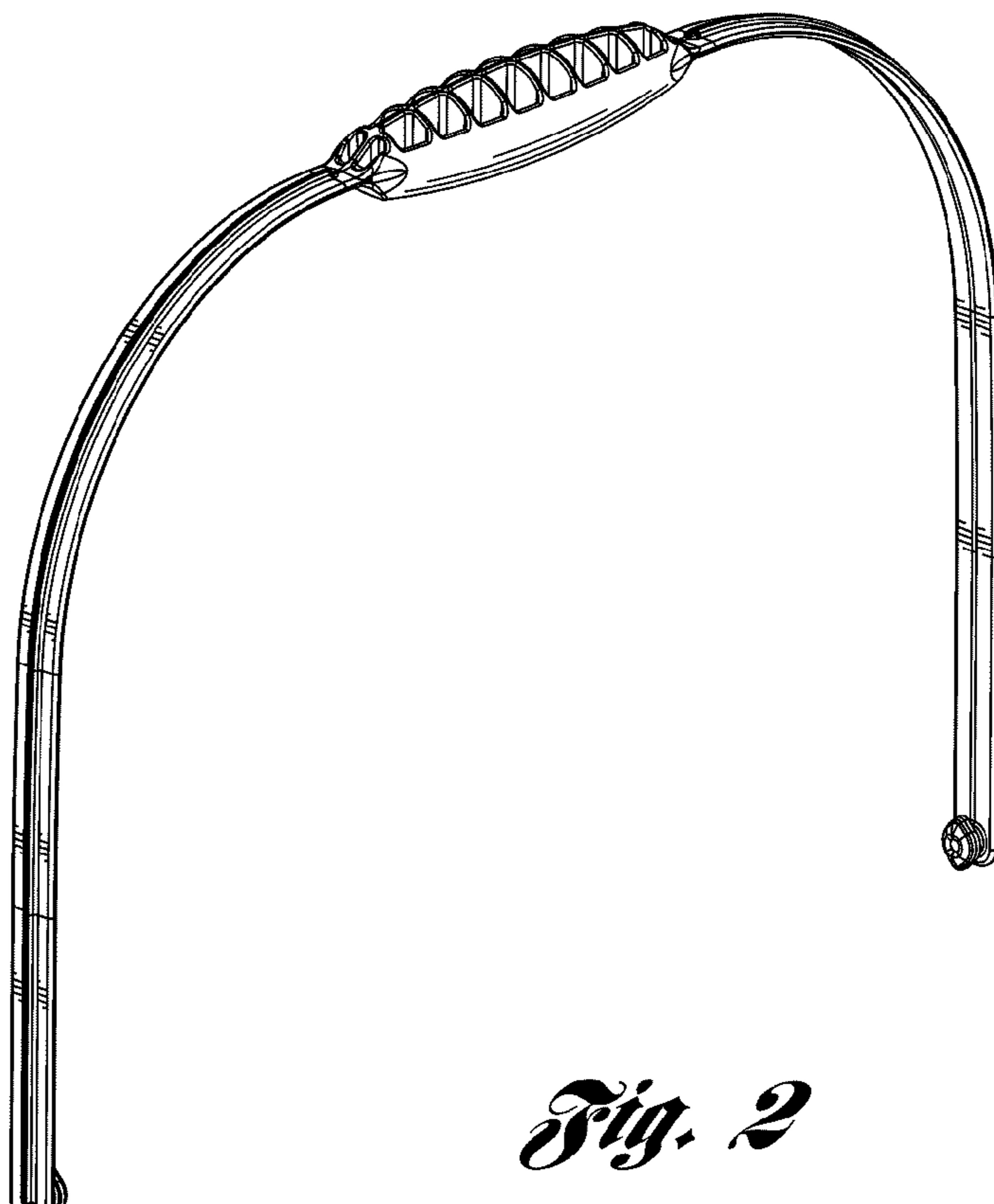
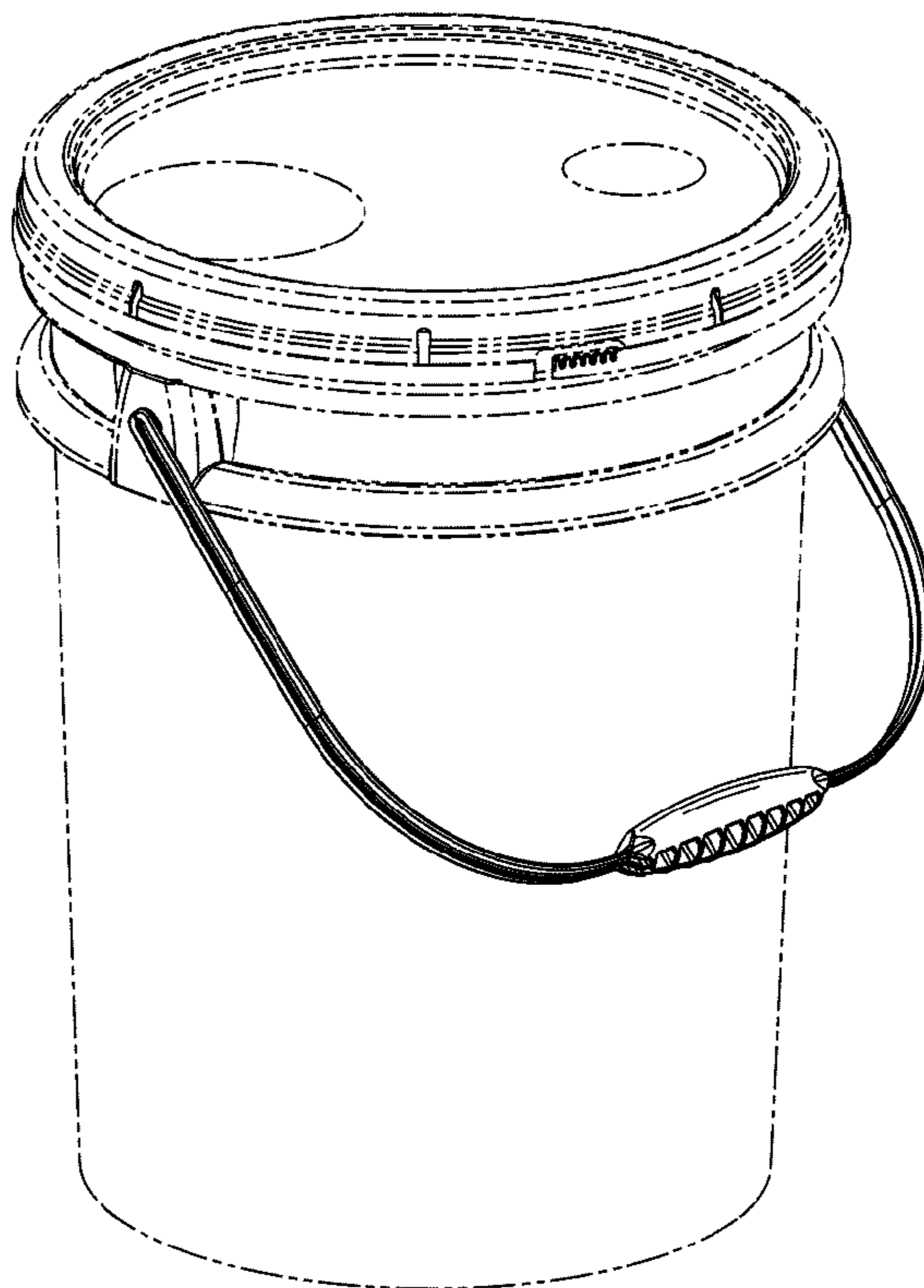
FIG. 6 is a bottom view of the handle of FIG. 1.

The broken lines shown herein are for illustrative purposes only and form no part of the claimed design.

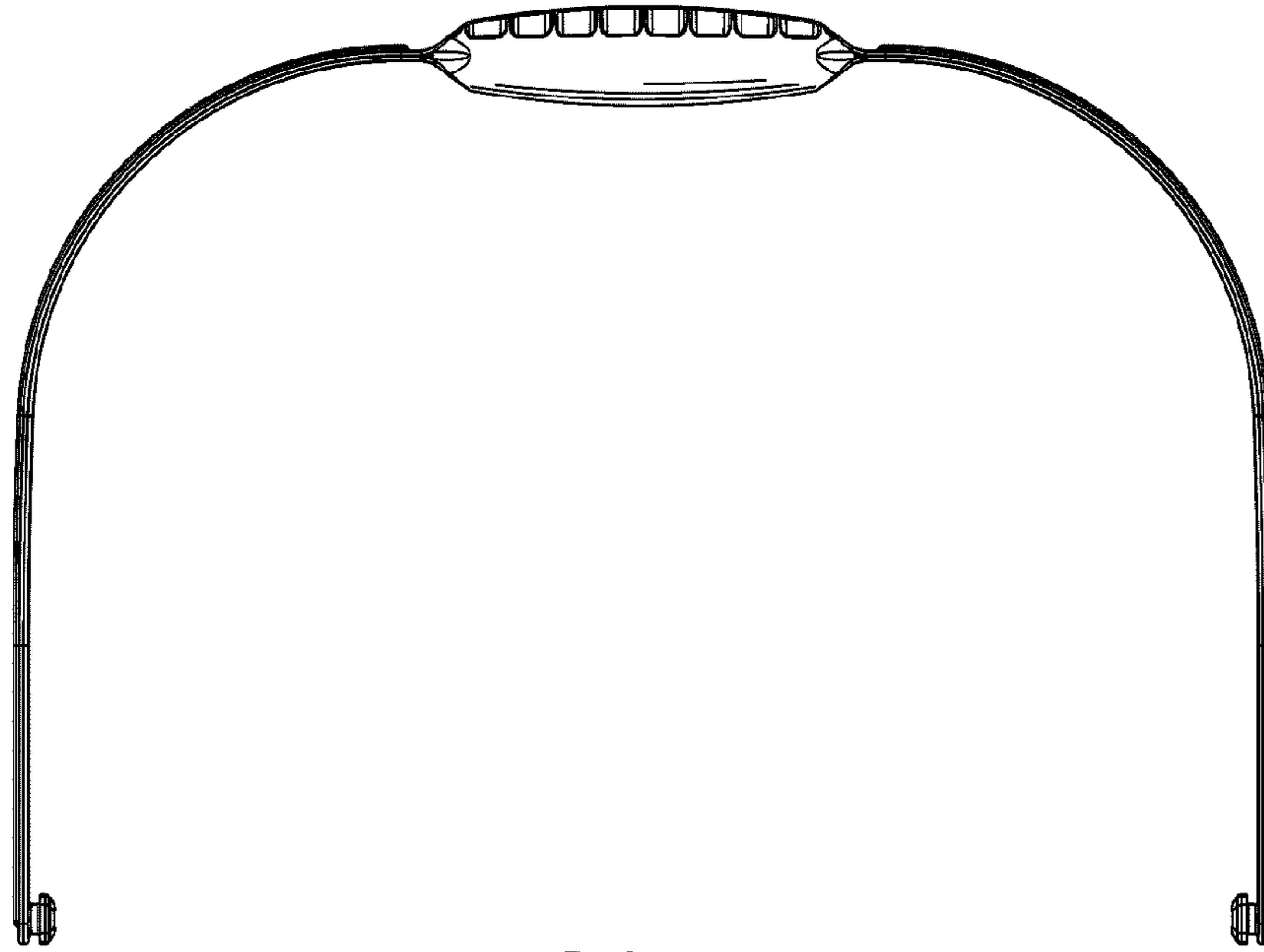

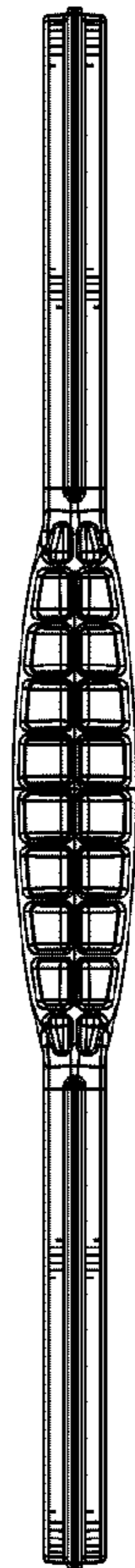

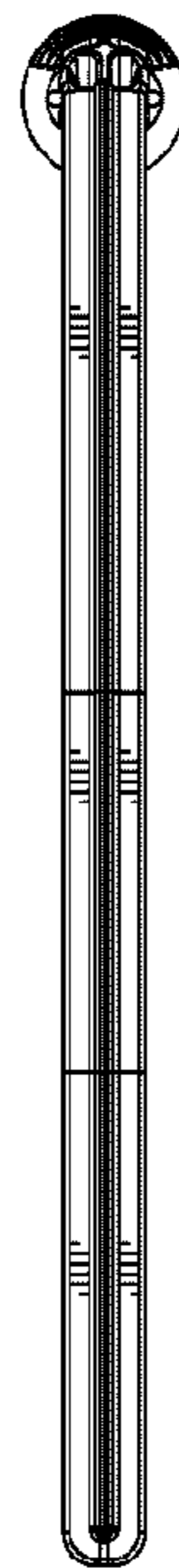
