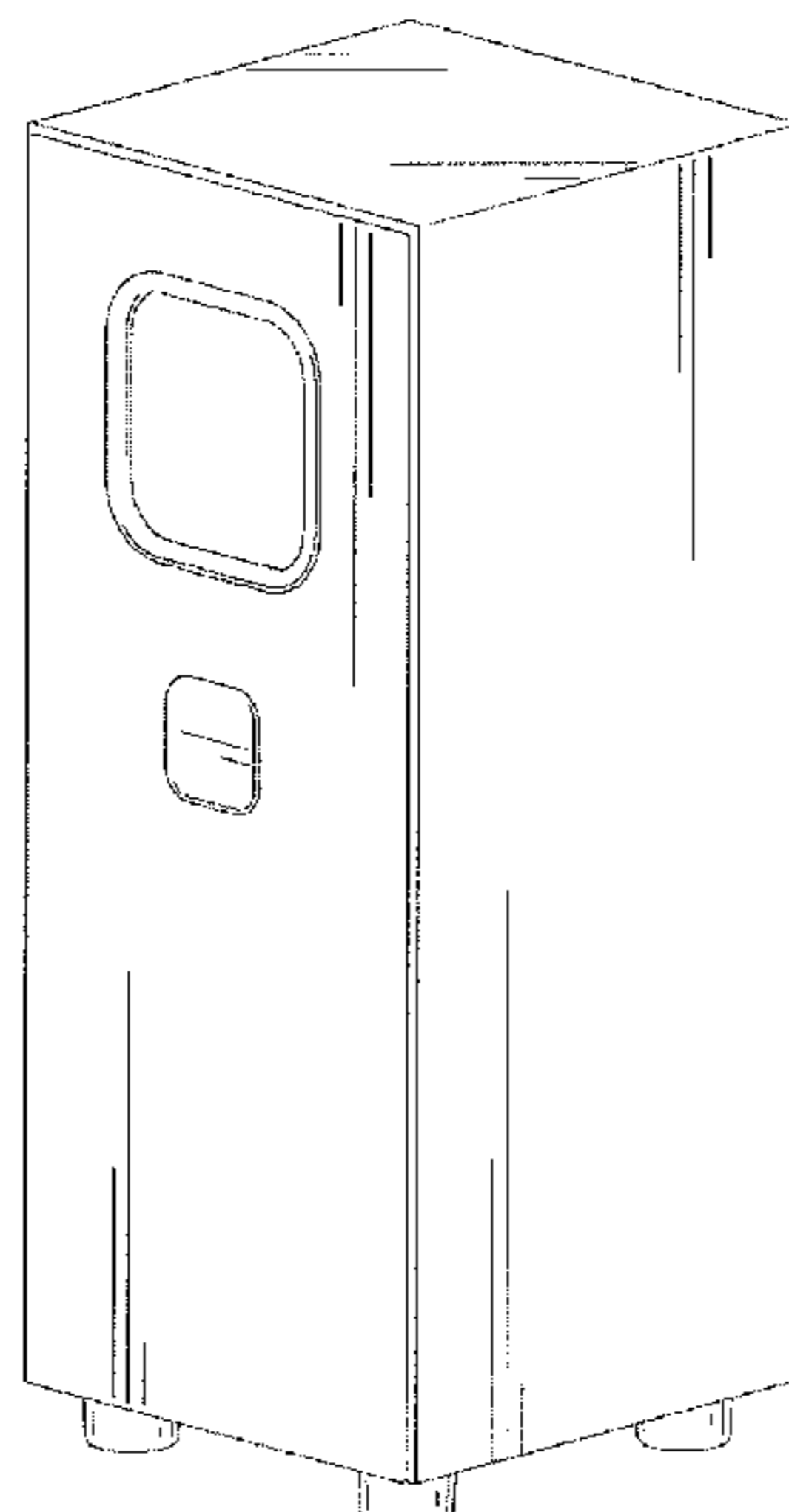
(57) **CLAIM**

The ornamental design for a recycling receptacle, as shown and described.

DESCRIPTION

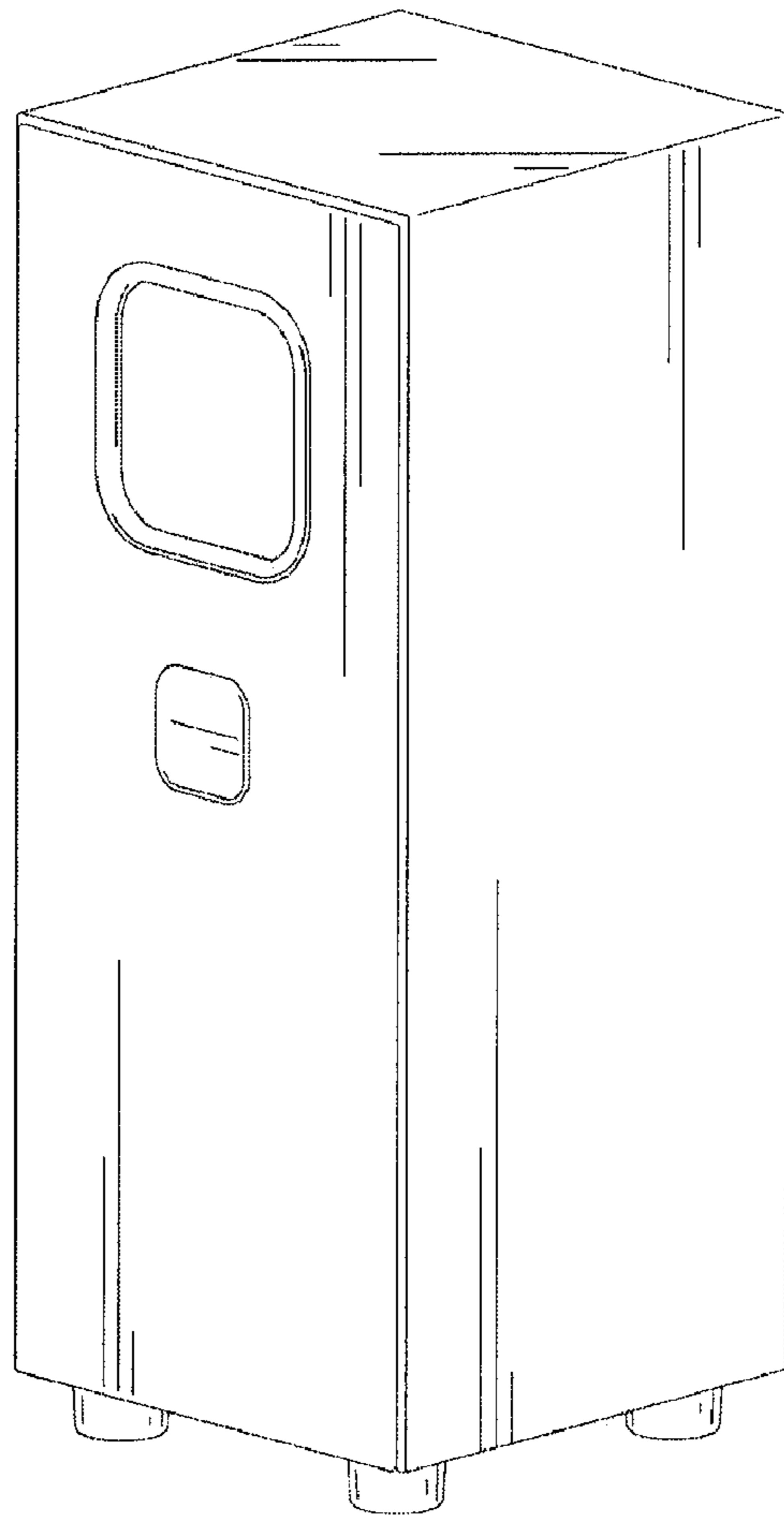

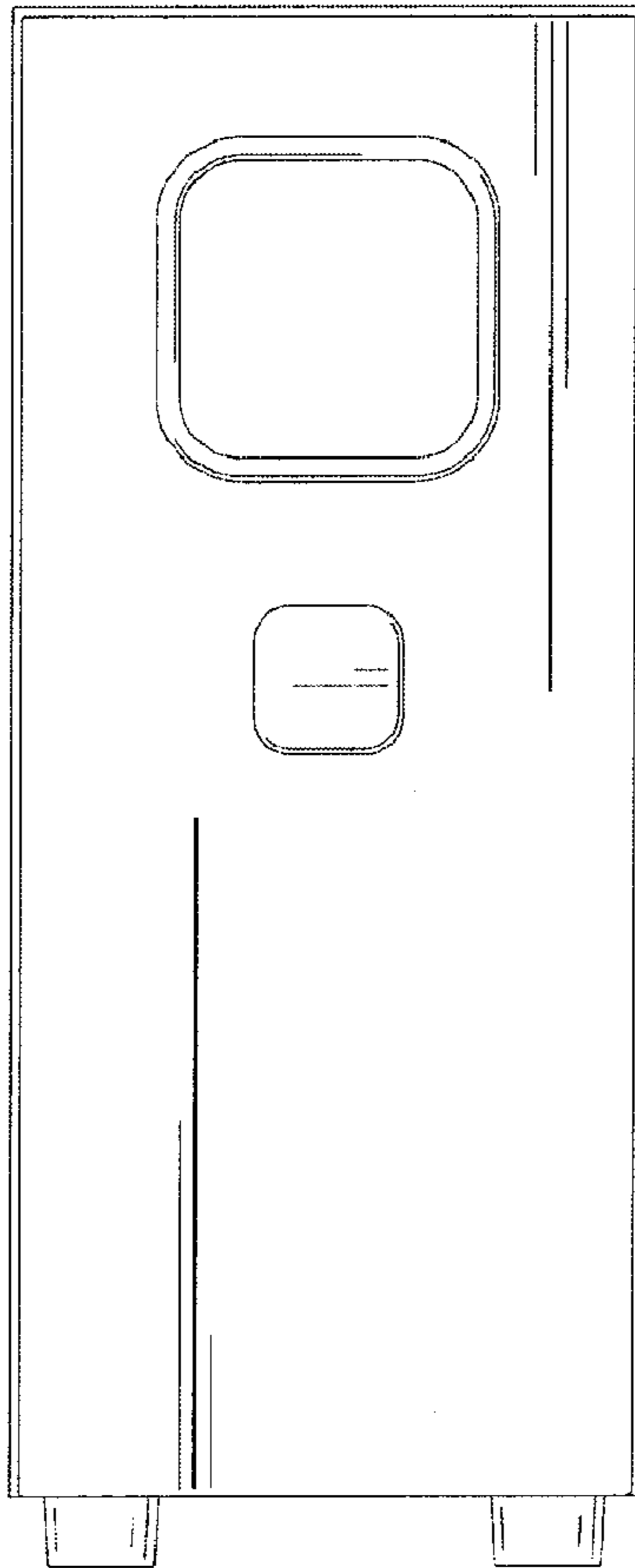

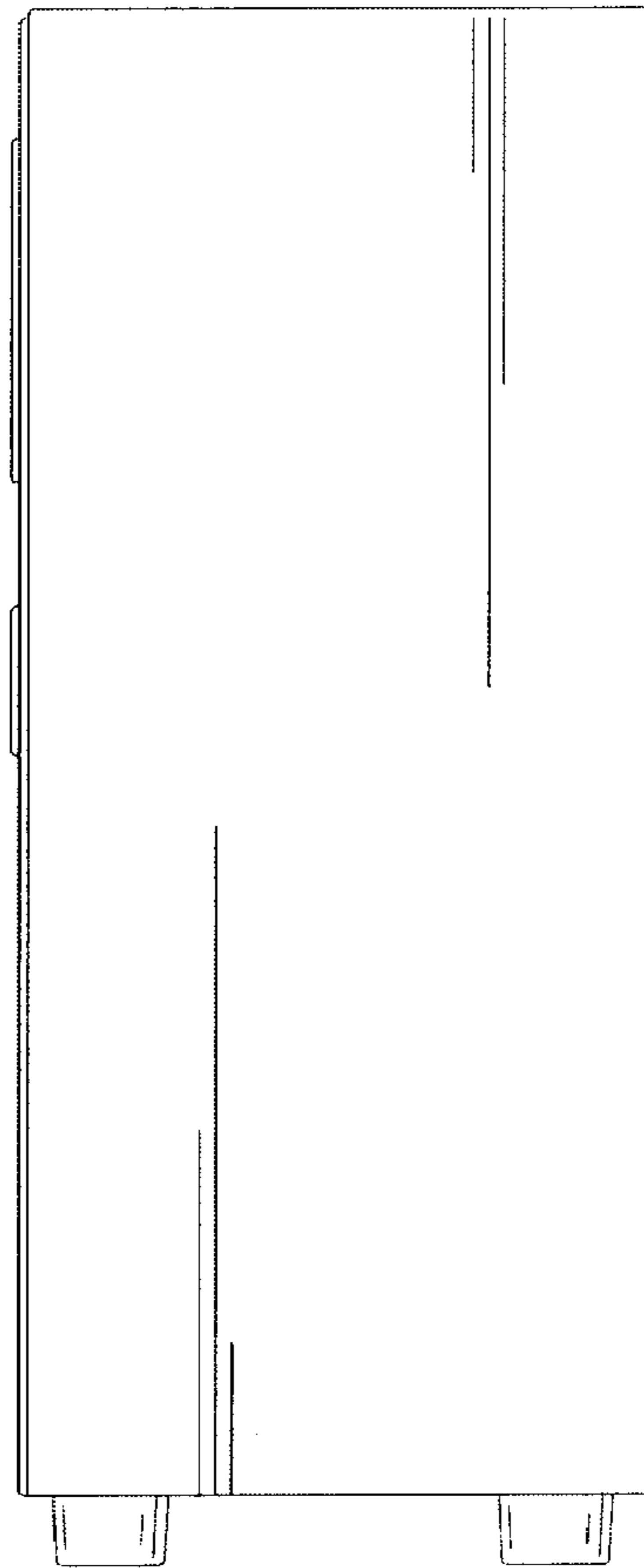

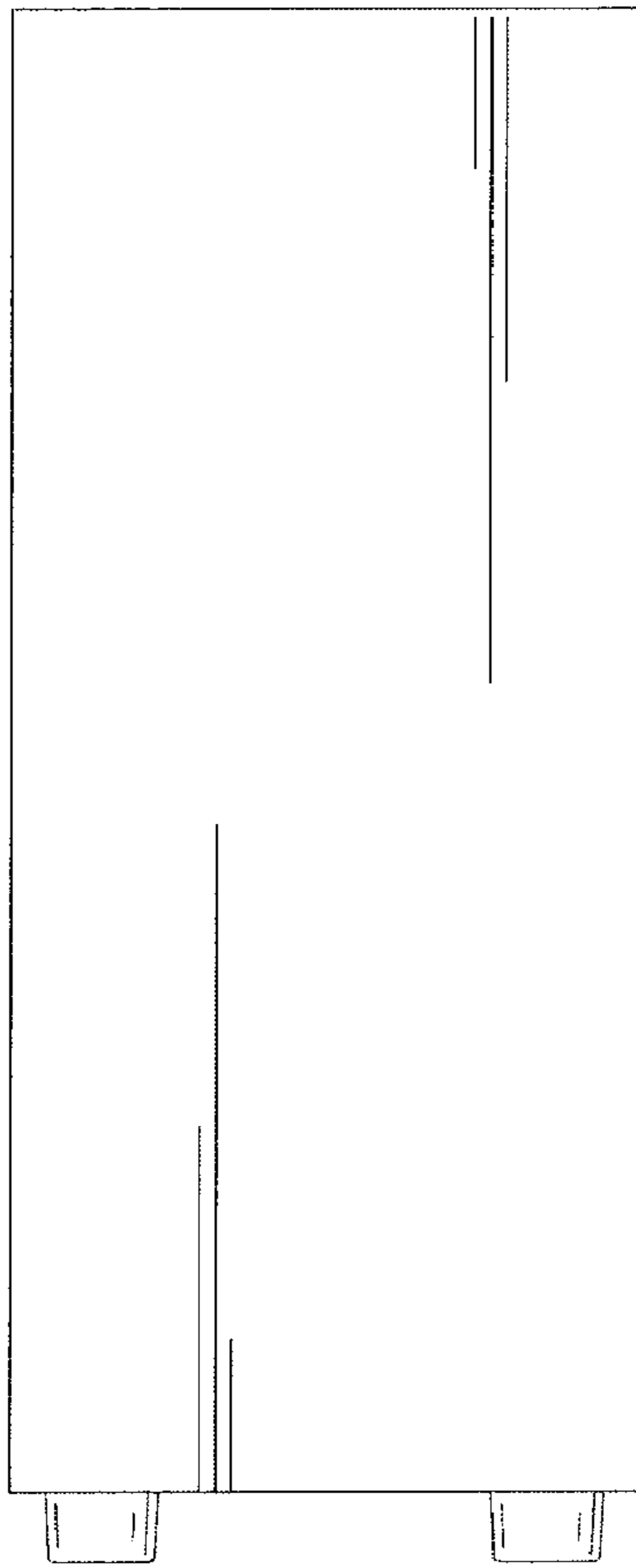

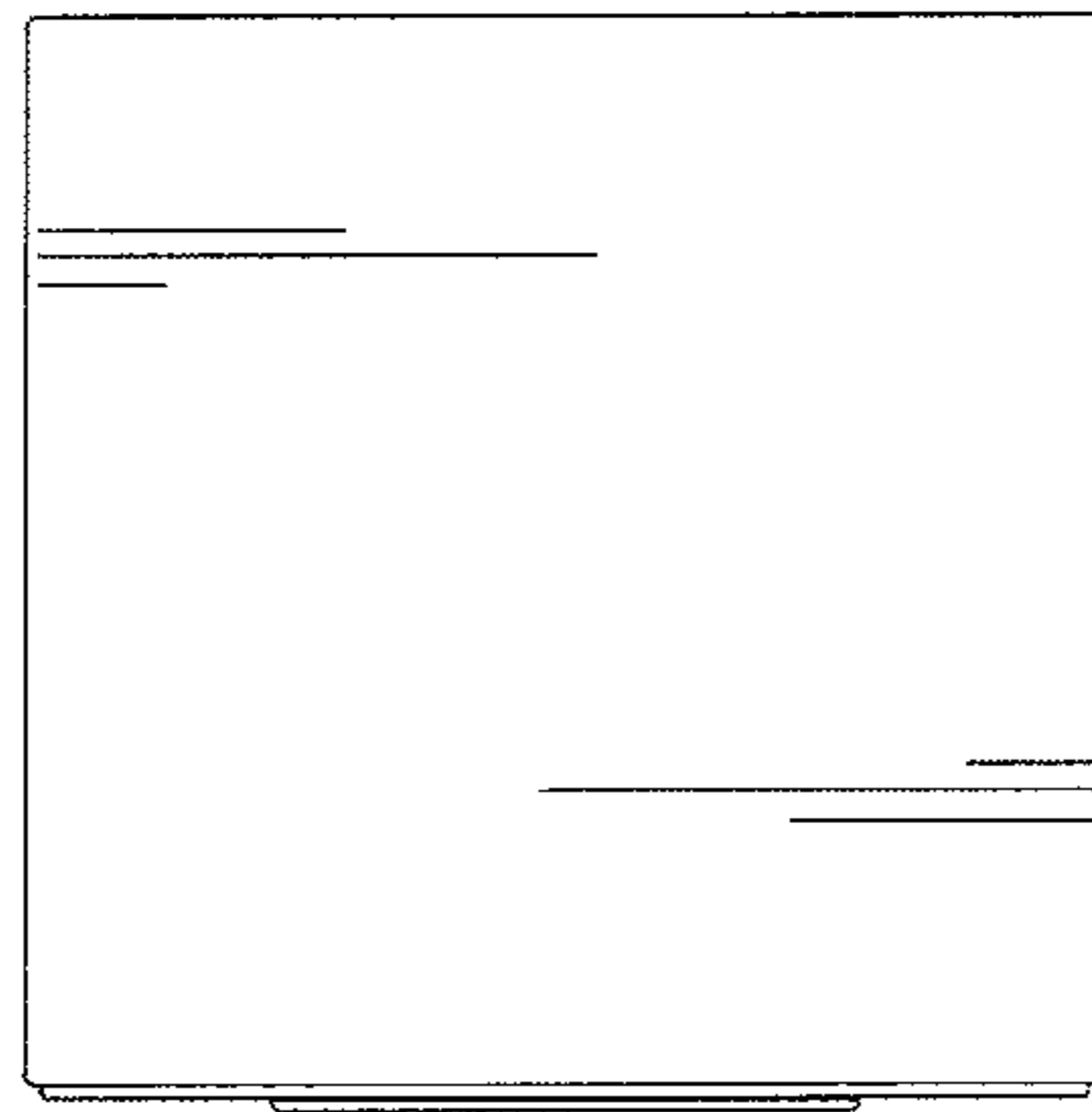

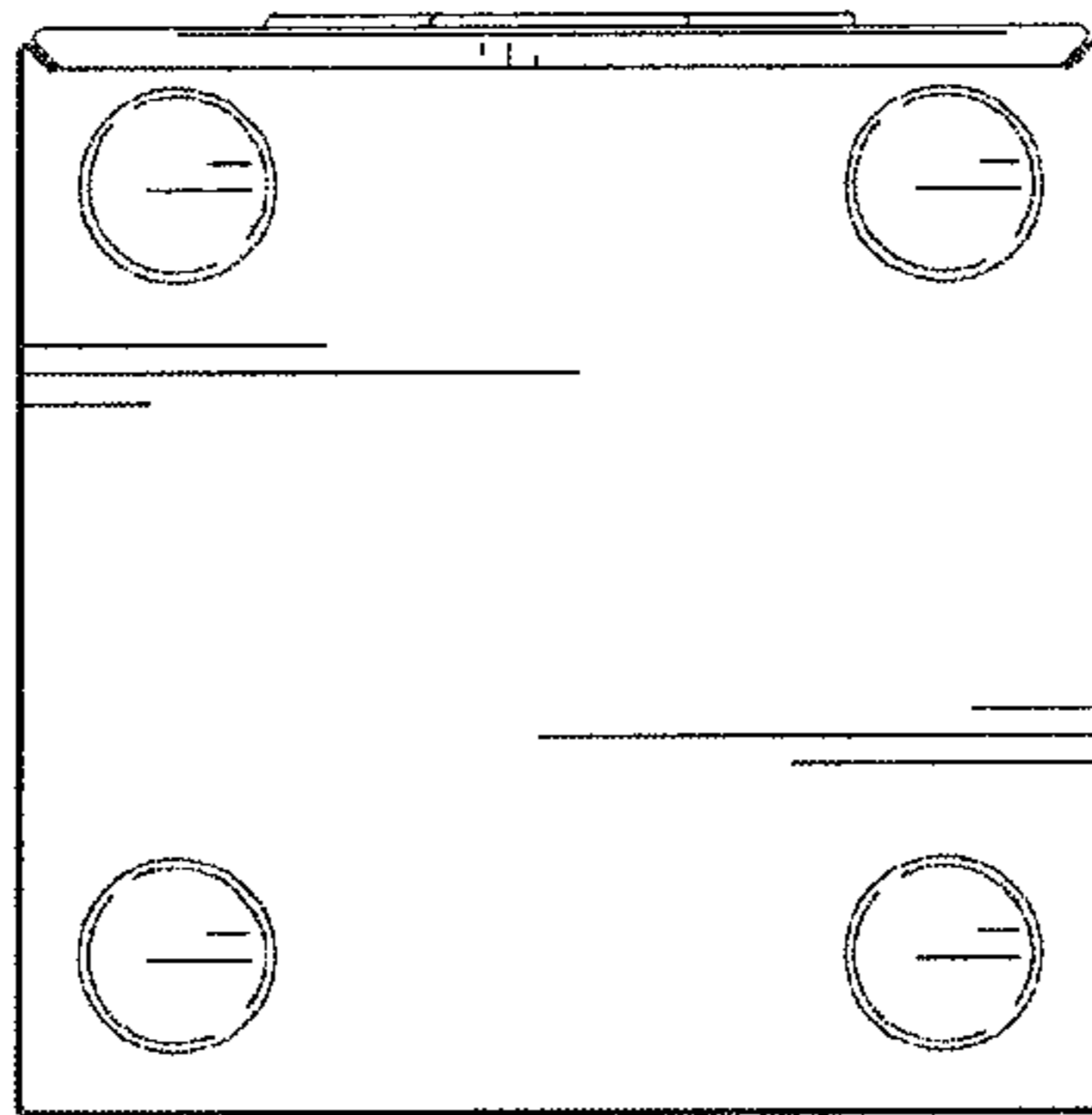

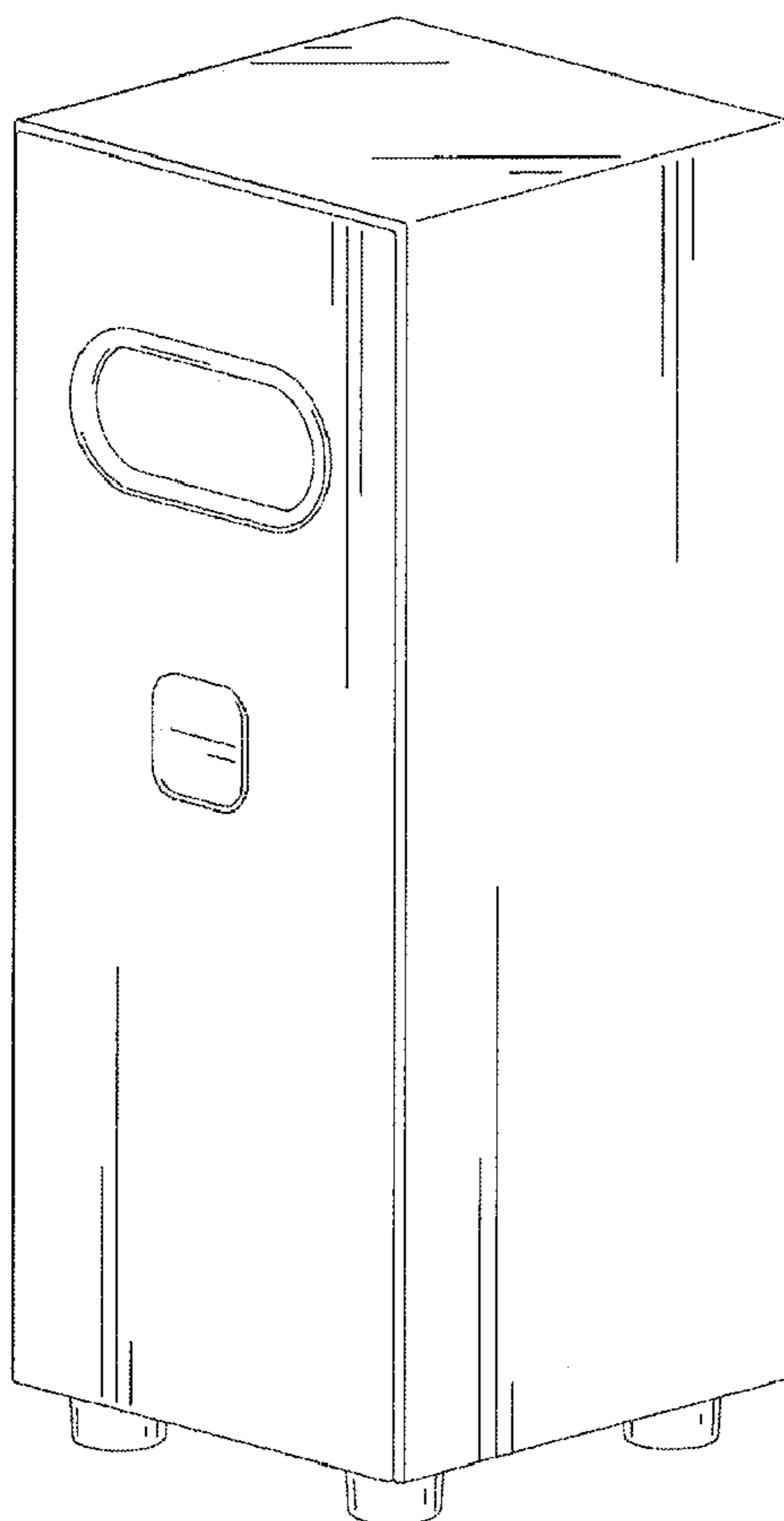

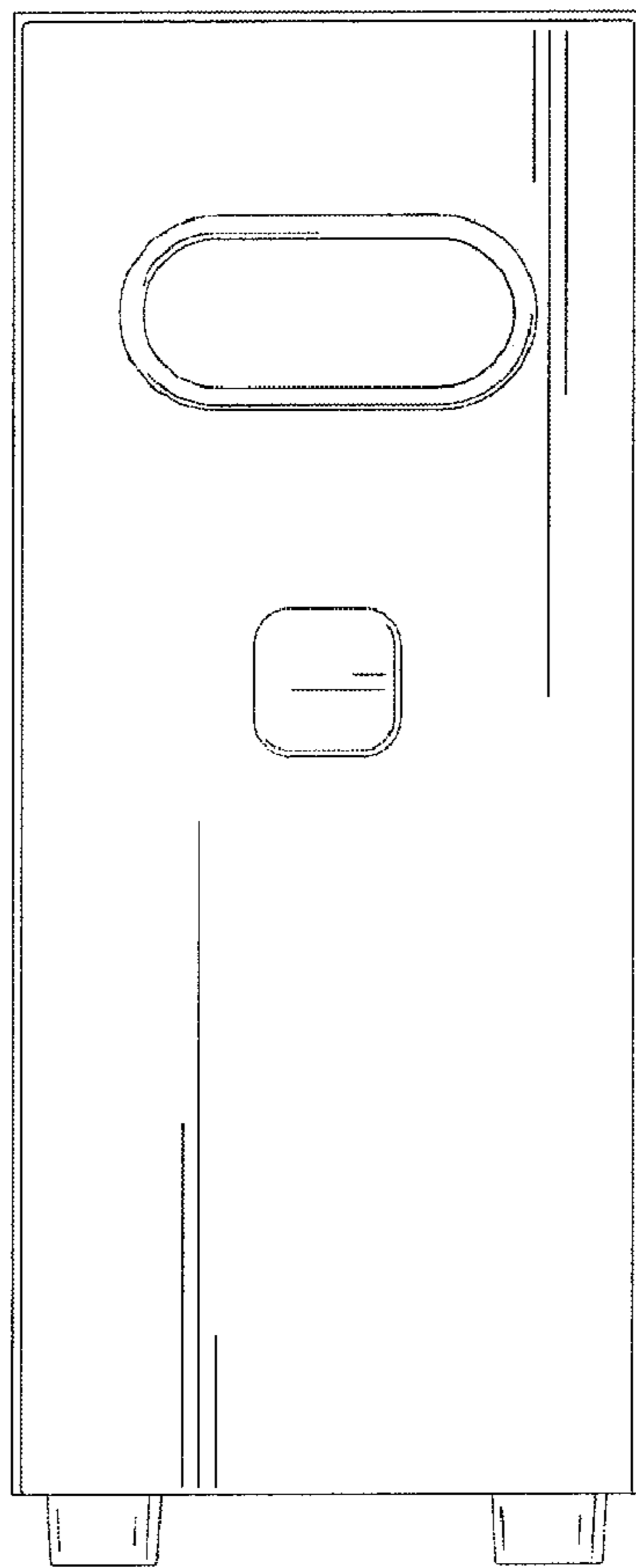

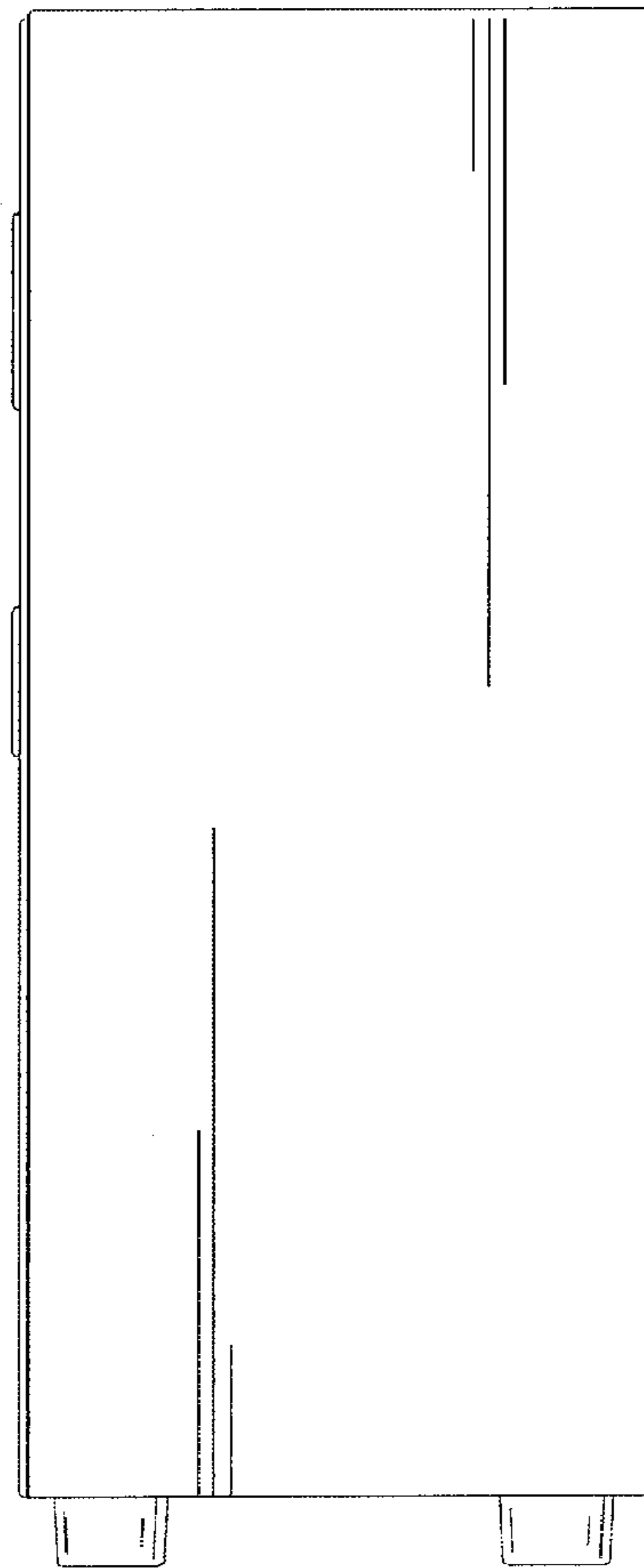

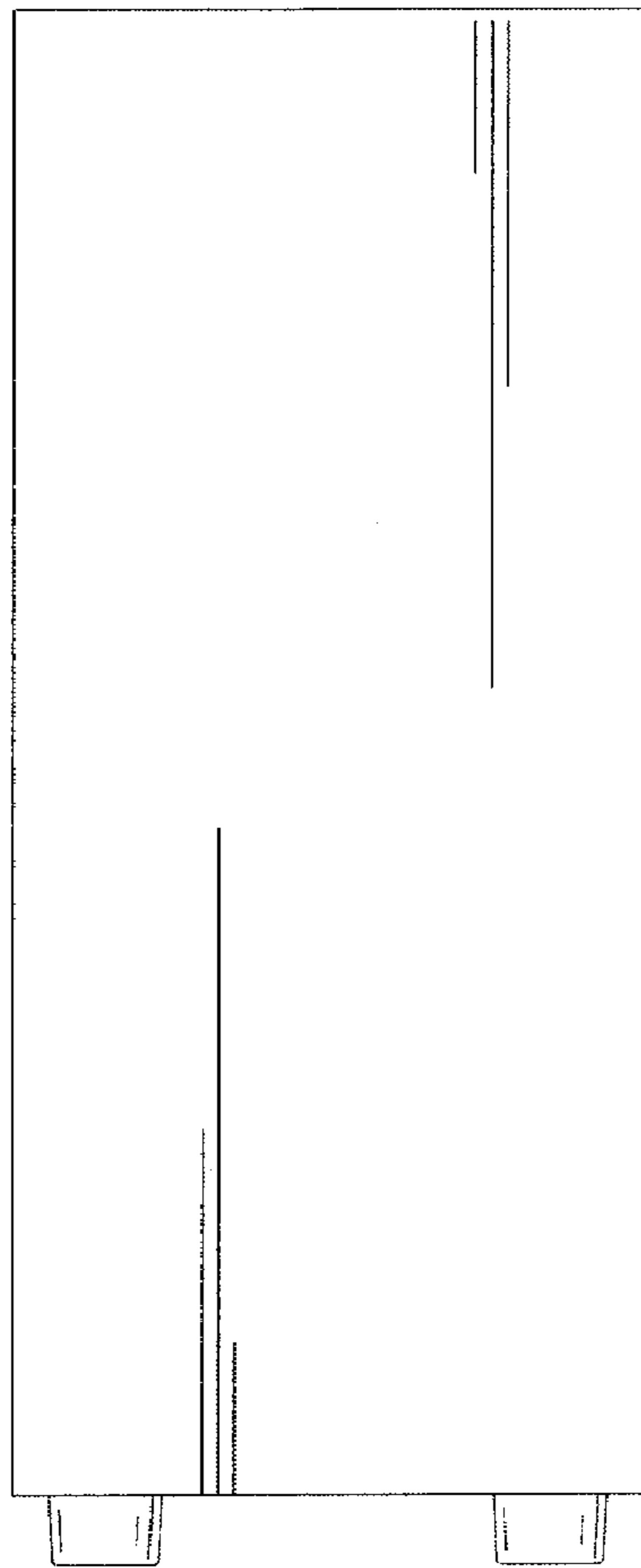

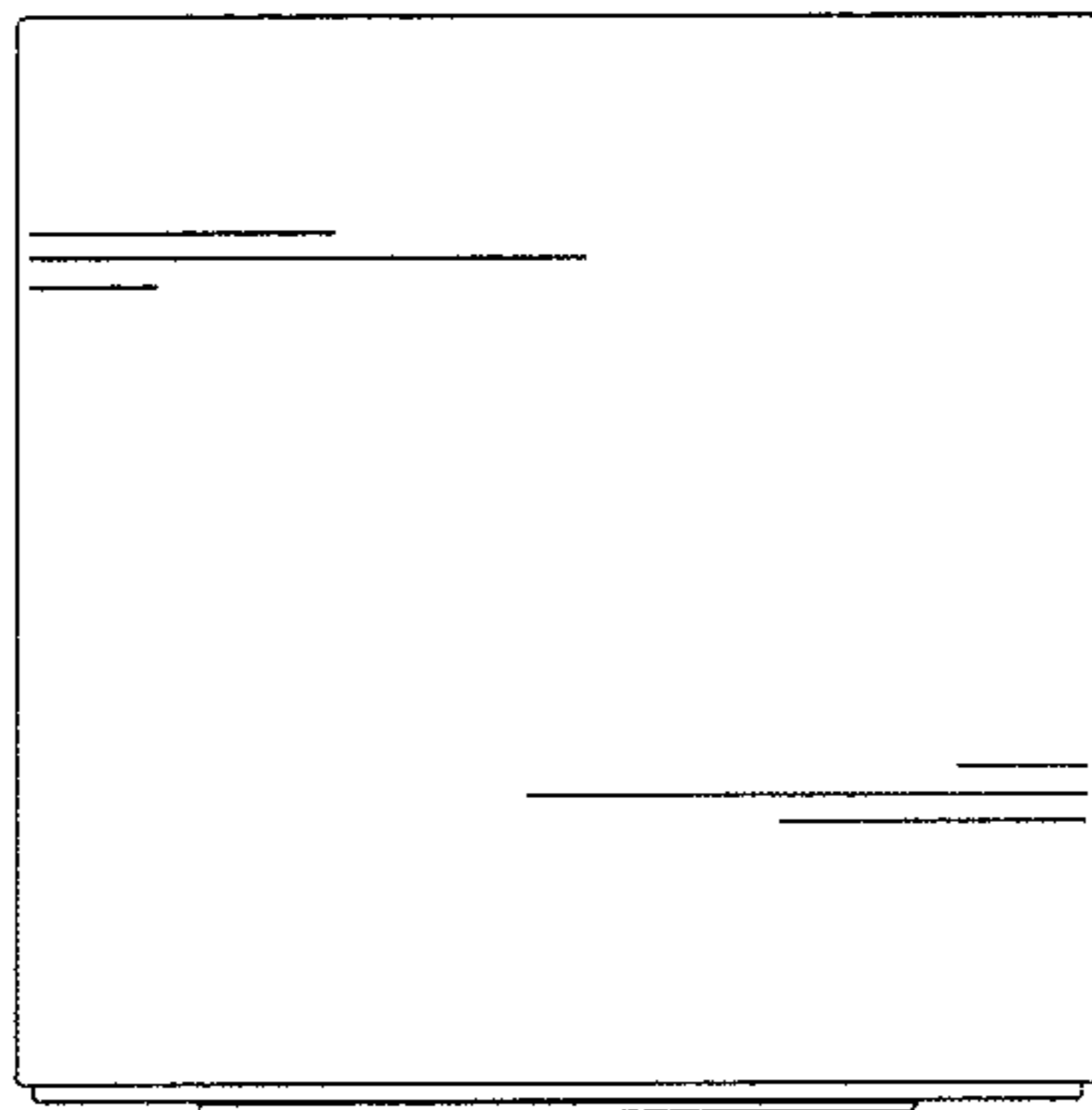

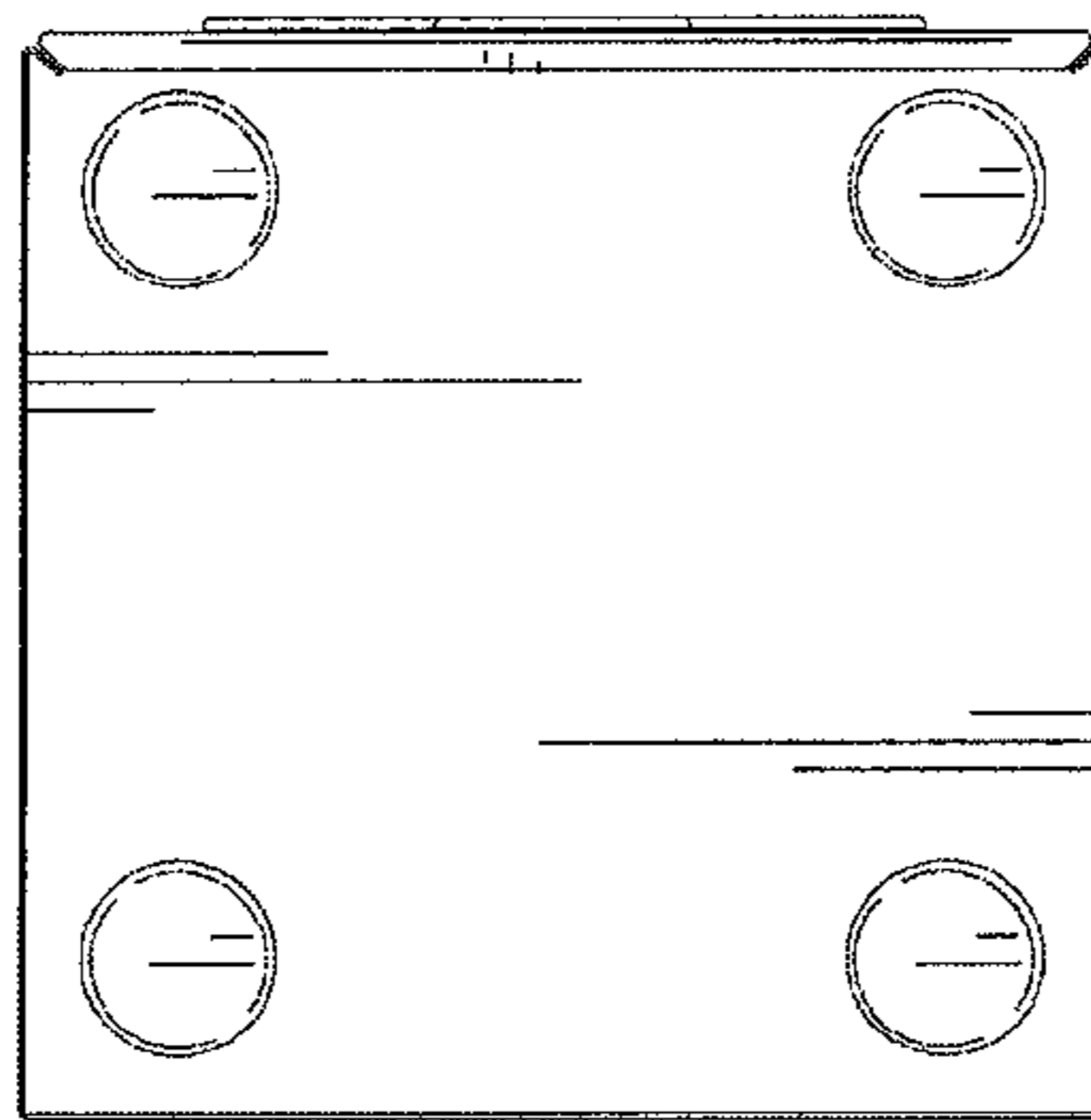

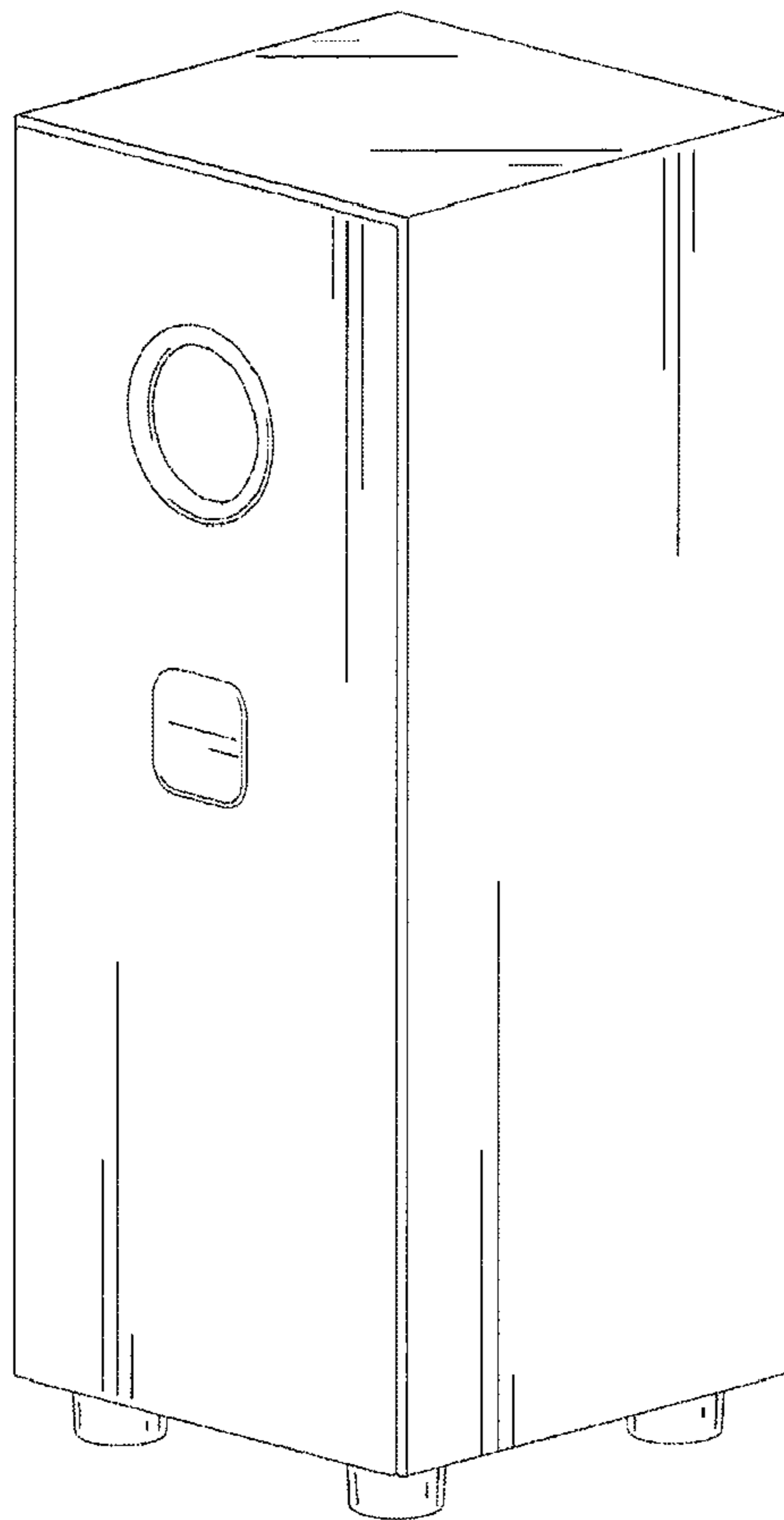

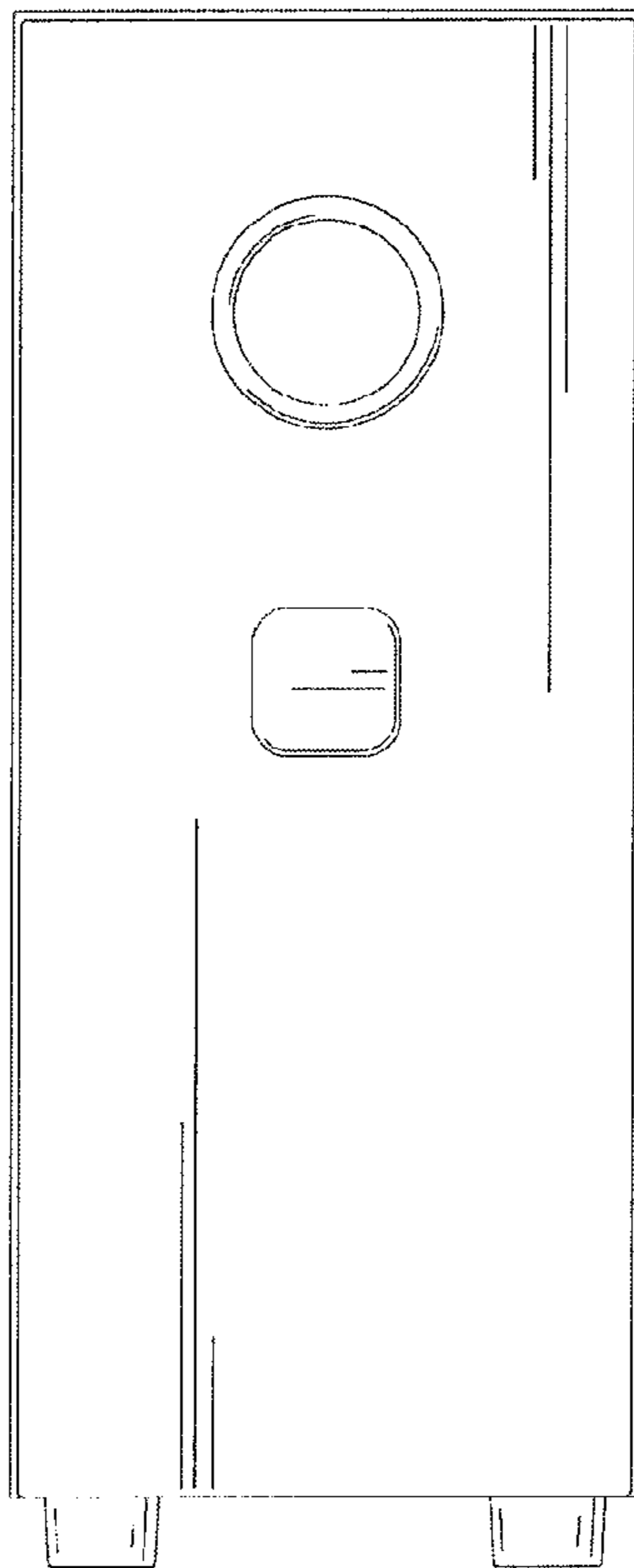

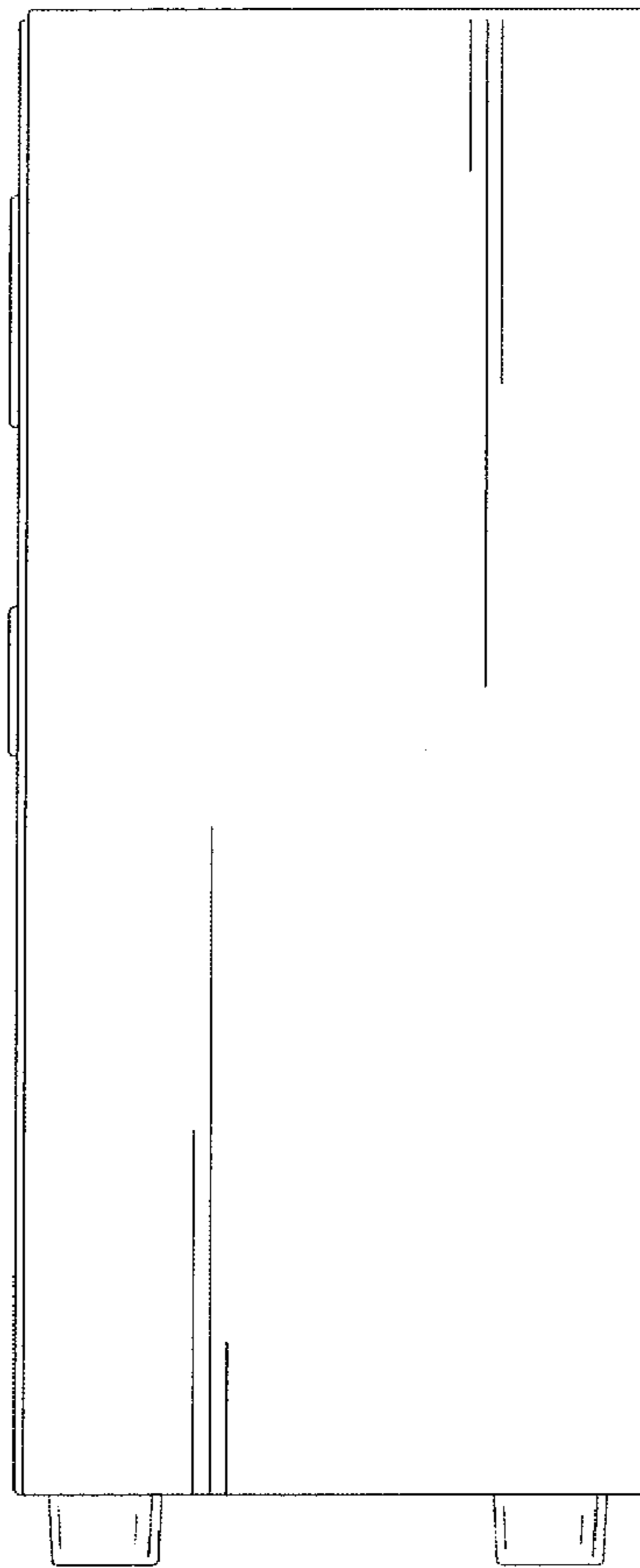

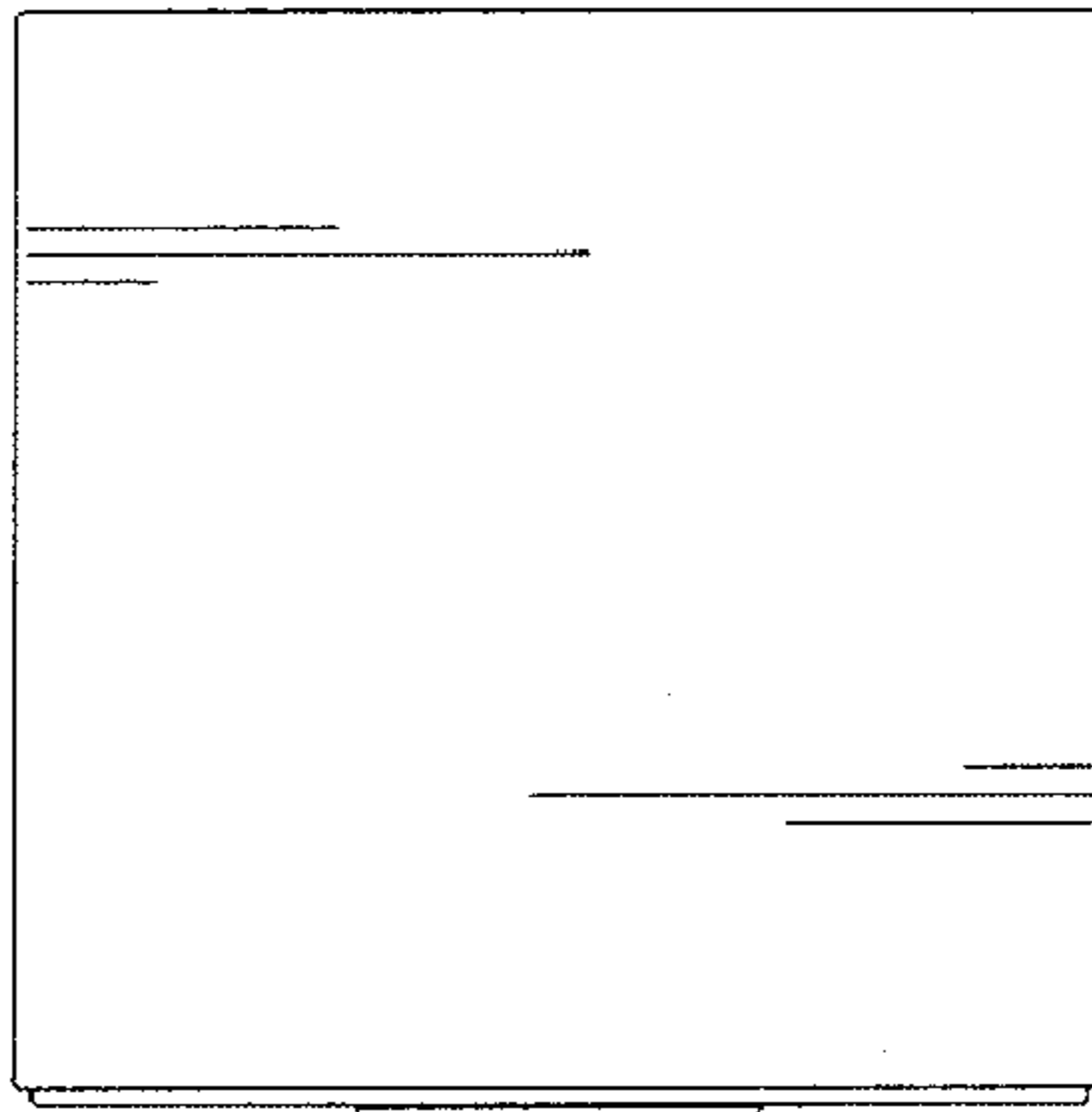

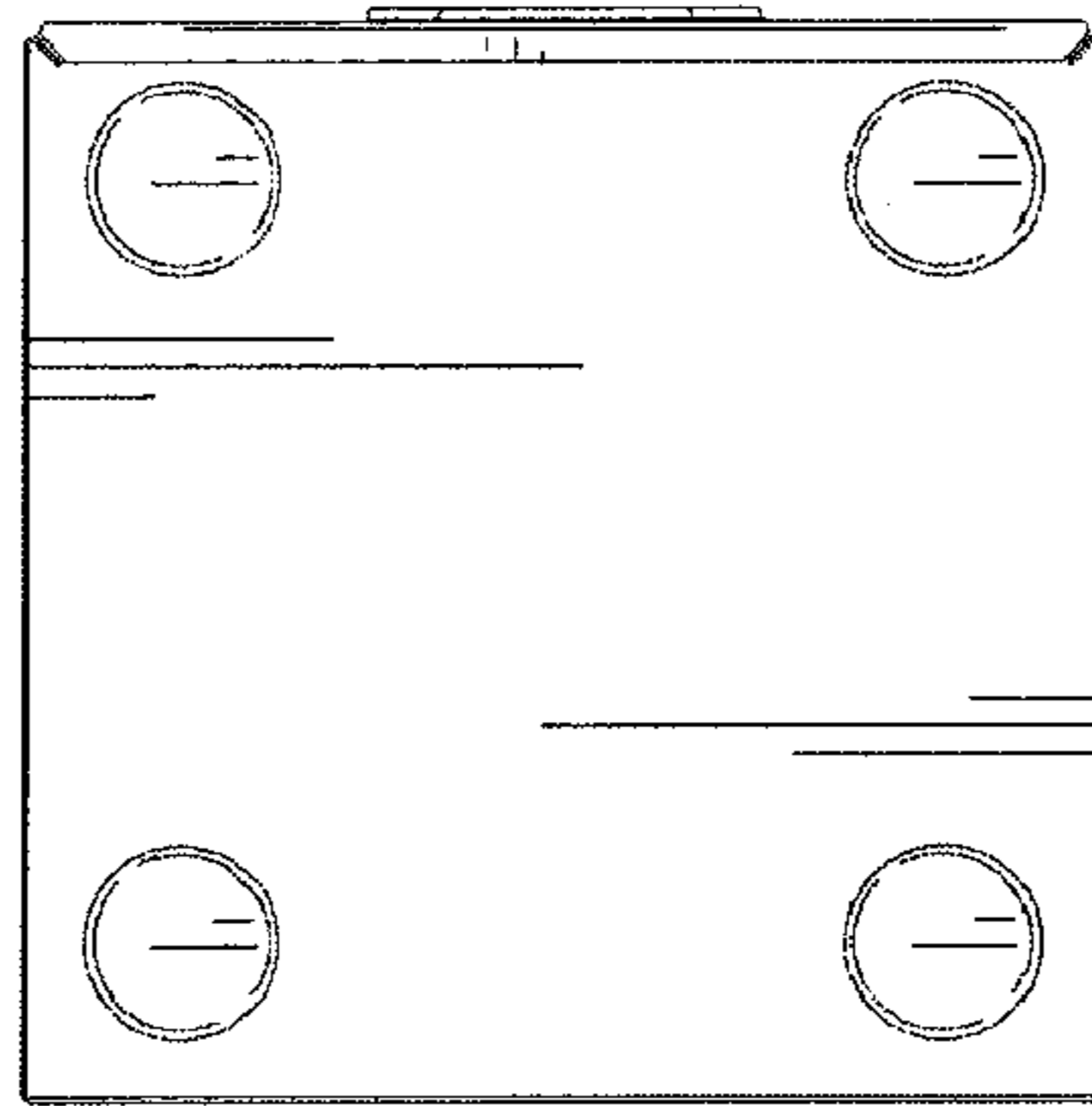

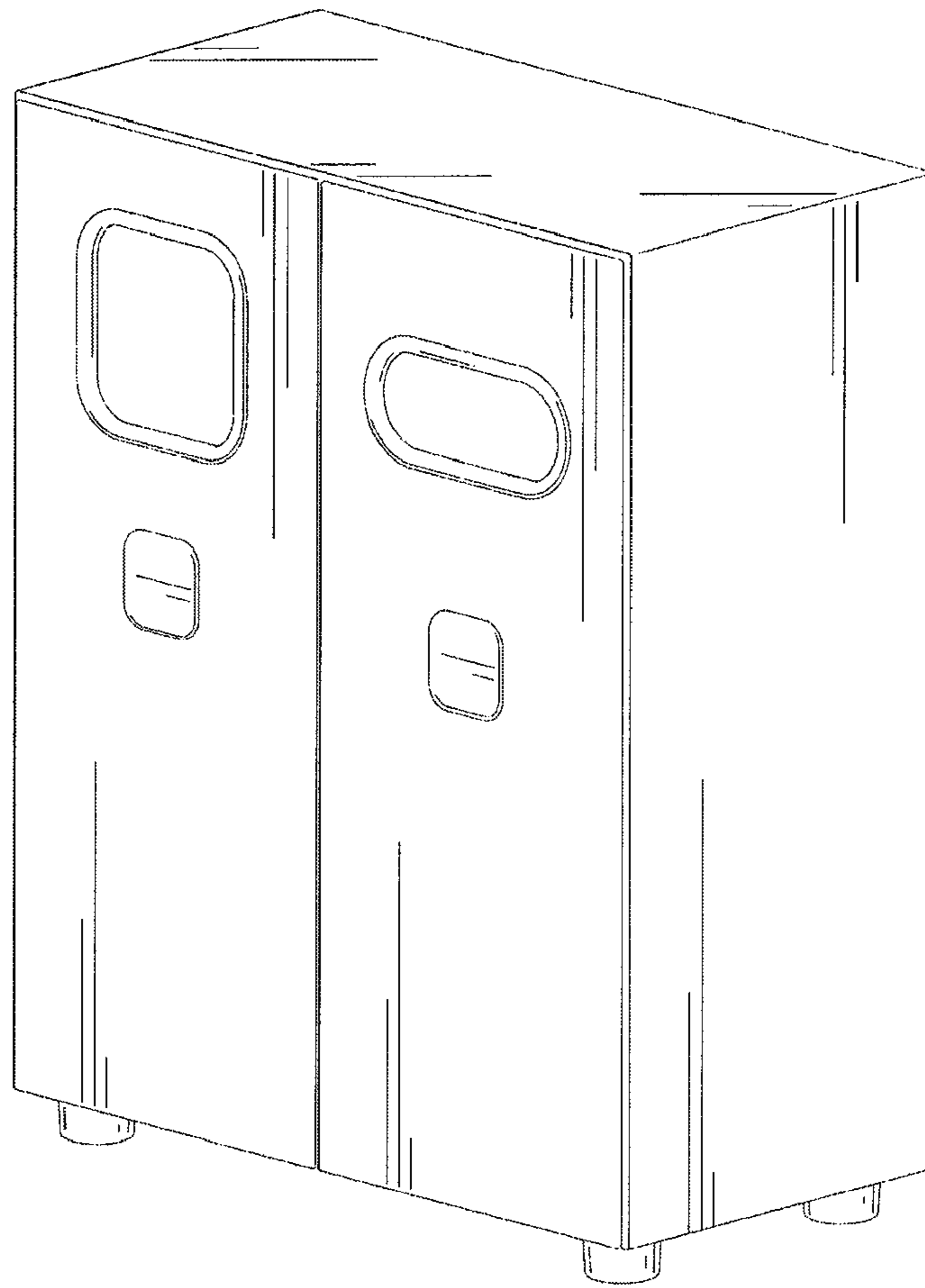

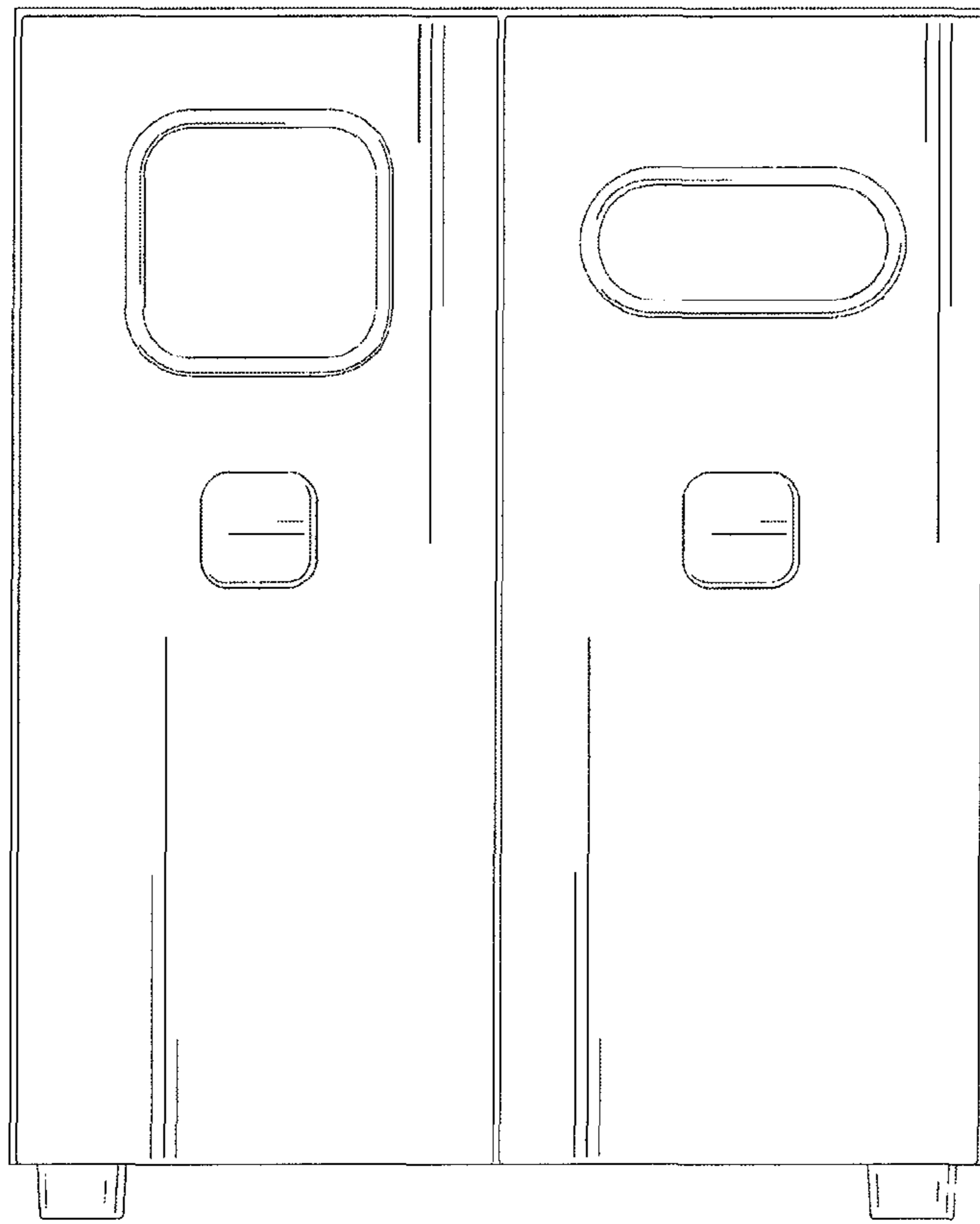

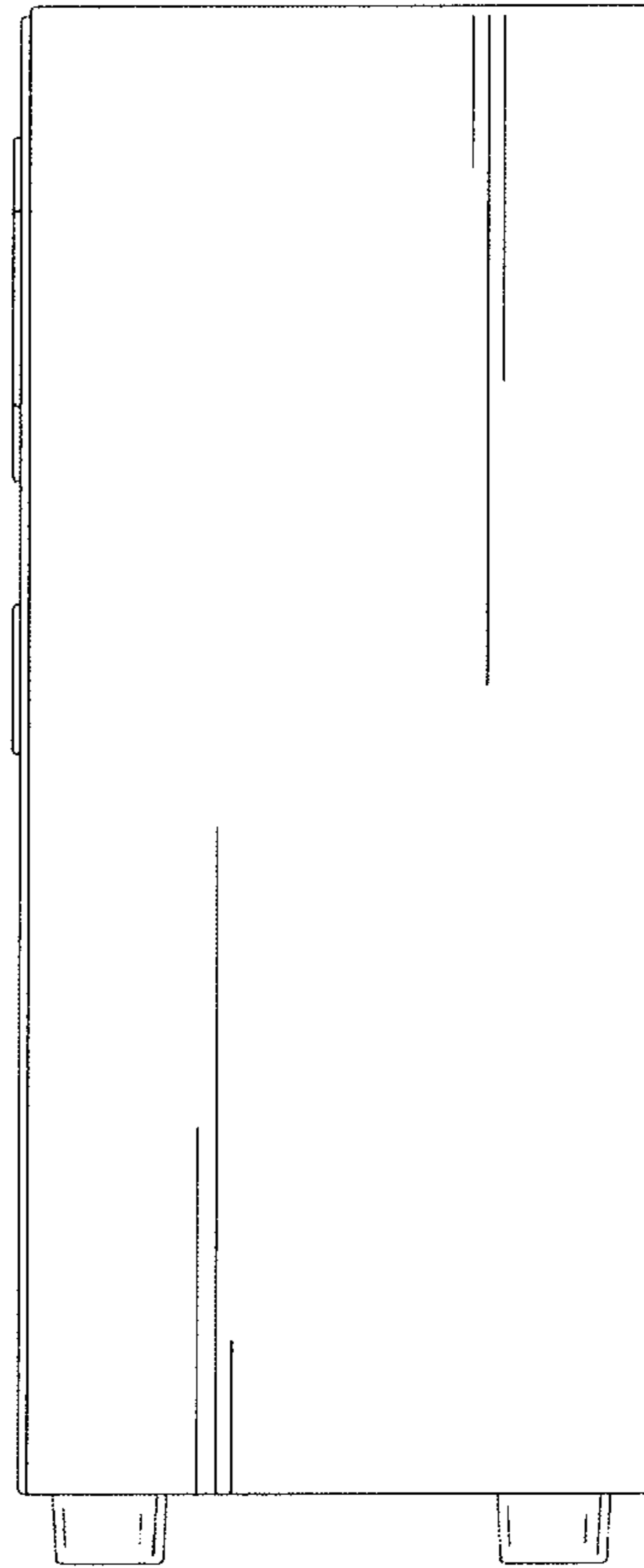

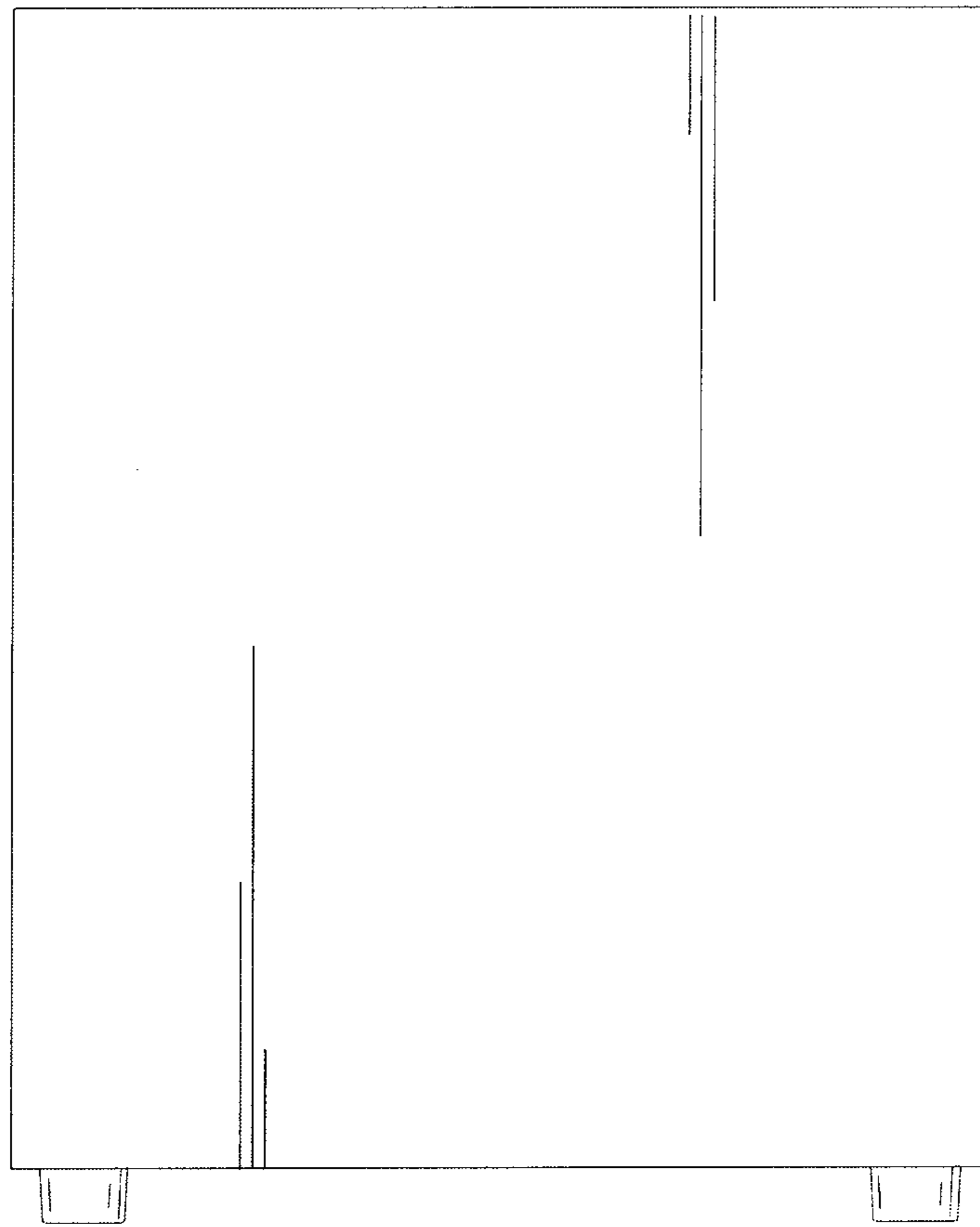

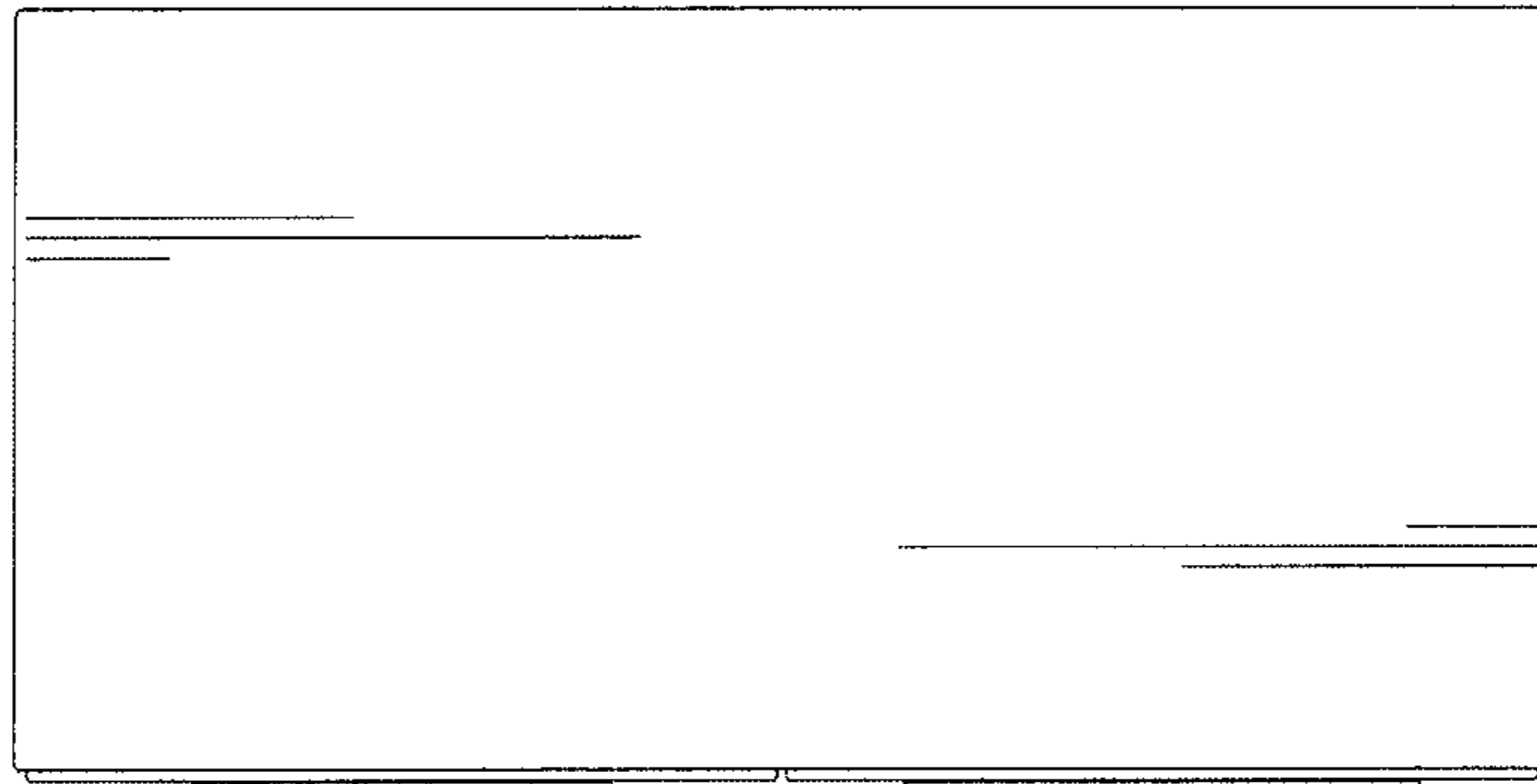

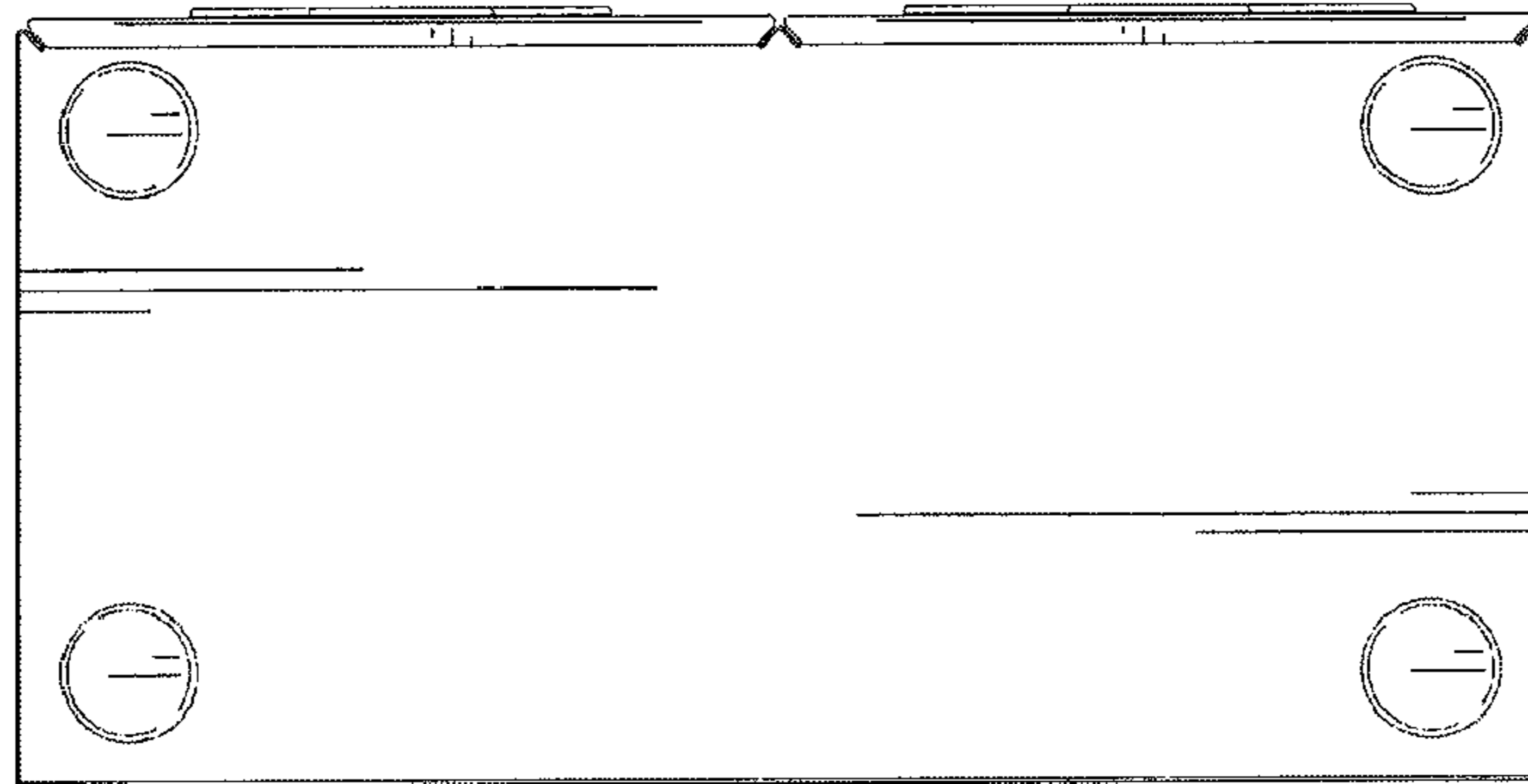

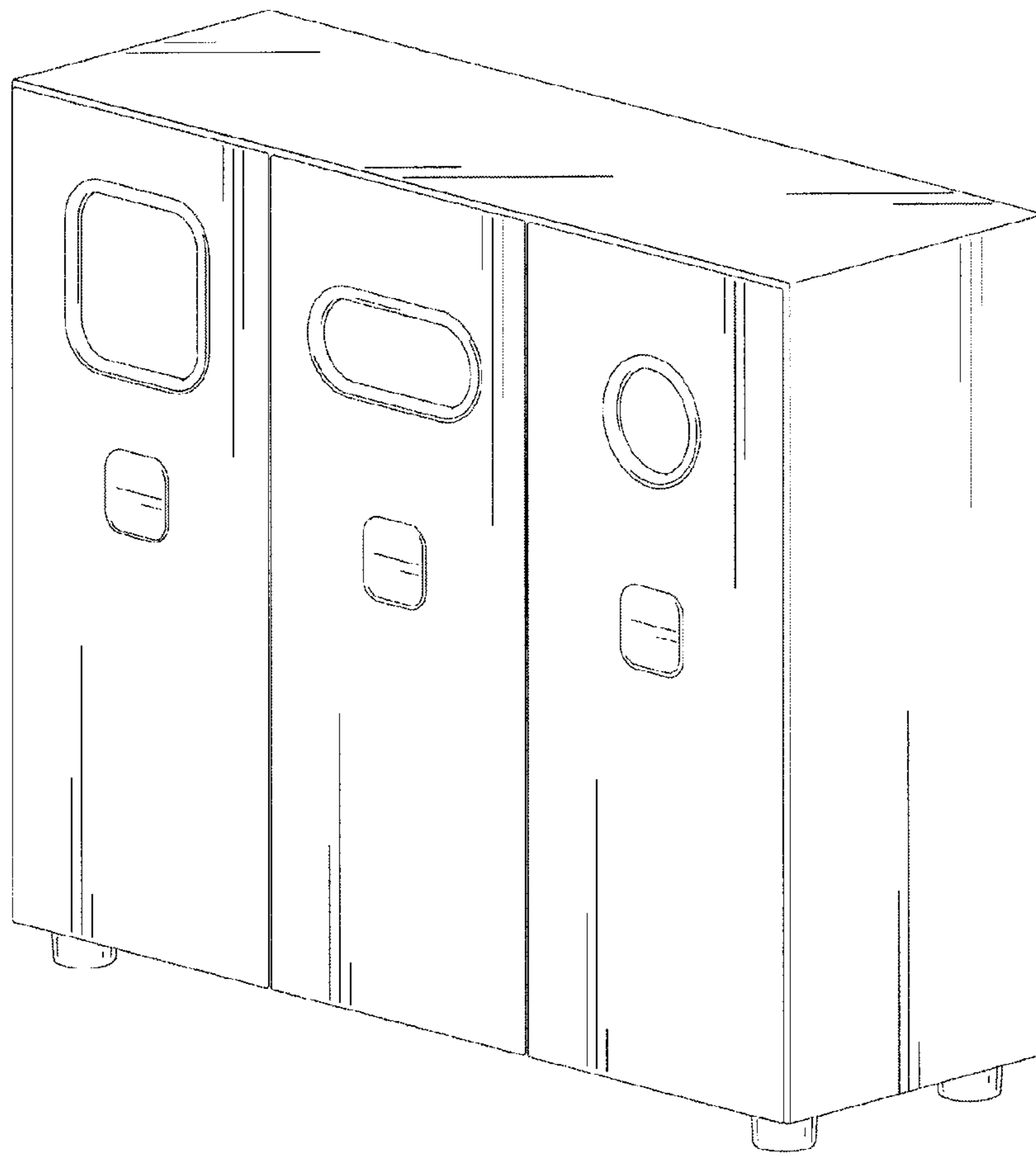

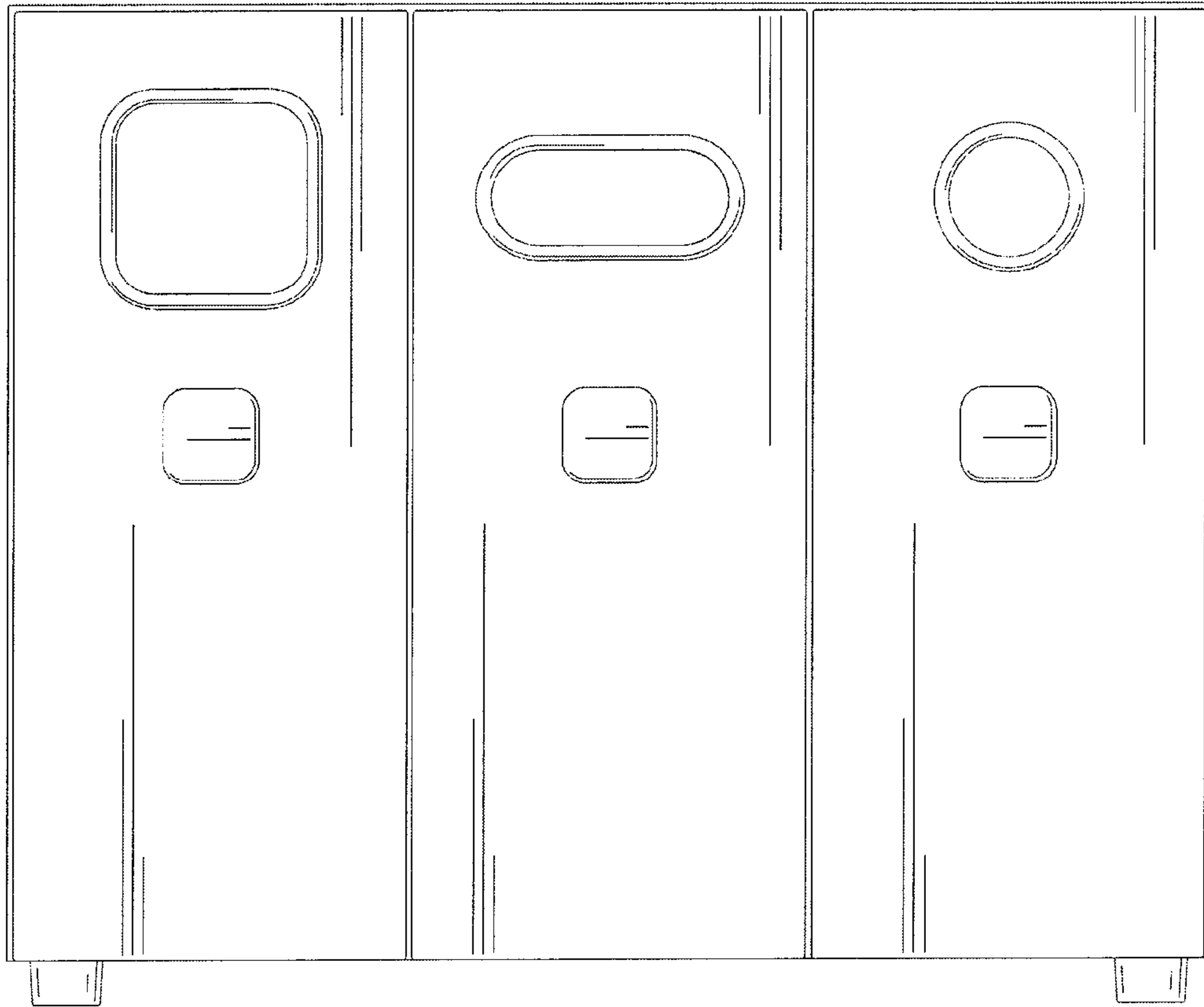

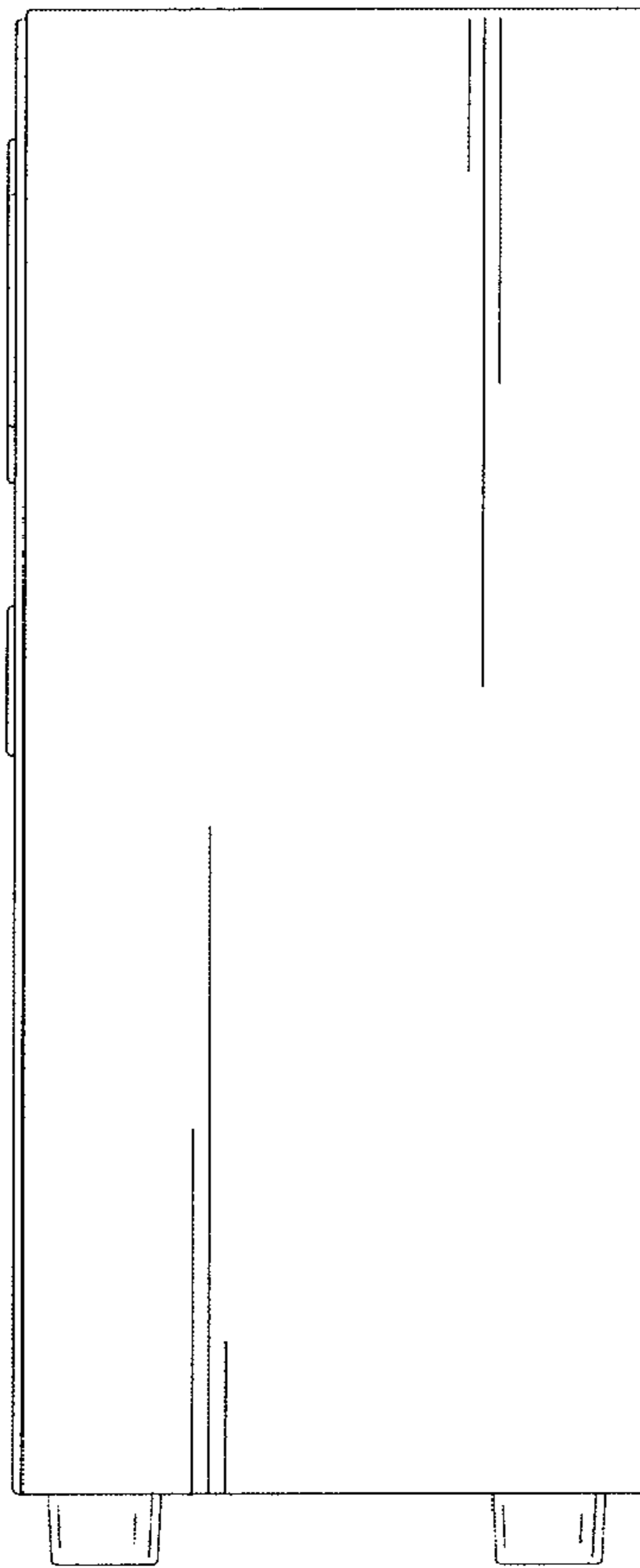

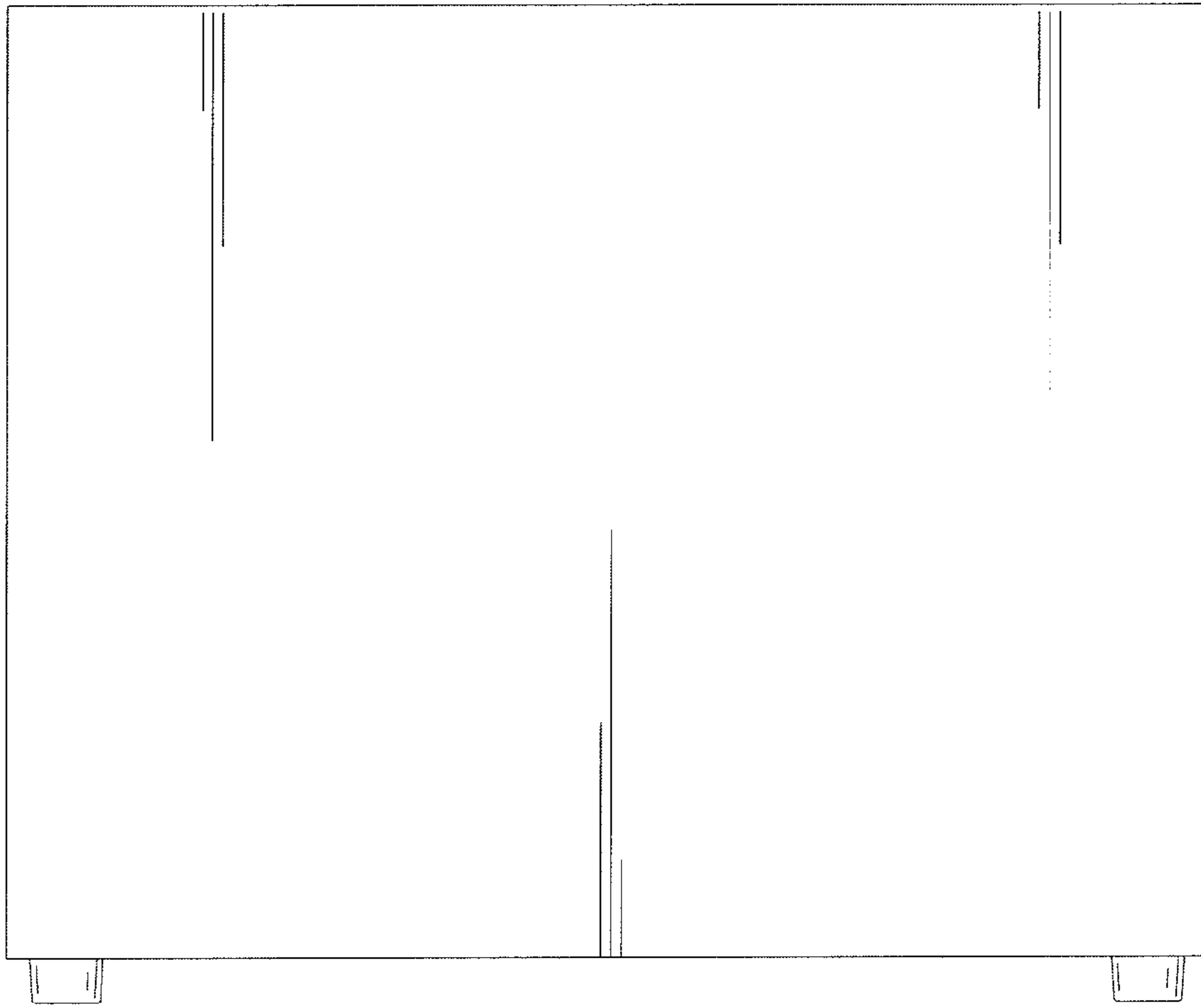

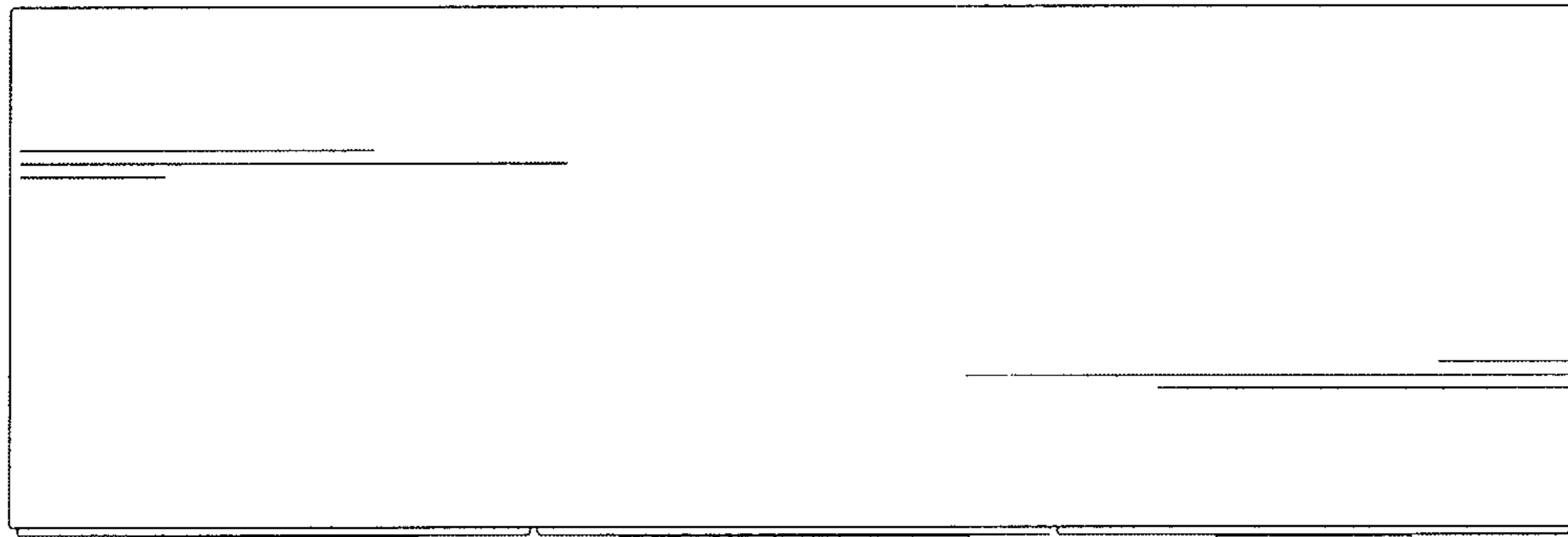

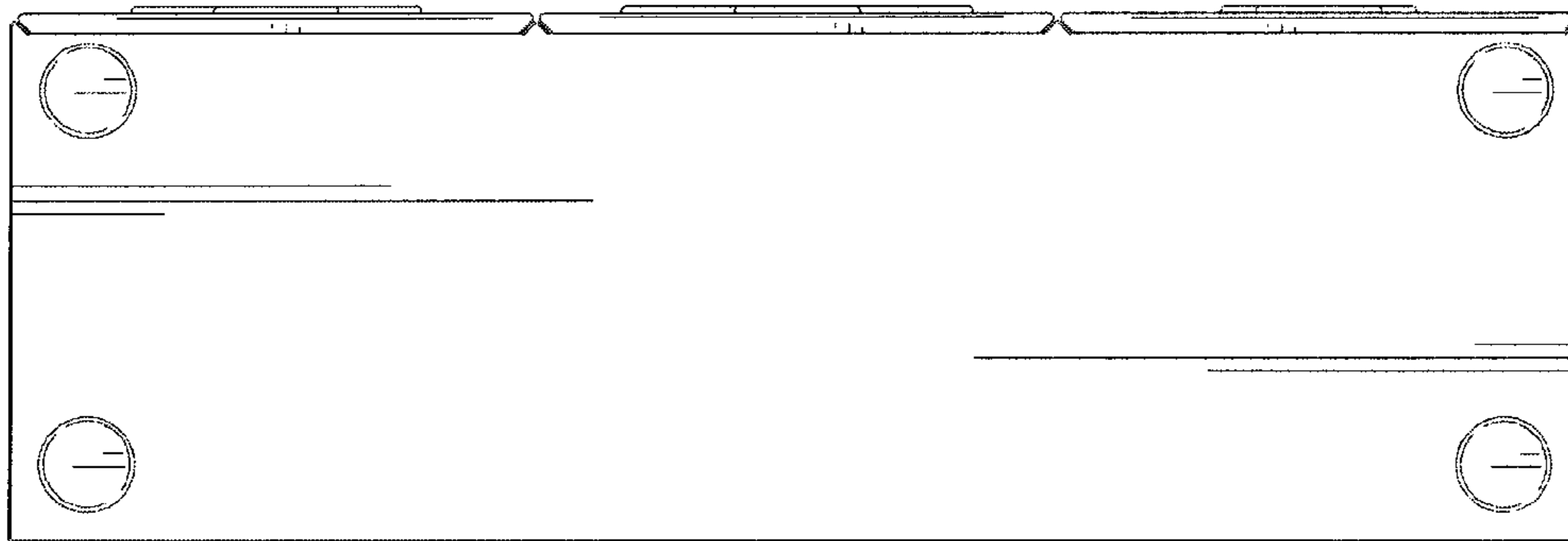
