The ornamental design for glove ornamented with a map of the state of Alaska, as shown and described.

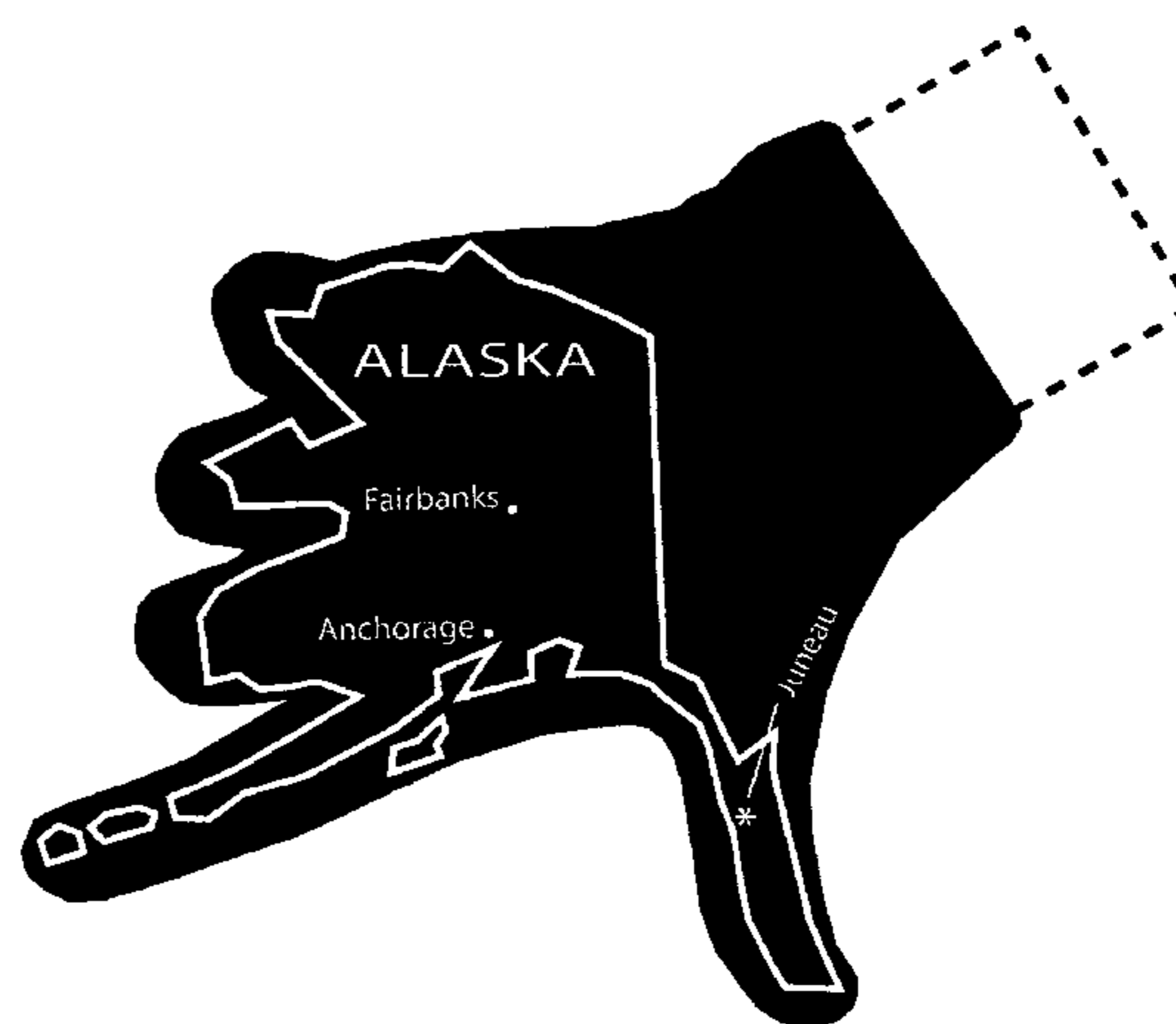
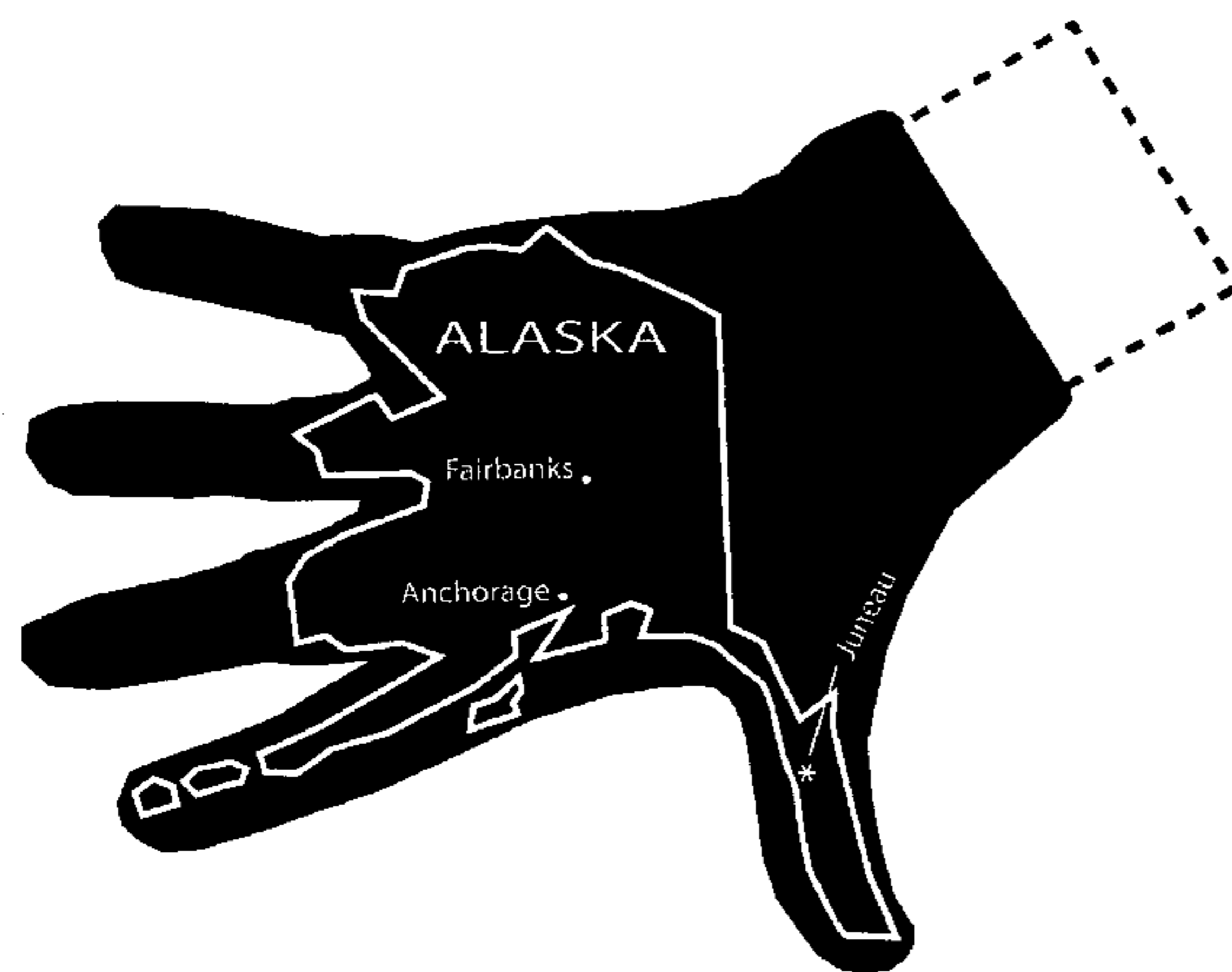
**DESCRIPTION**

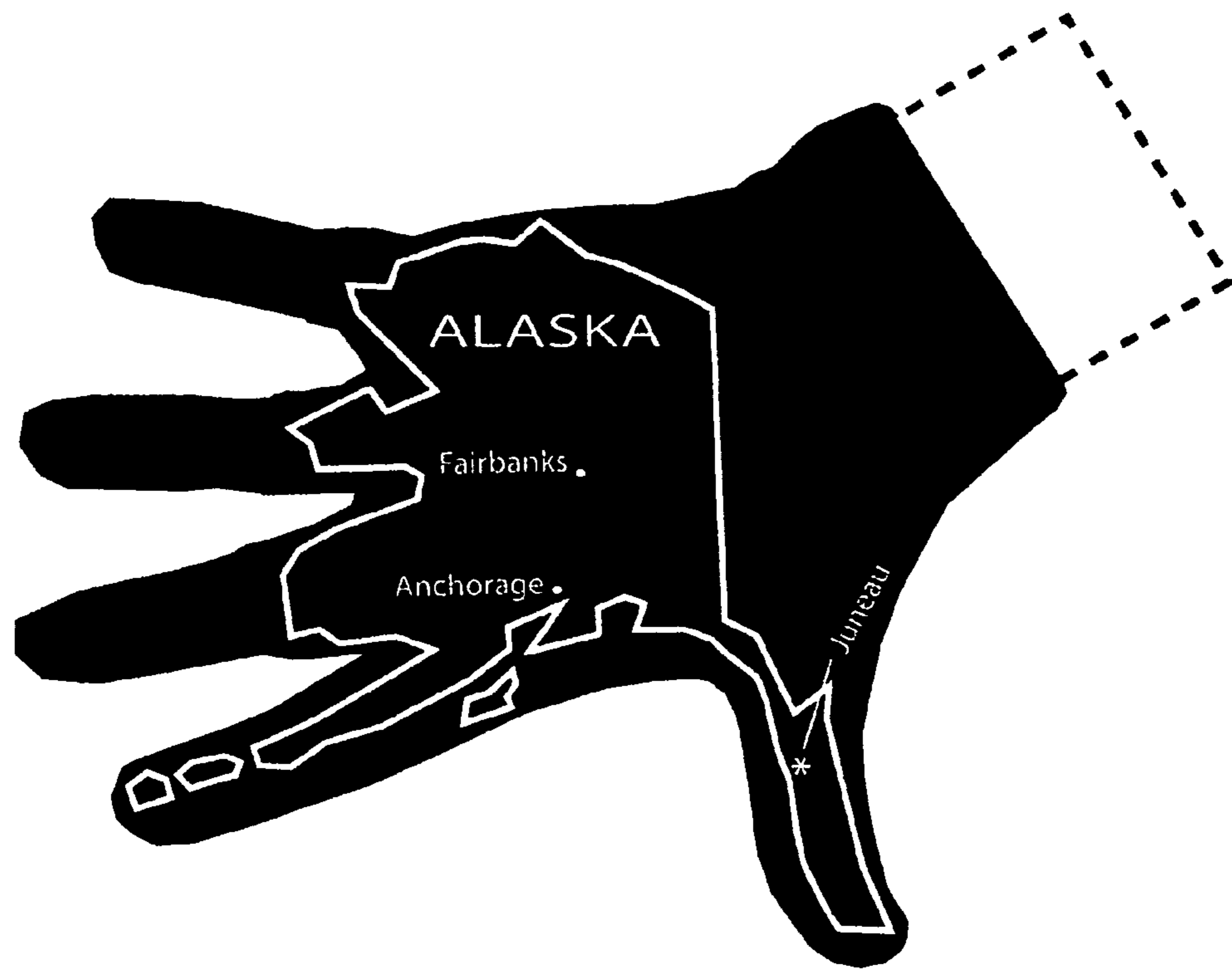

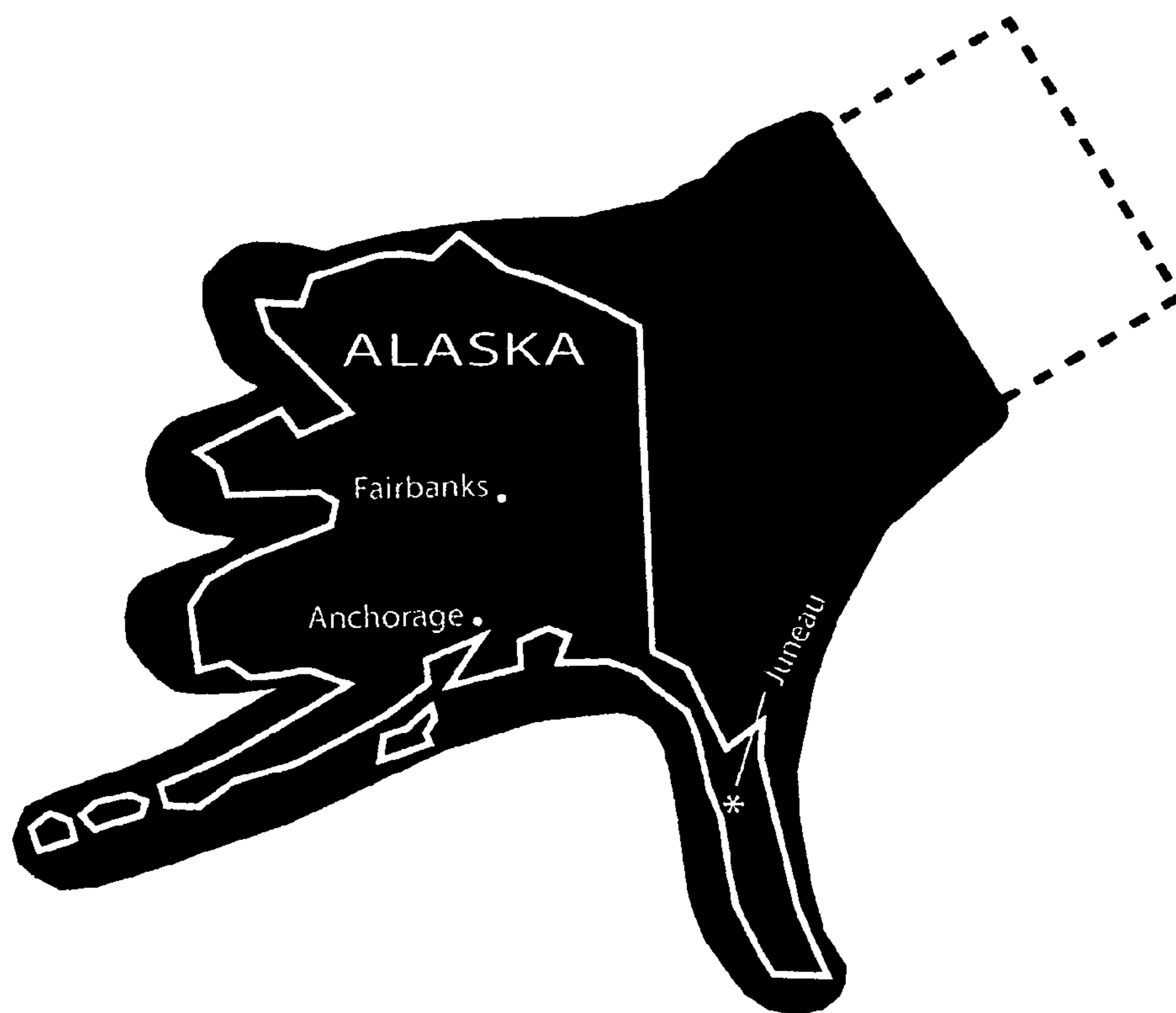
