(57) CLAIM

The ornamental design for a handle bag with wrapped frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from a side corner of a handle bag with wrapped frame according to the present invention, the tag indicated with dashed lines is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is an elevational view of a first side of the handle bag with wrapped frame of FIG. 1, the tag indicated with dashed lines is for illustrative purposes only and forms no part of the claimed design;

FIG. 3 is an elevational view of a second side of the handle bag with wrapped frame of FIG. 1 from a side opposite the view of FIG. 2;


FIG. 4 is an elevational view of a third side of the handle bag with wrapped frame of FIG. 1;

FIG. 5 is an elevational view of a fourth side of the handle bag with wrapped frame of FIG. 1 from a side opposite the view of FIG. 4, the tag indicated with dashed lines is for illustrative purposes only and forms no part of the claimed design;

FIG. 6 is a top plan view of the handle bag with wrapped frame of FIG. 1, the tag indicated with dashed lines is for illustrative purposes only and forms no part of the claimed design; and,

FIG. 7 is a bottom plan view of the handle bag with wrapped frame of FIG. 1.











