The ornamental design for a paper product, as shown and described.

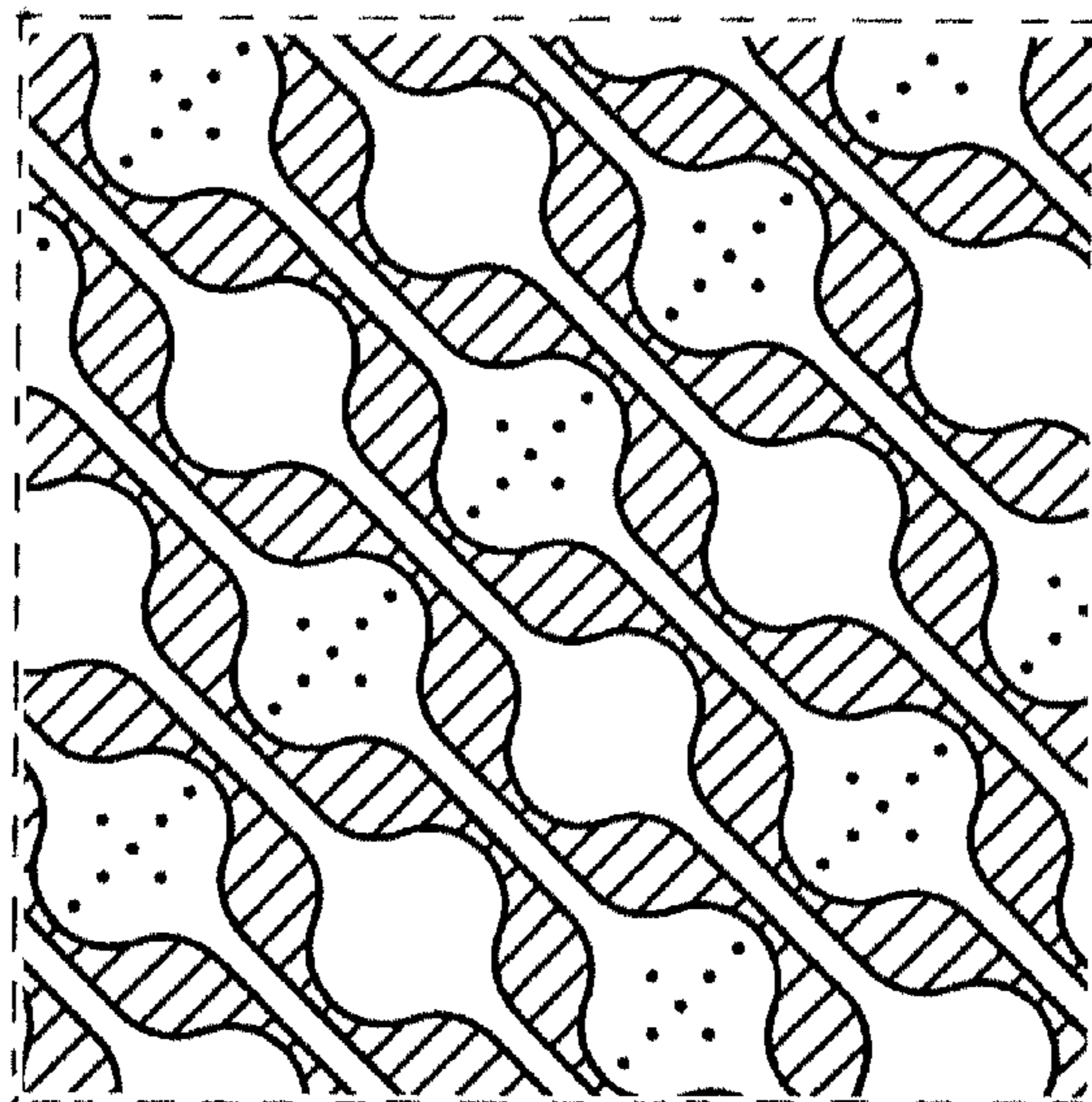
**DESCRIPTION**
