DESCRIPTION

FIG. 1 is a perspective view of a retractable vehicle seat clothes hanging bar, showing the new design in a retracted position;

FIG. 2 is a perspective view thereof, illustrated in a deployed position;

FIG. 3 is a front elevational view of FIG. 2, the rear elevational view being a mirror image thereof;

FIG. 4 is a left-side elevational view of FIG. 2, the right-side elevational view being a mirror image thereof;

FIG. 5 is a top plan view thereof, as illustrated in either the retracted or deployed positions; and,

FIG. 6 is a bottom plan view thereof, as illustrated in either the retracted or deployed positions.

The broken lines showing a vehicle seat in FIGS. 1 and 2 are included for the purpose of illustrating environmental matter, and form no part of the claimed design.

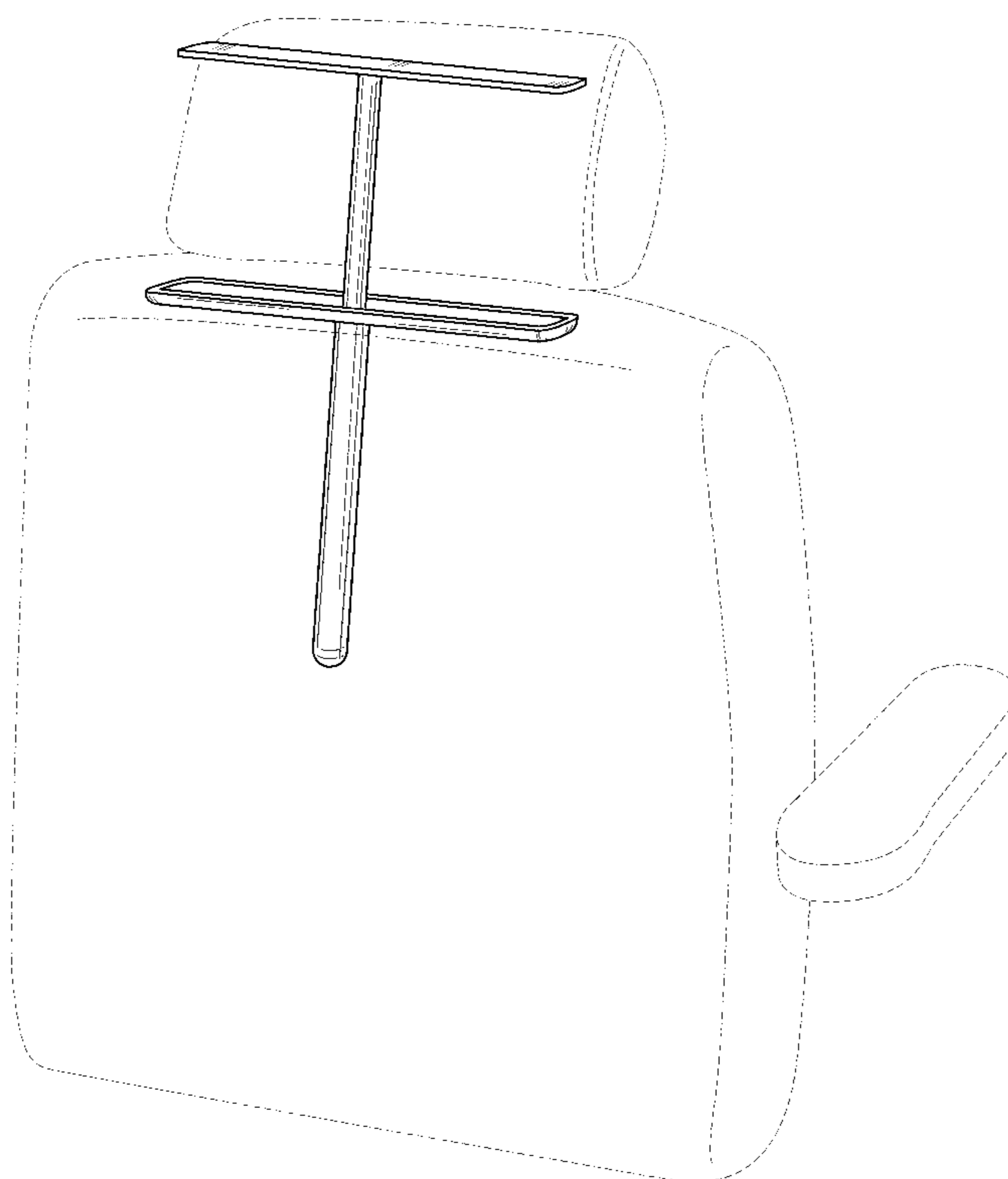

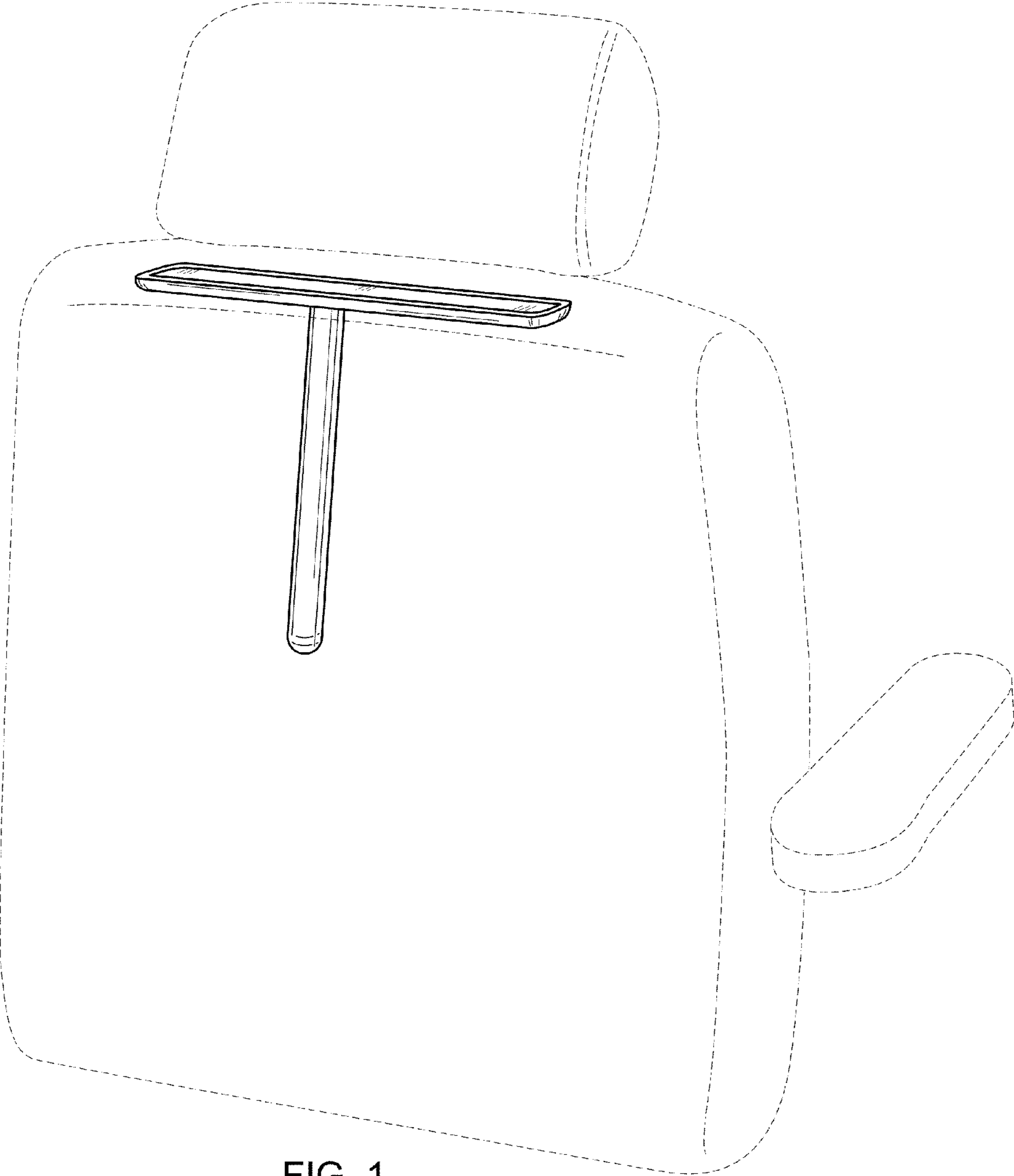

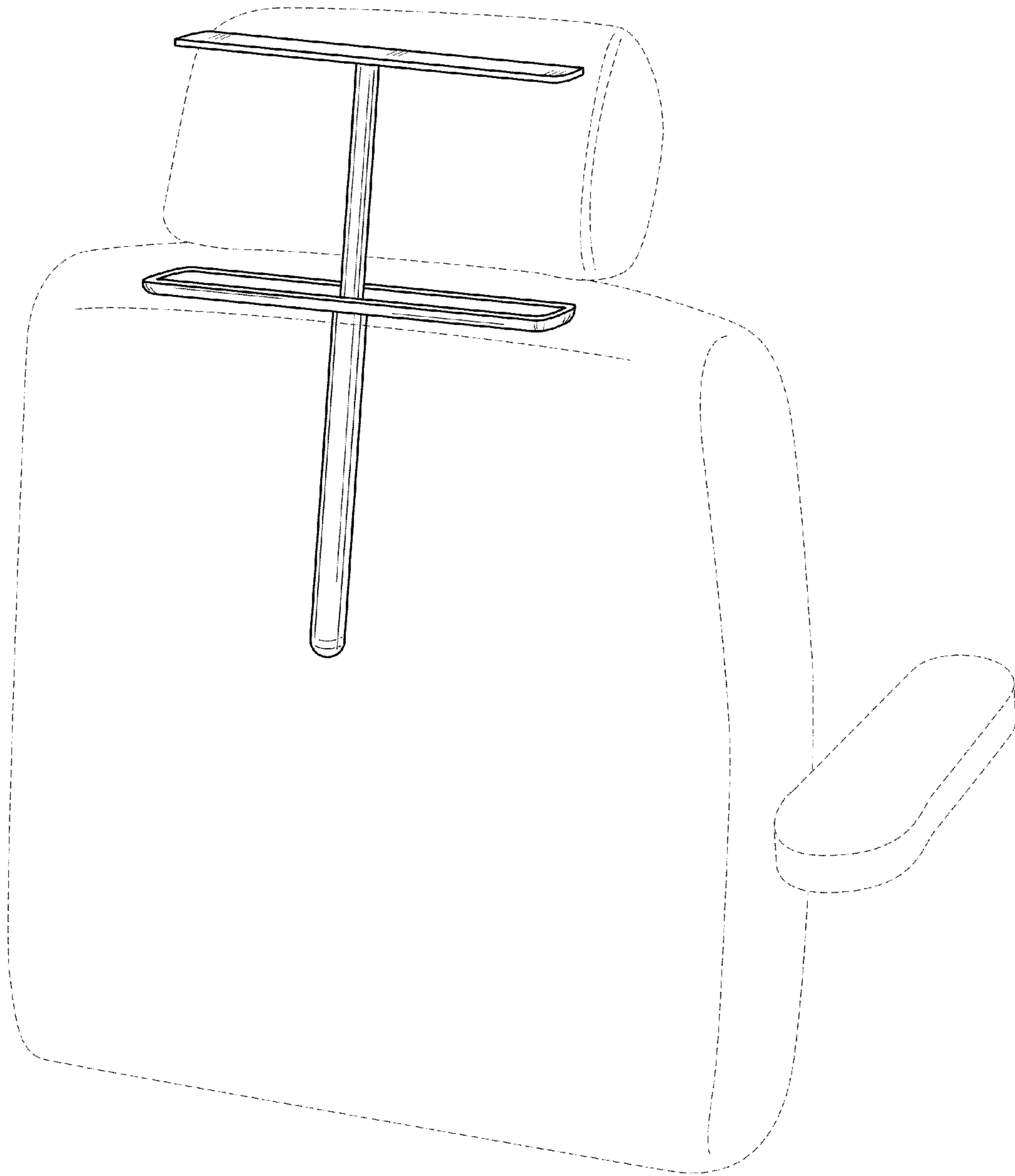

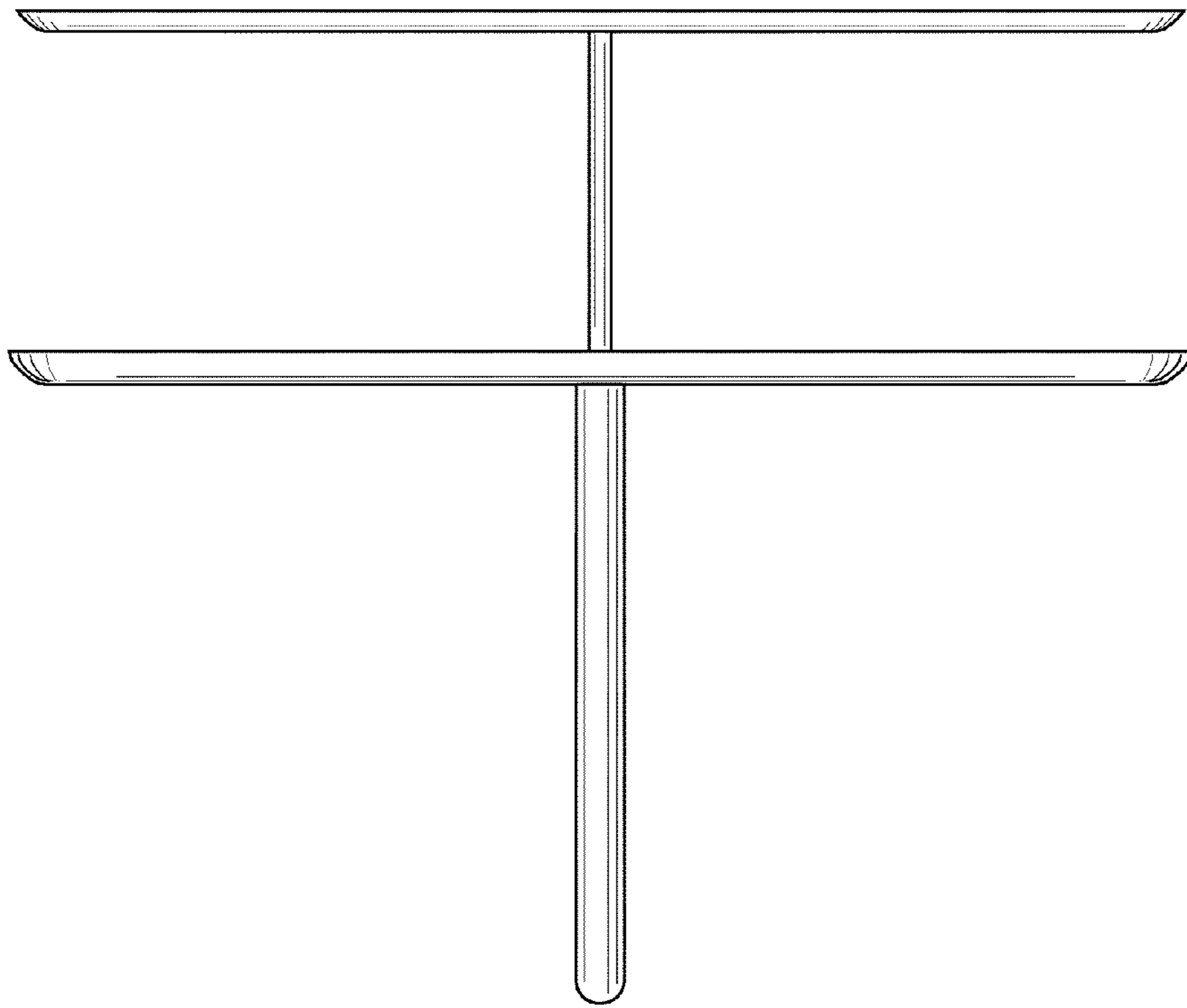

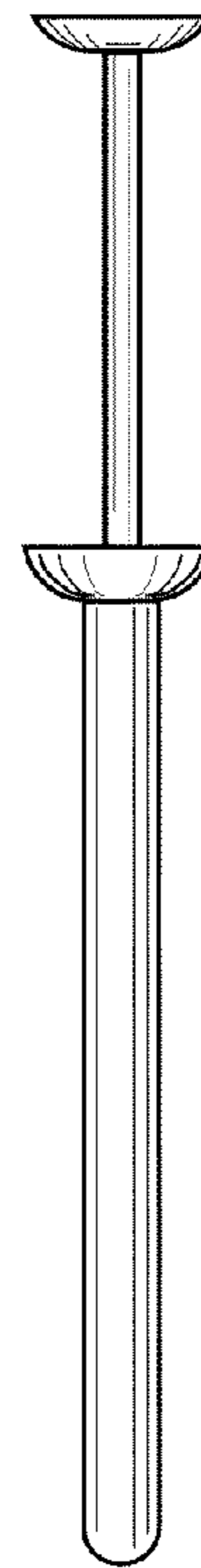

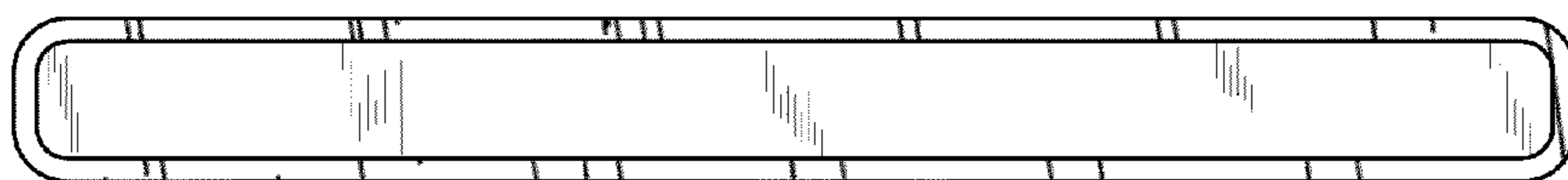

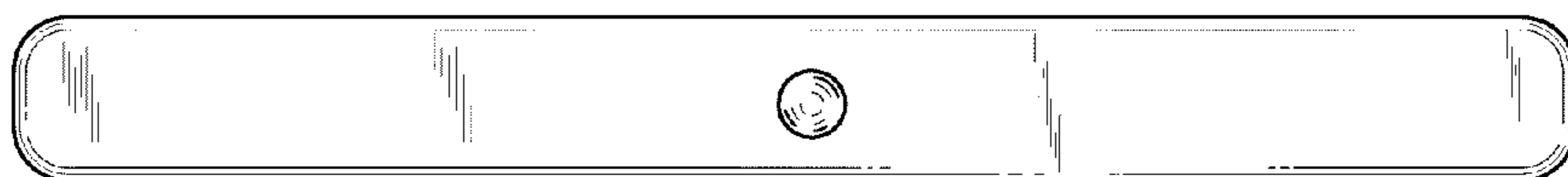
