DESCRIPTION

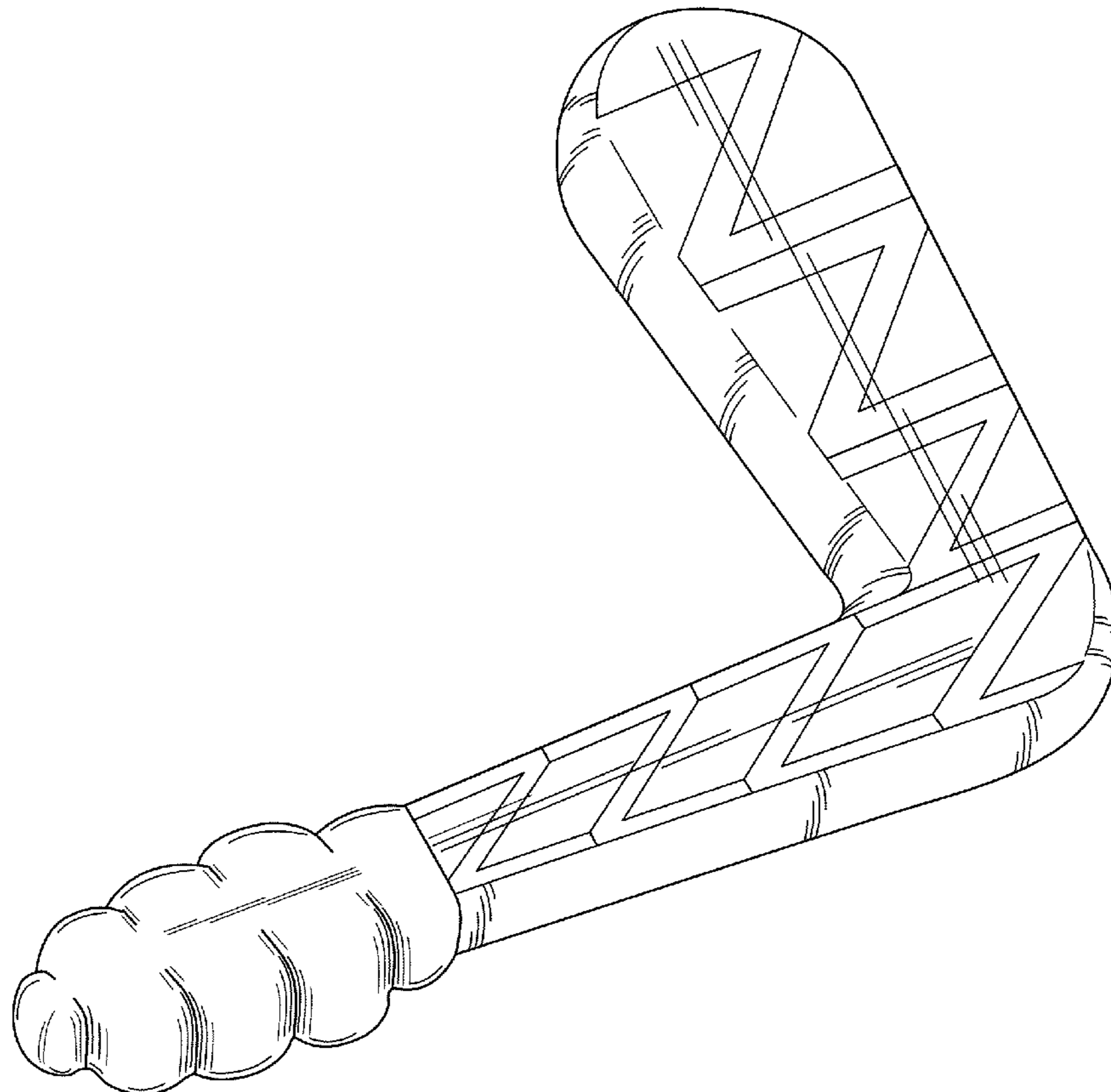
FIG. 1 is a front perspective view of a contoured pillow, showing my new design;

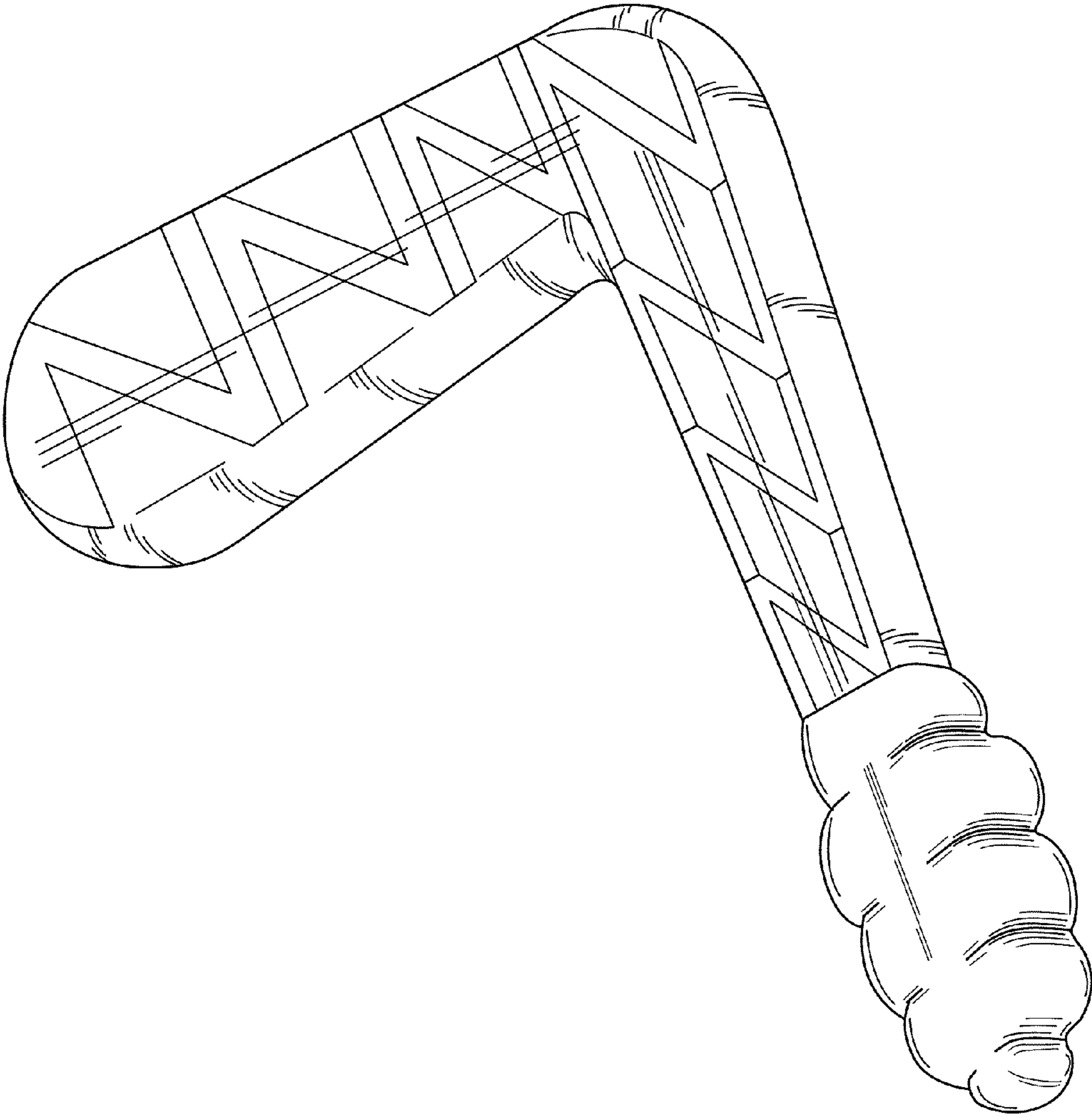

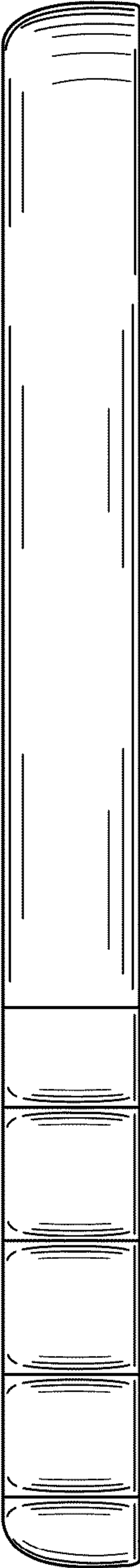

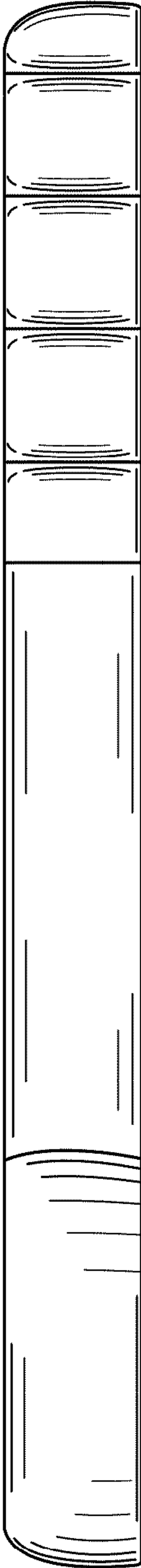

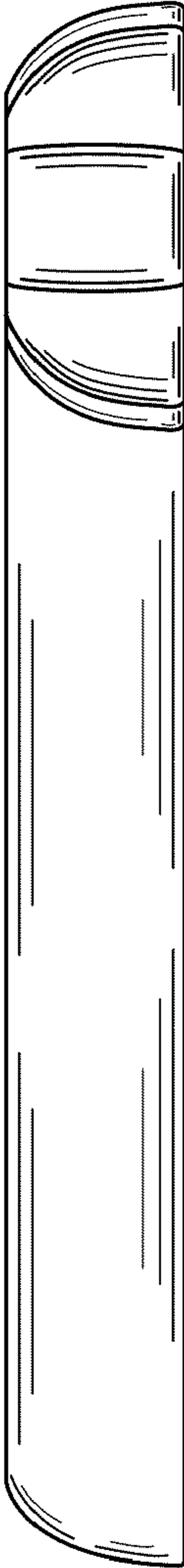

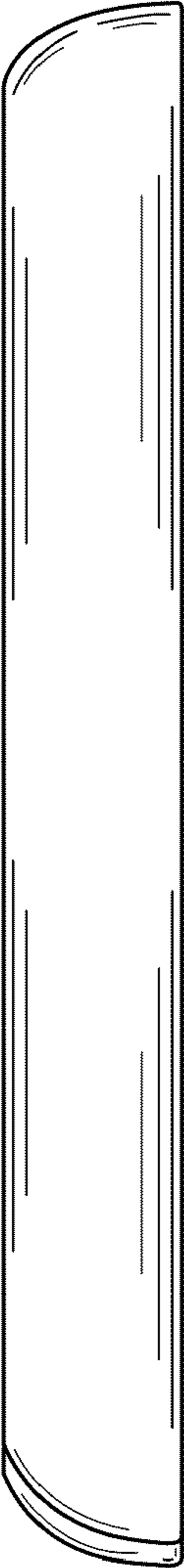

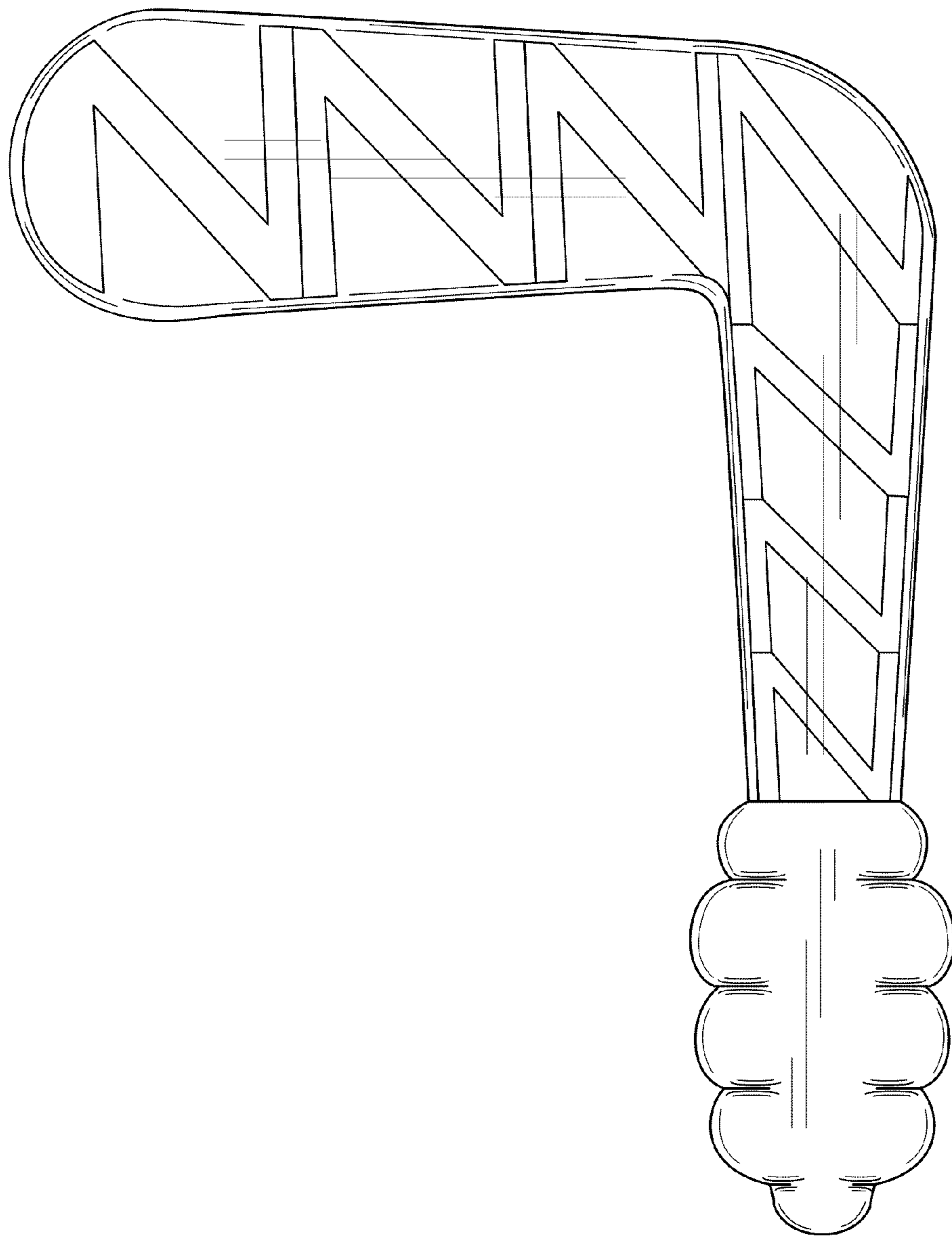

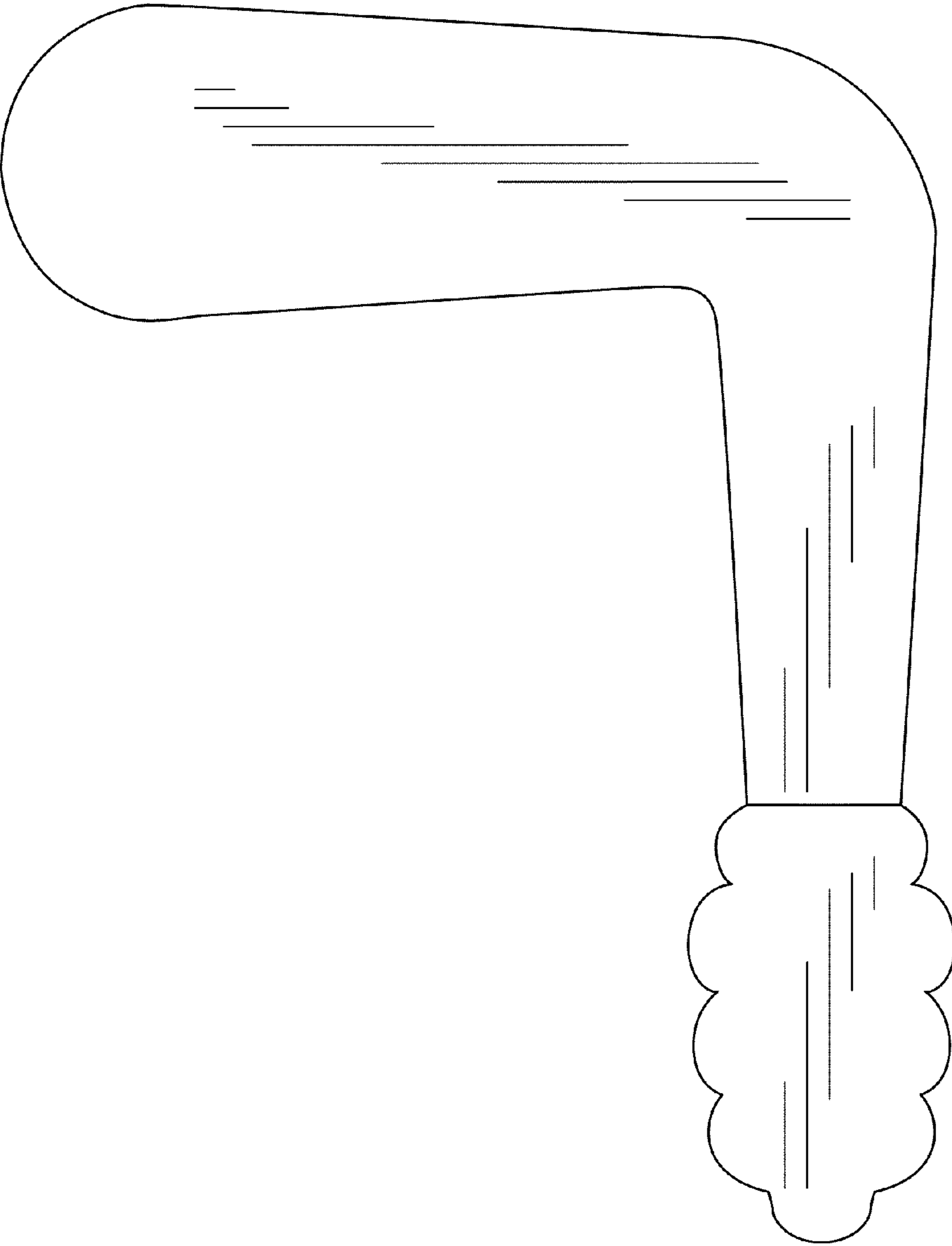
