(57) **CLAIM**

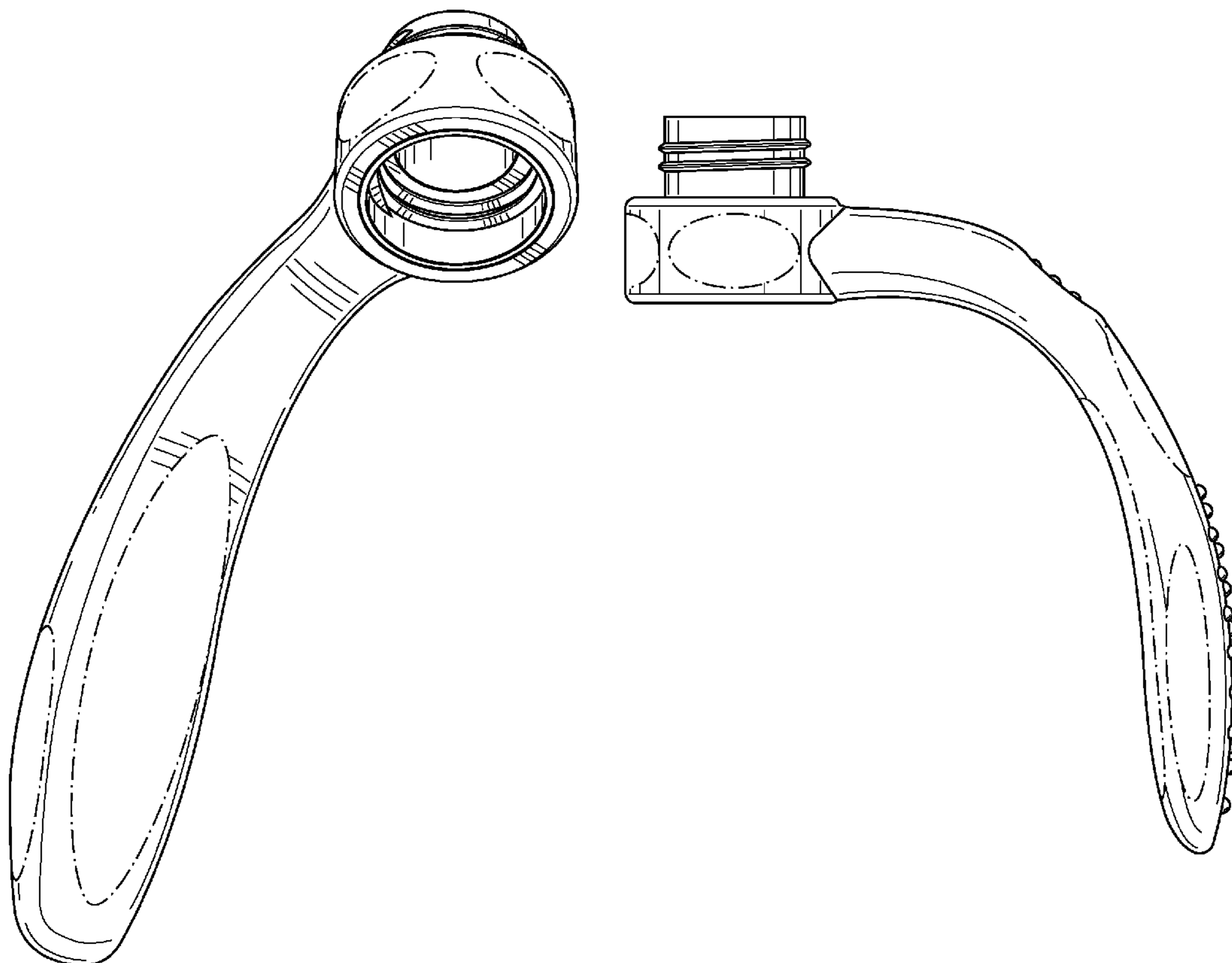
I claim the ornamental design for a grip, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear, right side perspective view of a grip showing my new design;
FIG. 2 is a bottom, front, left side perspective view thereof;
FIG. 3 is a right side elevation view thereof, shown at a reduced scale;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

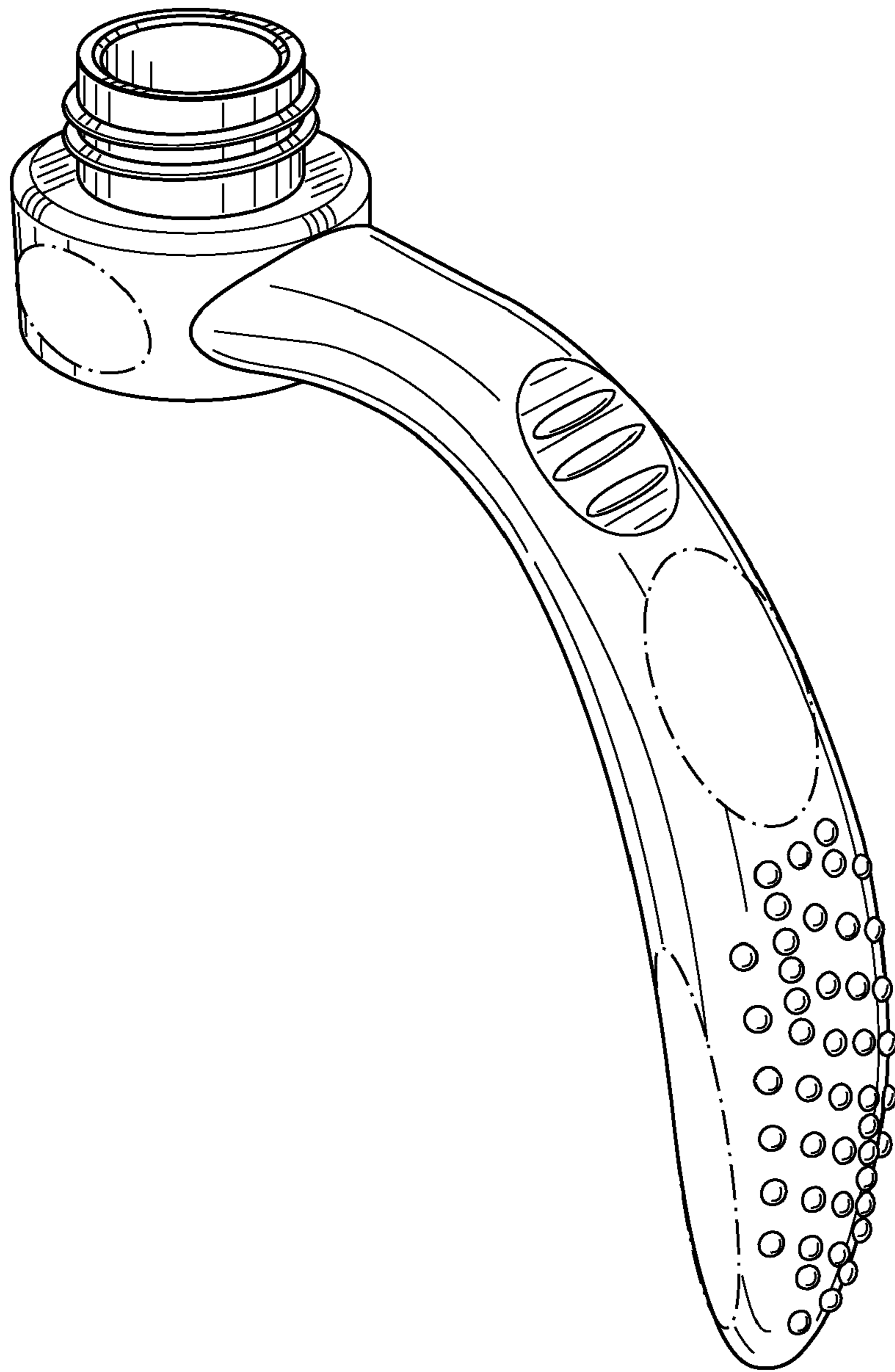

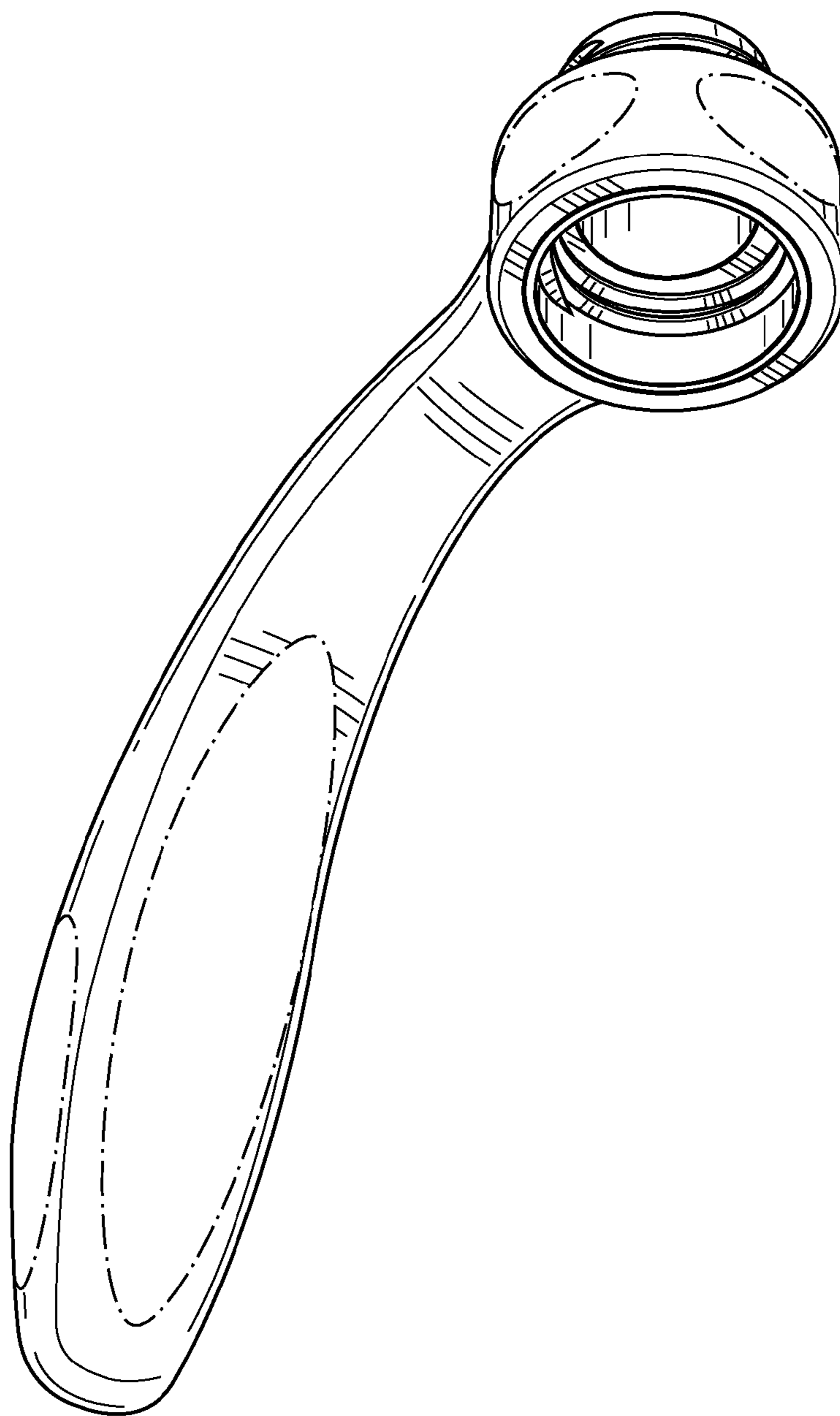

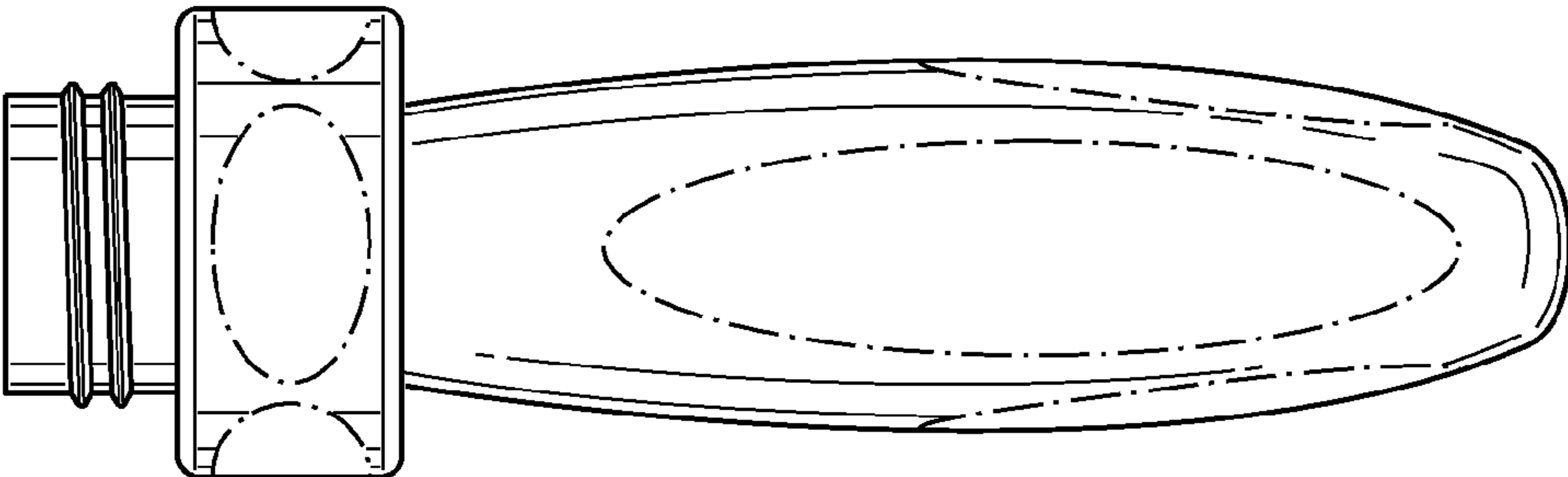

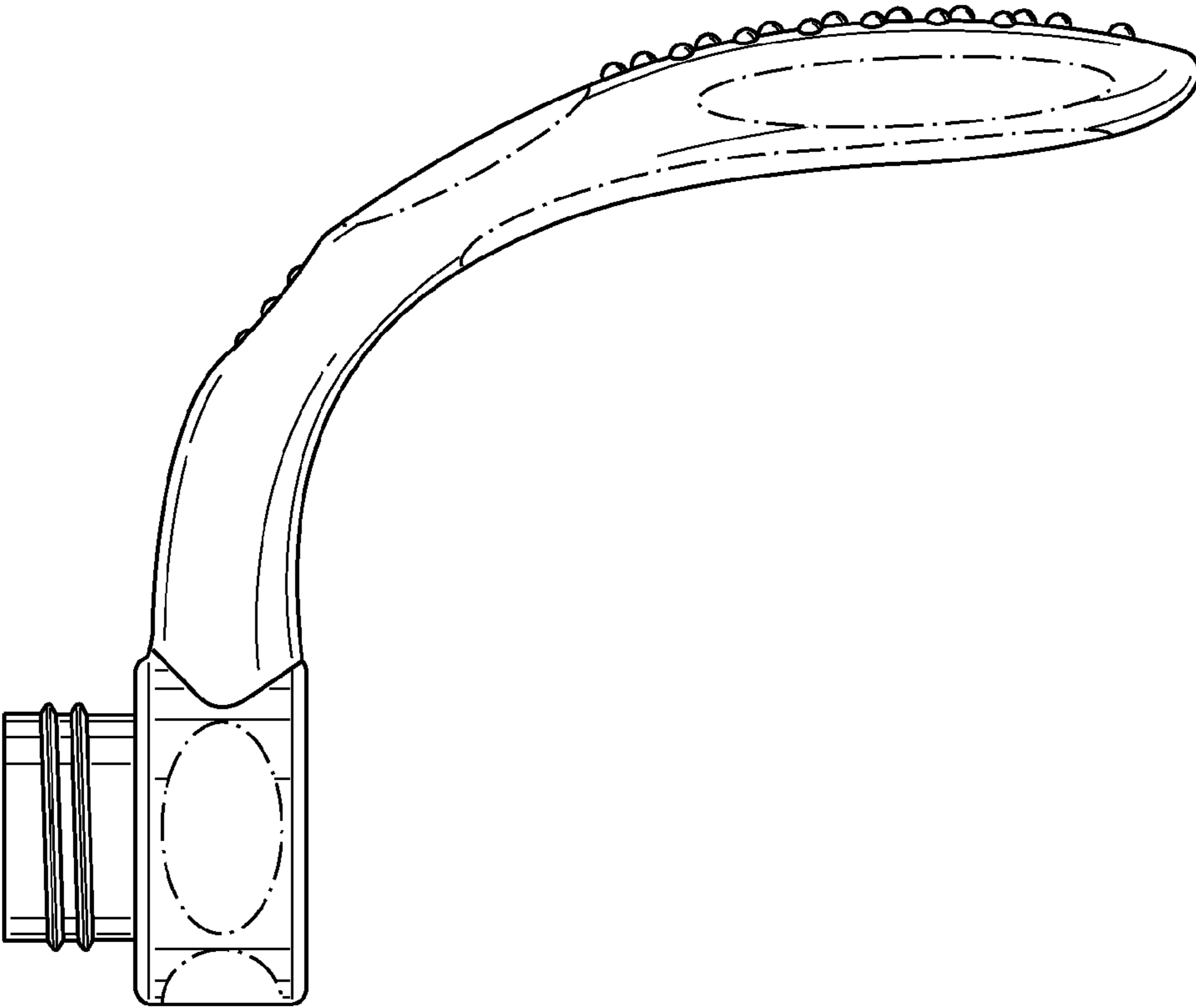

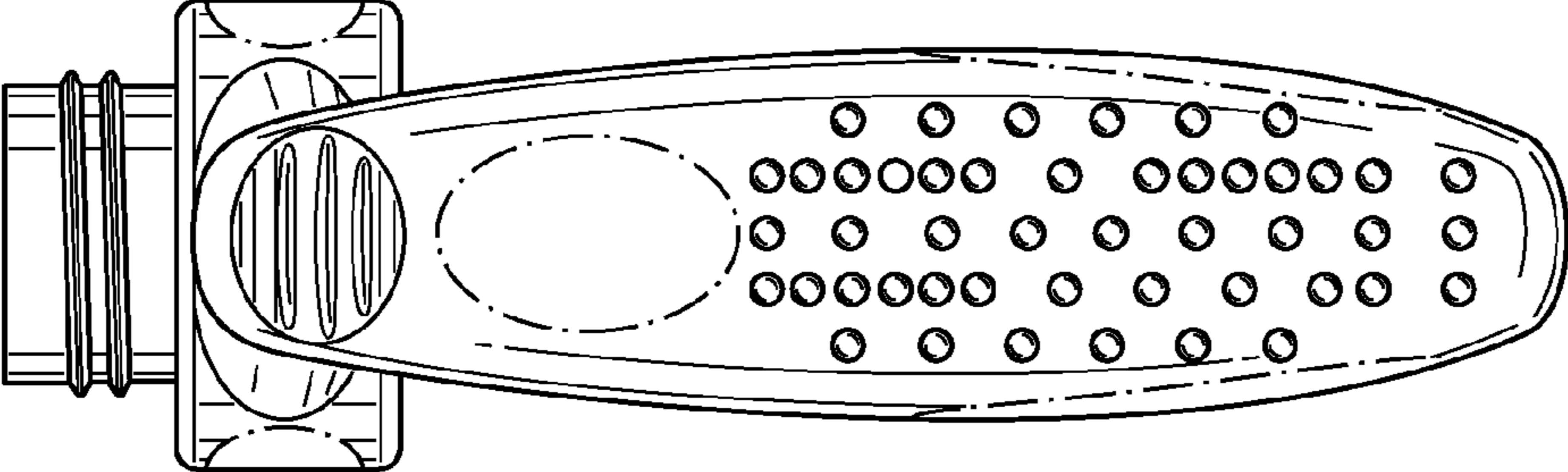

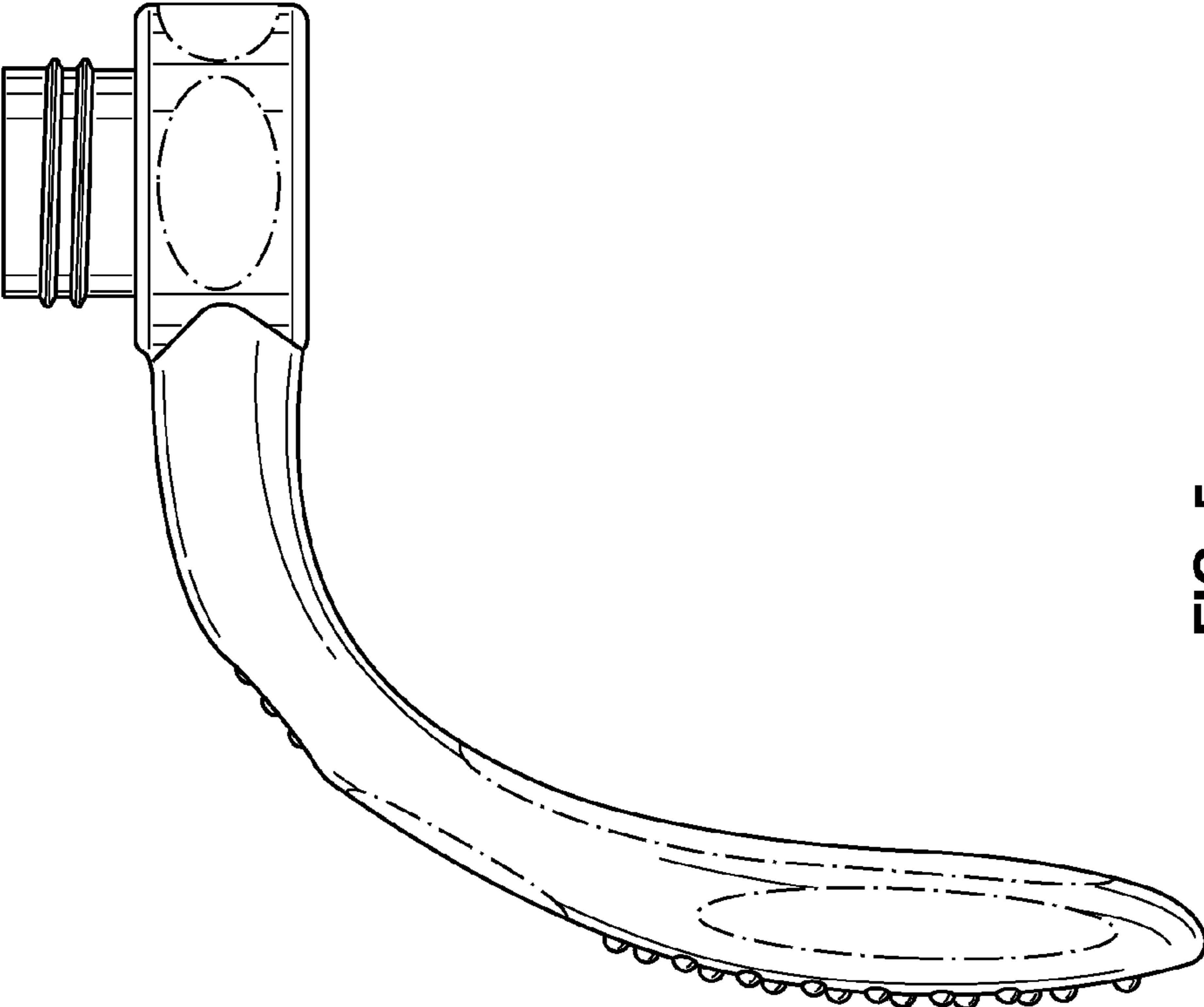

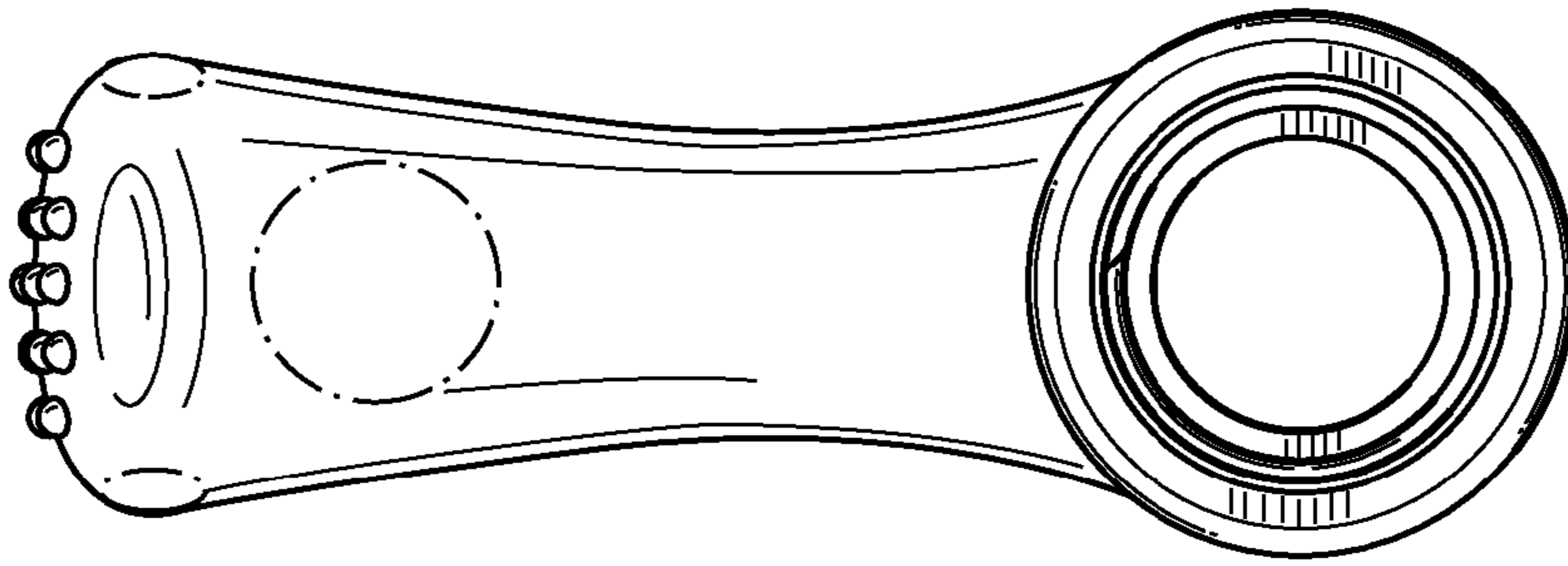

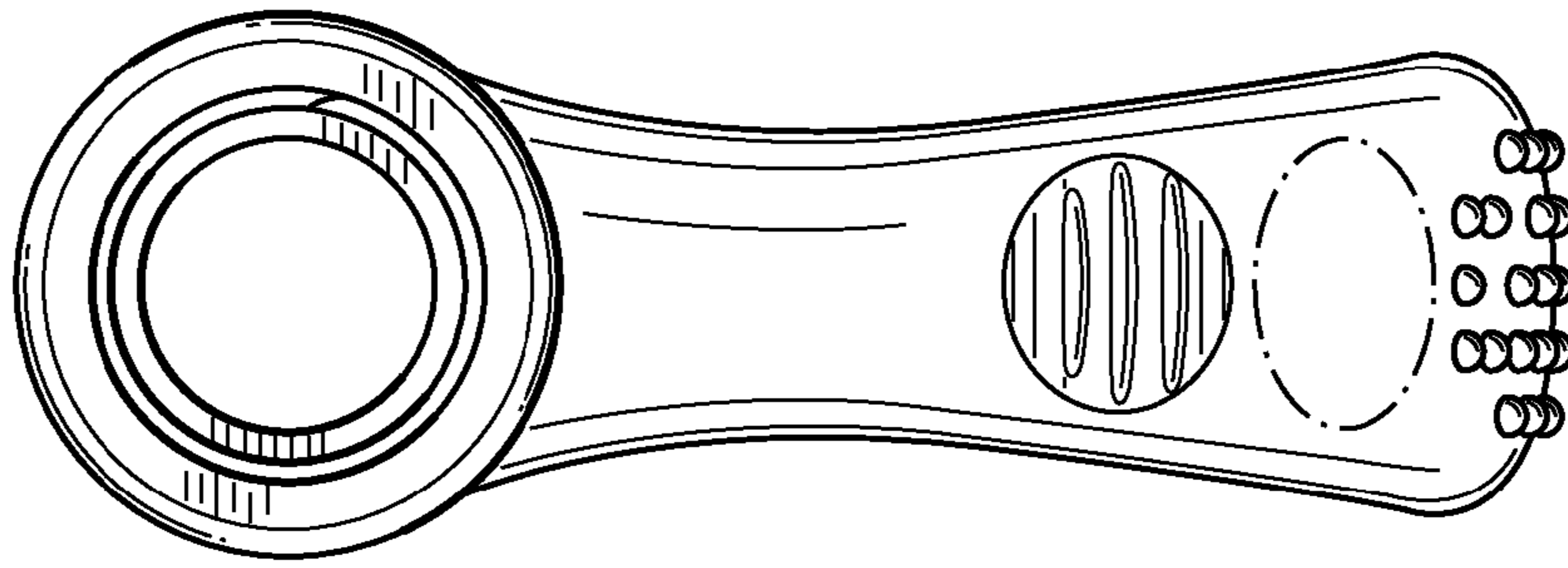
