of FIG. 1;

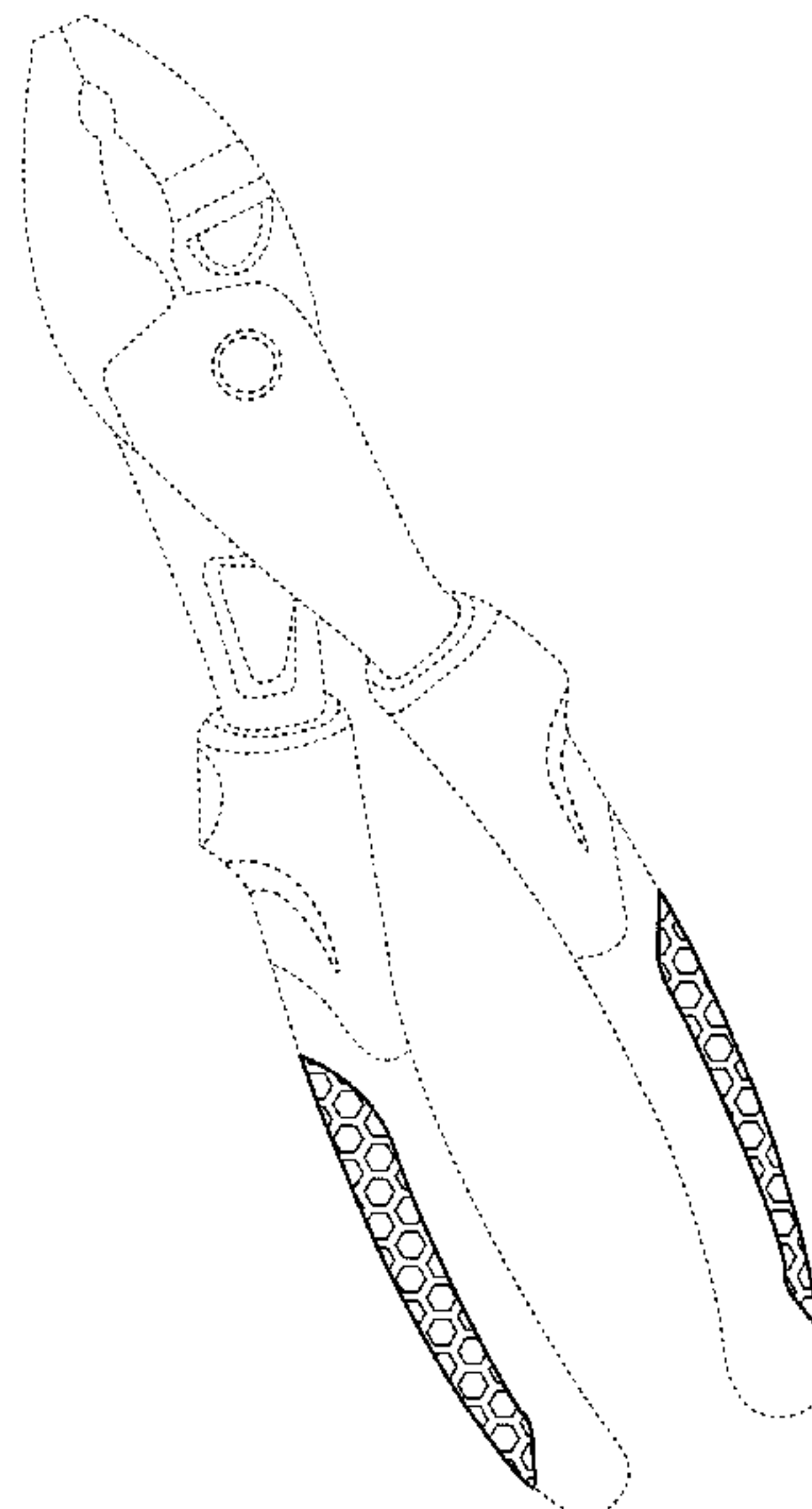
FIG. 5 is a plan view of the bottom side of the tool handle of

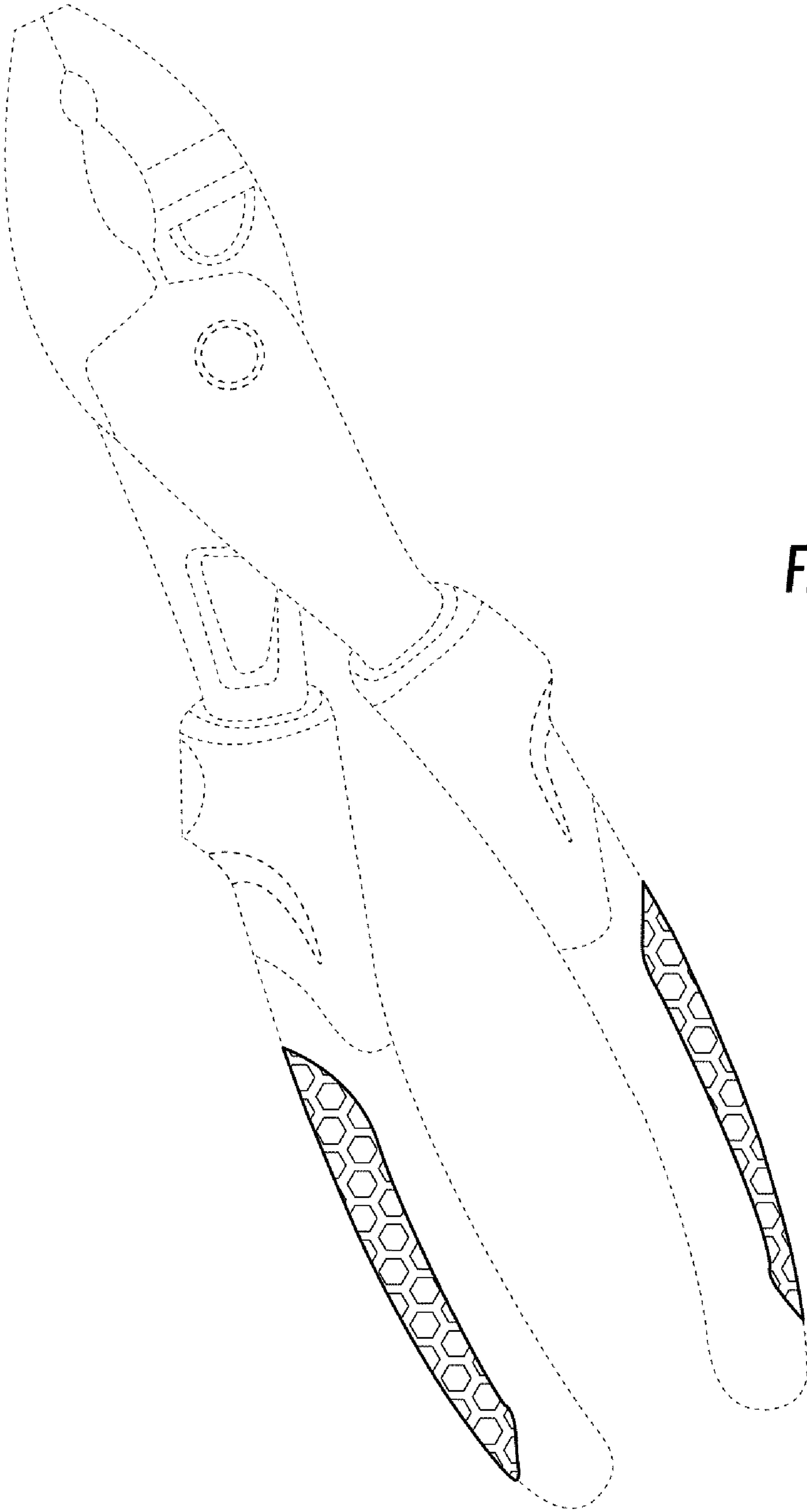

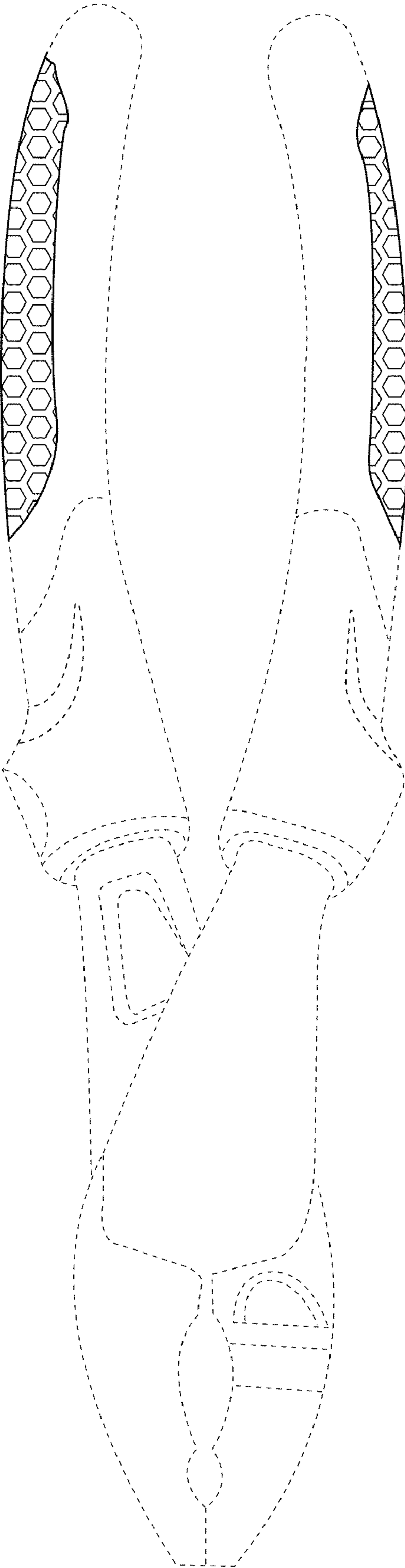

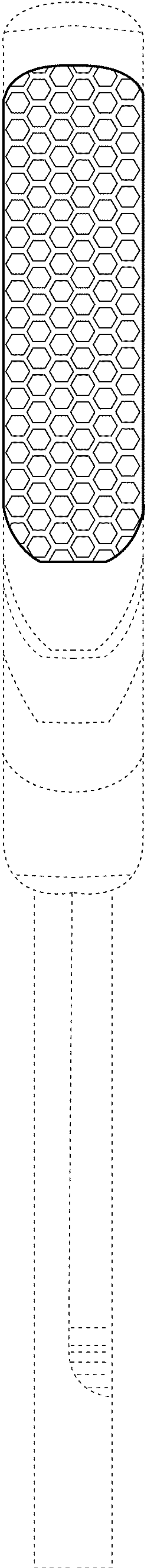

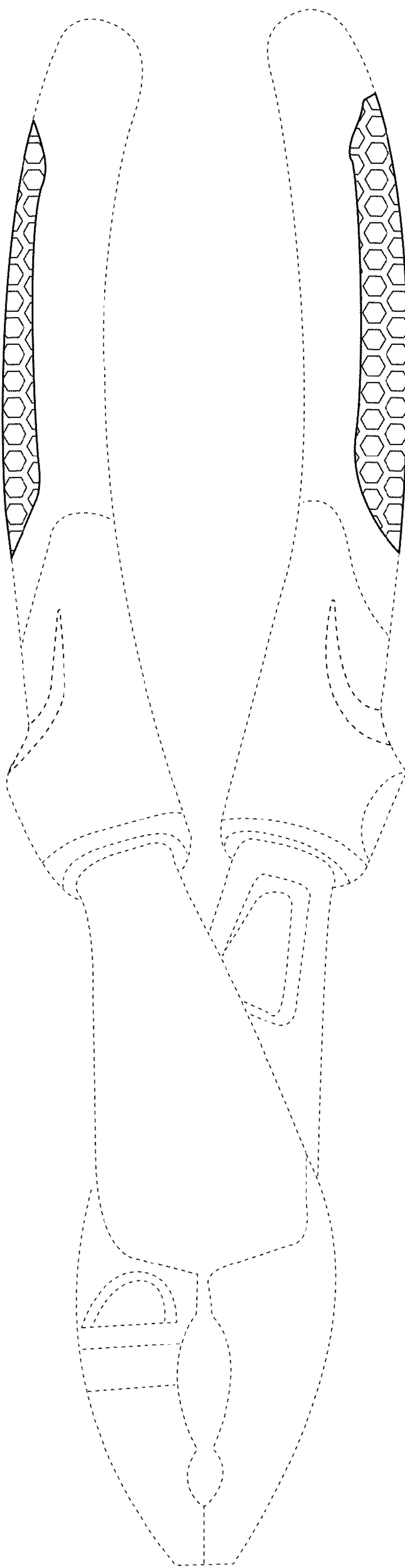

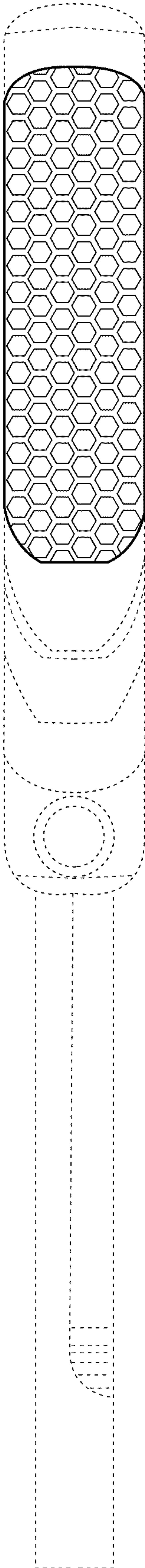

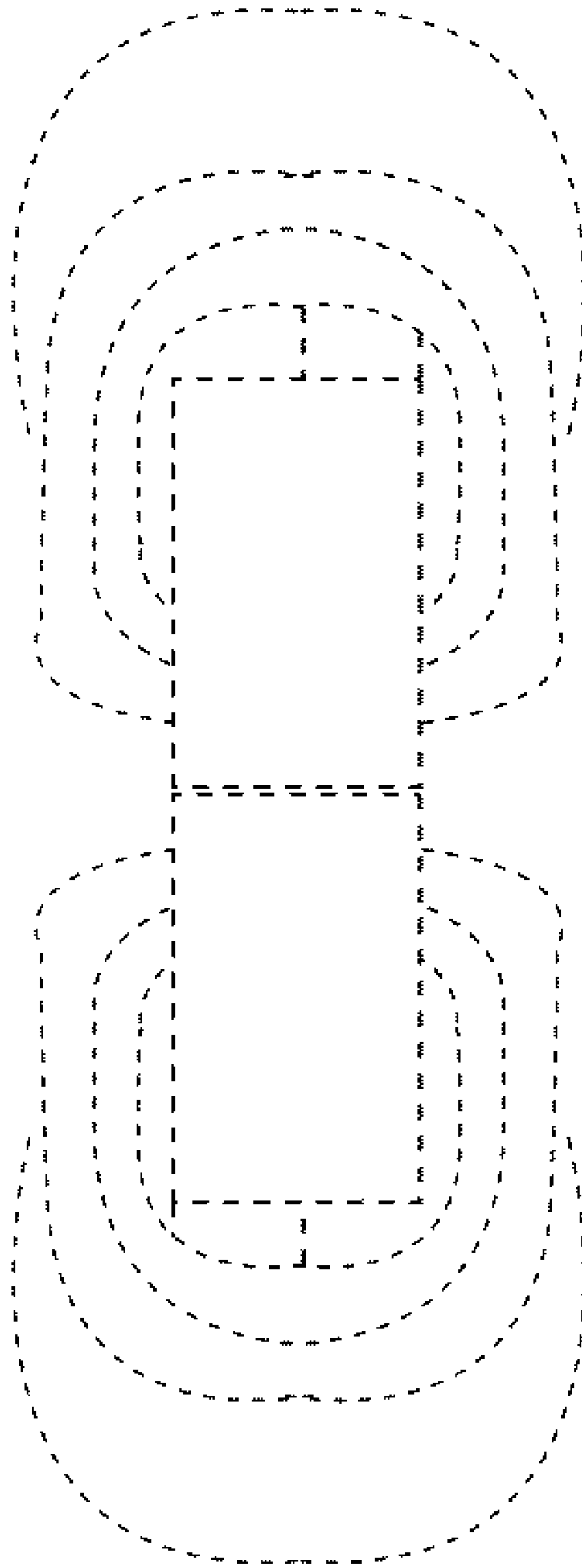

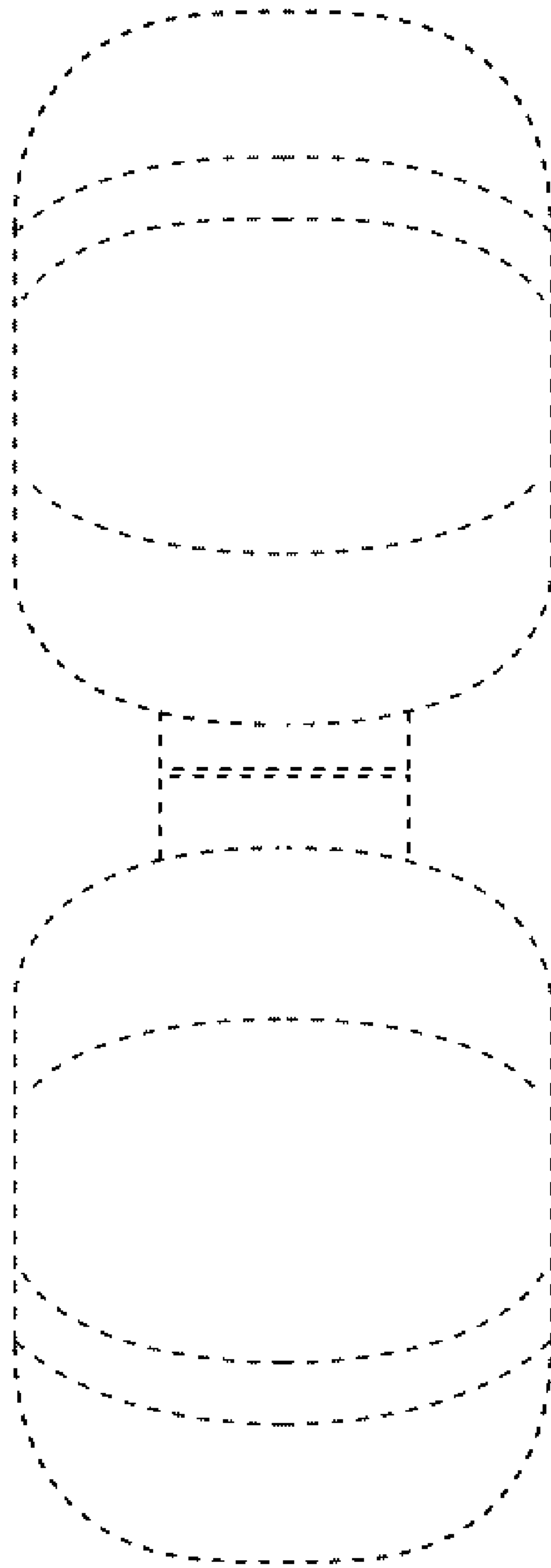
