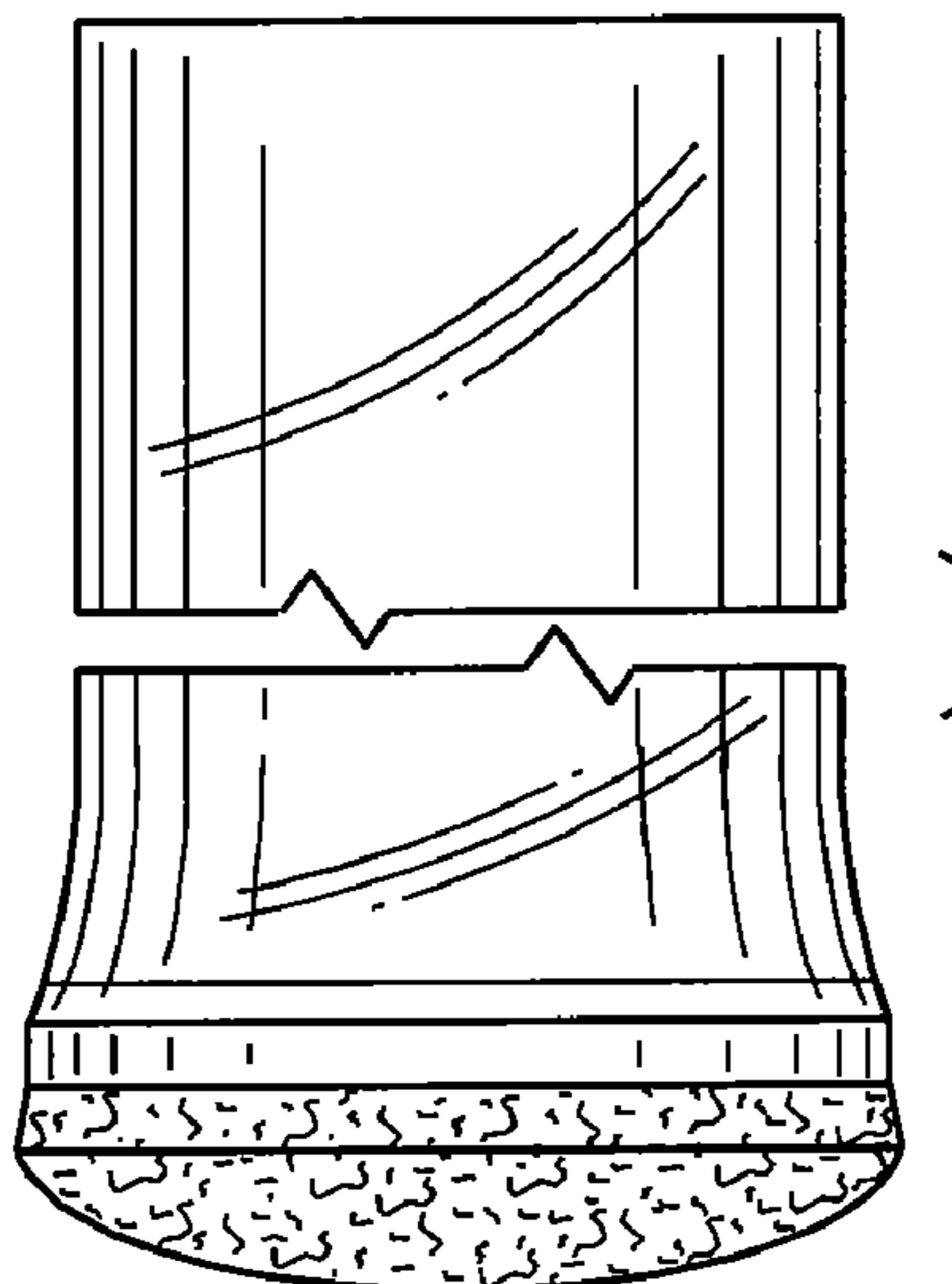

(57) **CLAIM**
The ornamental design for a furniture tip, as shown and described.

DESCRIPTION

FIG. 1 is a first isometric view showing the top and front of a furniture tip shown broken away to indicate no specific length;
FIG. 2 is a second isometric view showing the bottom and front view of a furniture tip shown broken away to indicate no specific length; and,
FIG. 3 is a side elevational view of a first side of the furniture tip of FIG. 1.

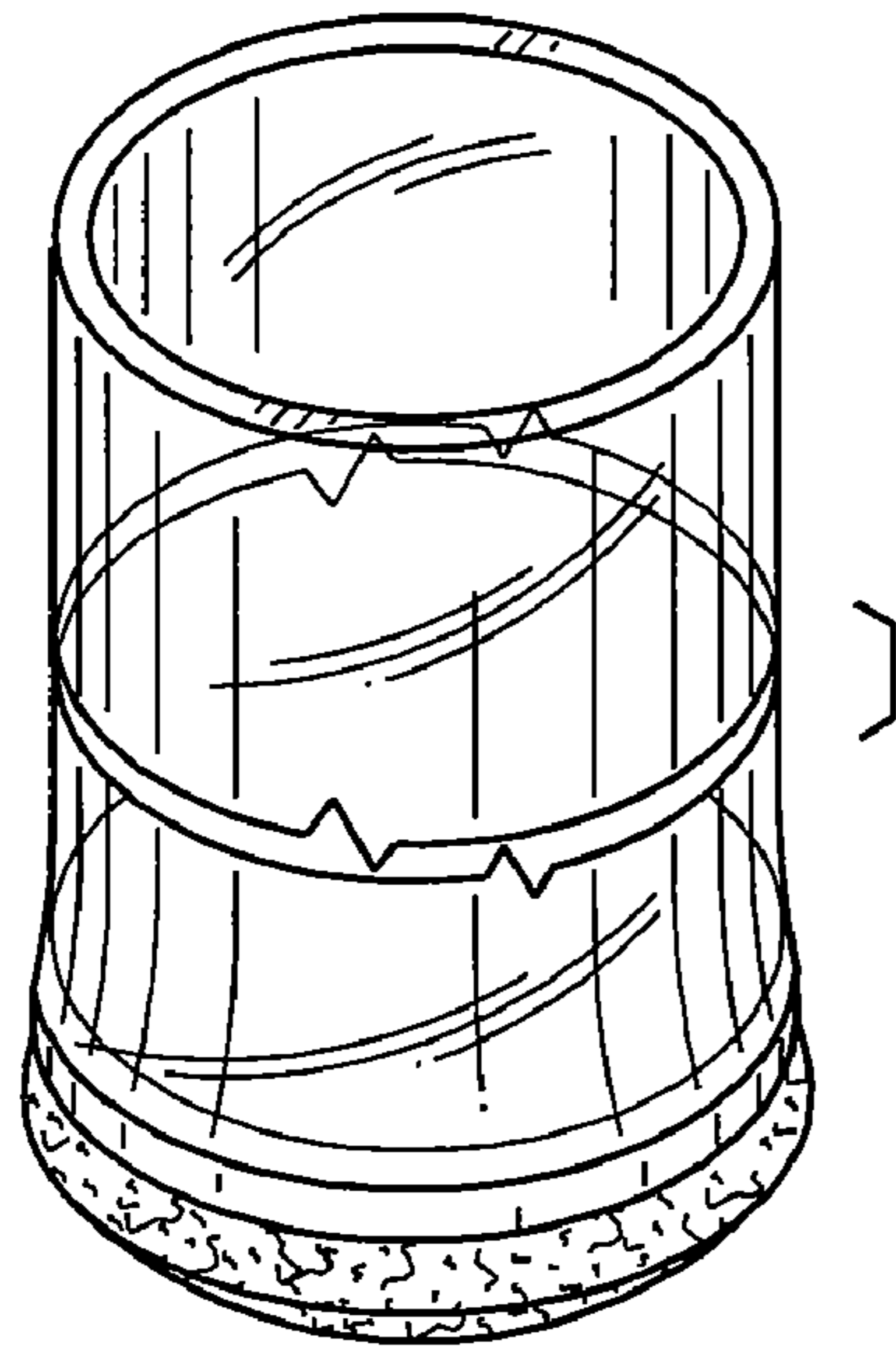

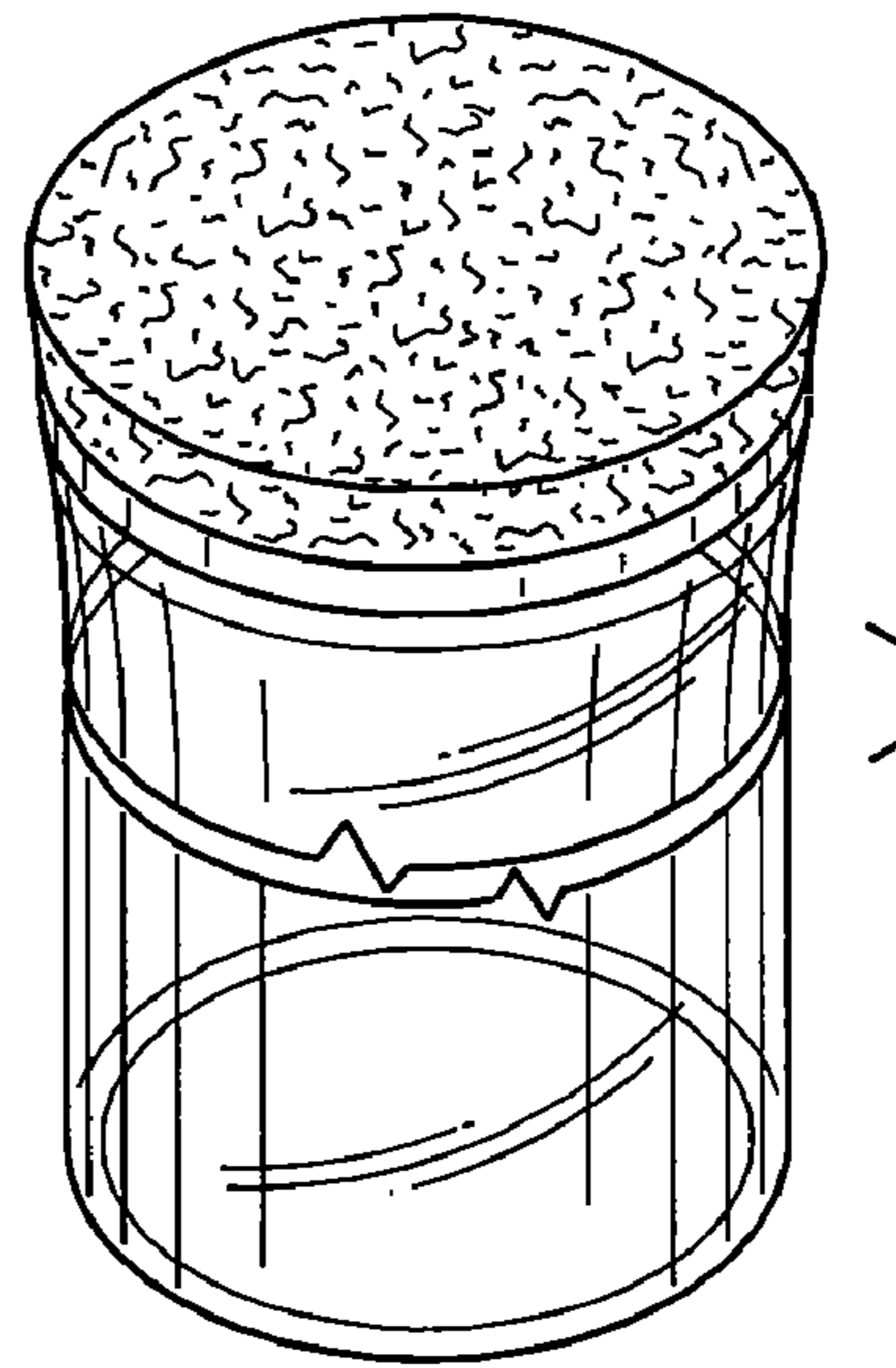

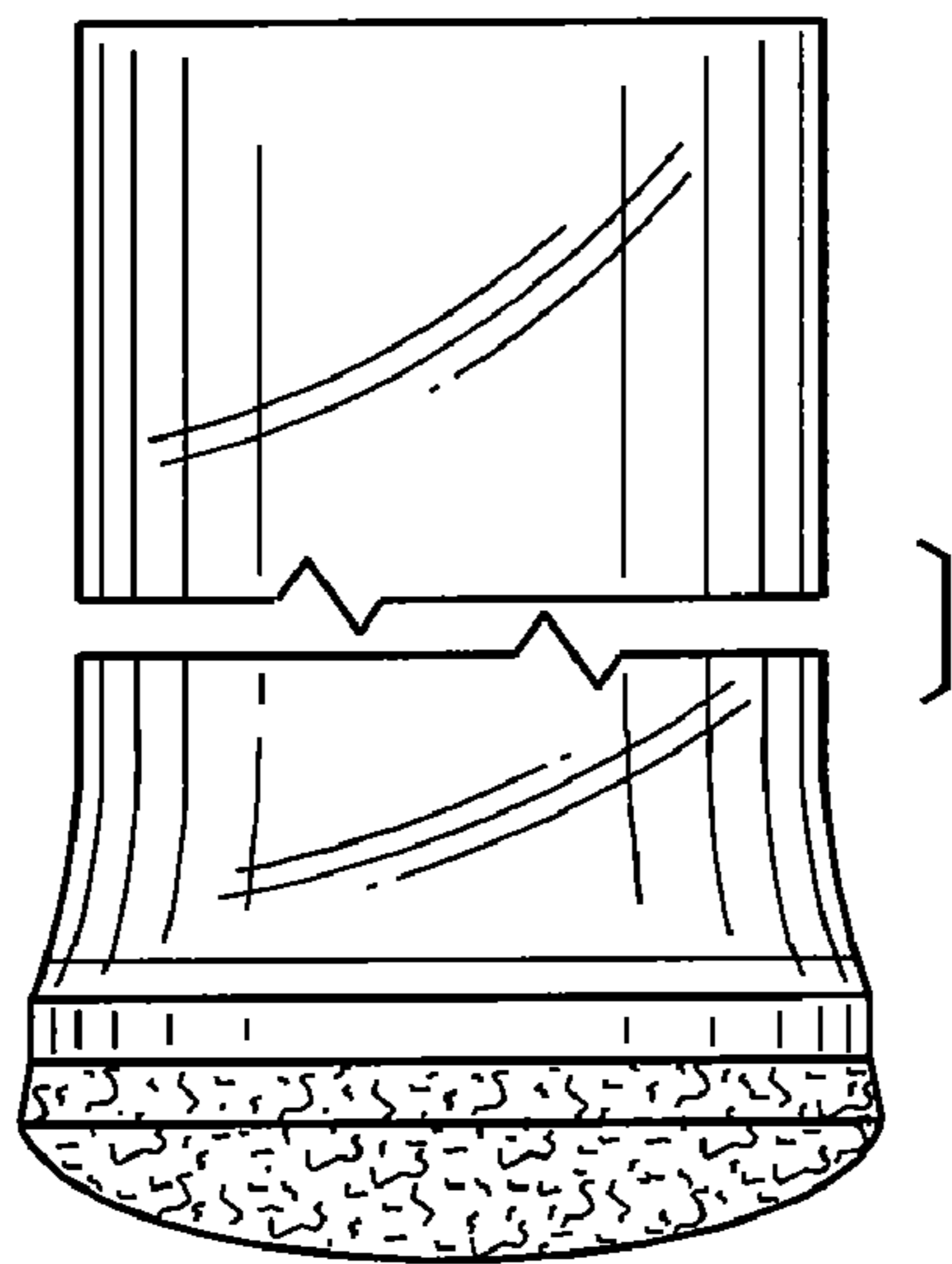
