DESCRIPTION

FIG. 1 is a front view of an electric brake actuator for vehicles showing our new design;

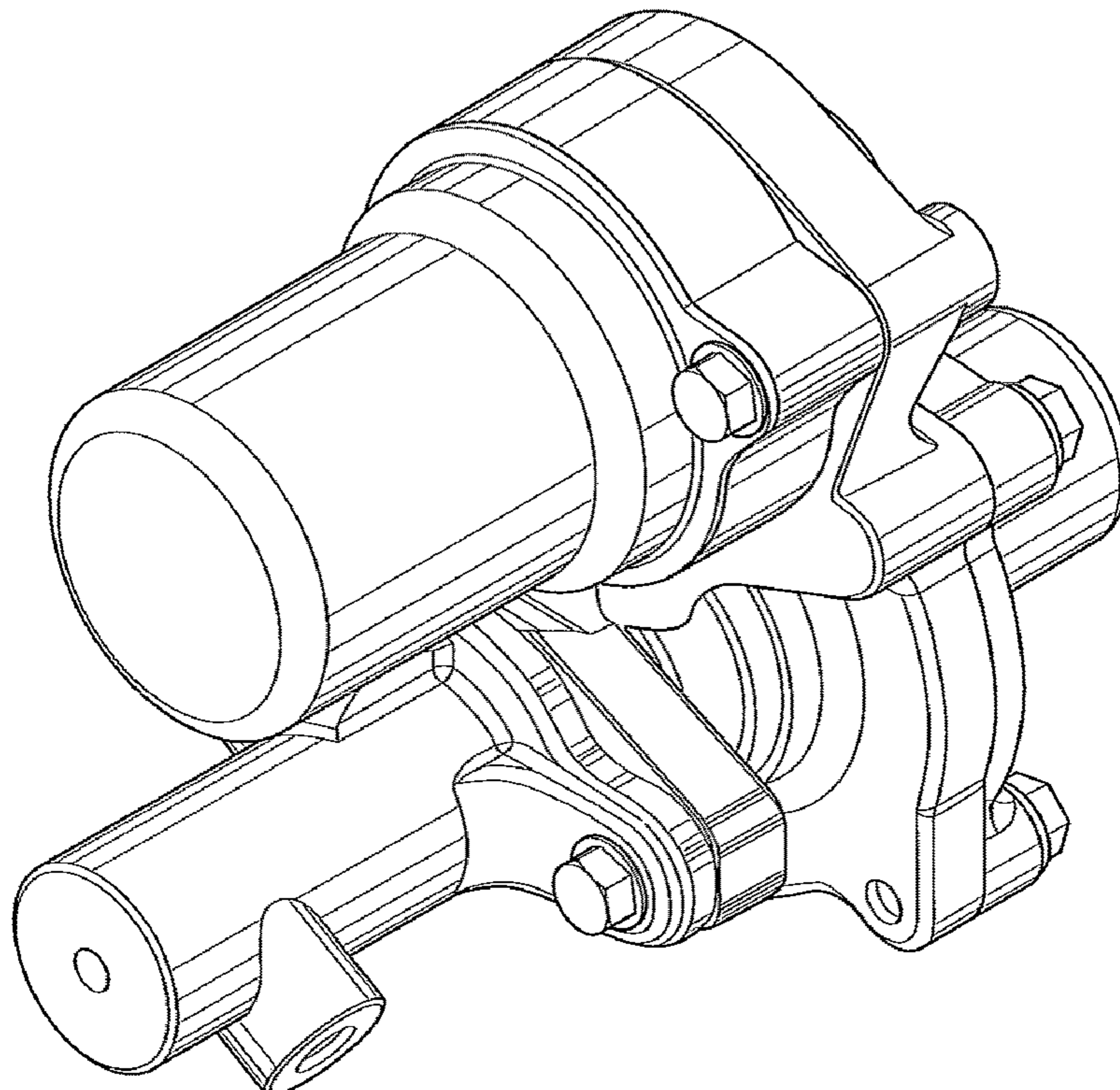

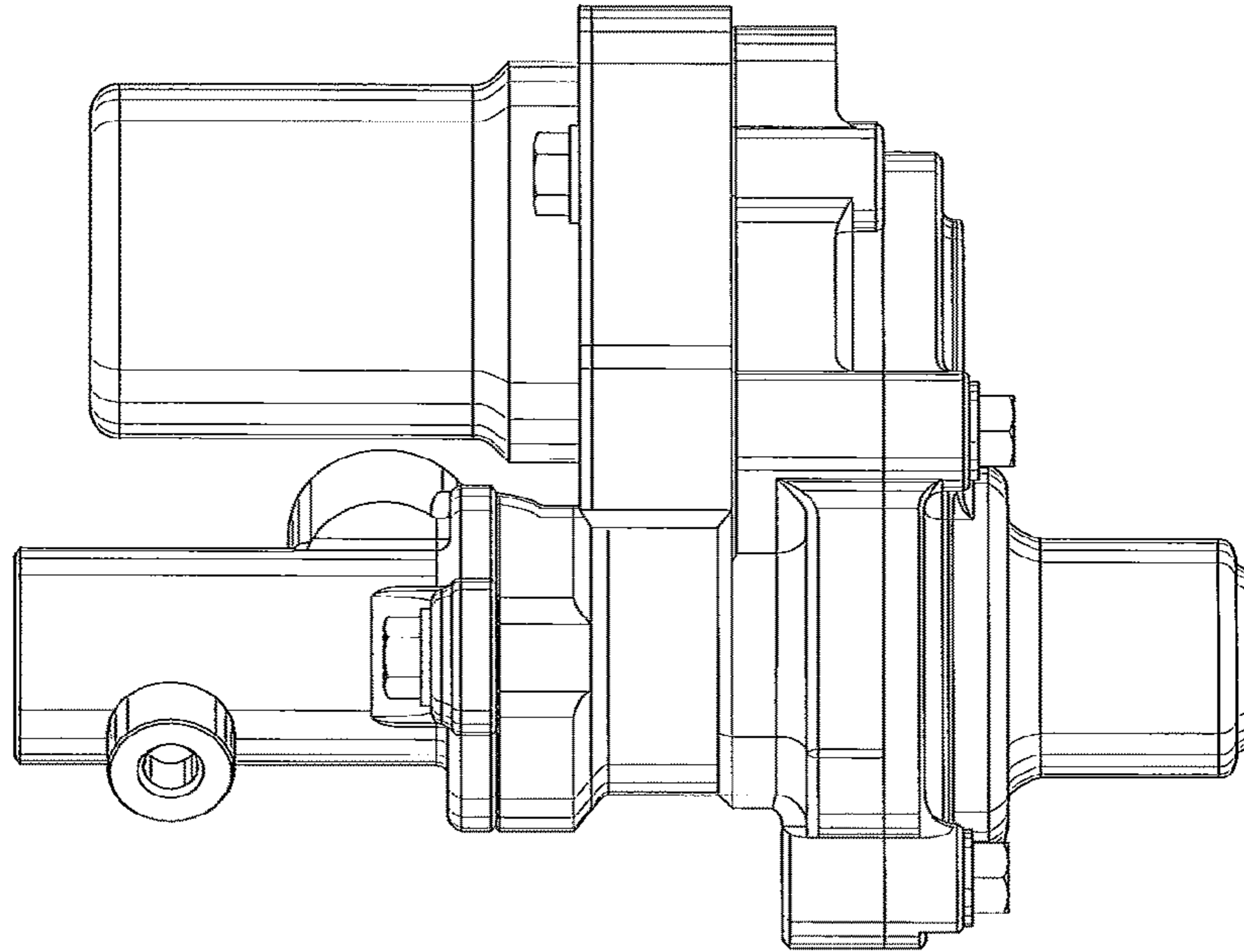

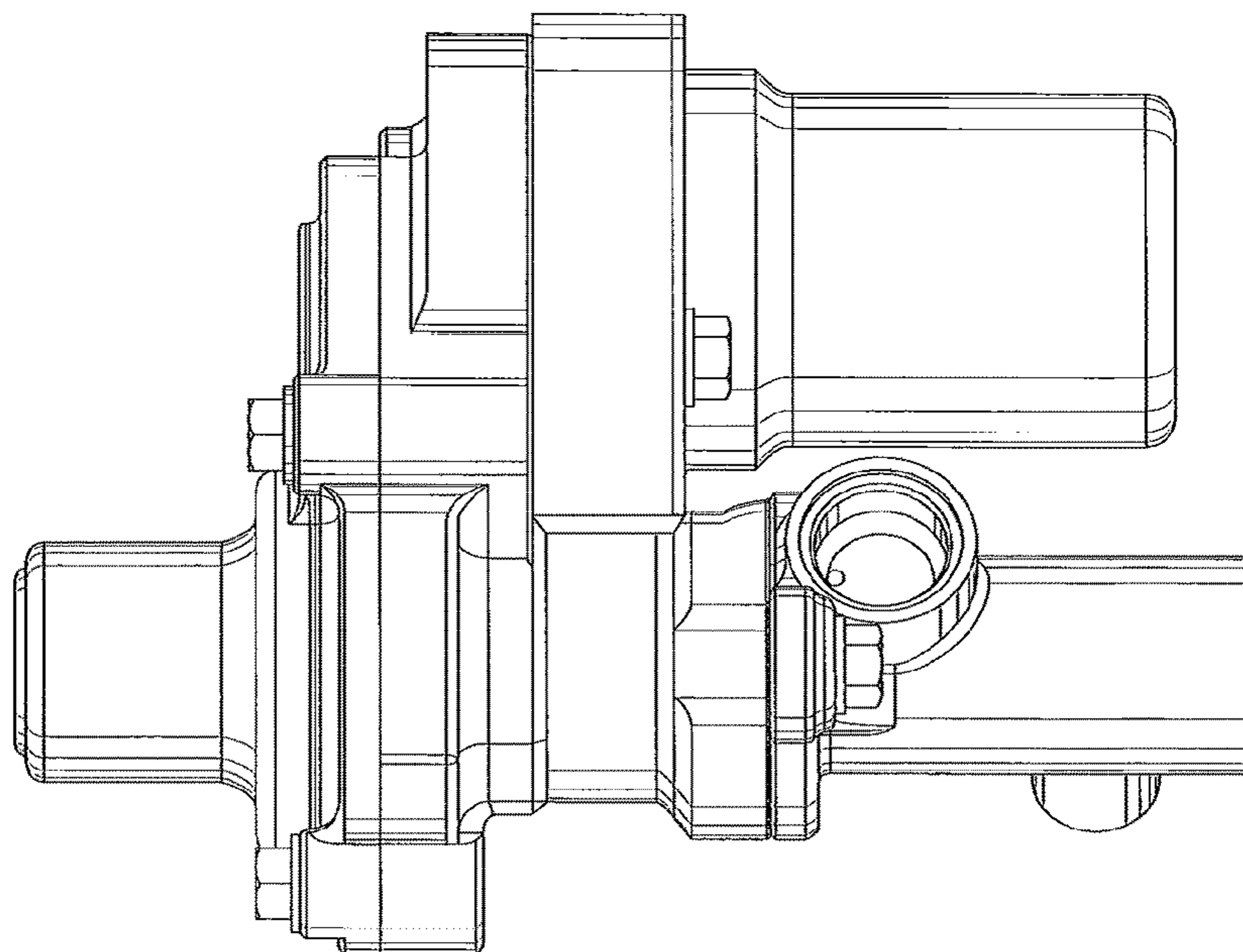

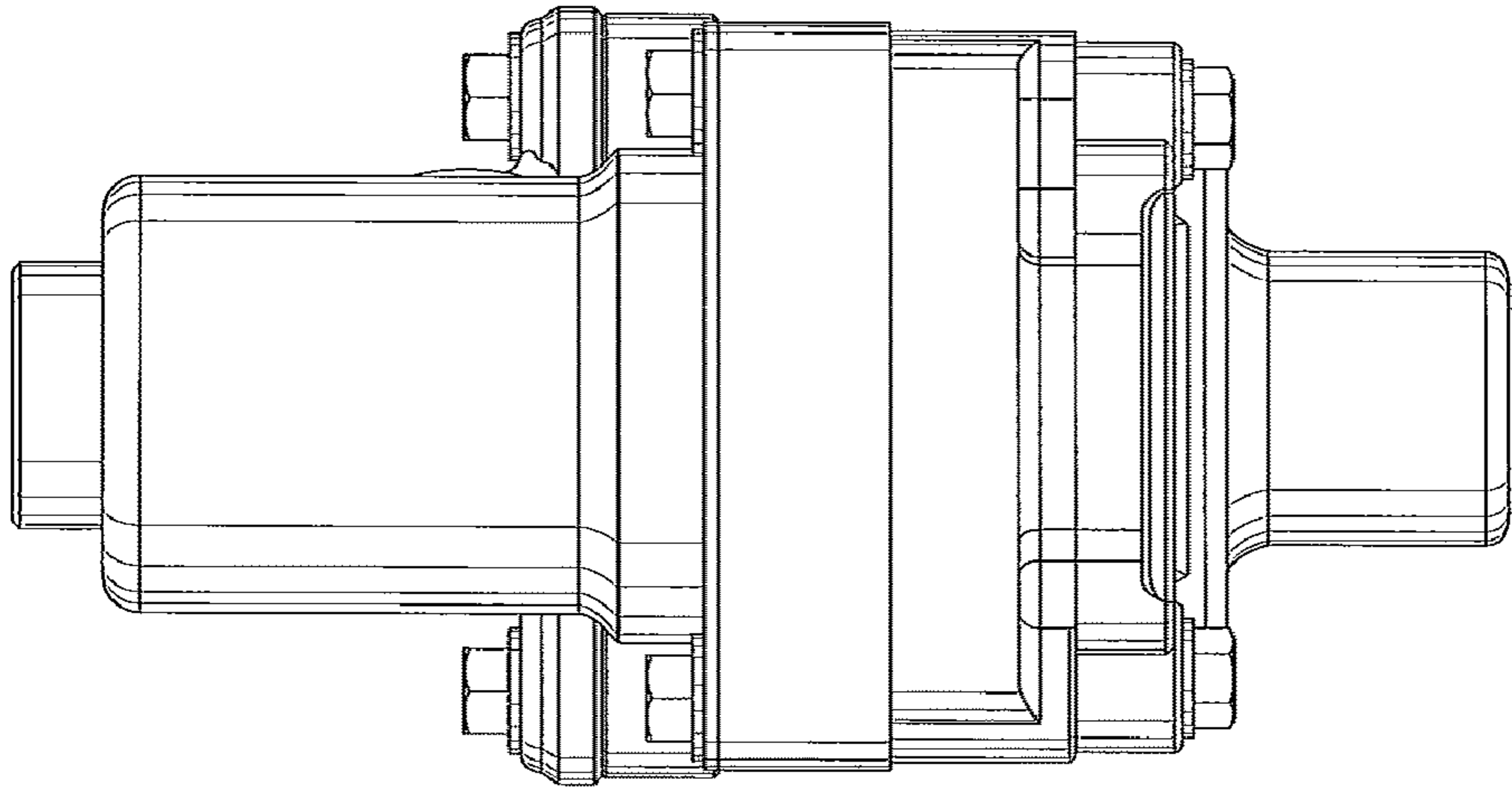

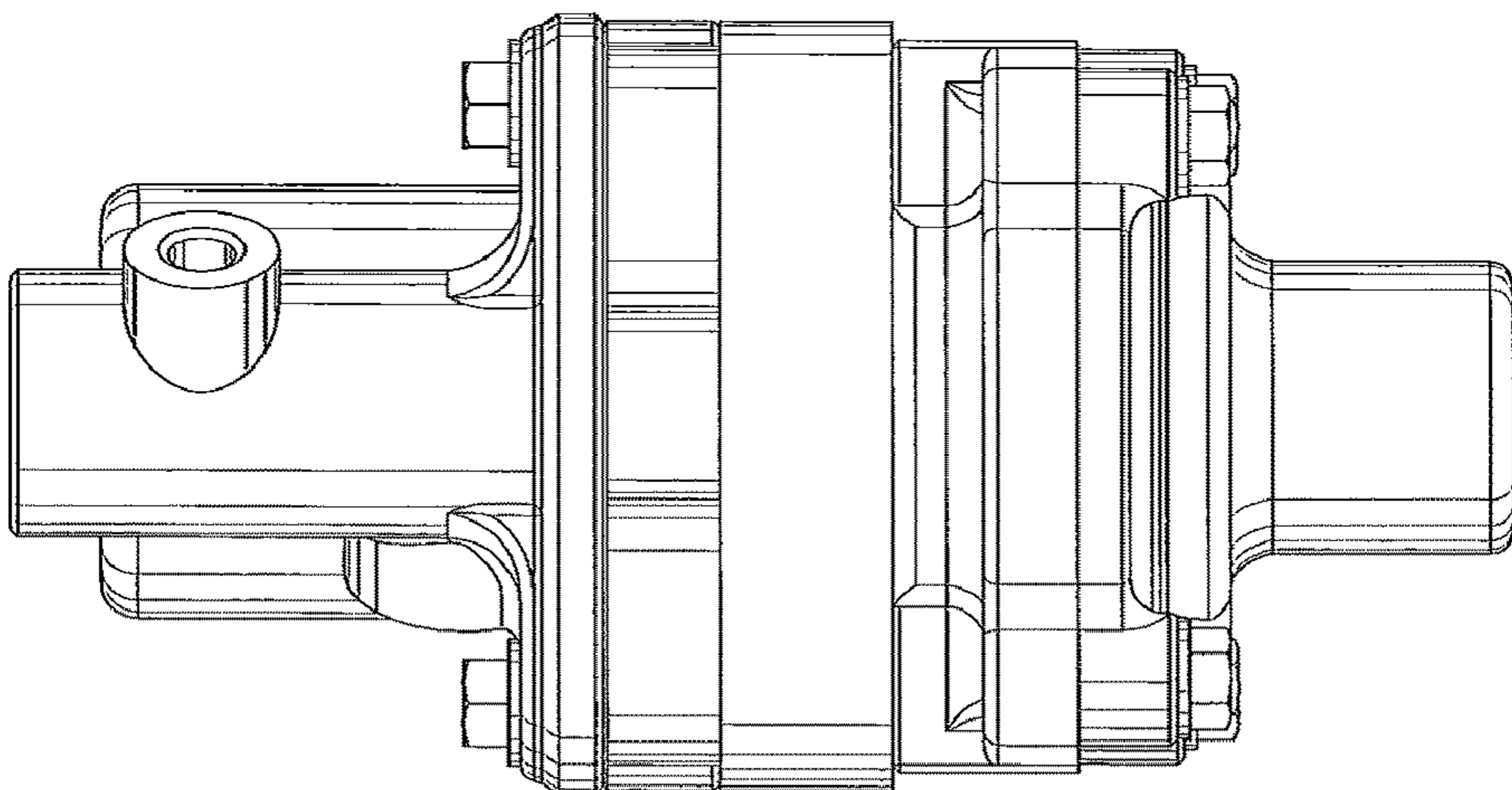

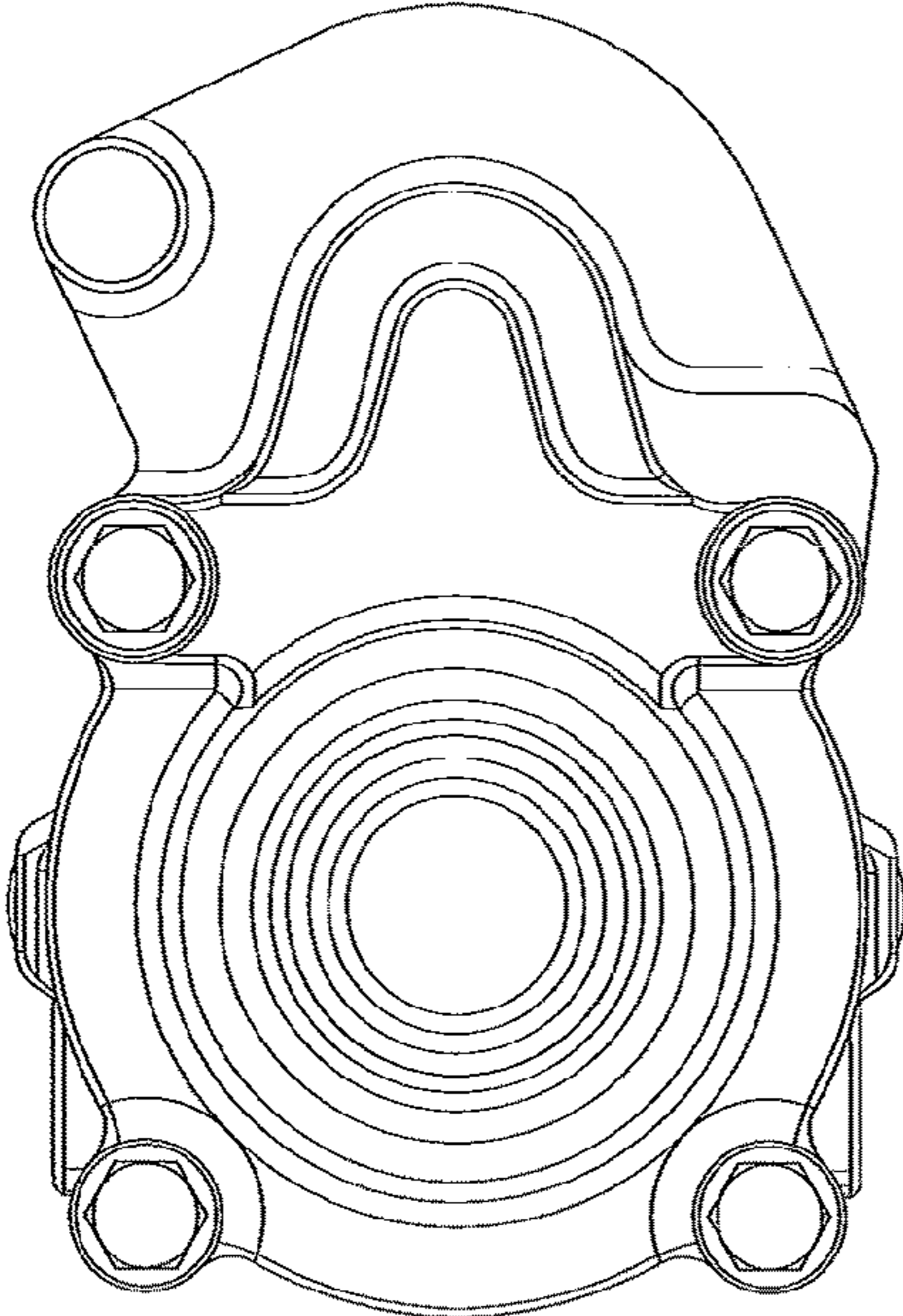

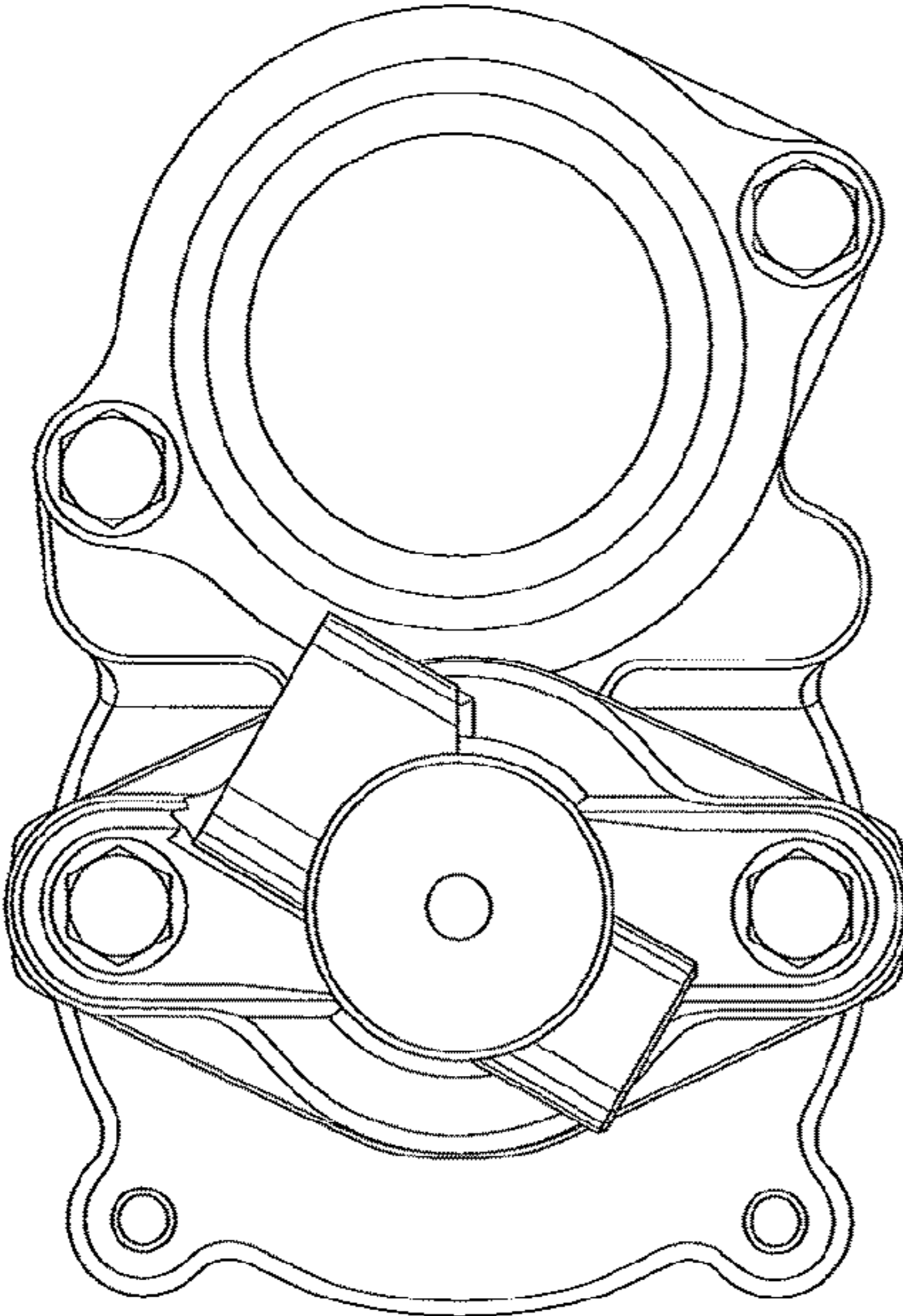

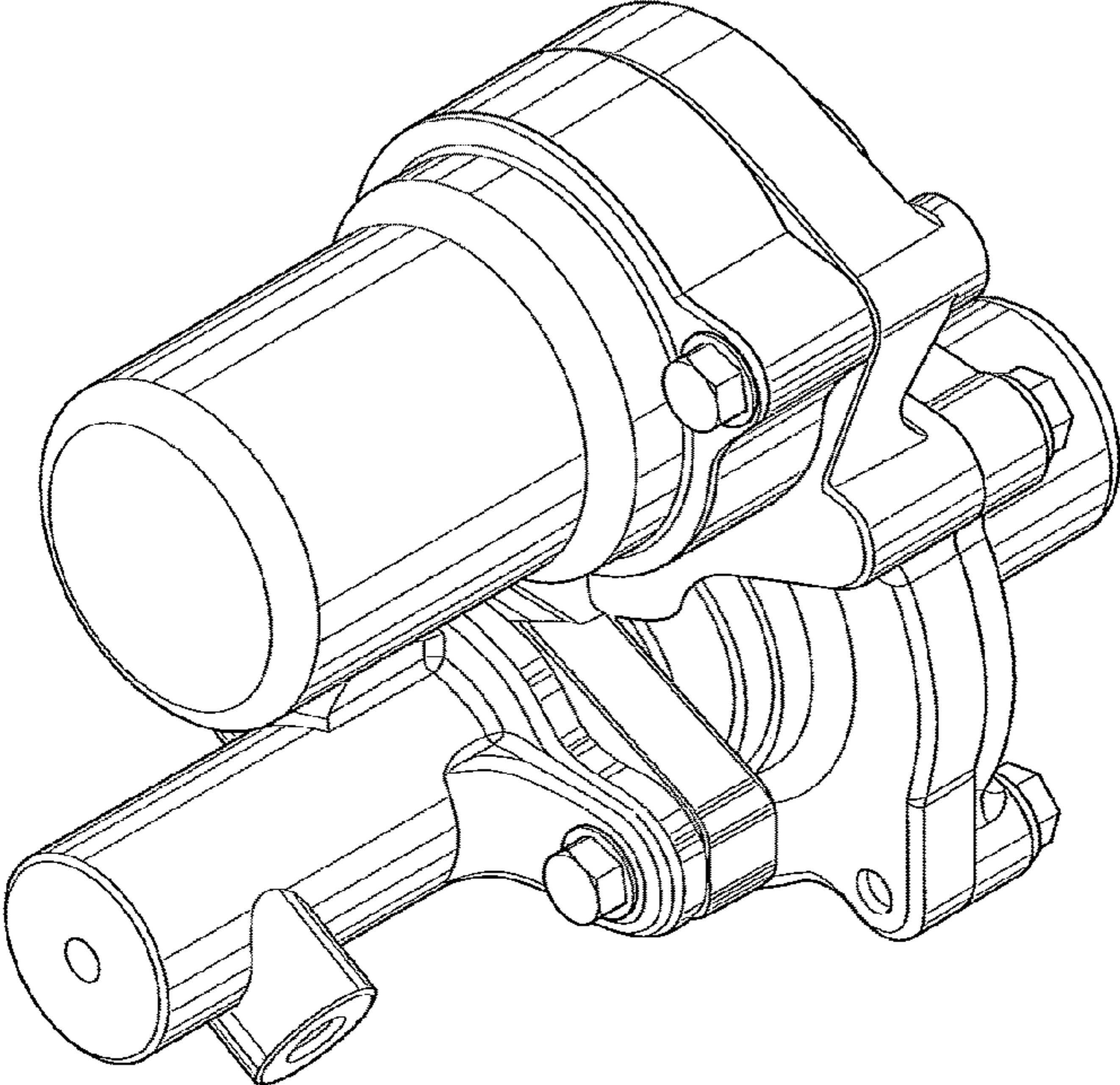
