(57) **CLAIM**

We claim the ornamental design for an LCD television receiver, as shown and described.

DESCRIPTION

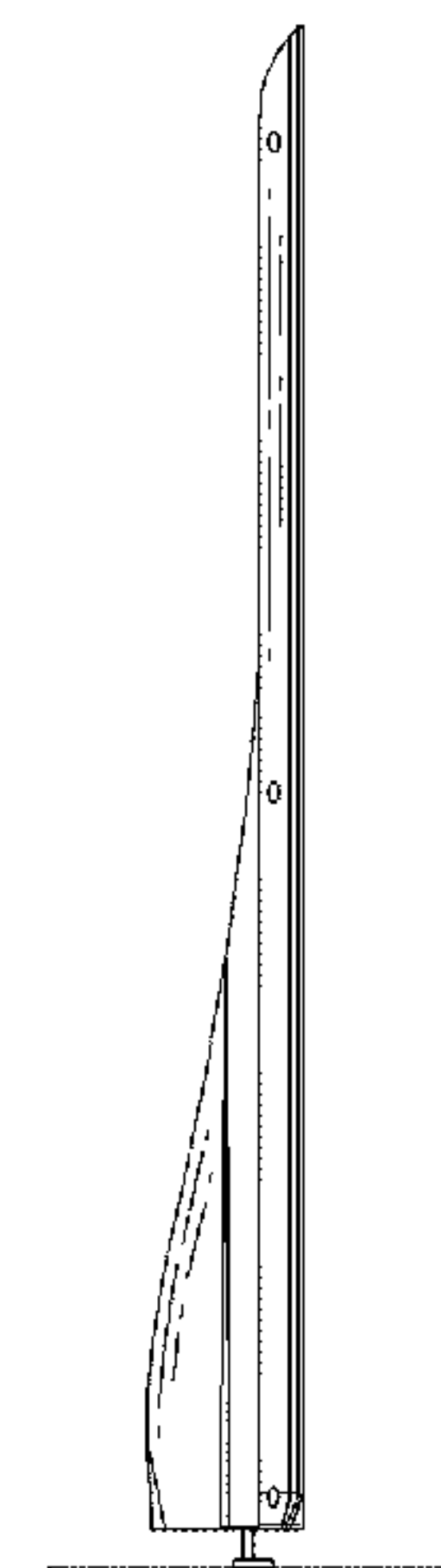
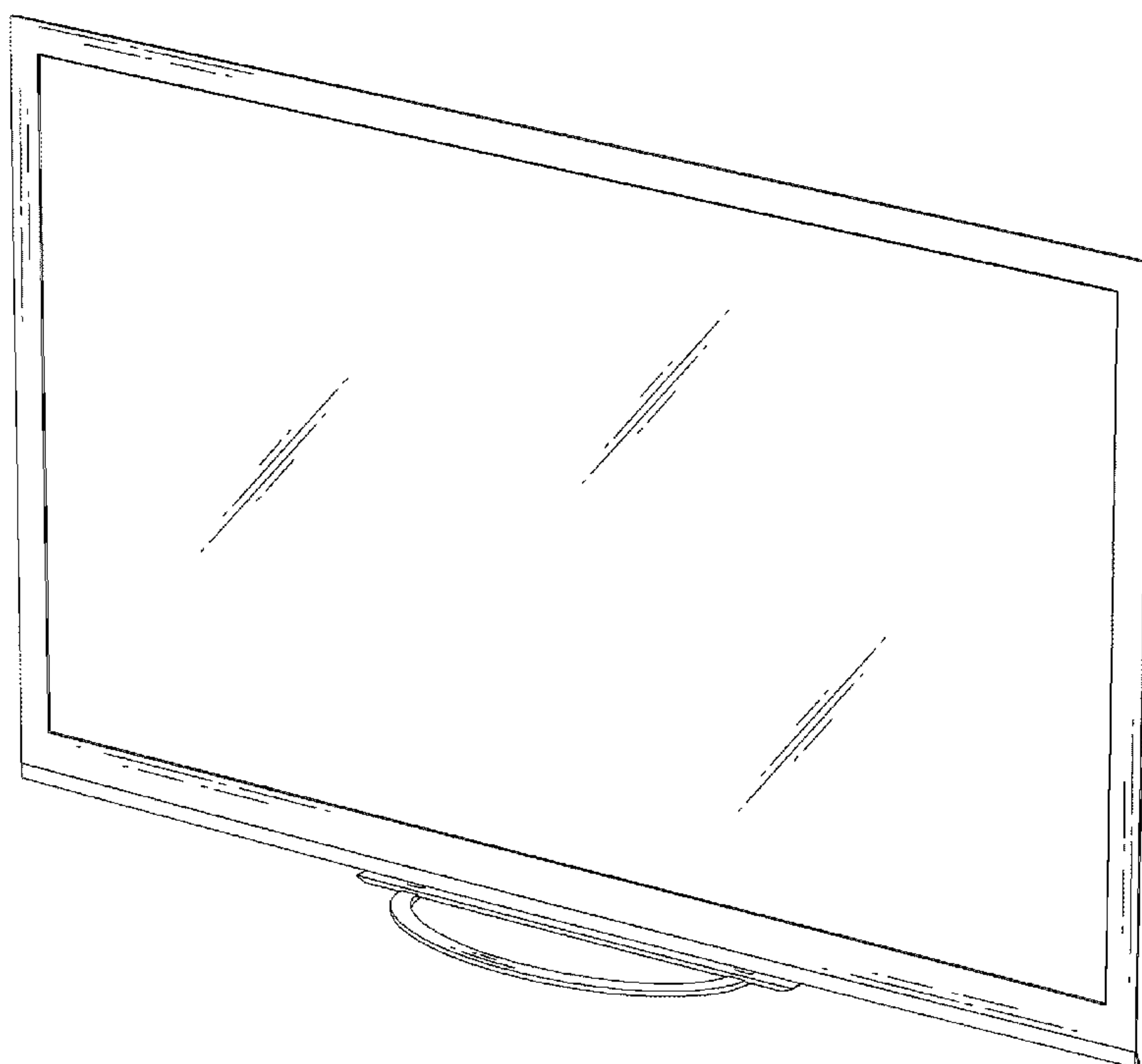

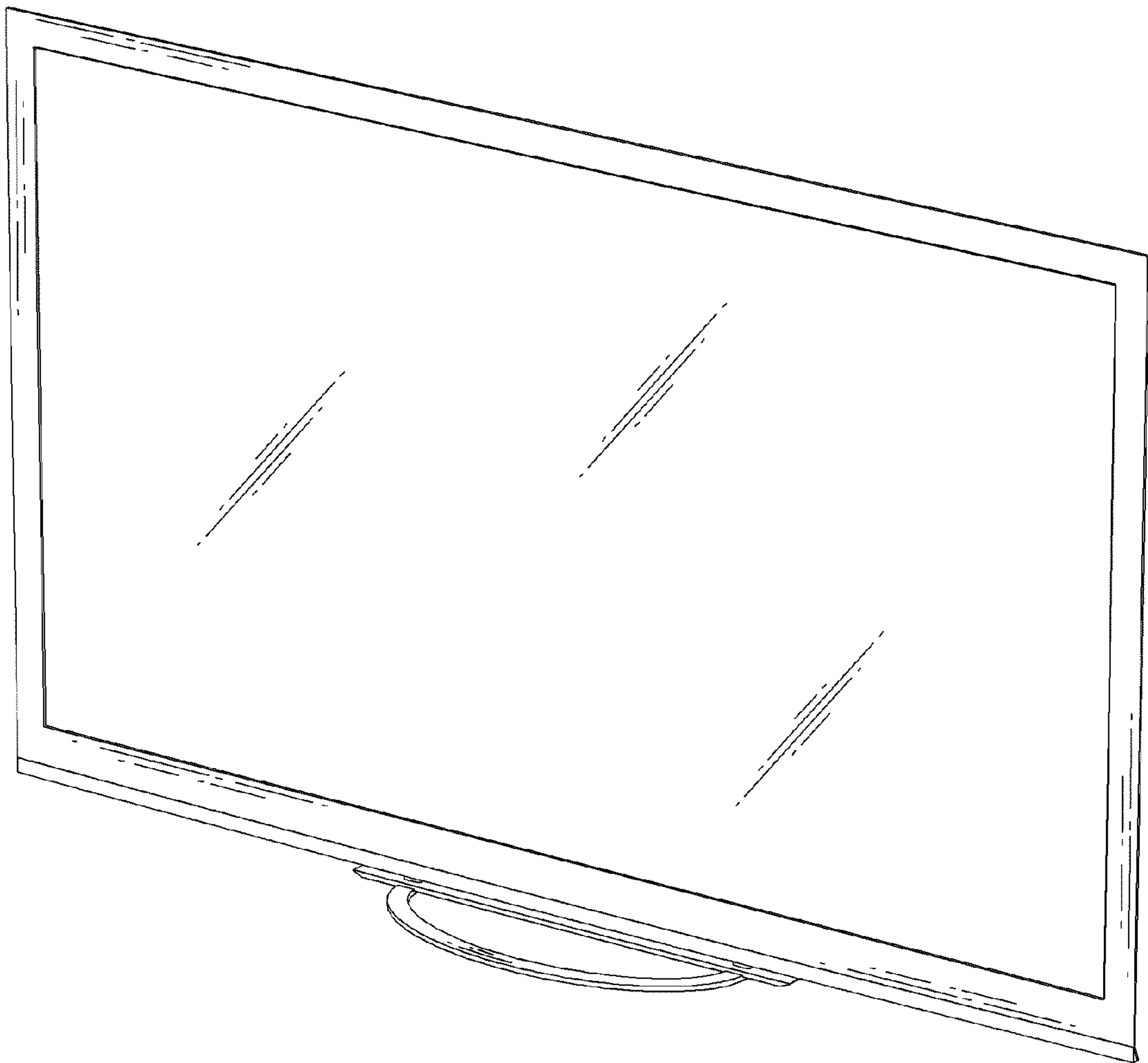

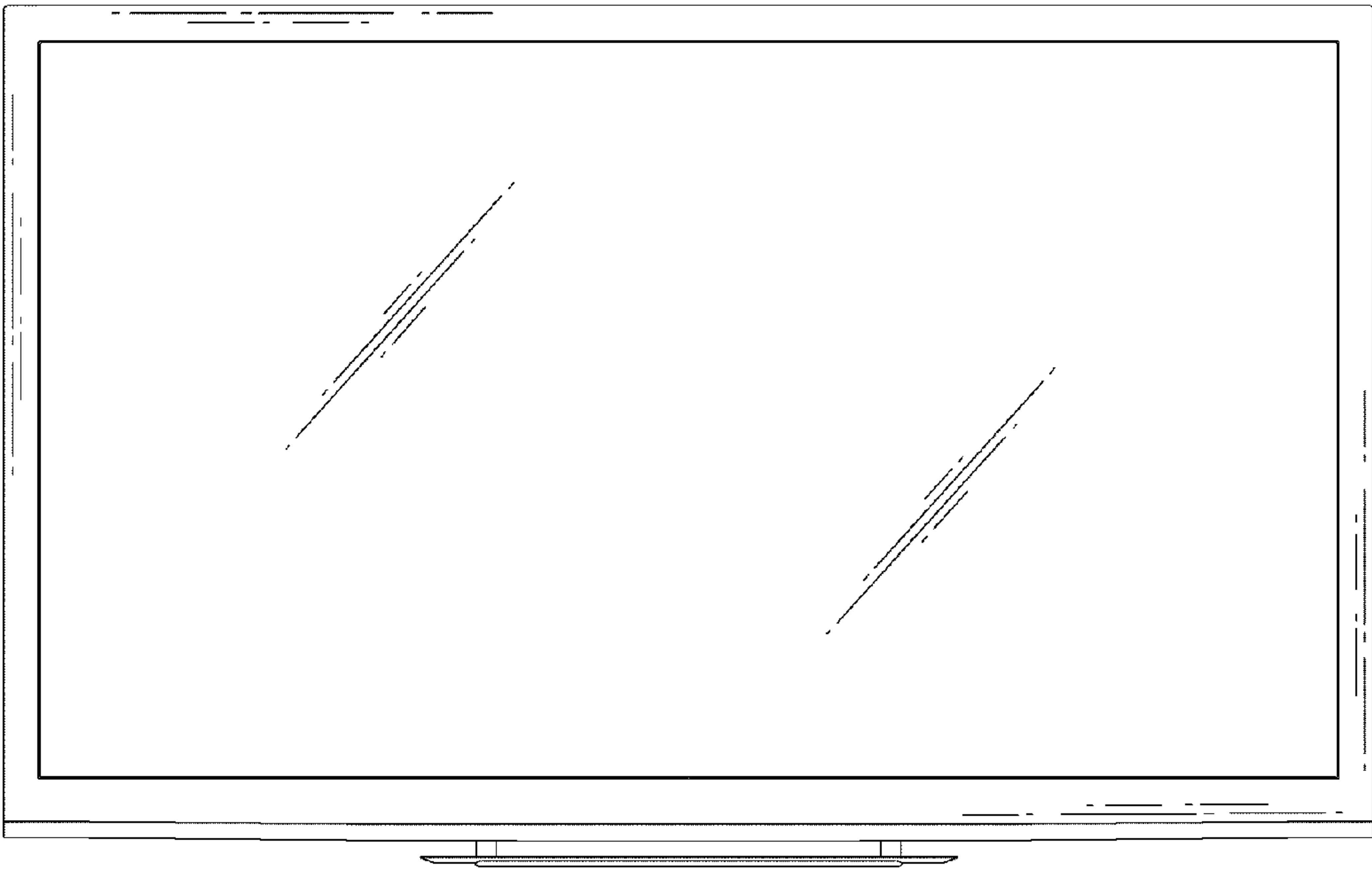

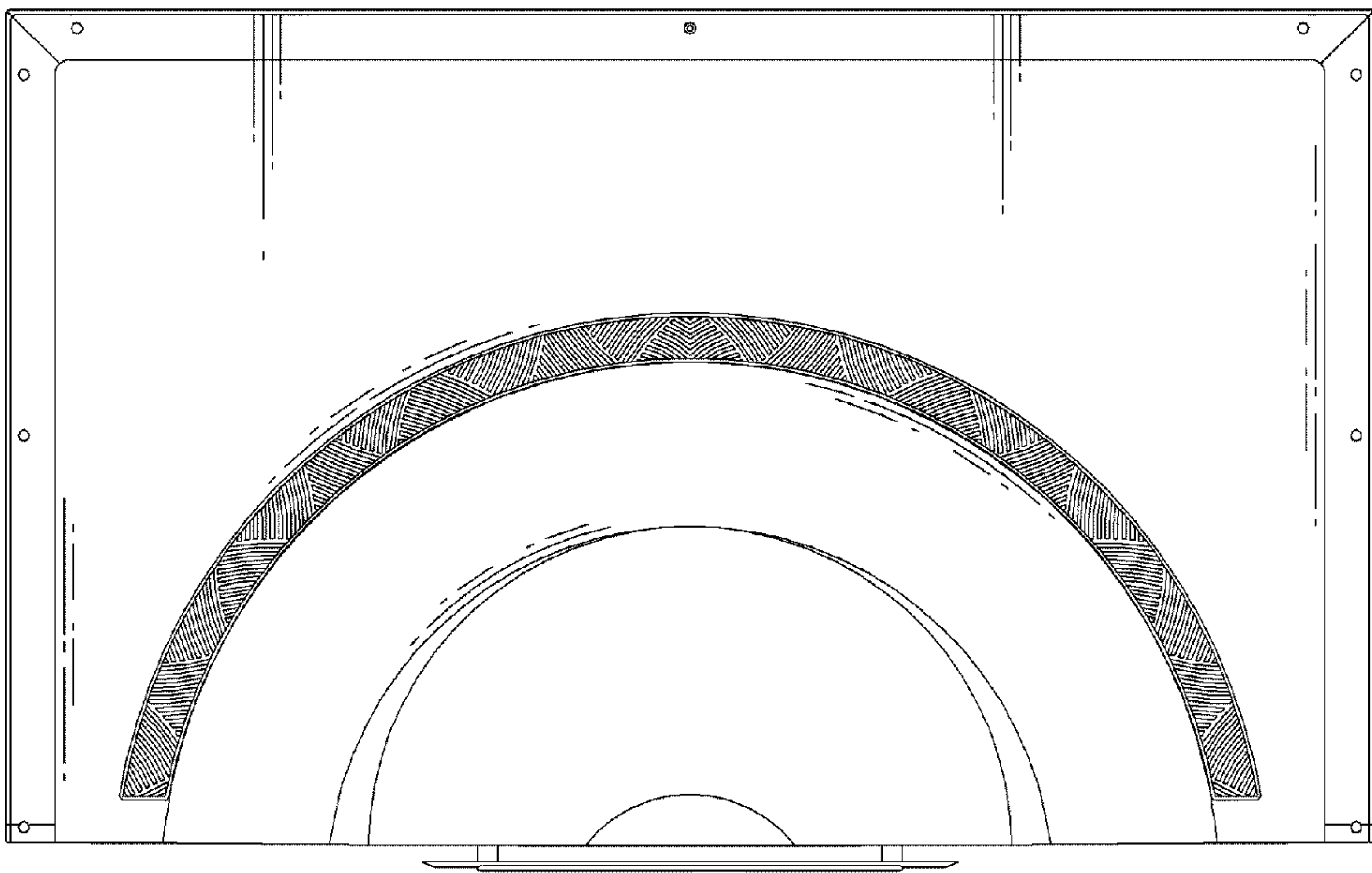

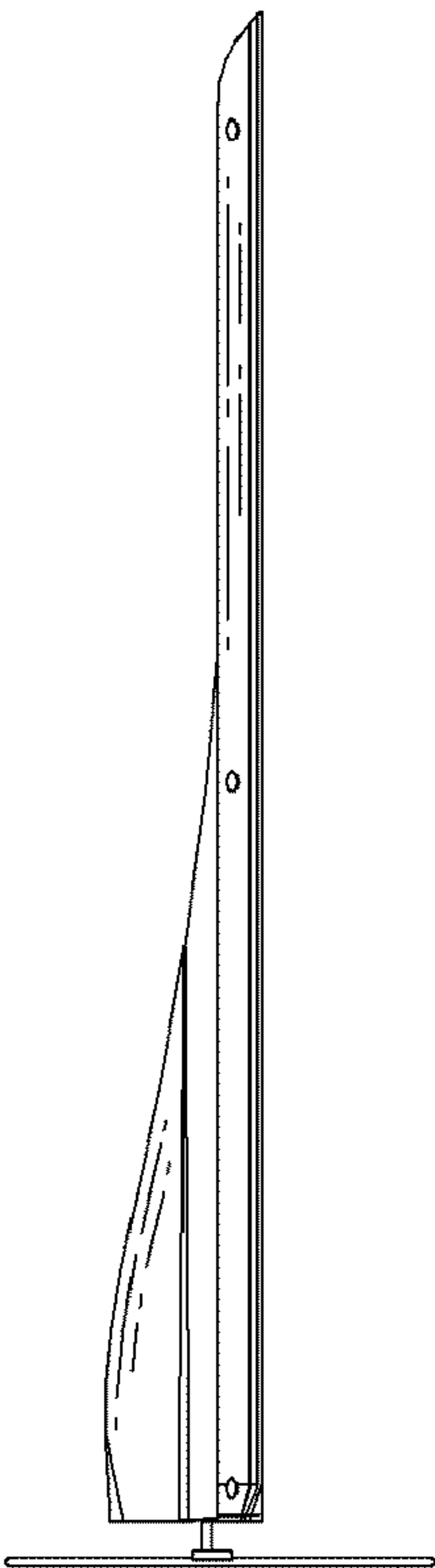

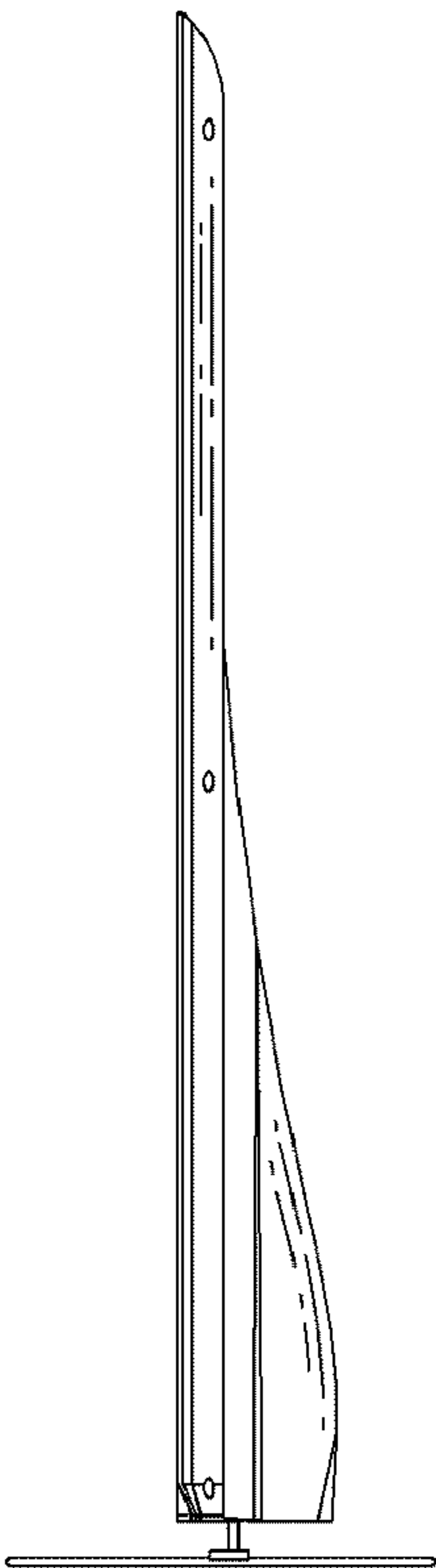

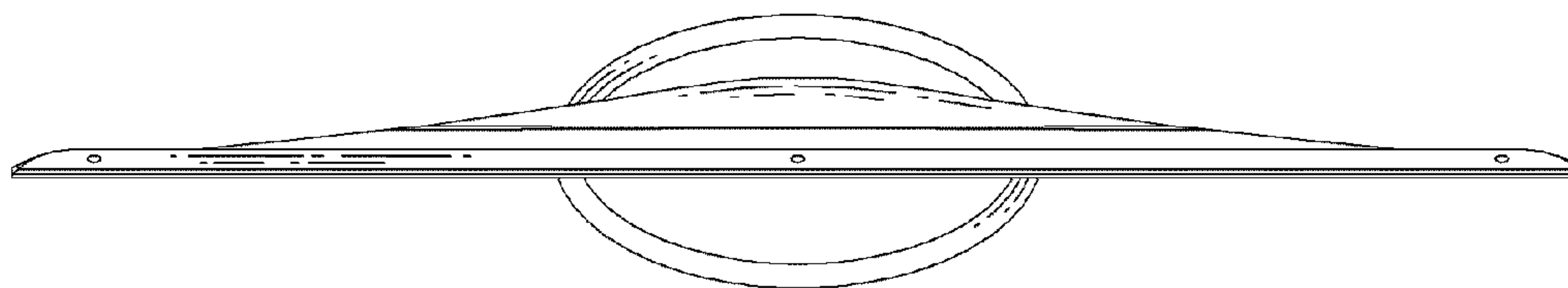
