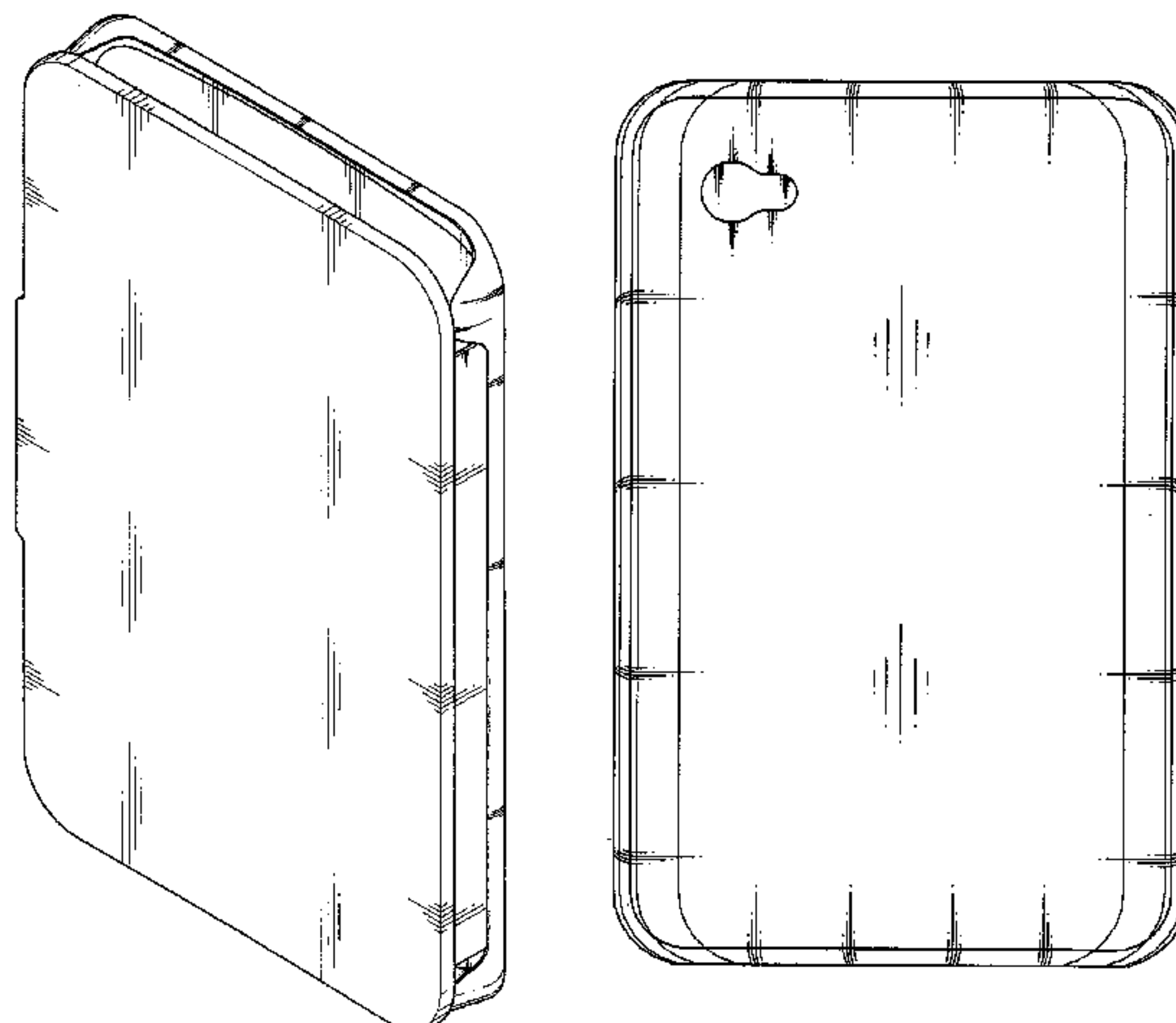
FIG. 1 is a front perspective view of a cover for mobile communication terminal;

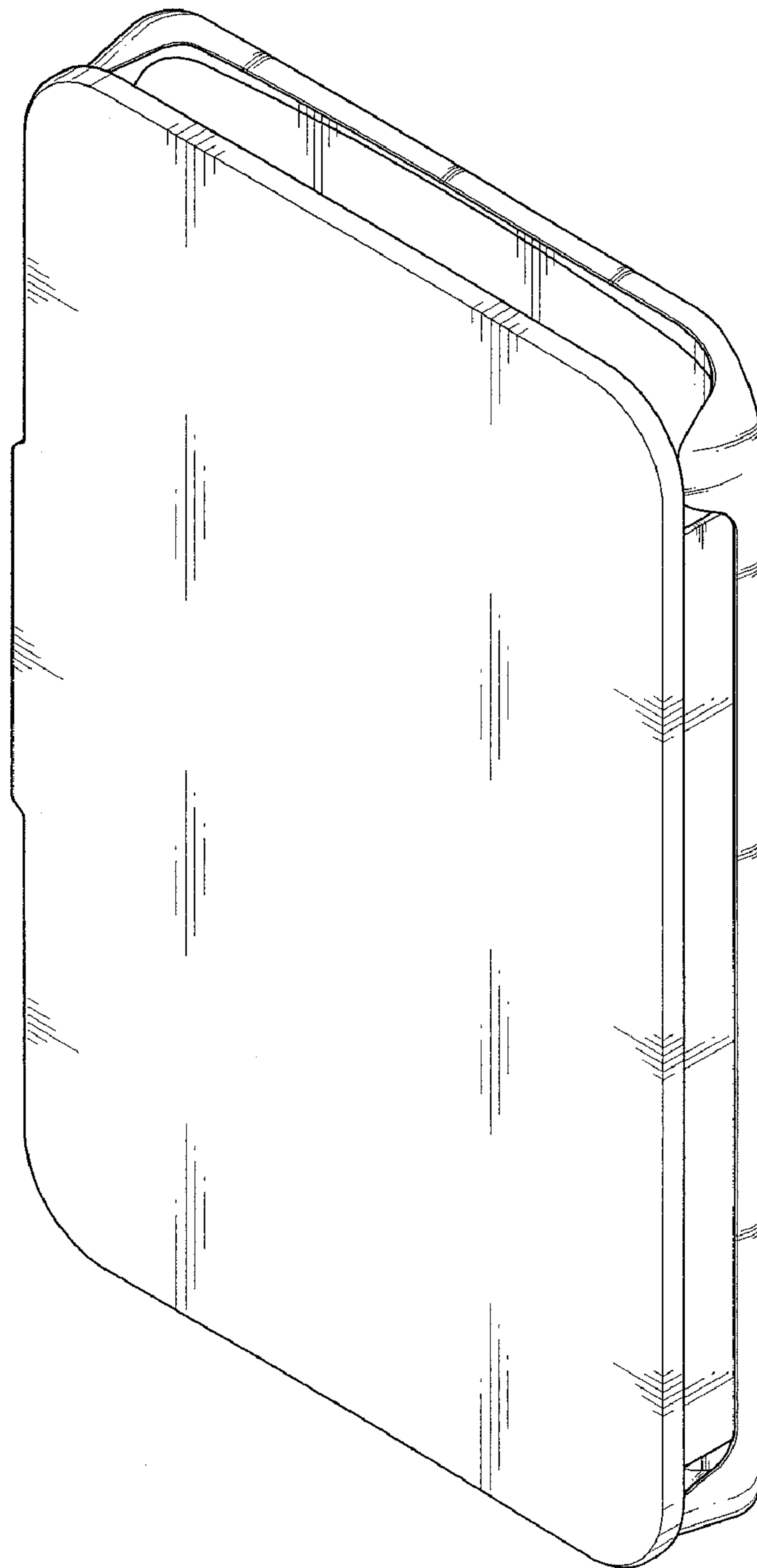

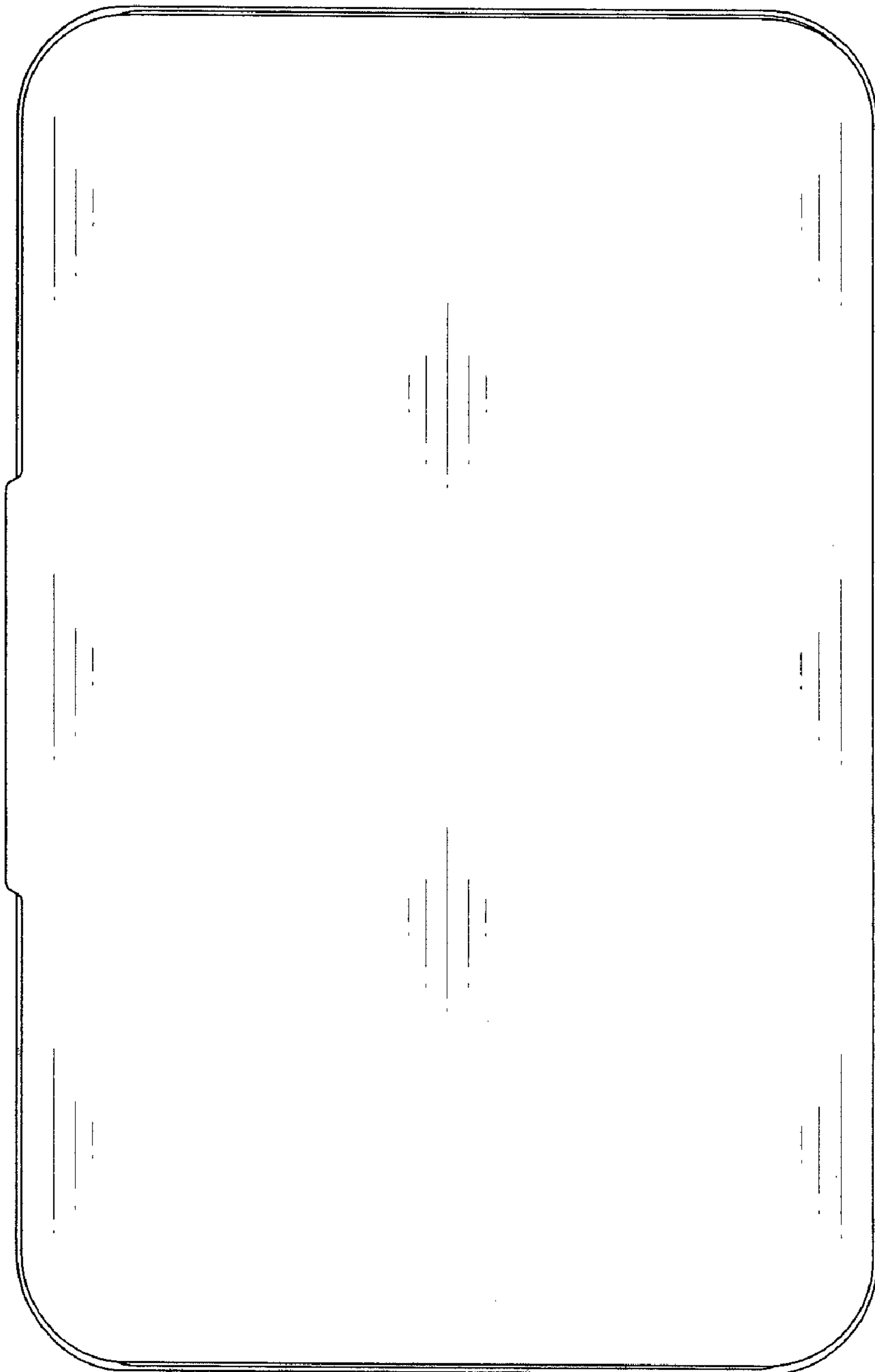

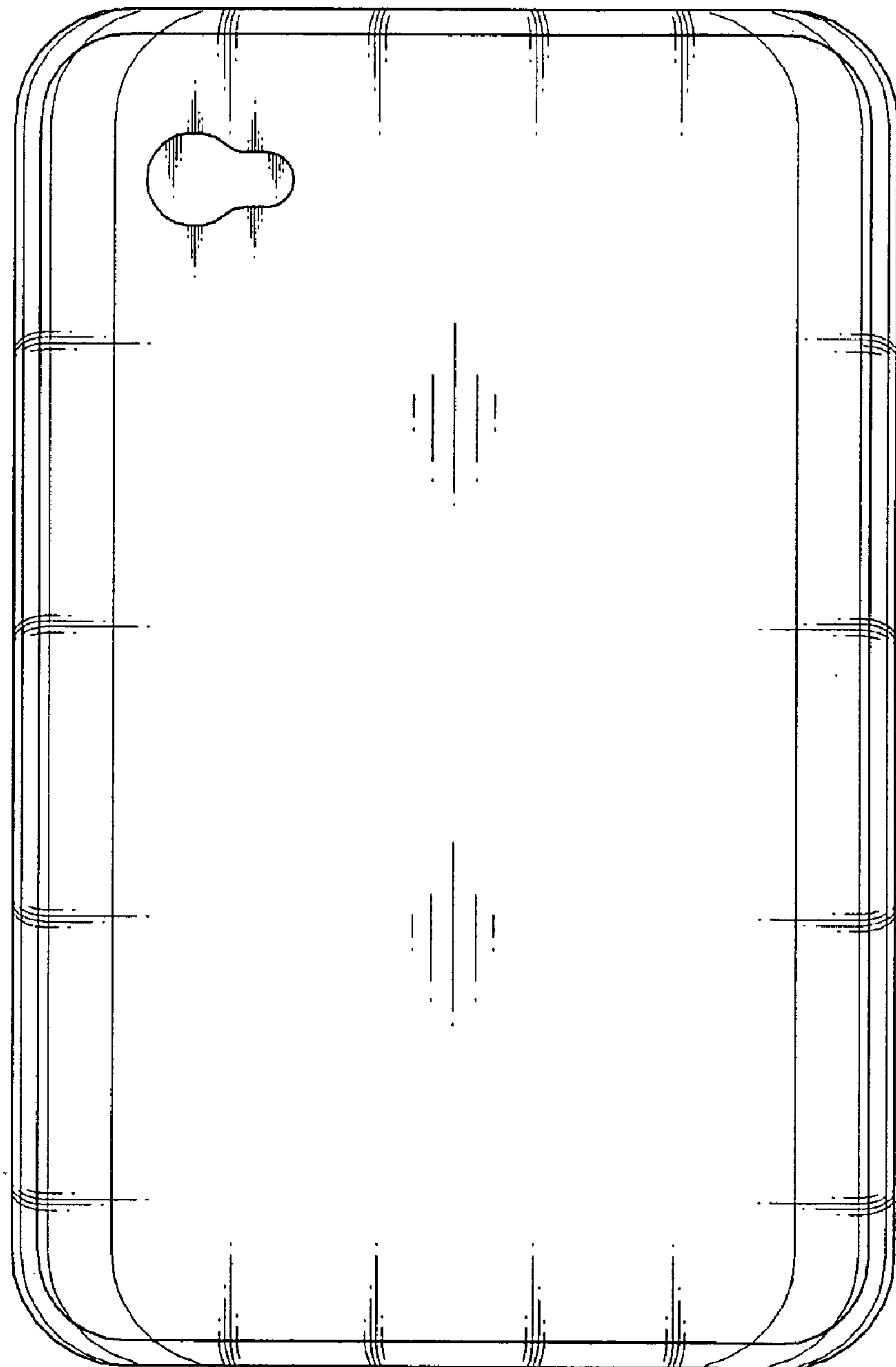

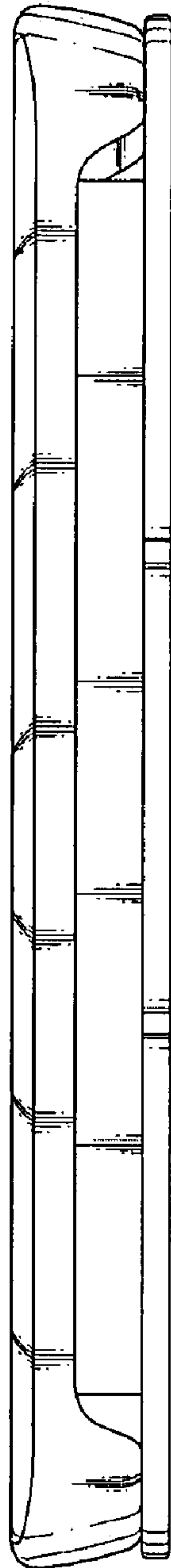

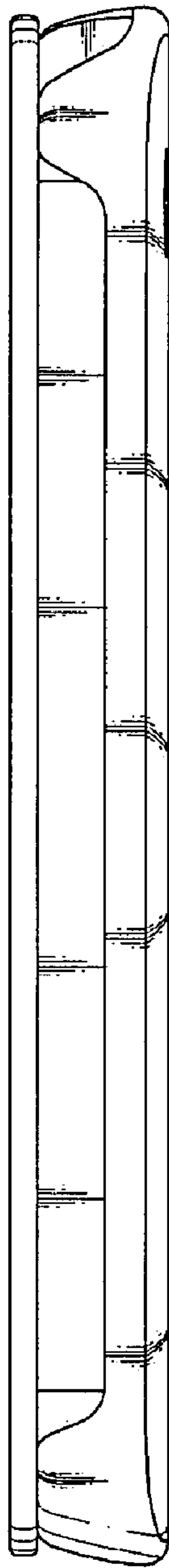

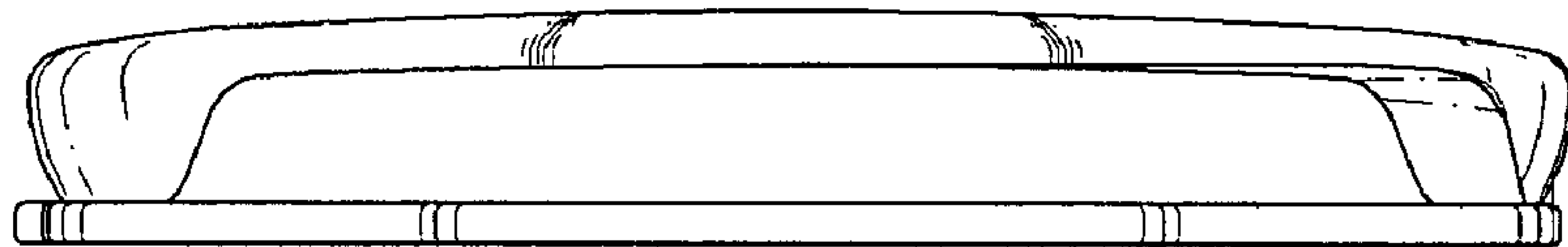

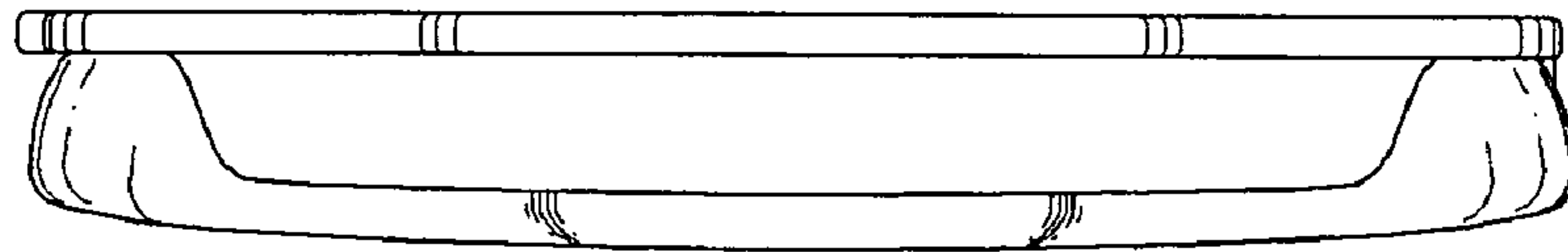
