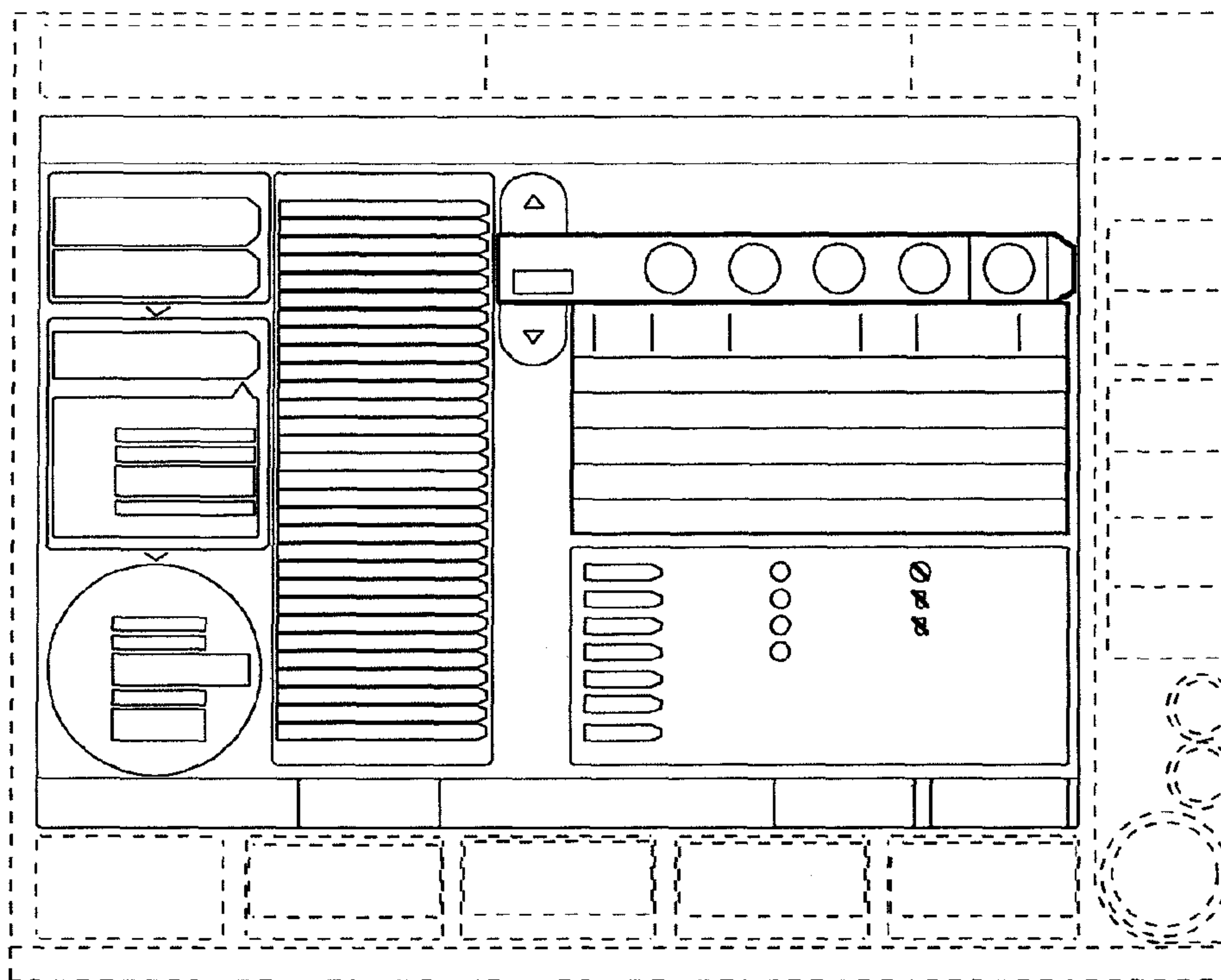
(57) **CLAIM**

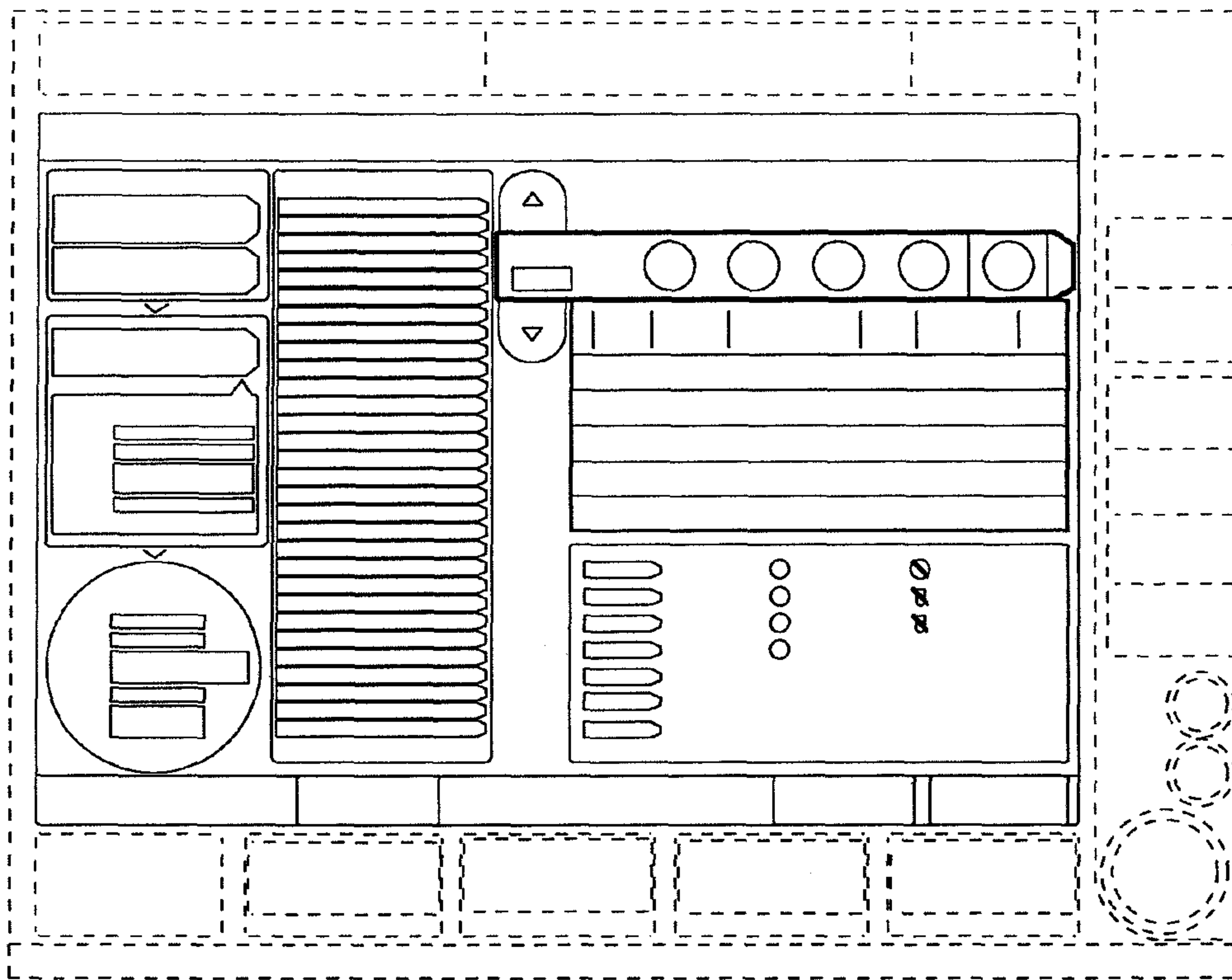
We claim the ornamental design for a graphical user interface for a computer display, as shown and described.
