The ornamental designs for the bookbinder card, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the bookbinder card.

FIG. 2 is a perspective view of the bookbinder card of FIG. 1 with an open cover.

FIG. 3 is a front view of the bookbinder card of FIG. 1.

FIG. 4 is a rear view of the bookbinder card of FIG. 1.

FIG. 5 is a right-side view of the bookbinder card of FIG. 1.

FIG. 6 is a left-side view of the bookbinder card of FIG. 1.

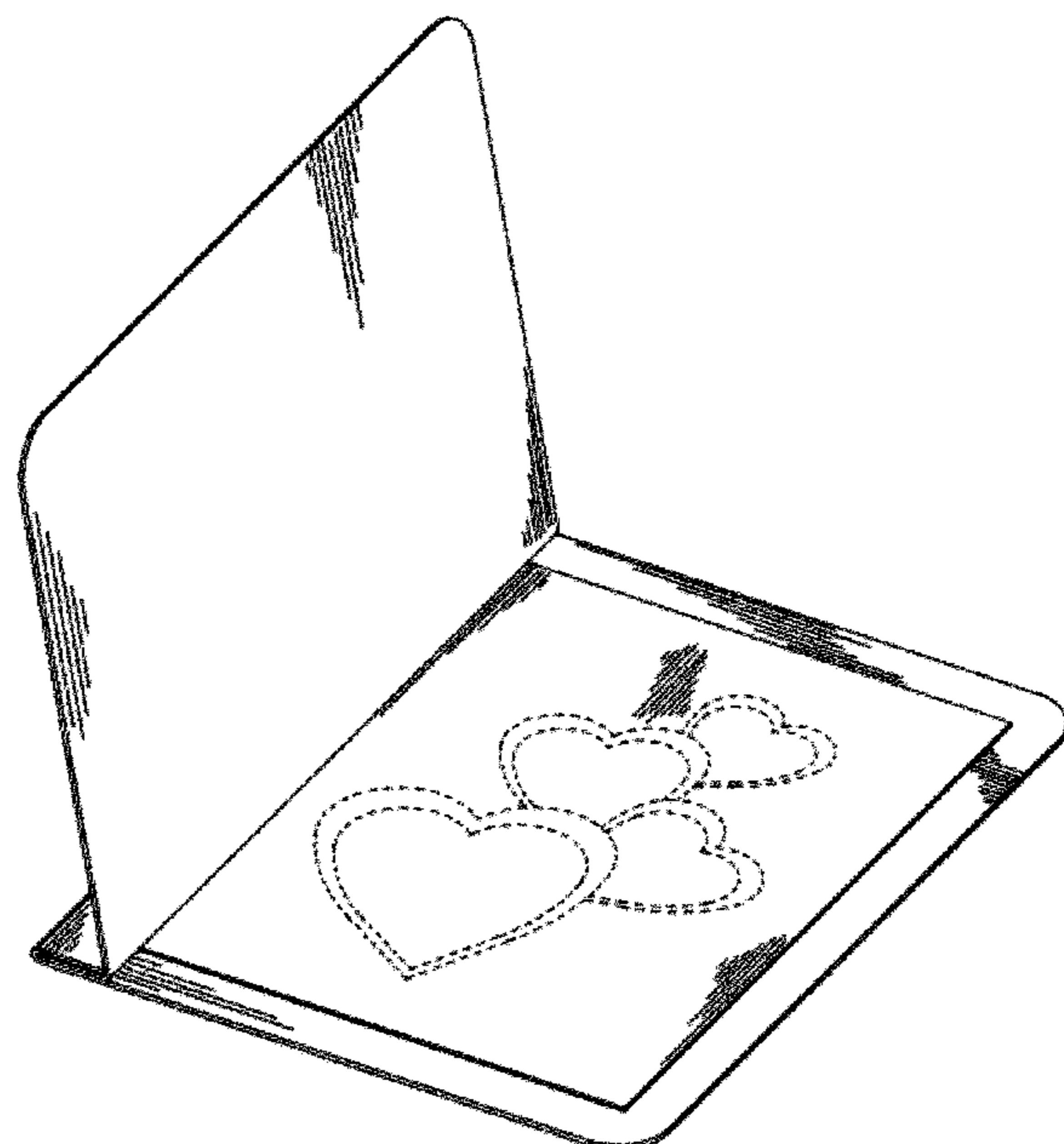
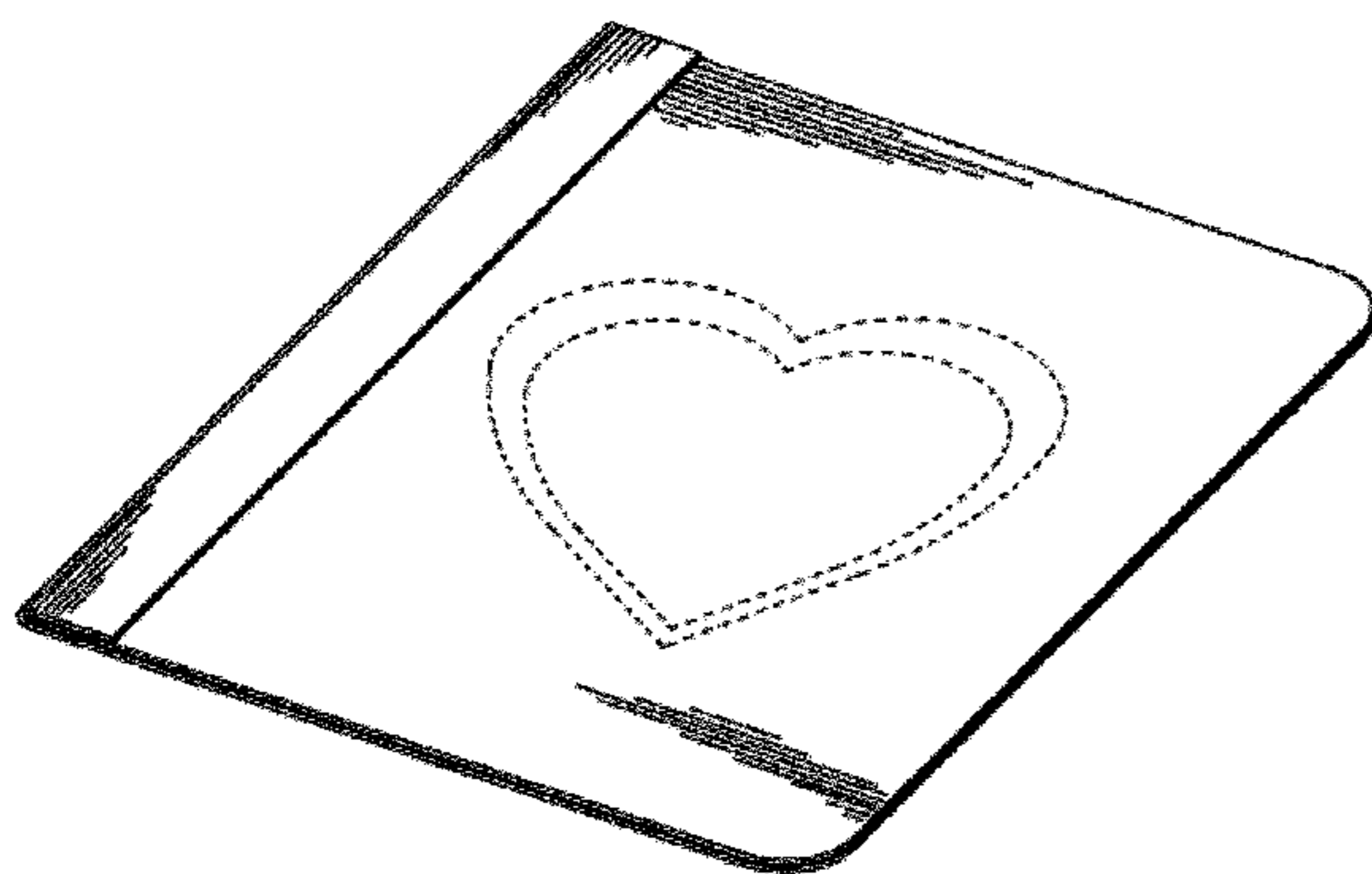
FIG. 7 is a bottom view of the bookbinder card of FIG. 1.

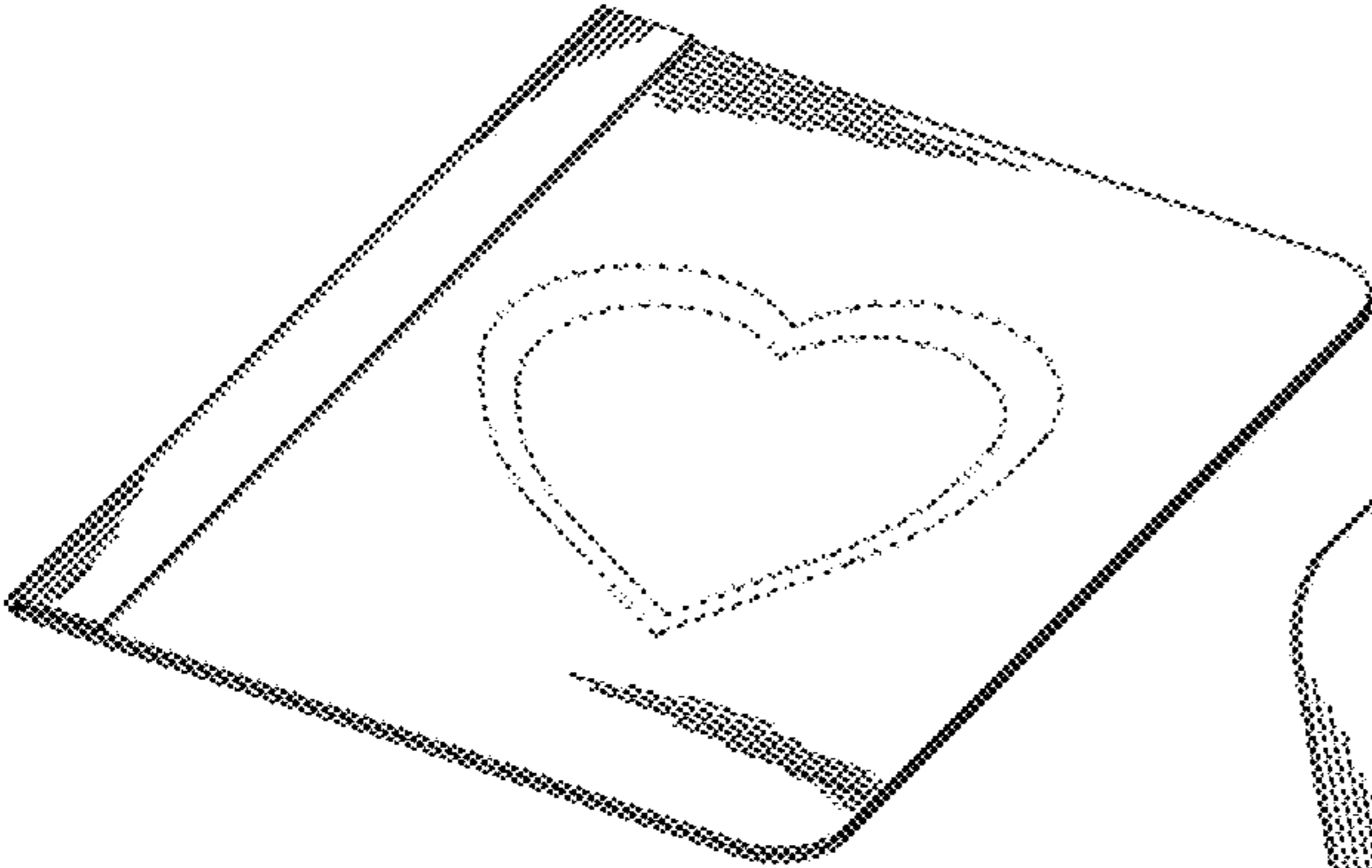

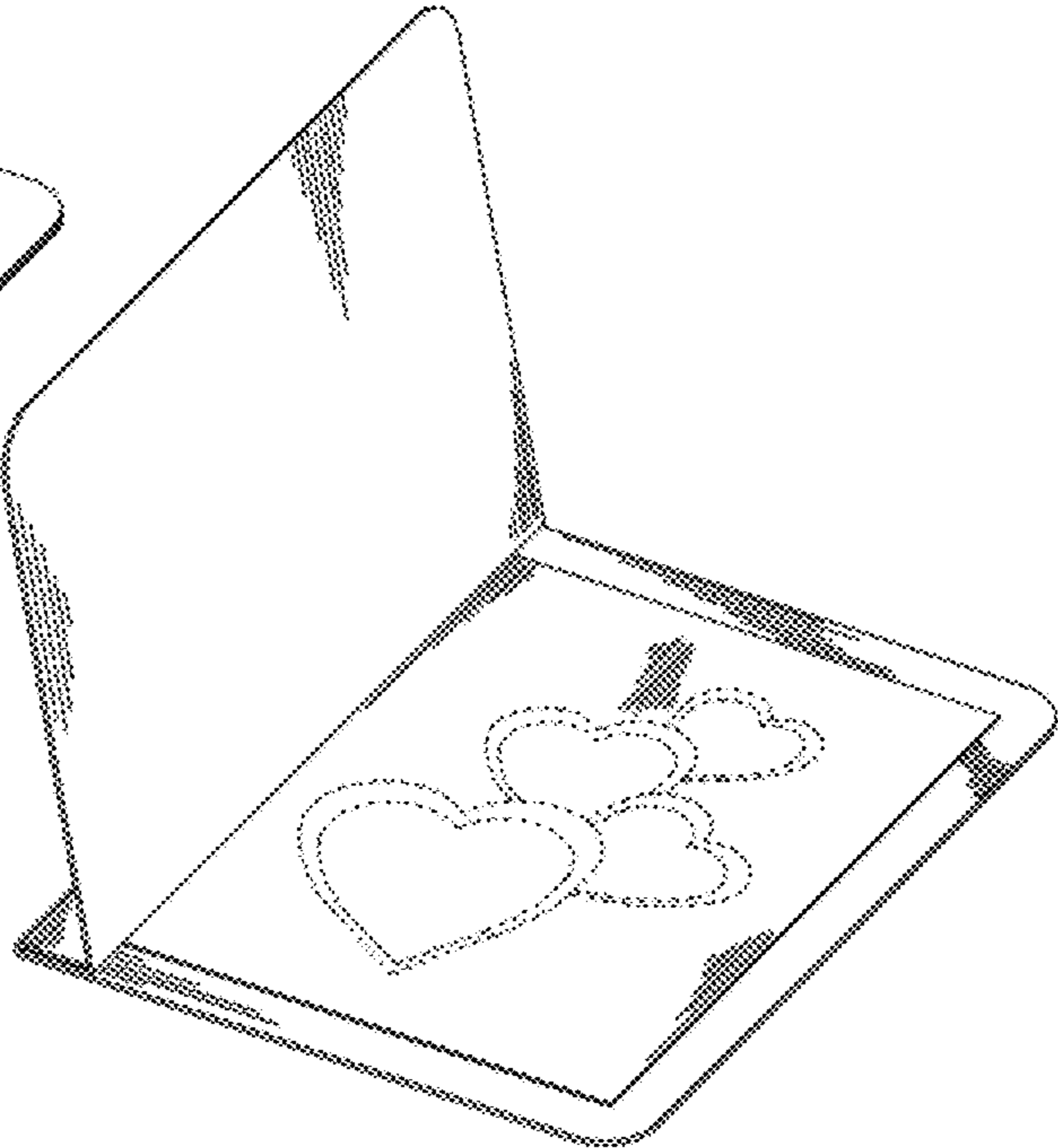

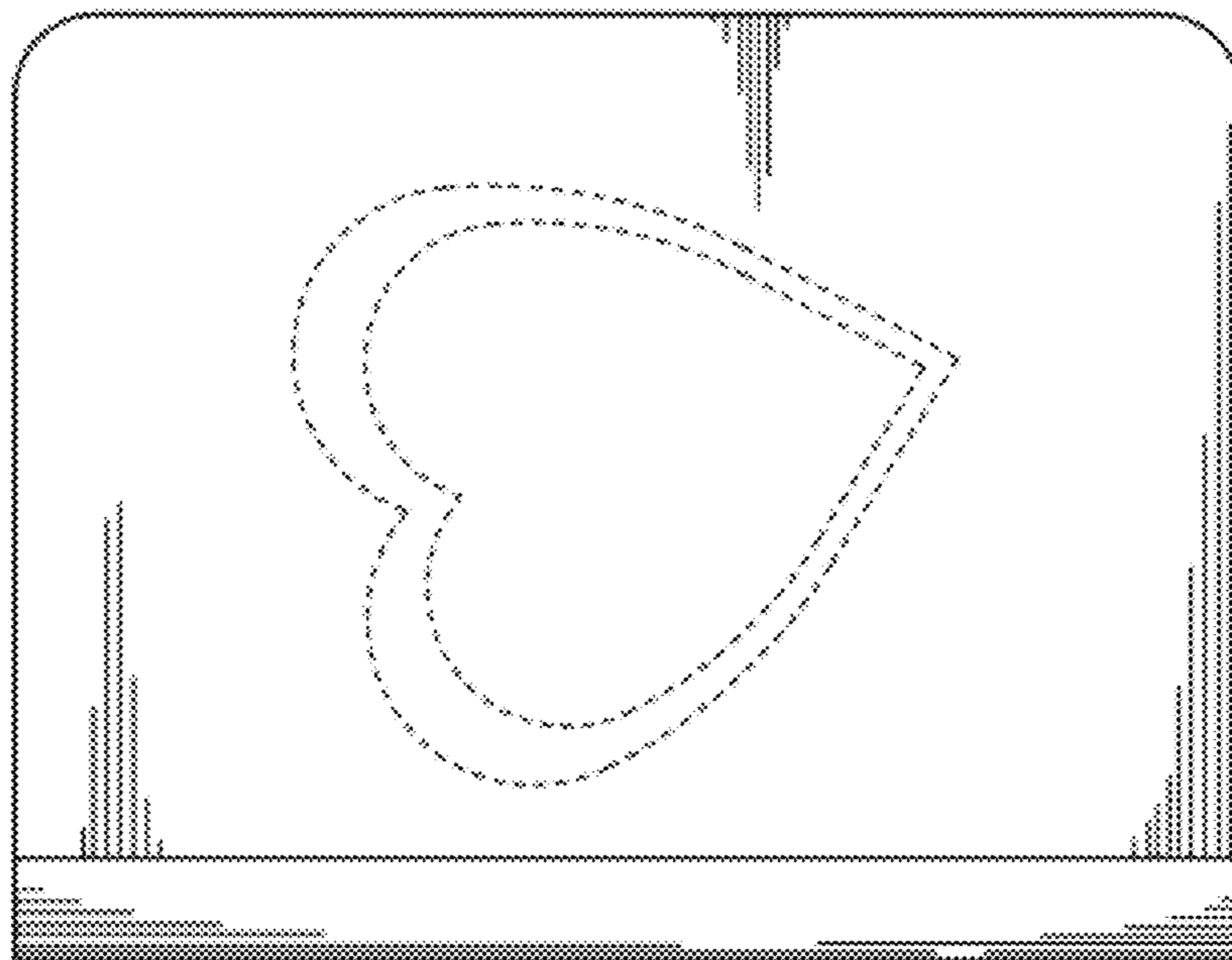

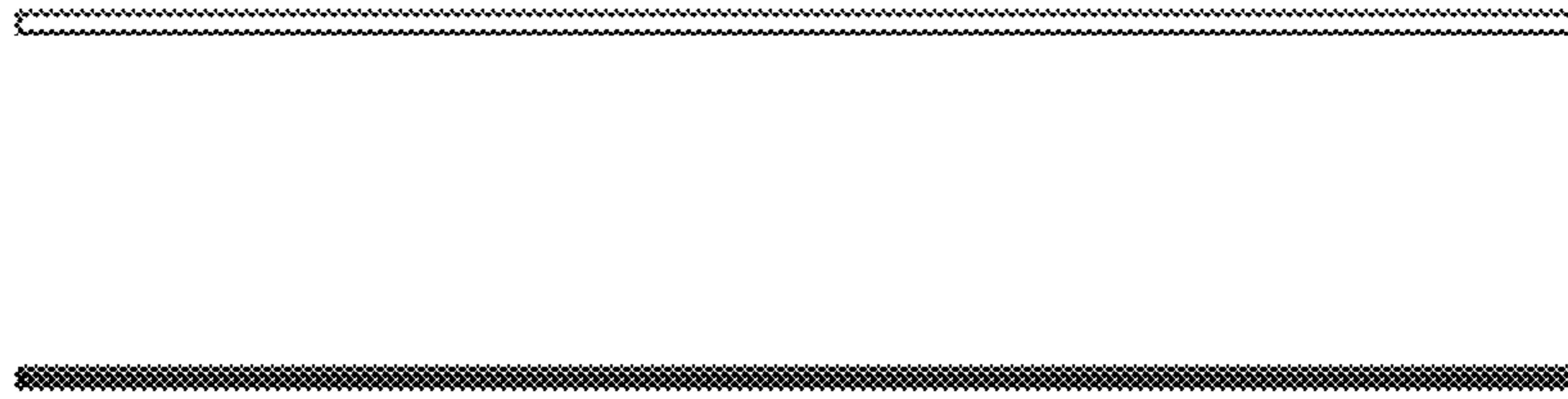

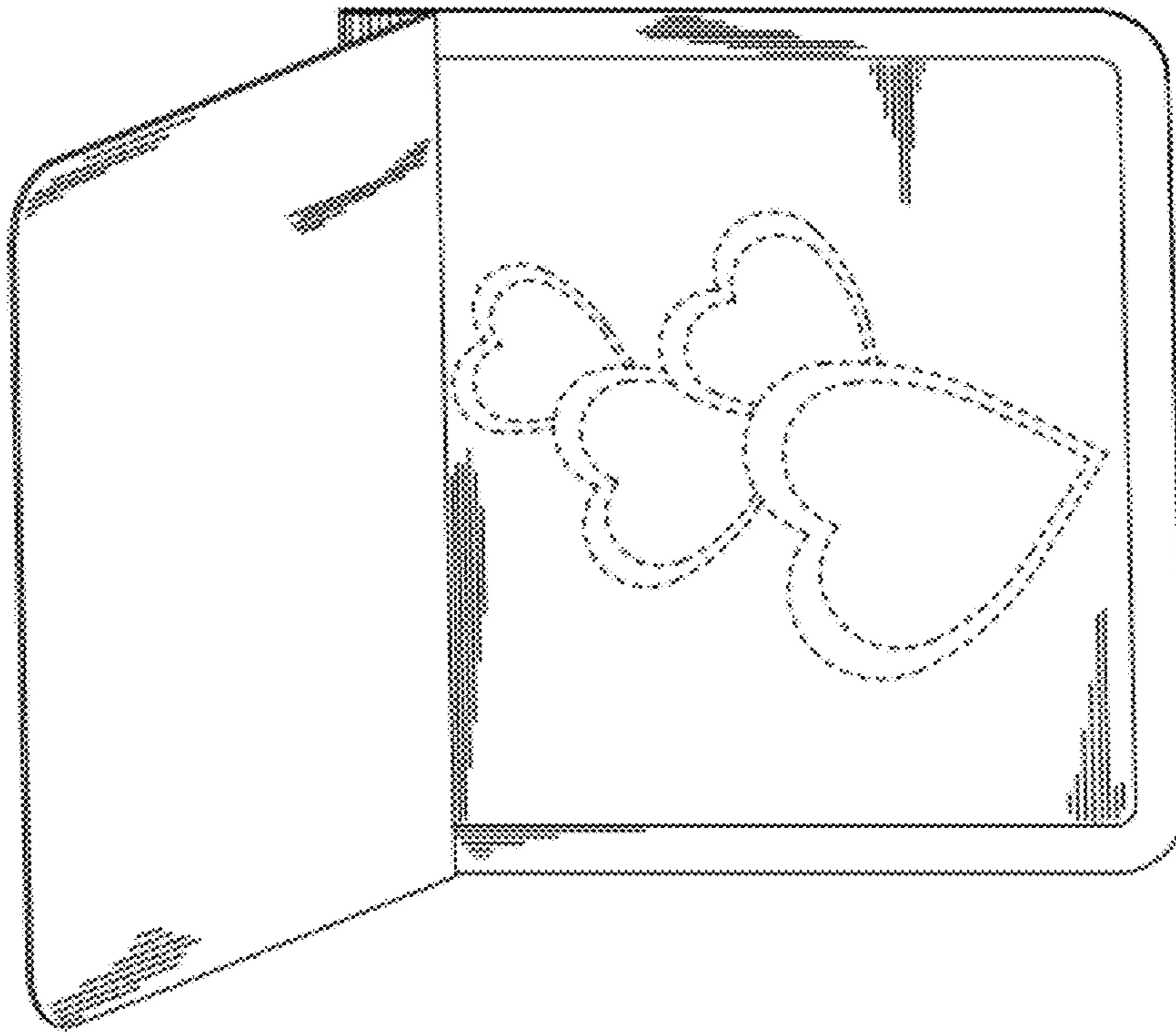

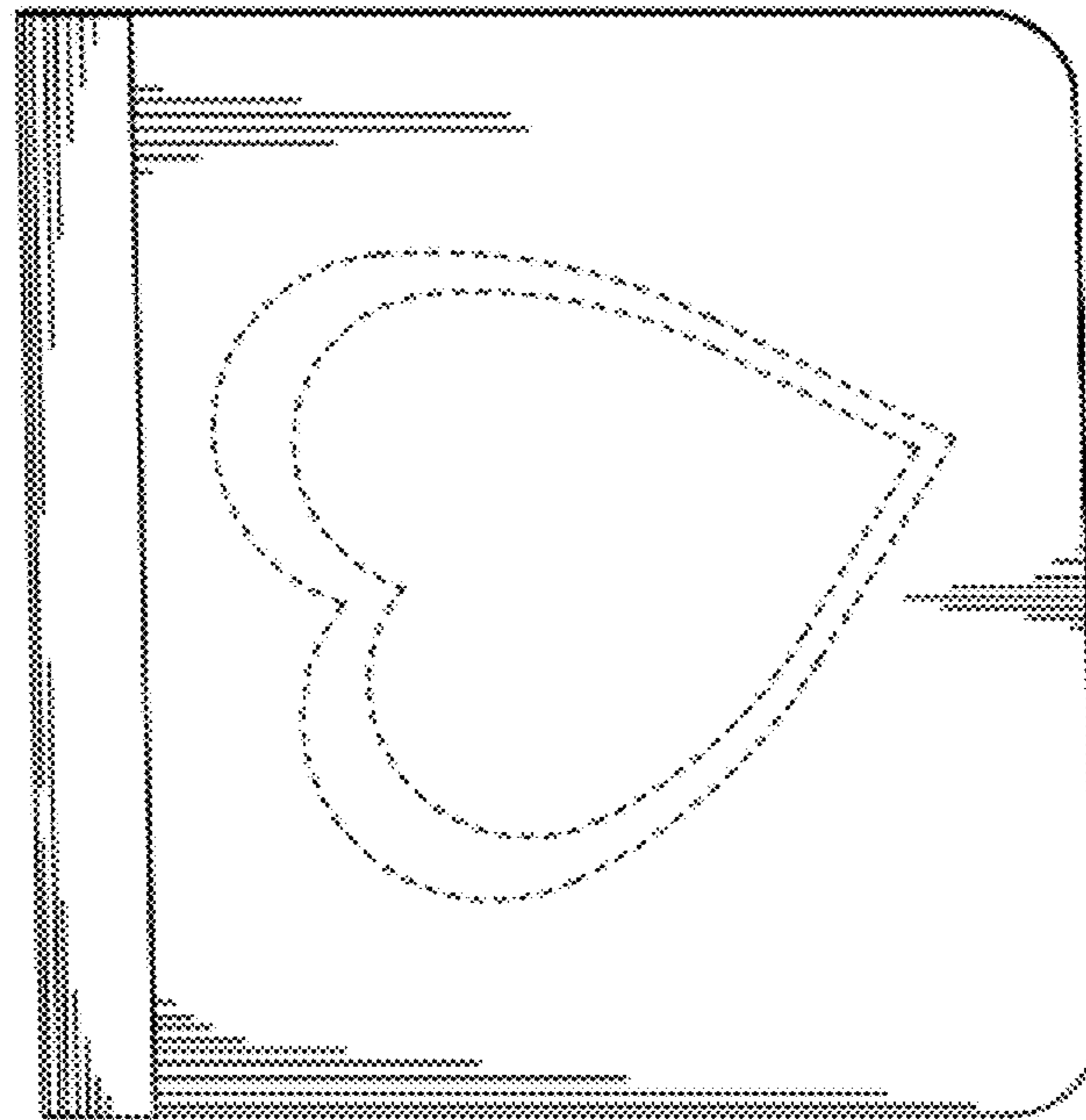
