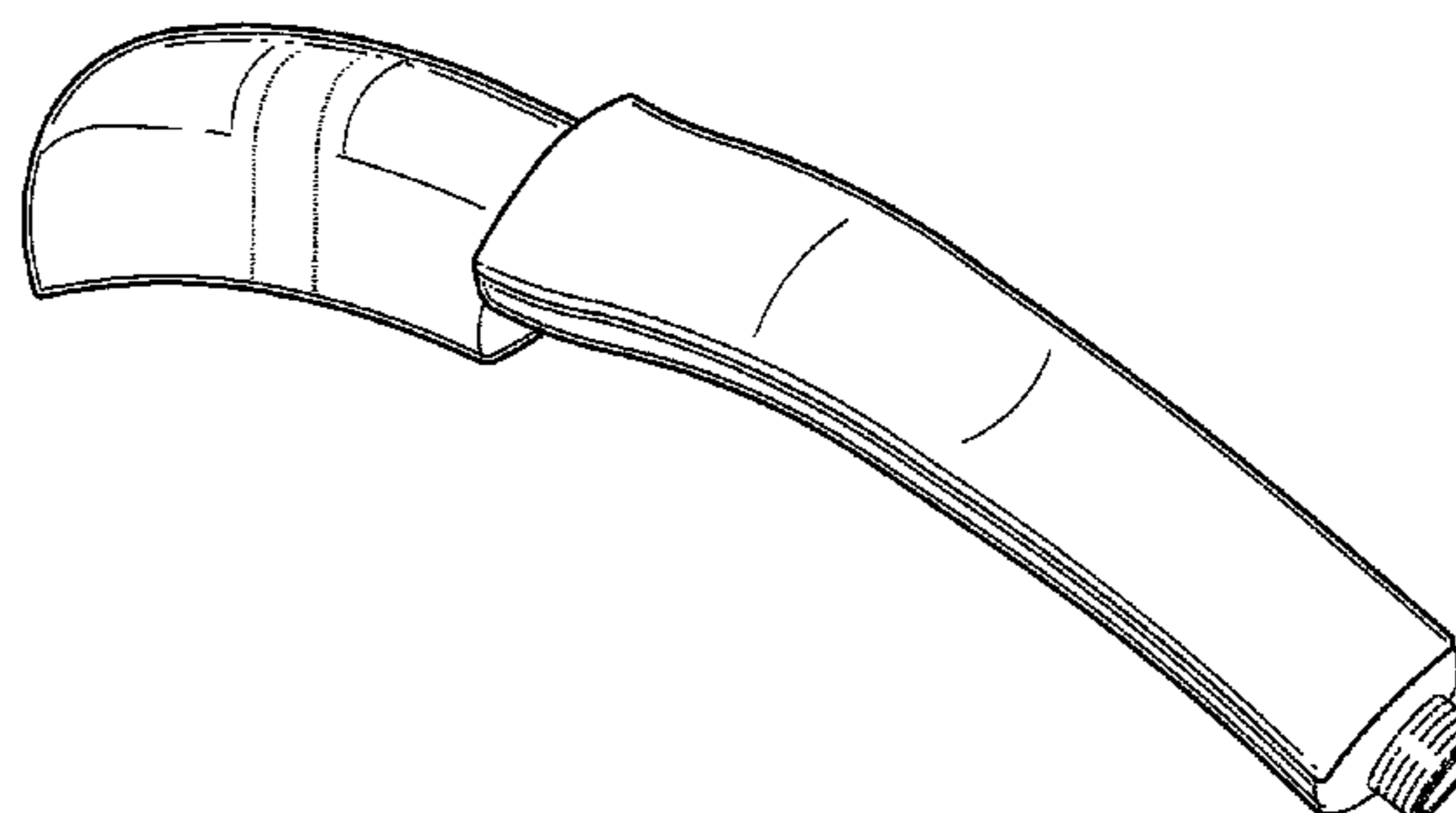
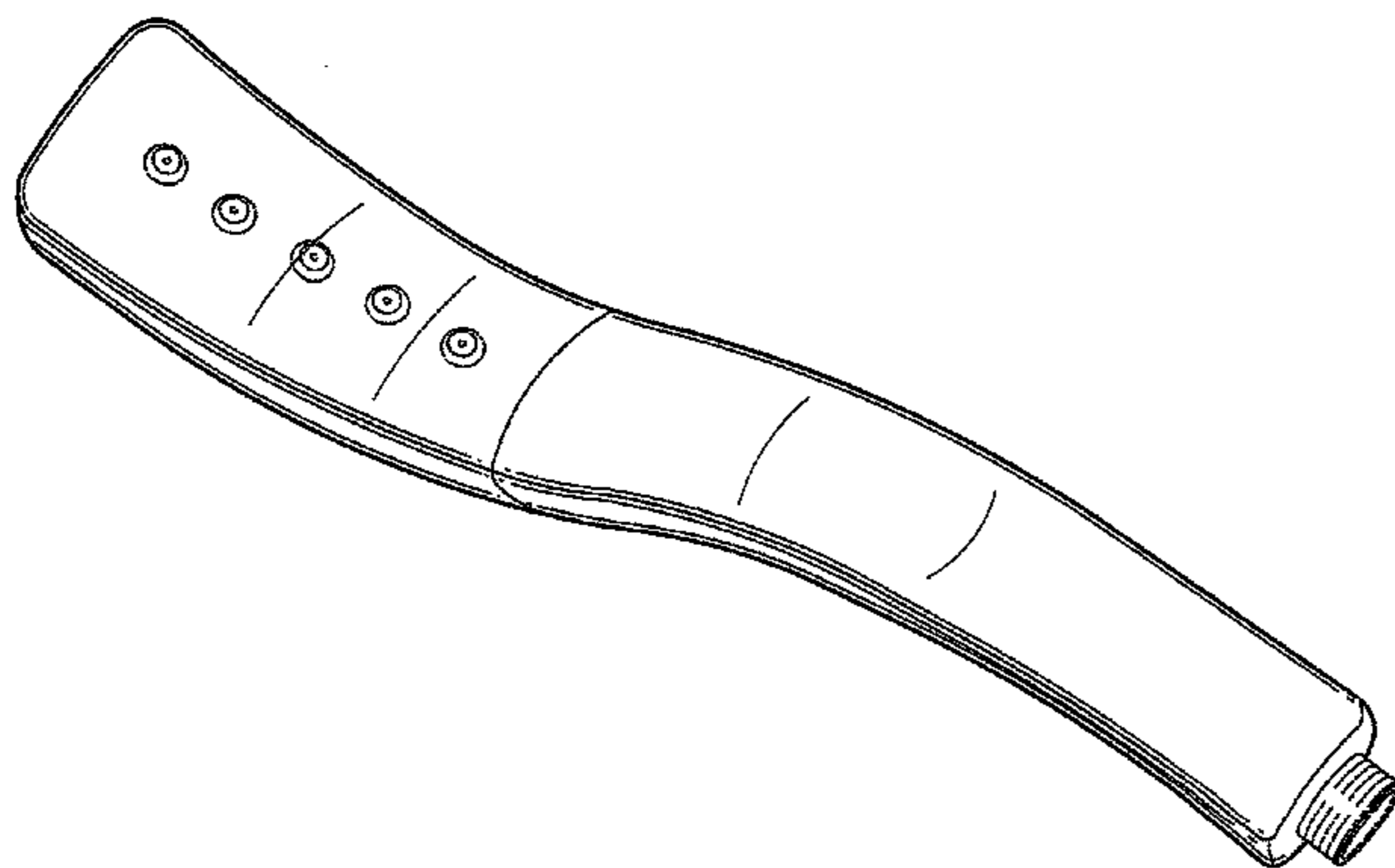
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front plan view of a handheld shower showing my new design;

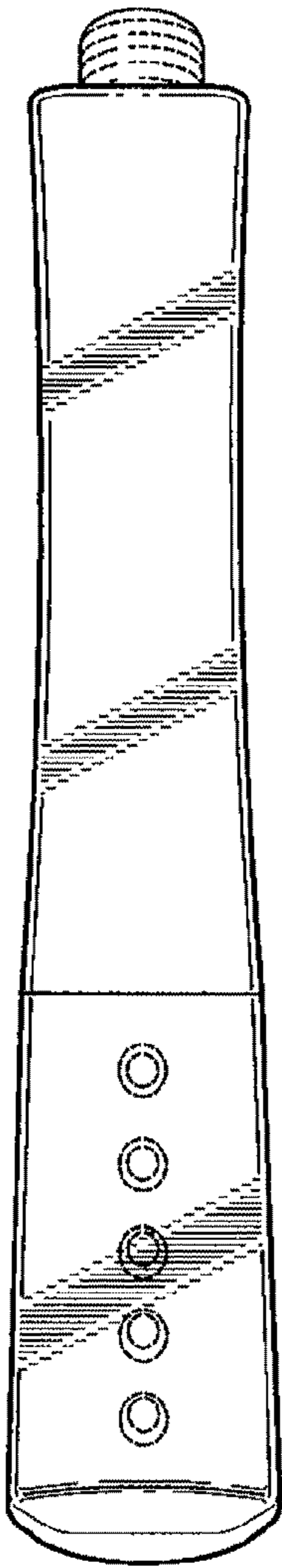

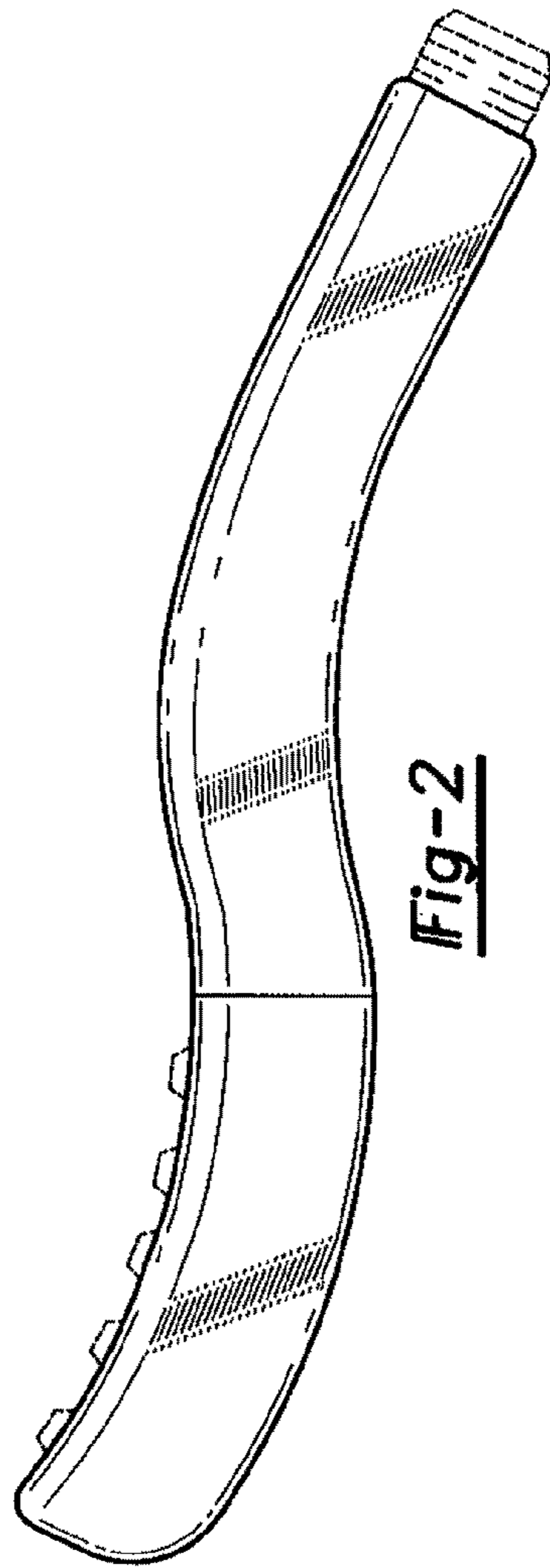

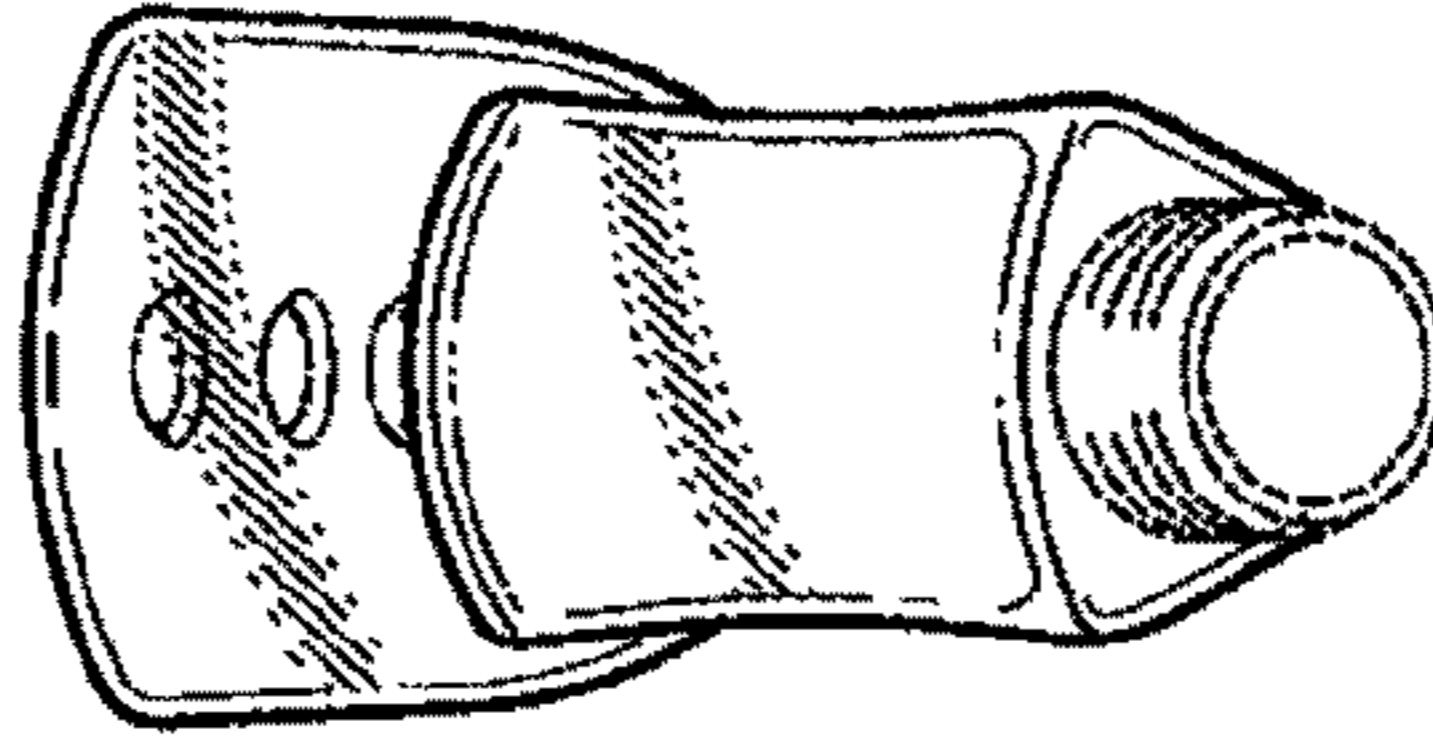

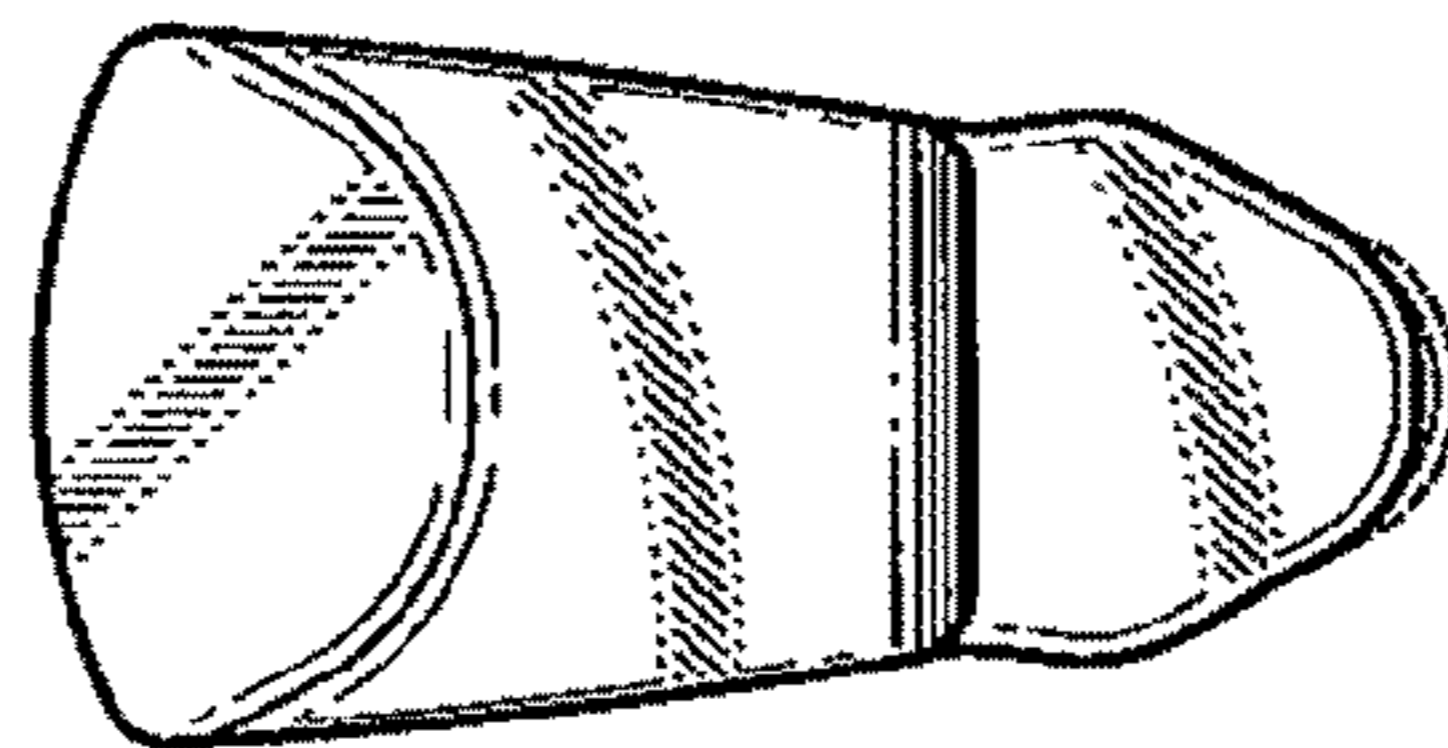
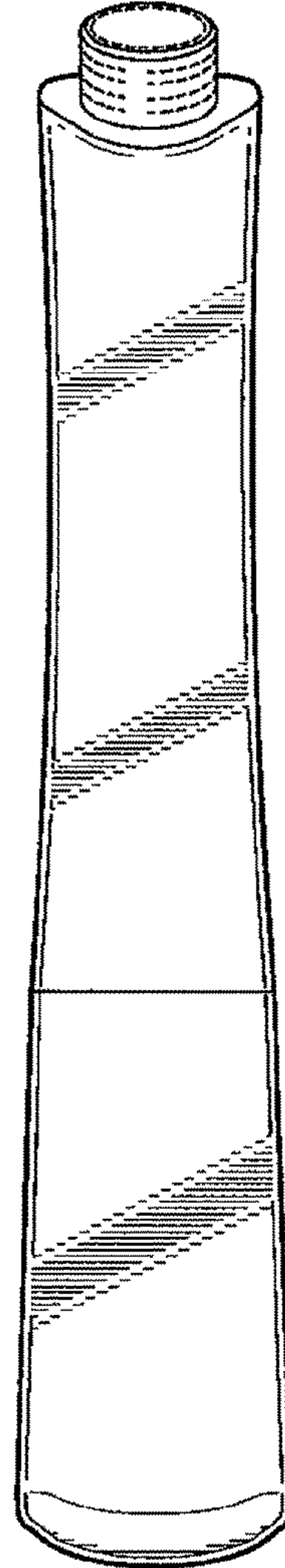
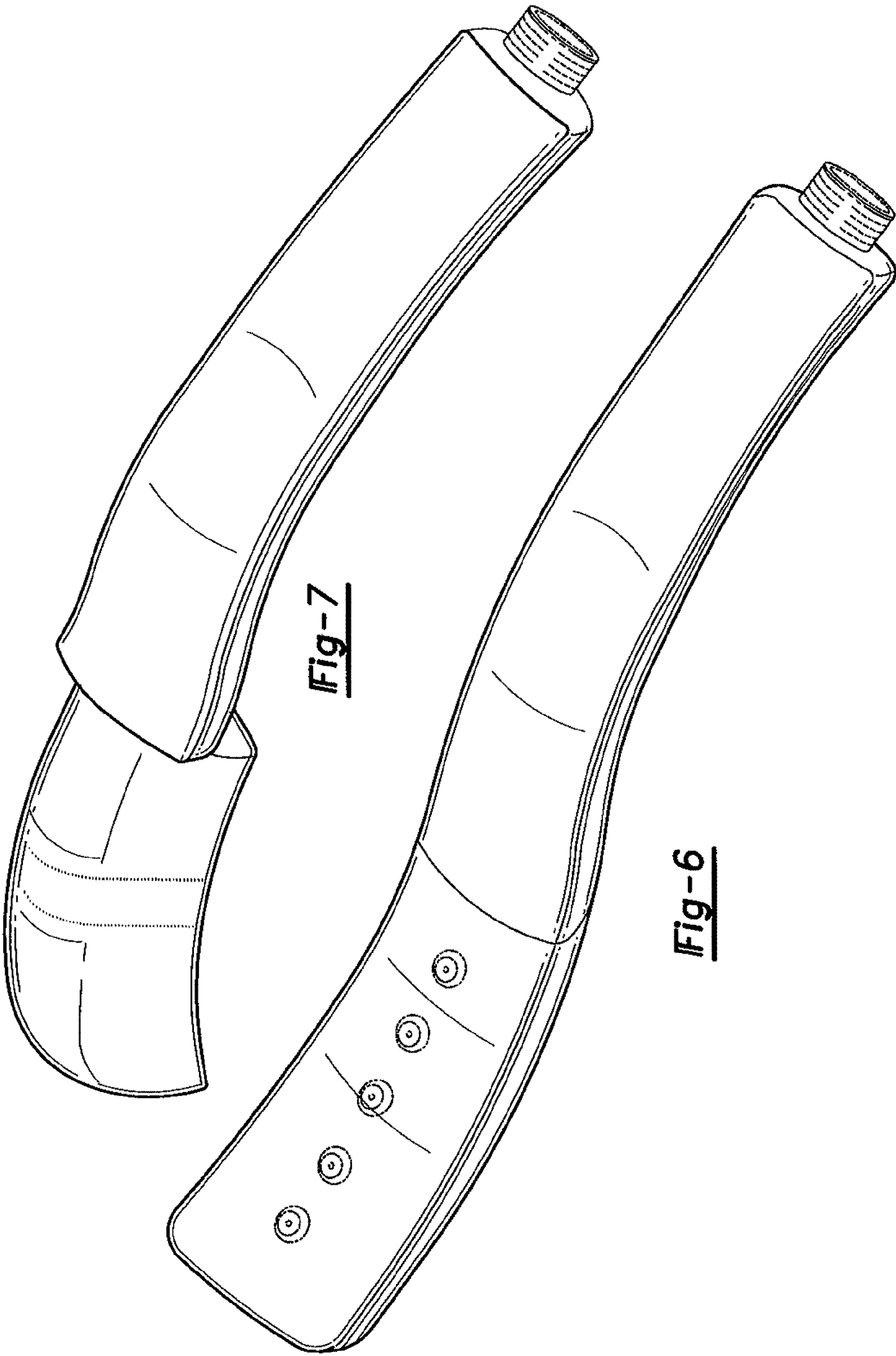

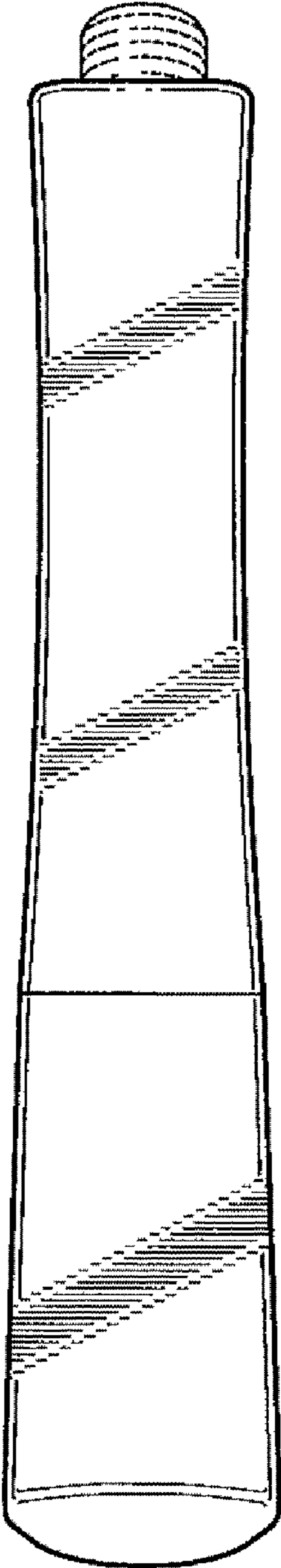

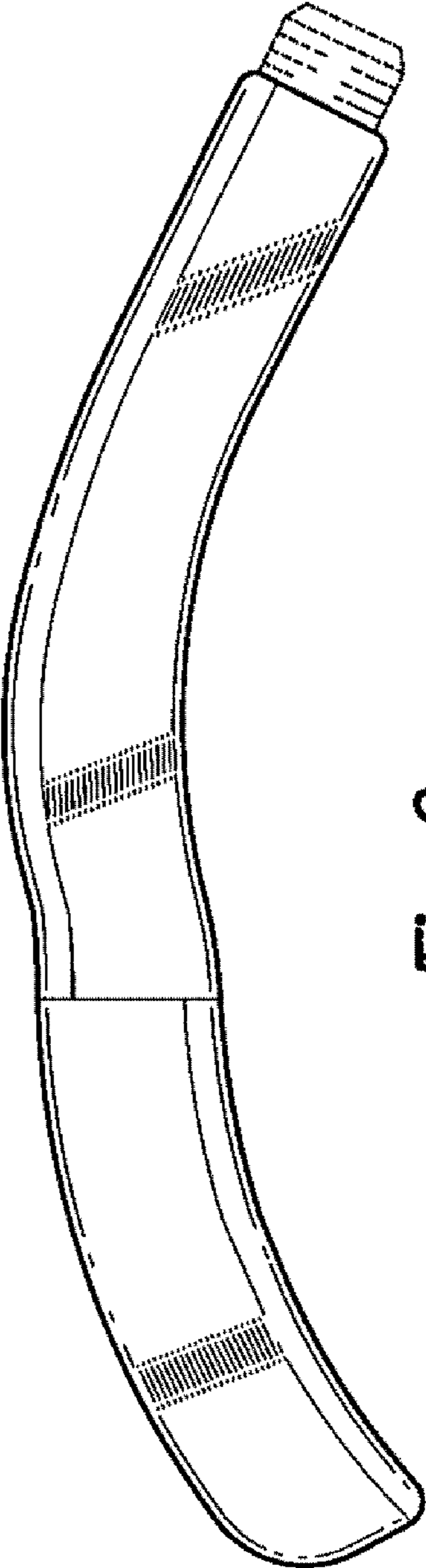
