FIG. 3 is a bottom view of the vibrator.

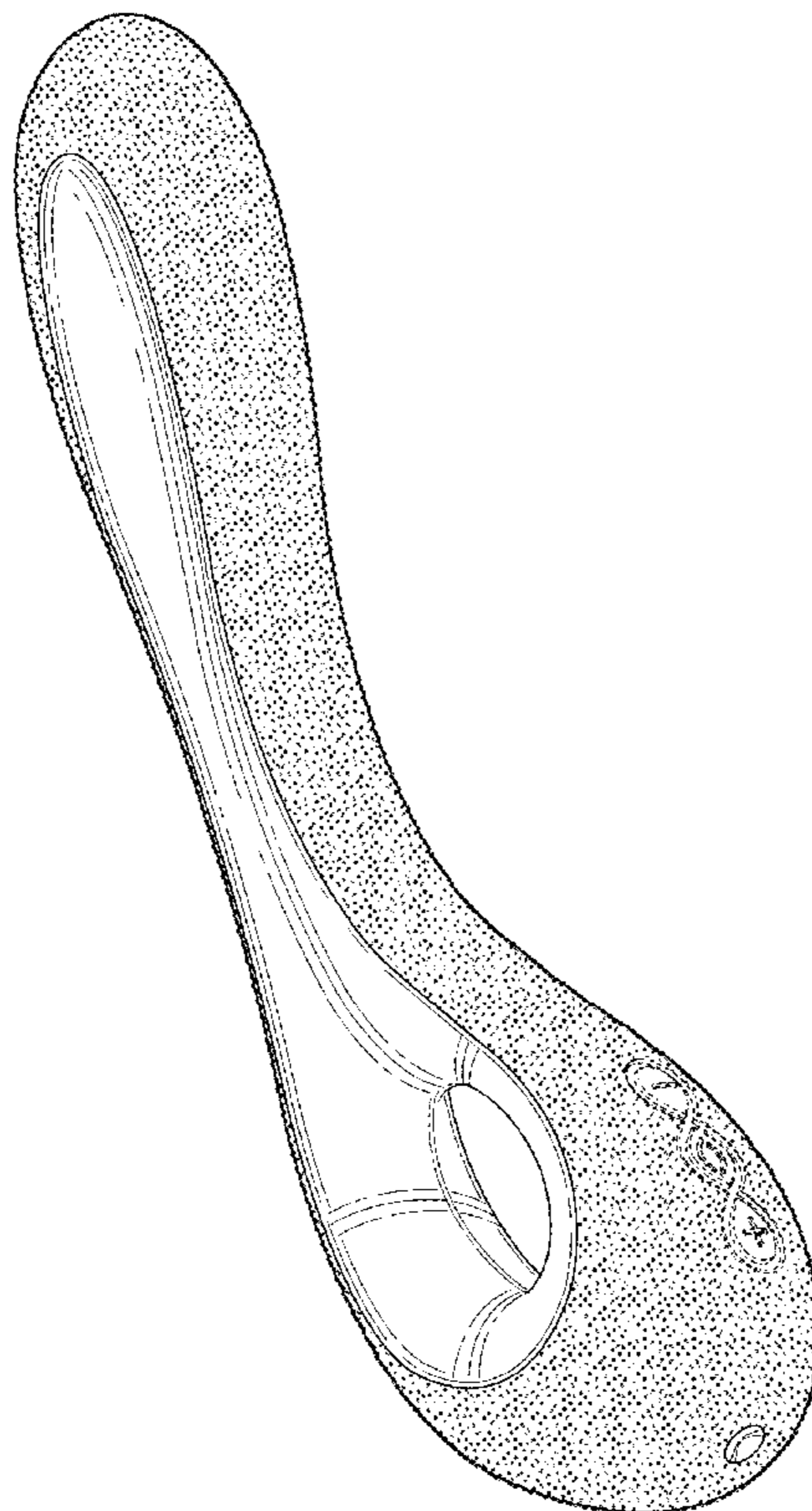
FIGS. 4 and 5 are right and left side views, respectively, of the vibrator.

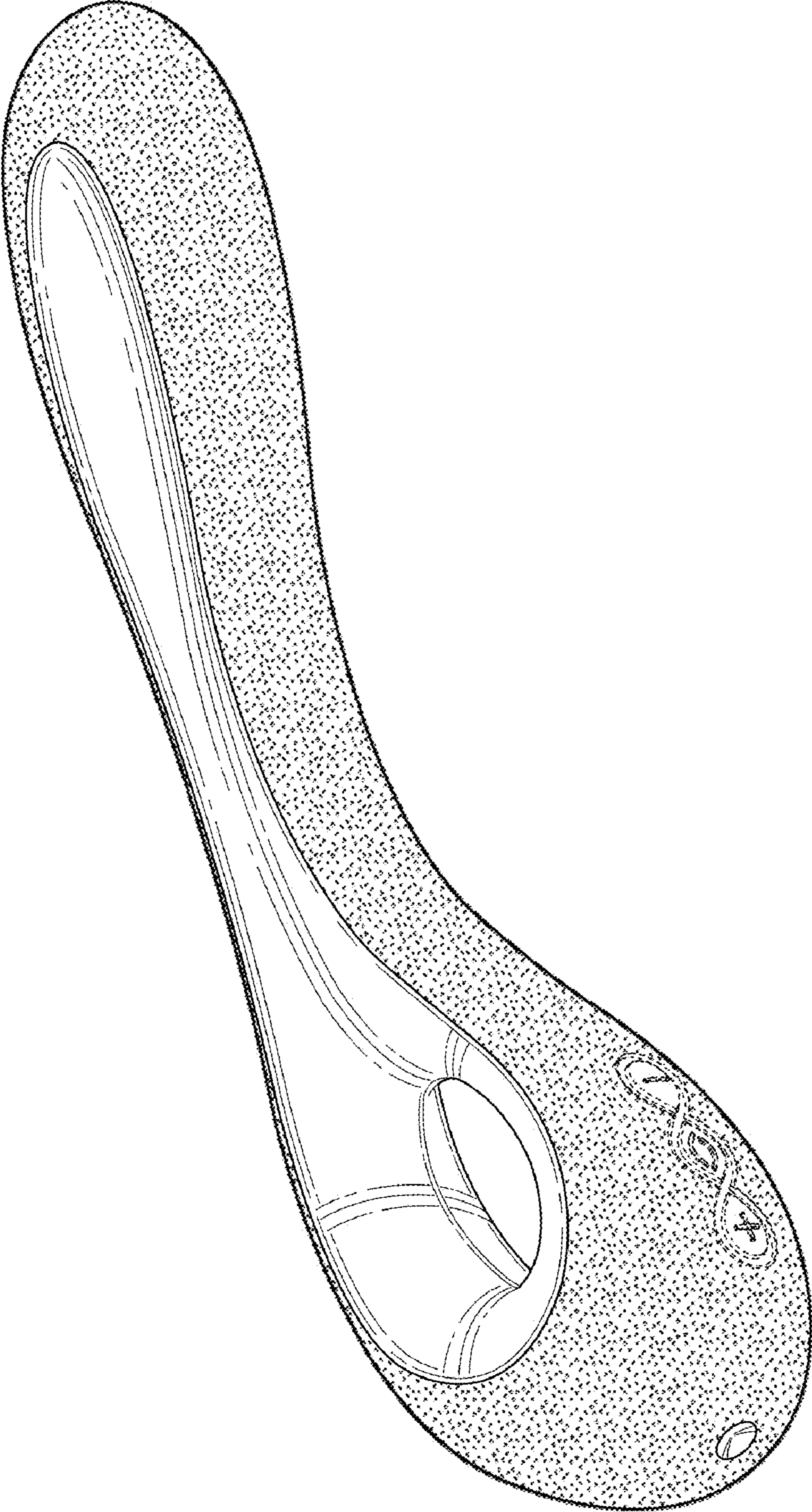

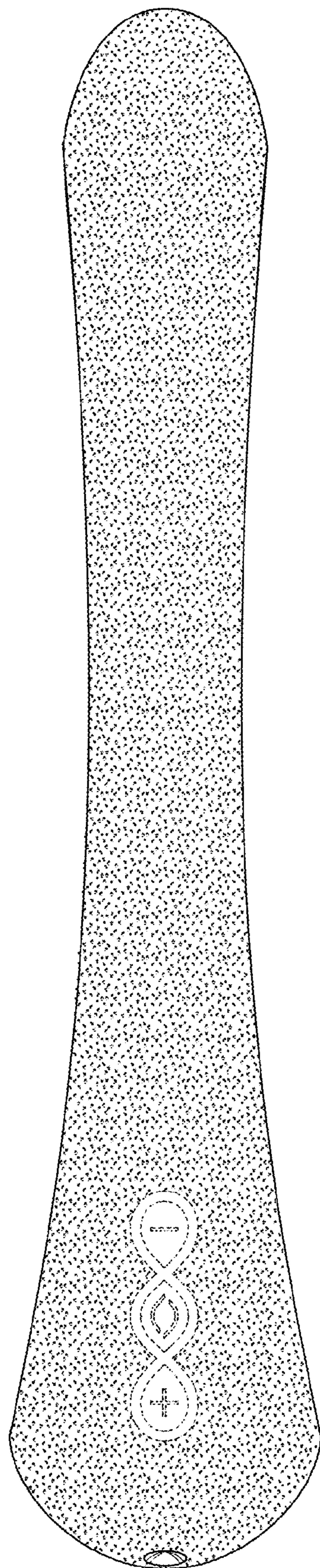

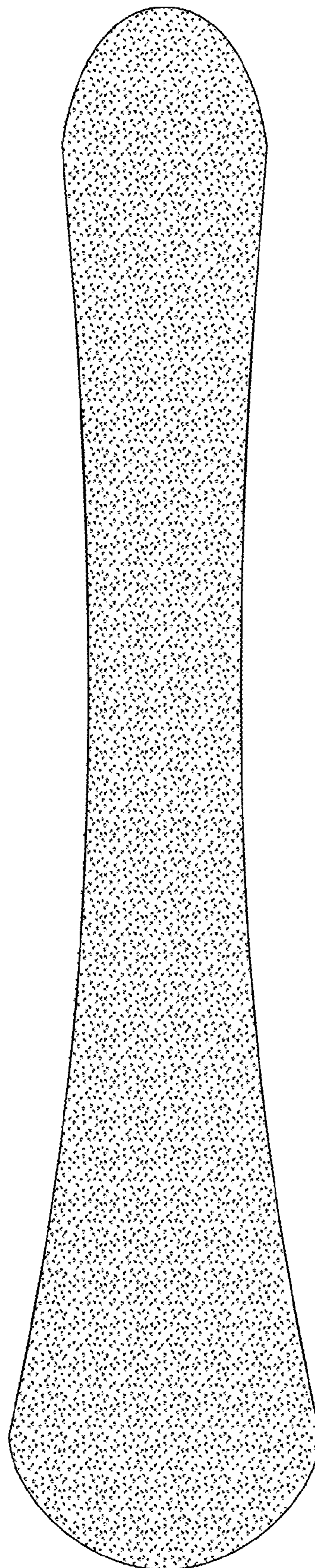

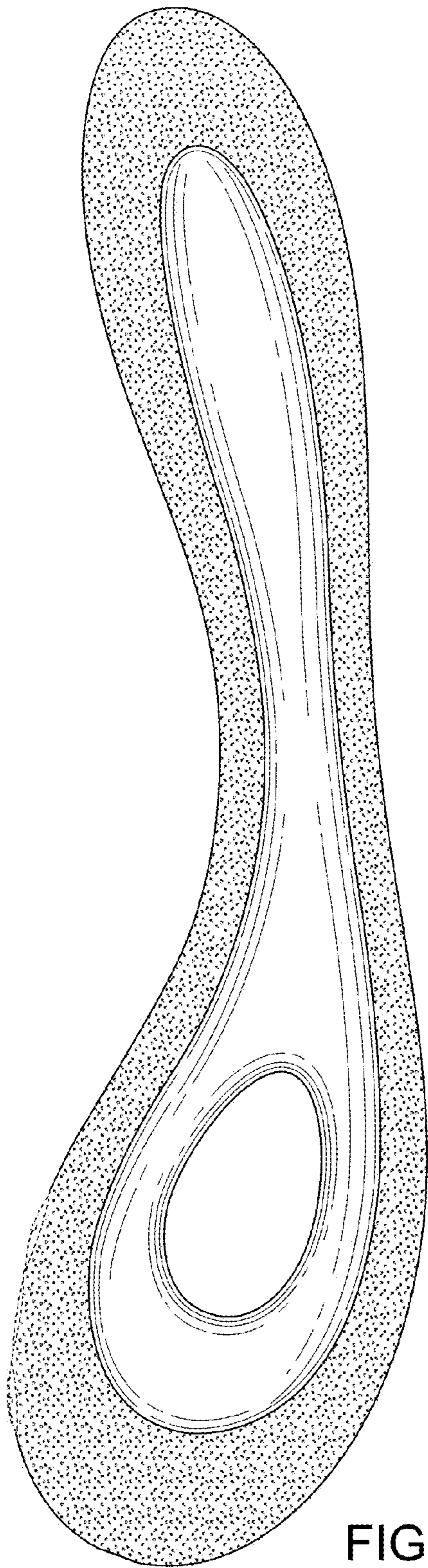

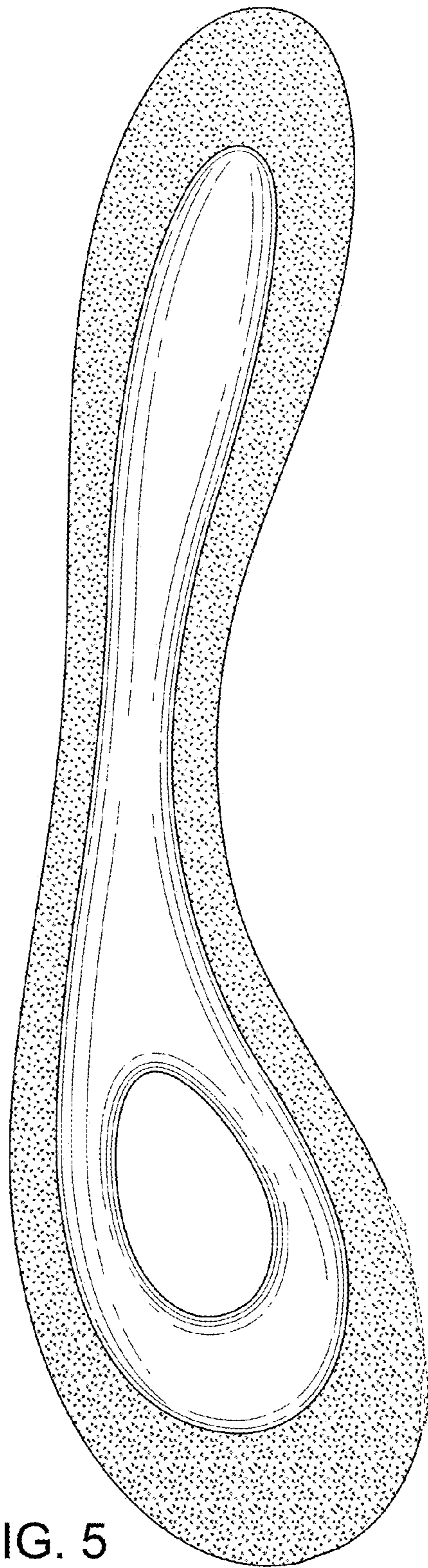

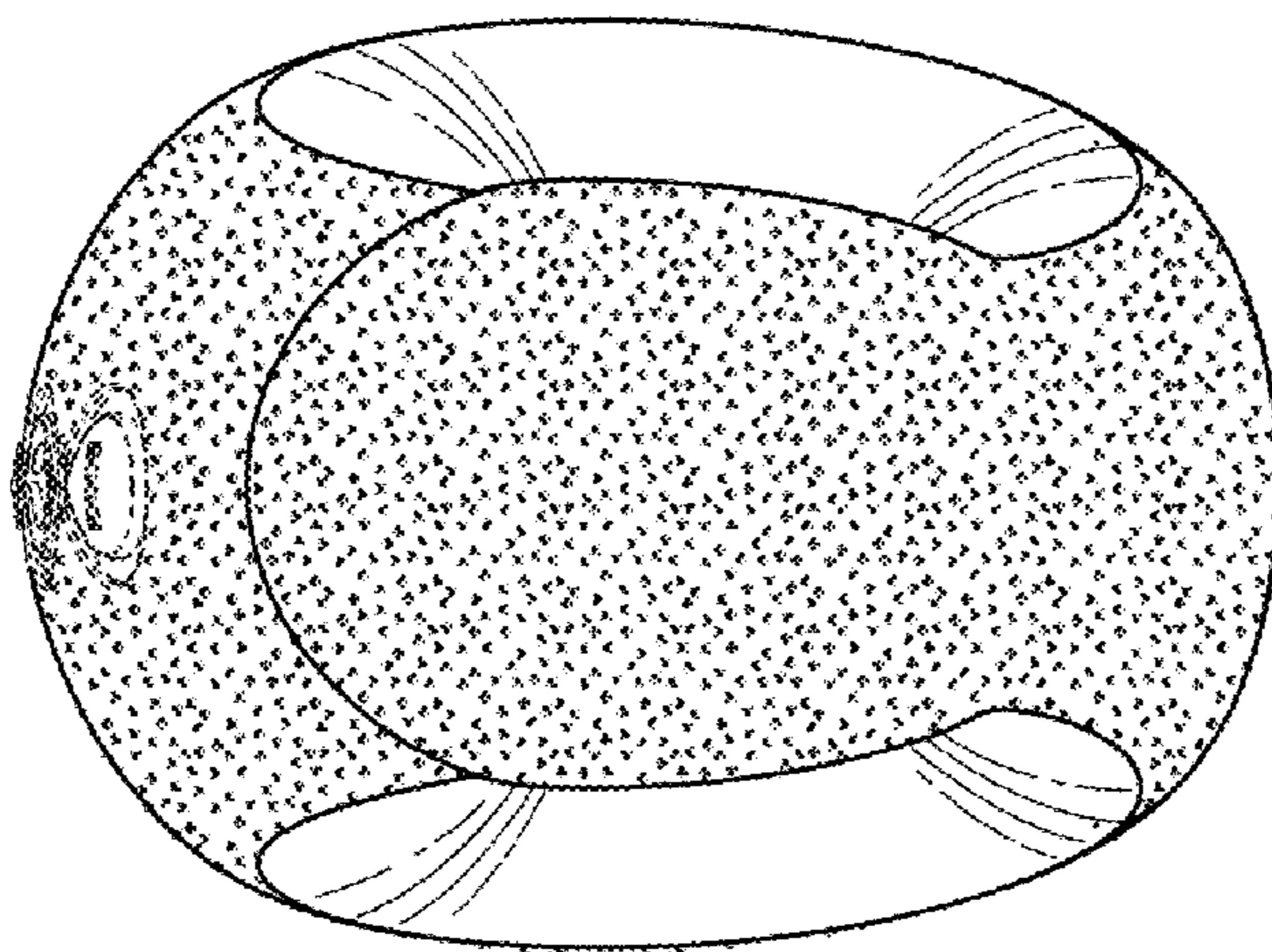

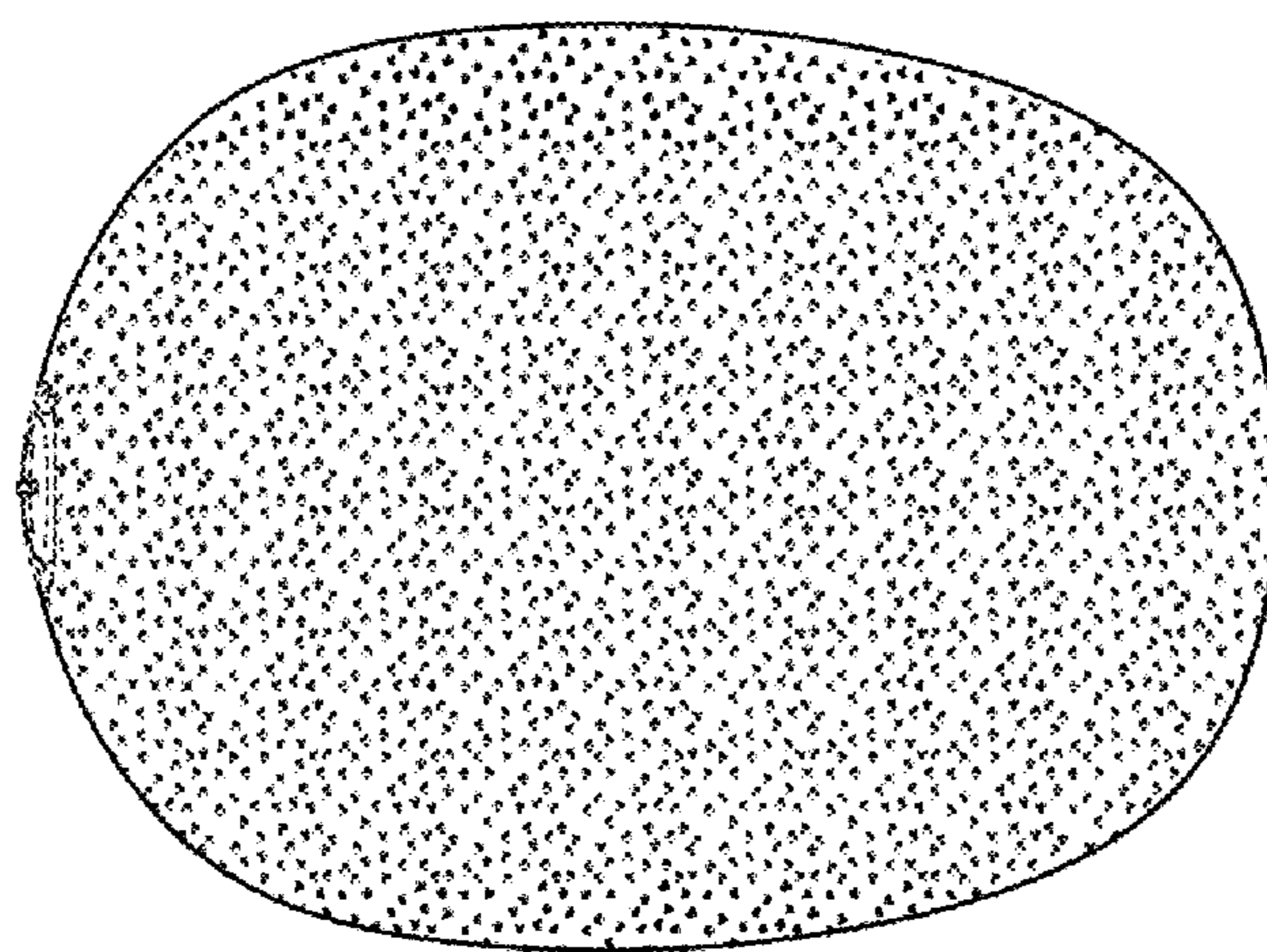
