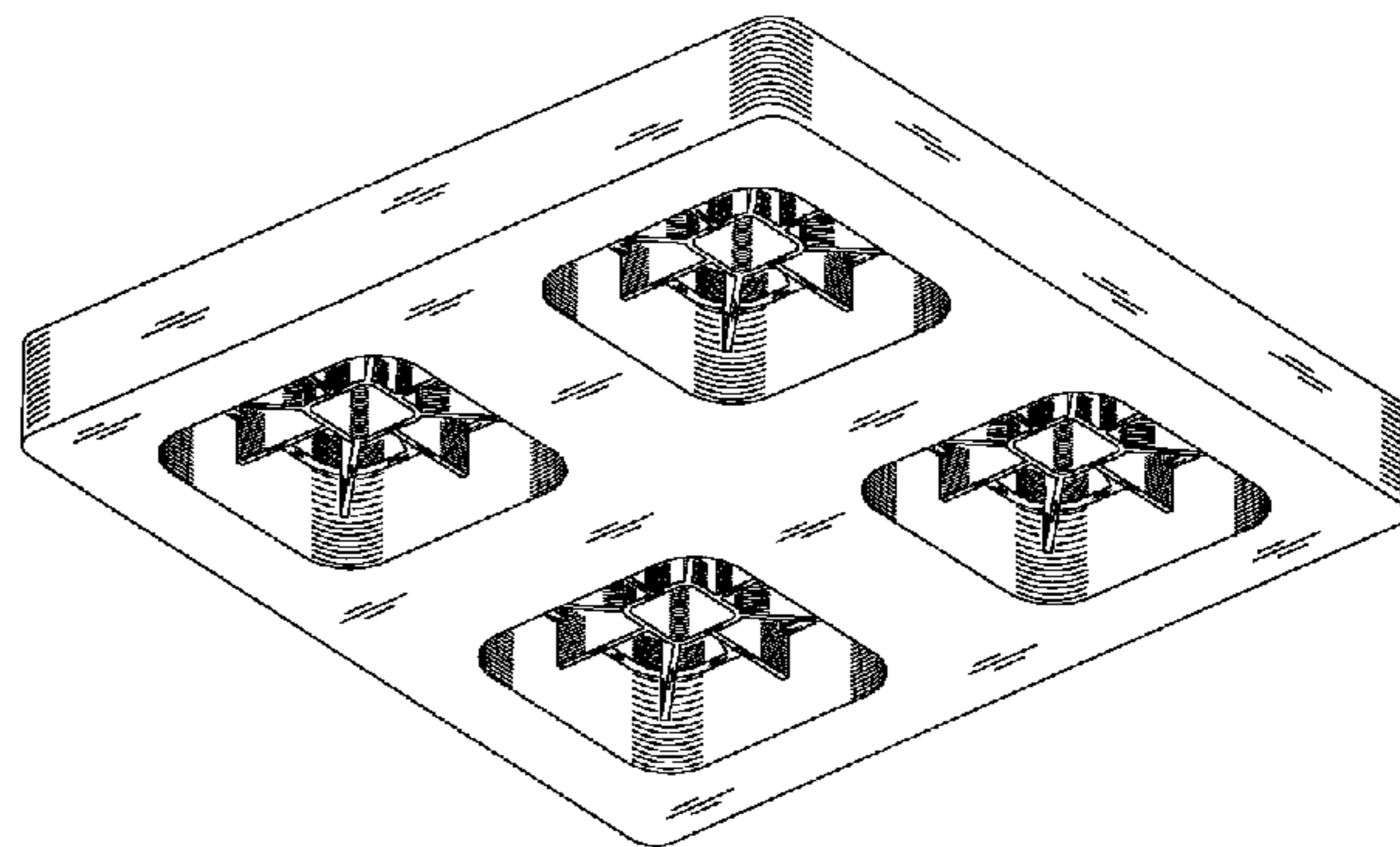
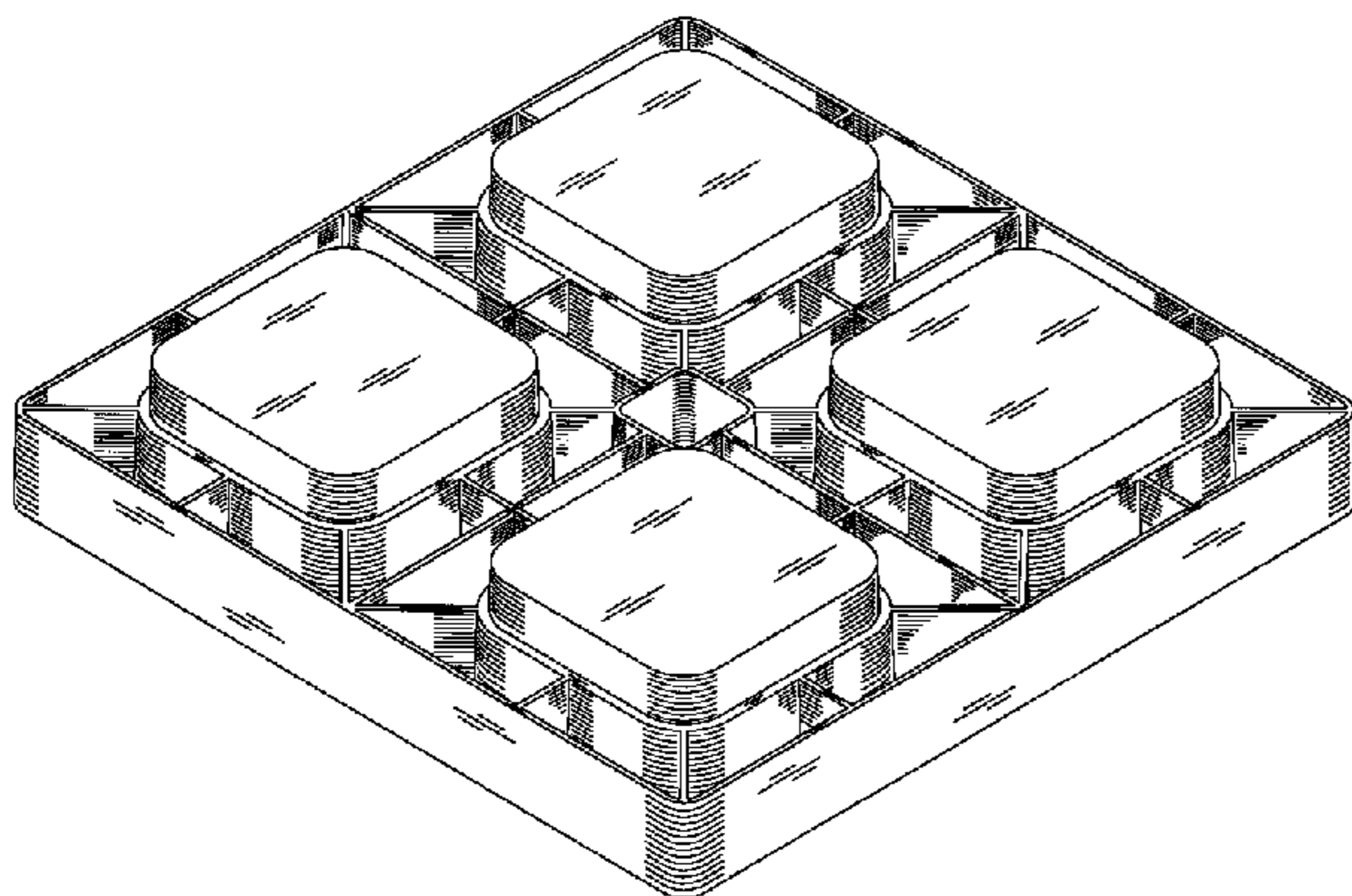
(57) **CLAIM**

The ornamental design for a leveling block, as shown and described.

DESCRIPTION

FIG. 1 is a top, front right perspective view of a leveling block according to the invention;
FIG. 2 is a front elevational view according to the invention and the rear elevational view being a mirror image thereof;
FIG. 3 is a top plan view according to the invention;
FIG. 4 is a right elevational view according to the invention and the left elevational view being a mirror image thereof;
FIG. 5 is a bottom plan view according to the invention;
FIG. 6 is a bottom, front right perspective view of a leveling block according to the invention;
FIG. 7 is a right, front top perspective view of a leveling block according to the invention; and,
FIG. 8 is a left, rear bottom perspective view of a leveling block according to the invention.

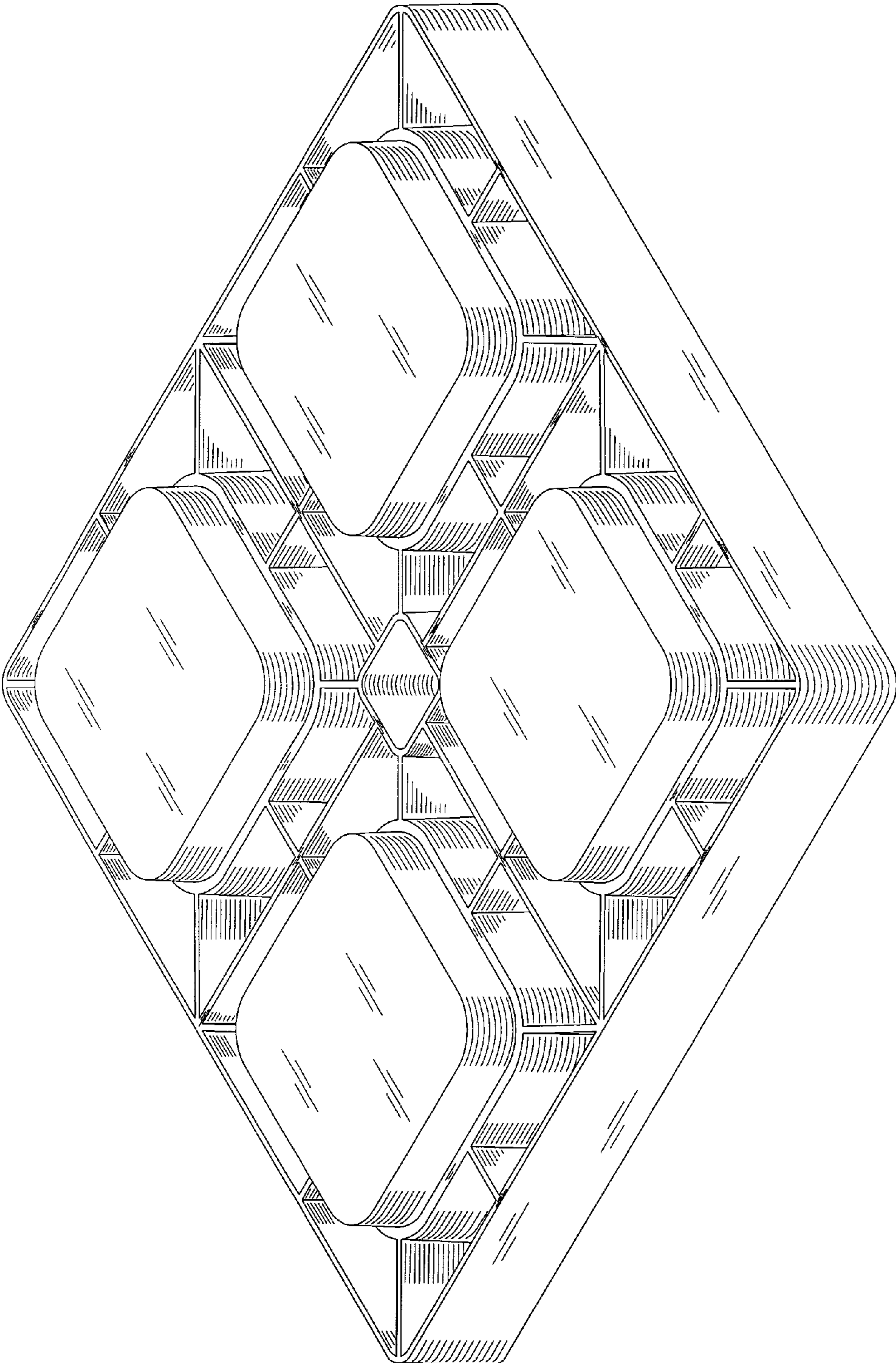

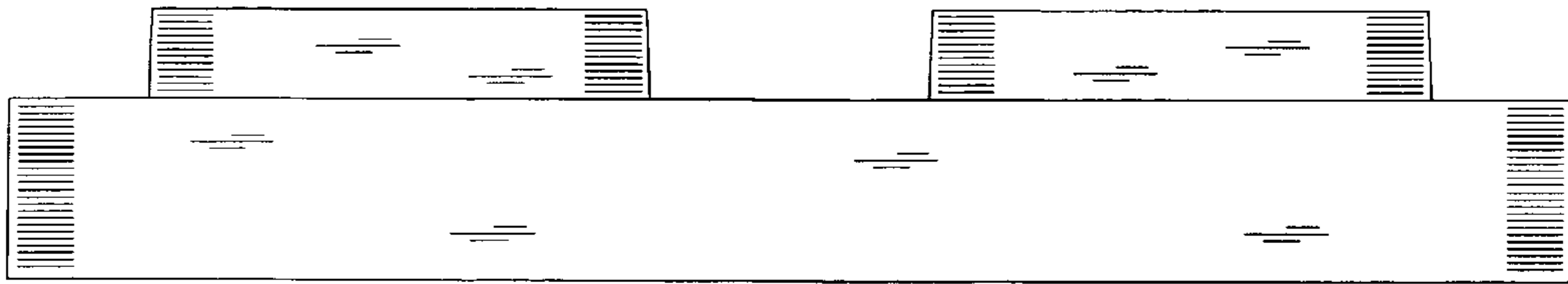

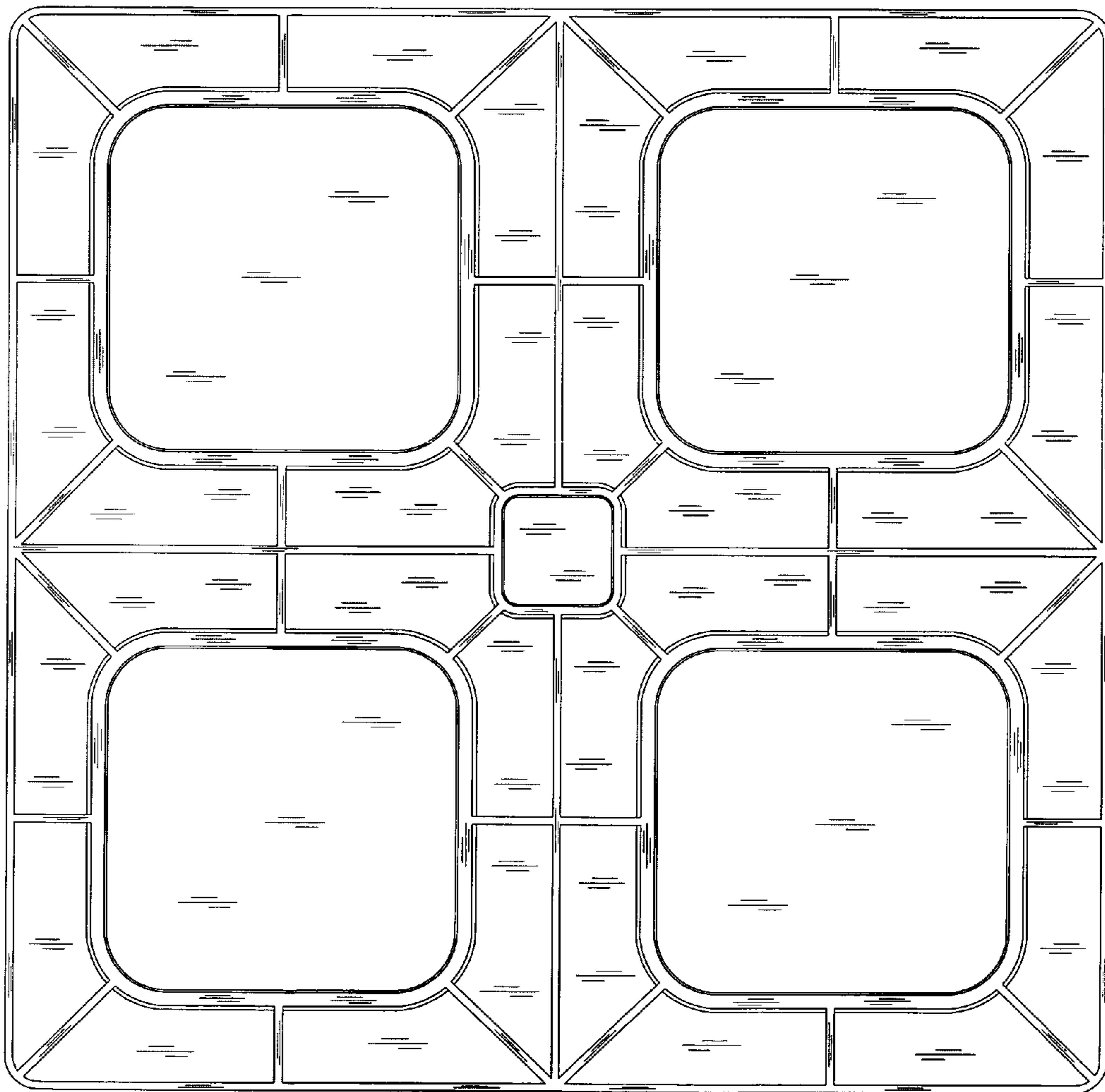

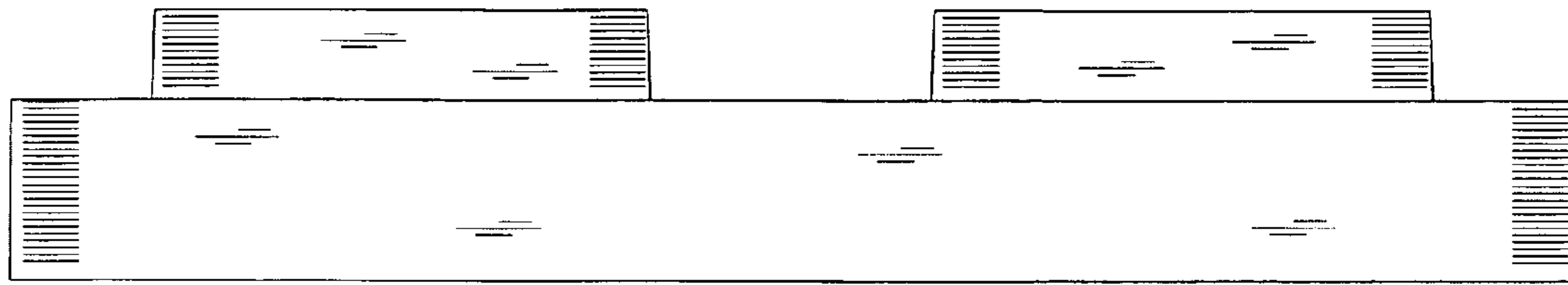

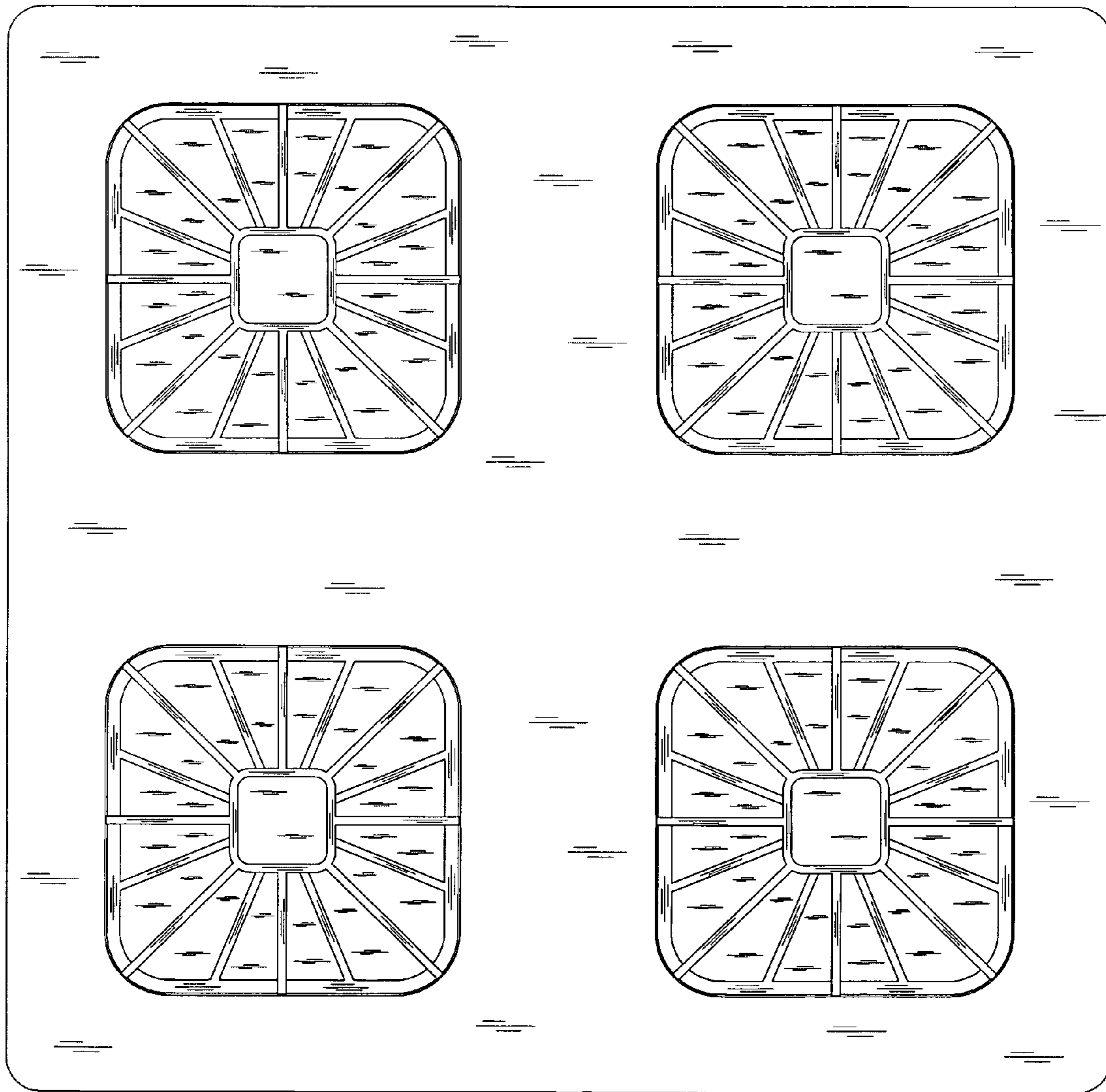

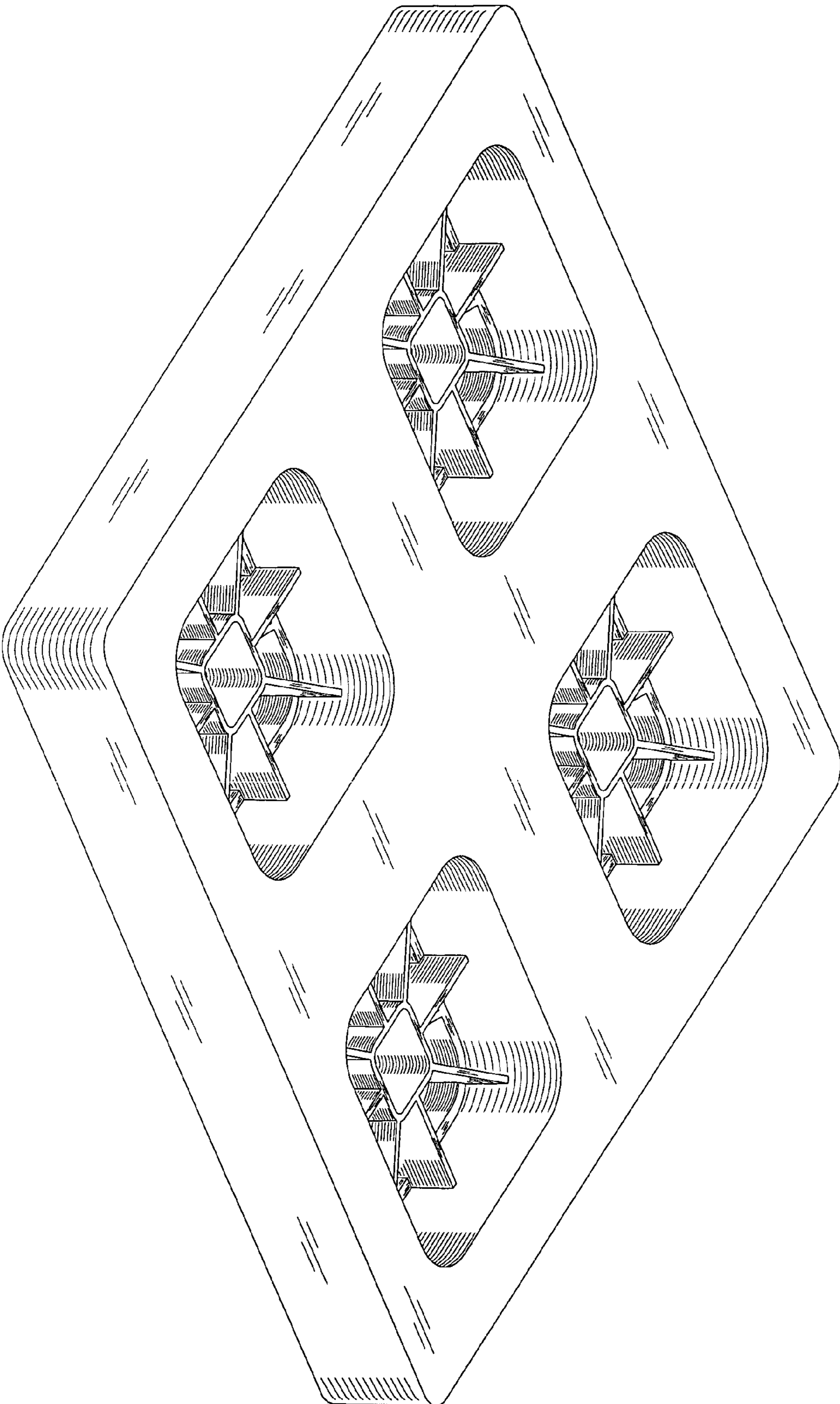

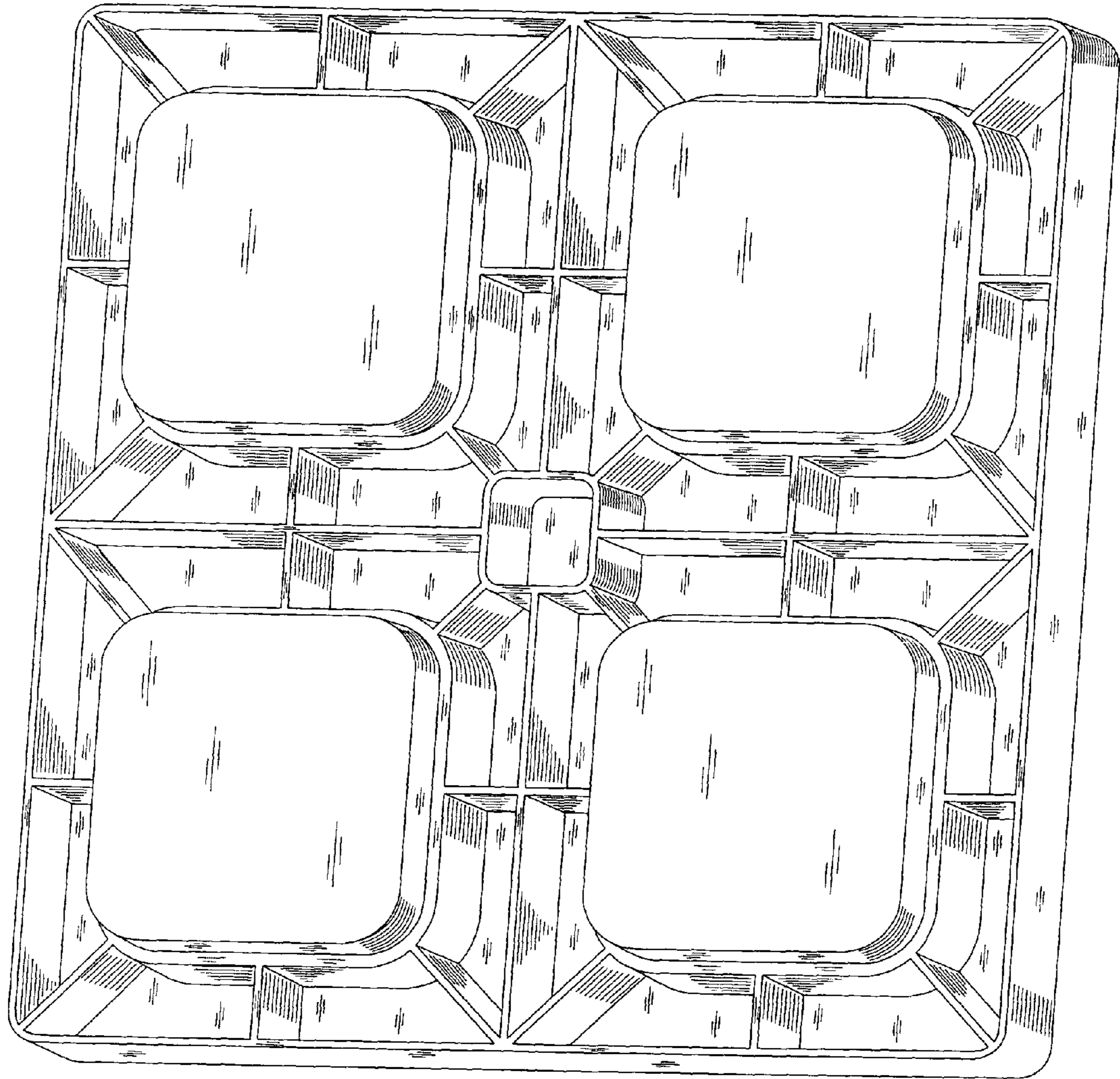

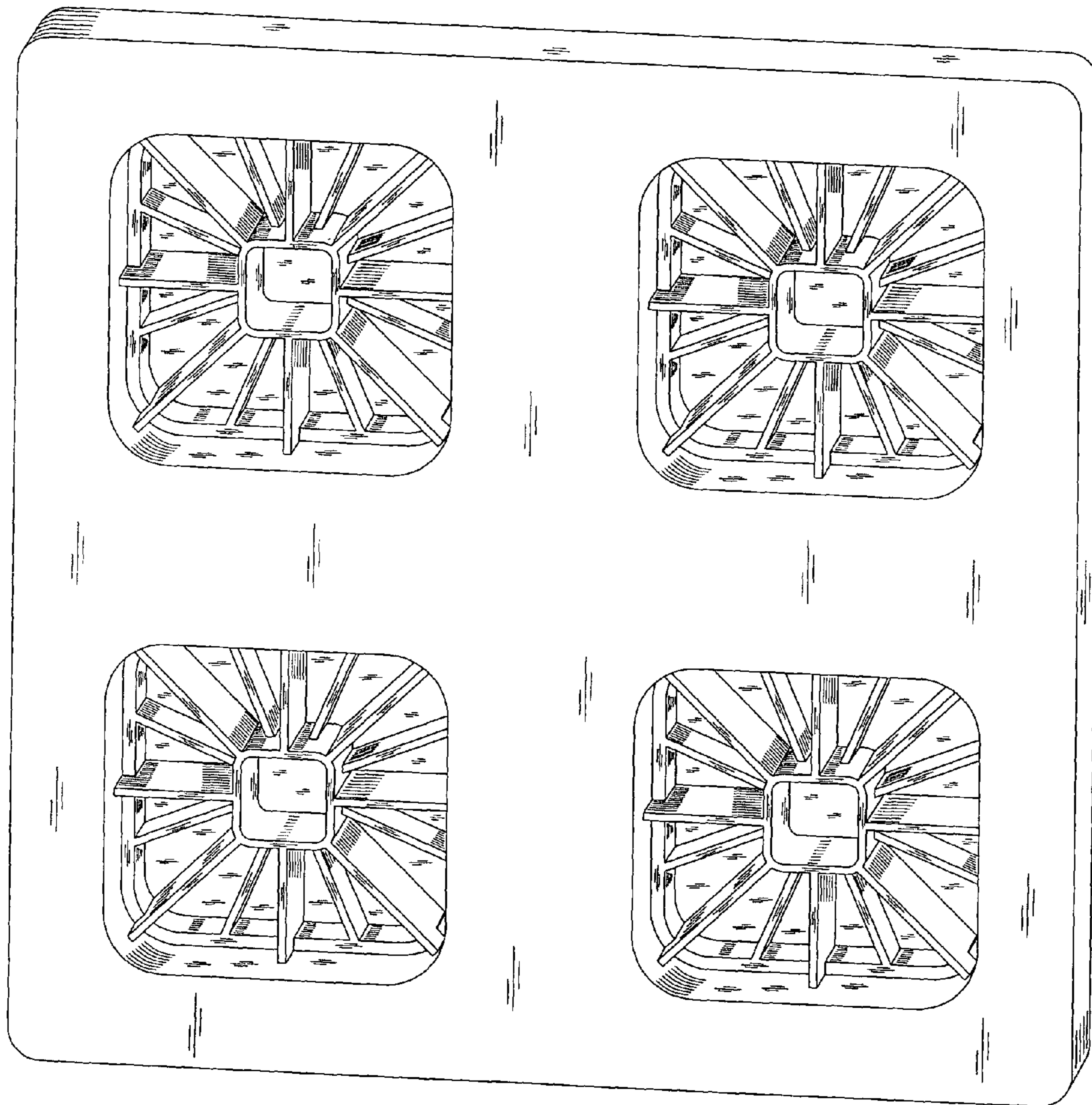
