(57) **CLAIM**

The ornamental design for a wall panel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall panel.
 FIG. 2 is a front elevation view thereof.
 FIG. 3 is a rear elevation view thereof.
 FIG. 4 is a right side elevation view thereof. A left side elevation view is omitted because it is symmetrical with the right side elevation view.
 FIG. 5 is a top plan view thereof. A bottom plan view is omitted because it is symmetrical with the top plan view.
 FIG. 6 is an enlarged fragmentary perspective view thereof.
 FIG. 7 is an enlarged fragmentary perspective view thereof.
 FIG. 8 is an enlarged fragmentary front view thereof.
 FIG. 9 is an enlarged fragmentary right side view thereof.
 FIG. 10 is an enlarged top plan view thereof.
 FIG. 11 is an enlarged cross-sectional view thereof taken along line 11-11 in FIG. 2.
 FIG. 12 is an enlarged cross-sectional view thereof taken along line 12-12 in FIG. 2; and,
 FIG. 13 is an enlarged cross-sectional view thereof taken along line 13-13 in FIG. 8.

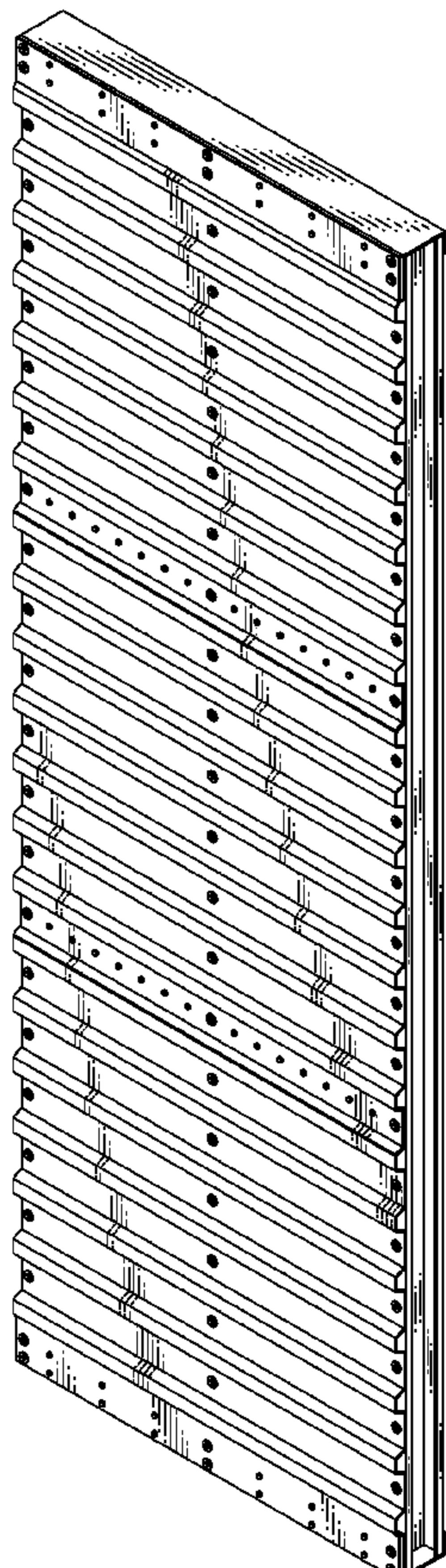

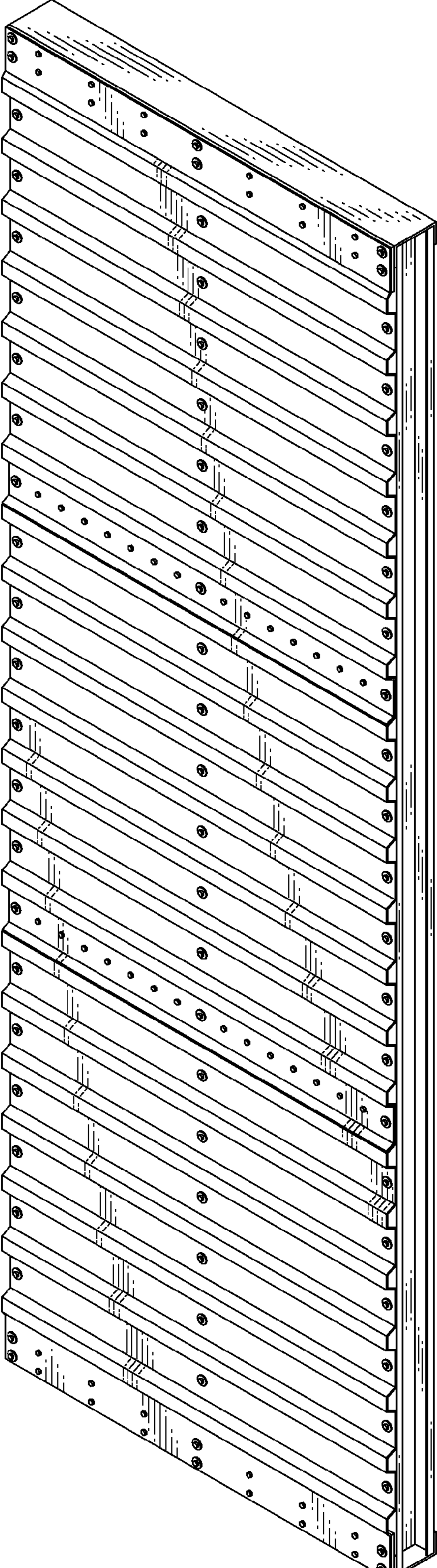

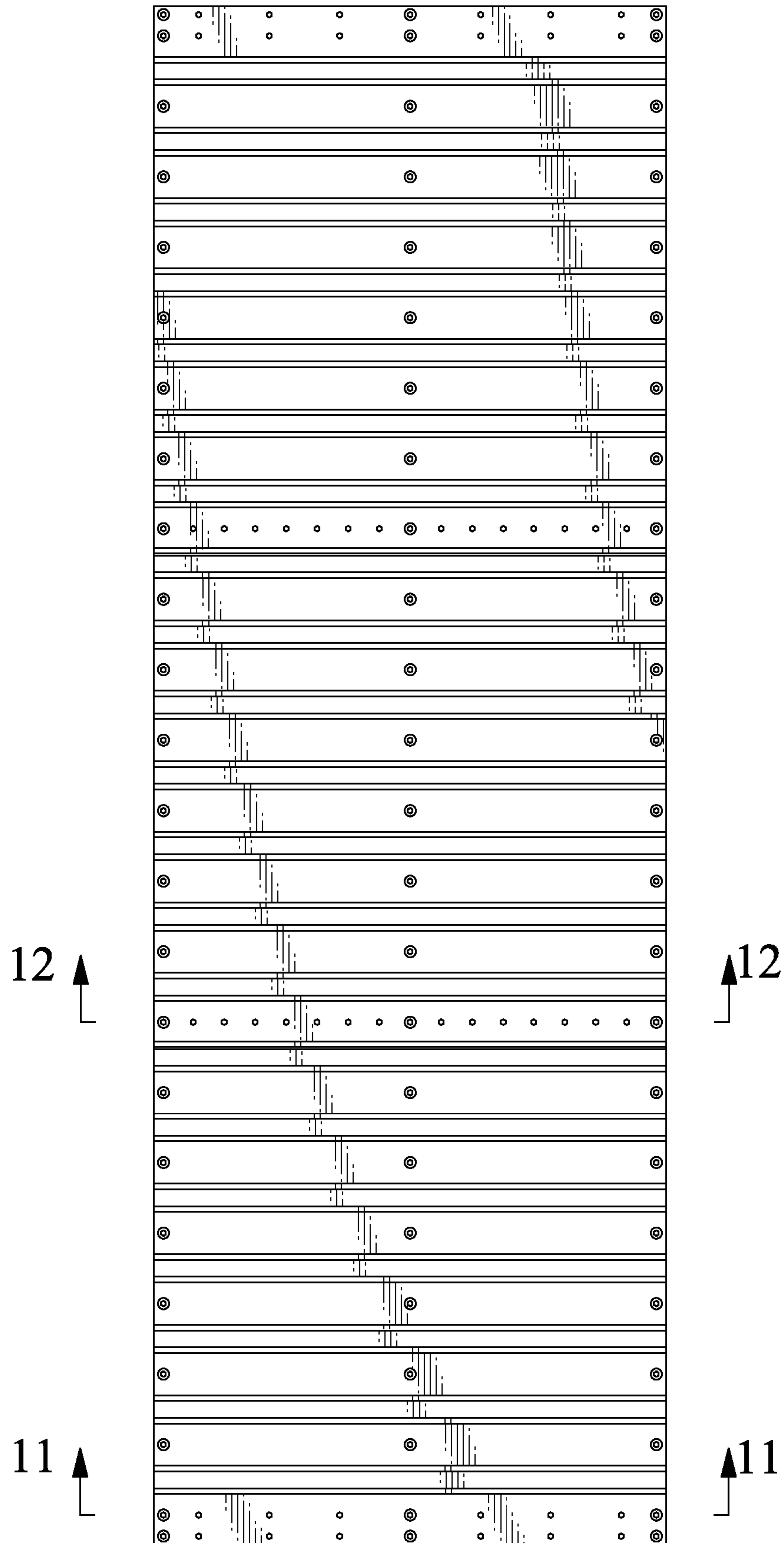

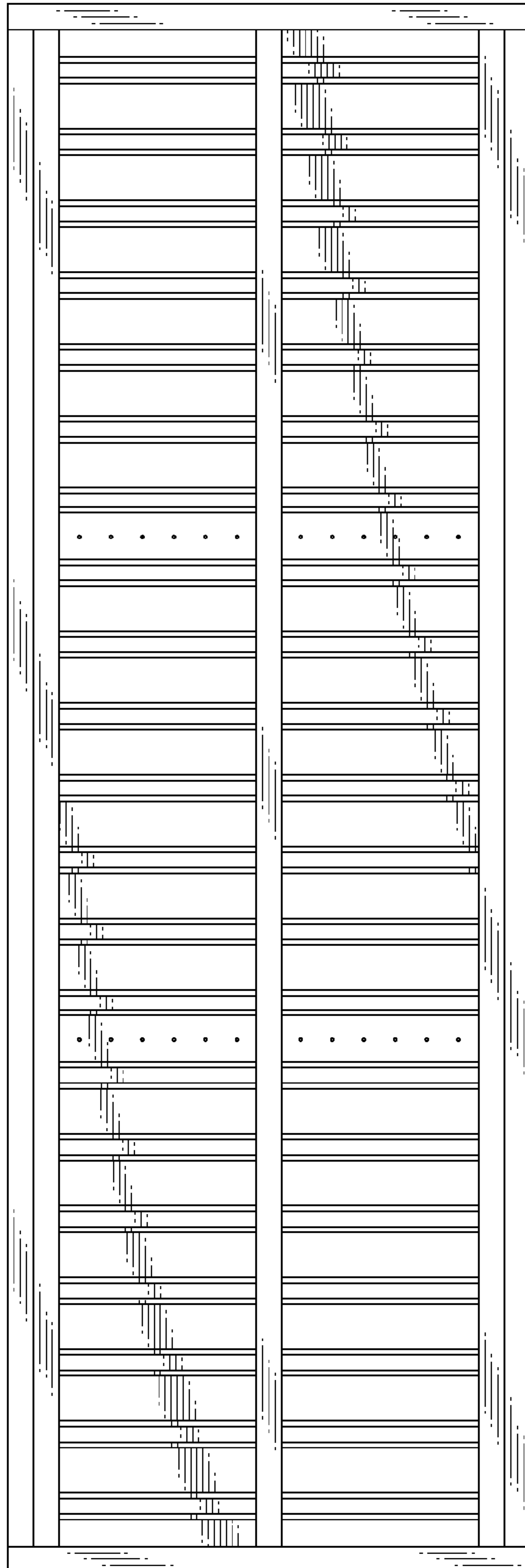

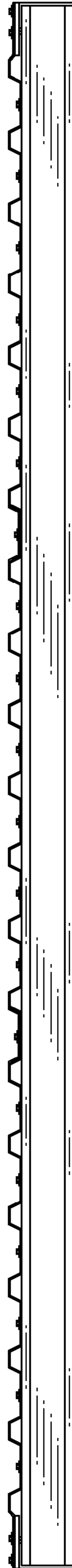

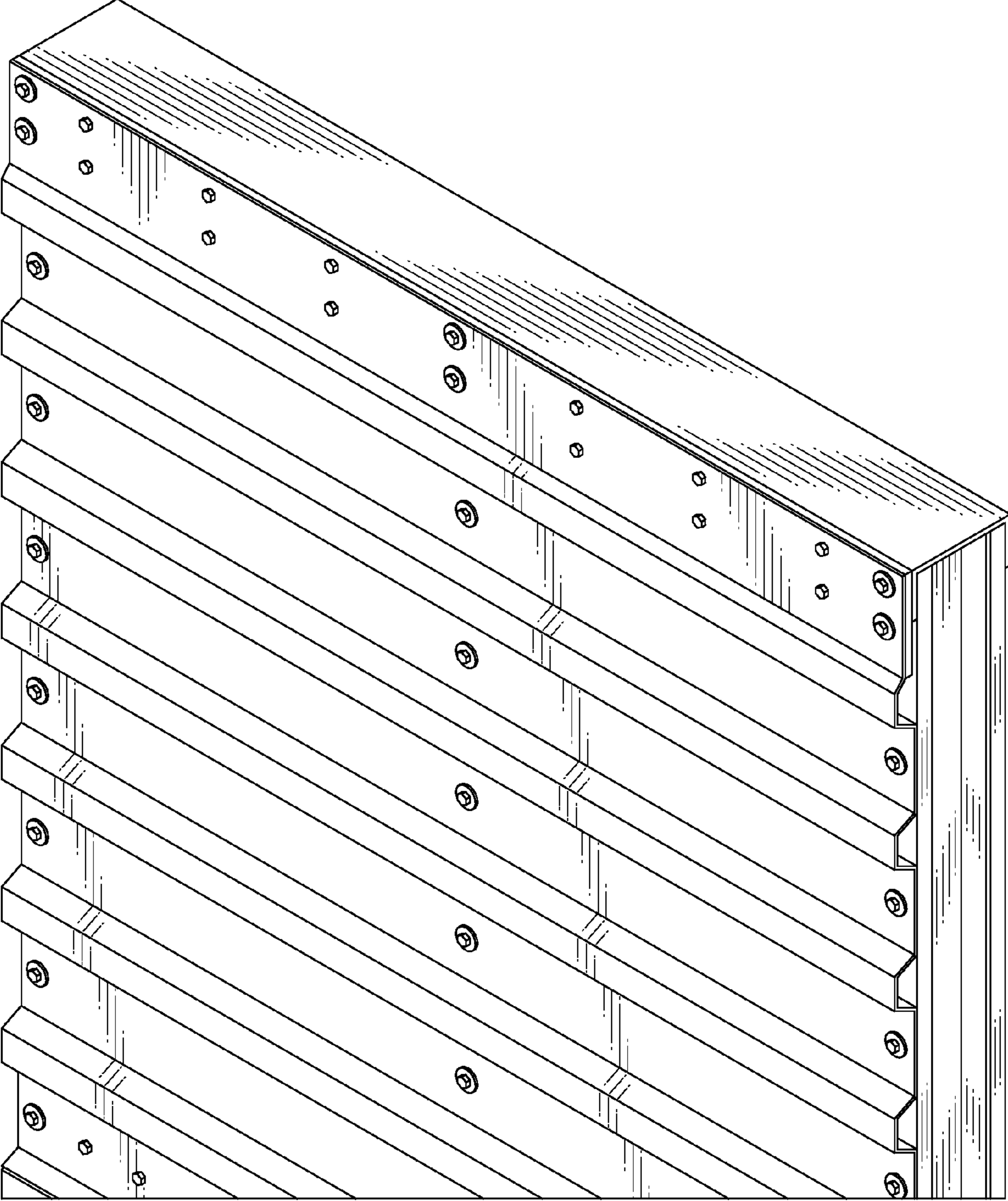

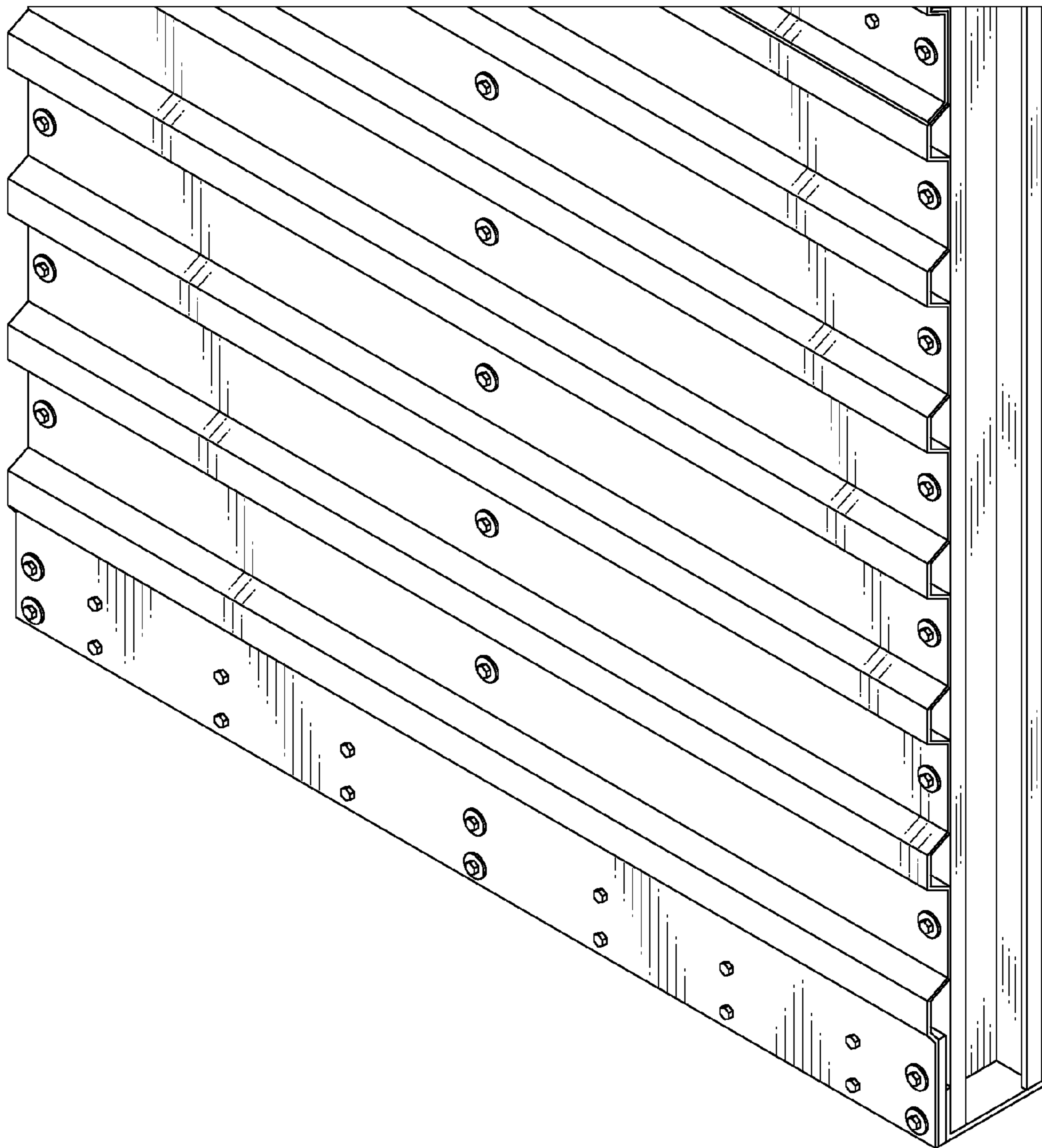

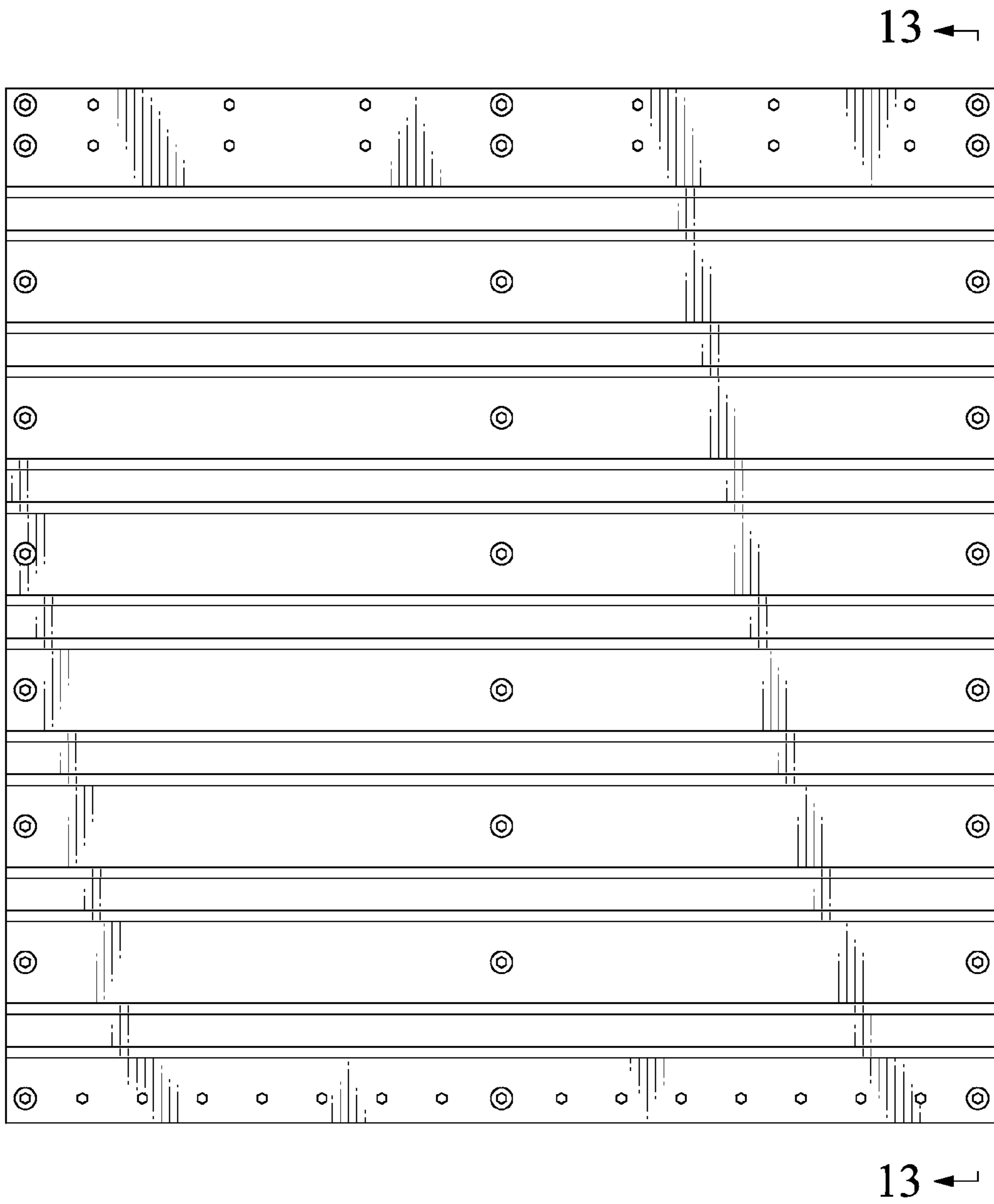

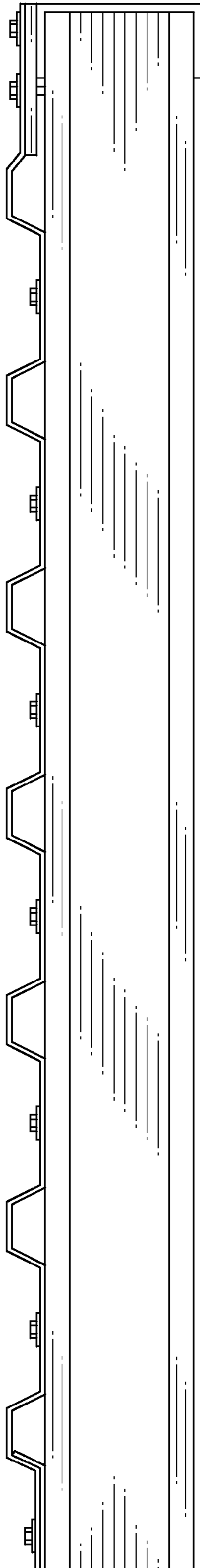

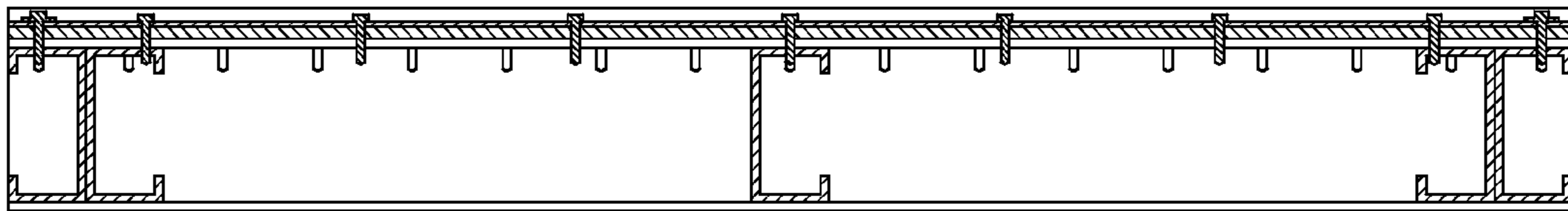

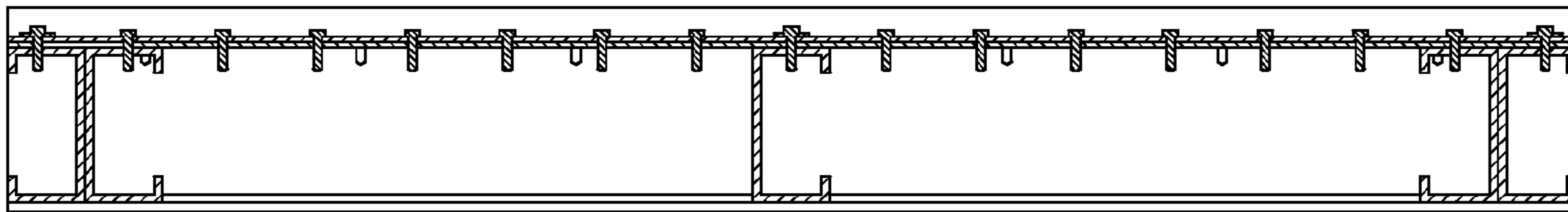
