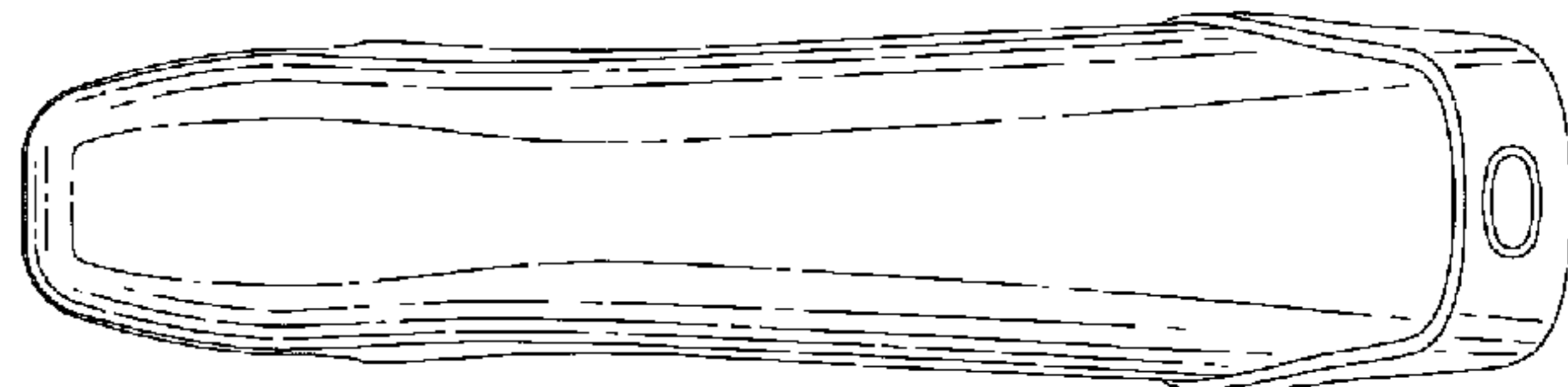
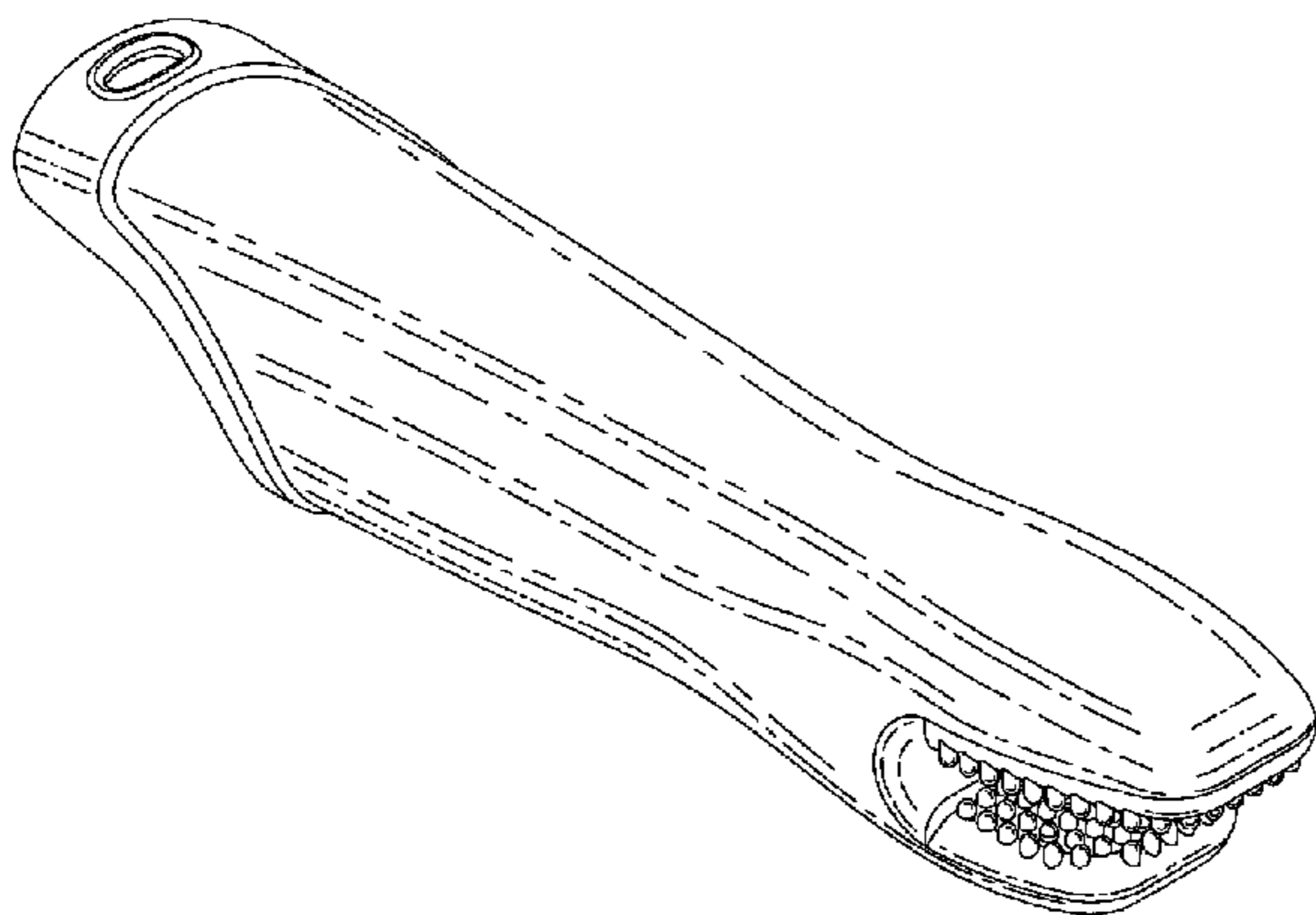
(57) **CLAIM**

The ornamental design for a long-sleeve grill mitt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-facing perspective view of the long-sleeve grill mitt showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a left-side elevational view thereof;  
FIG. 5 is a right-side elevational view thereof;

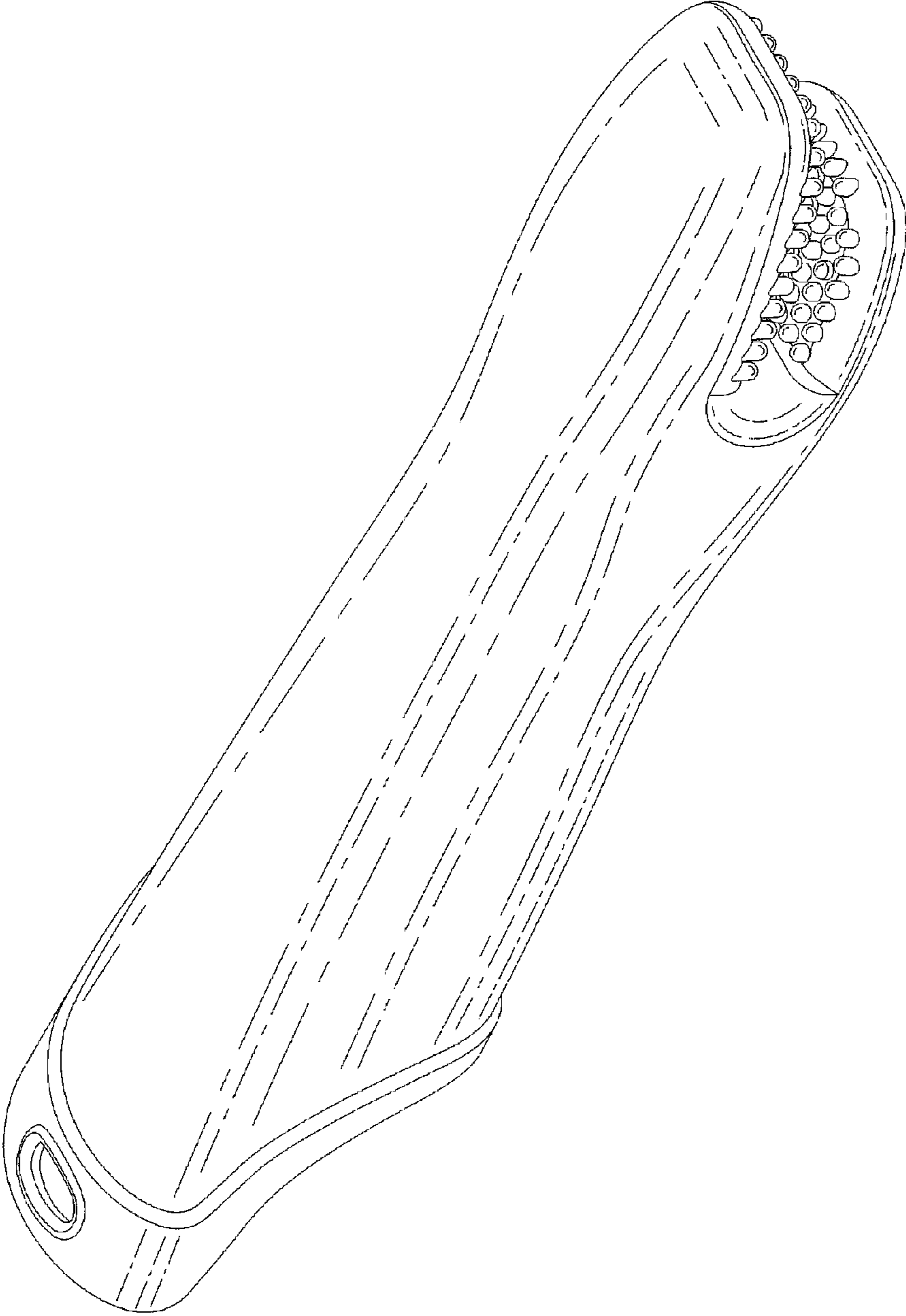

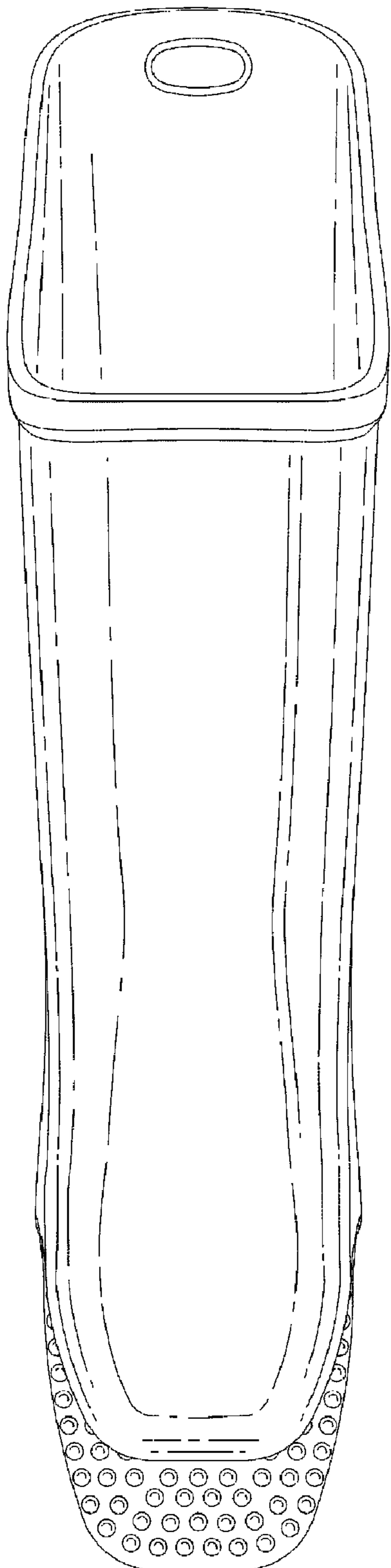

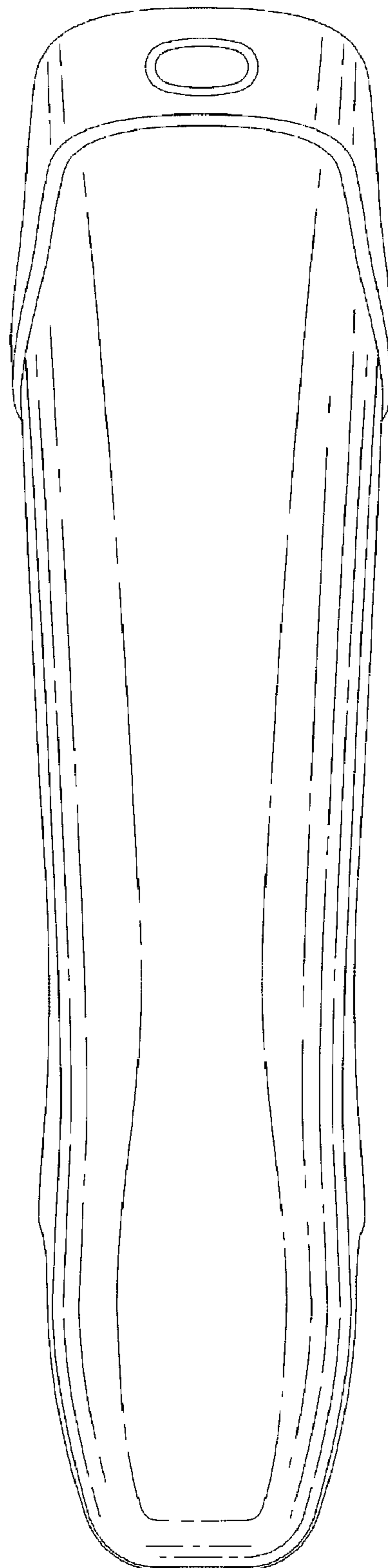

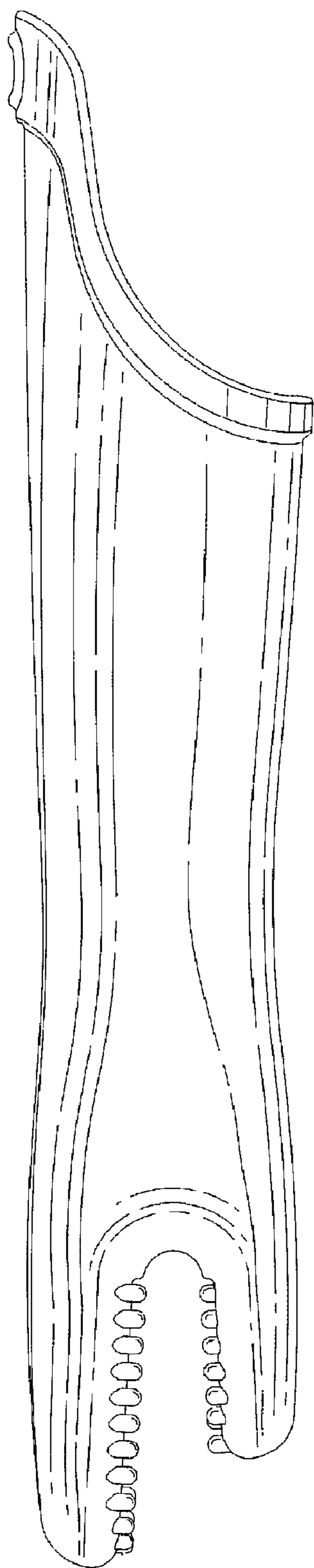

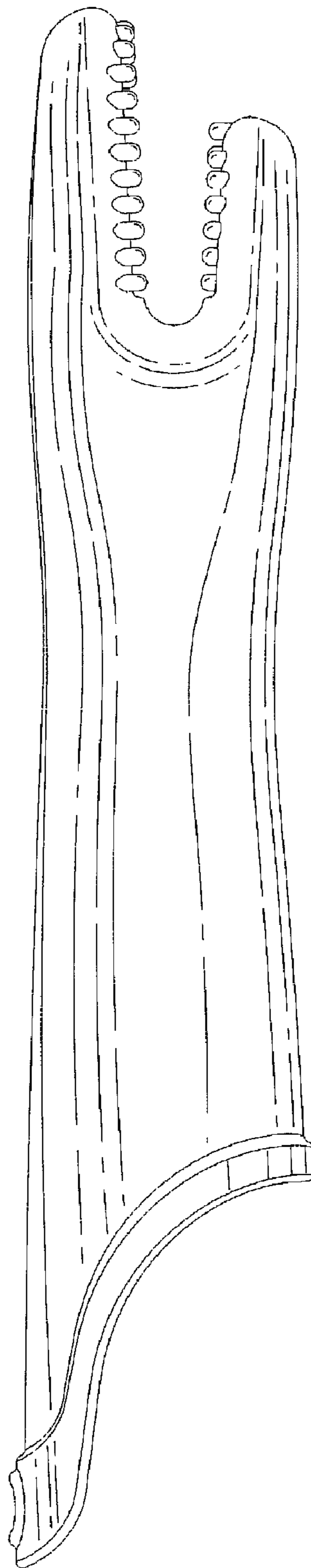

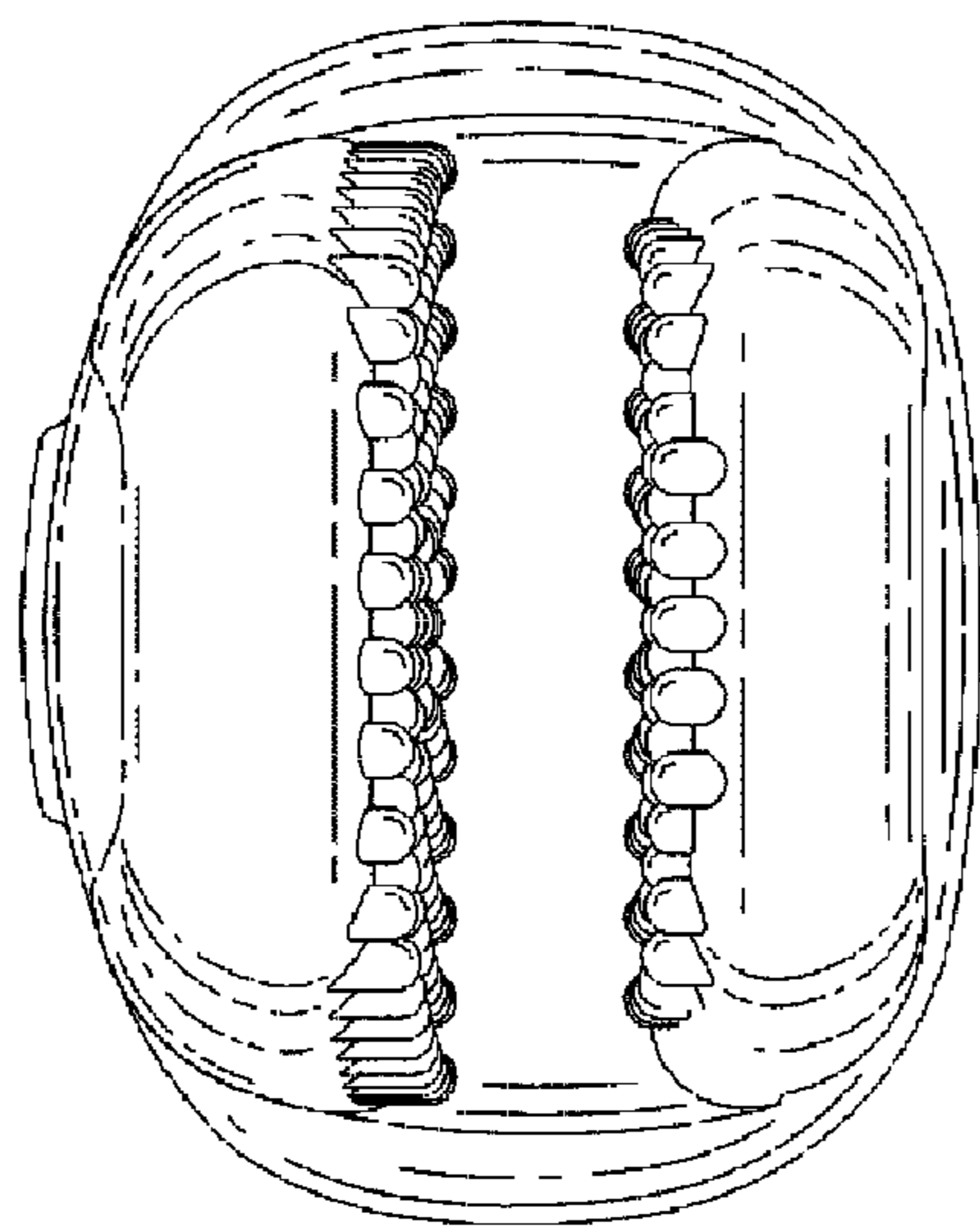

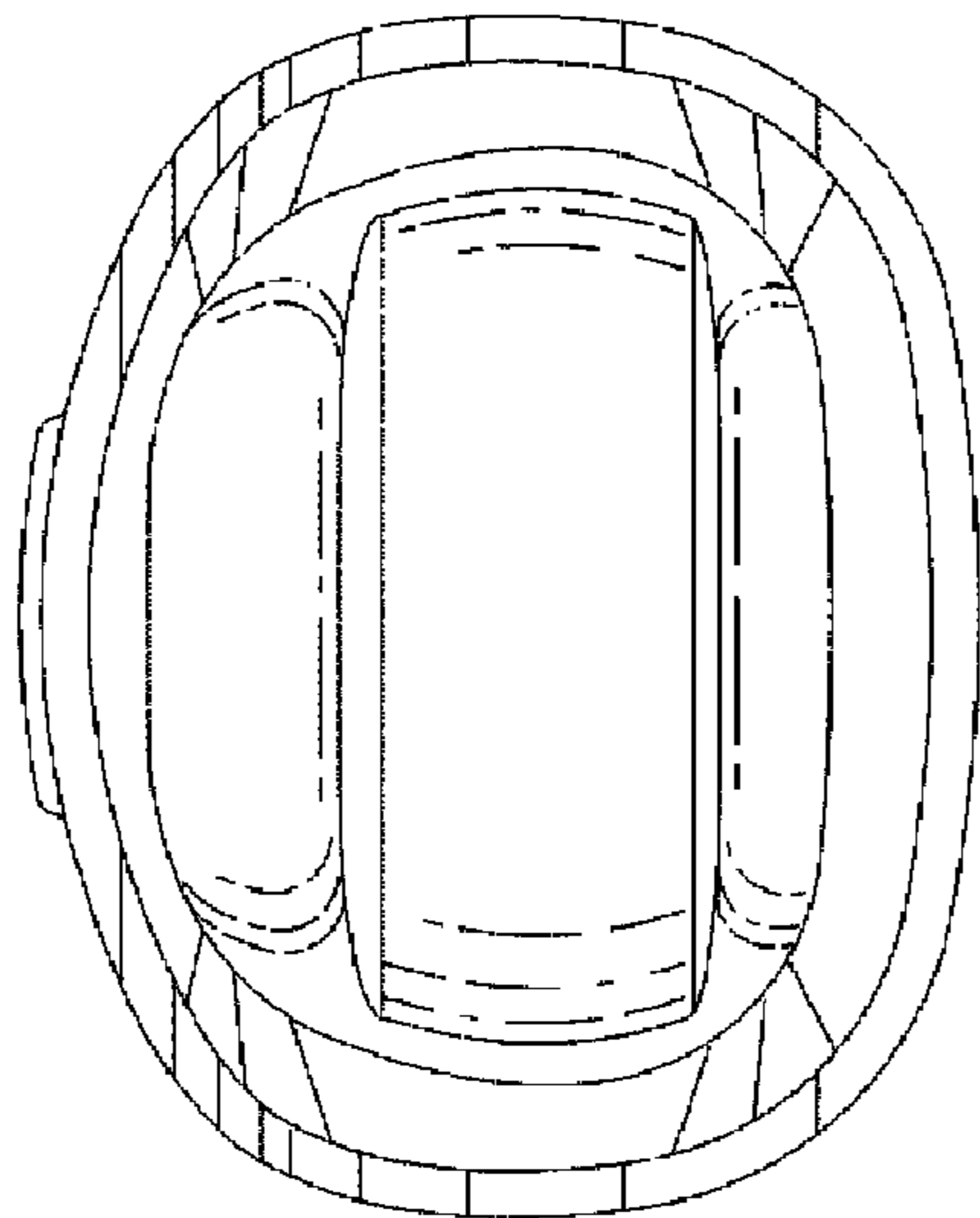
