(57) **CLAIM**

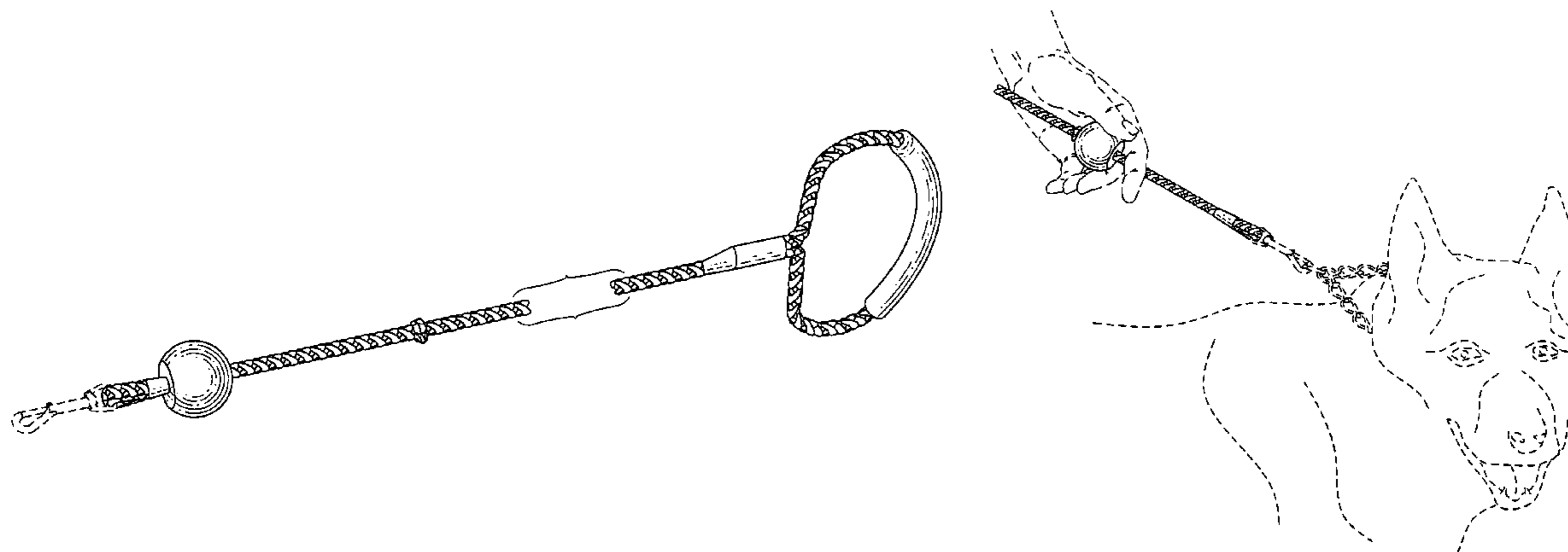
The ornamental design for a dog leash, as shown and described.

DESCRIPTION

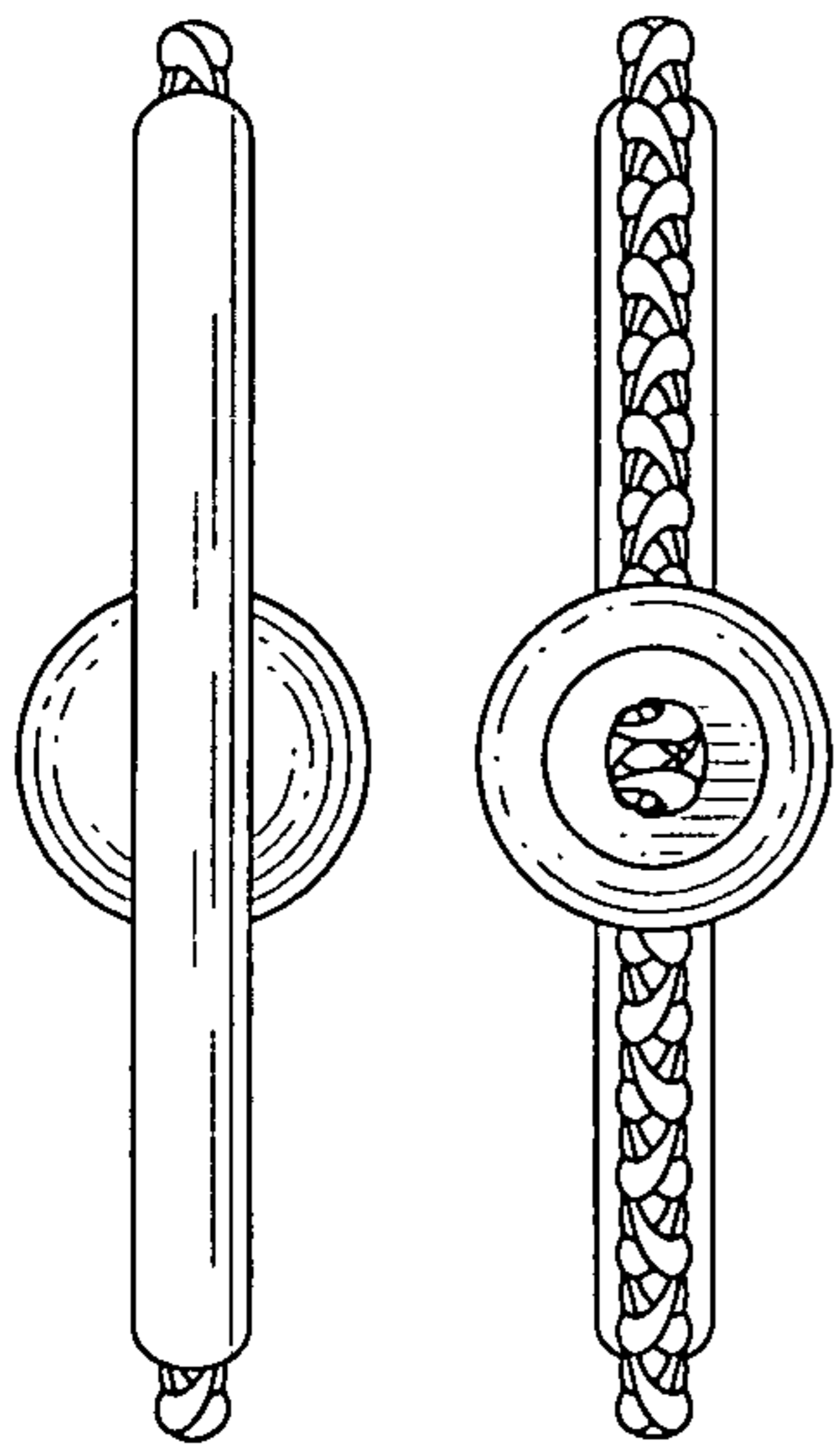


Fig. 4 Fig. 5

FIG. 1 is a perspective view of the dog leash of this design. FIG. 2 is a left side view of the product of this design. The right side view is a mirror image thereof. FIG. 3 is a top plan view of this leash. The bottom view is a mirror image of the top view. FIG. 4 is a rear view thereof. FIG. 5 is a front view of this dog leash. FIG. 6 is an enlarged closeup view of a segment of the side view of the first embodiment. FIG. 7 is an enlarged closeup view of a segment of the side view of the second embodiment. FIG. 8 is an enlarged closeup view of a segment of the side view of the third embodiment; and, FIG. 9 is an environmental perspective view illustrating the leash in use.

The broken line elements are not claimed.

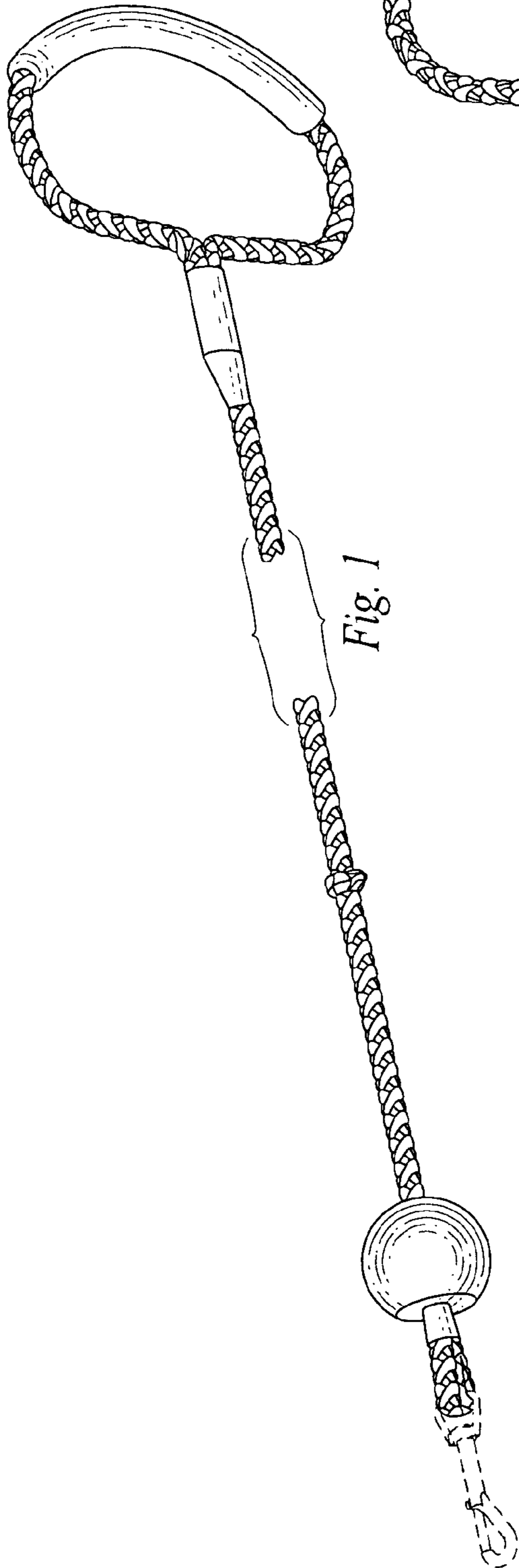

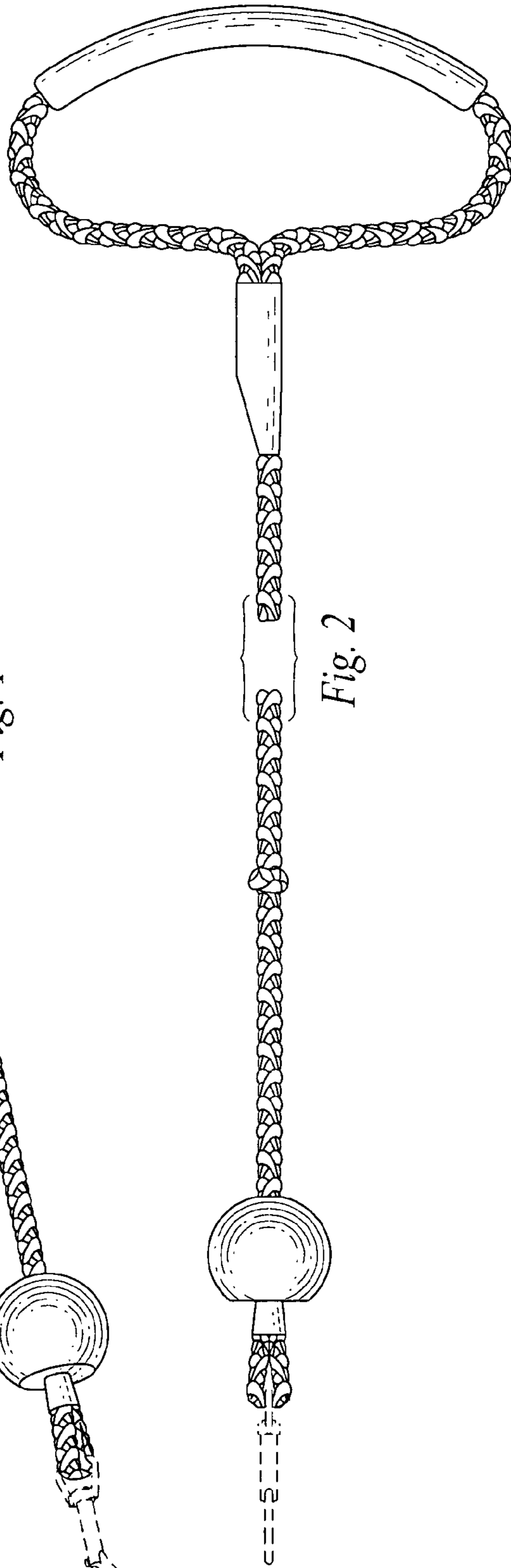

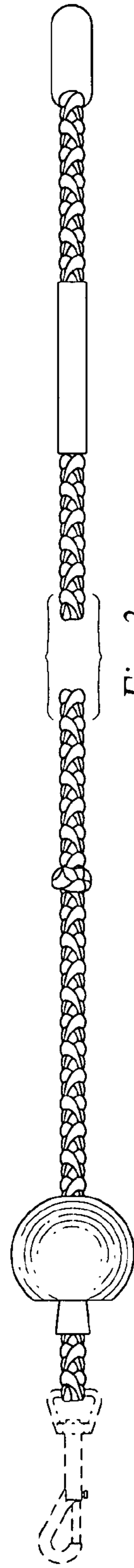

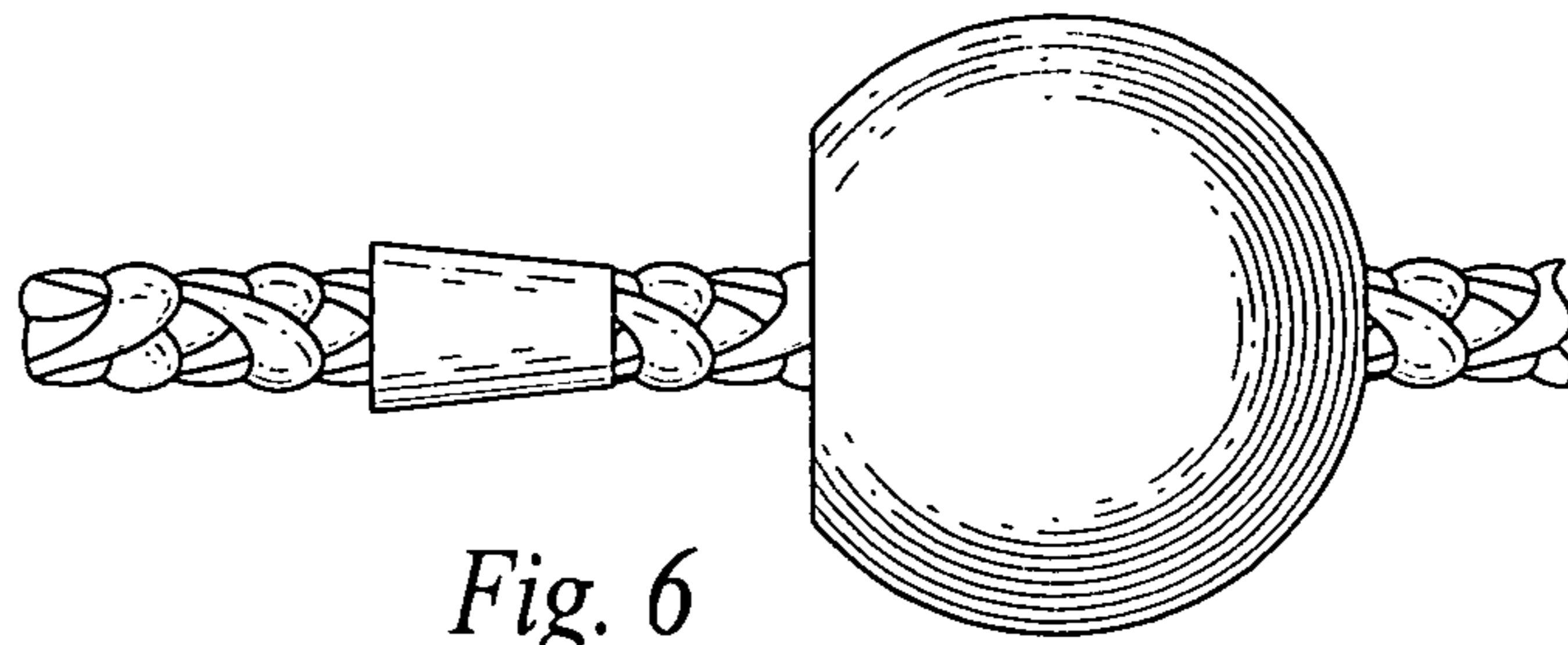

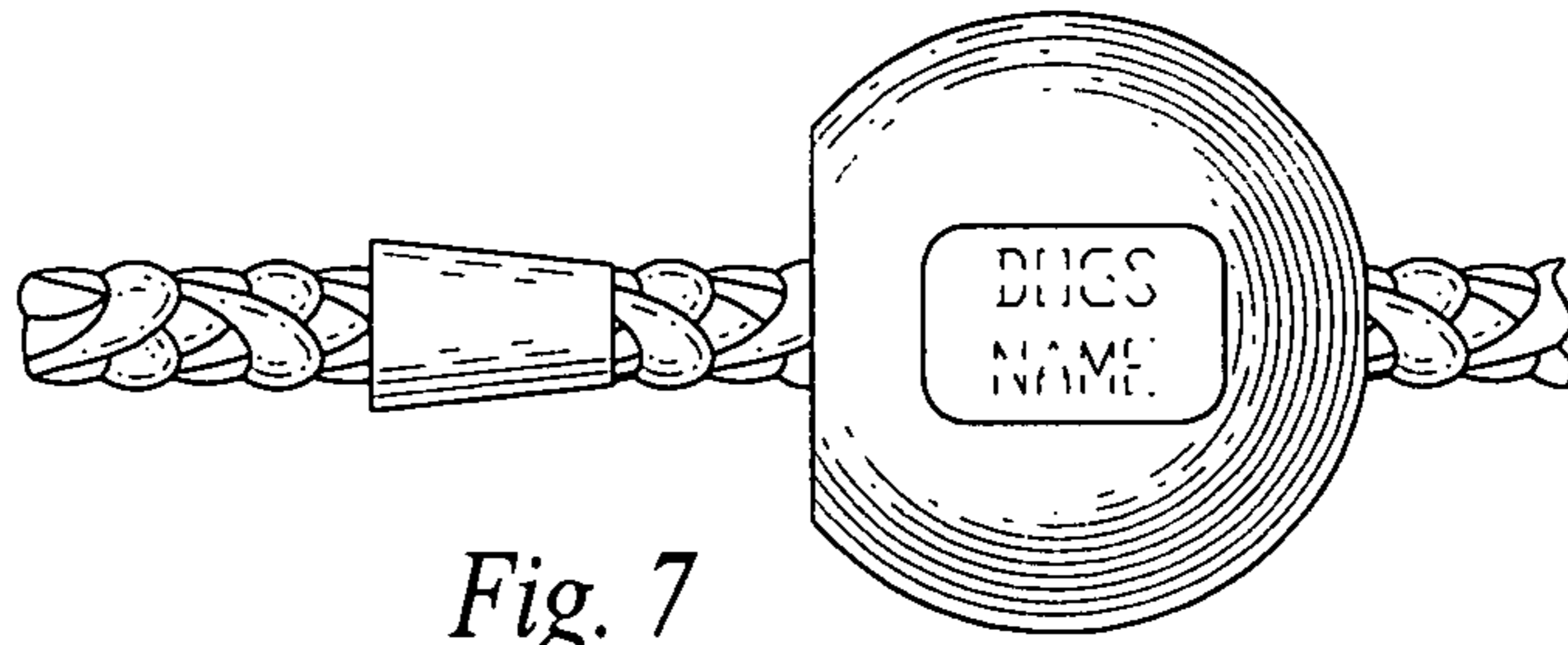

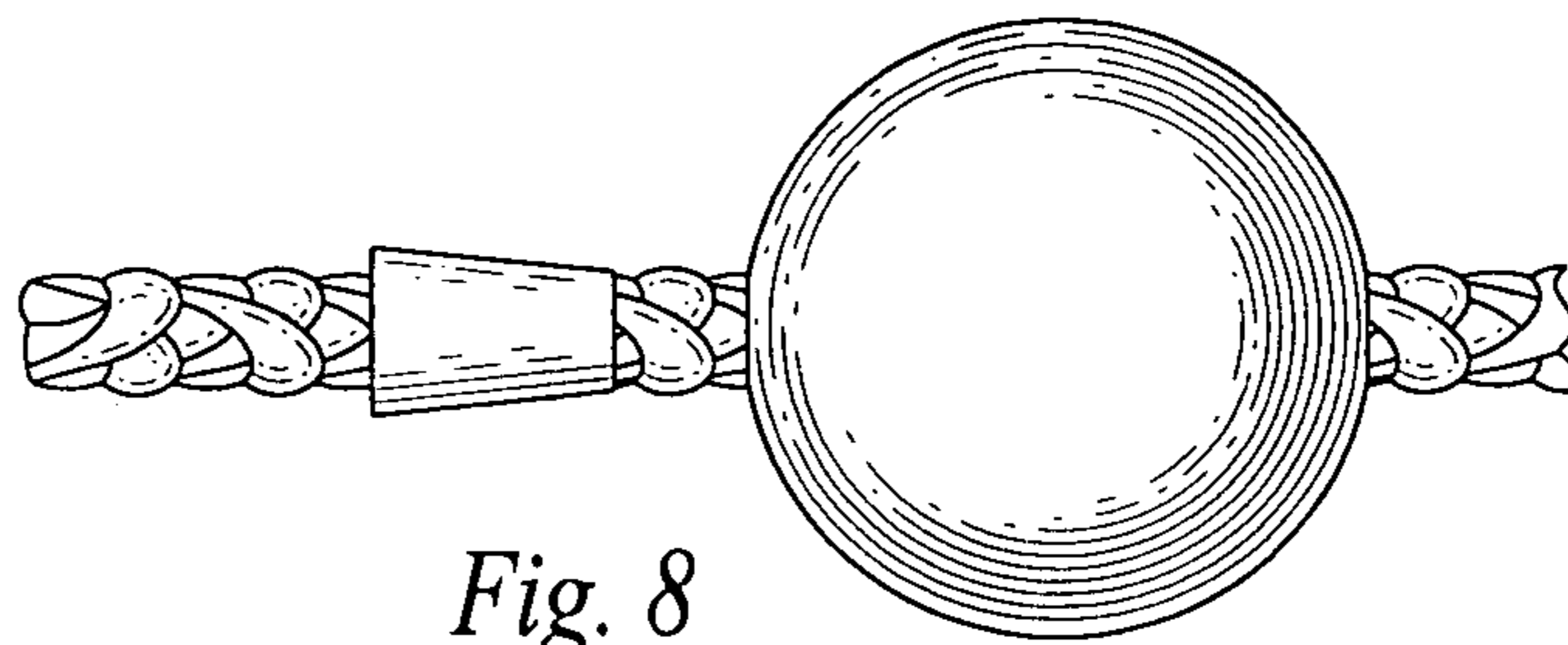

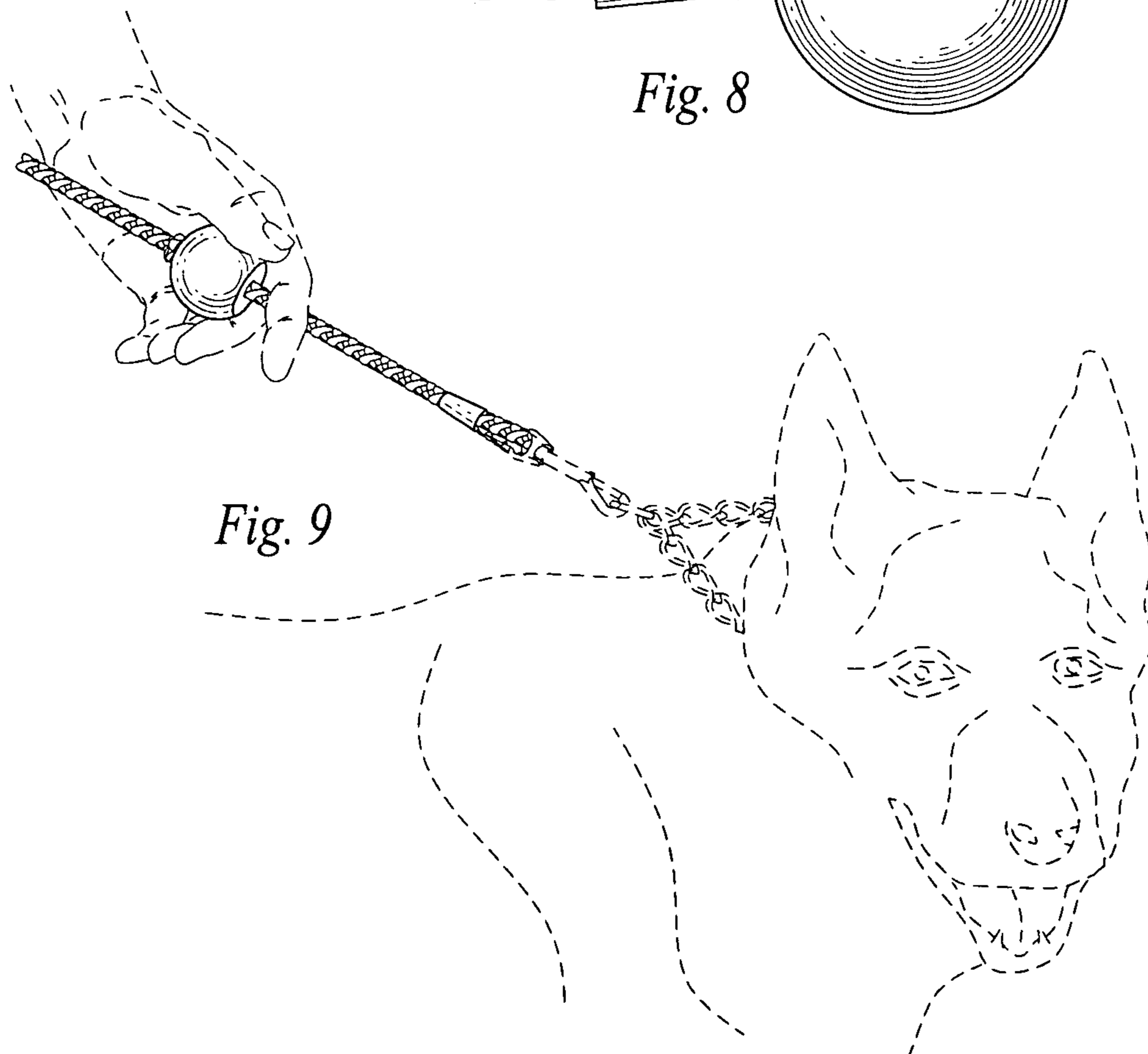
