(57) **CLAIM**

The ornamental design for a cat groom and play mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cat groom and play mat showing my new design;

FIG. 2 is a top plan view of FIG. 1;

FIG. 3 is a bottom plan view of FIG. 1;

FIG. 4 is a left side view of FIG. 1;

FIG. 5 is a right side view of FIG. 1;

FIG. 6 is a front view of FIG. 1;

FIG. 7 is a rear view of FIG. 1;

FIG. 8 is a perspective view of the cat groom and play mat in a folded orientation showing the straps unsnapped from the frame;

FIG. 9 is a top plan view of the cat groom and play mat shown in FIG. 8 showing the straps unsnapped from the frame;

FIG. 10 is a bottom plan view of the cat groom and play mat shown in FIG. 8 showing the straps unsnapped from the frame;

FIG. 11 is a left side view of the cat groom and play mat shown in FIG. 8 showing the straps unsnapped from the frame;

FIG. 12 is a right side view of the cat groom and play mat shown in FIG. 8 showing the straps unsnapped from the frame;

FIG. 13 is a front view of the cat groom and play mat shown in FIG. 8 showing the straps unsnapped from the frame; and,

FIG. 14 is a rear view of the cat groom and play mat shown in FIG. 8 showing the straps unsnapped from the frame.

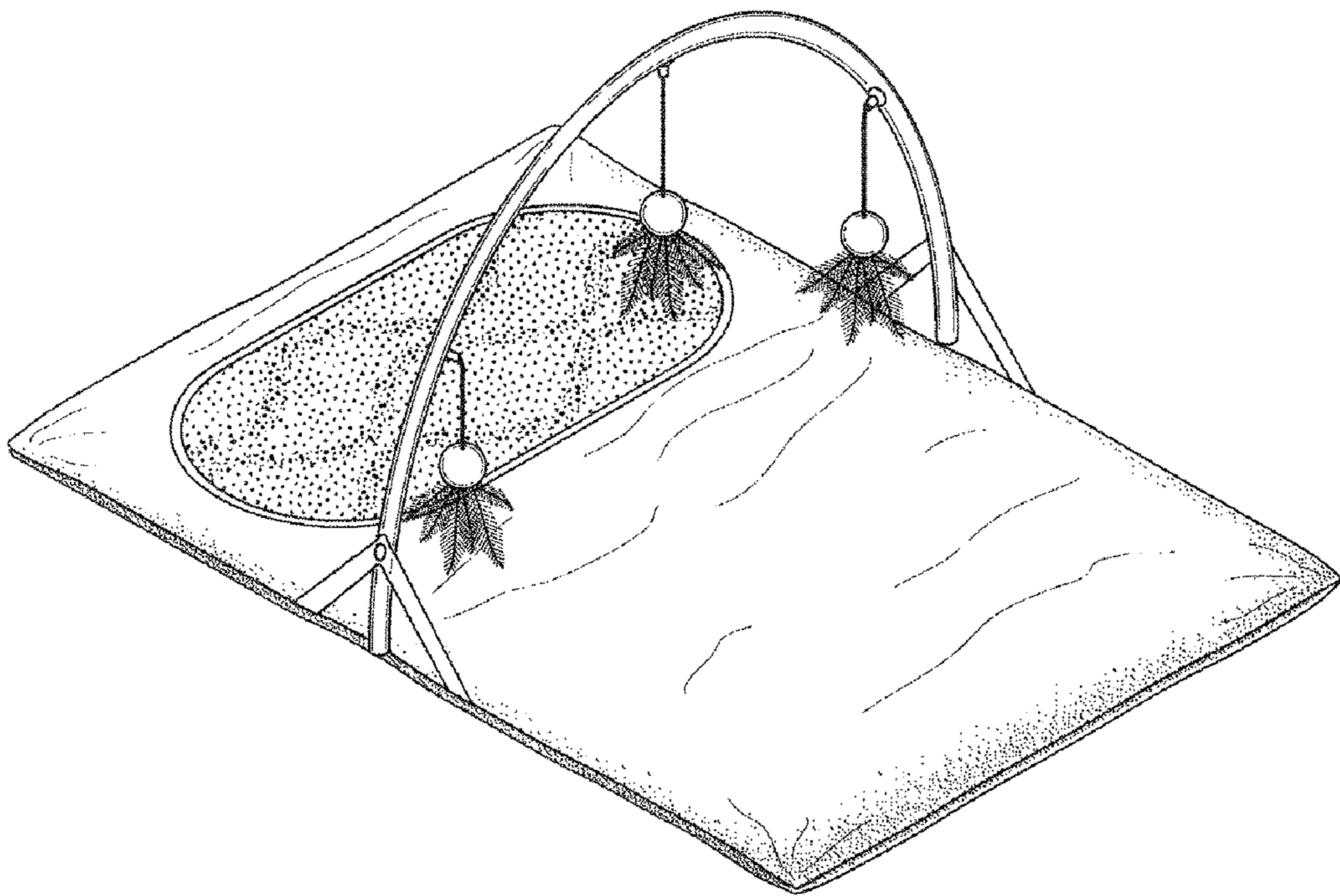

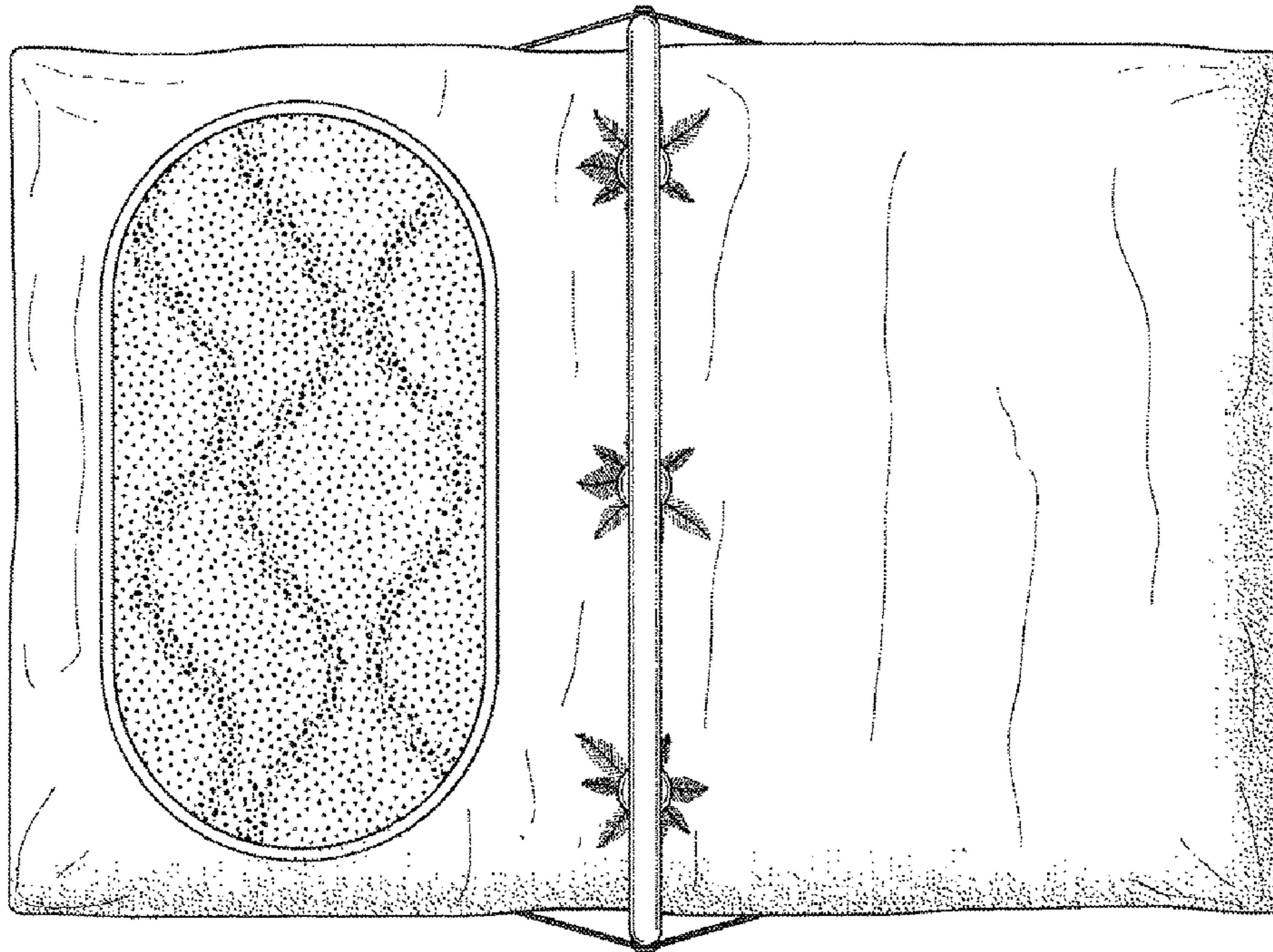

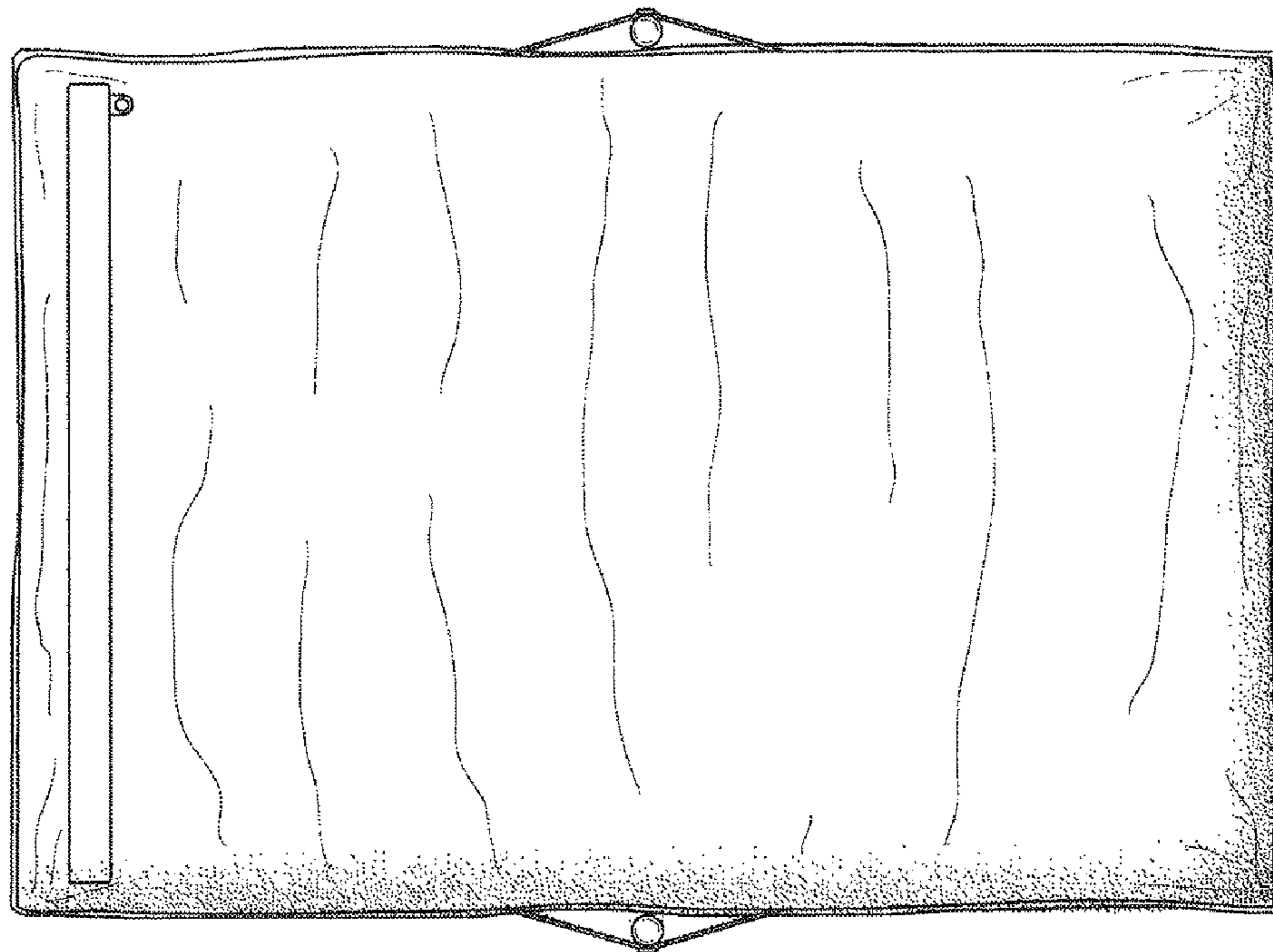

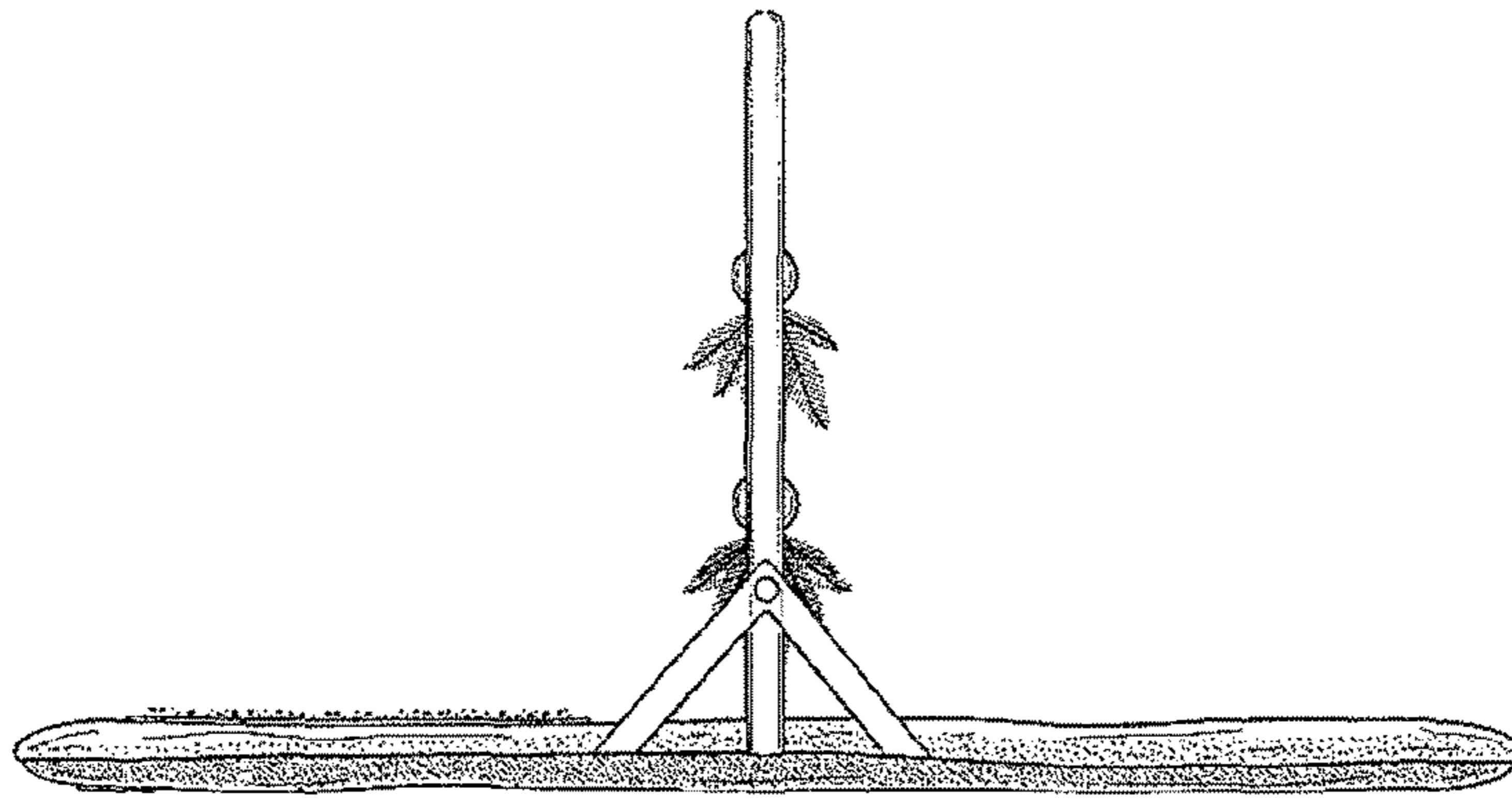

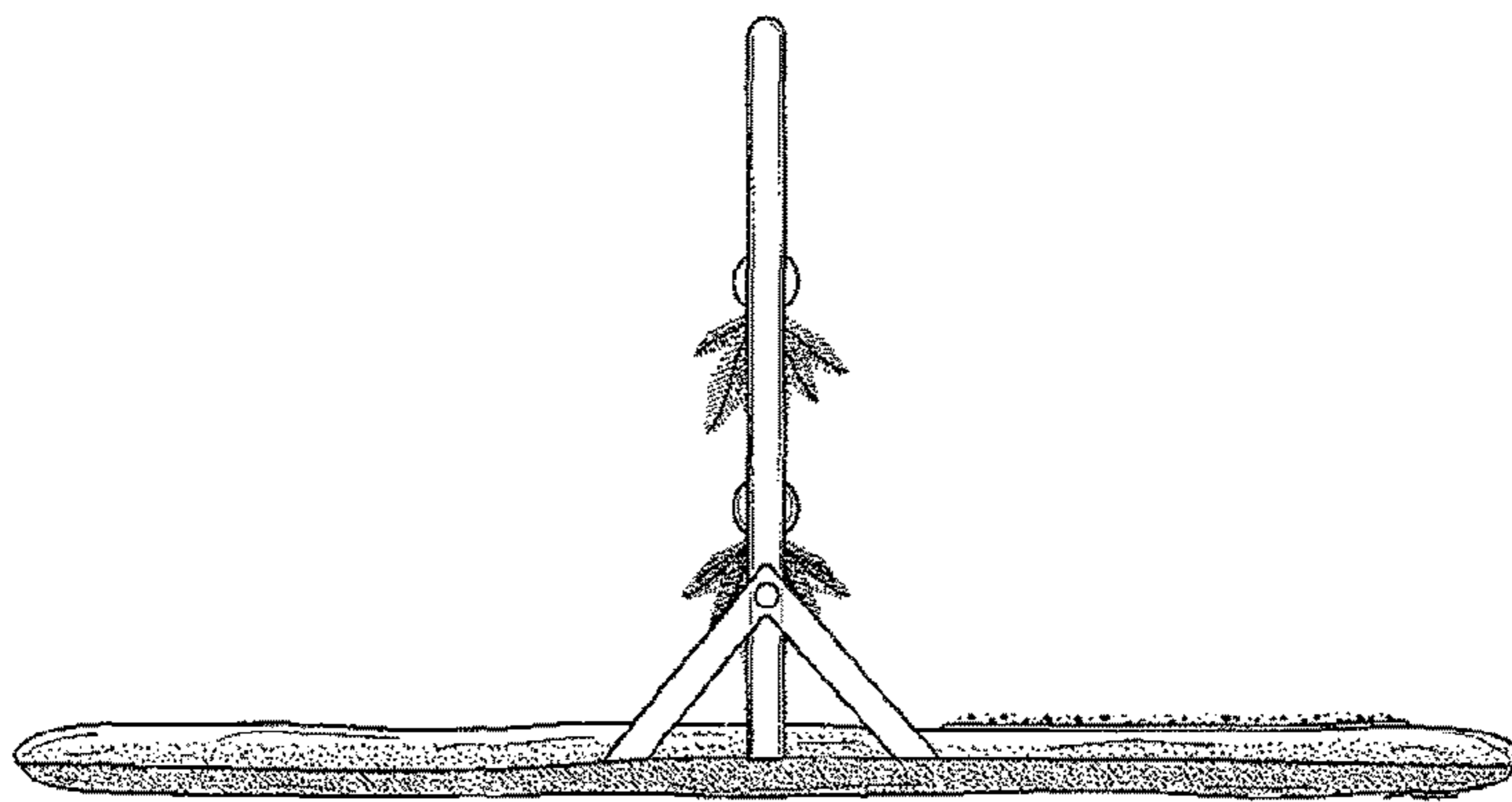

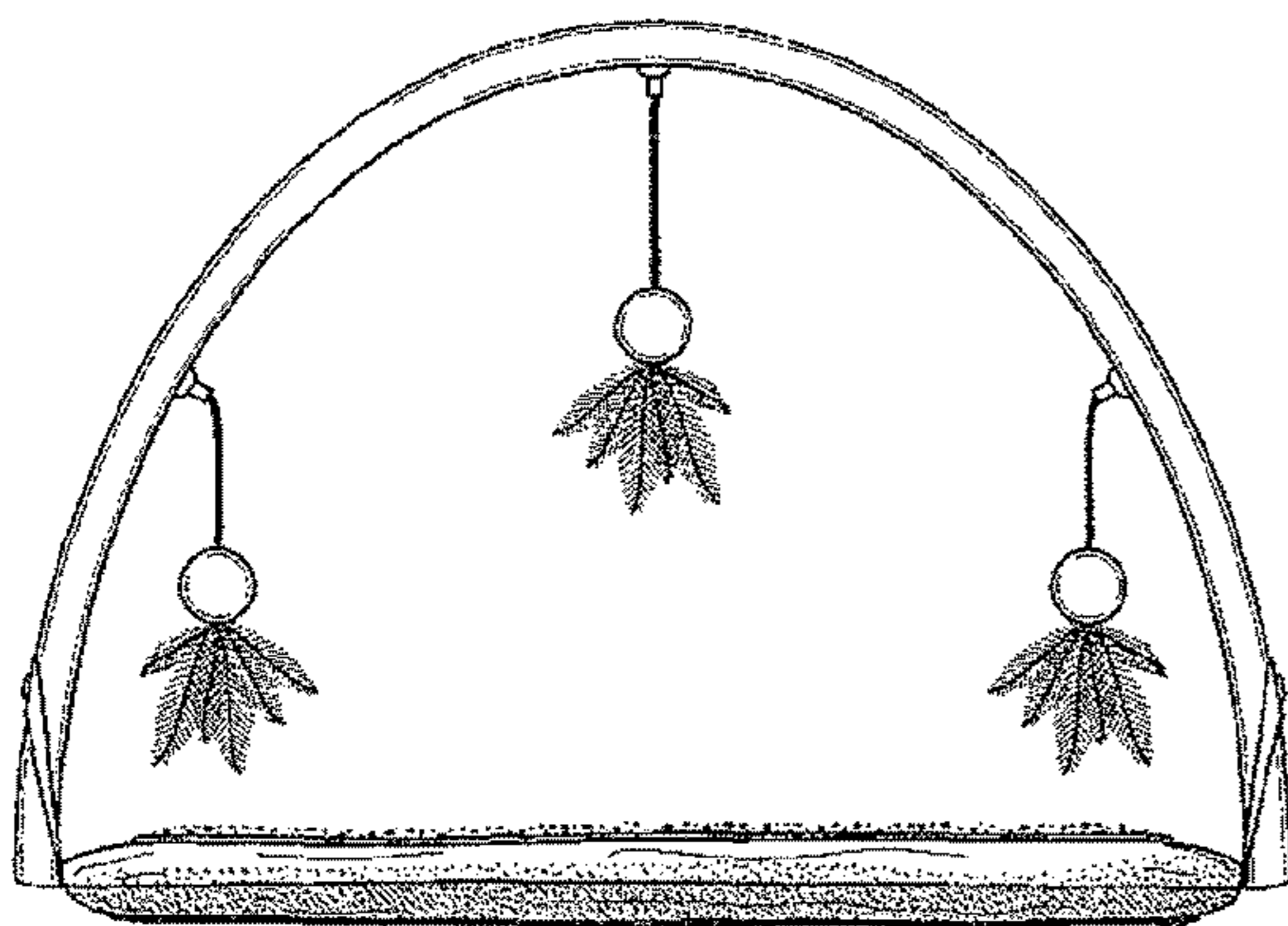

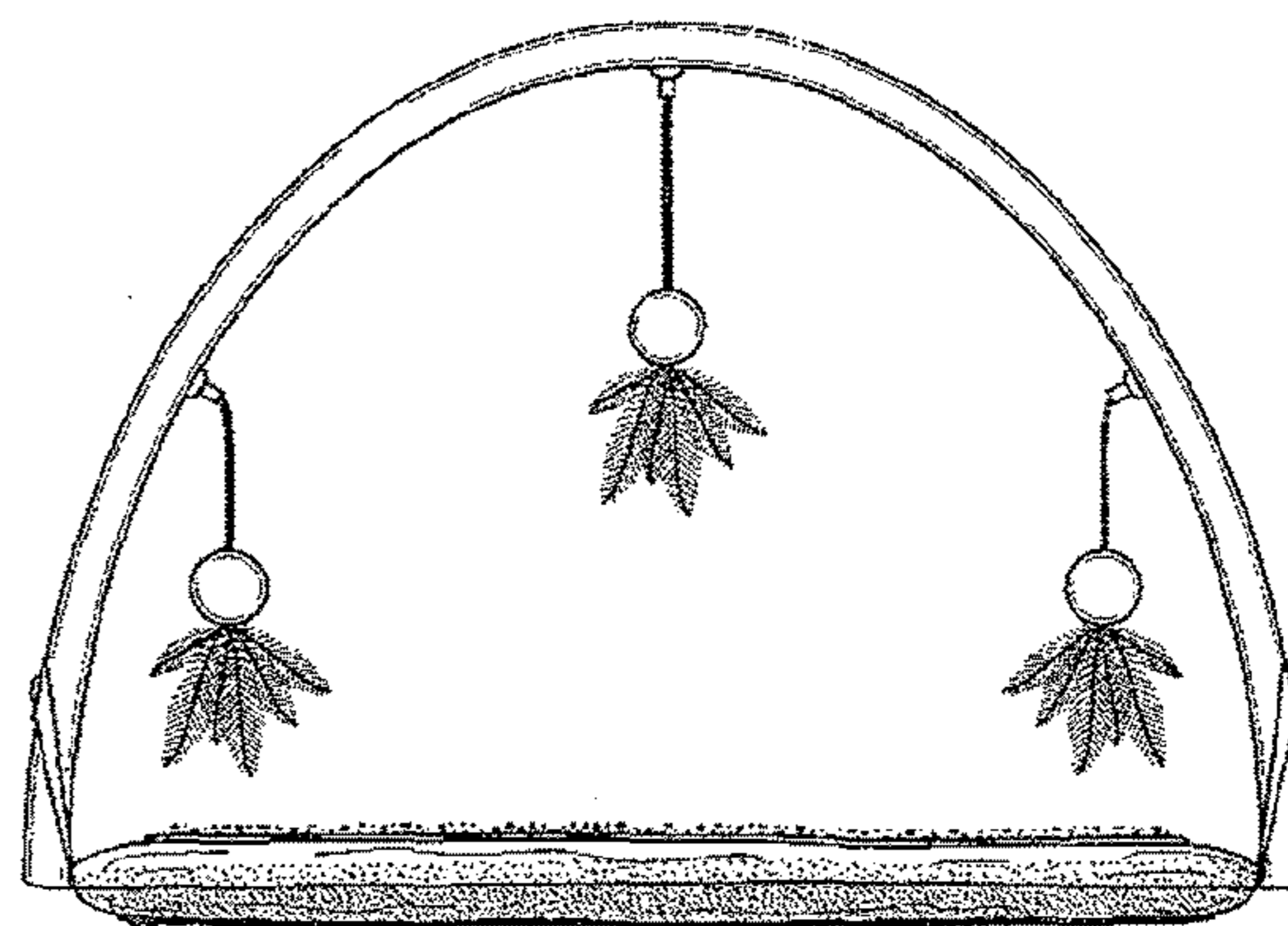

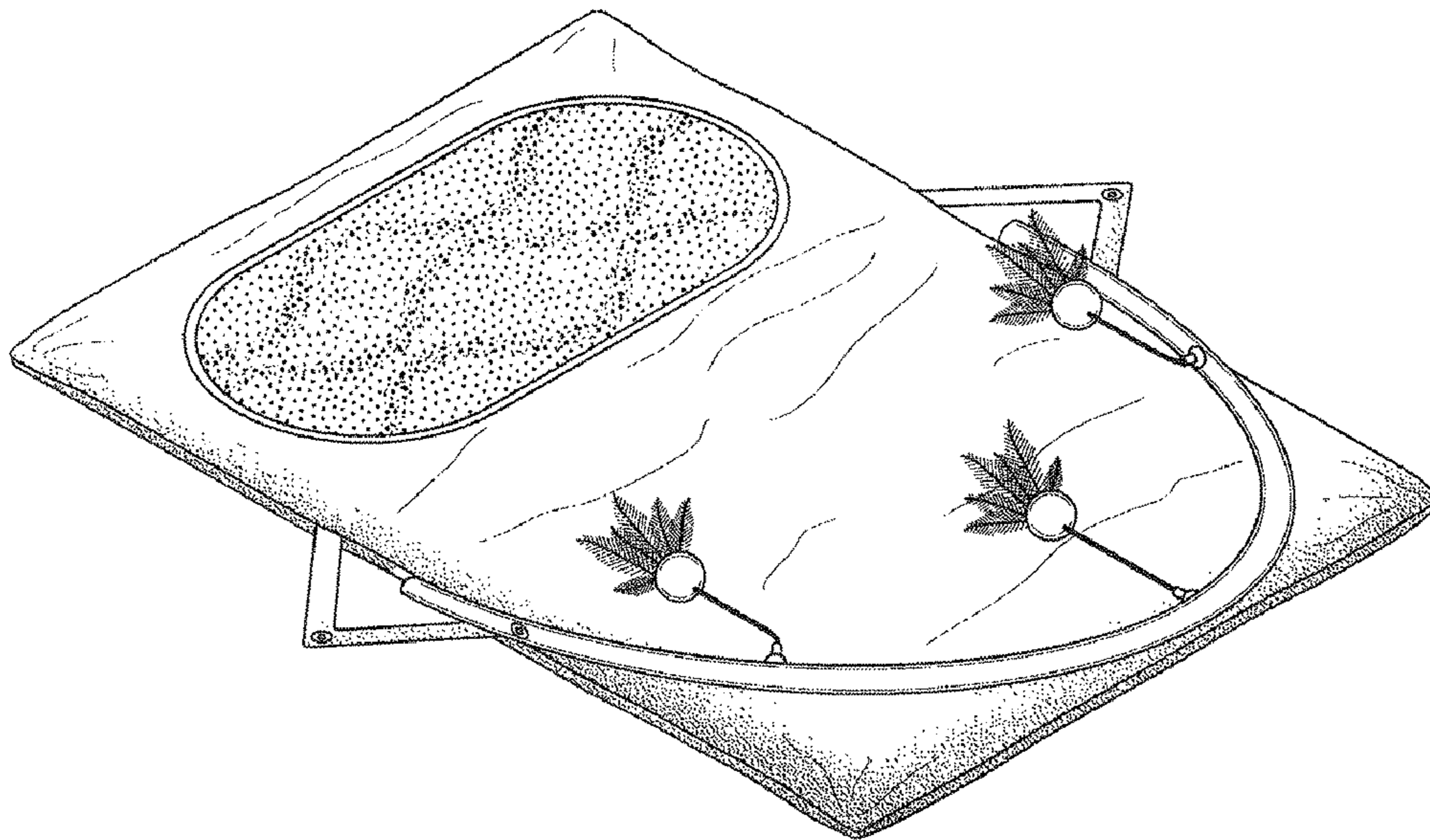

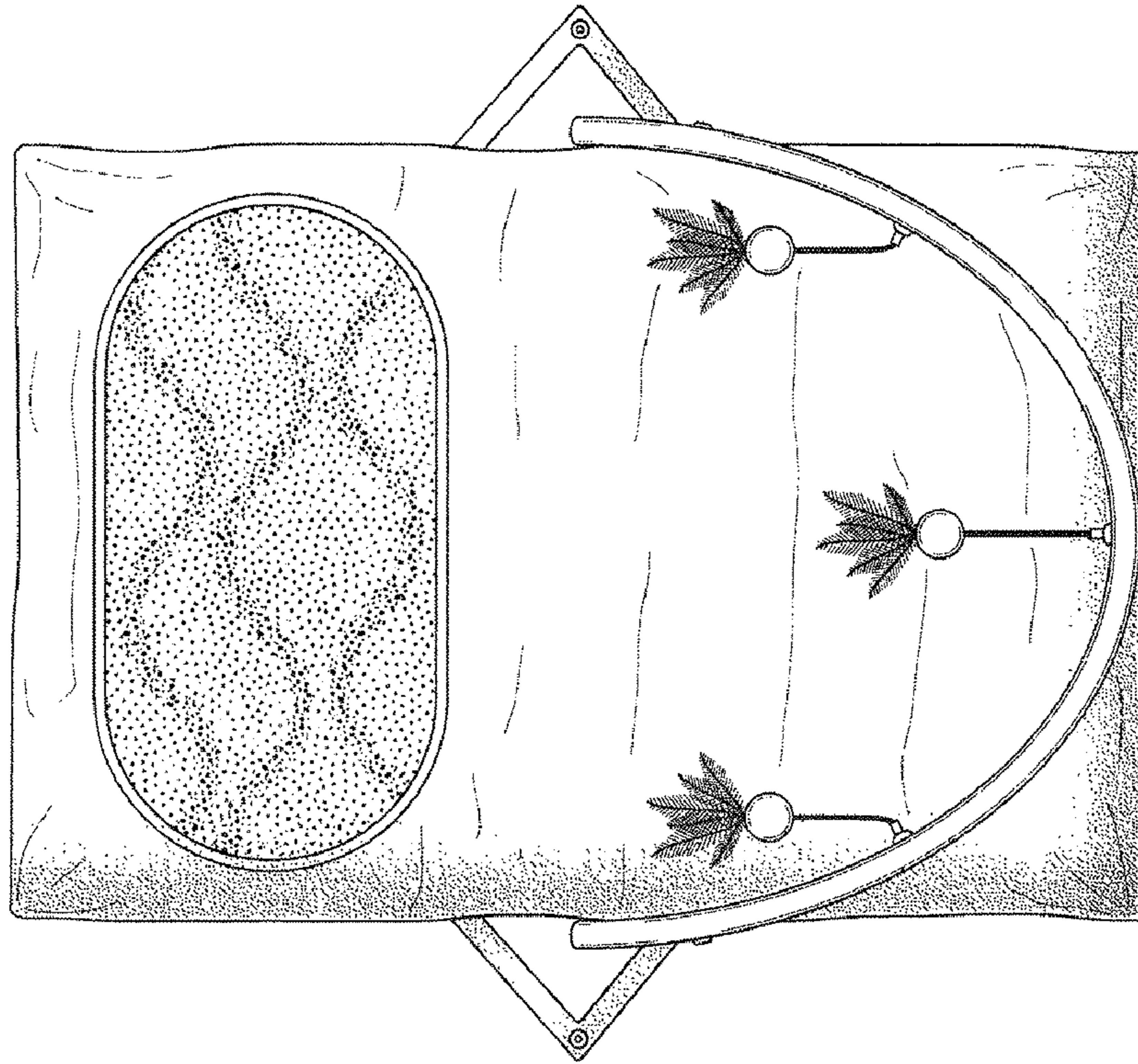

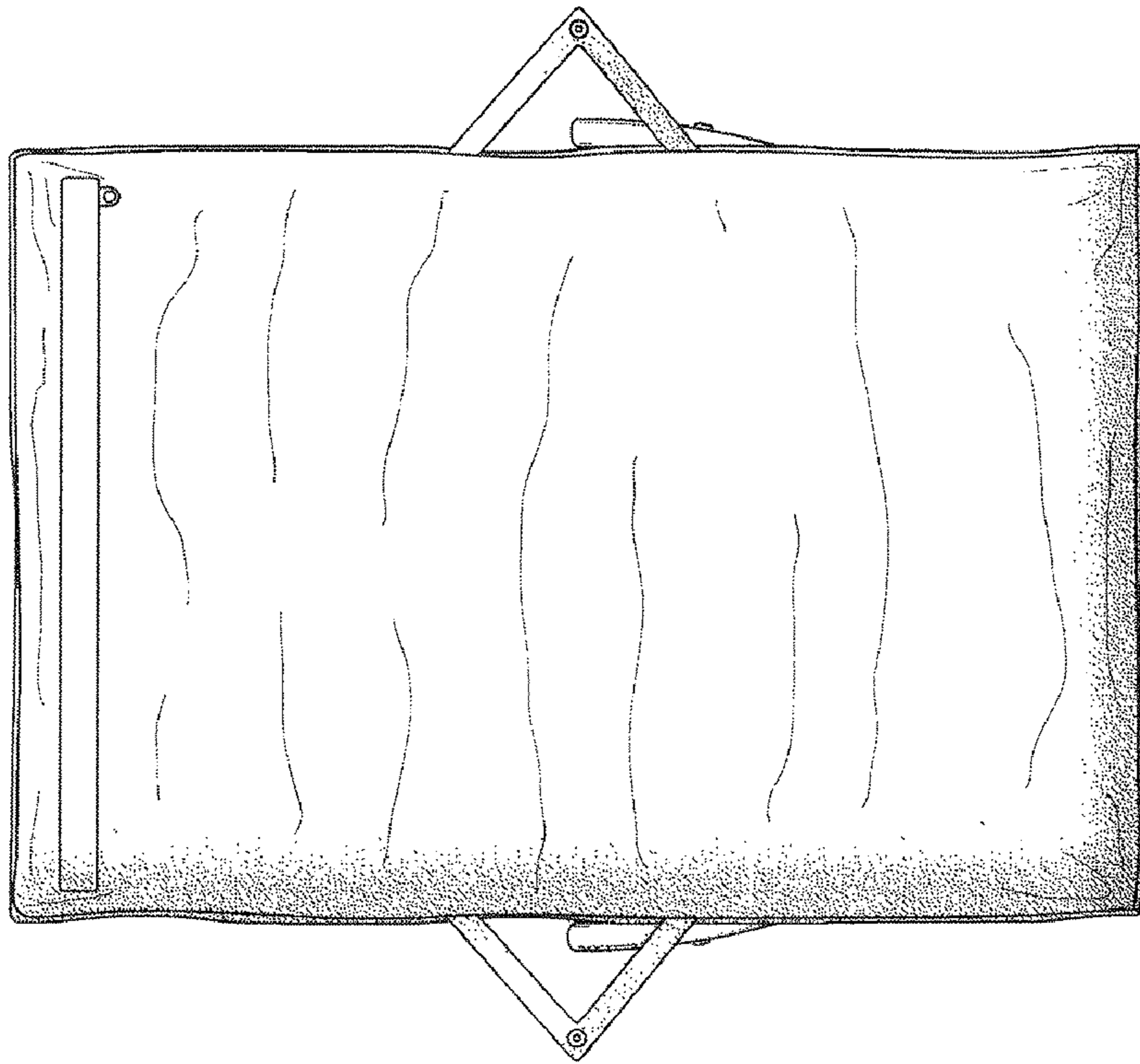

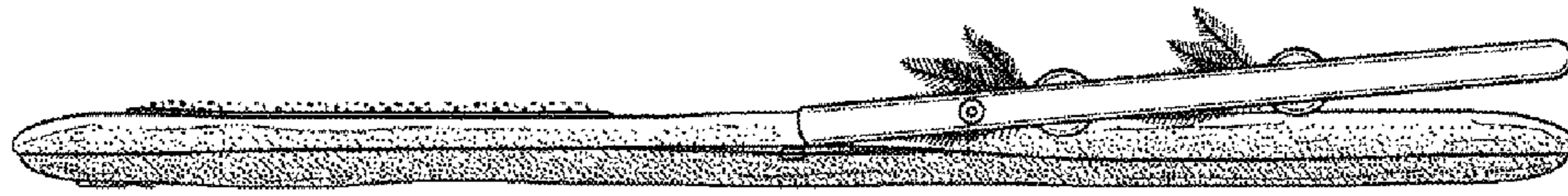

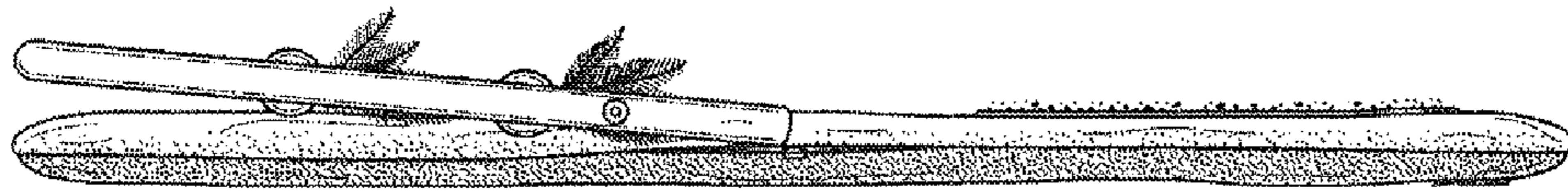

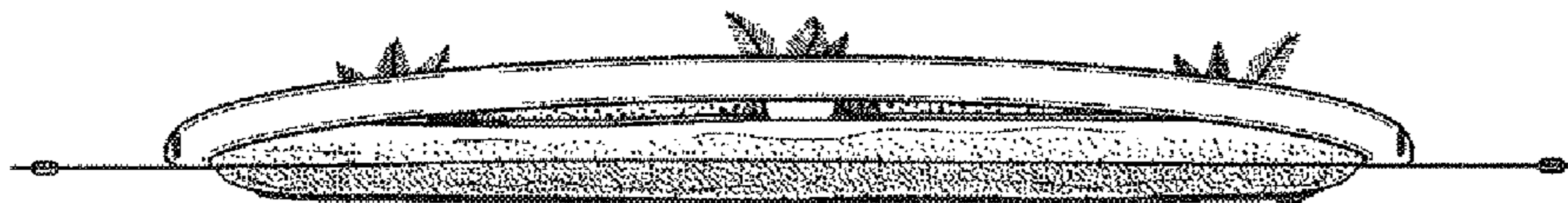

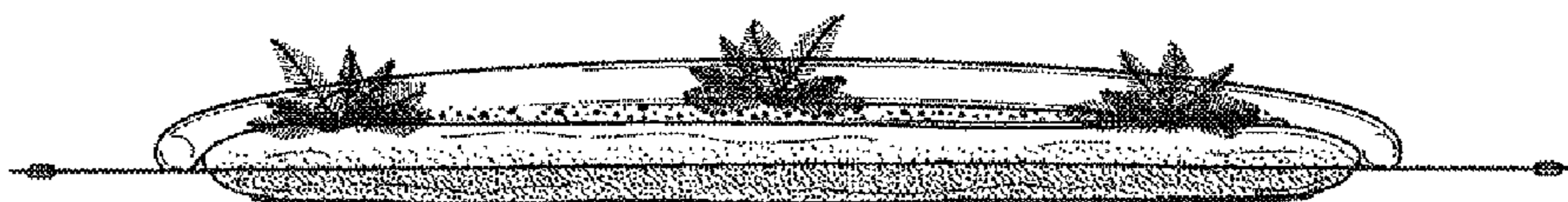
