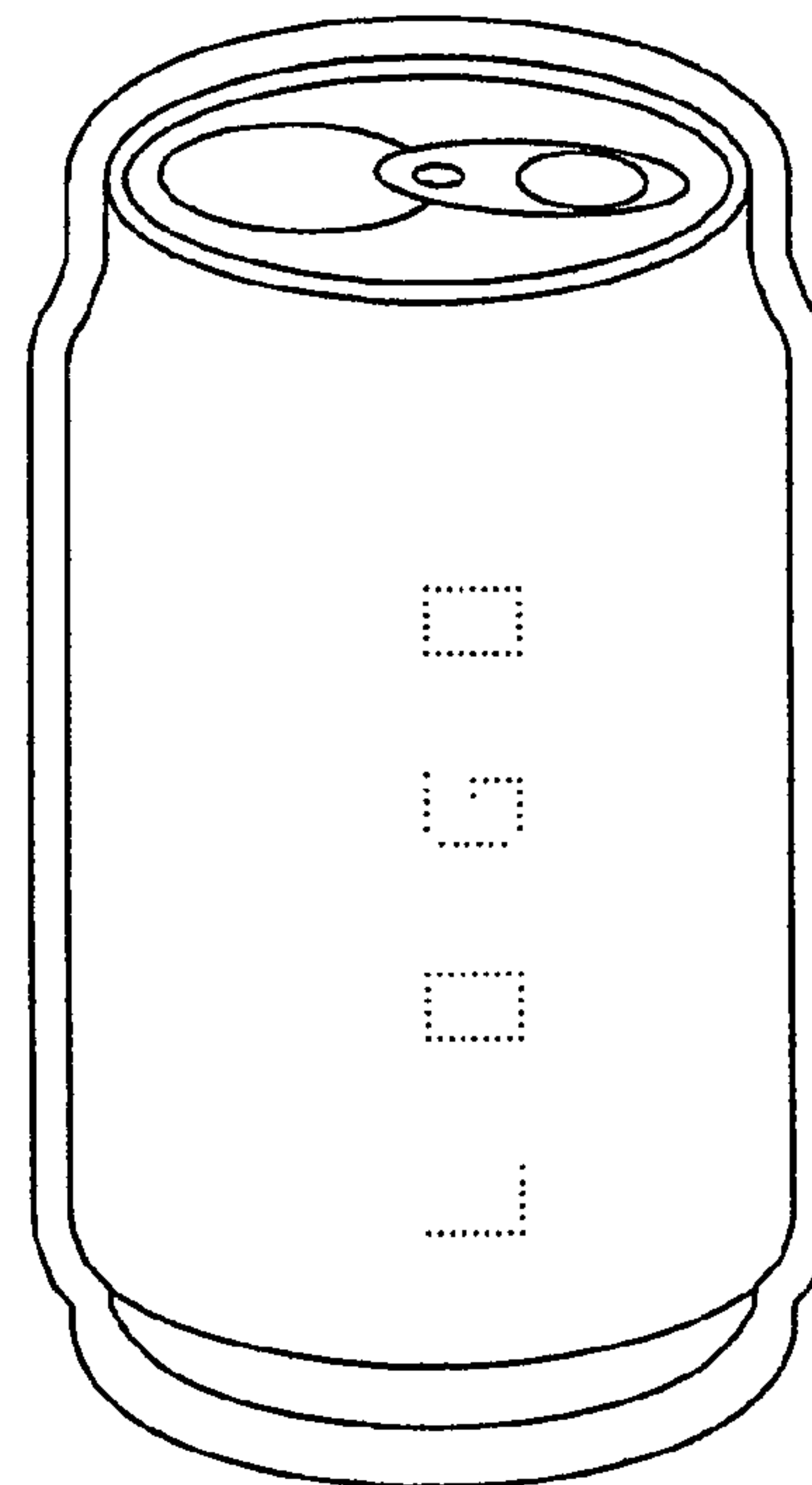
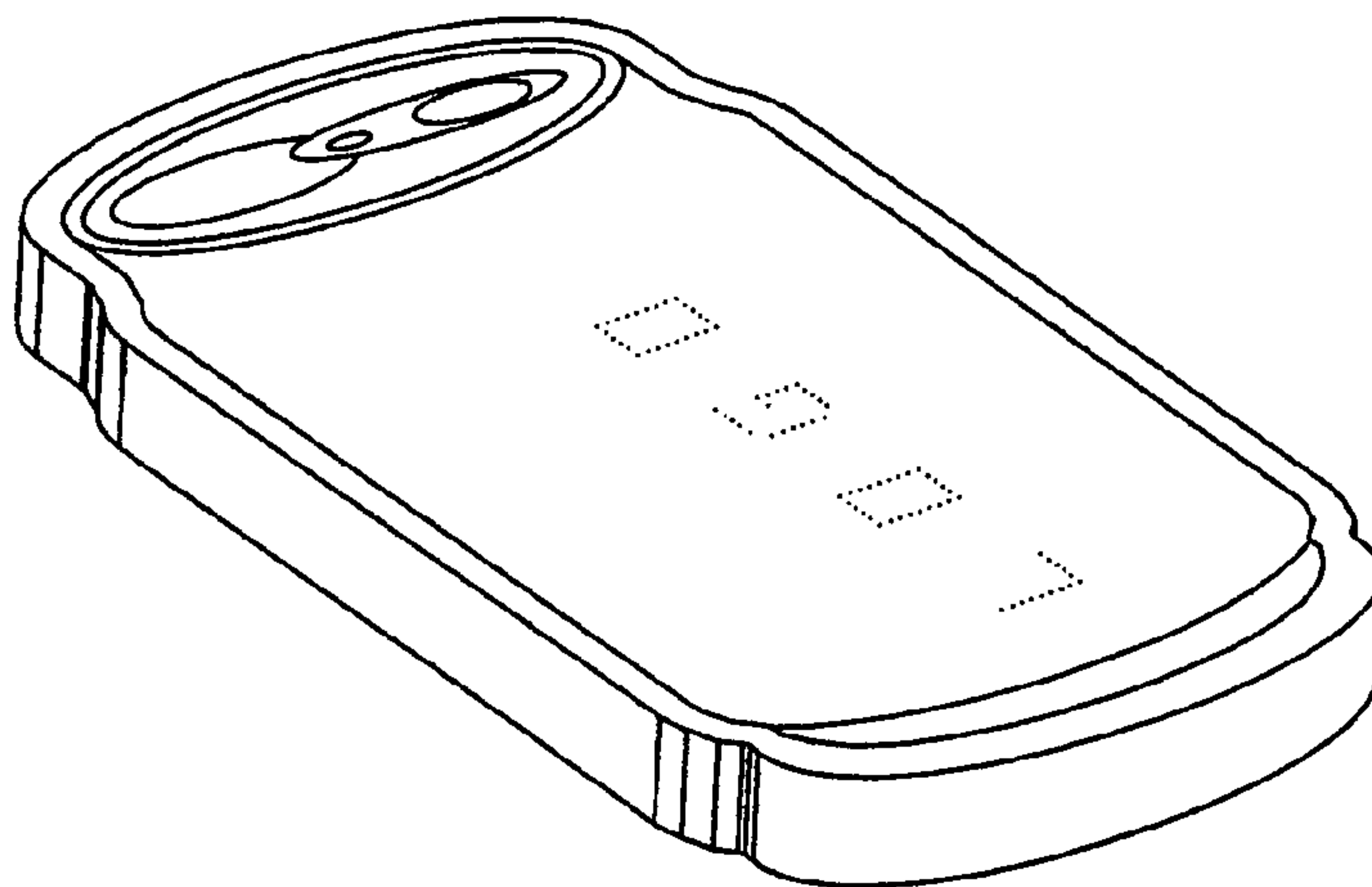
The ornamental design for a foot rest, as shown and described.

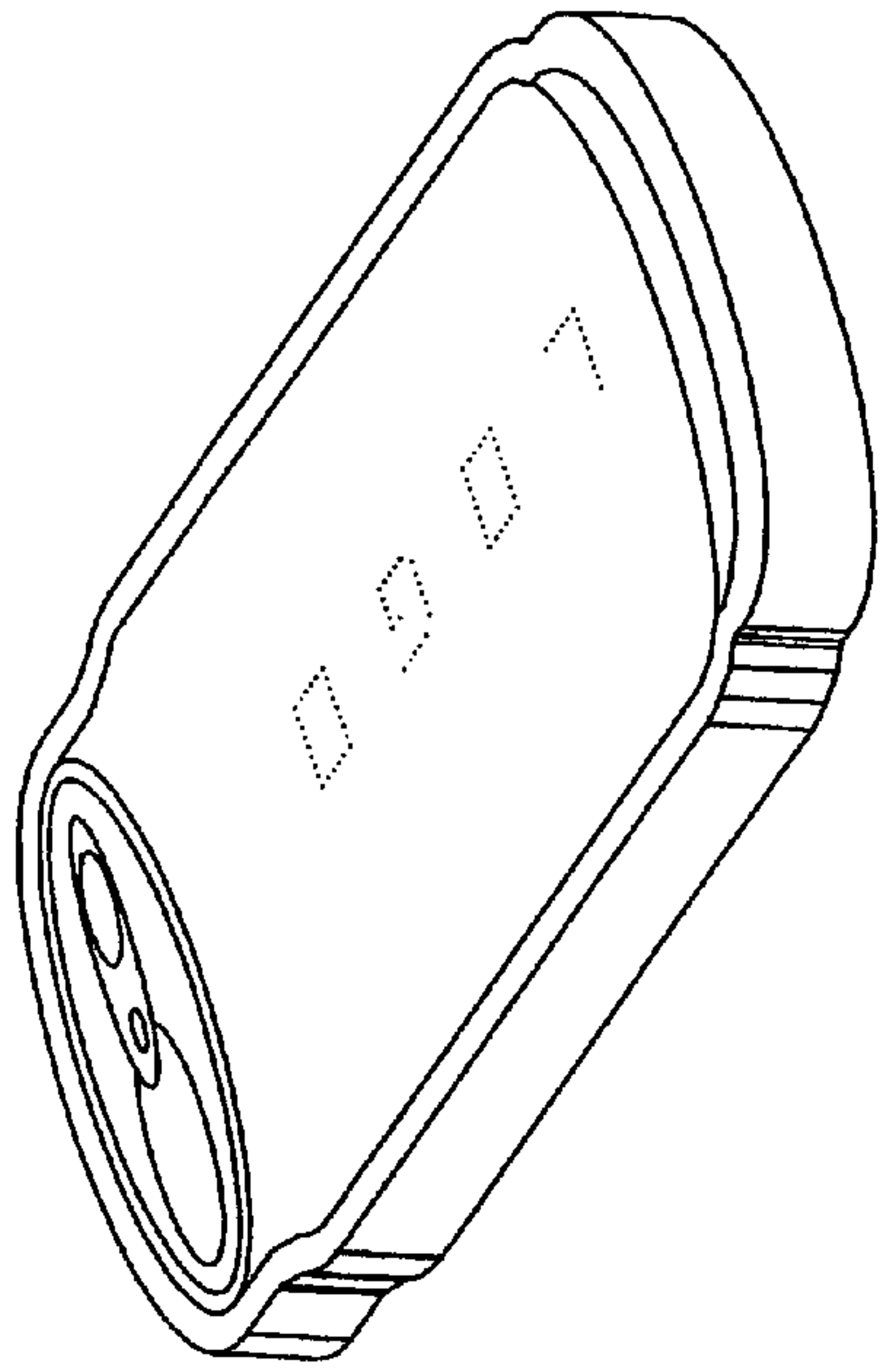

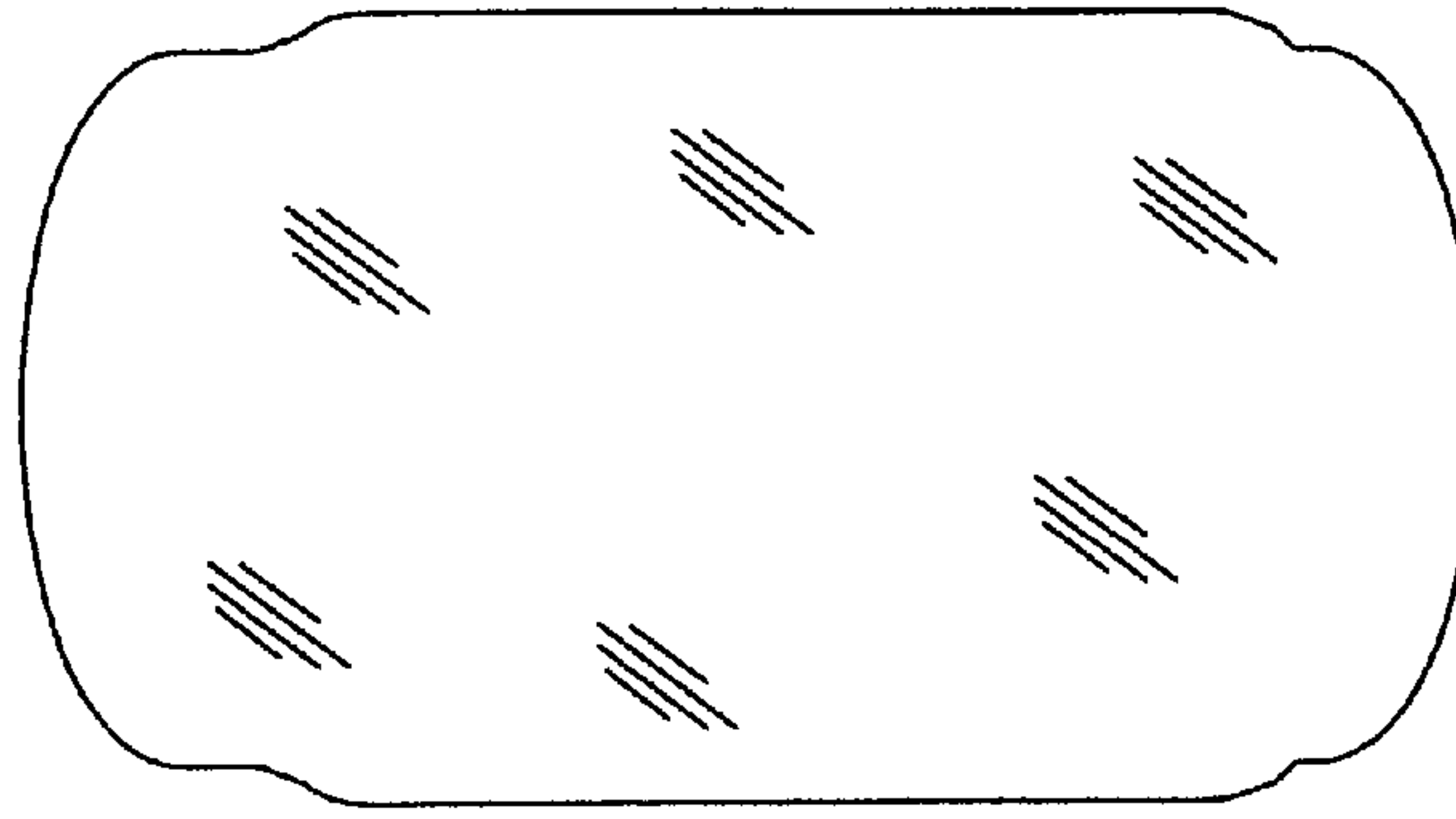

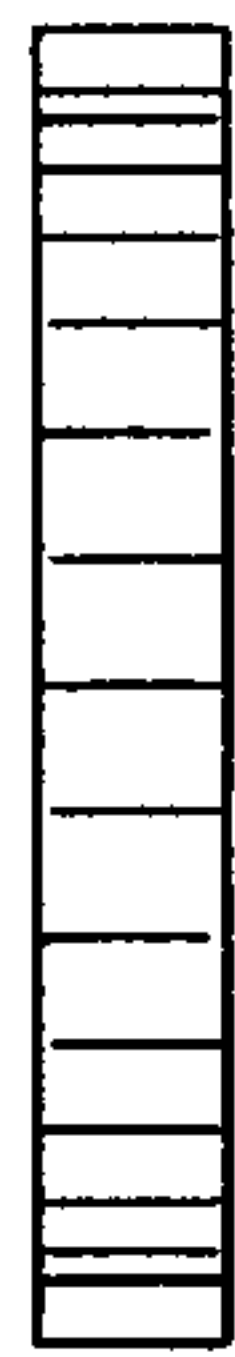

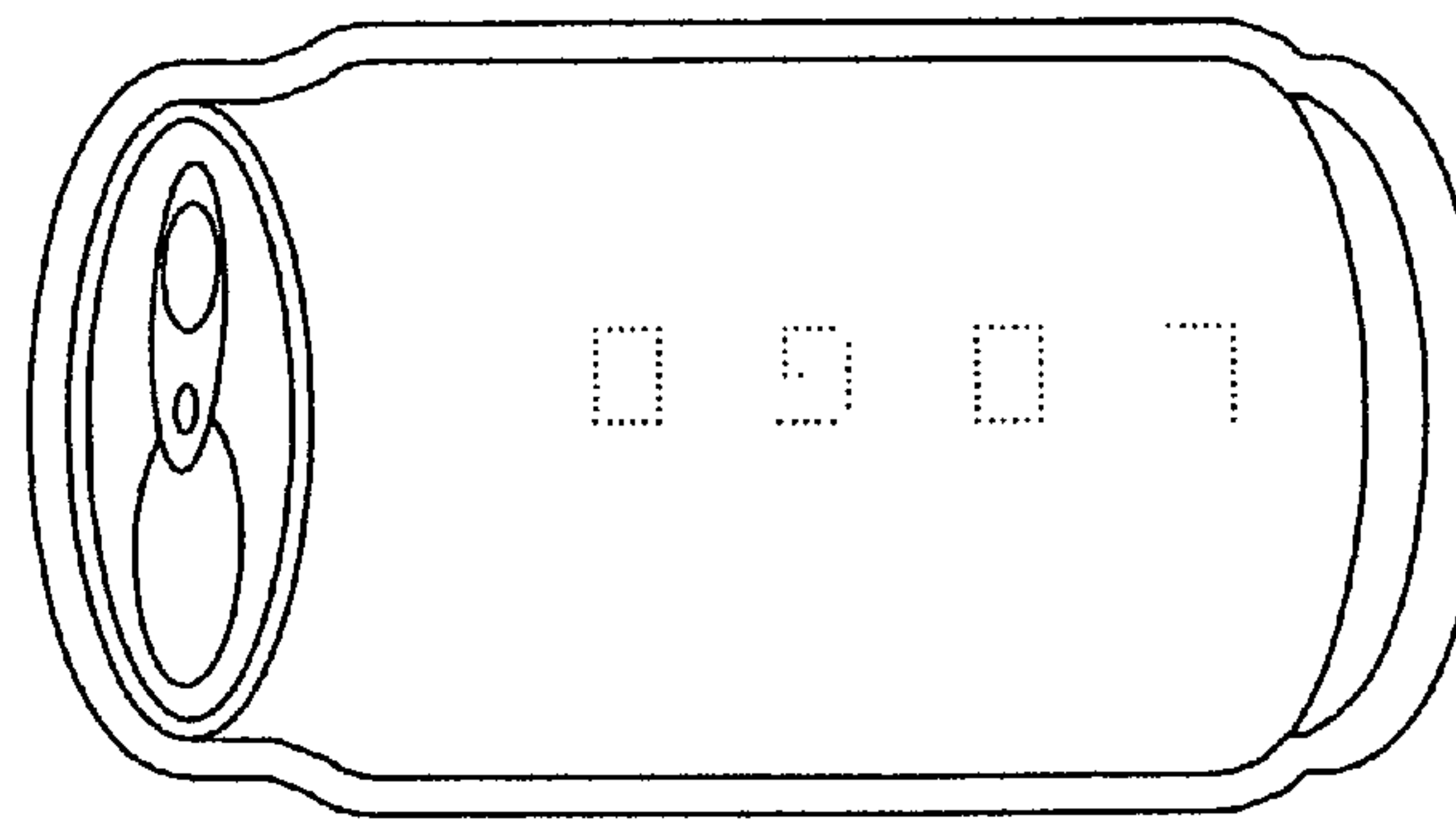
