DESCRIPTION

FIG. 18 is a left side elevational view thereof.

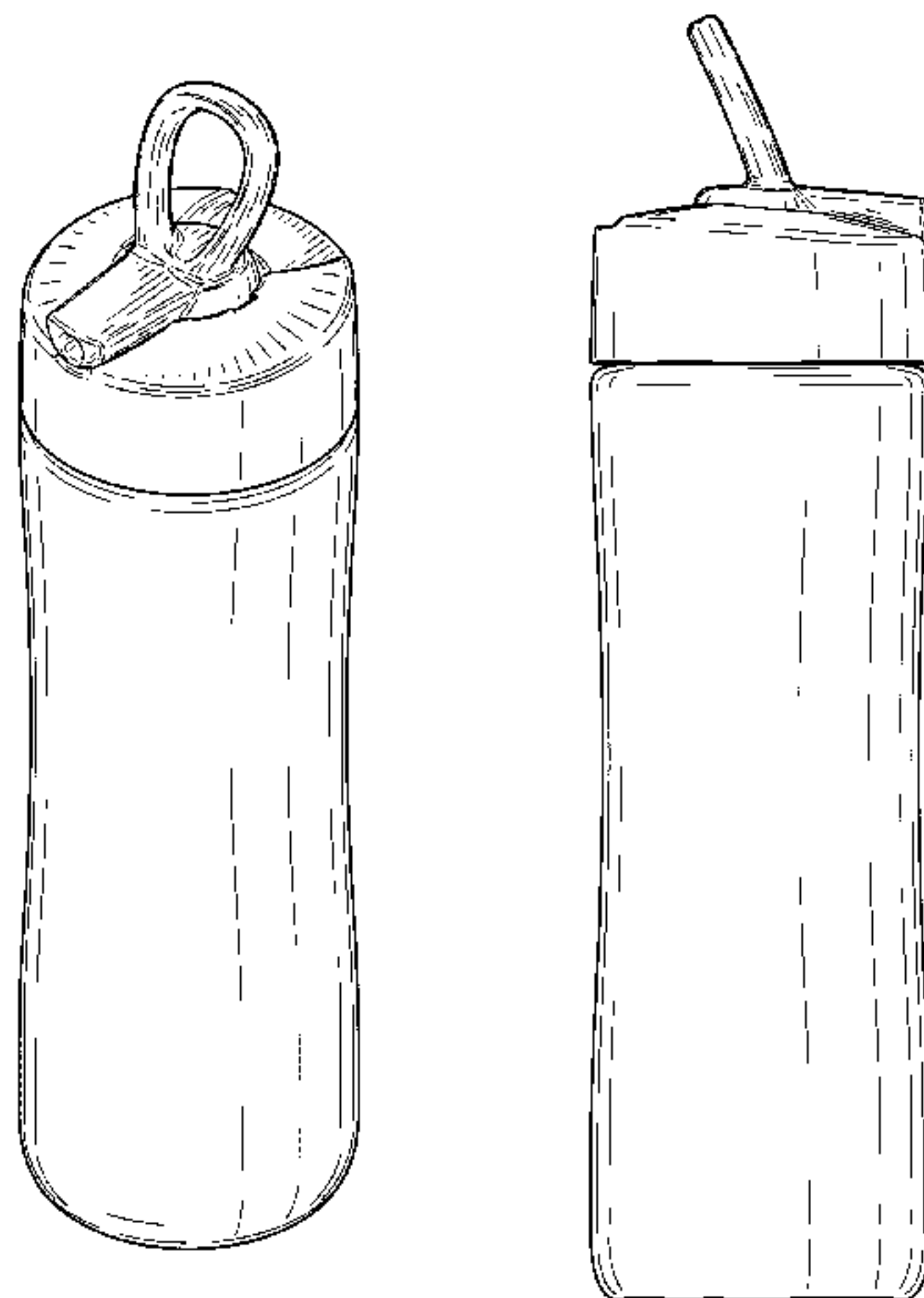
FIG. 19 is a rear elevational view thereof.

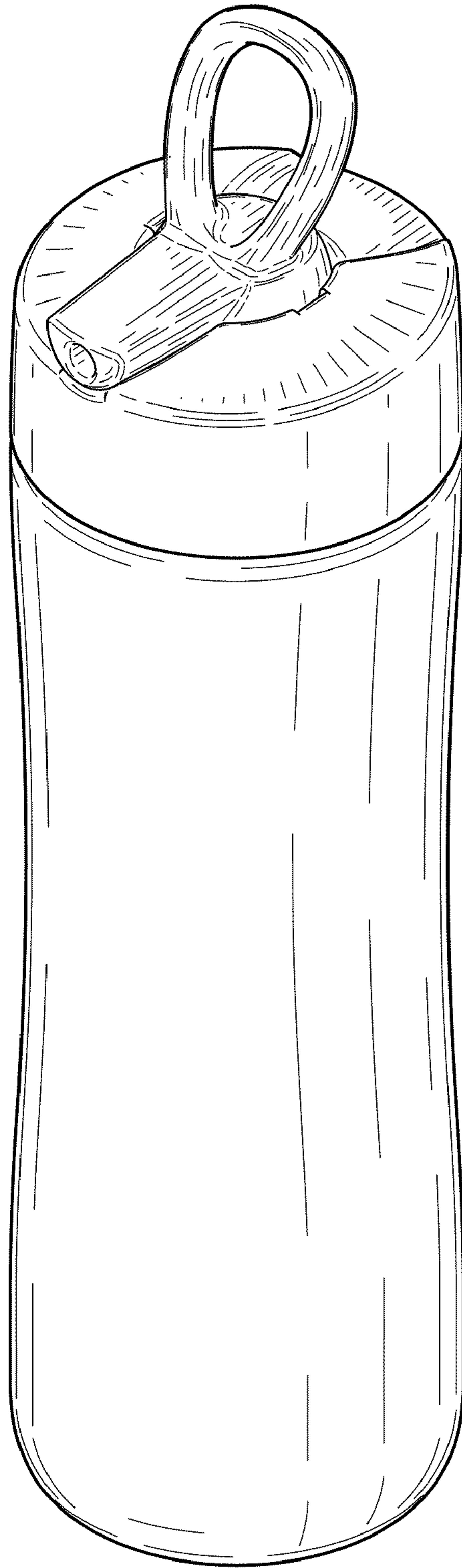

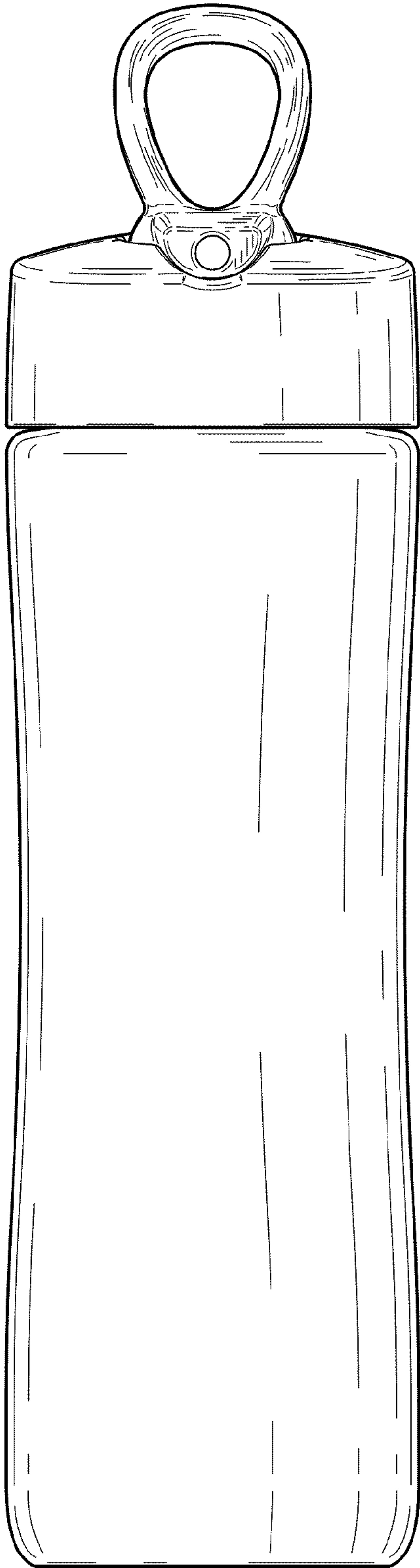

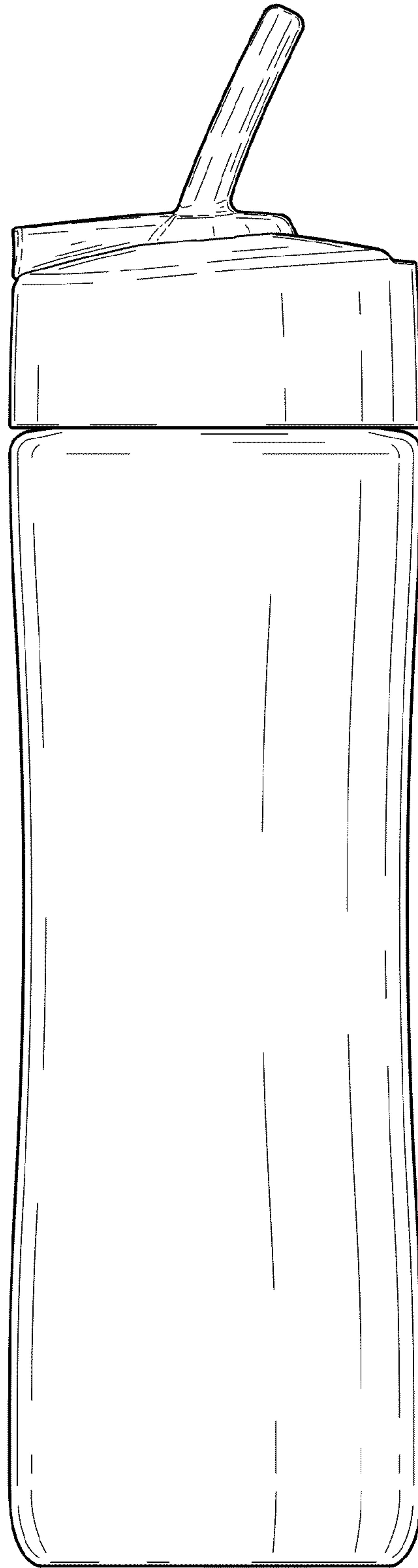

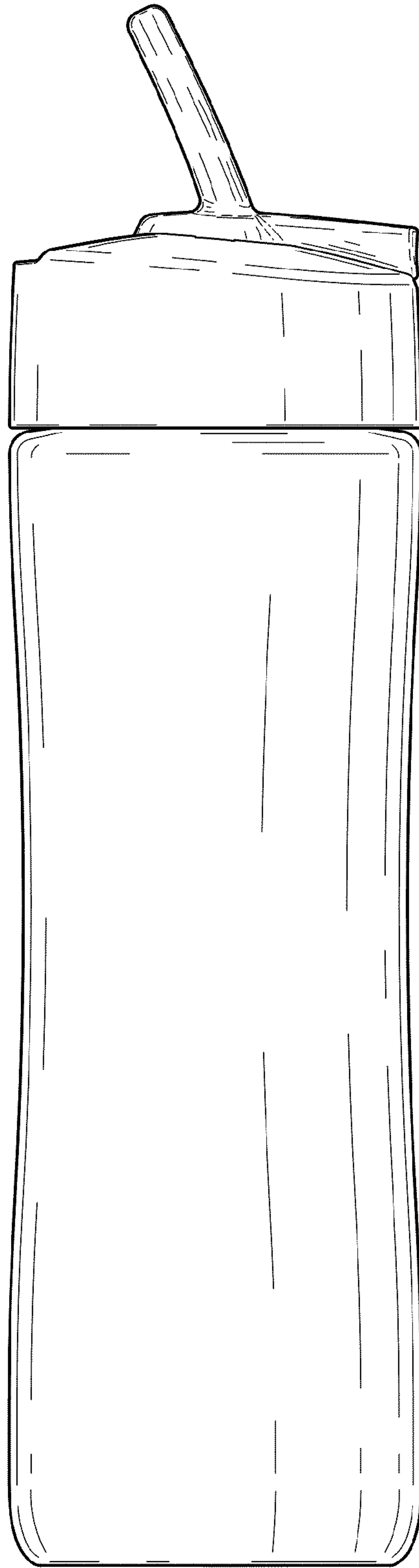

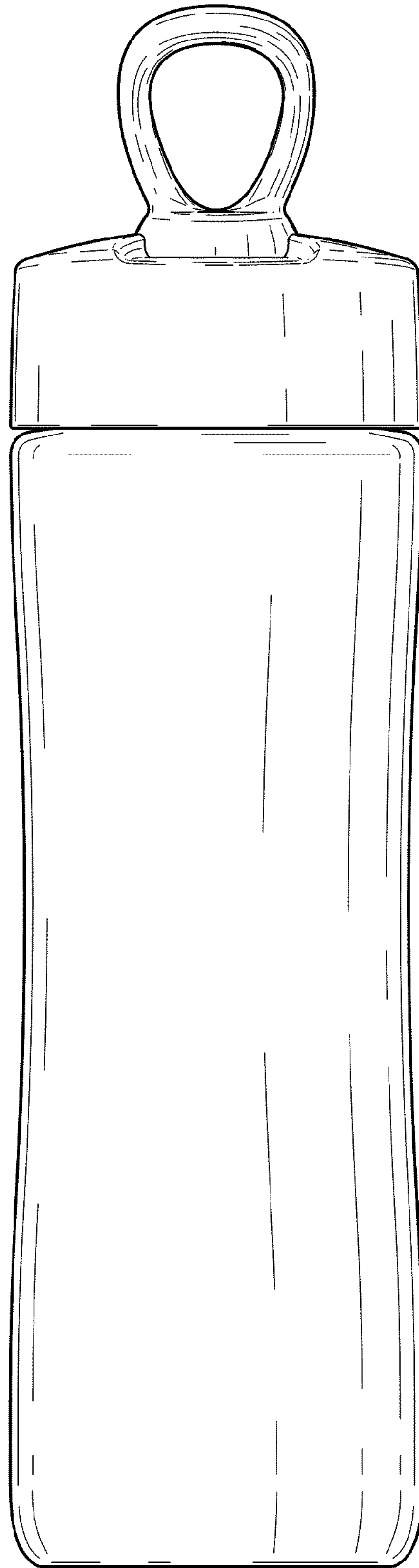

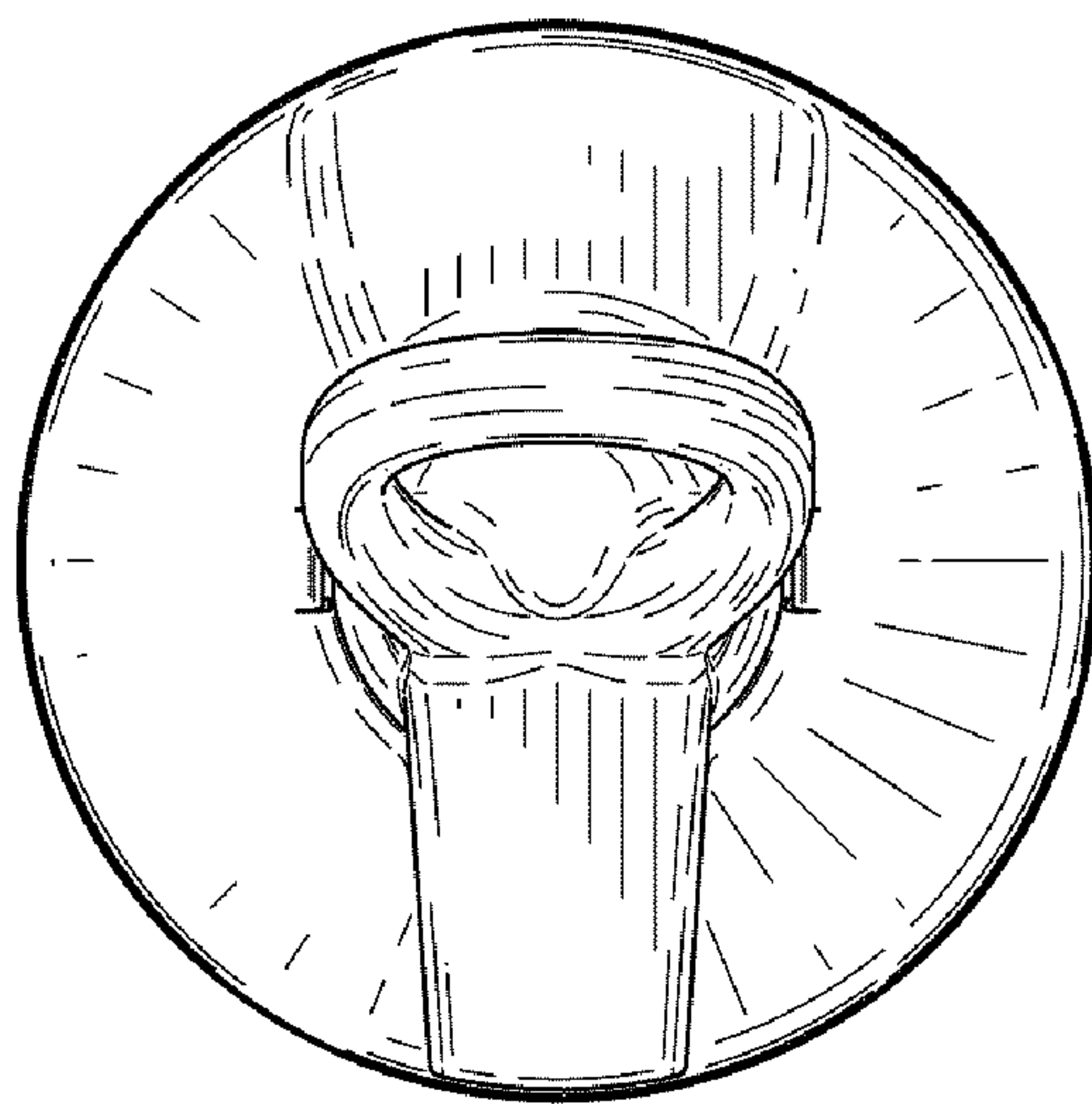

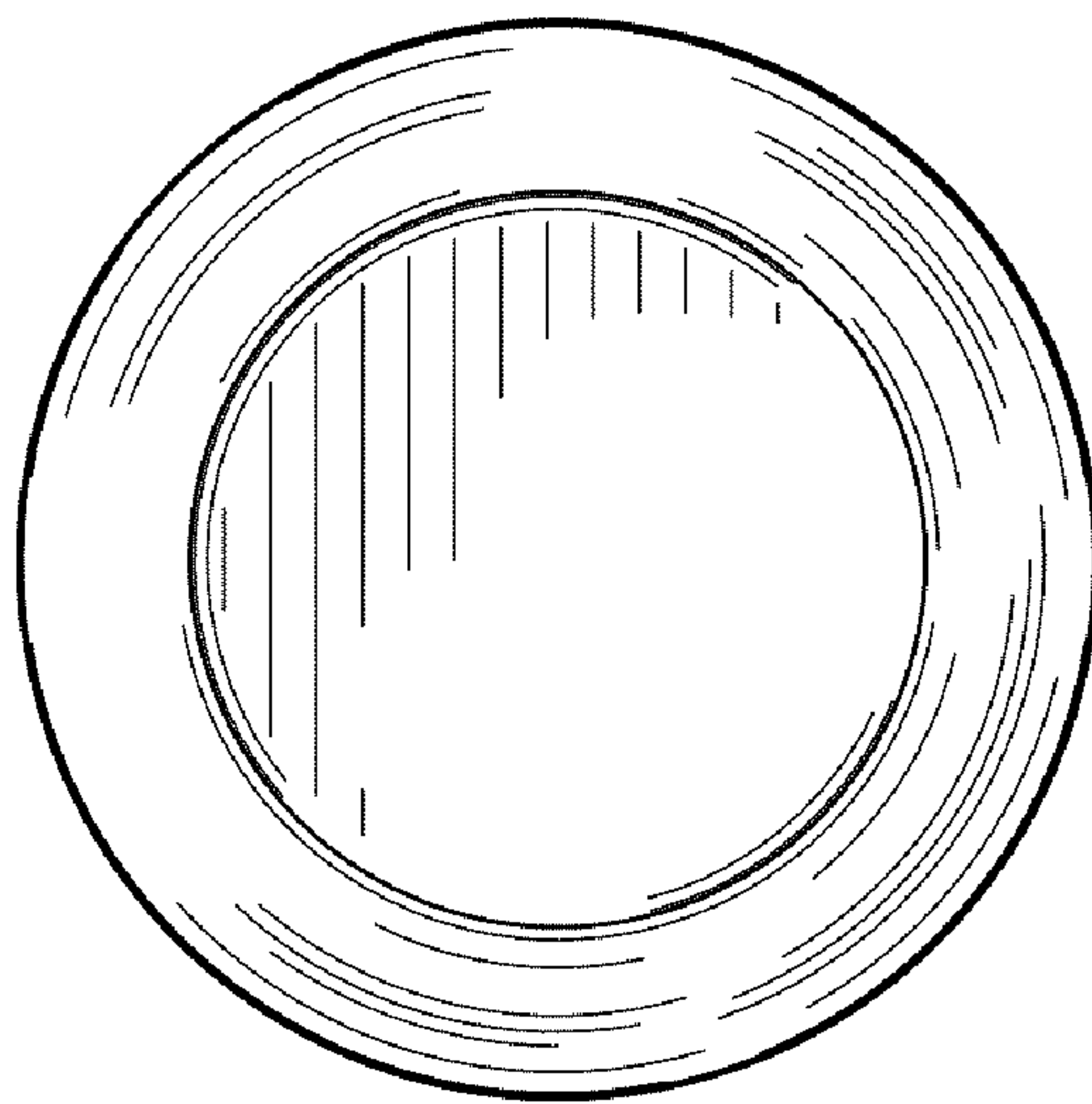

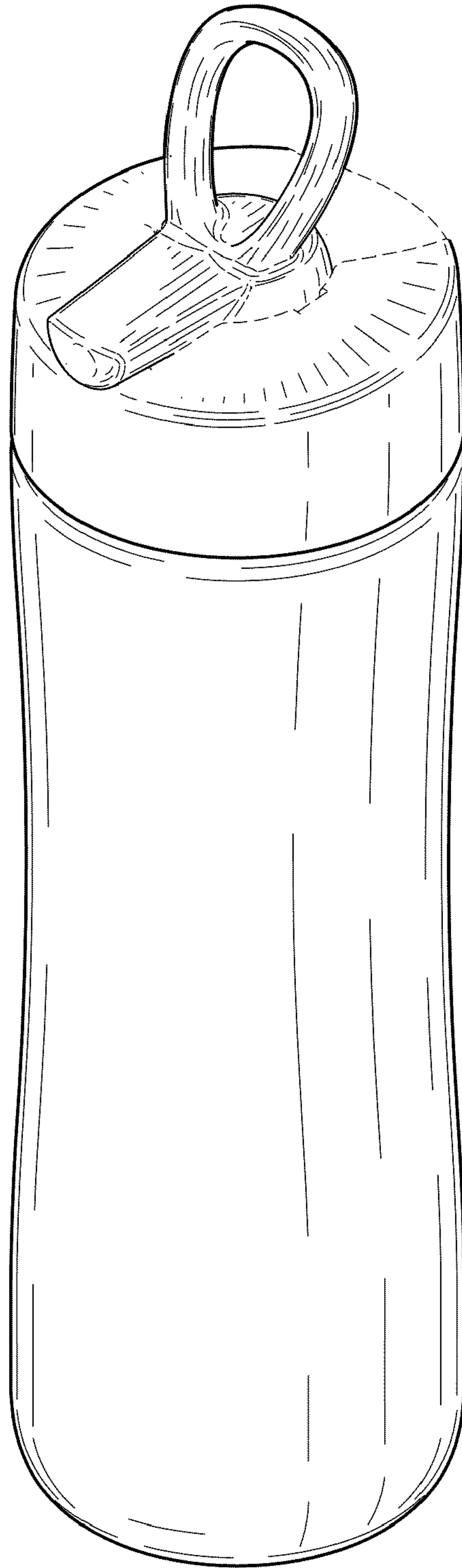

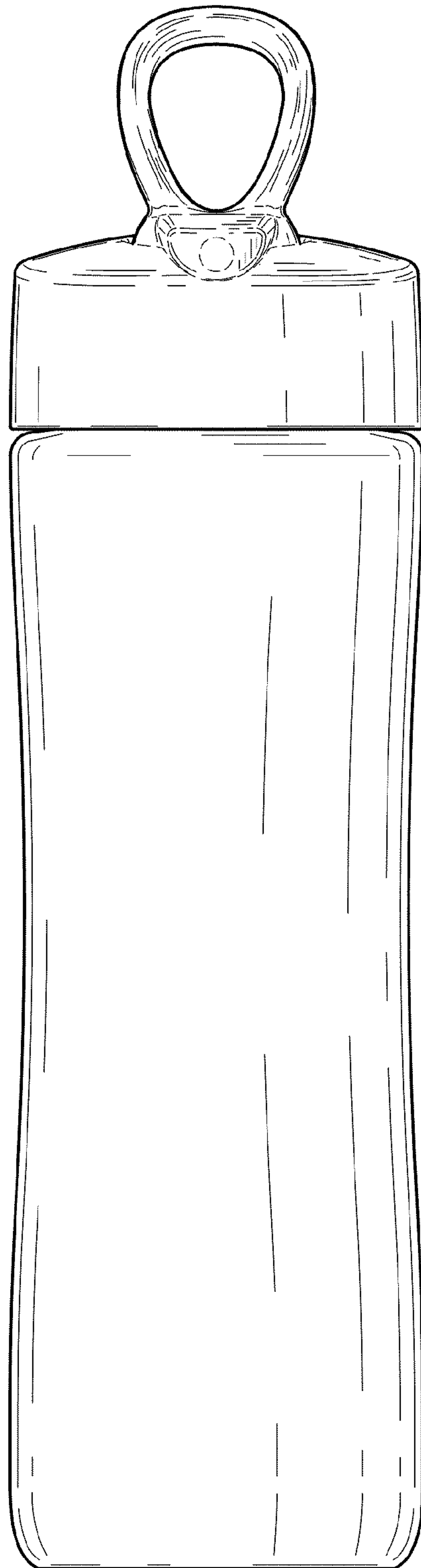

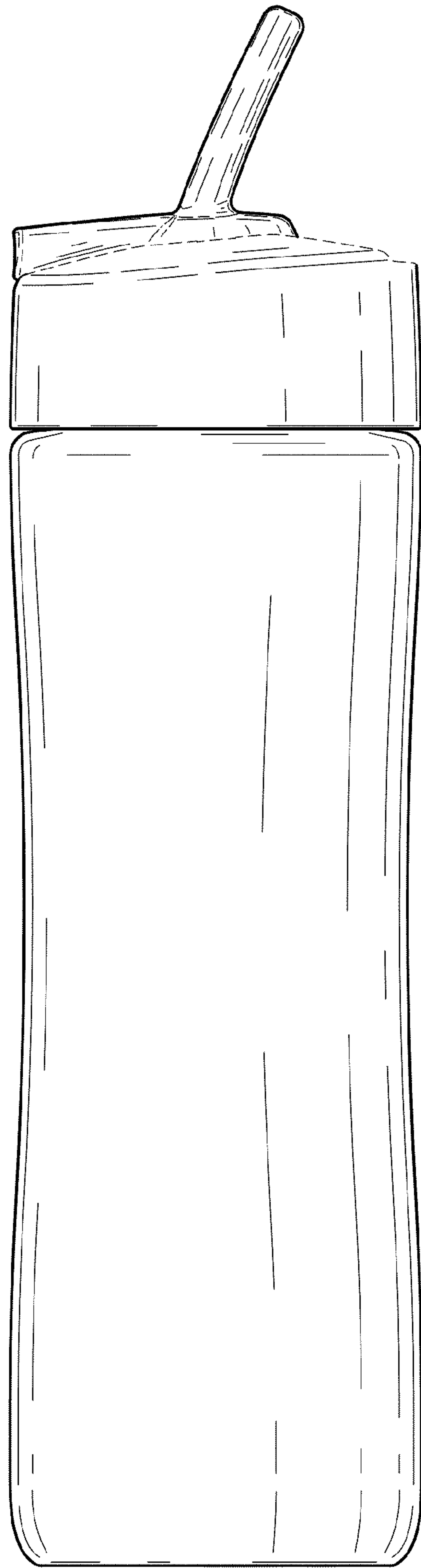

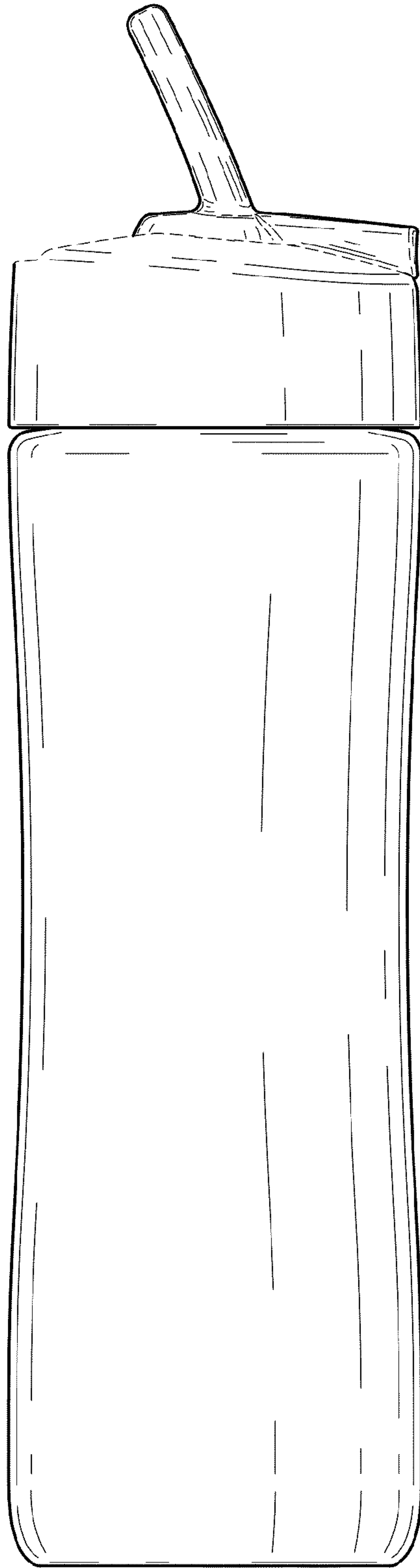

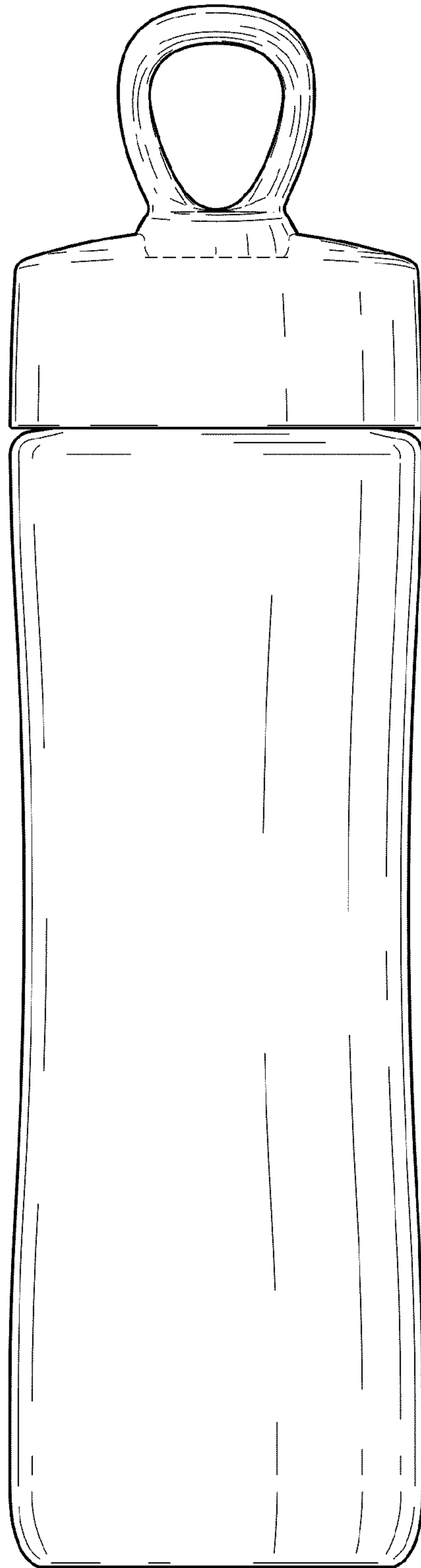

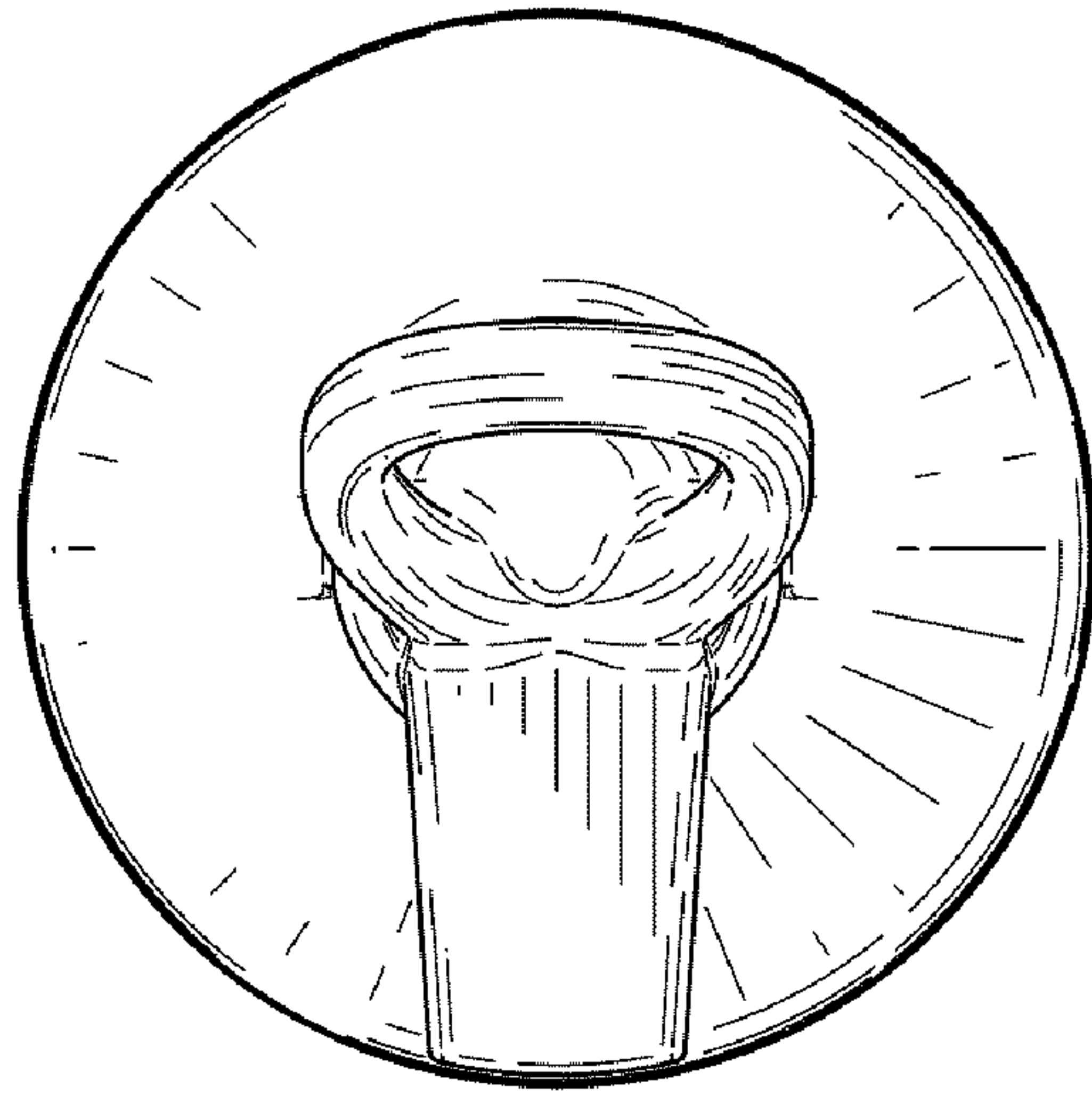

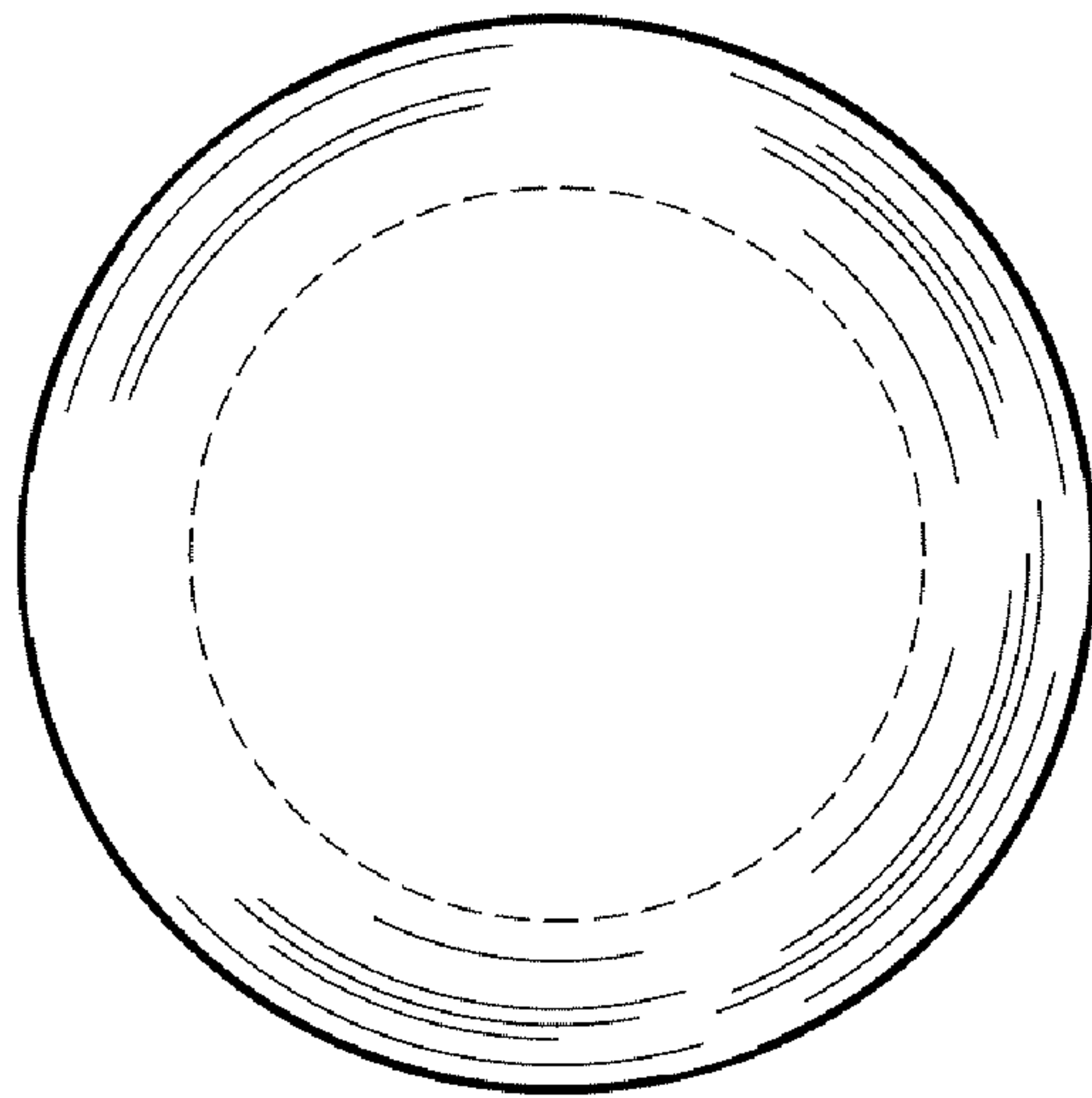

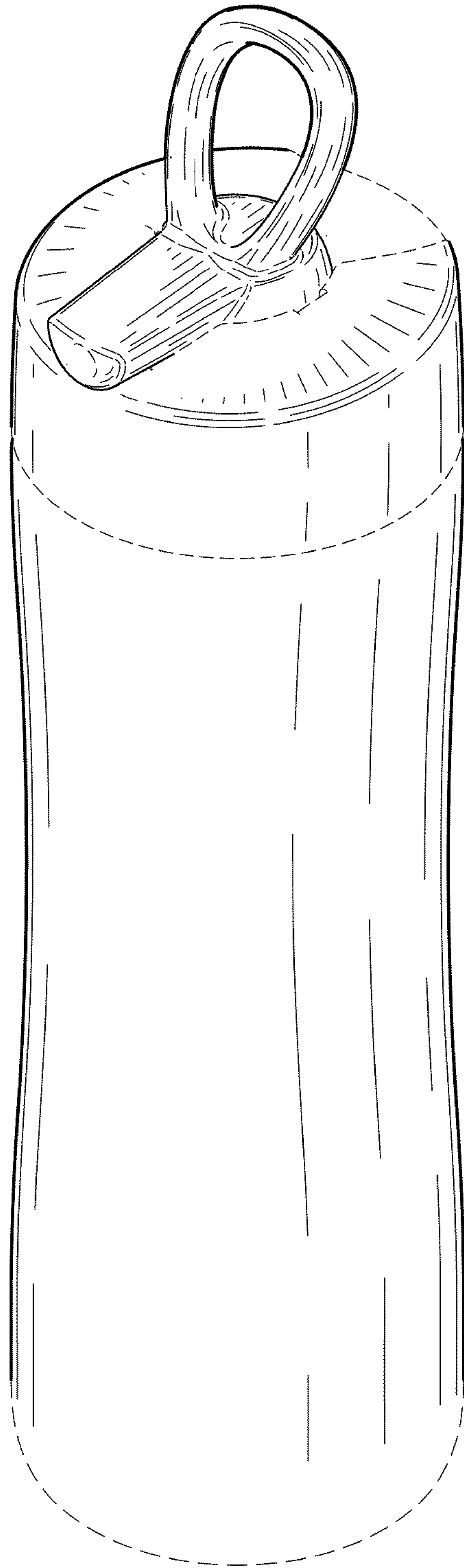

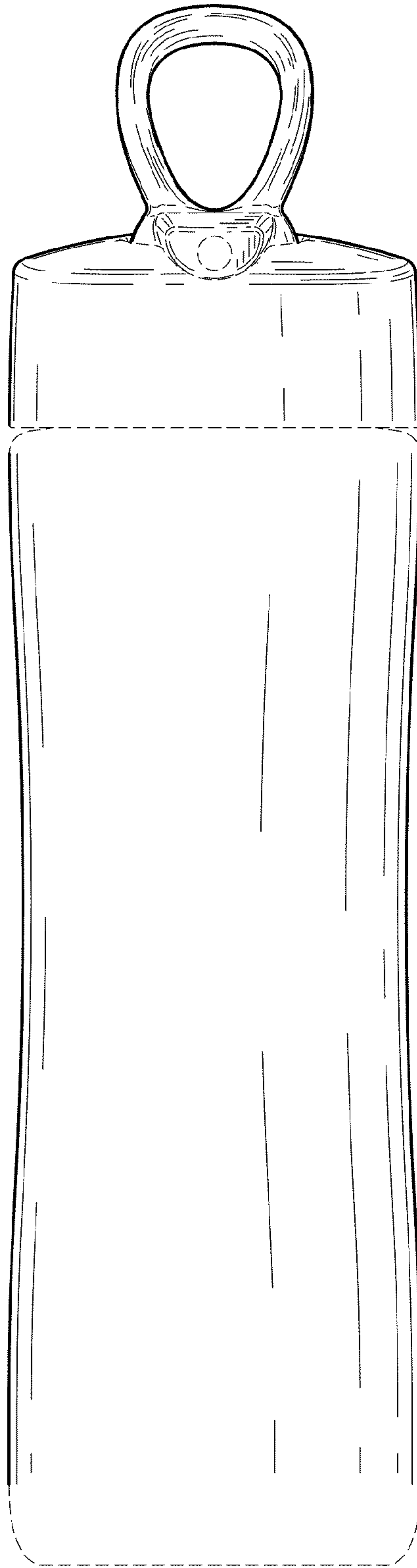

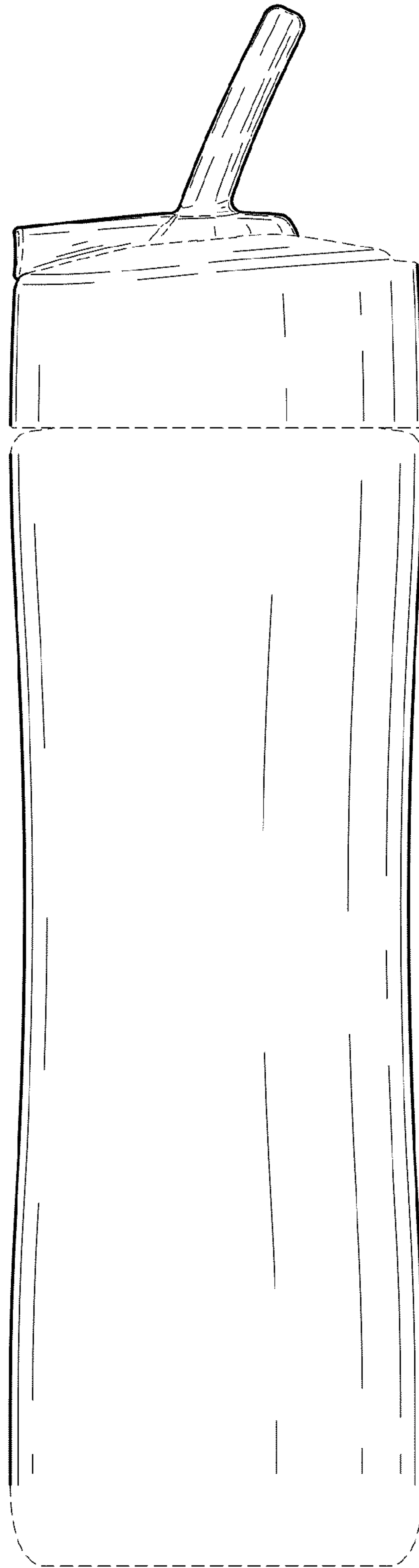

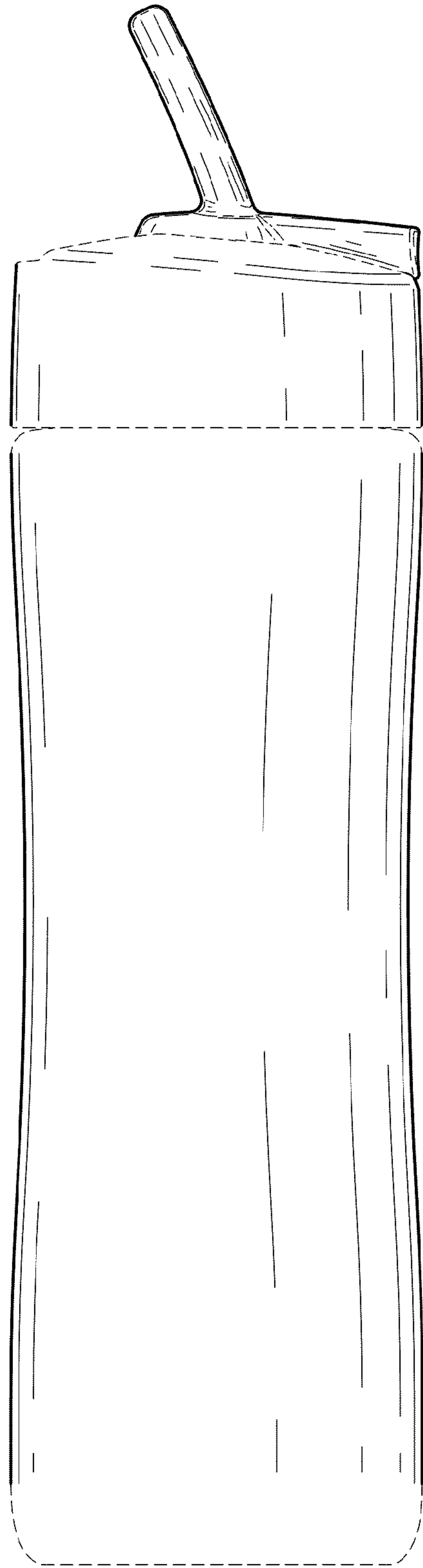

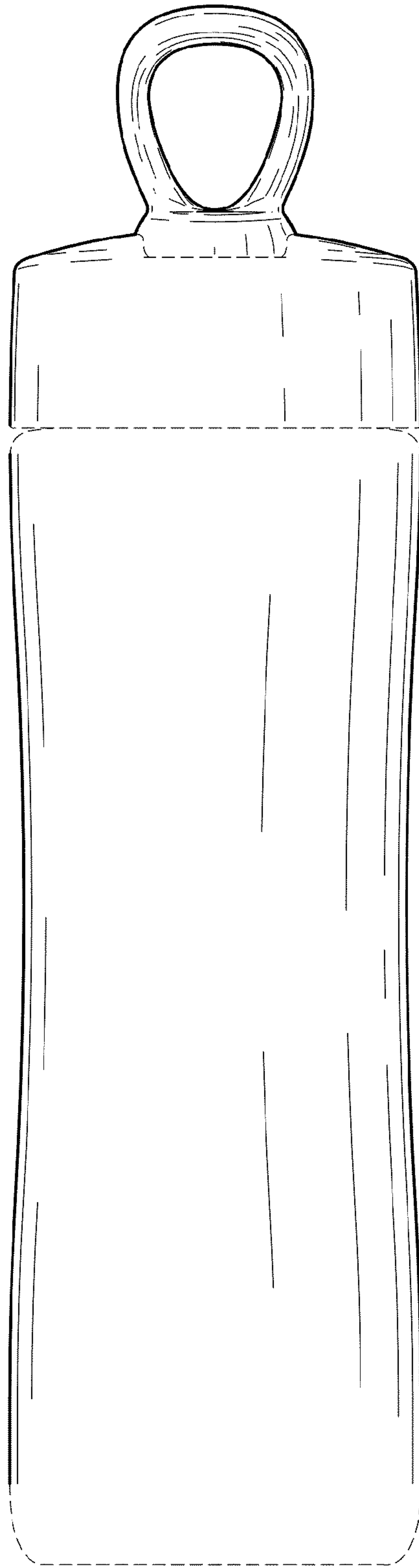

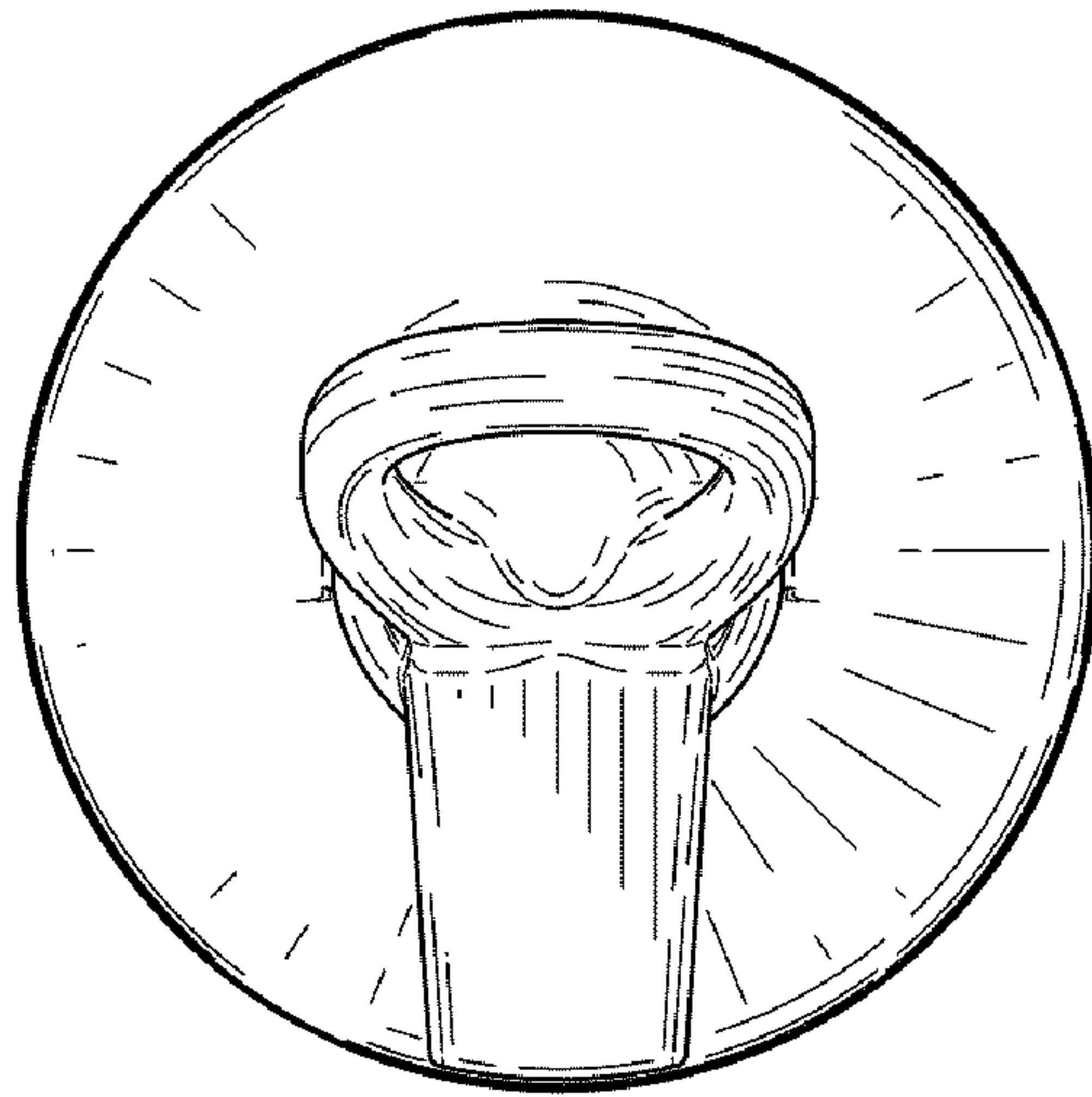

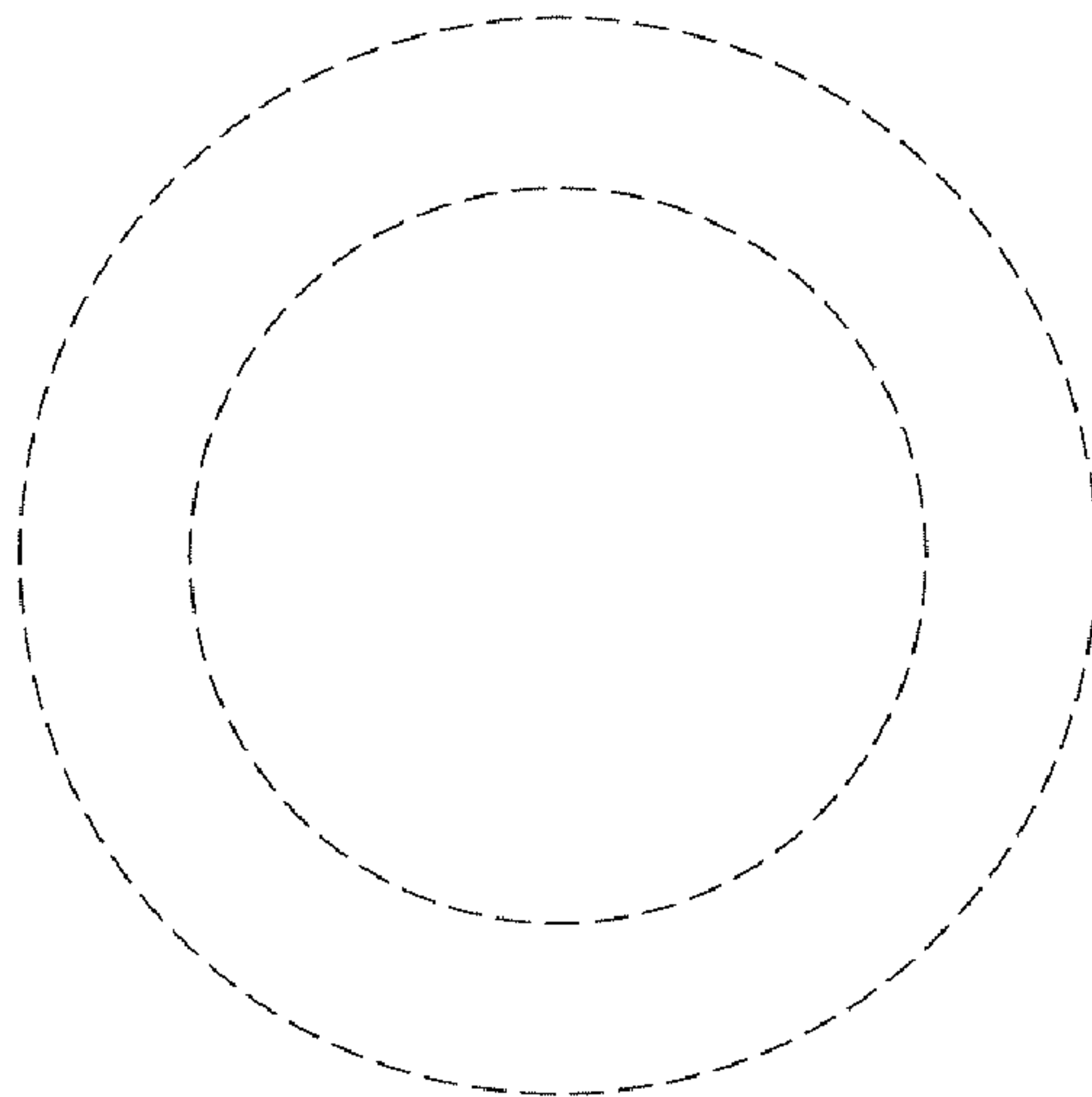
