DESCRIPTION

FIG. 1 is a perspective view of a string trimmer showing my new design.

FIG. 4 is a rear view of the string trimmer according to FIG. 1.

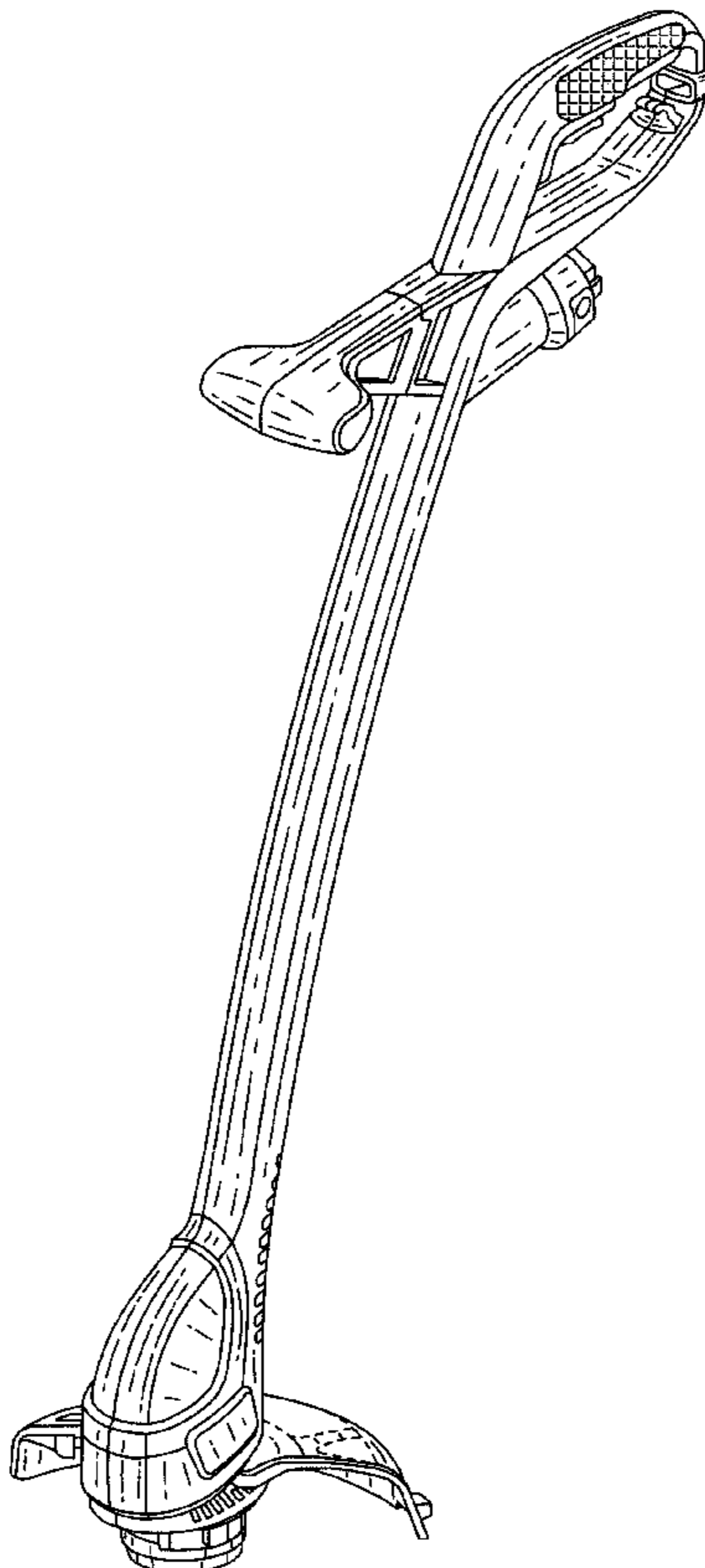
FIG. 5 is a front view of the string trimmer according to FIG. 1.

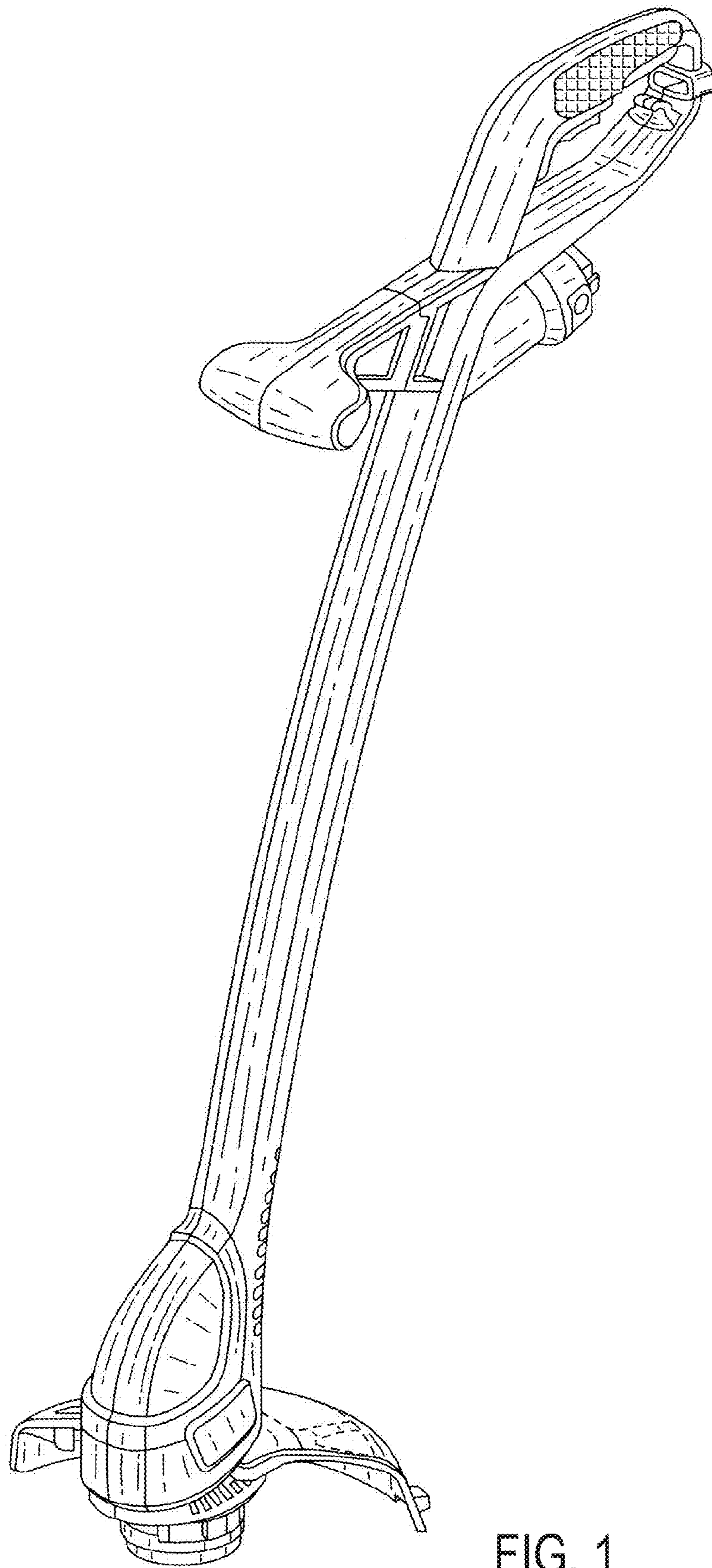

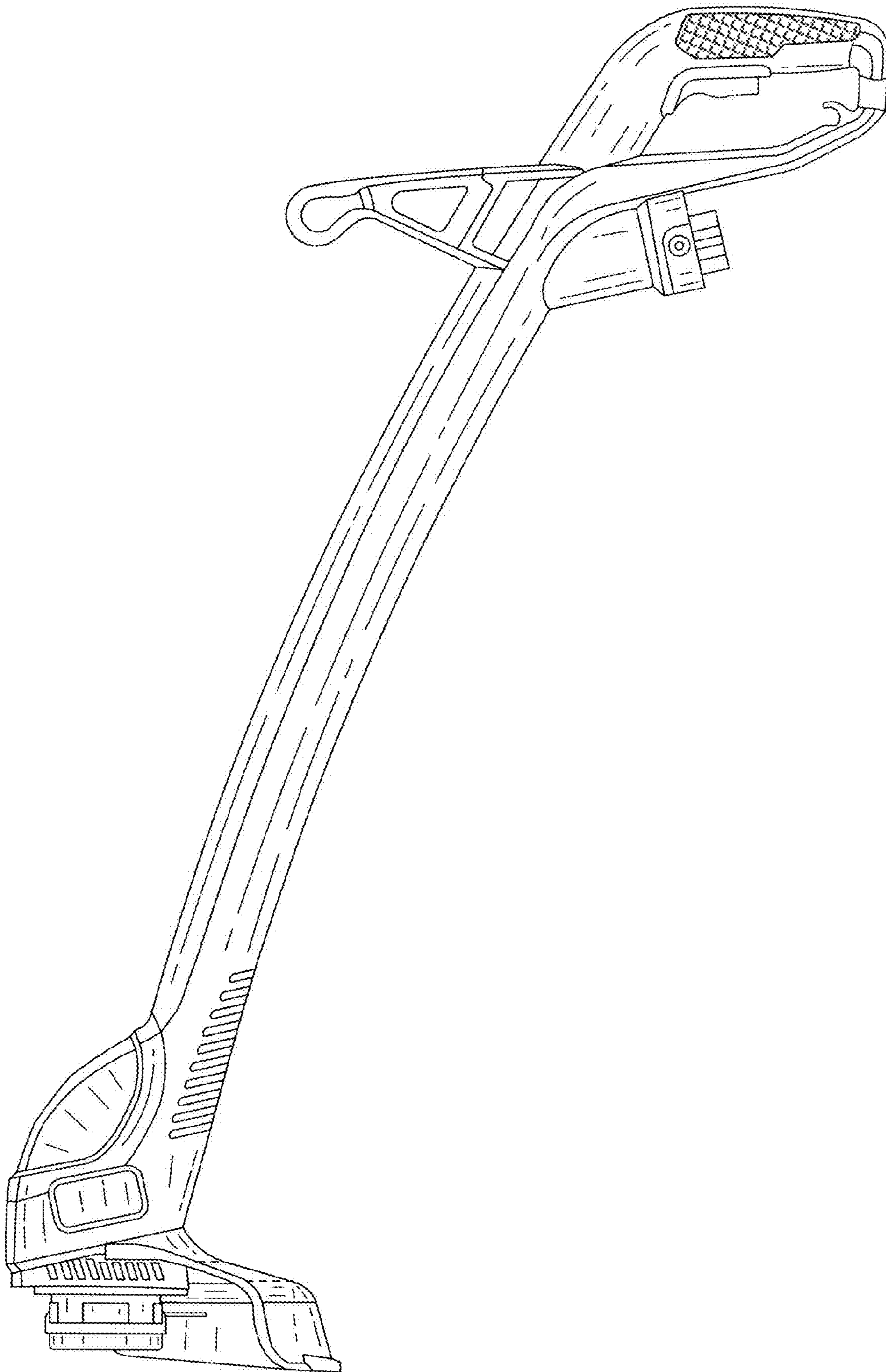

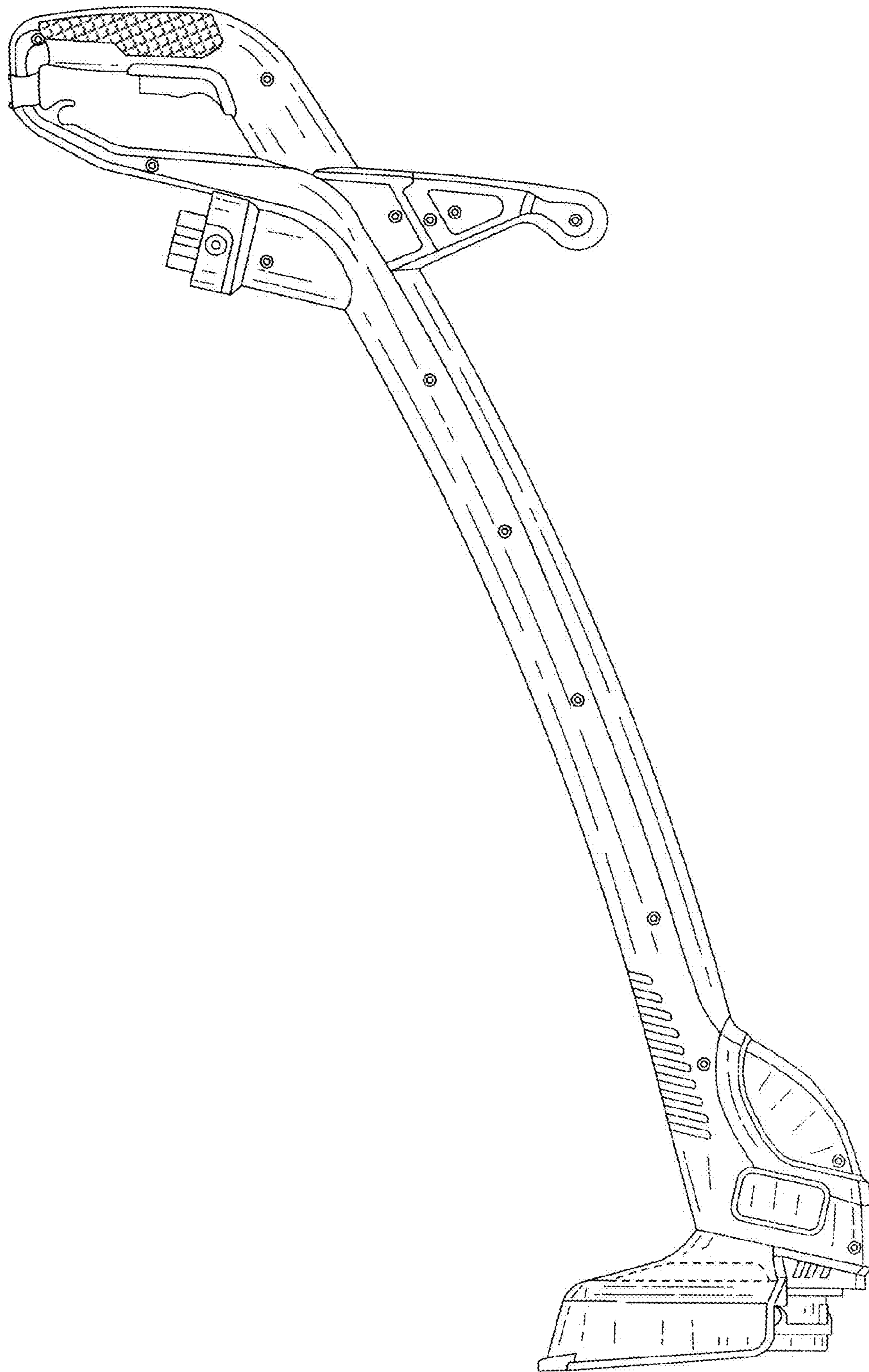

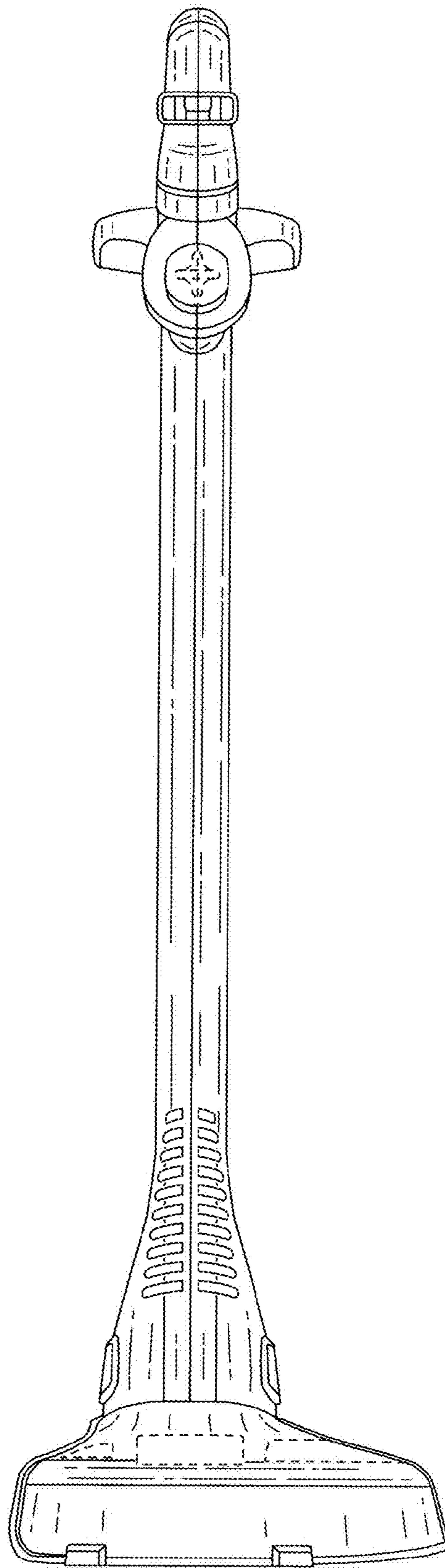

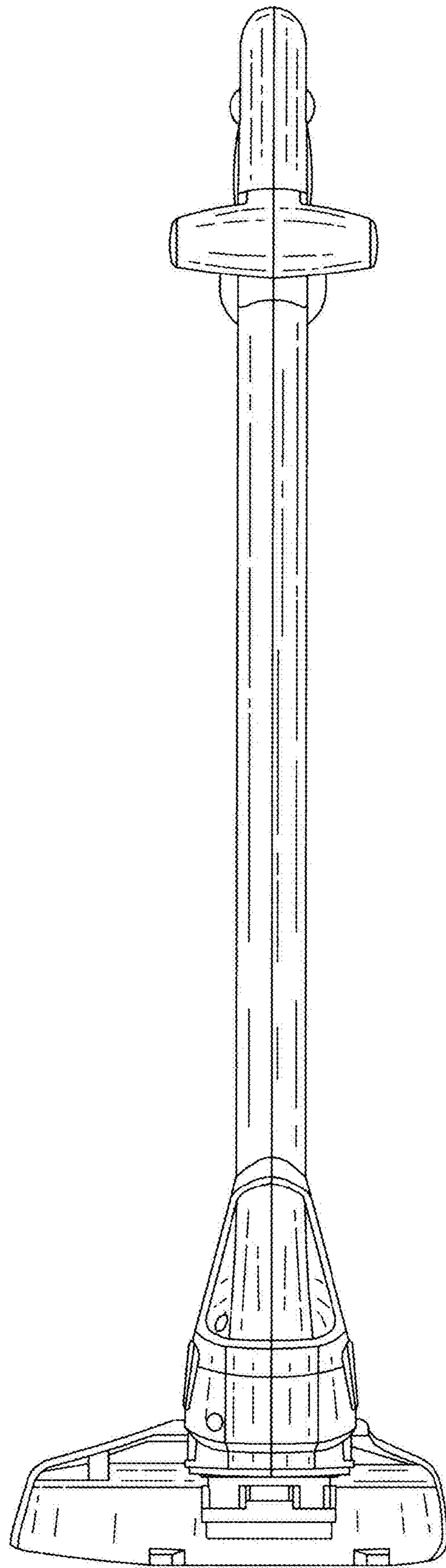

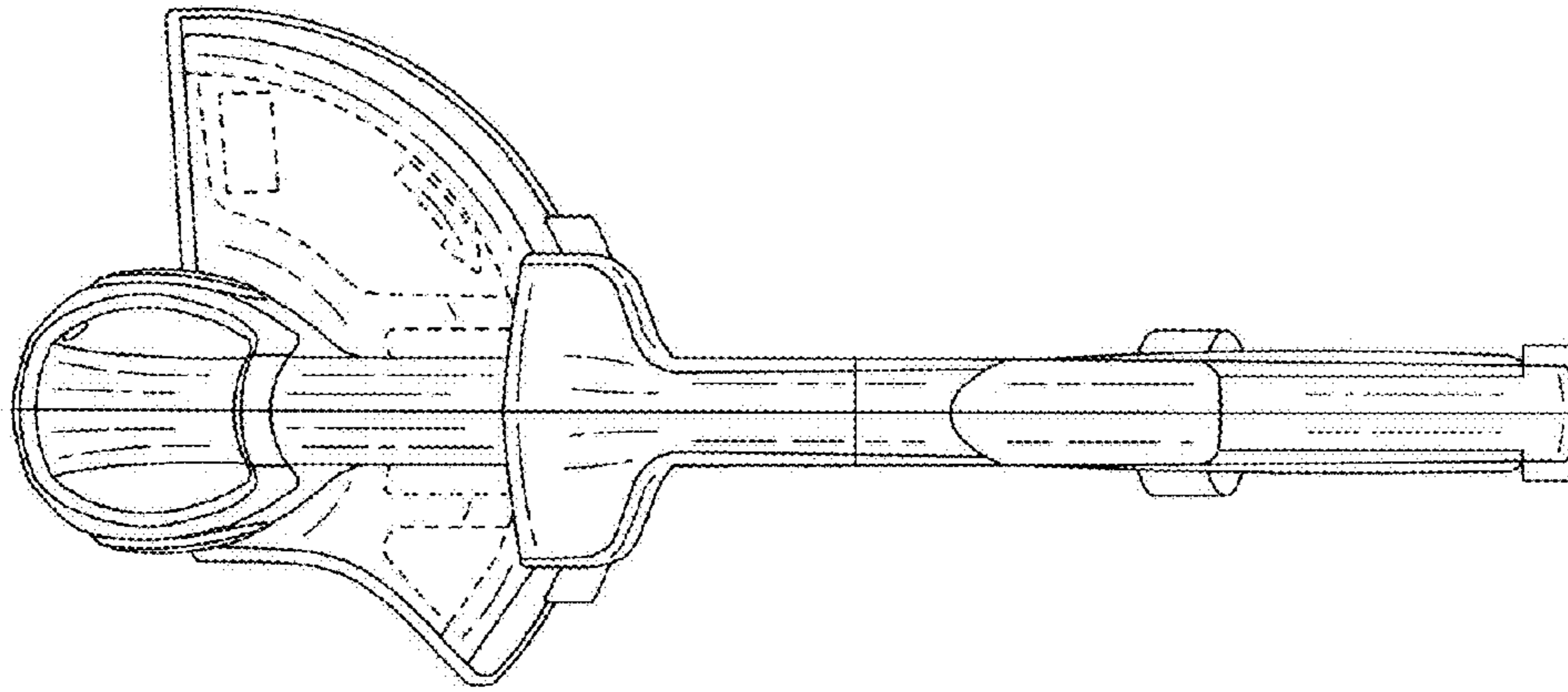

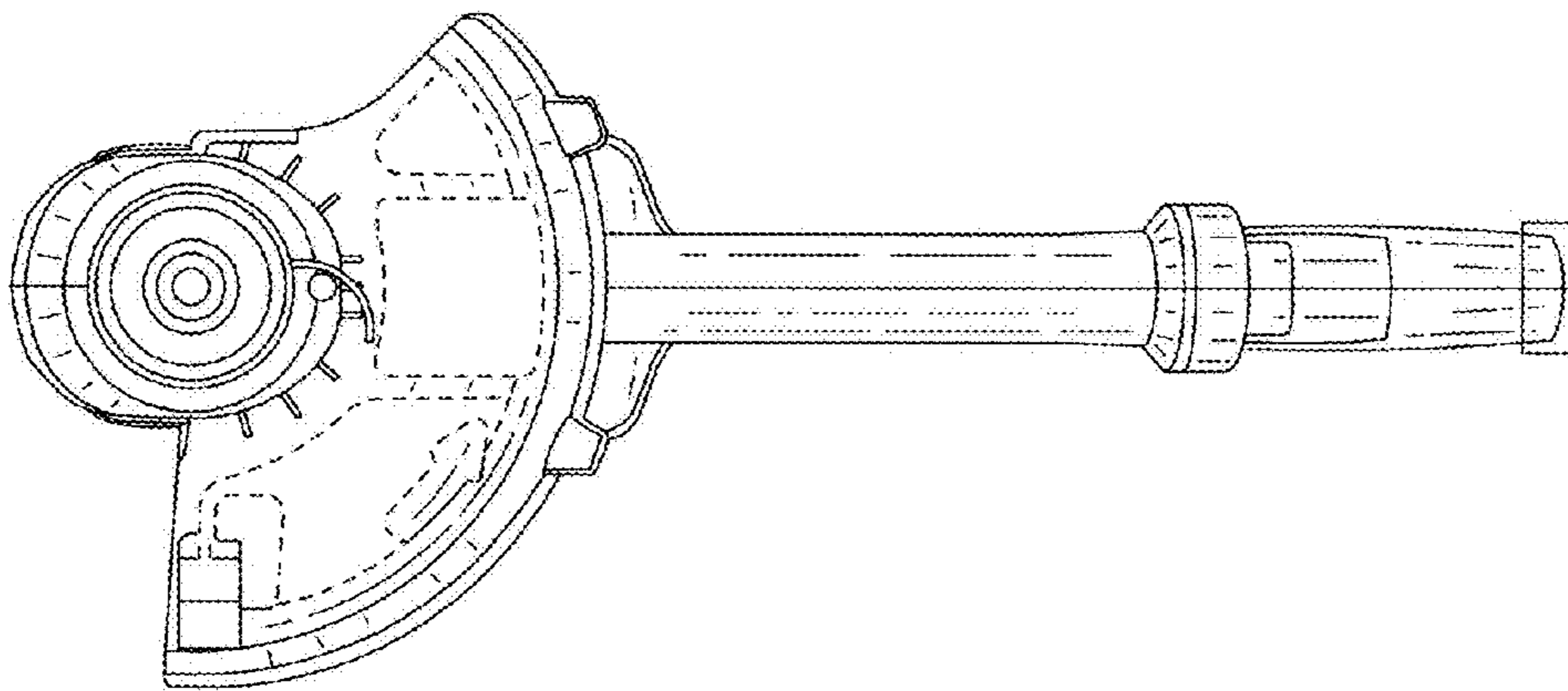
