(57) **CLAIM**

The ornamental design for a corner protector, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a corner protector showing the new design;

FIG. 2 is a bottom perspective view of the corner protector shown in FIG. 1;

FIG. 3 is a first side elevational view of one of three sides of the corner protector shown in FIG. 1;

FIG. 4 is a second side elevational view shown looking directly towards one of three elevated edges of the corner protector shown in FIG. 1;

FIG. 5 is a top plan view of the corner protector shown in FIG. 1;

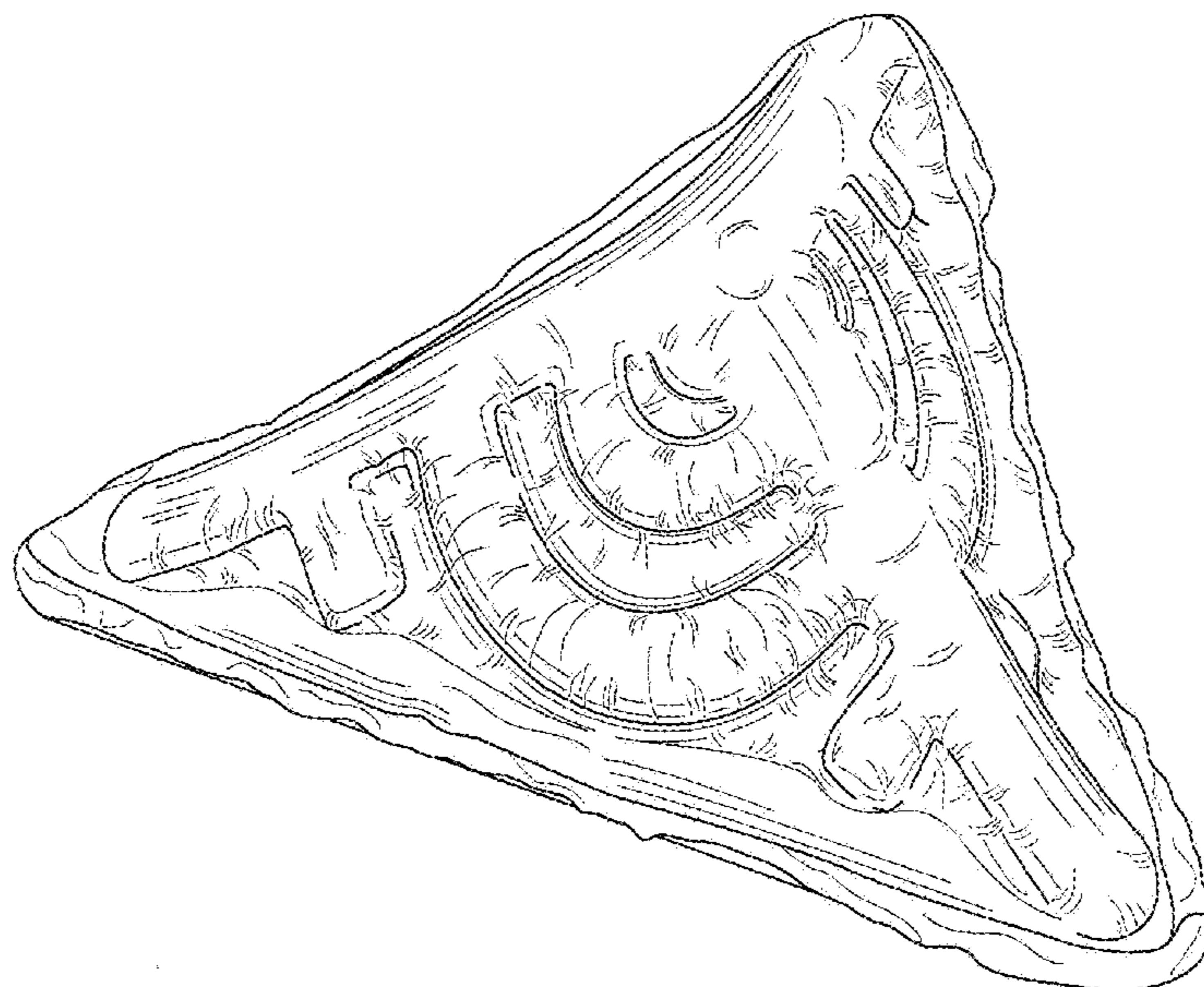
FIG. 6 is a bottom plan view of the corner protector shown in FIG. 1; and

FIG. 7 is a cross-sectional view of the corner protector shown in FIG. 1 taken along the line 7-7 shown in FIG. 5; and,

FIG. 8 is a perspective view showing the corner of an article to which the corner protector of FIG. 1 has been attached.

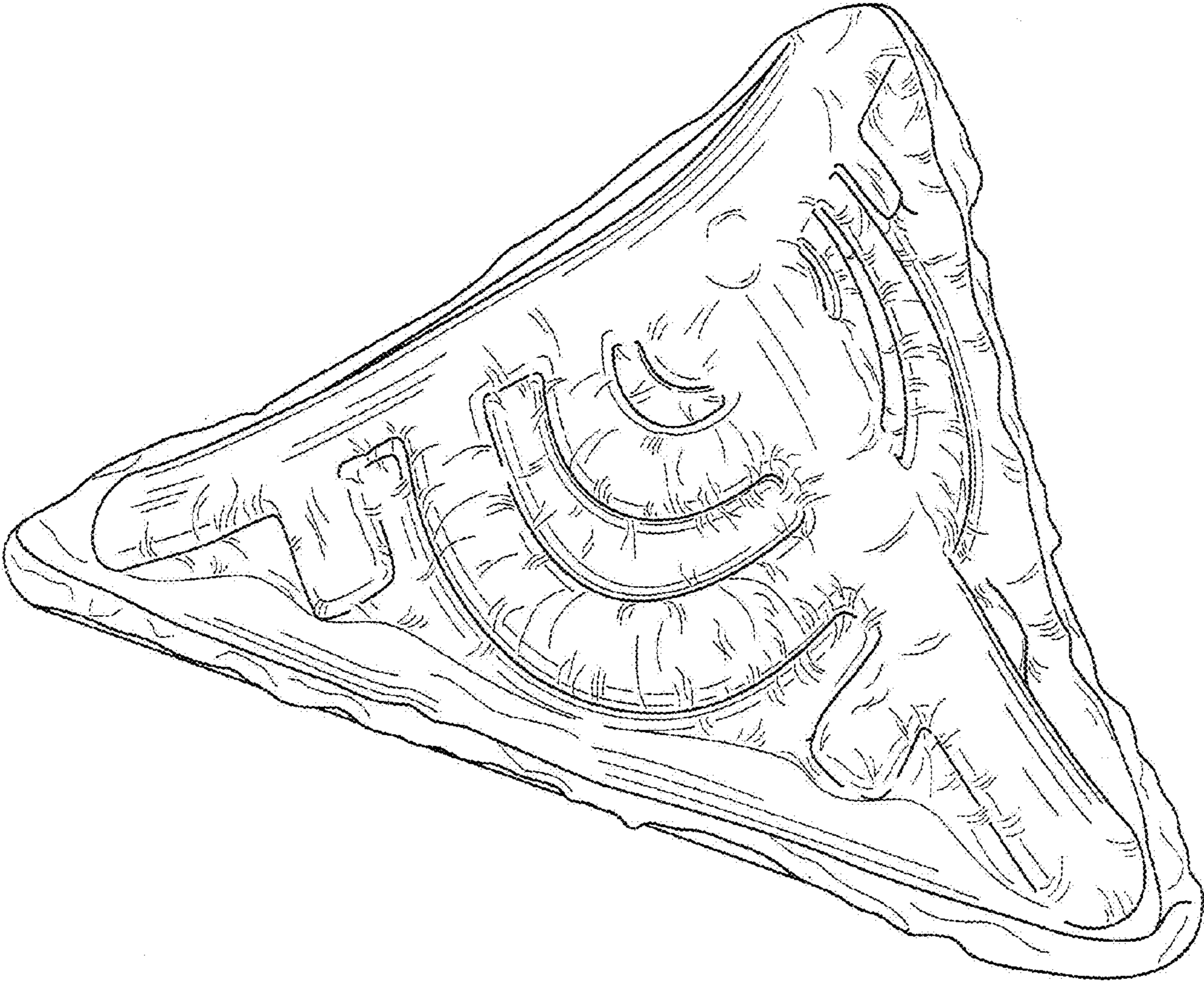

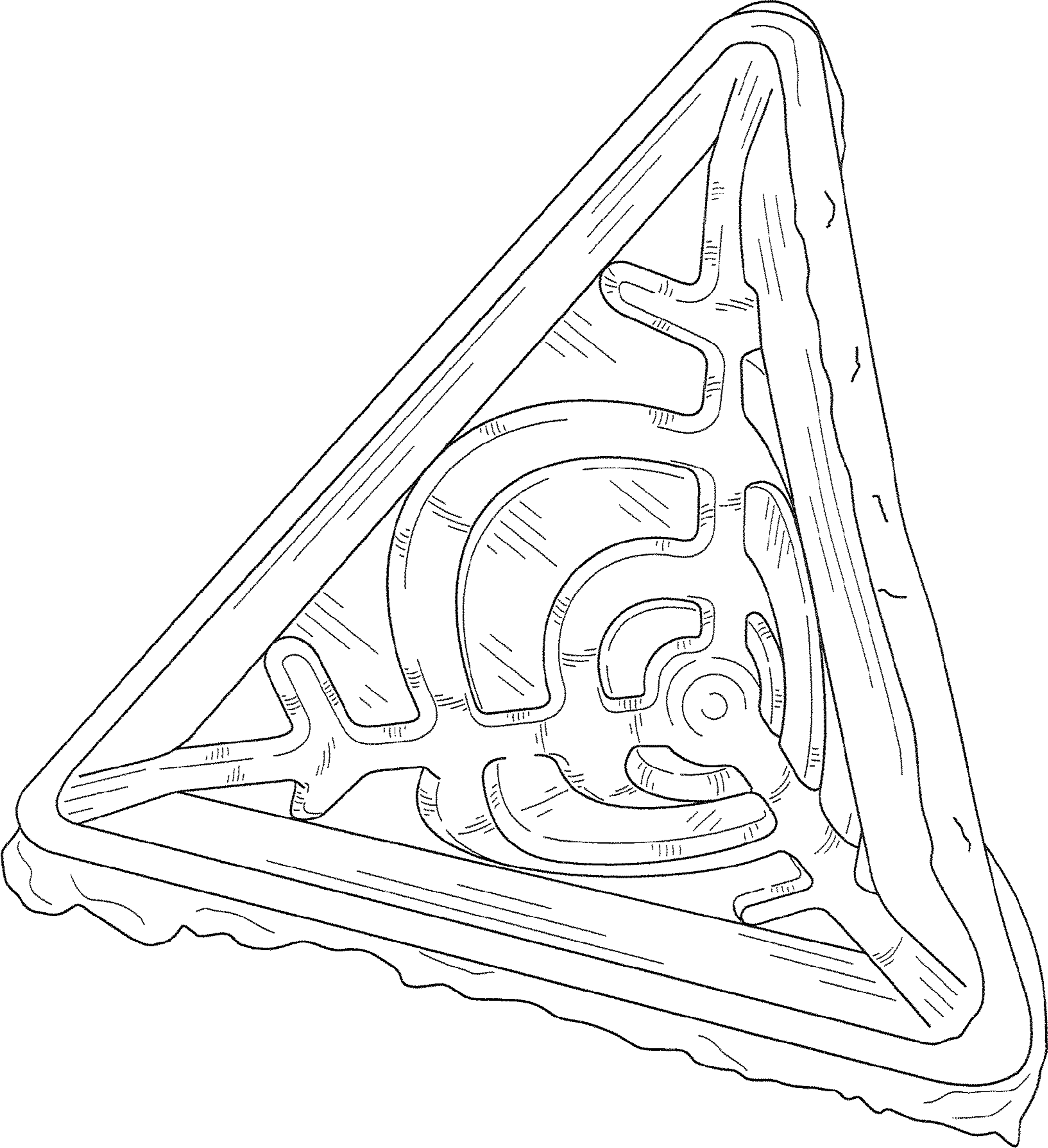

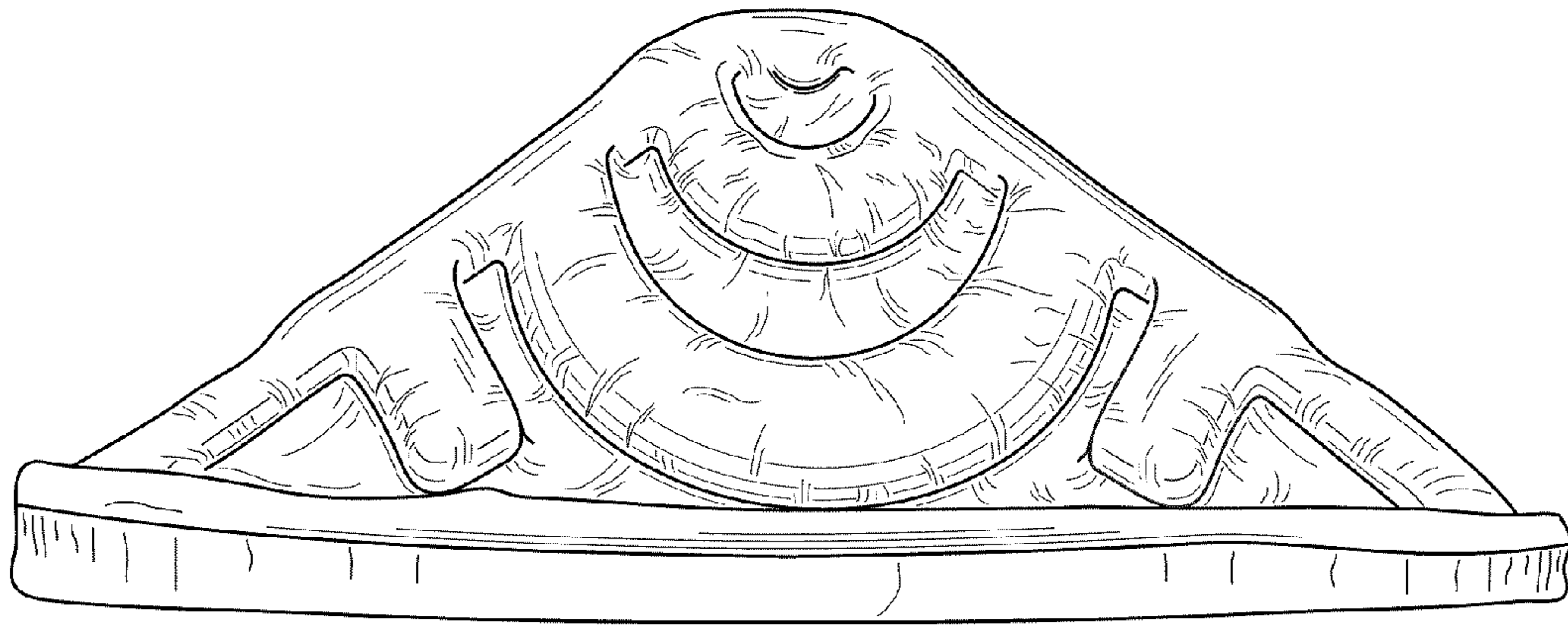

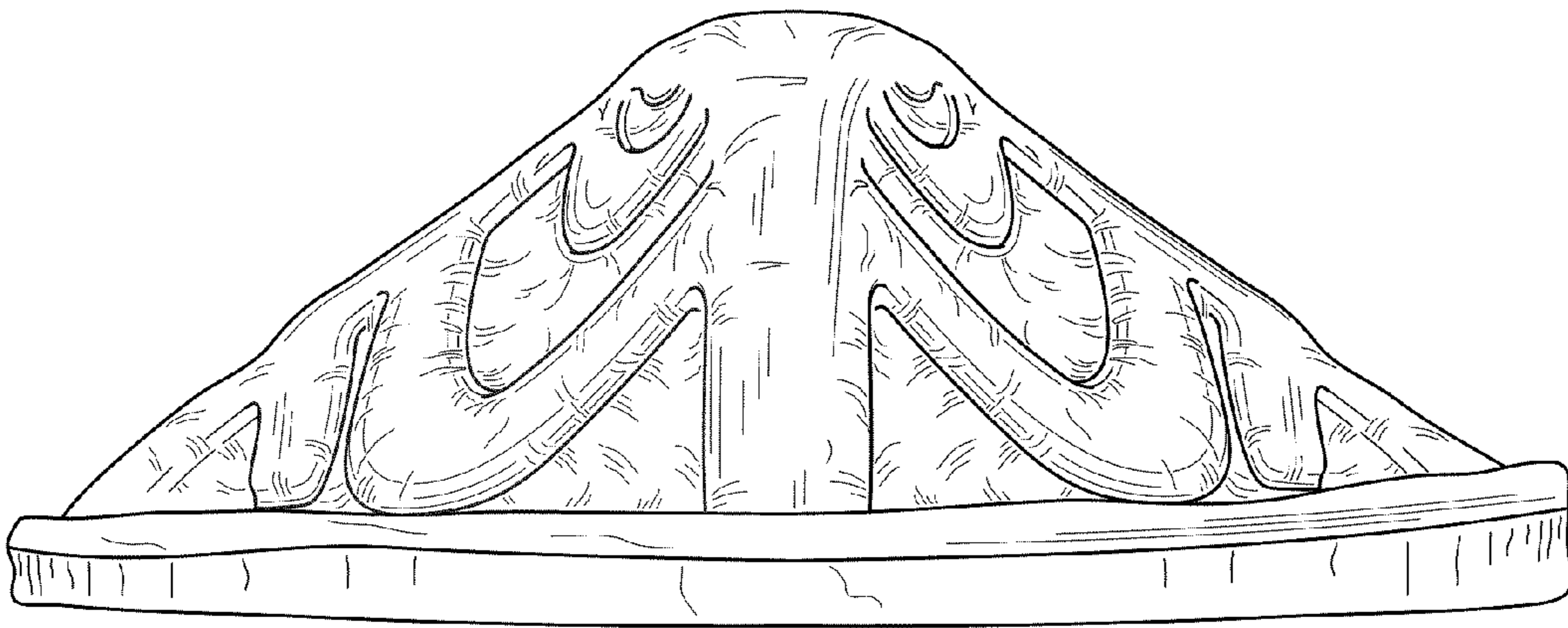

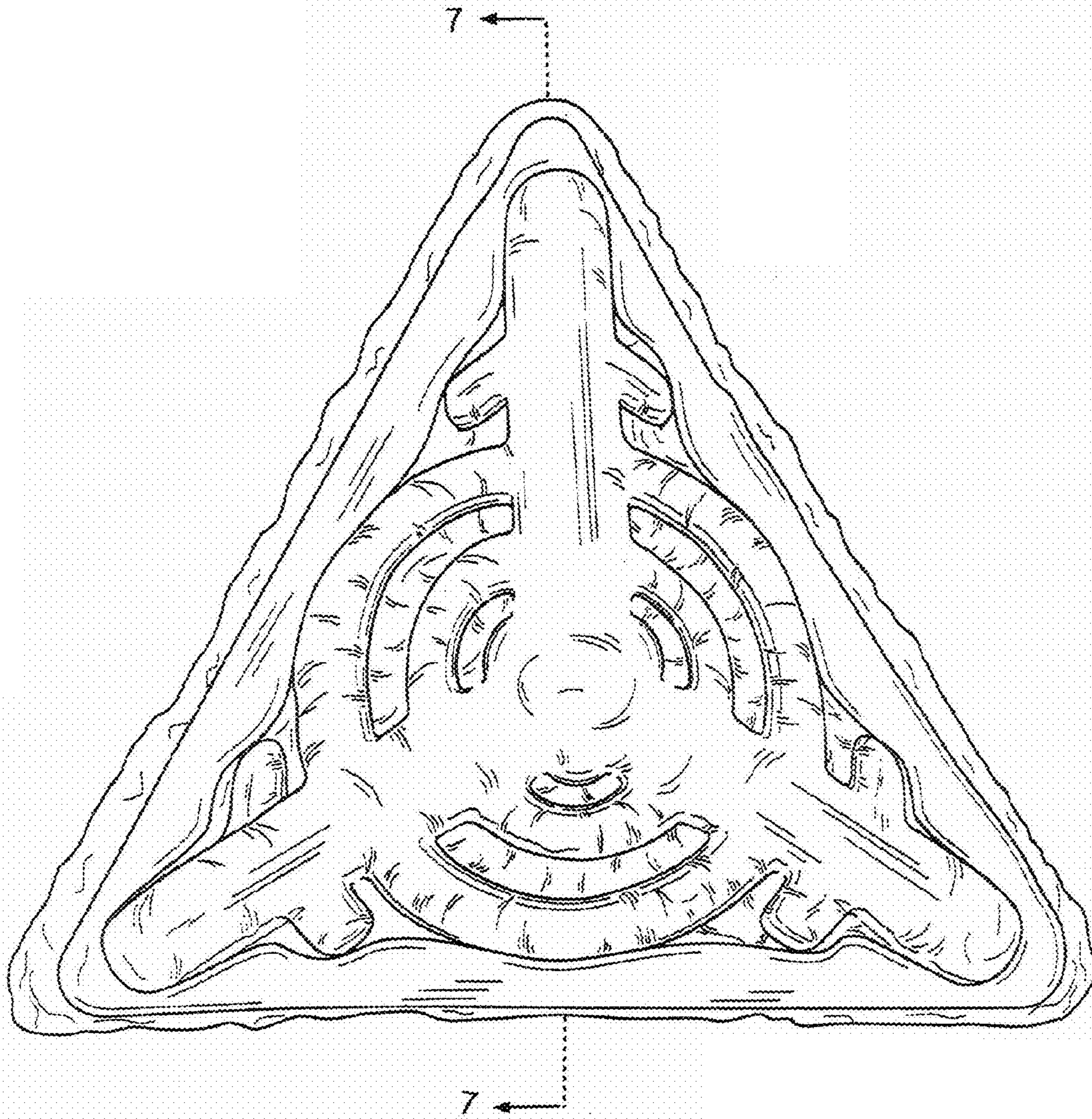

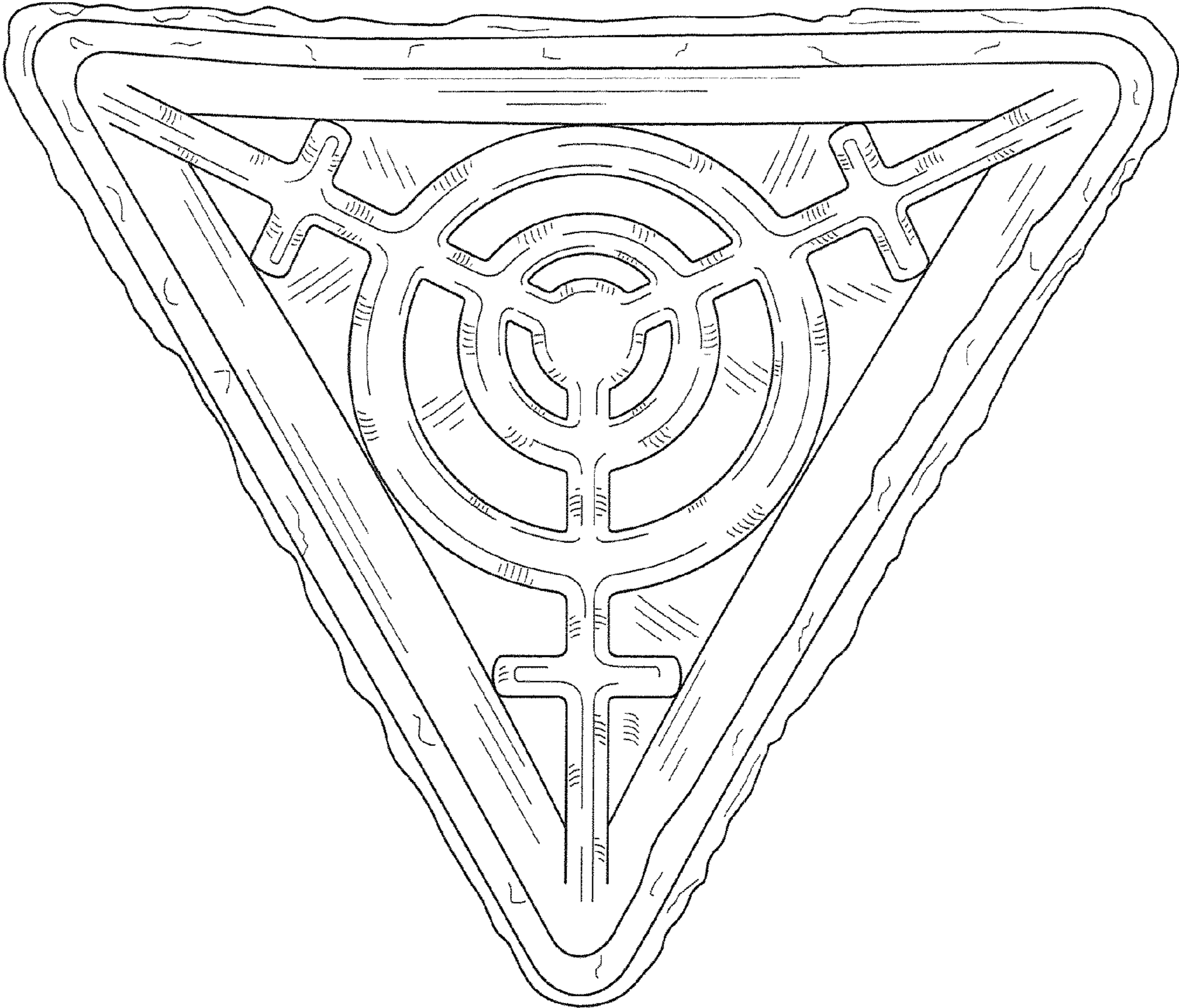

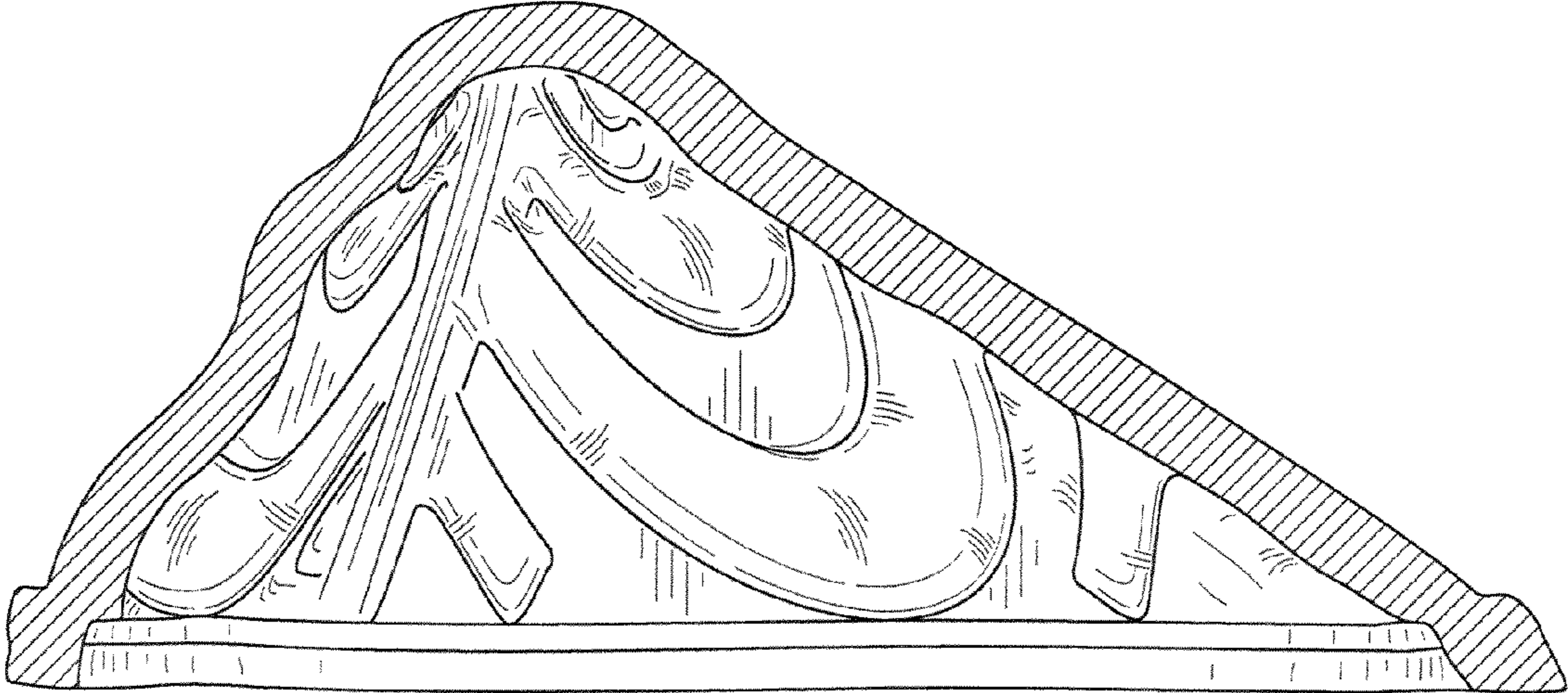

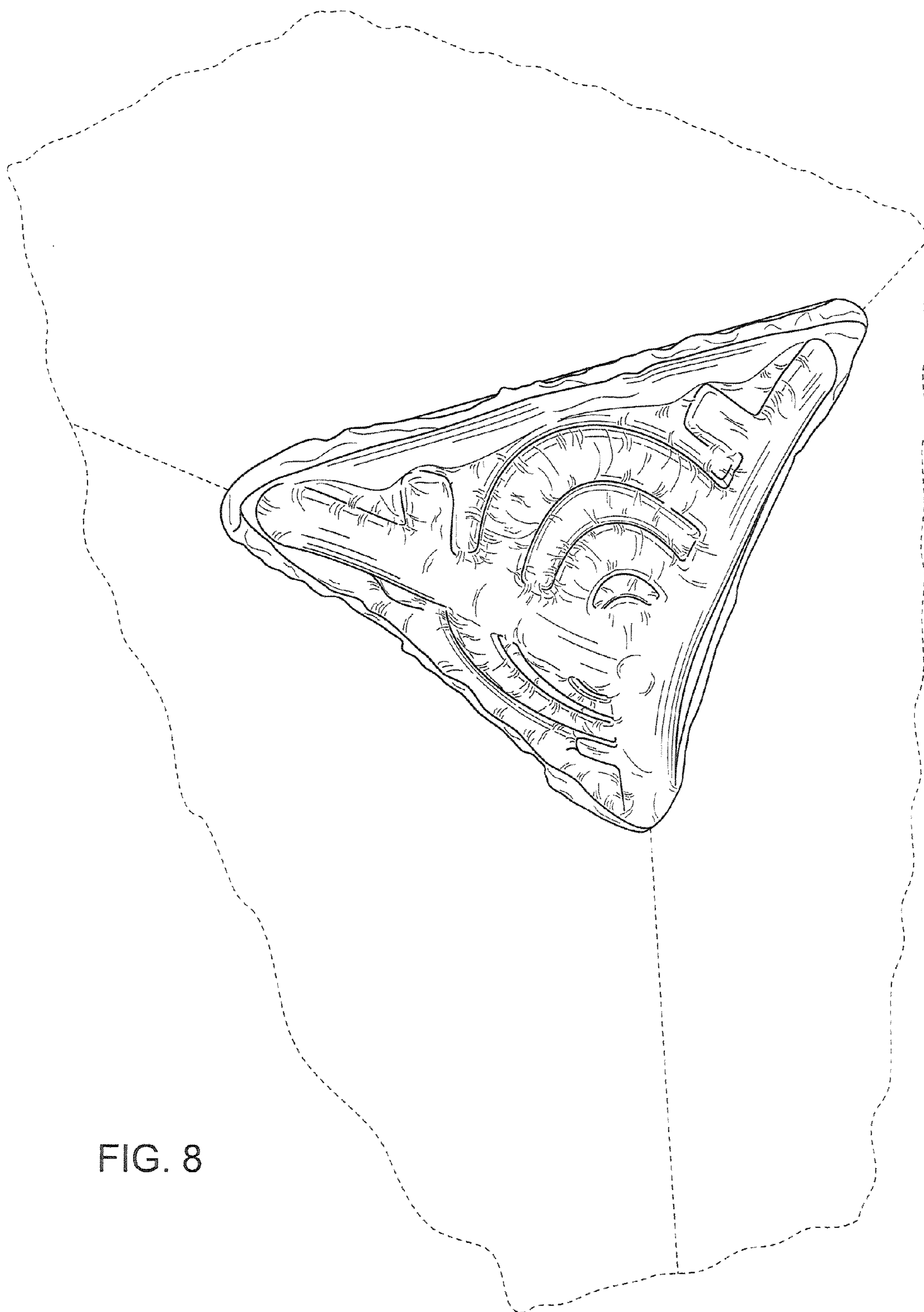
