FIG. 2 is an elevation front view of the stackable container shown in FIG. 1;

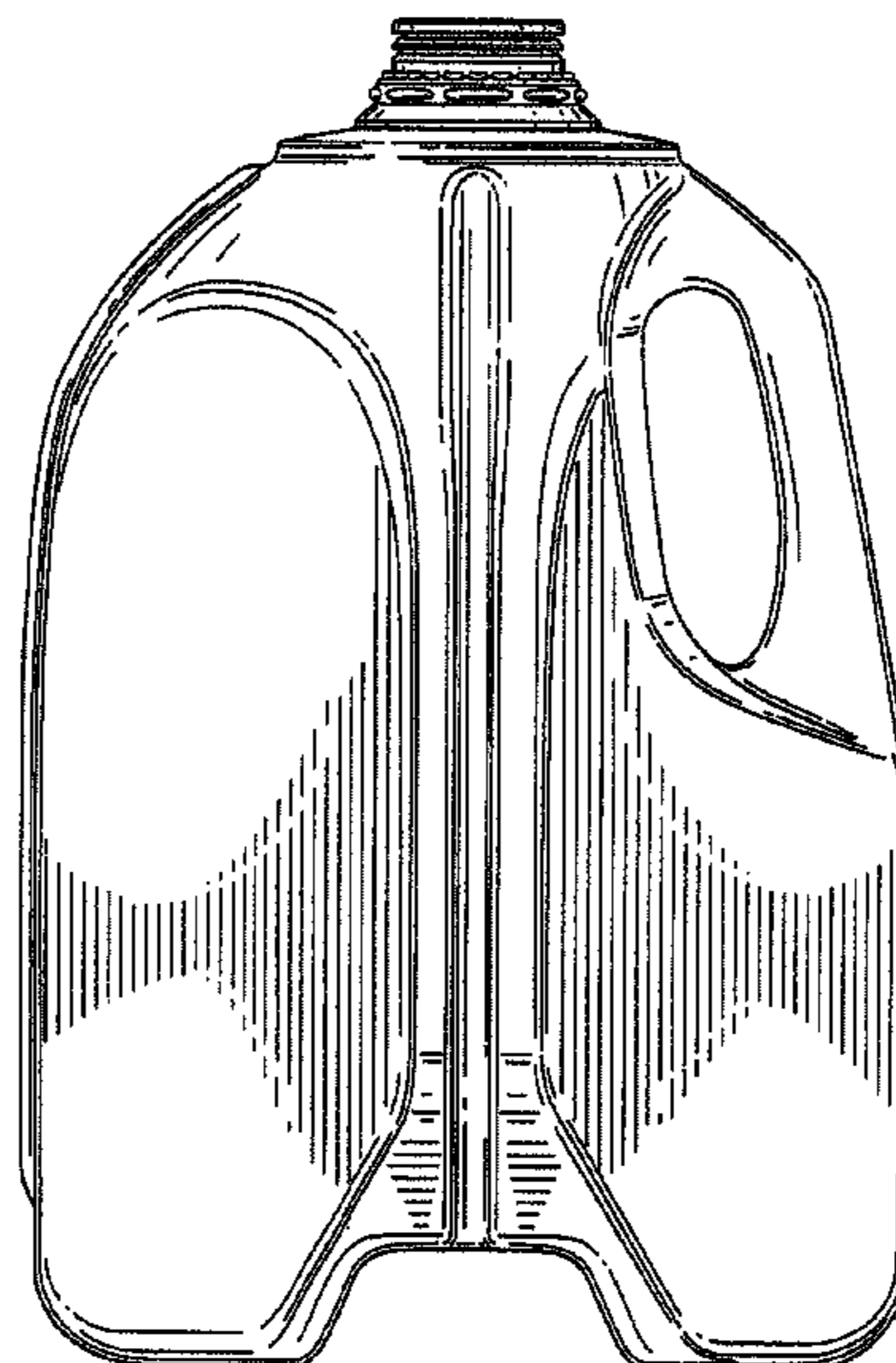
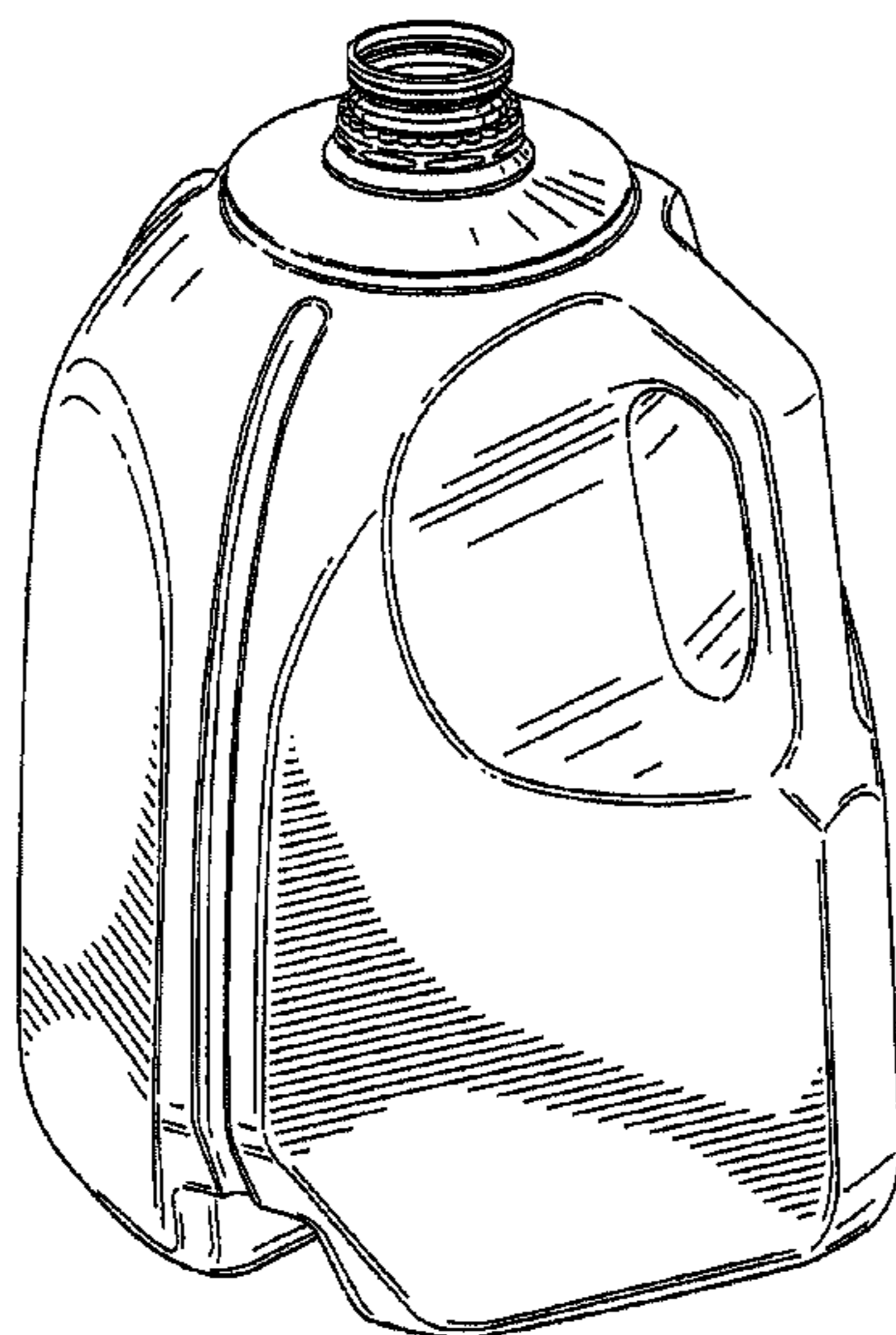
FIG. 3 is an elevation side view of the stackable container shown in FIG. 1, the opposite side being a mirror image thereof;

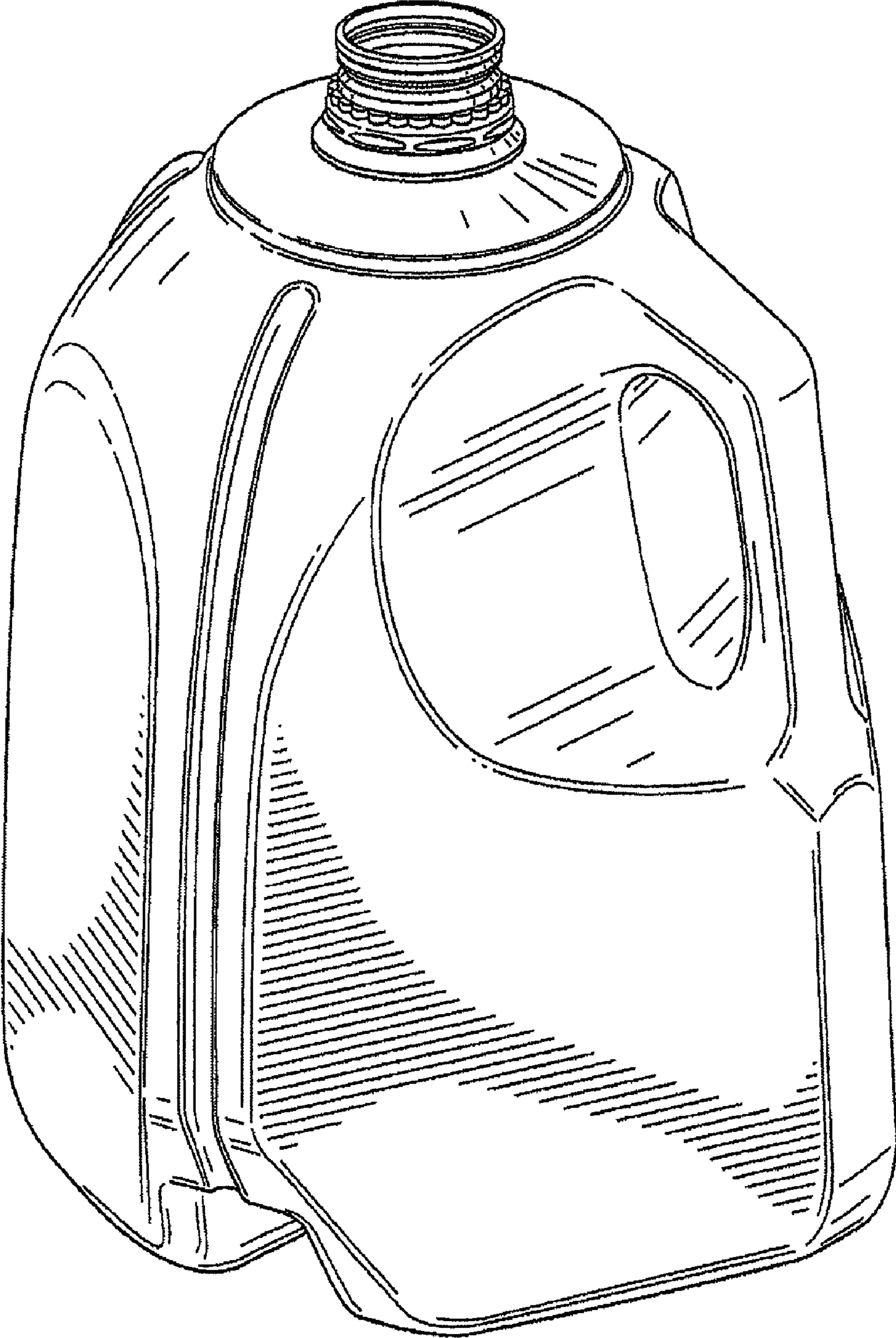

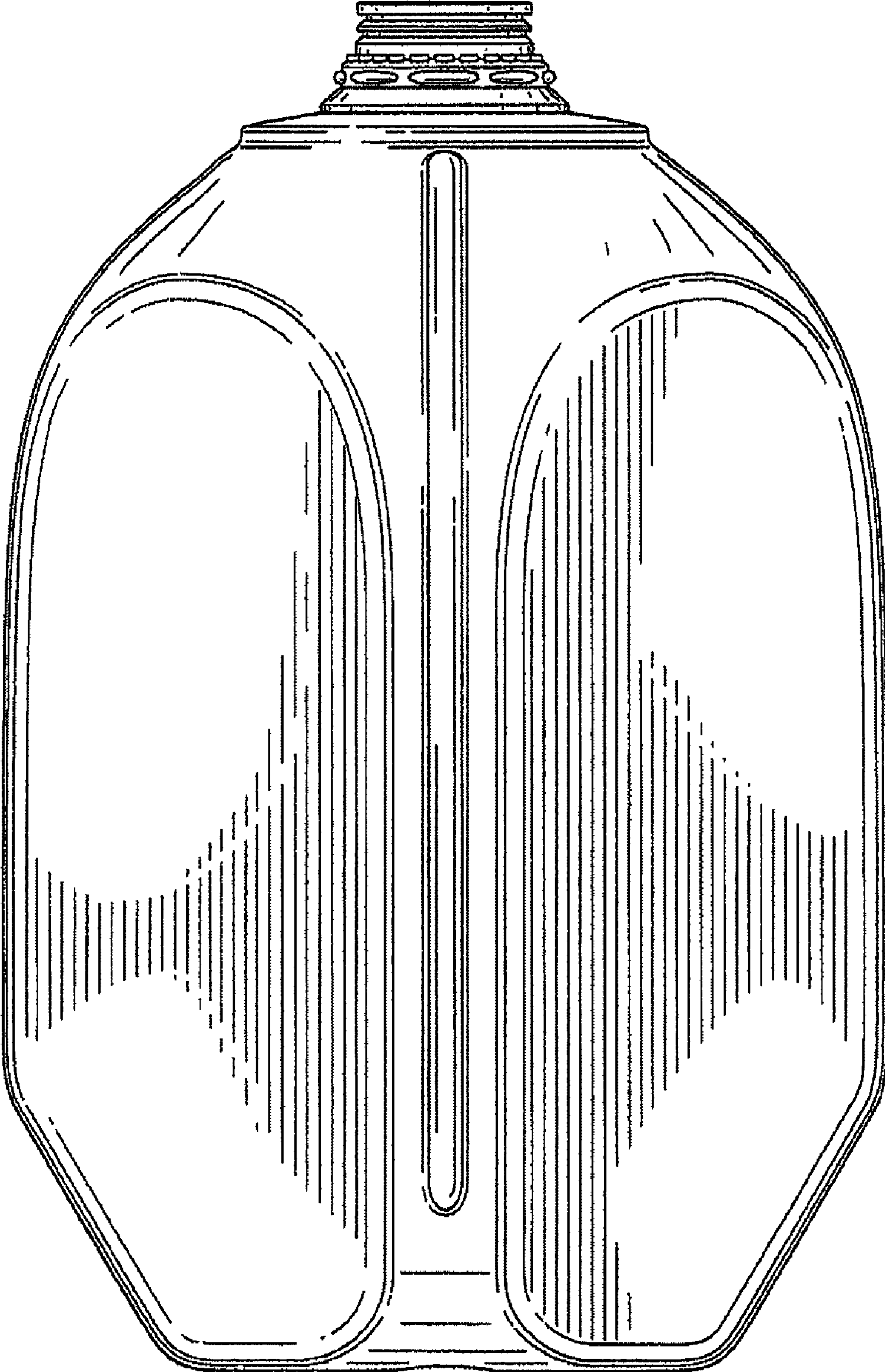

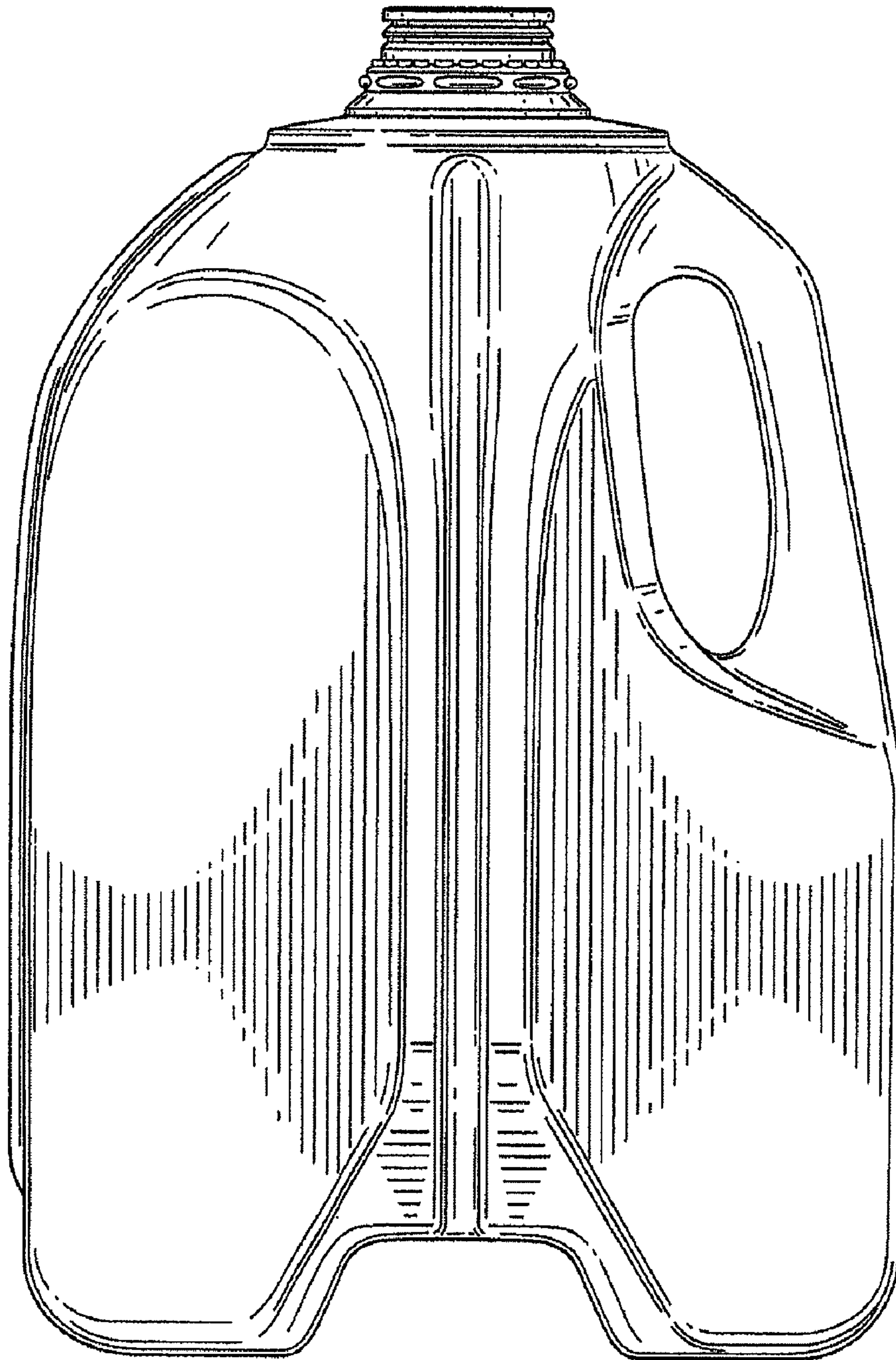

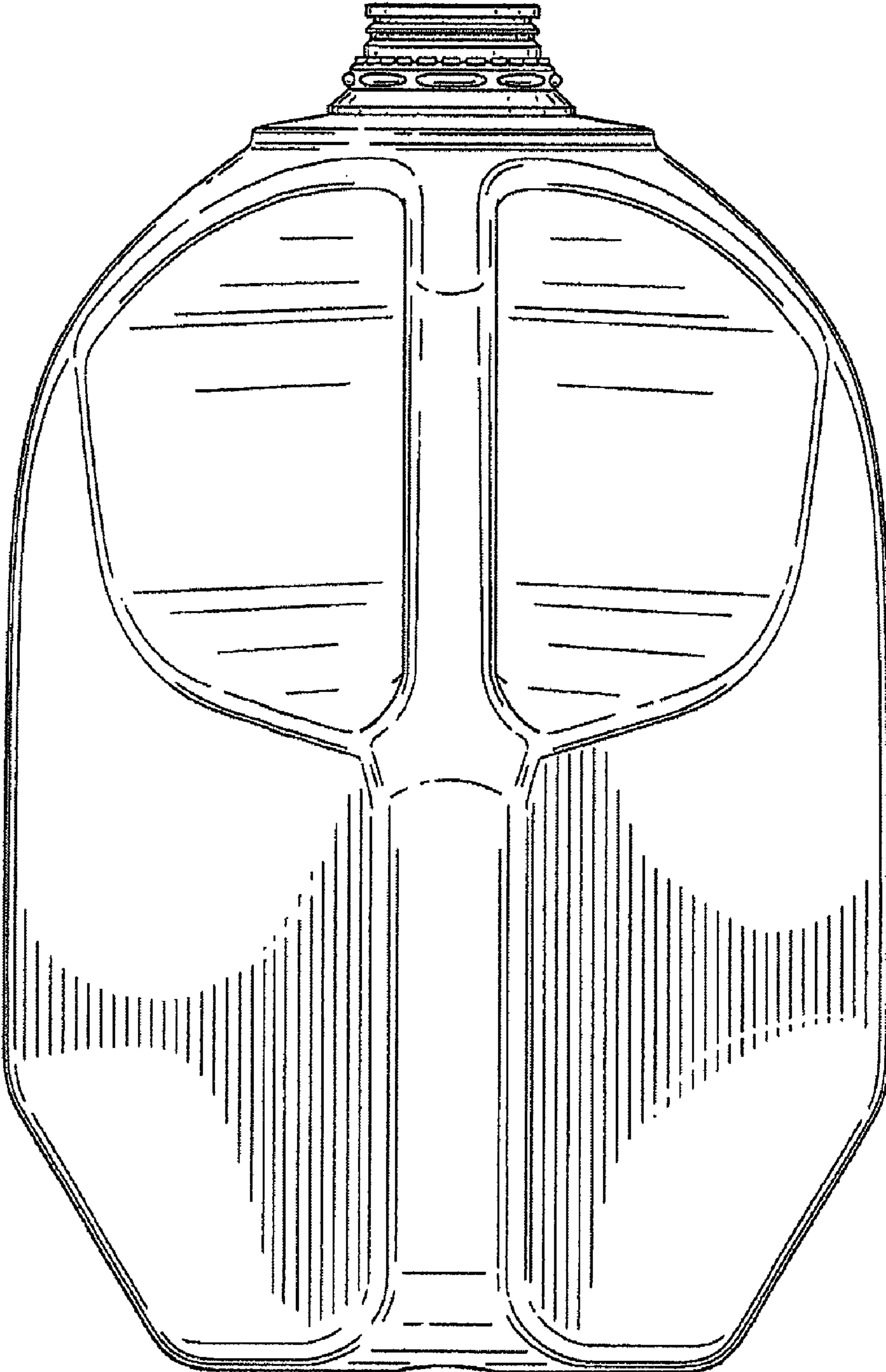
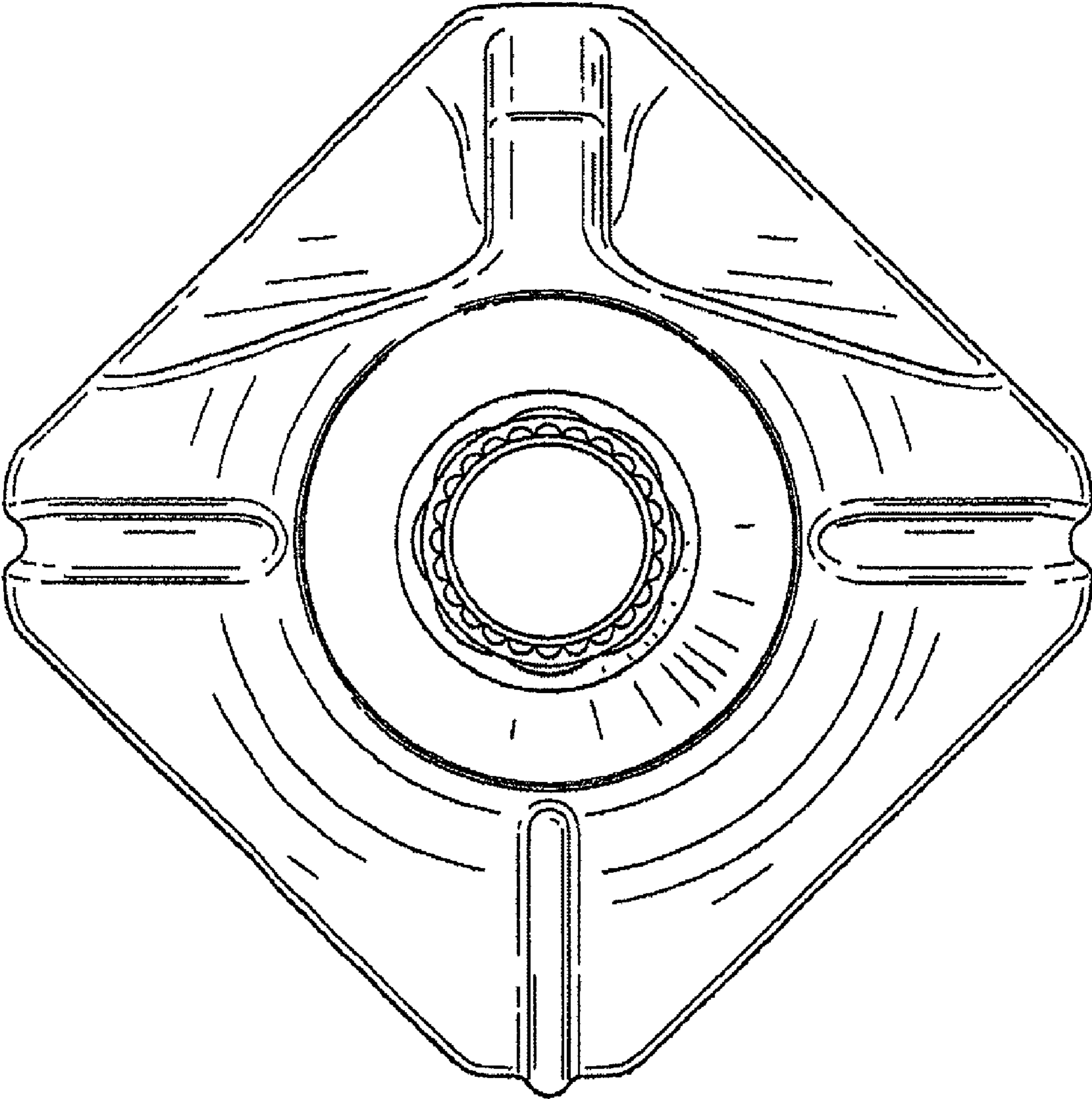
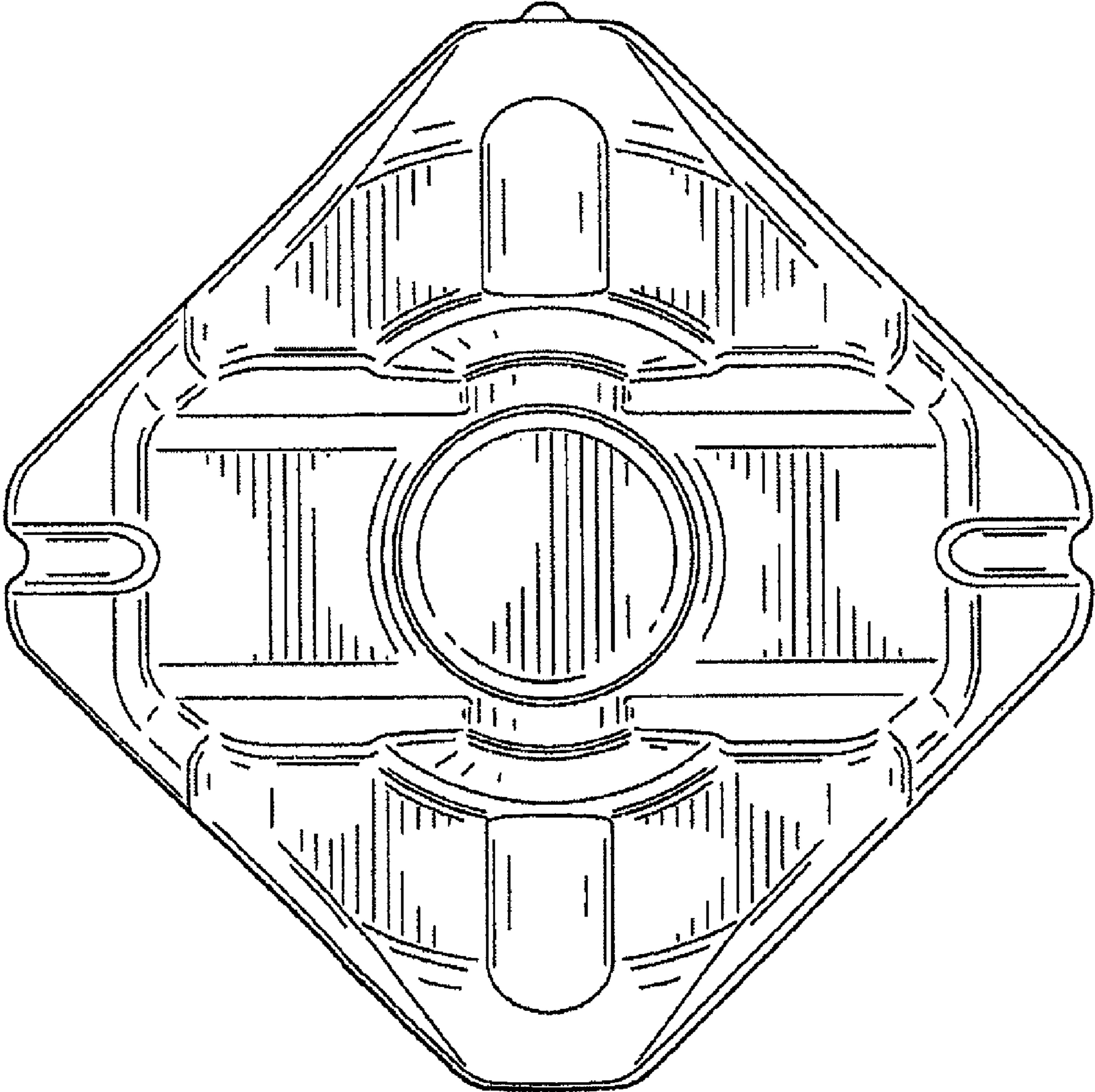
