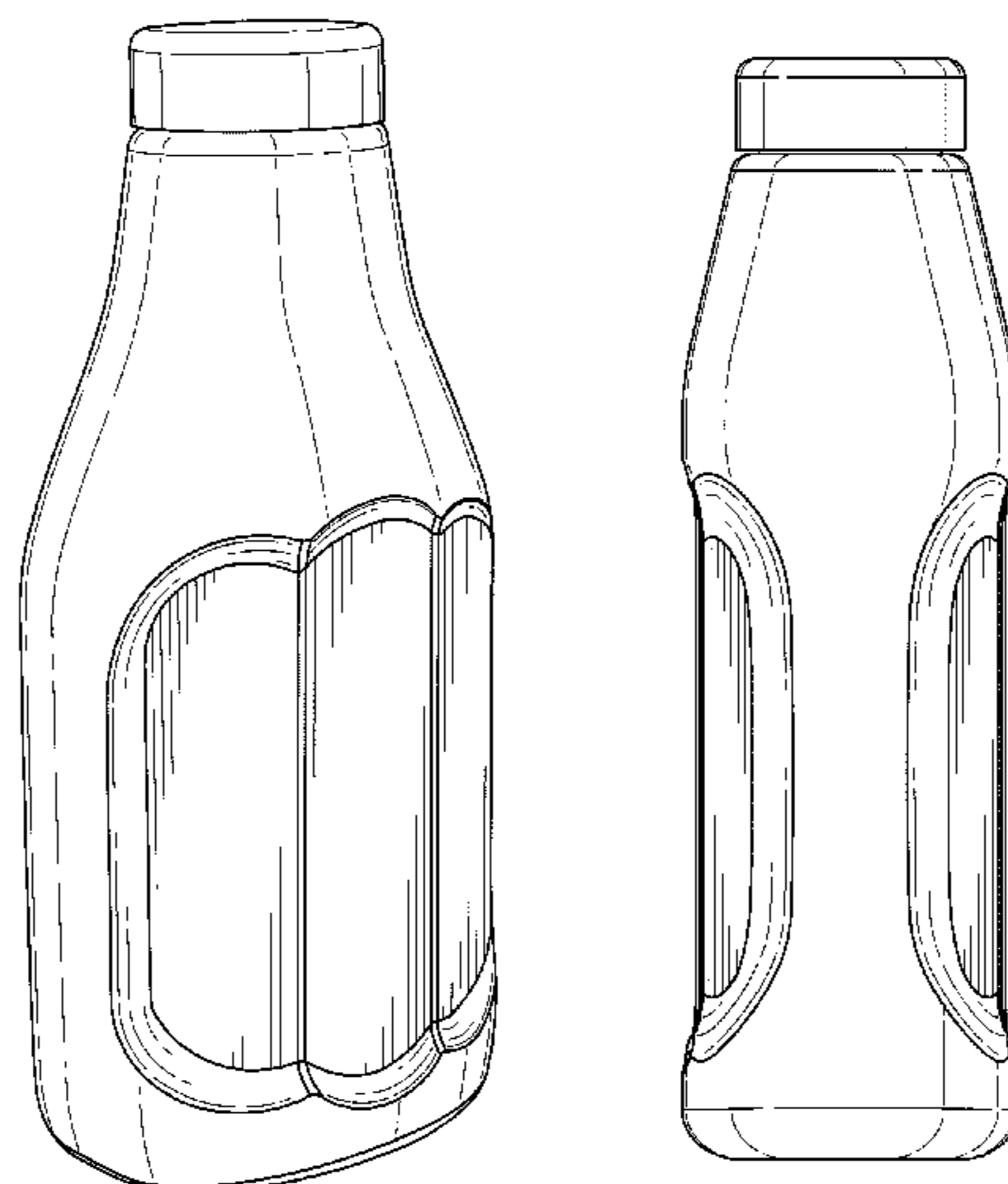
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a container showing our new design; FIG. 2 is a rear elevational view thereof, the front elevational view being identical; FIG. 3 is a right side elevational view thereof, the left side elevational view being identical; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The broken lines showing the central portion of the bottom surface in the drawings are for the purpose of illustrating environmental structure and form no part of the claimed design.

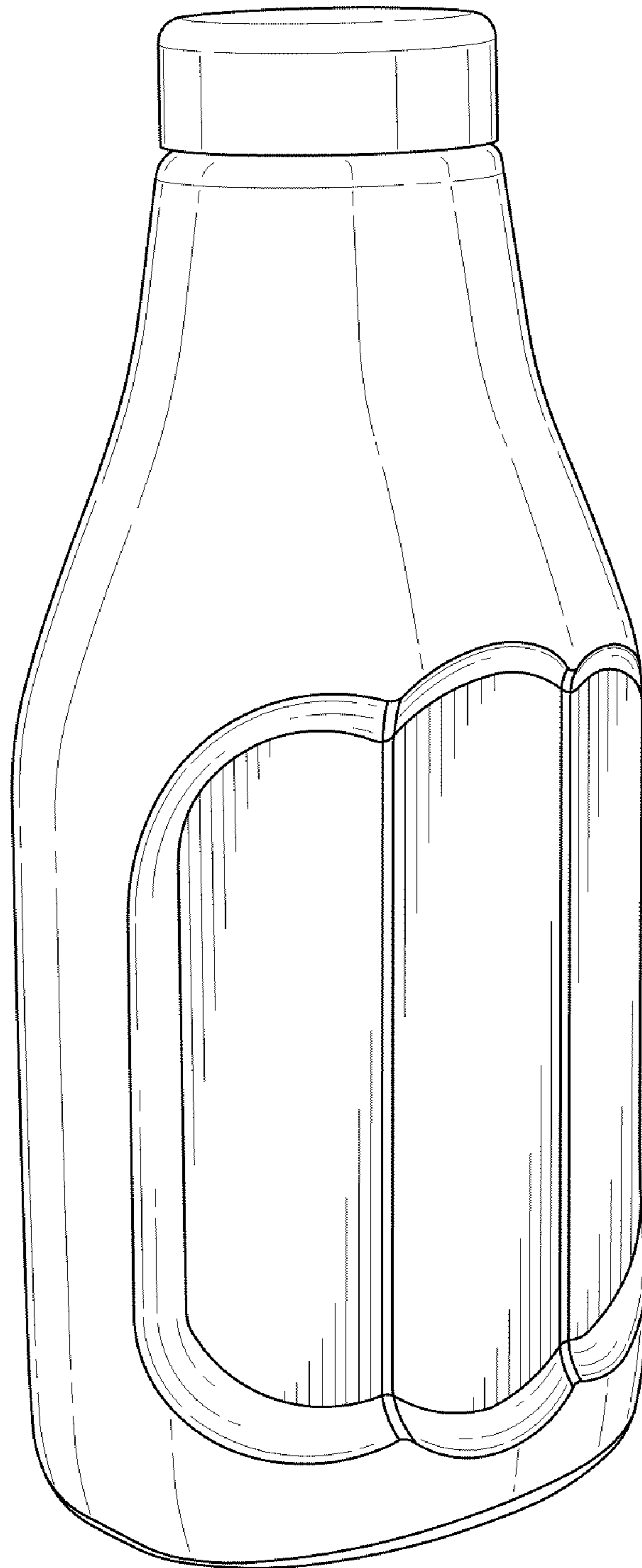

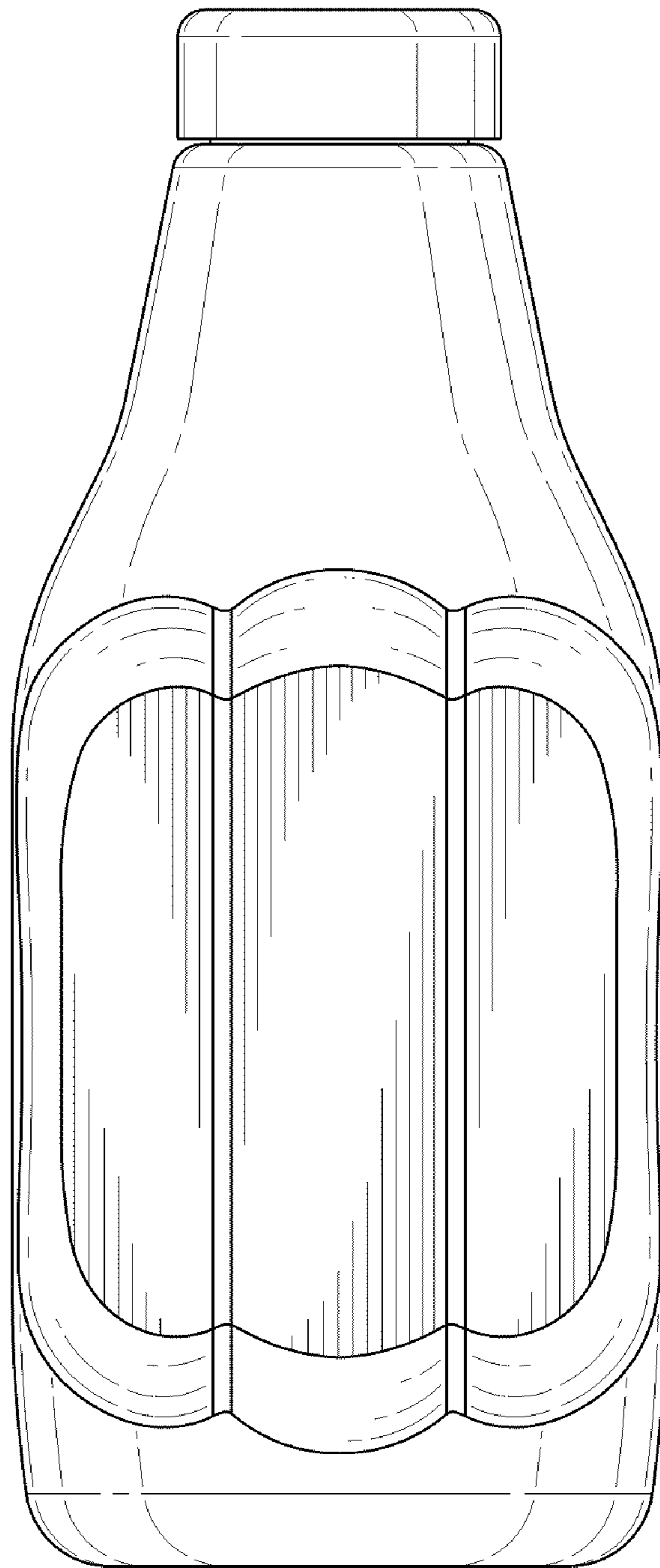

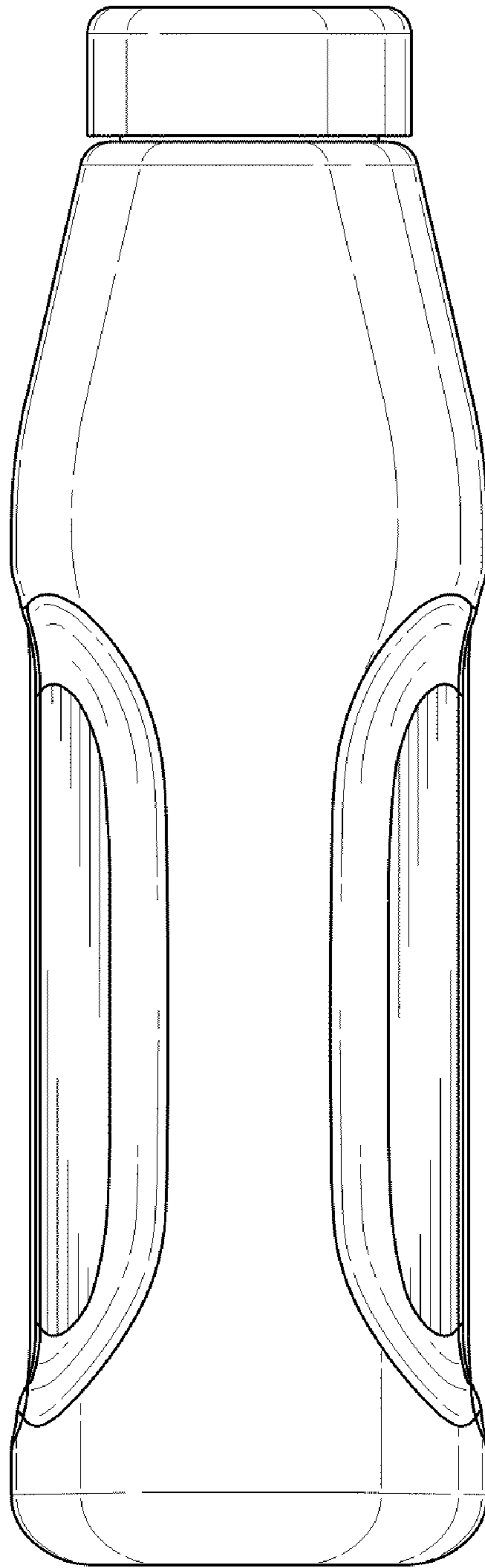

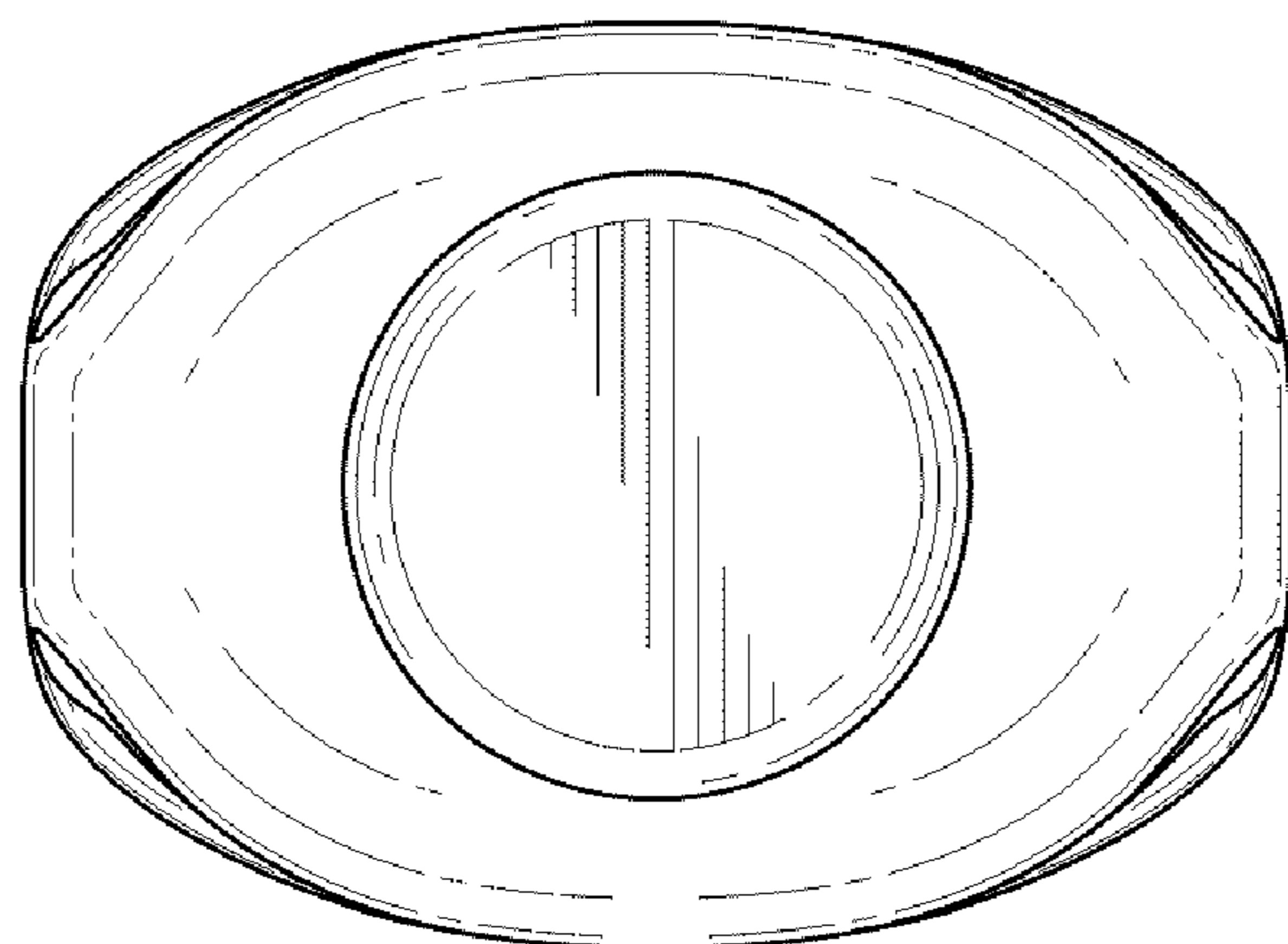

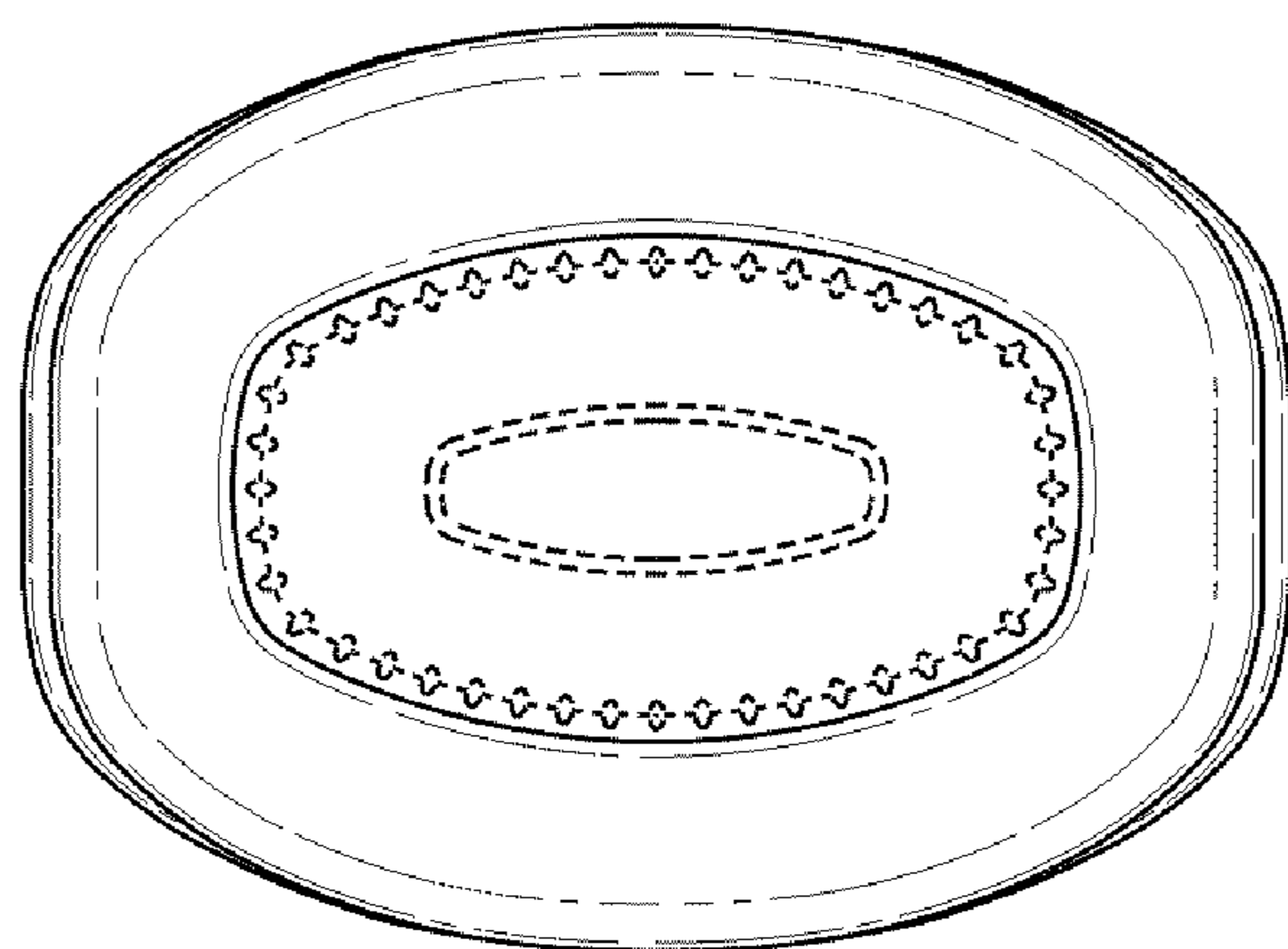
