DESCRIPTION

FIG. 1 is a front elevated view of a planter assembly showing my new design;

FIG. 2 is a rear elevated view of the planter assembly;

FIG. 3 is a right side elevated view of the planter assembly;

FIG. 4 is a left side elevated view of the planter assembly;

FIG. 5 is a top plan view of the planter assembly;

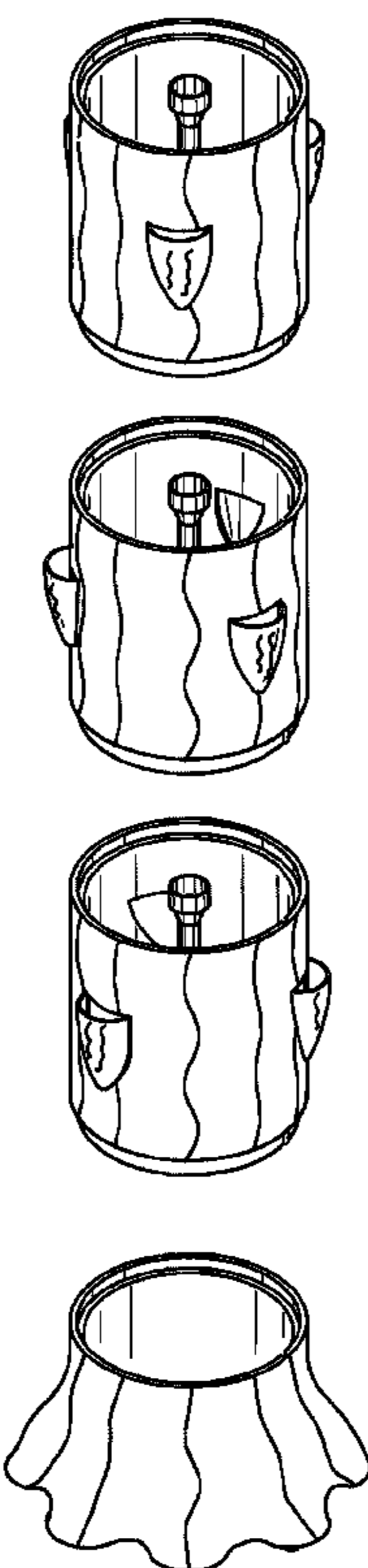
FIG. 6 is a bottom plan elevated view of the planter assembly;

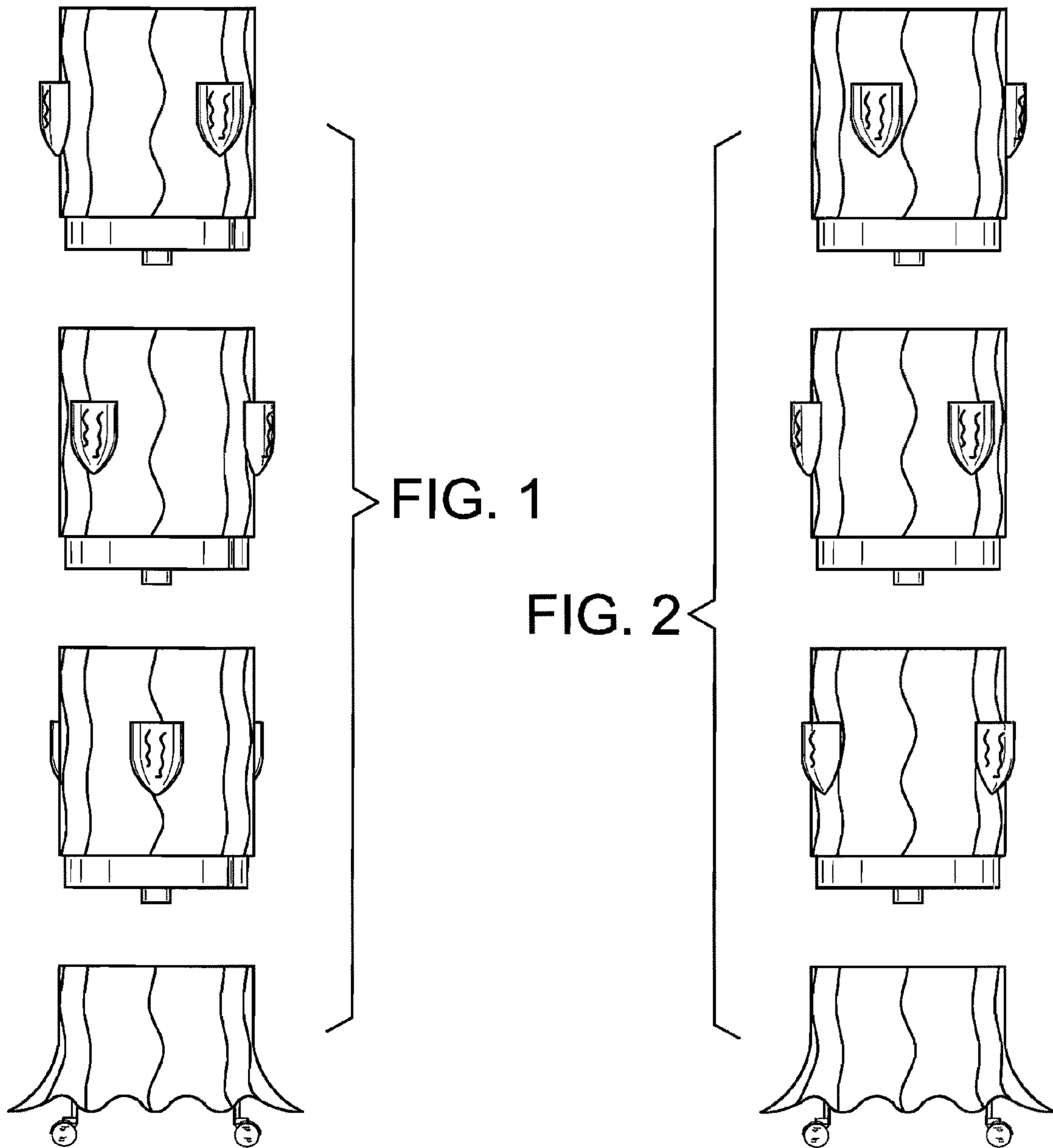
FIG. 7 is a top isometric view of the planter assembly; and,

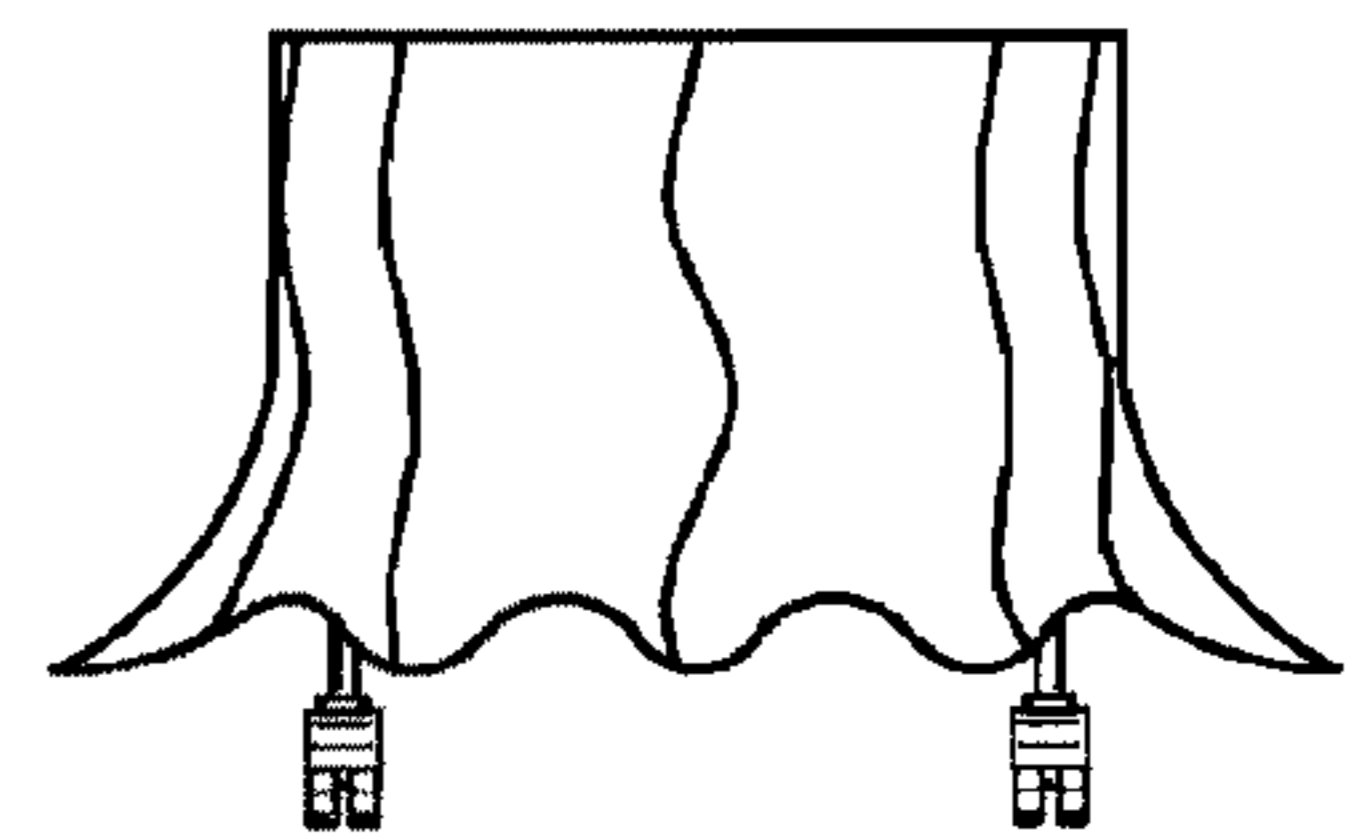
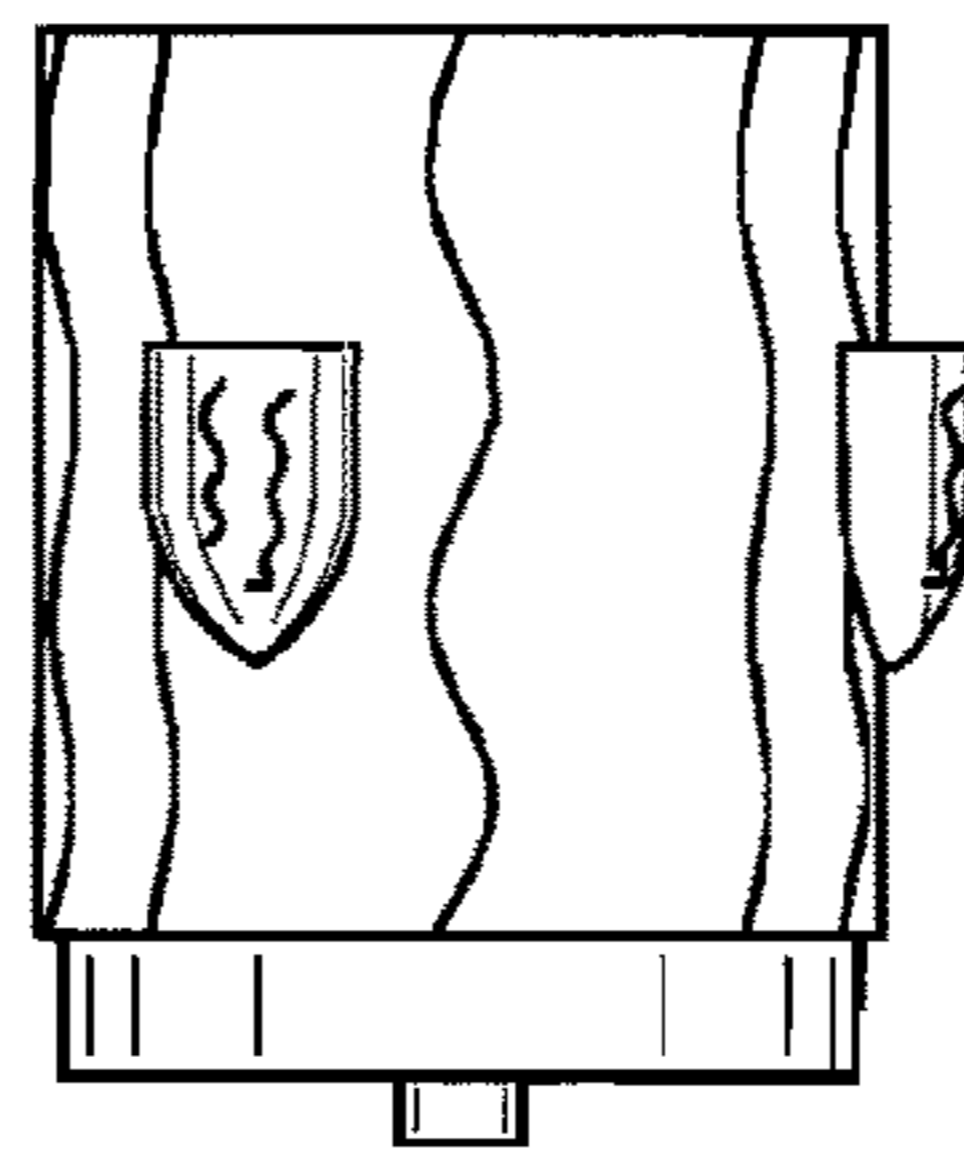
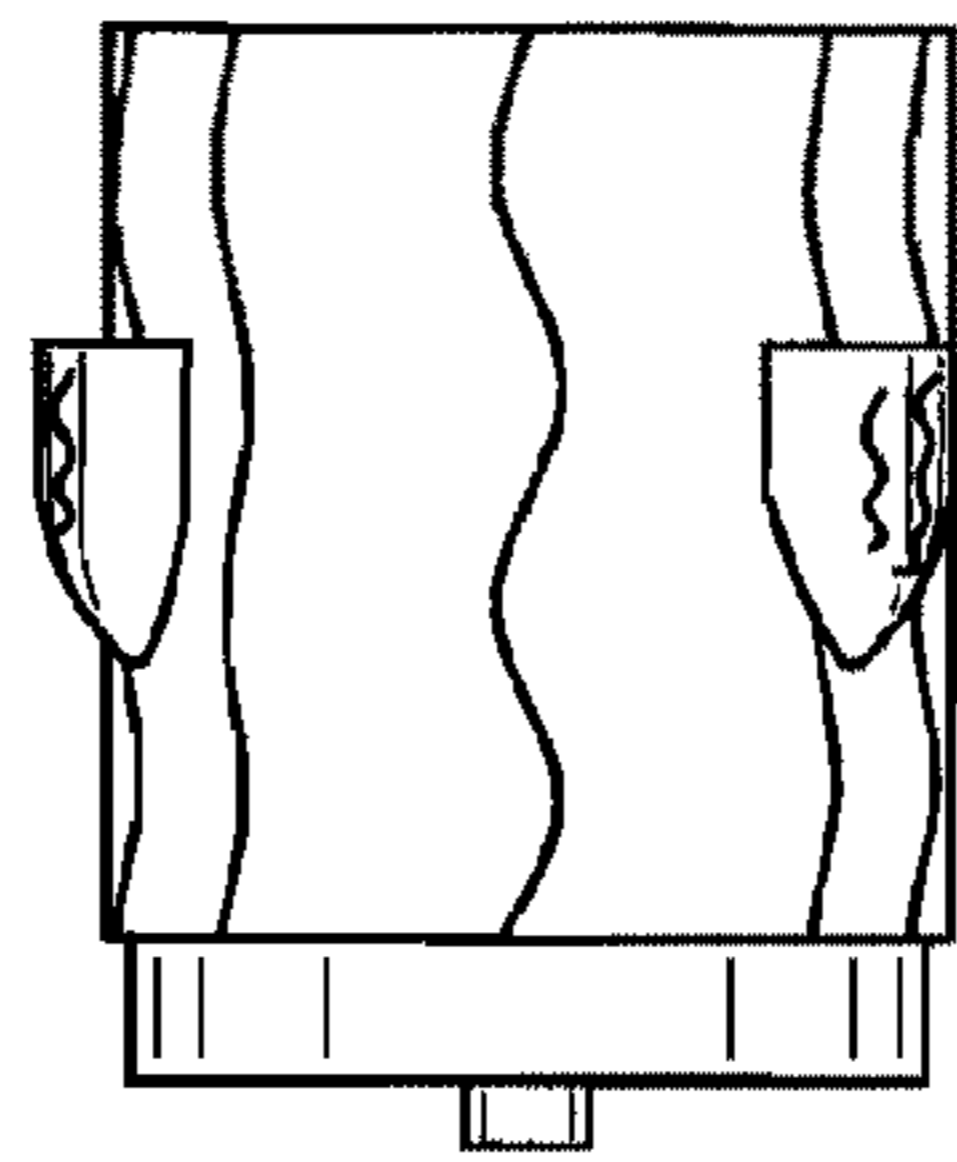
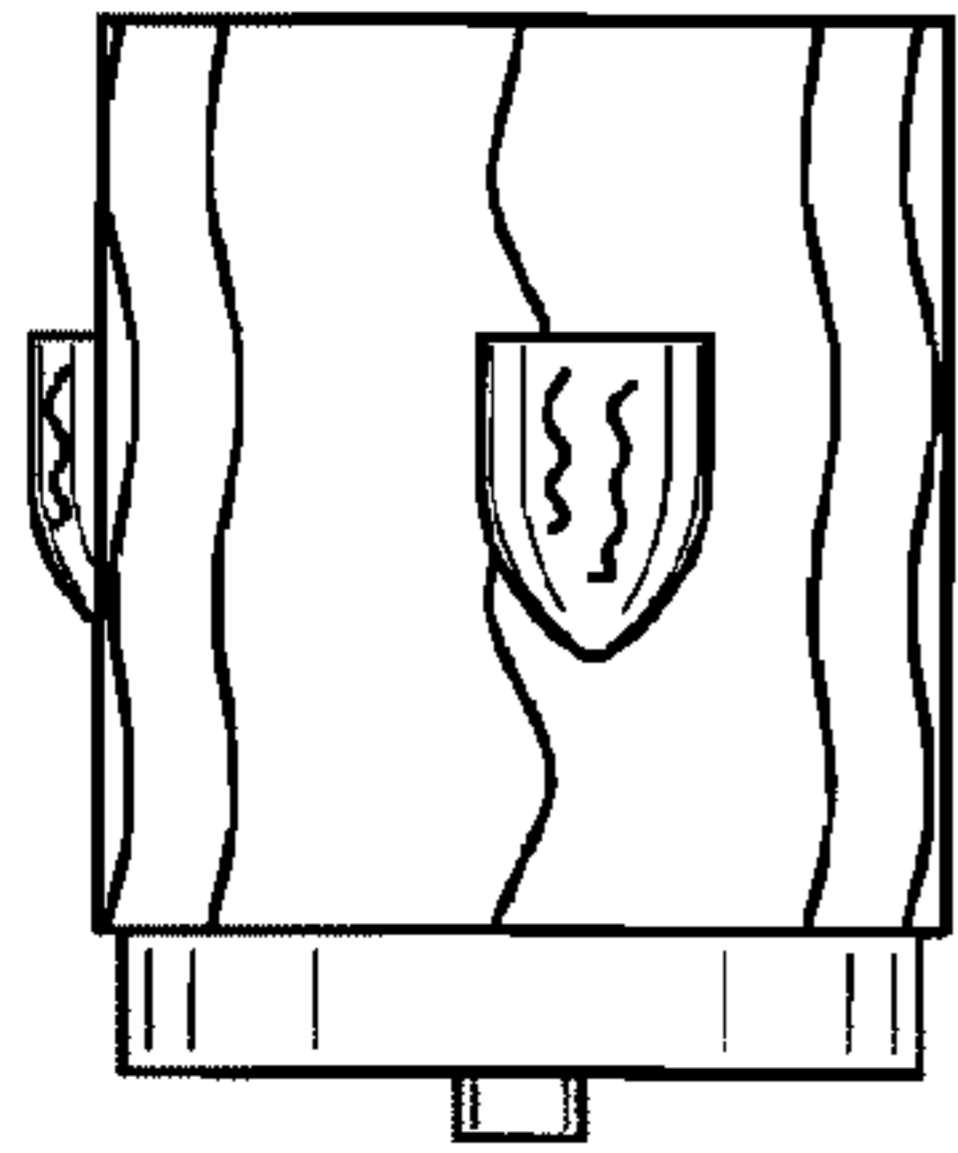
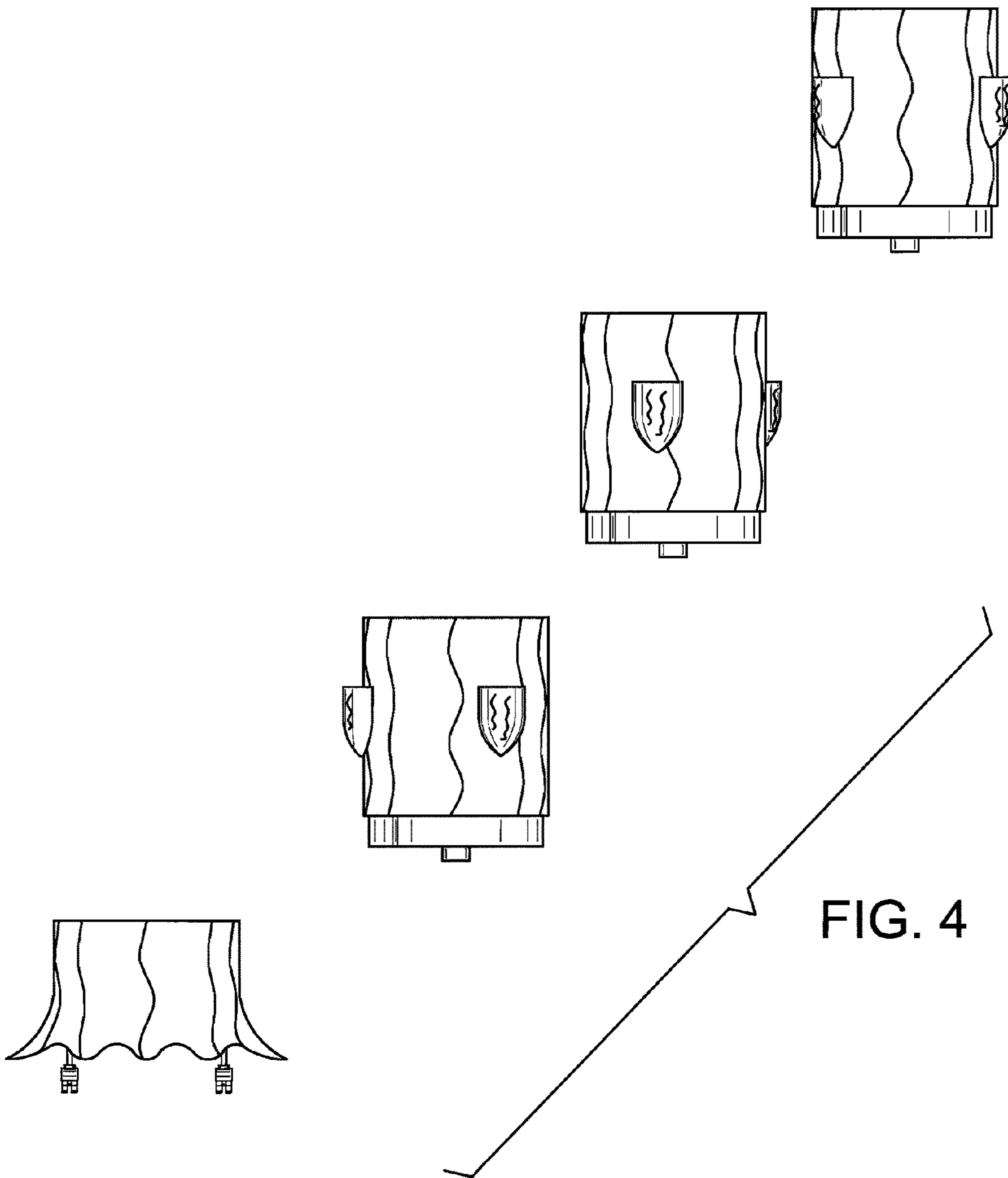

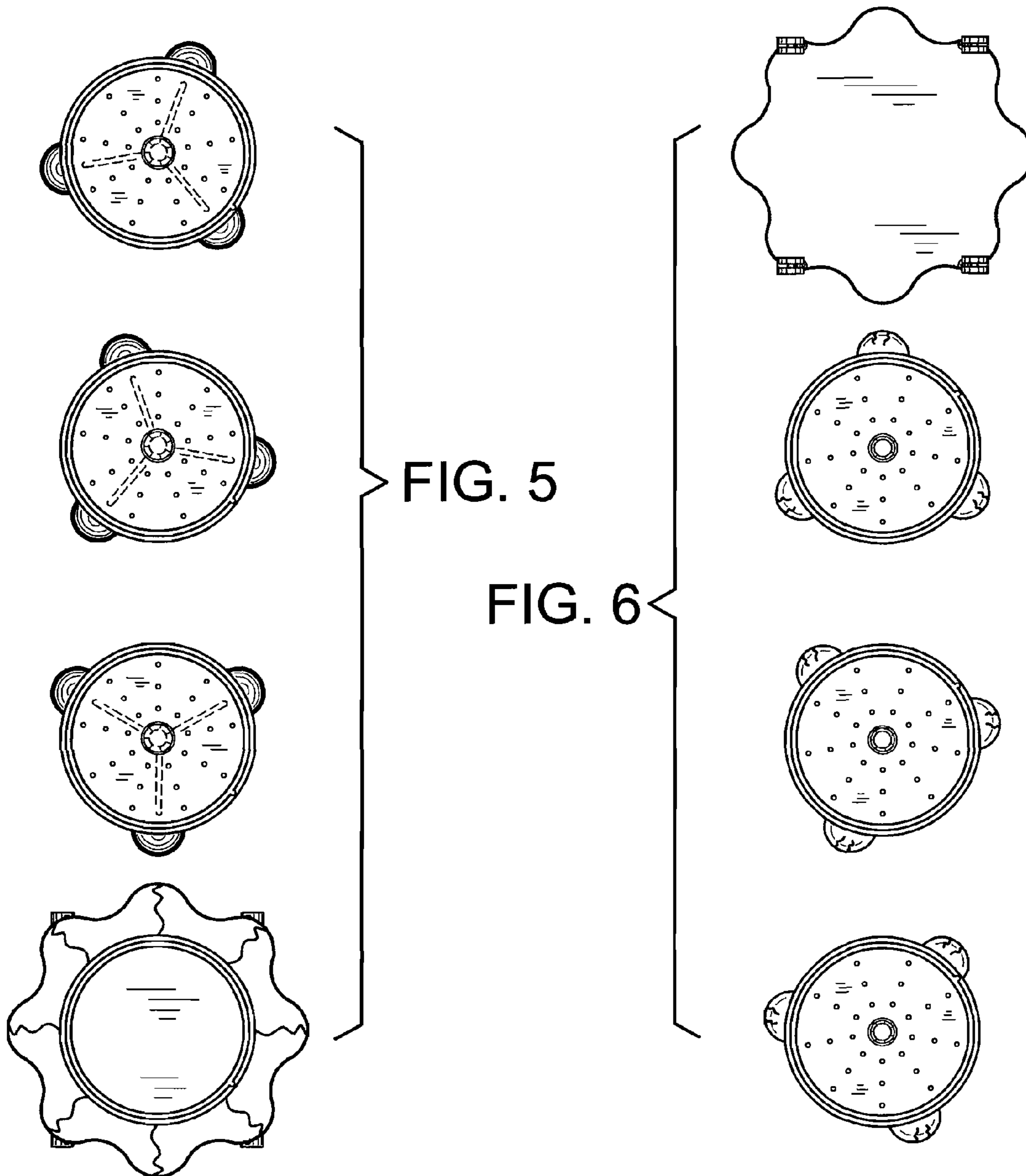

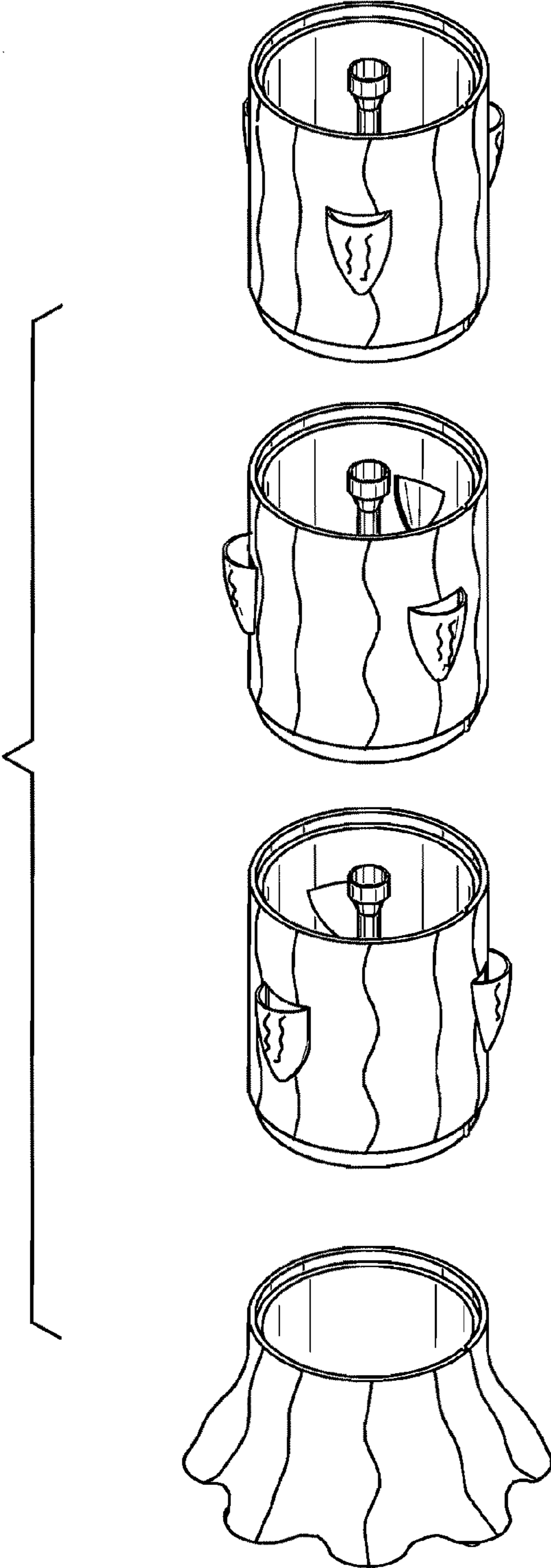
