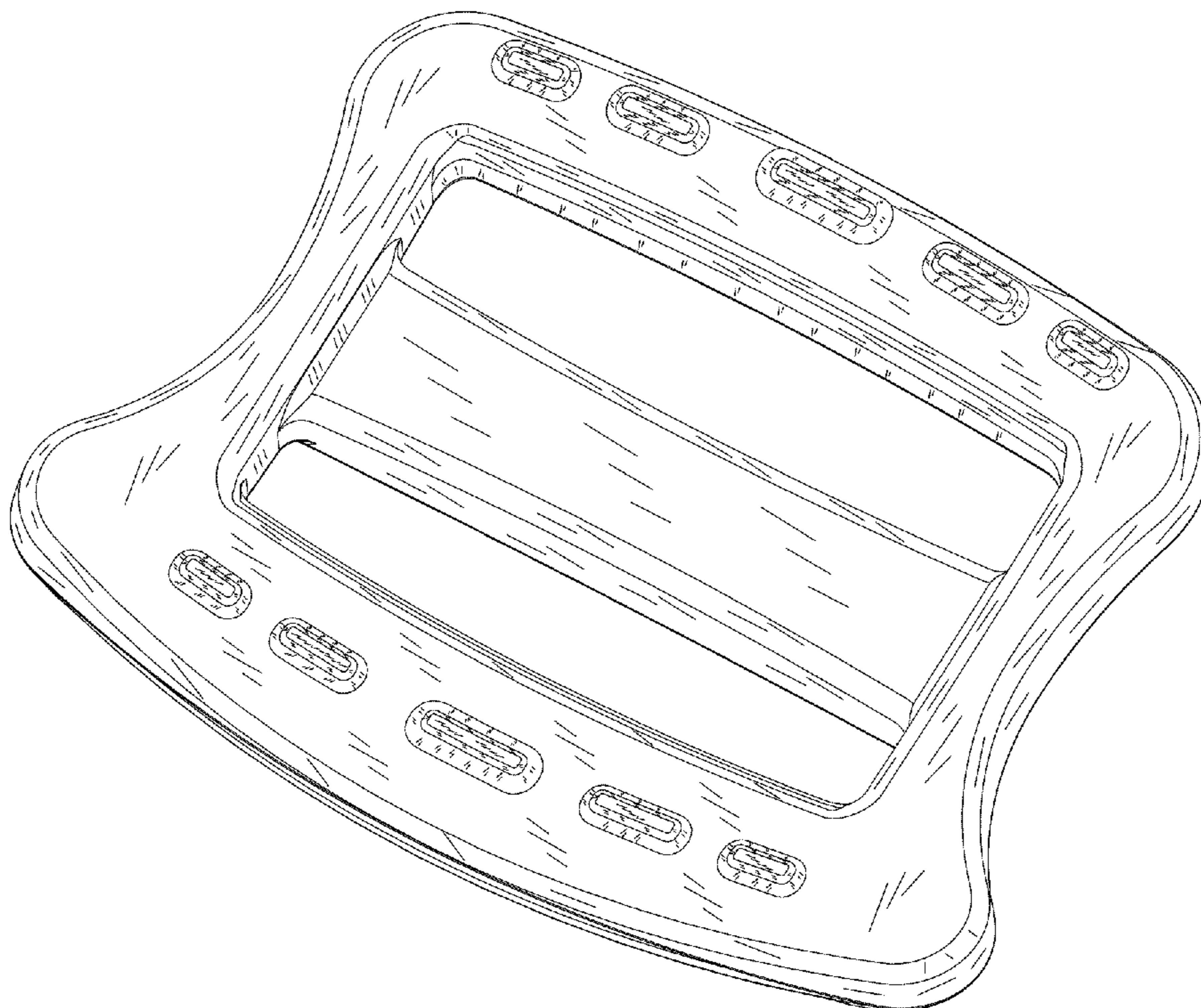
FIG. 1 is a perspective view of a first embodiment of a buckle of our new design;

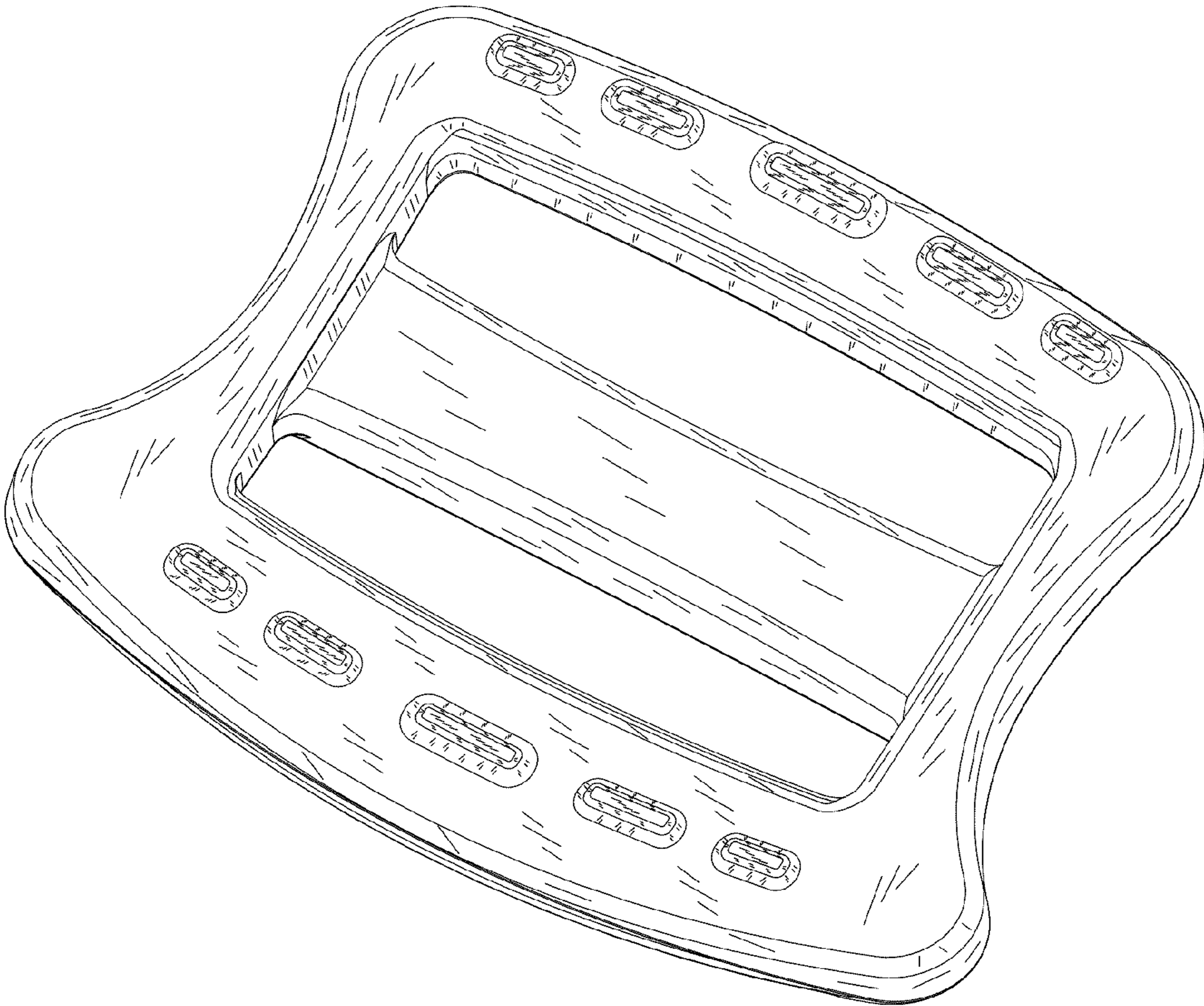

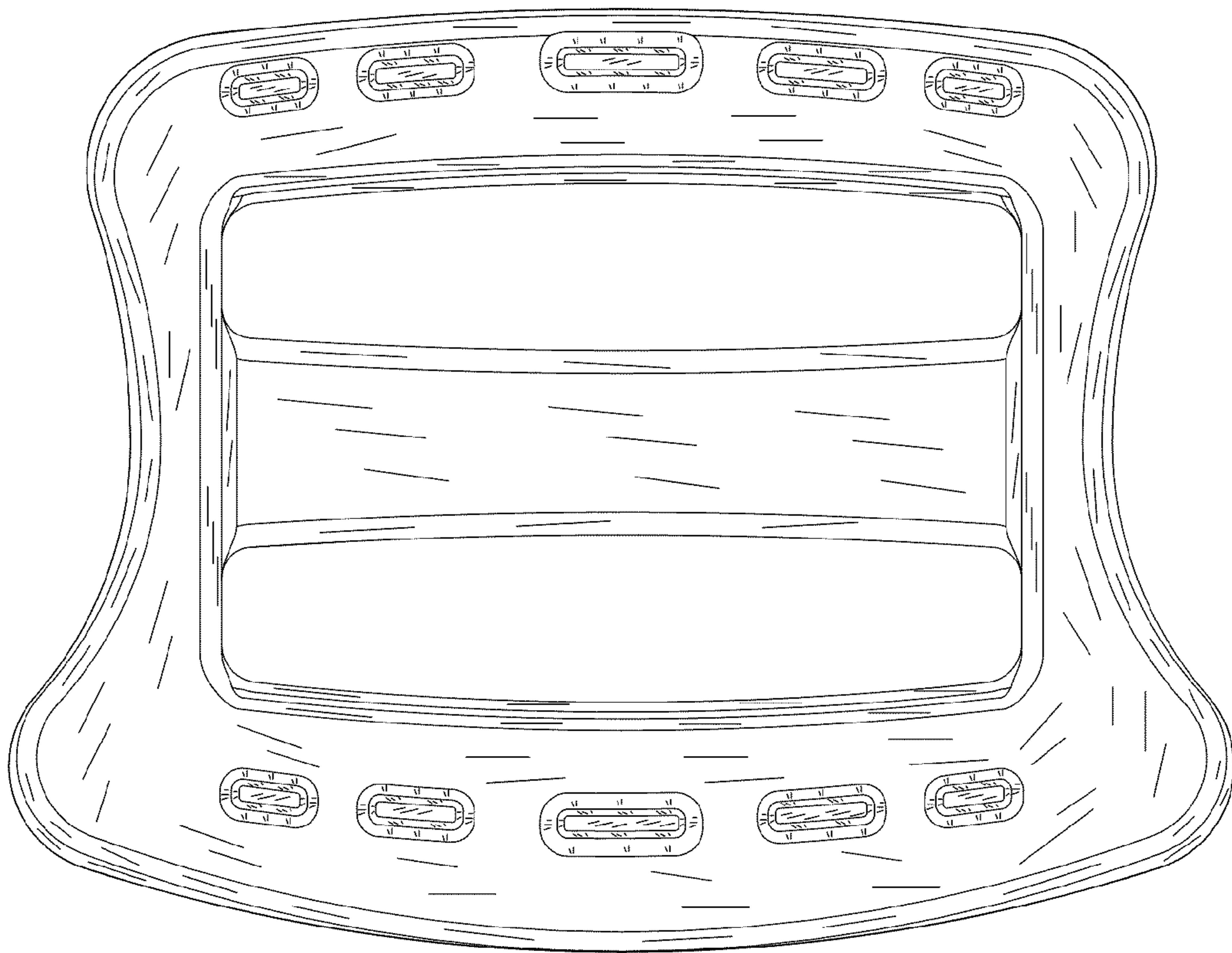

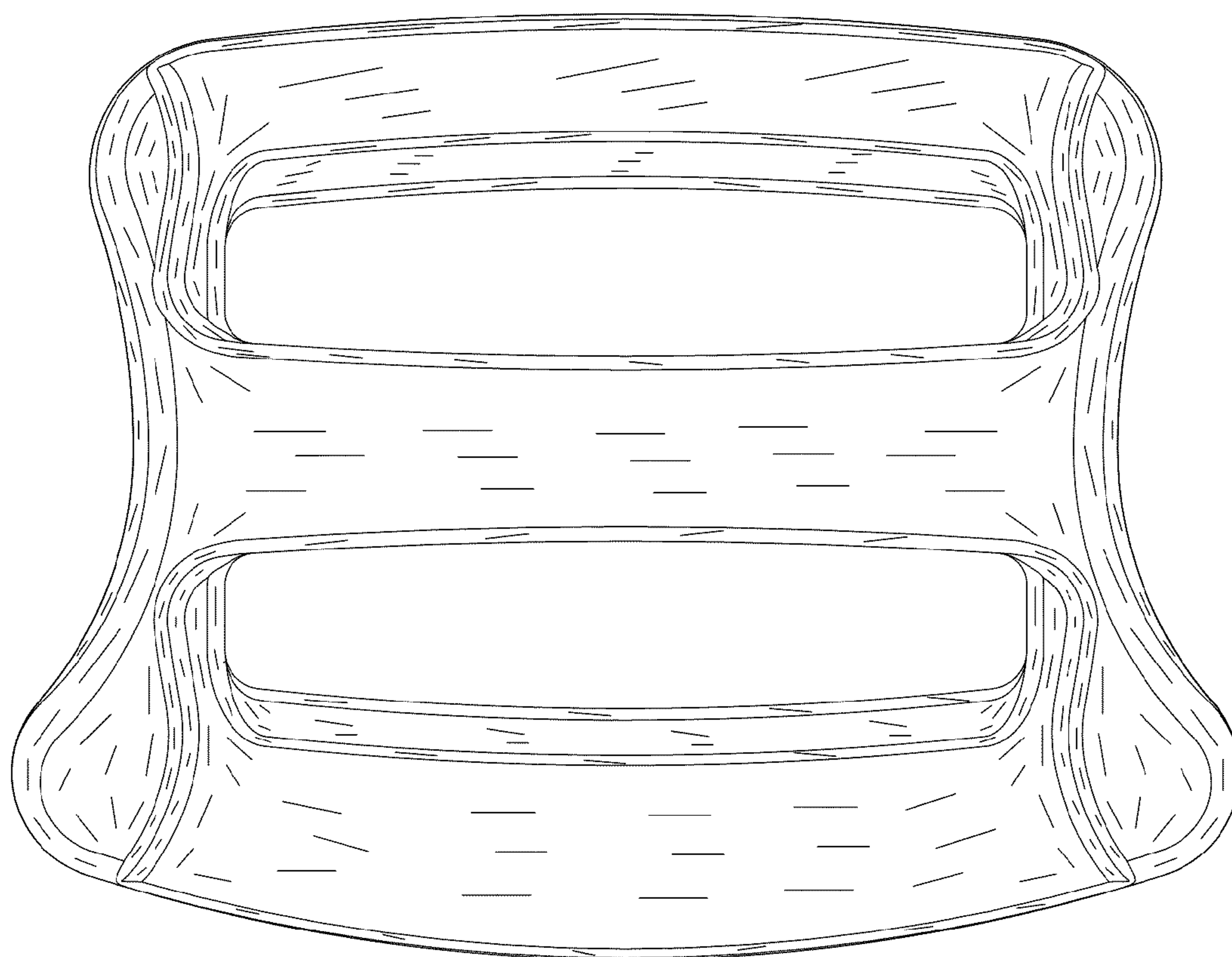

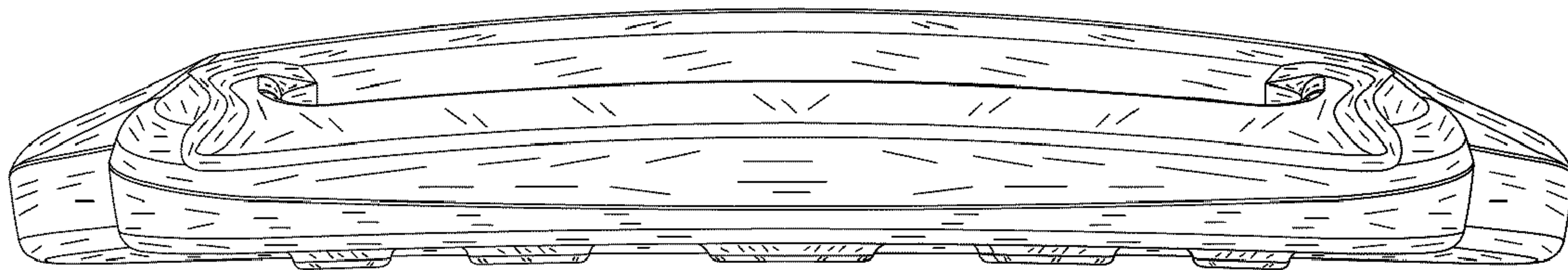

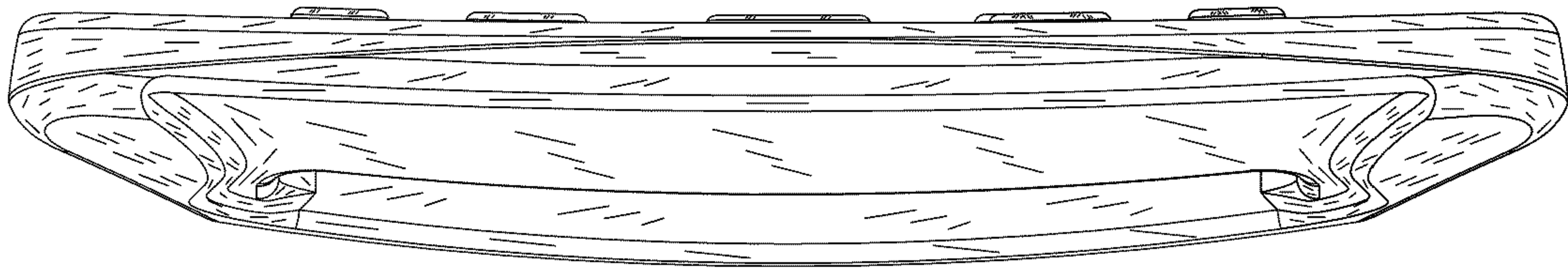

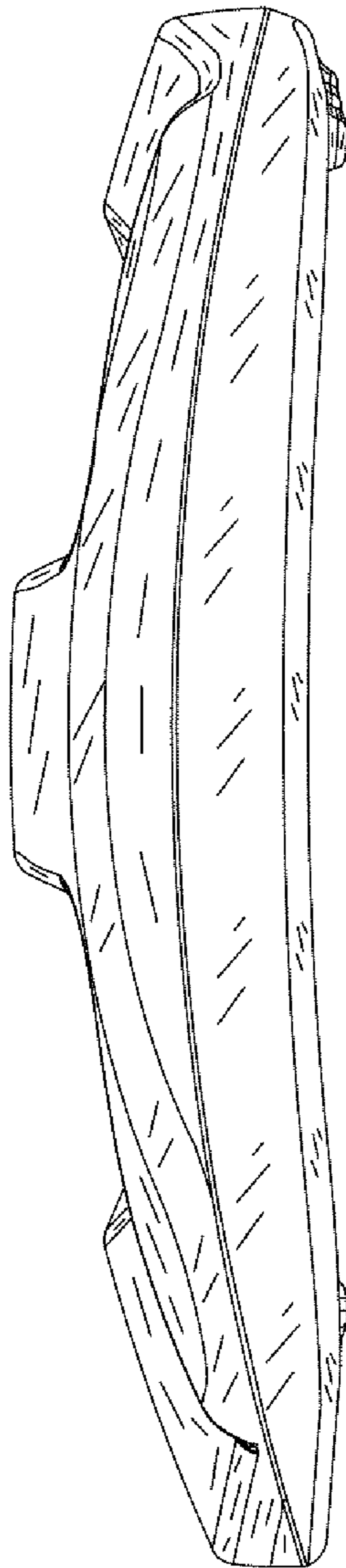

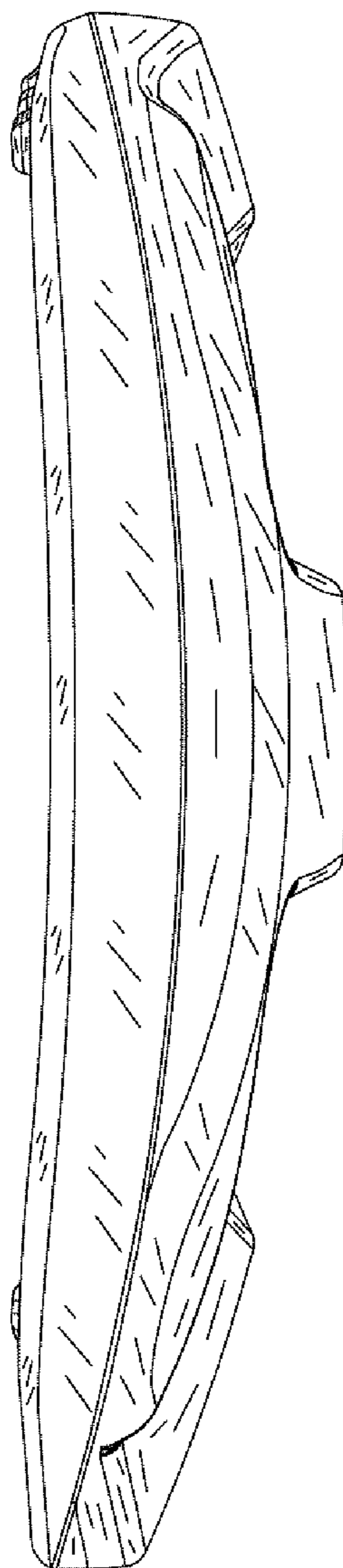

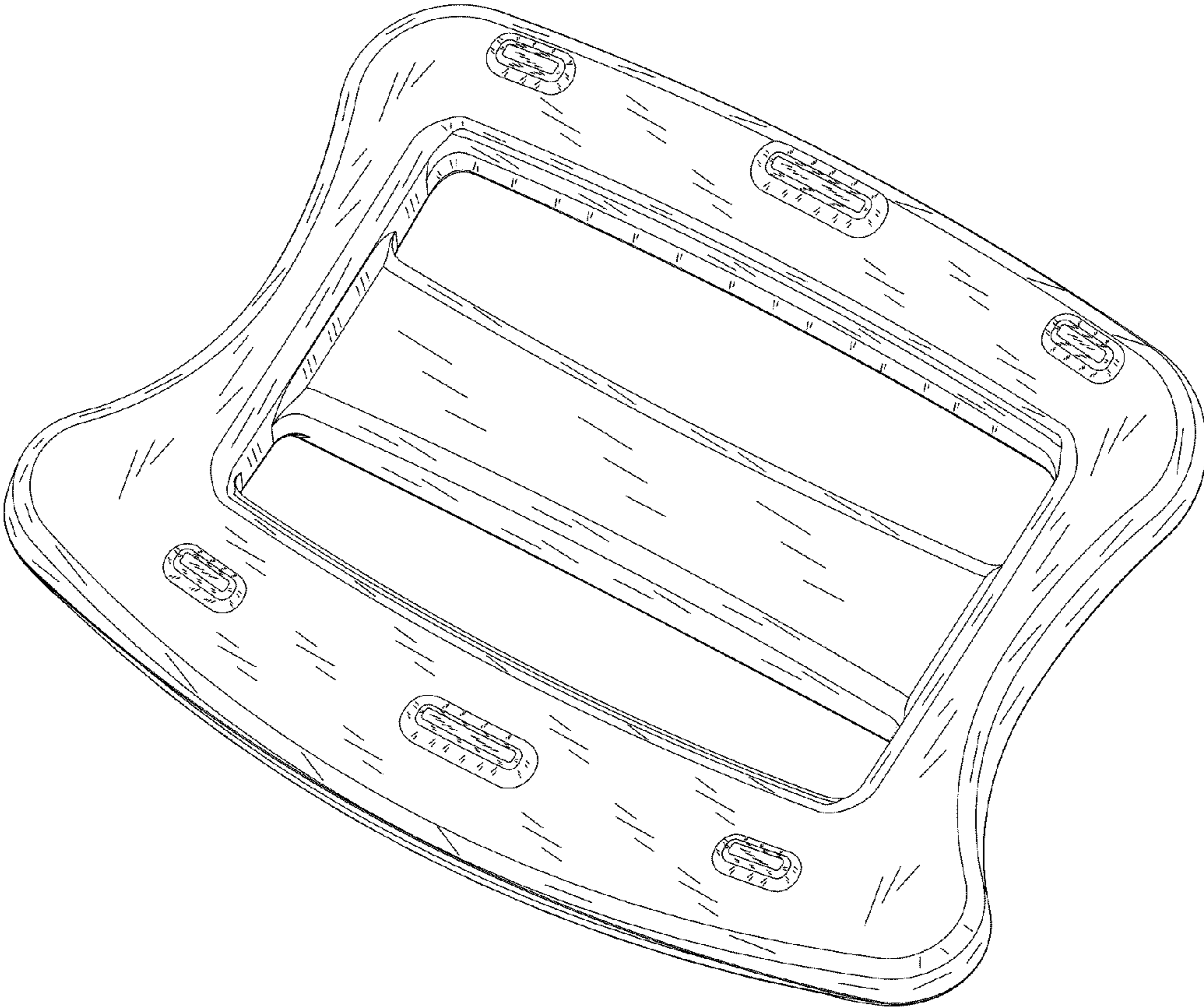

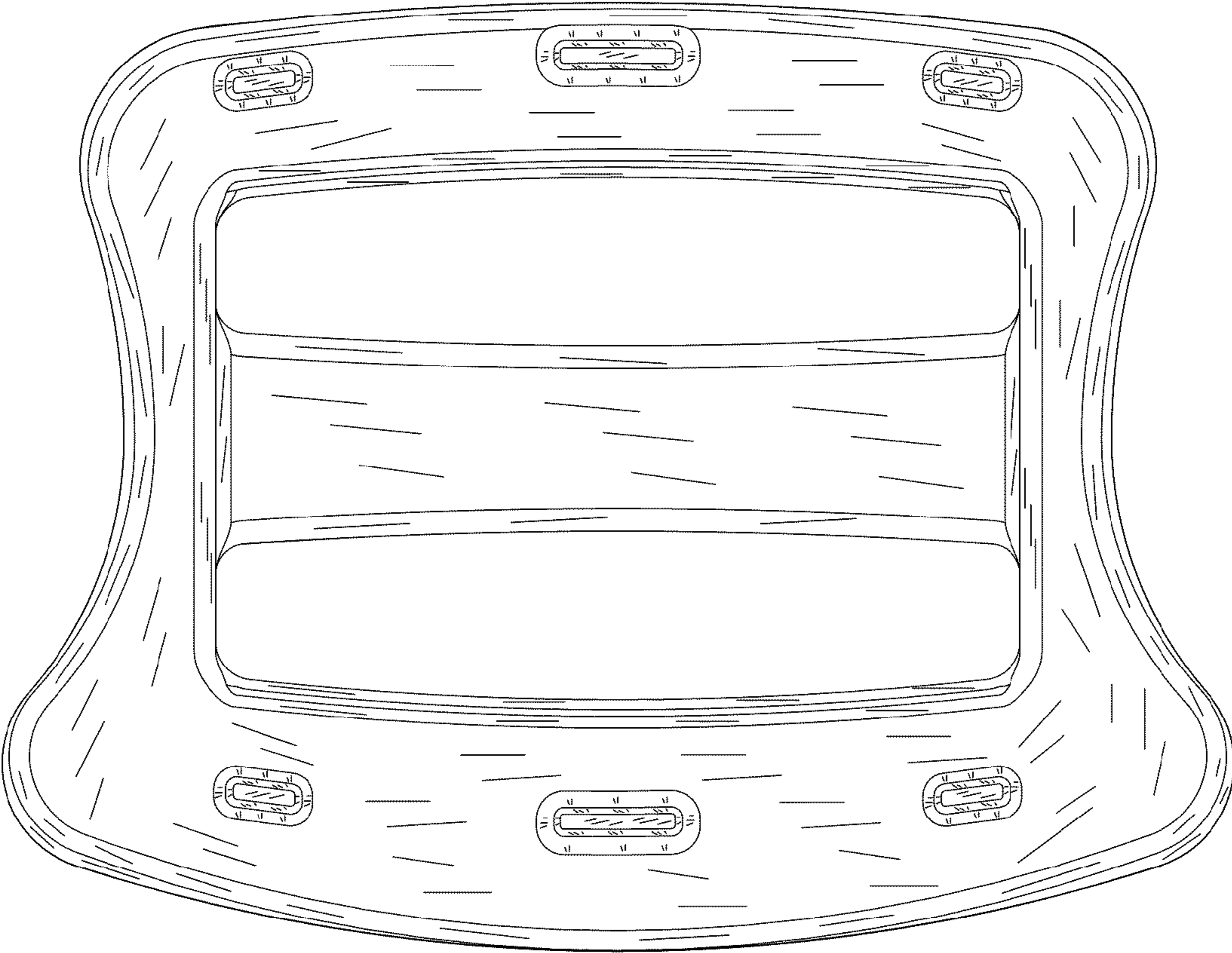

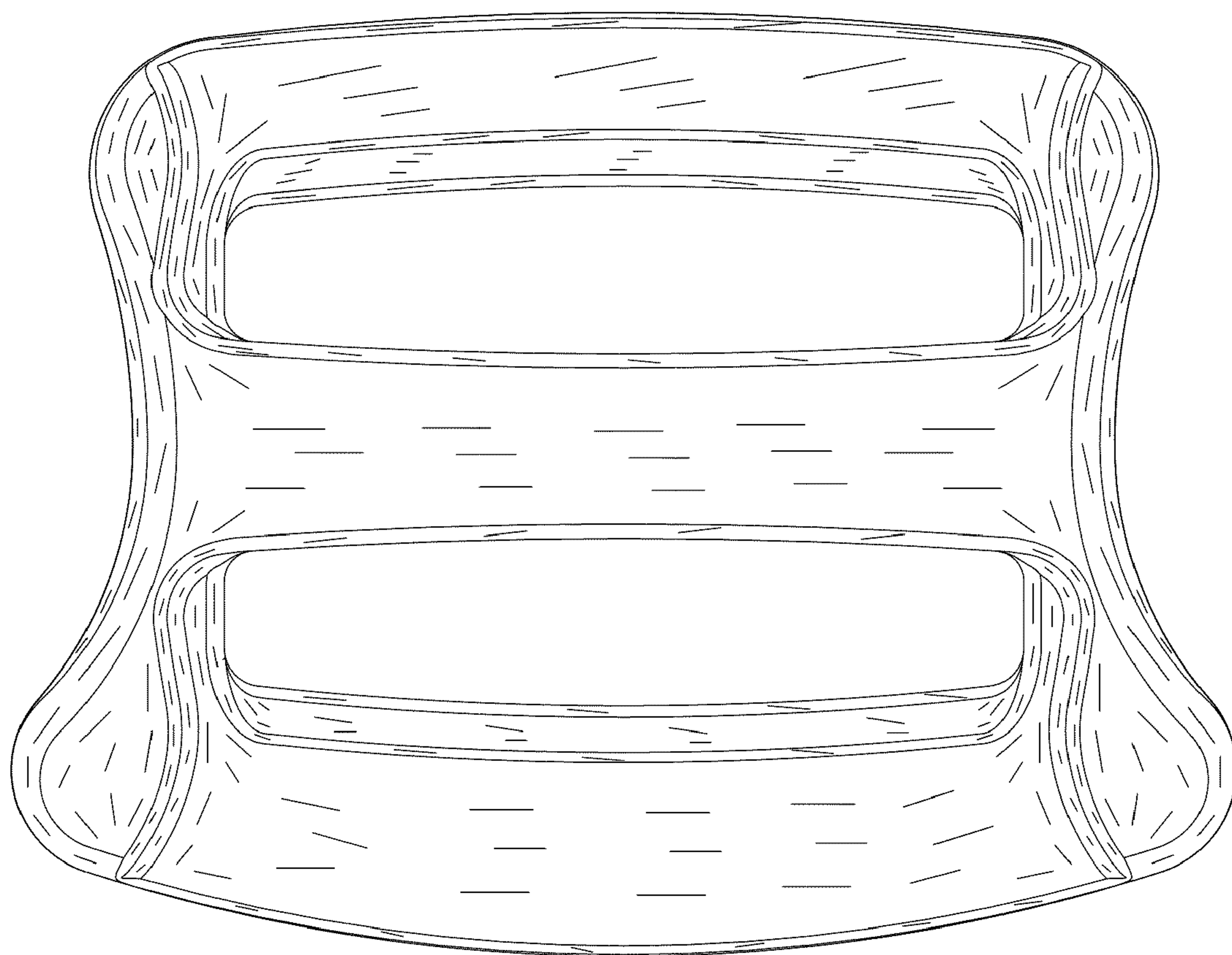

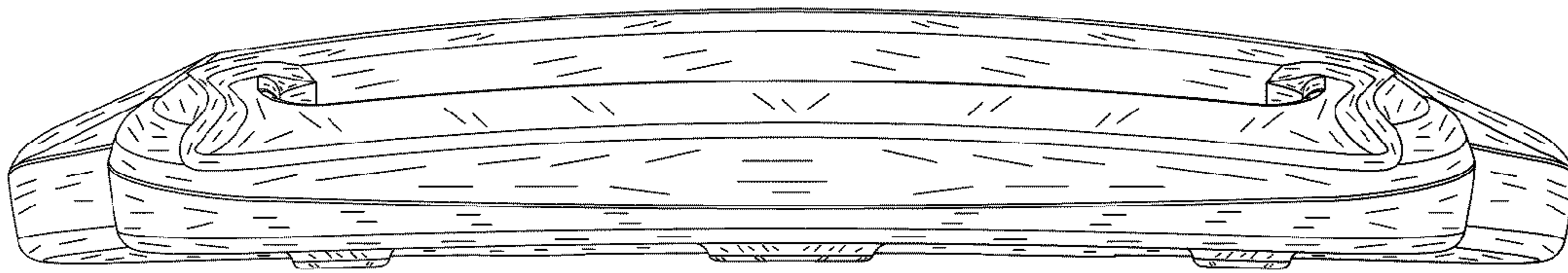

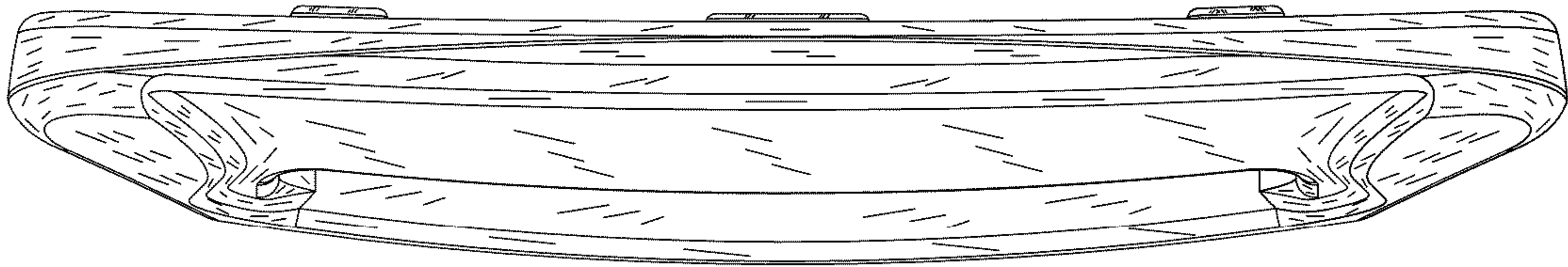

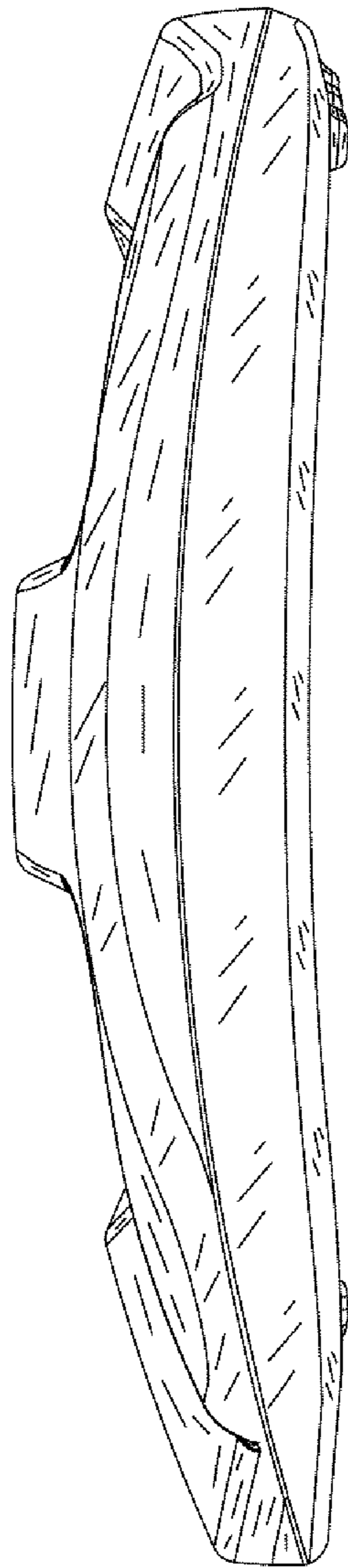

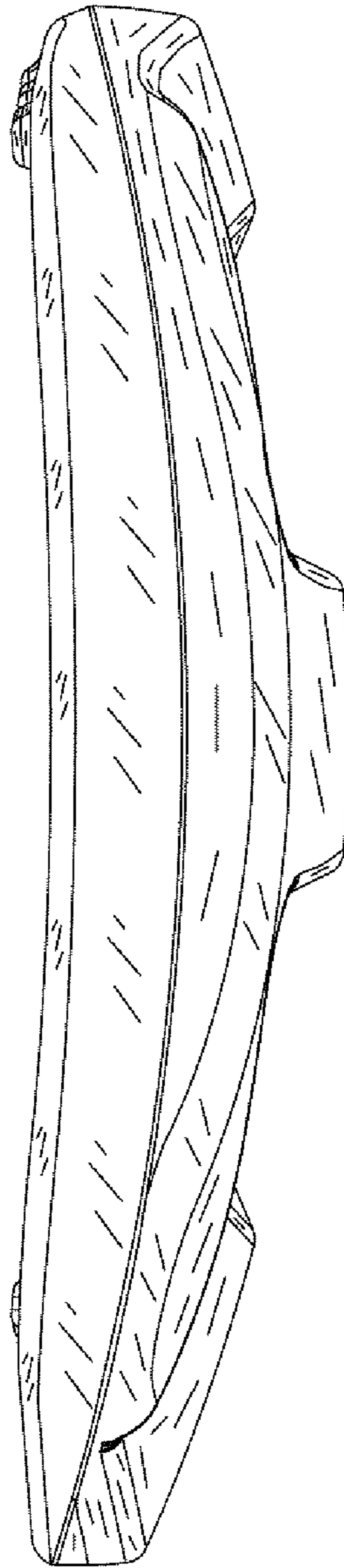
