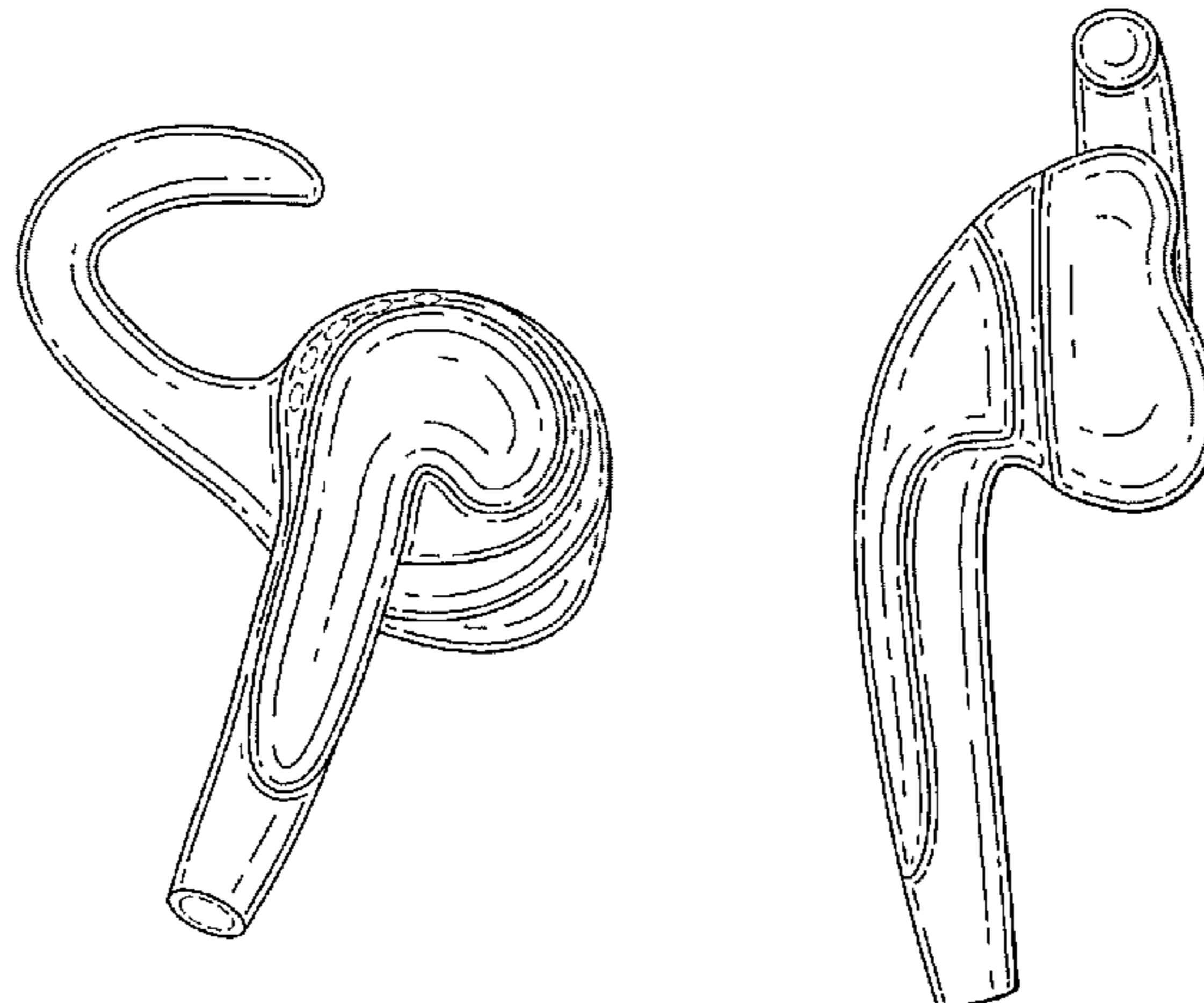
The ornamental design for an ear piece, as shown and described.

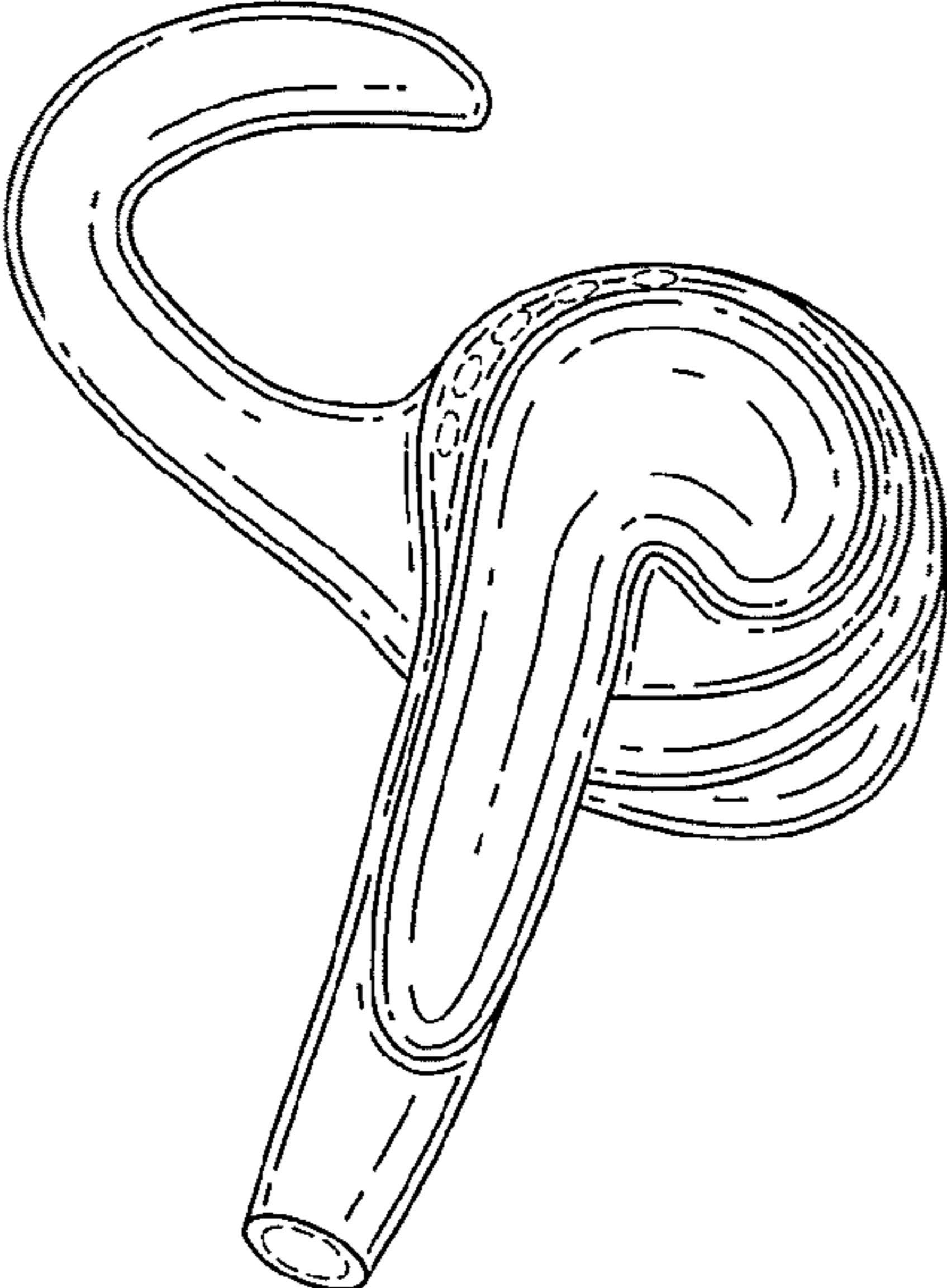

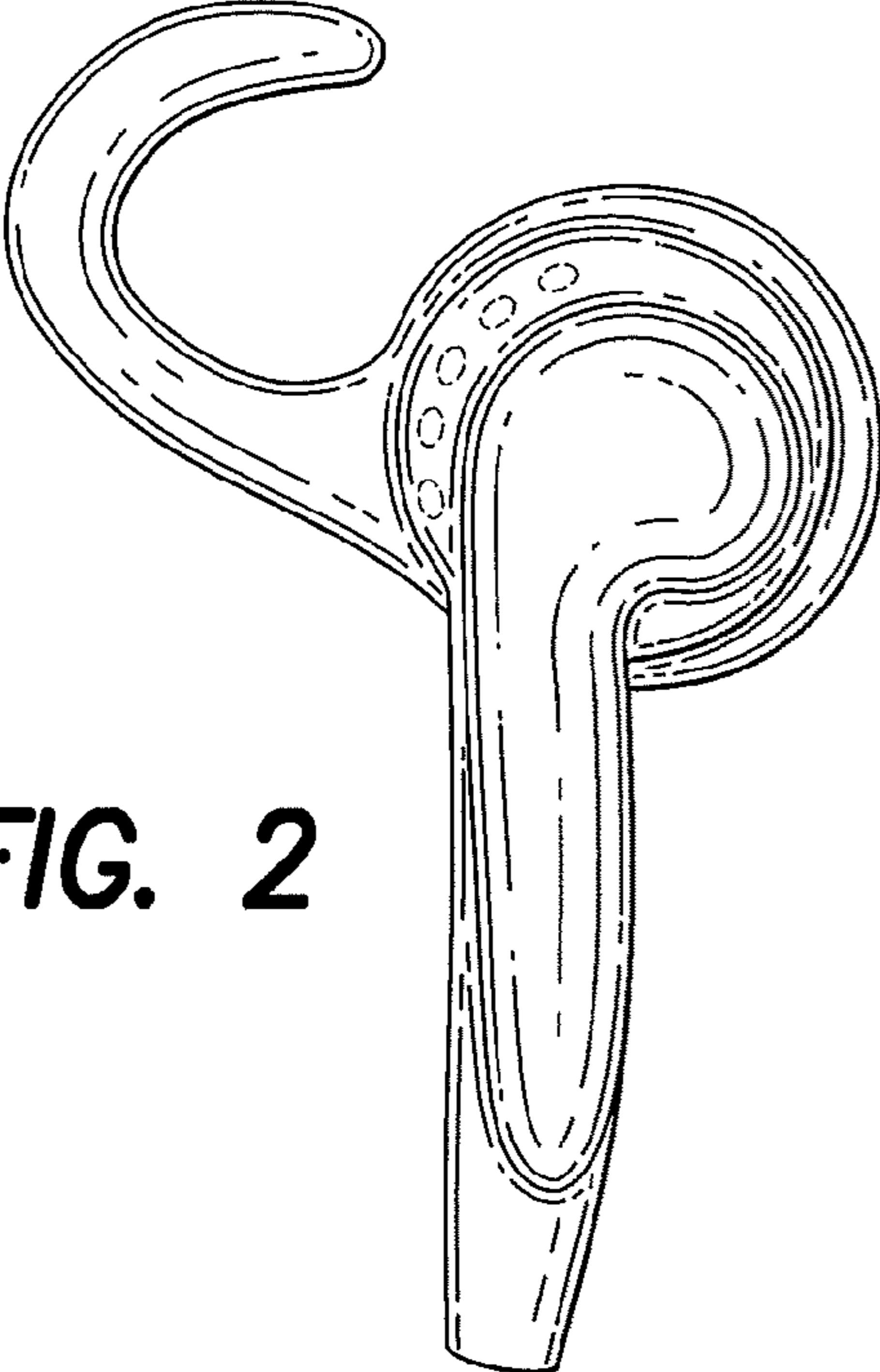

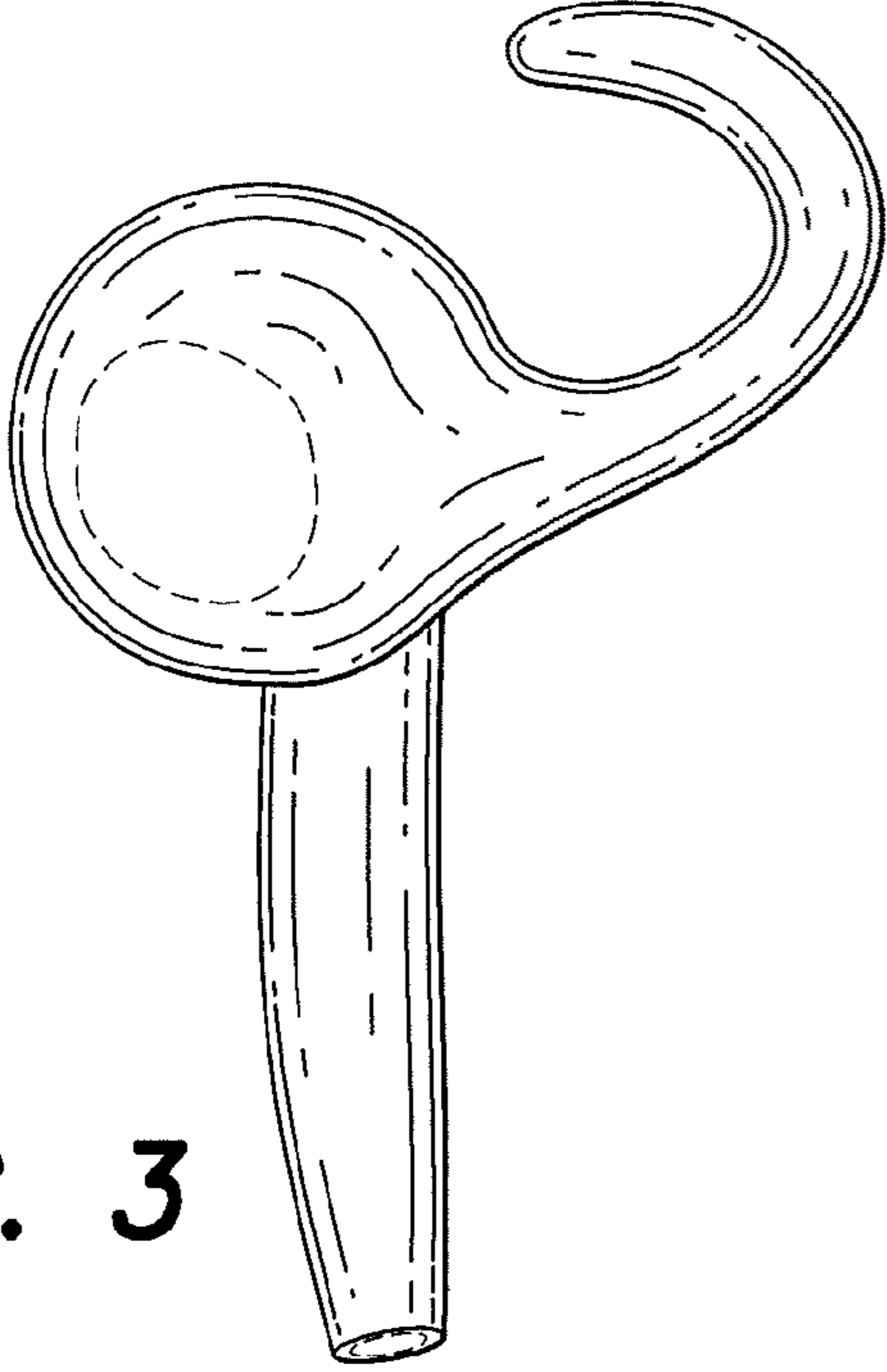

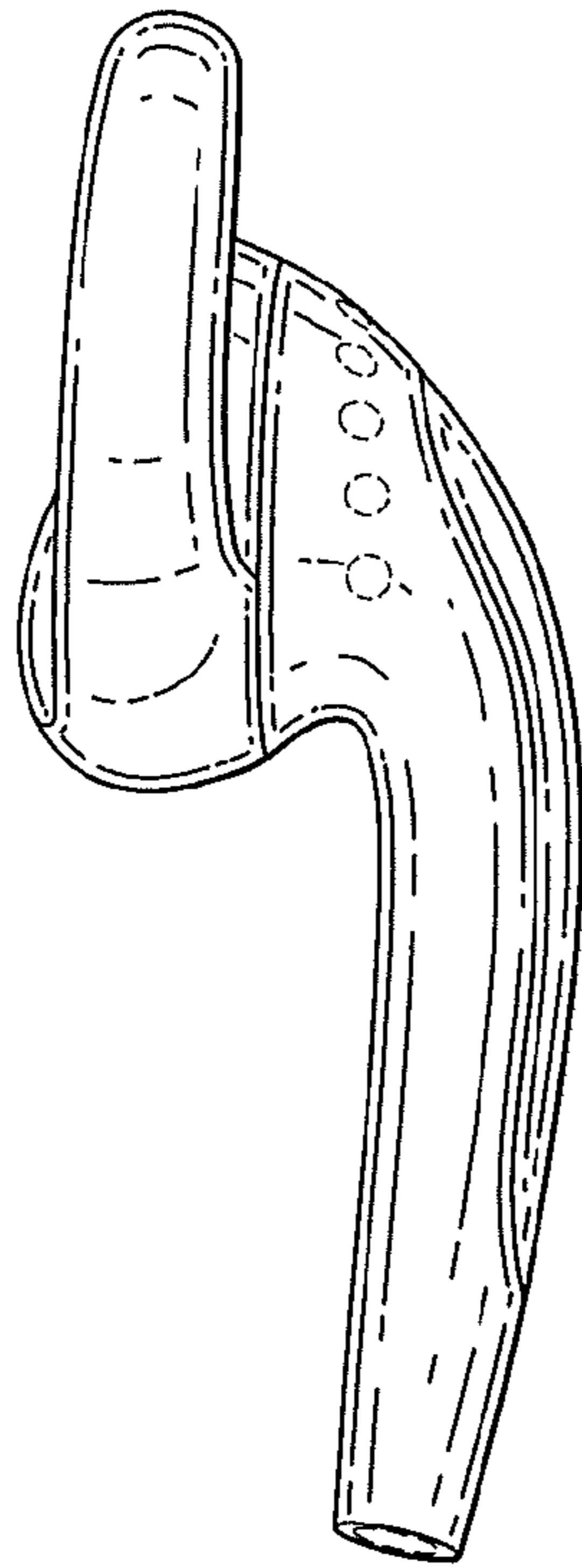

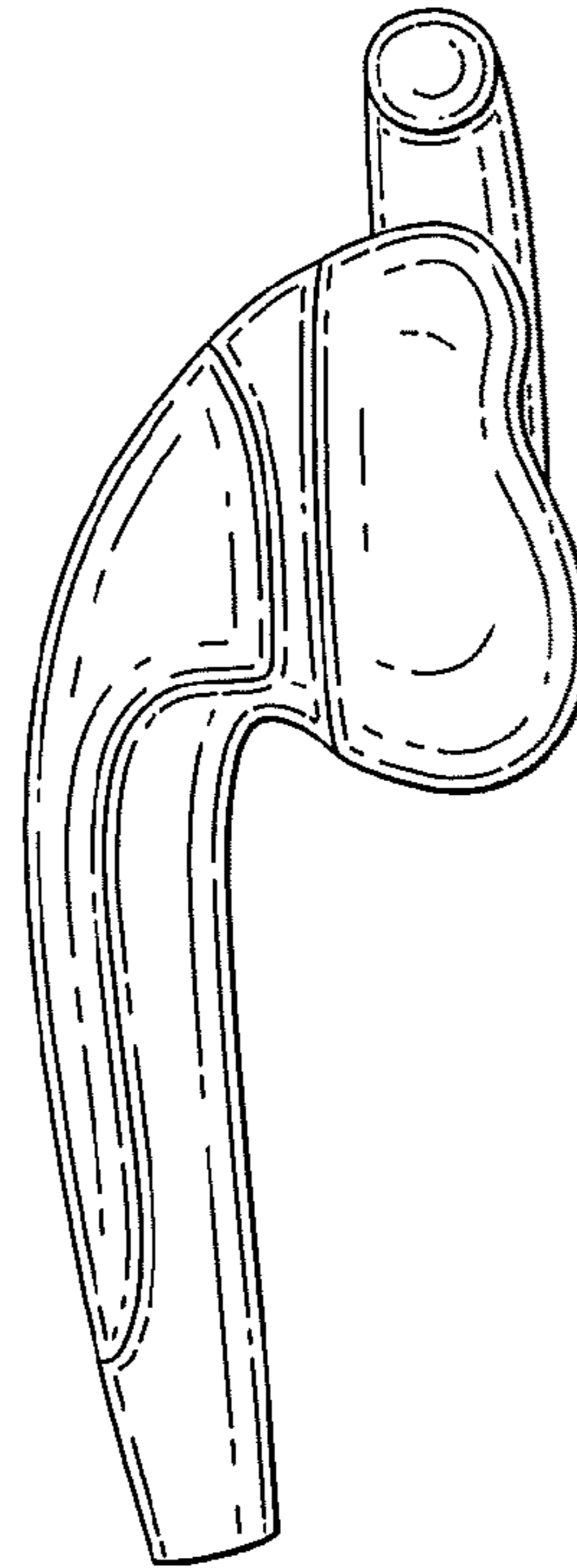

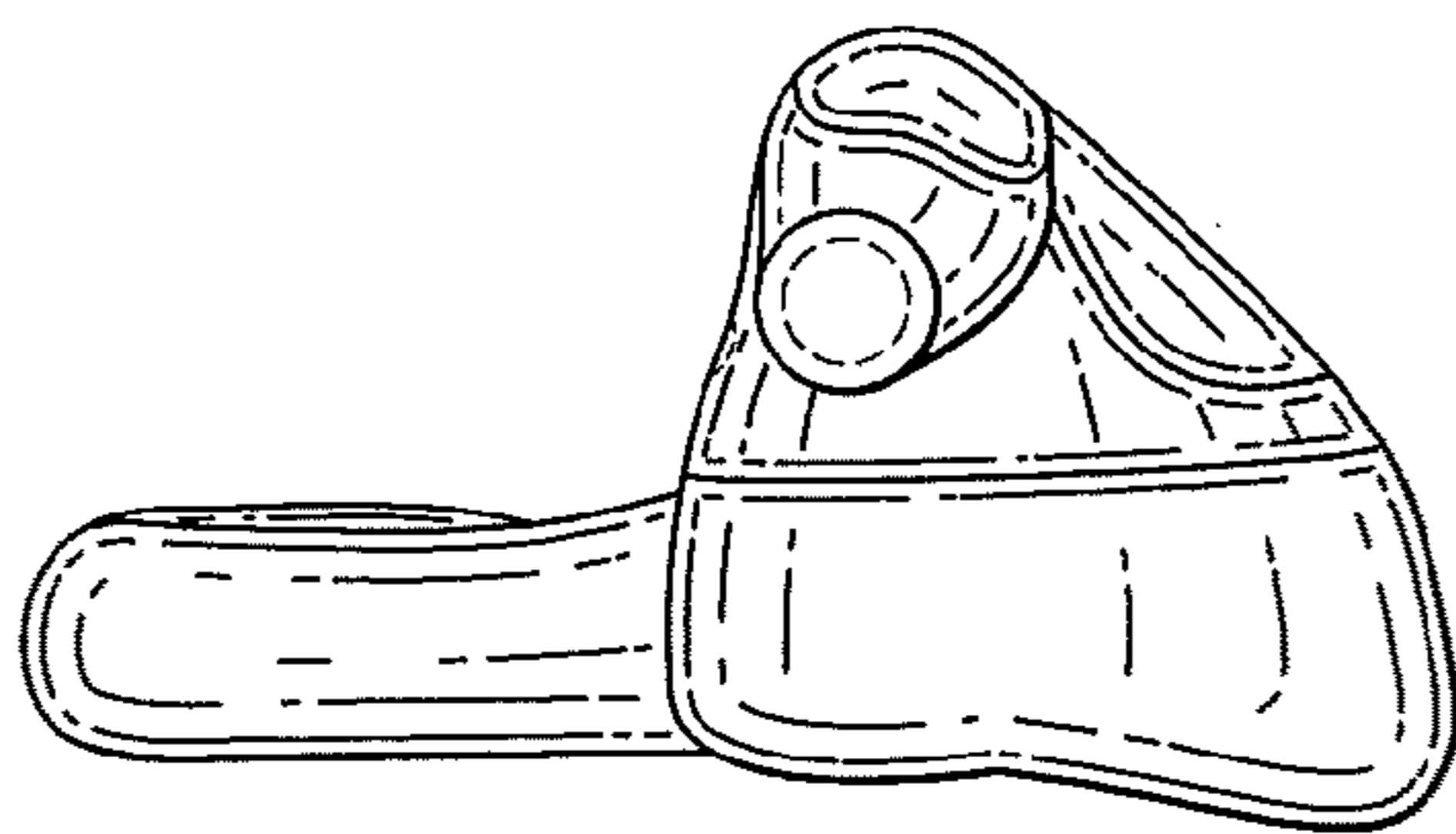

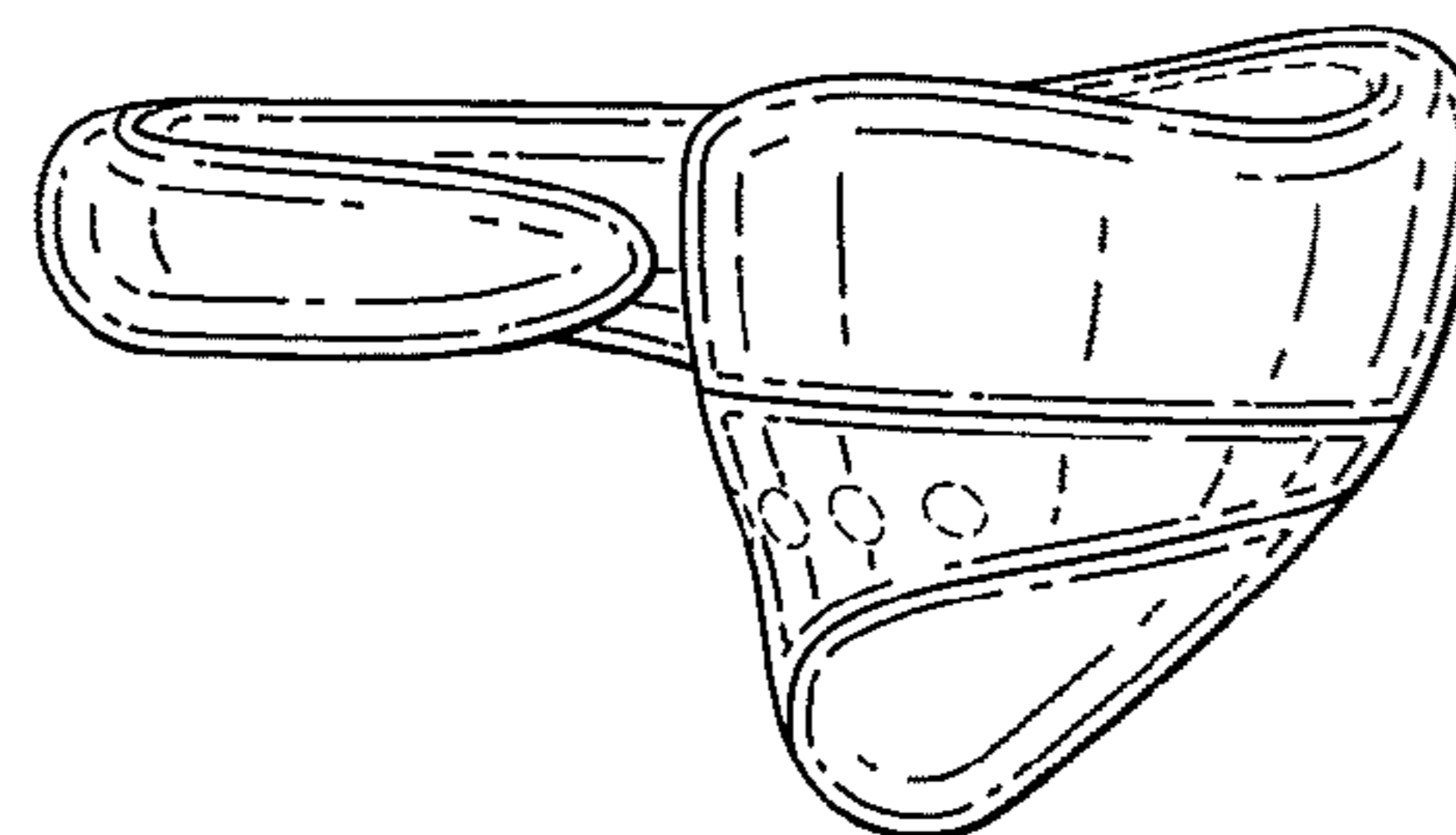
