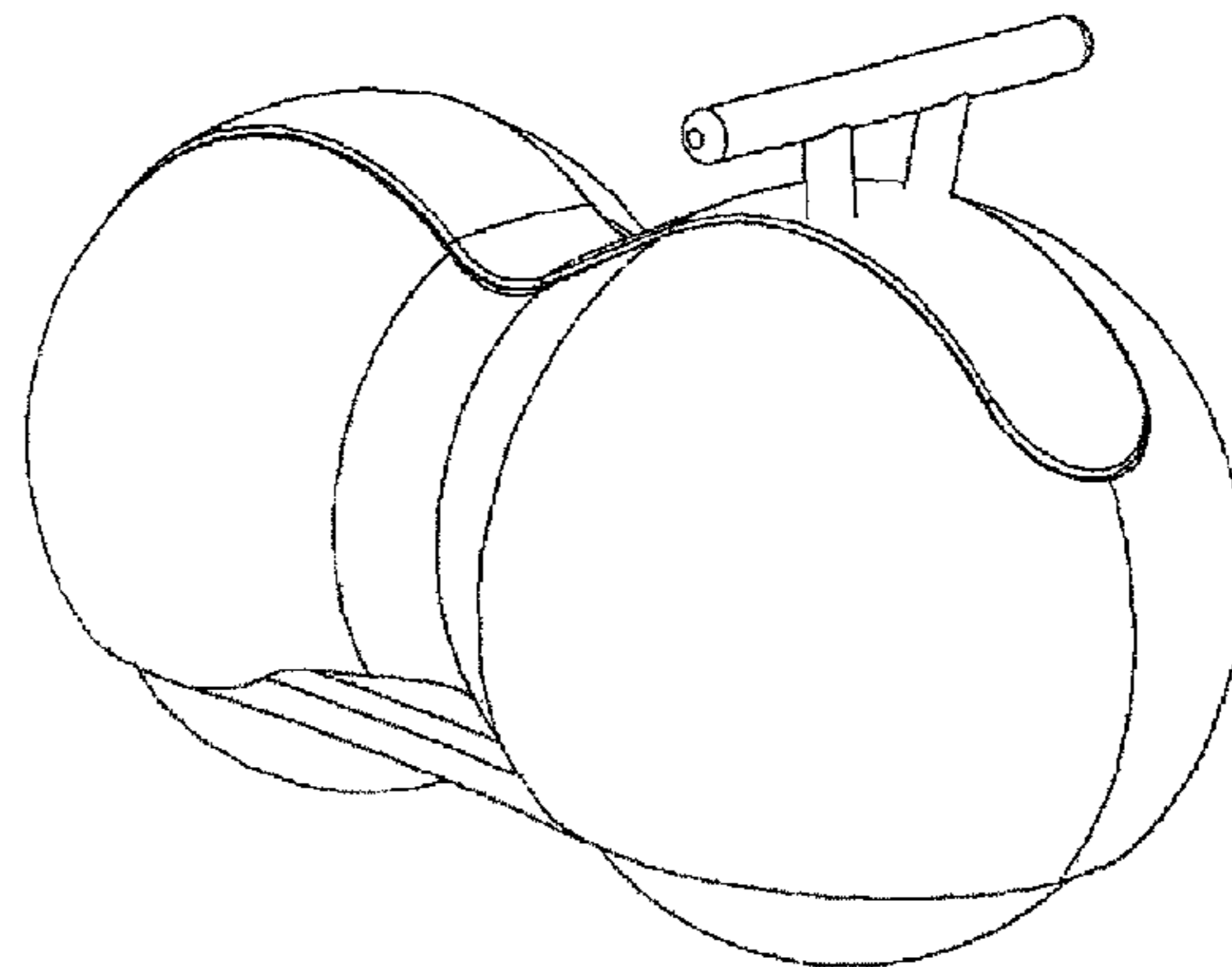
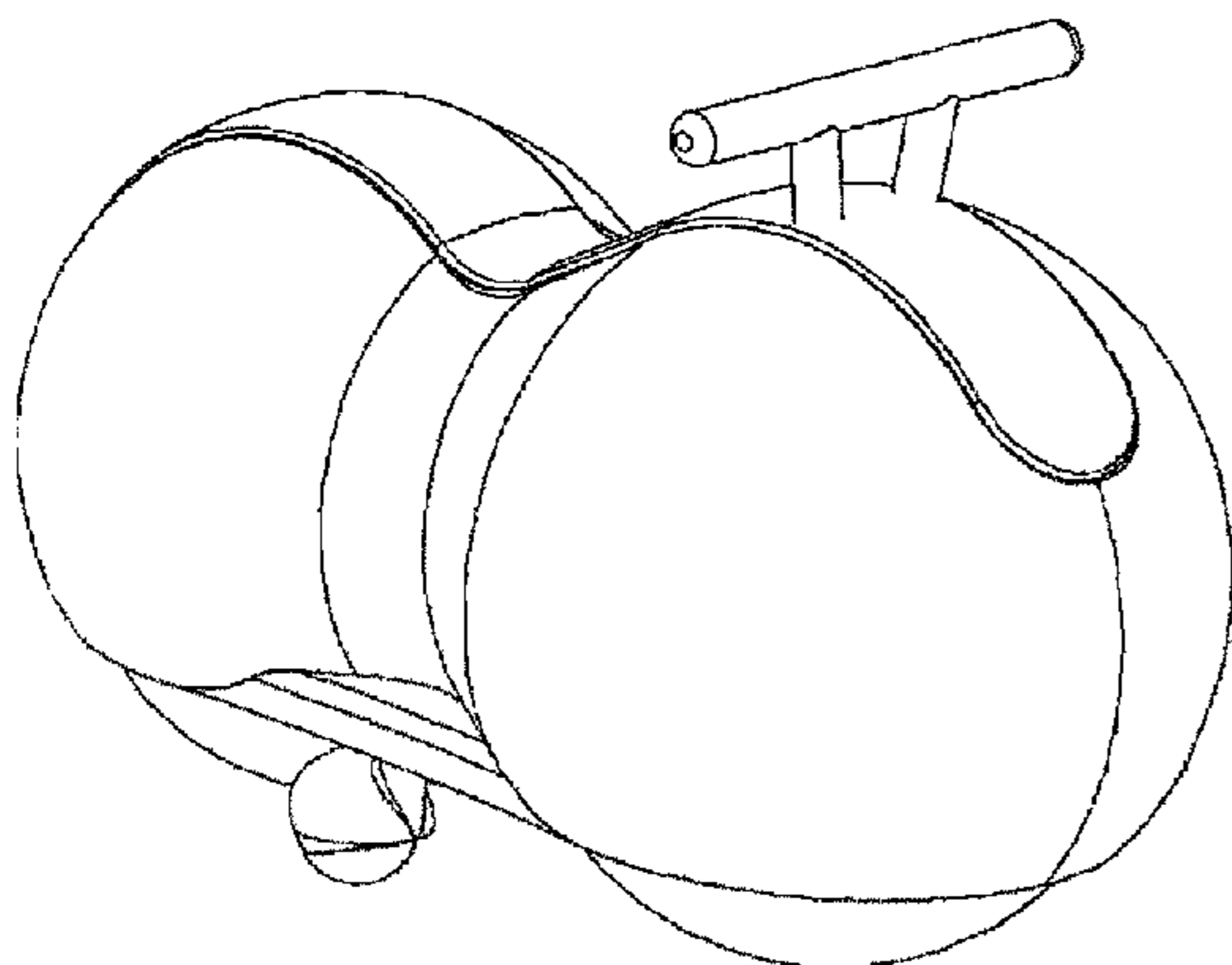
(57) **CLAIM**

The ornamental design for a foot propelled vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front and one side of a foot propelled vehicle of a first embodiment of the invention; FIG. 2 is a perspective view from the front and the other side of the embodiment of FIG. 1; FIG. 3 is a view from one side of the embodiment of FIG. 1; FIG. 4 is a view from the other side of the embodiment of FIG. 1; FIG. 5 is a front view of the embodiment of FIG. 1; FIG. 6 is a rear view of the embodiment of FIG. 1; FIG. 7 is a top view of the embodiment of FIG. 1; FIG. 8 is a perspective view from the front and one side of a foot propelled vehicle of a second embodiment of the invention; FIG. 9 is a perspective view from the front and the other side of the embodiment of FIG. 8; FIG. 10 is a view from one side of the embodiment of FIG. 8; FIG. 11 is a view from the other side of the embodiment of FIG. 8; FIG. 12 is a front view of the embodiment of FIG. 8; FIG. 13 is a rear view of the embodiment of FIG. 8; FIG. 14 is a top view of the embodiment of FIG. 8; and, FIG. 15 is a perspective view from the rear and the other side of the embodiment of FIG. 8.

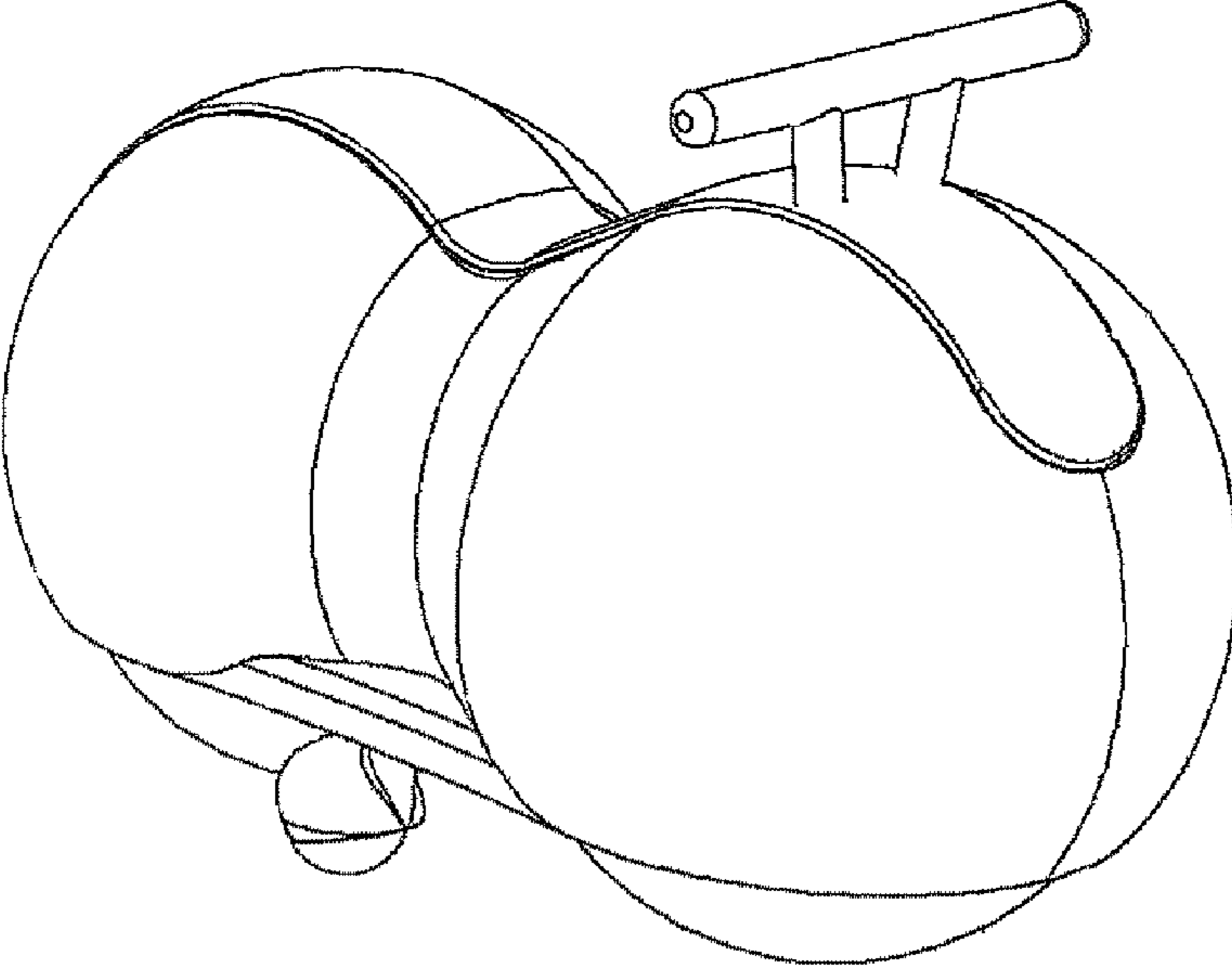

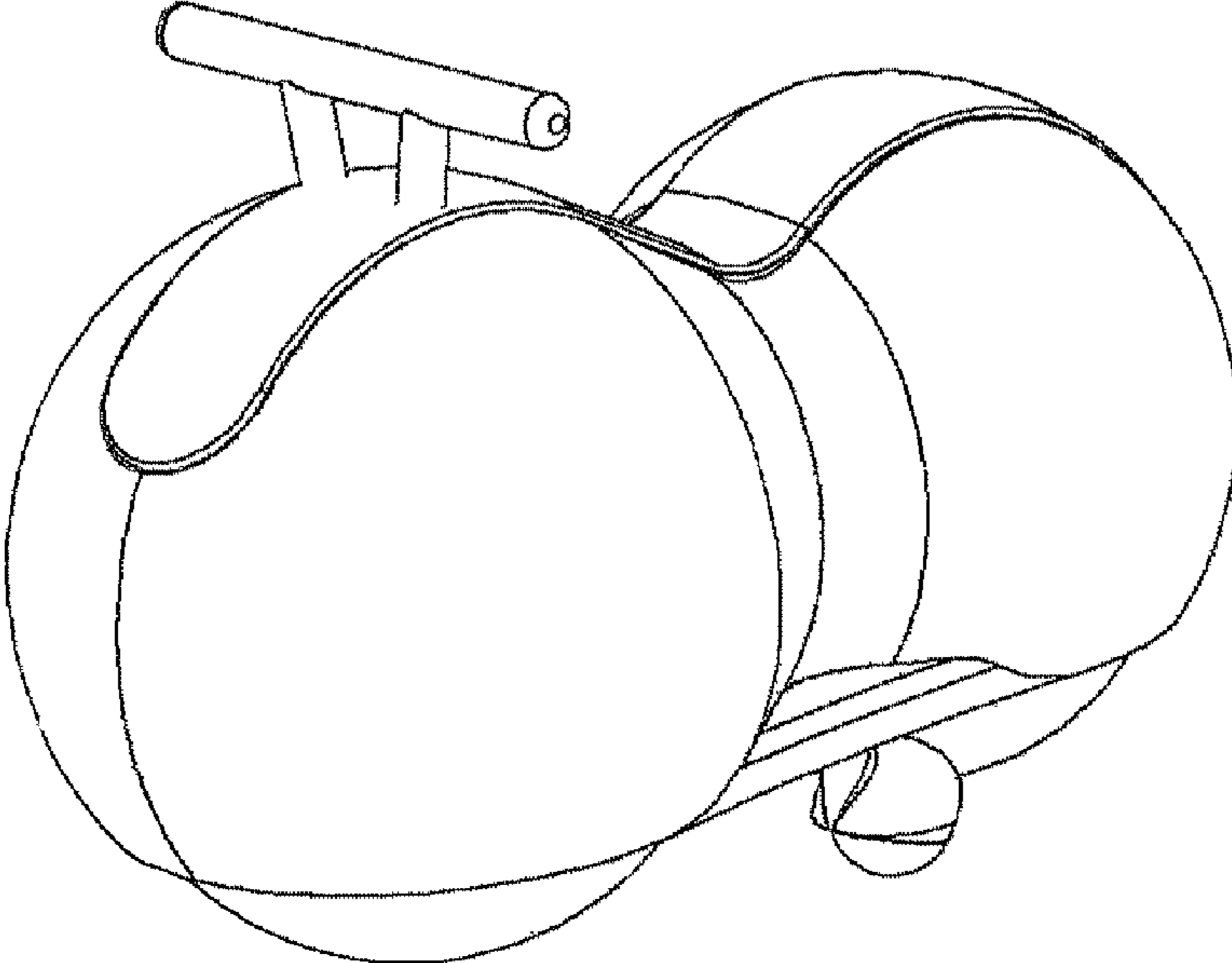

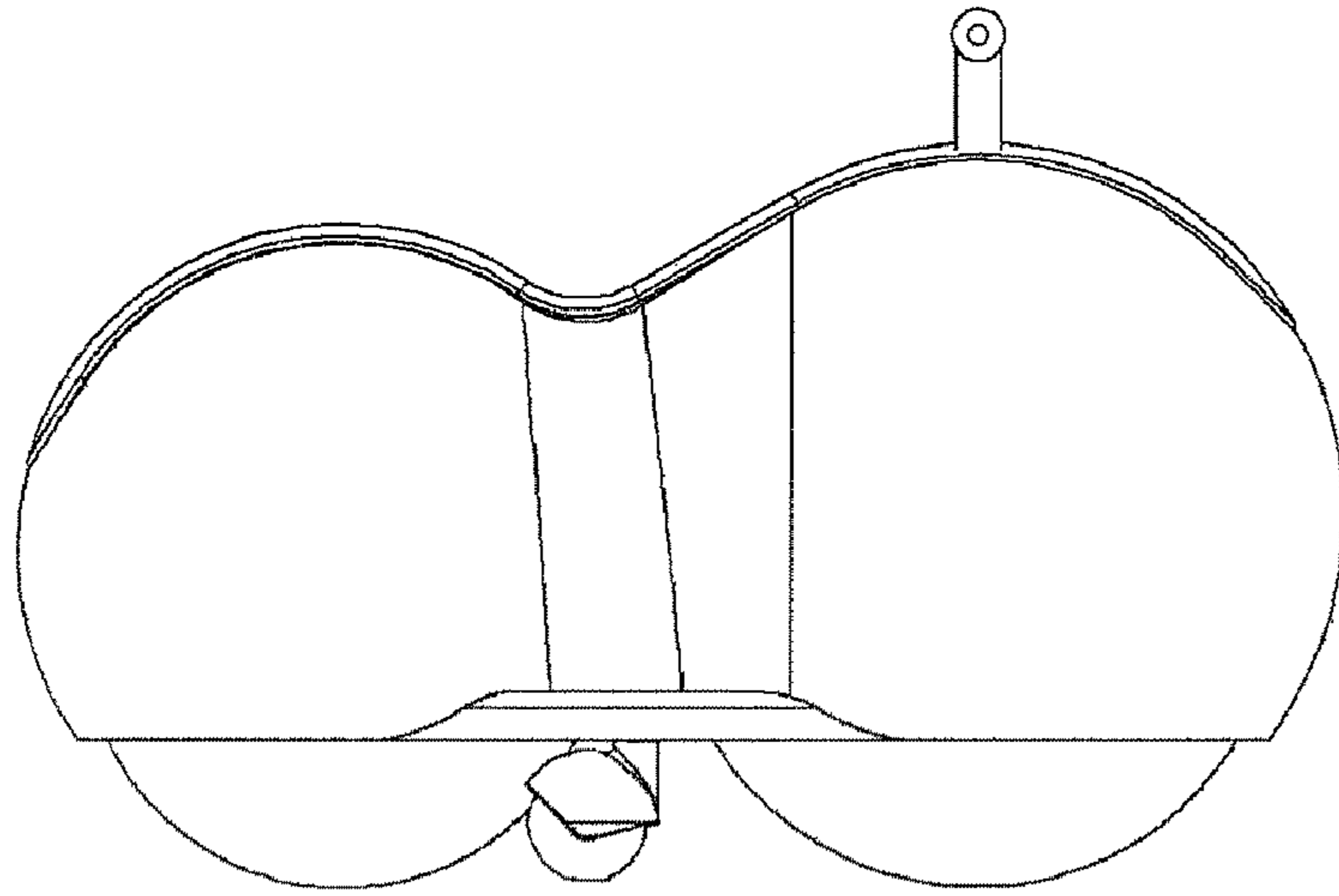

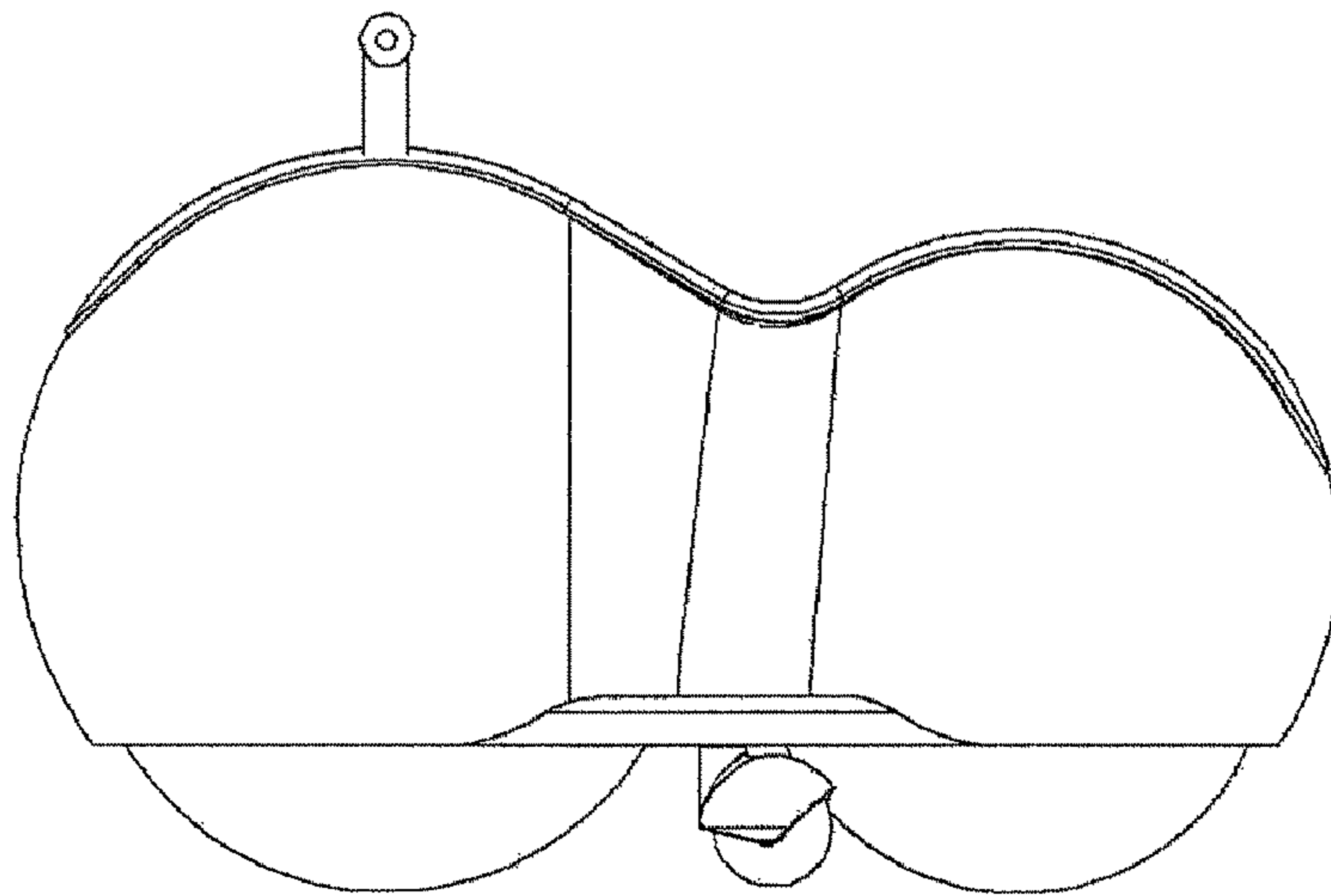

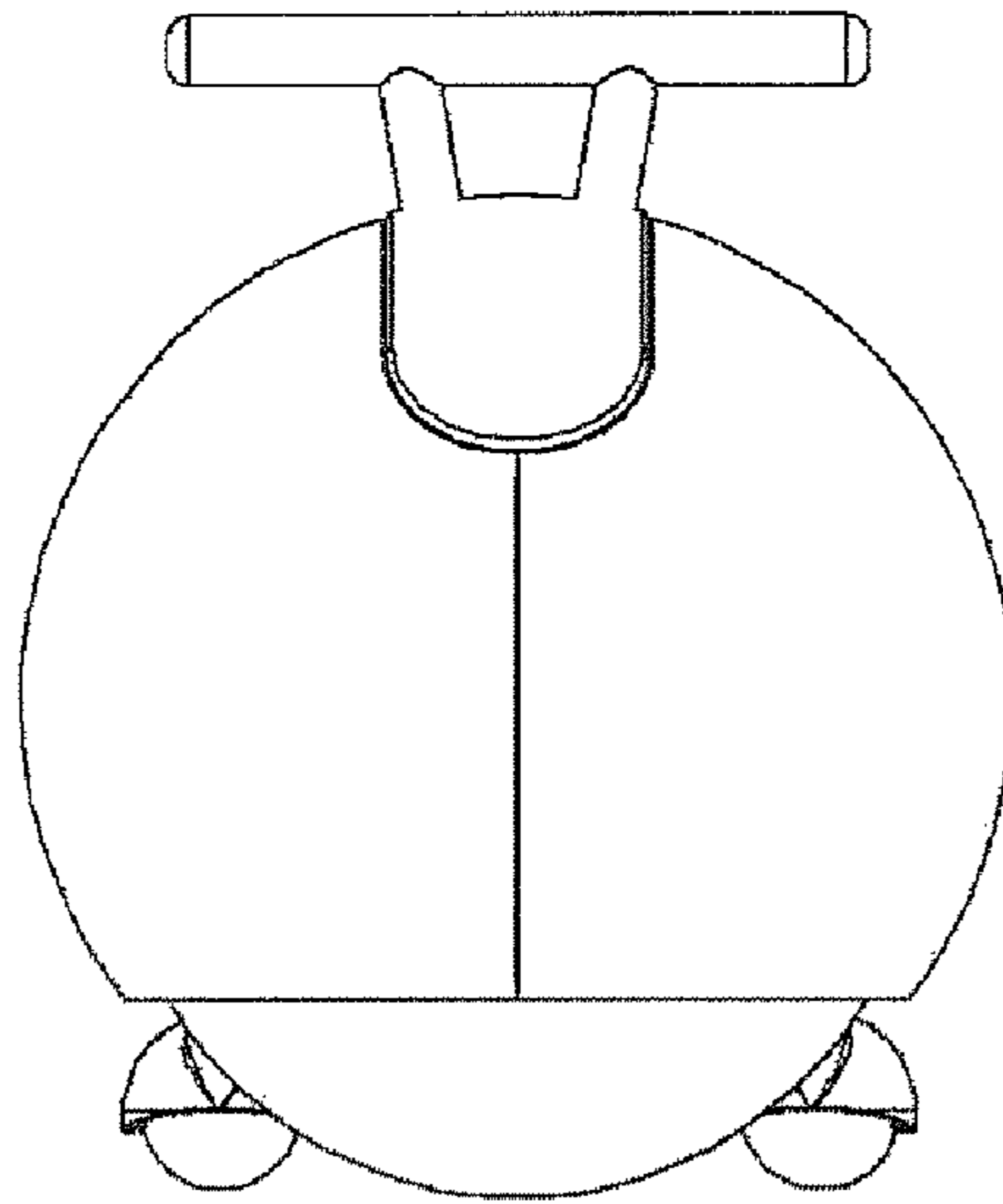

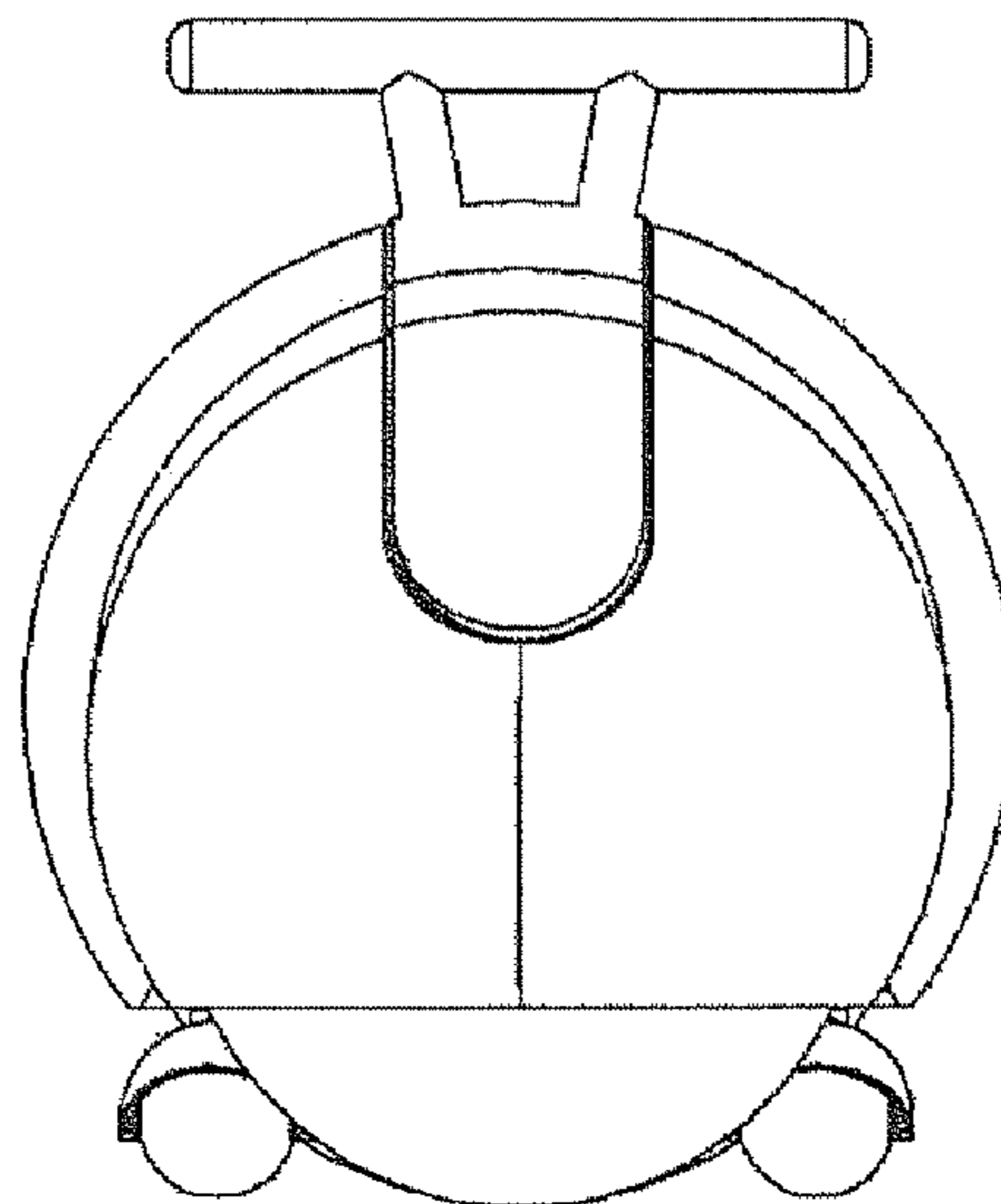

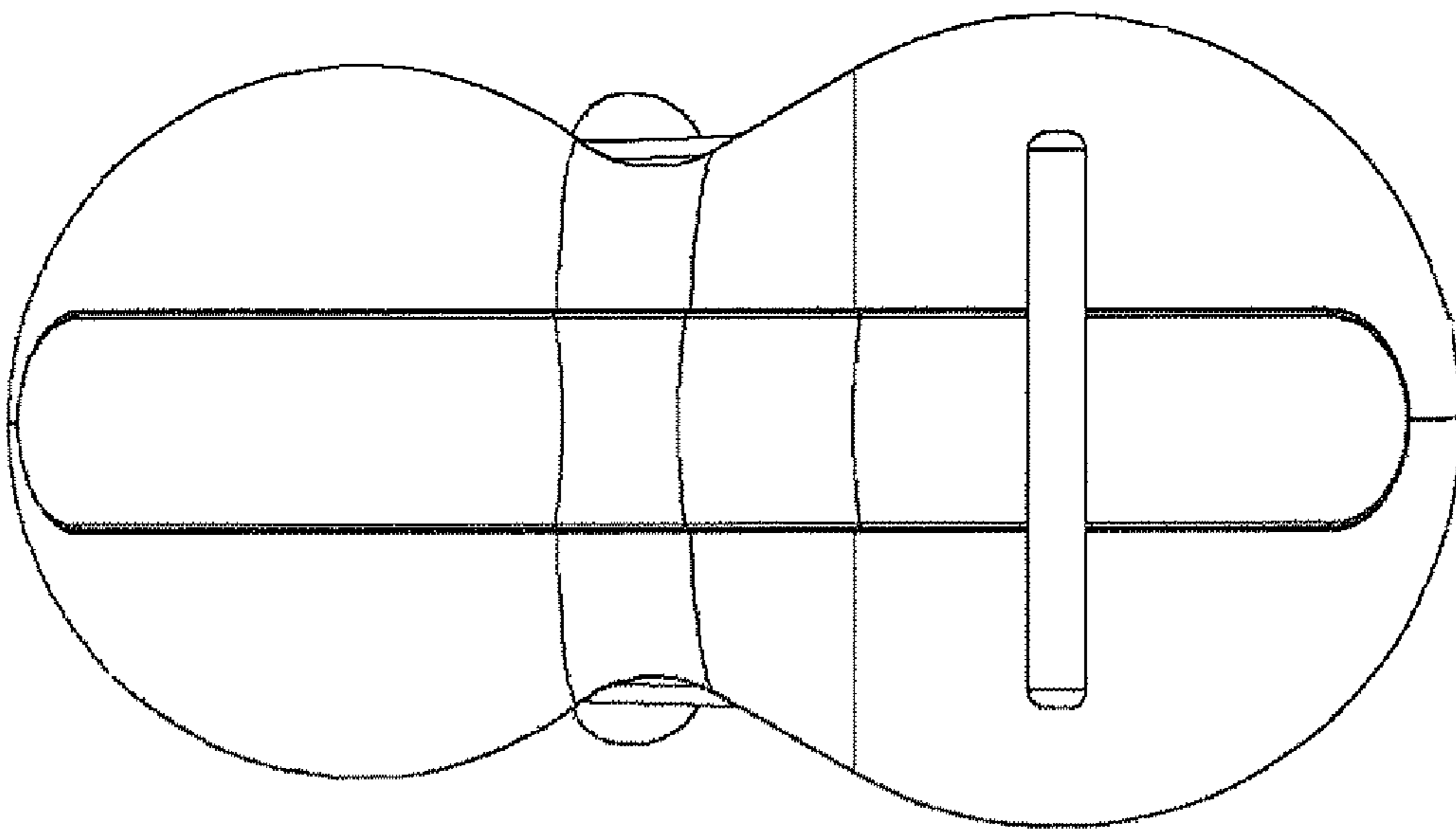

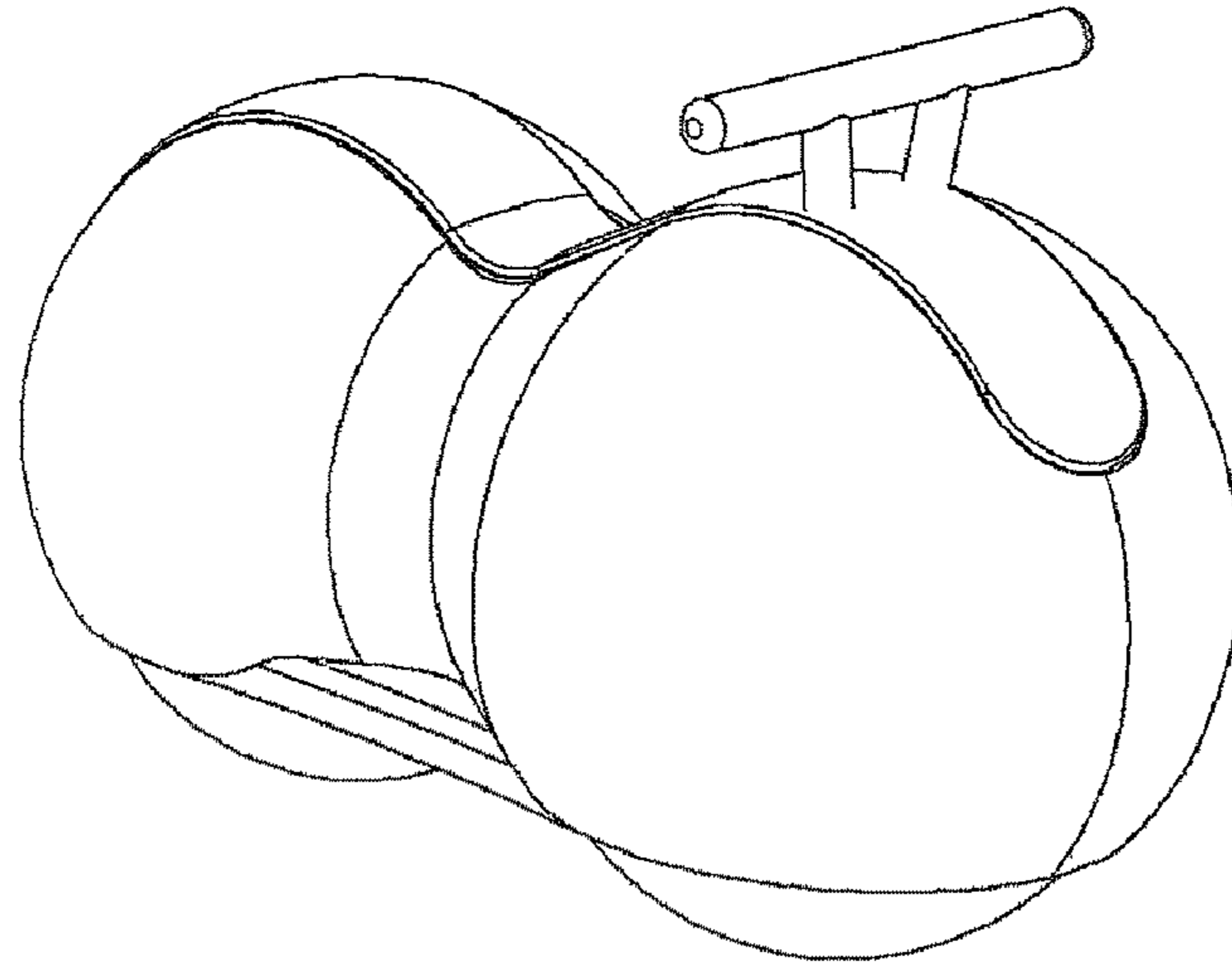

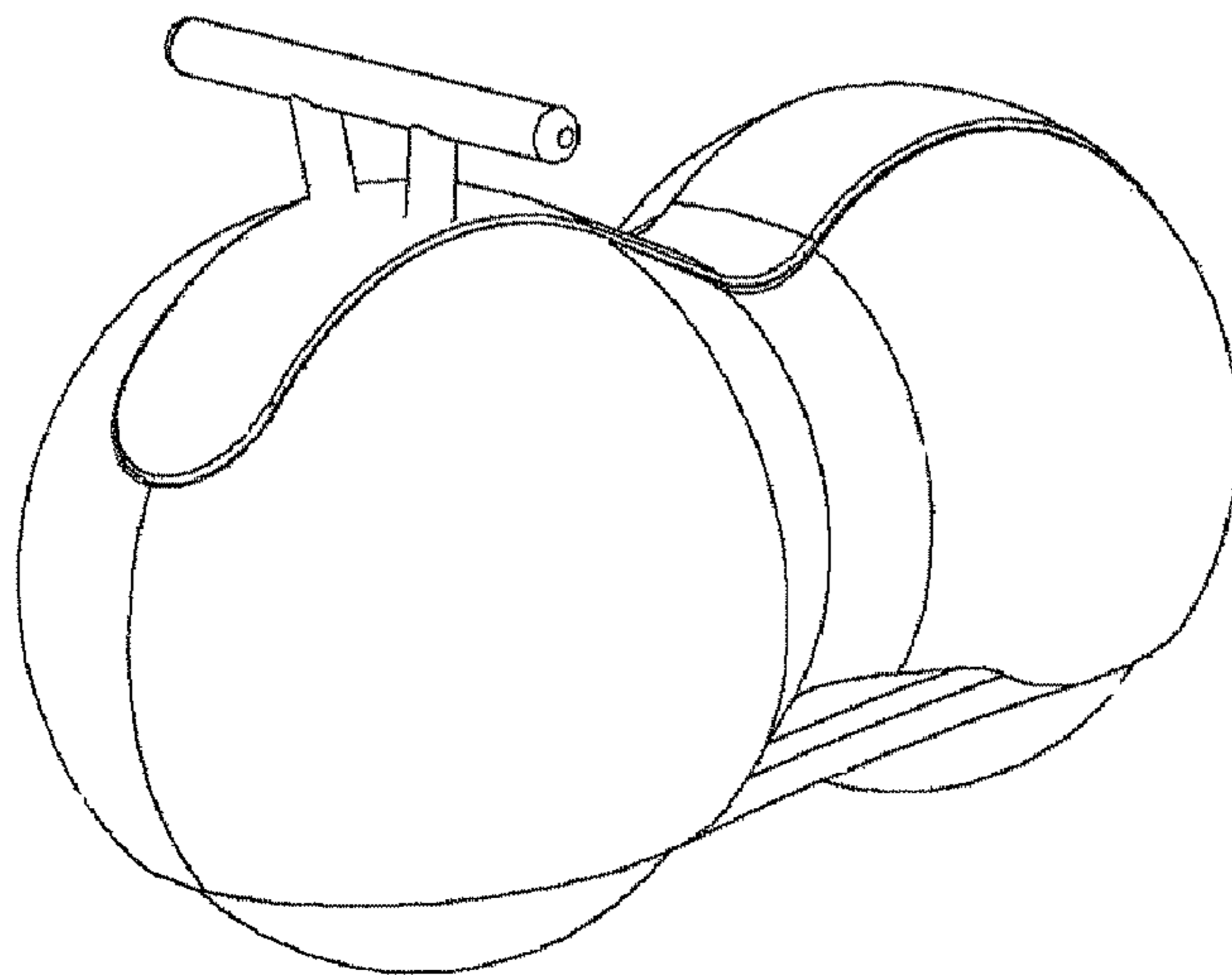

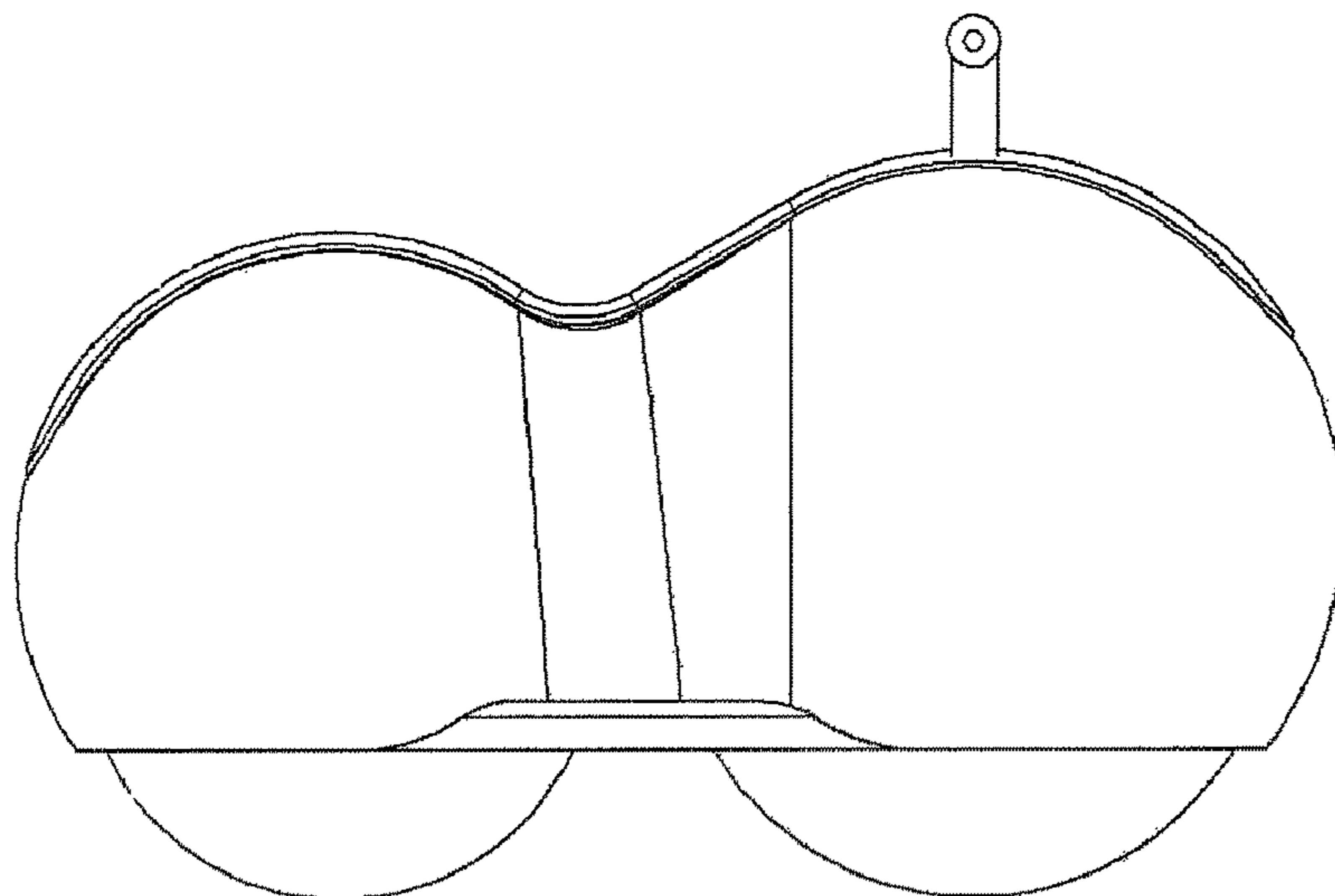

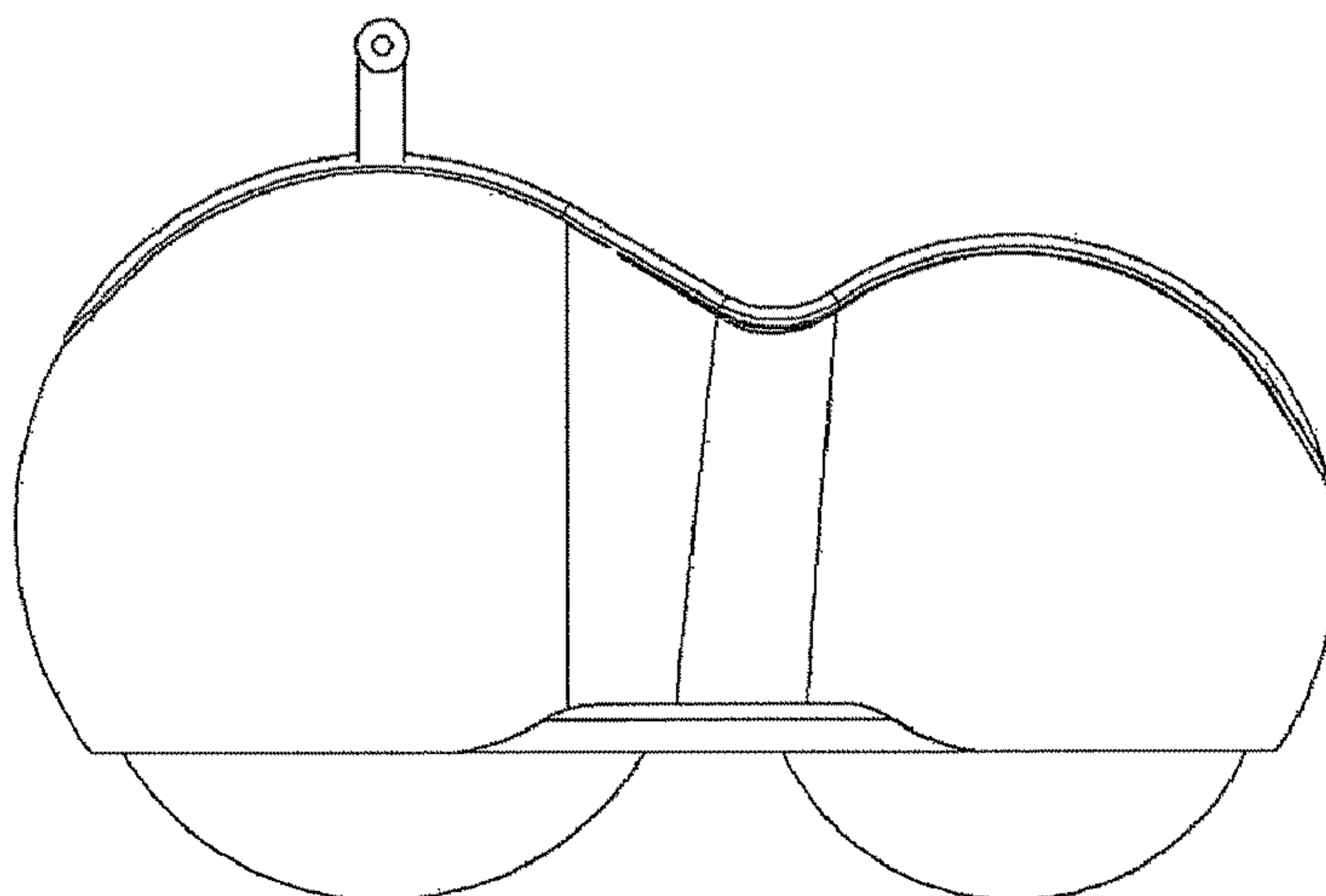

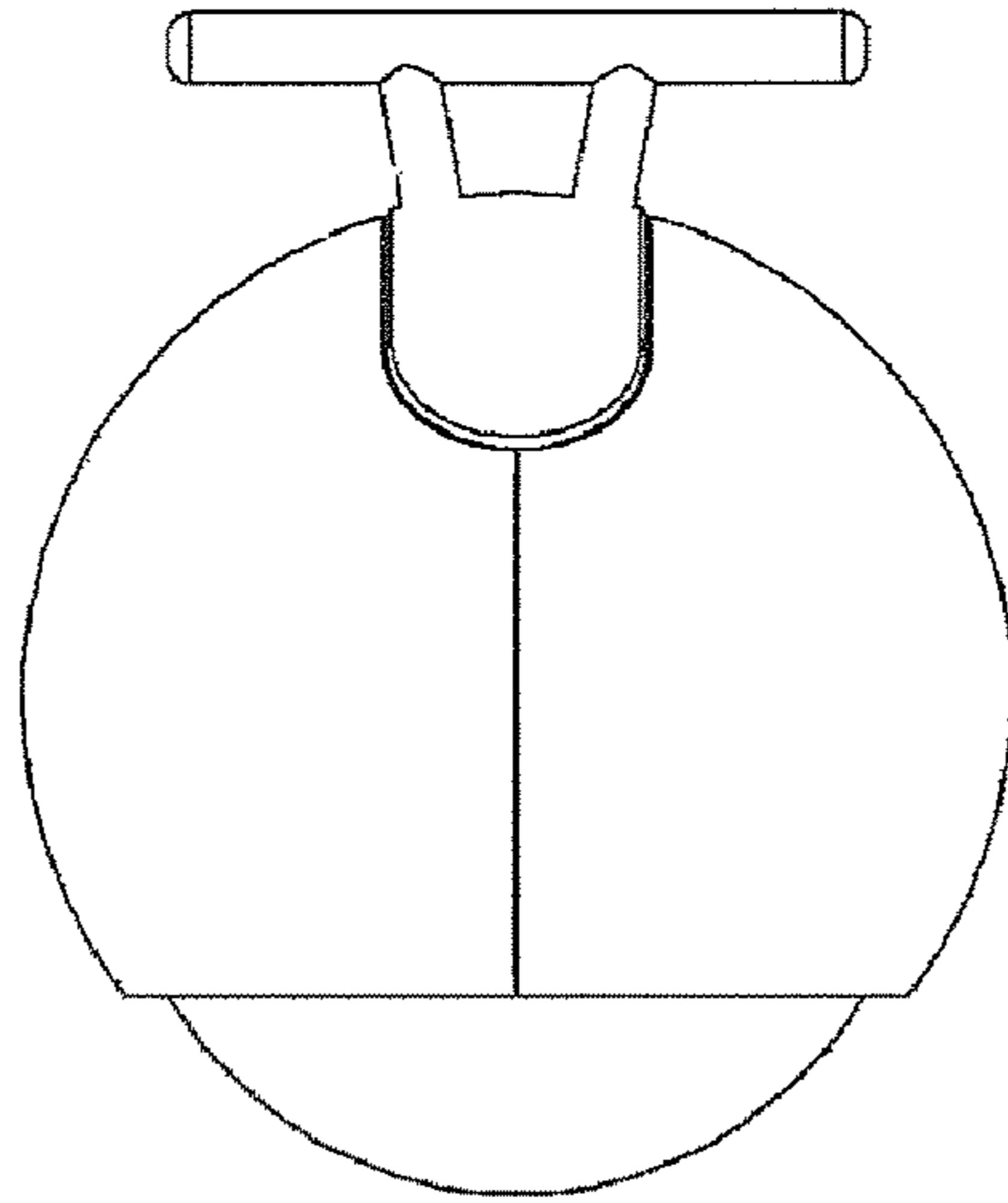

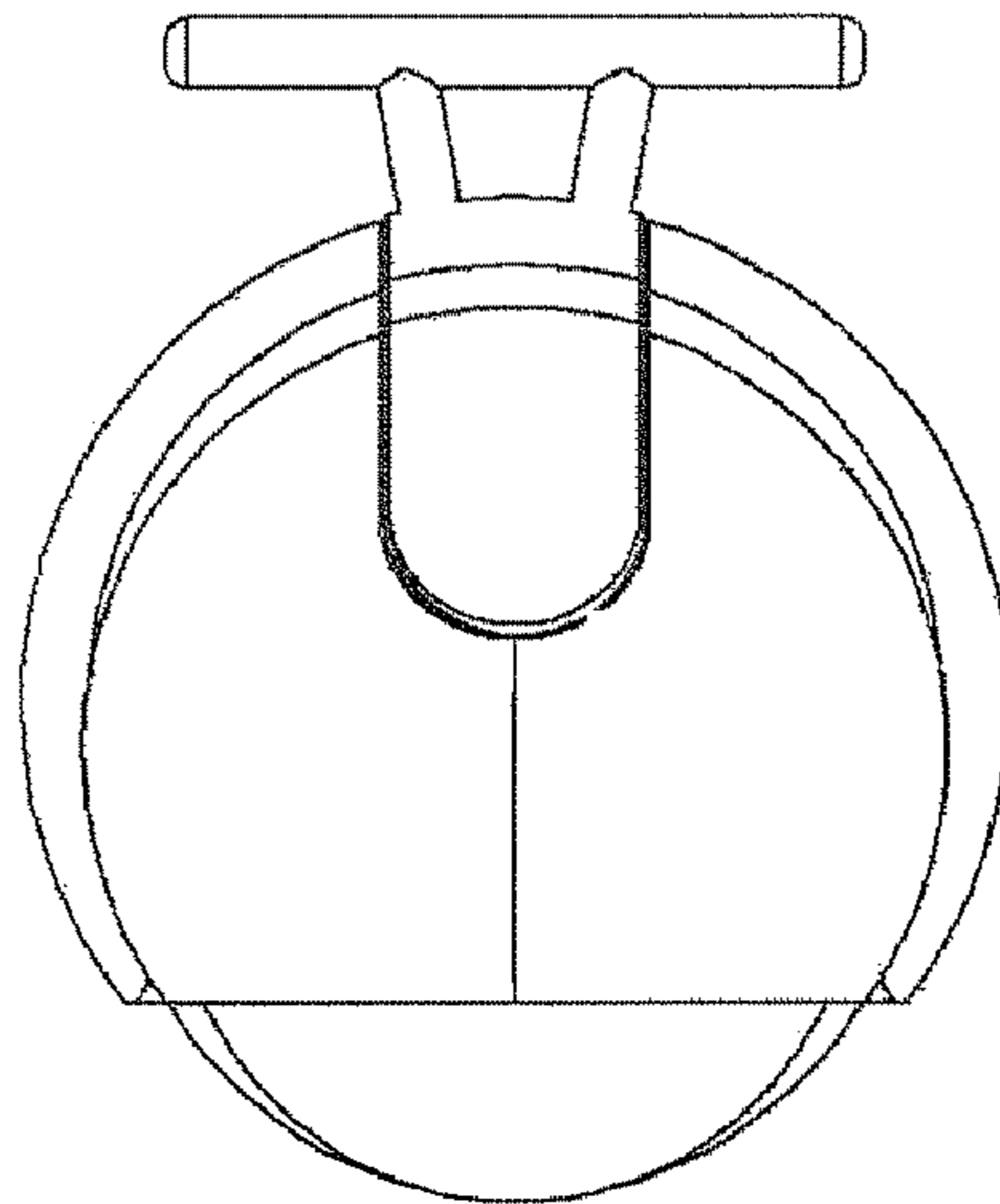

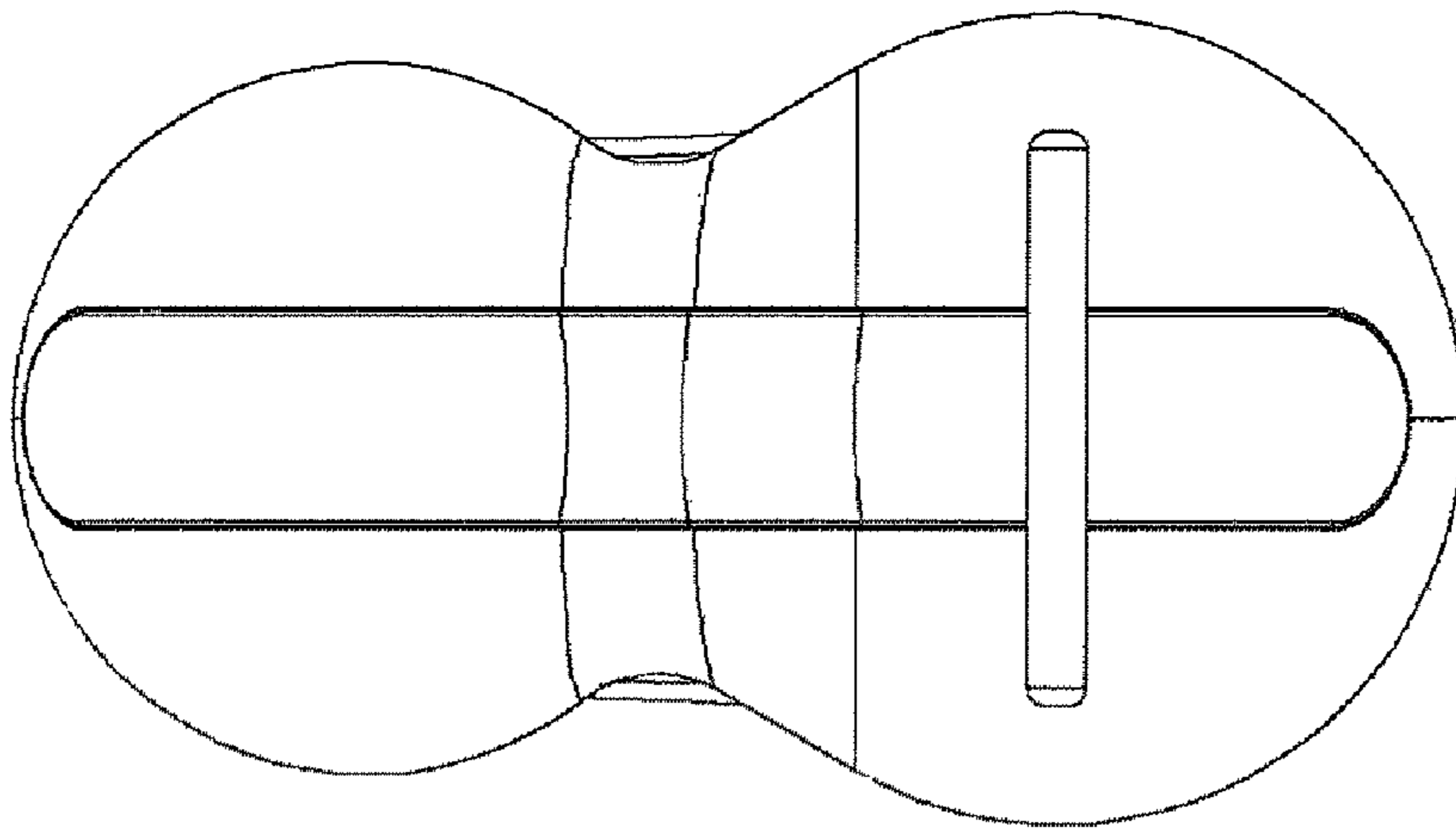

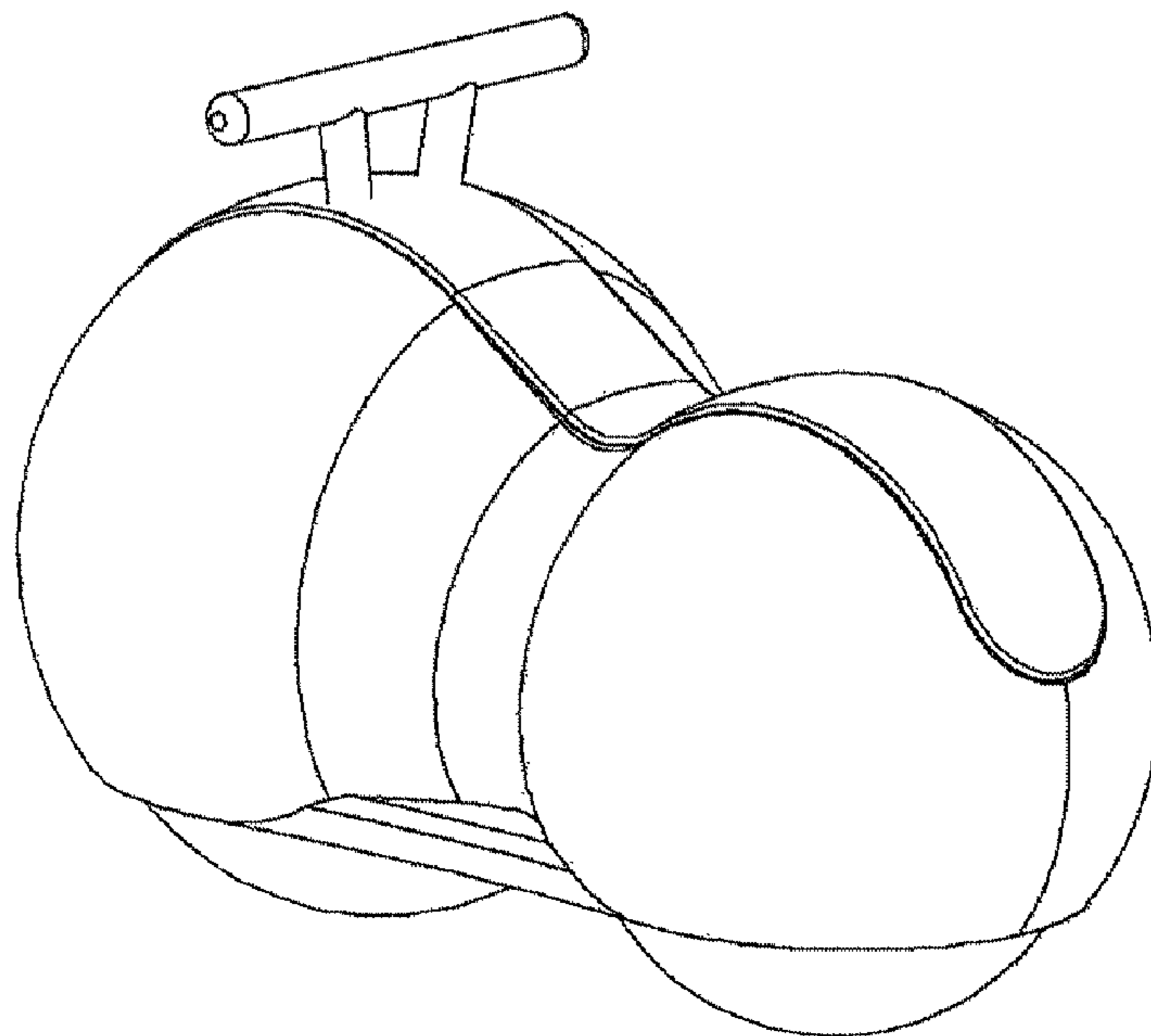
