(57) **CLAIM**

The ornamental design for a golf club stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a golf club stand, showing the new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a perspective view of a second embodiment of the design;  
 FIG. 8 is a front elevational view of FIG. 7;  
 FIG. 9 is a left-side elevational view of FIG. 7, the right-side elevational view being a mirror image thereof;  
 FIG. 10 is a rear elevational view of FIG. 7;  
 FIG. 11 is a top plan view of FIG. 7; and,  
 FIG. 12 is a bottom plan view thereof.  
 The broken lines showing a ground surface and golf clubs in FIG. 1 illustrate environmental matter as the invention is in use, and form no part of the claimed design.

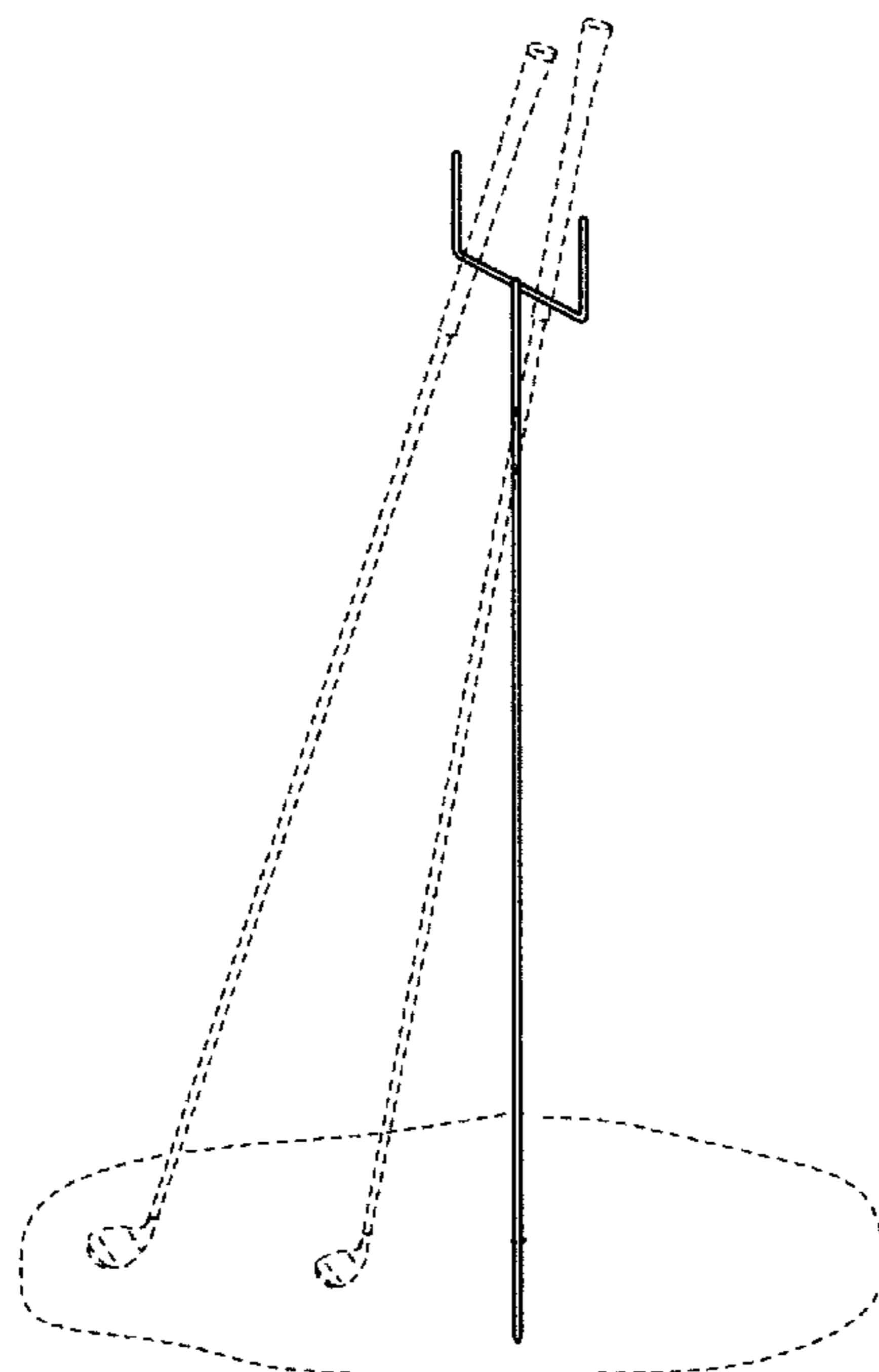
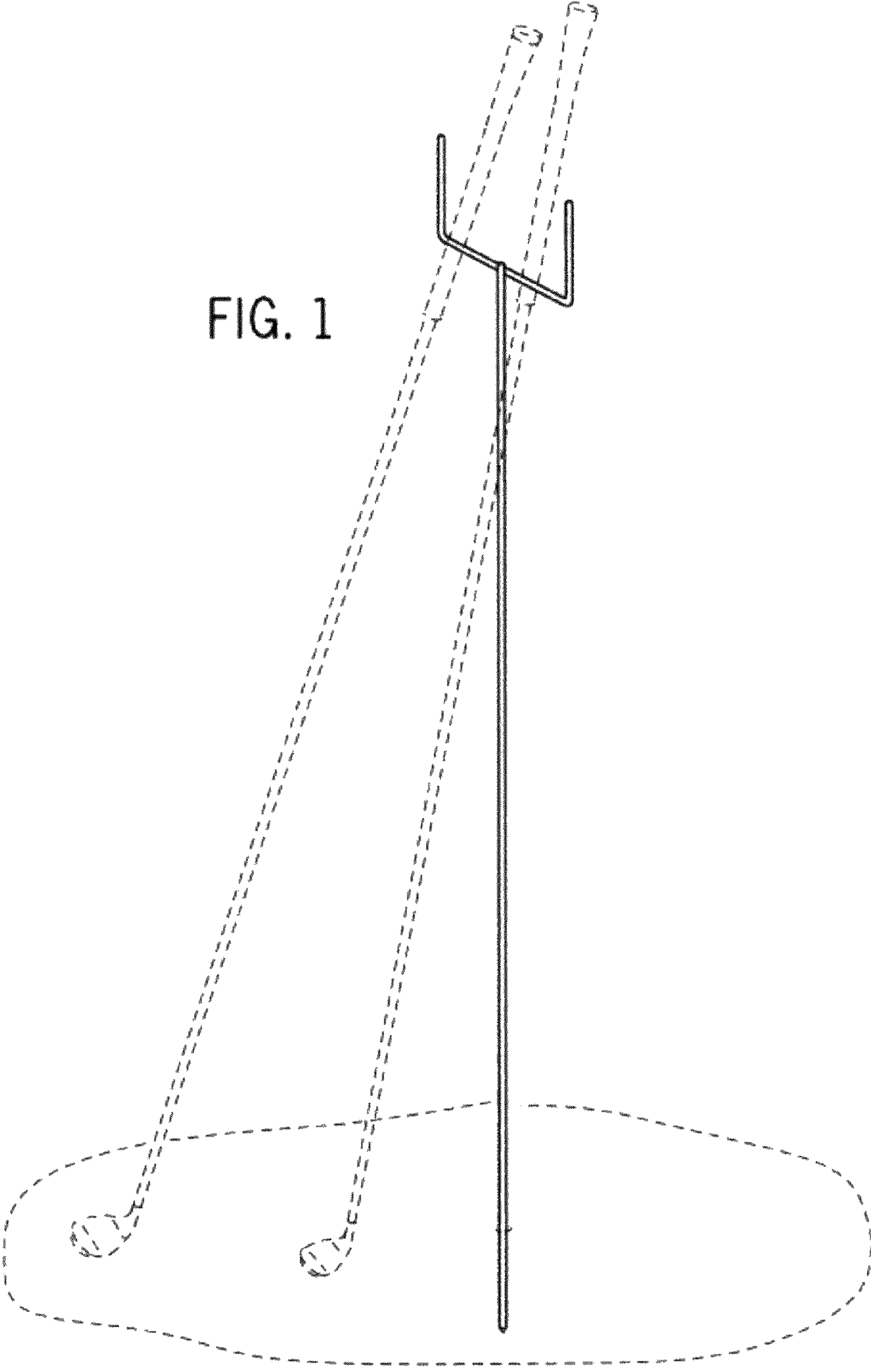

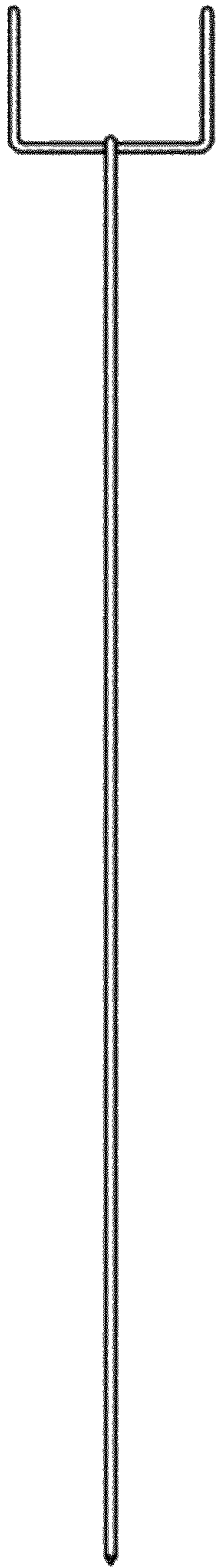

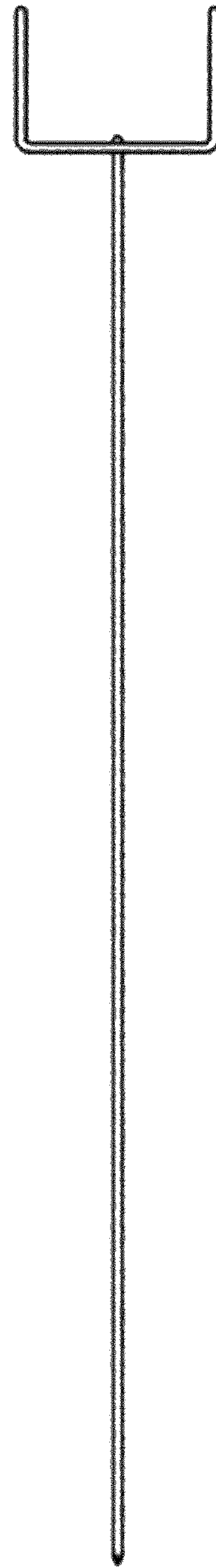

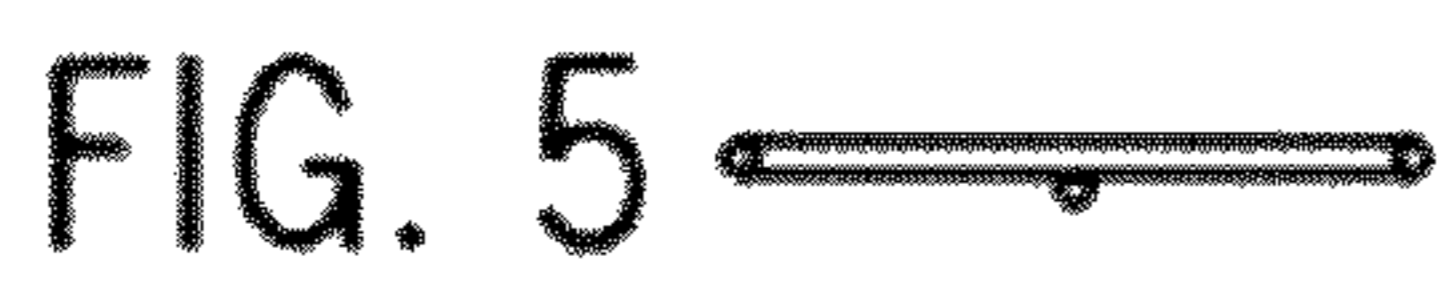

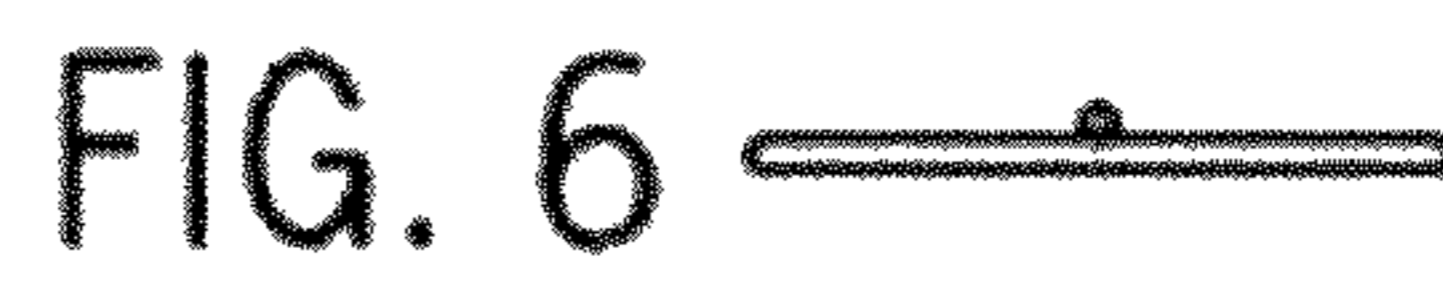

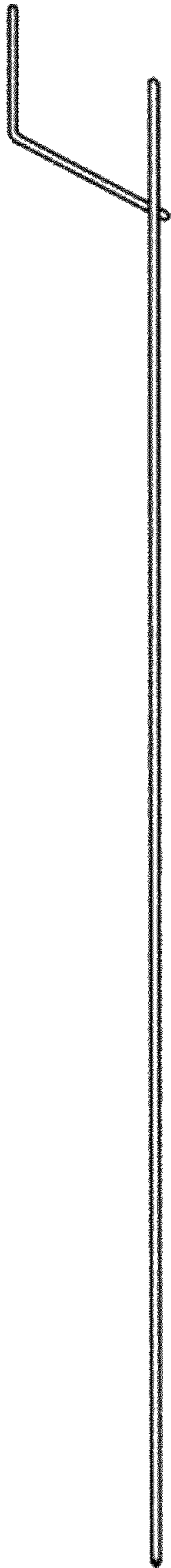

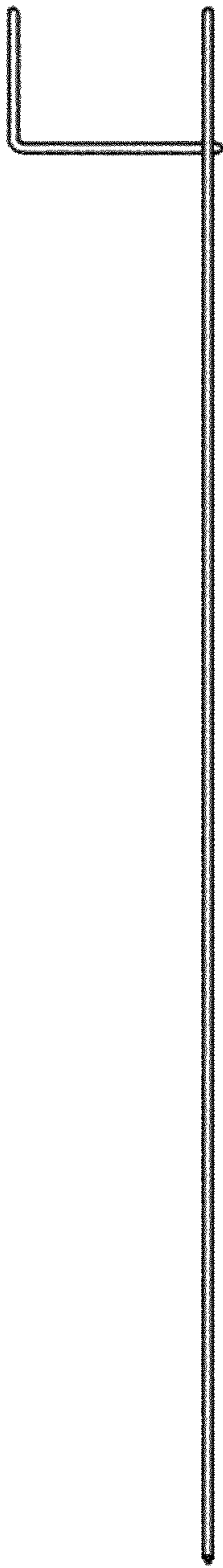

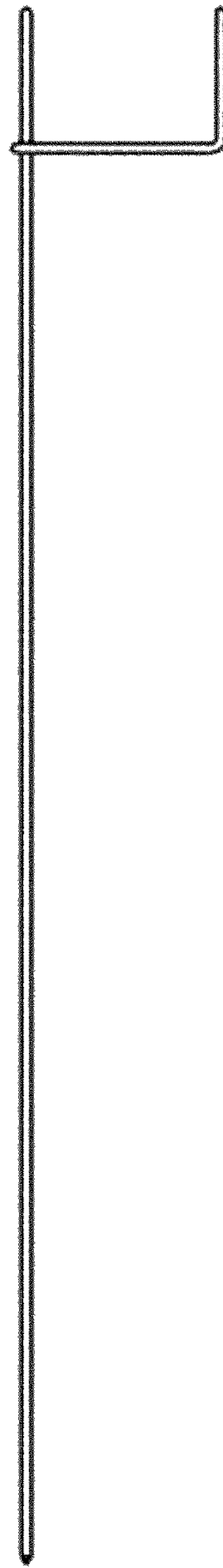
