FIG. 3 is a left side view of the collar for pipes;

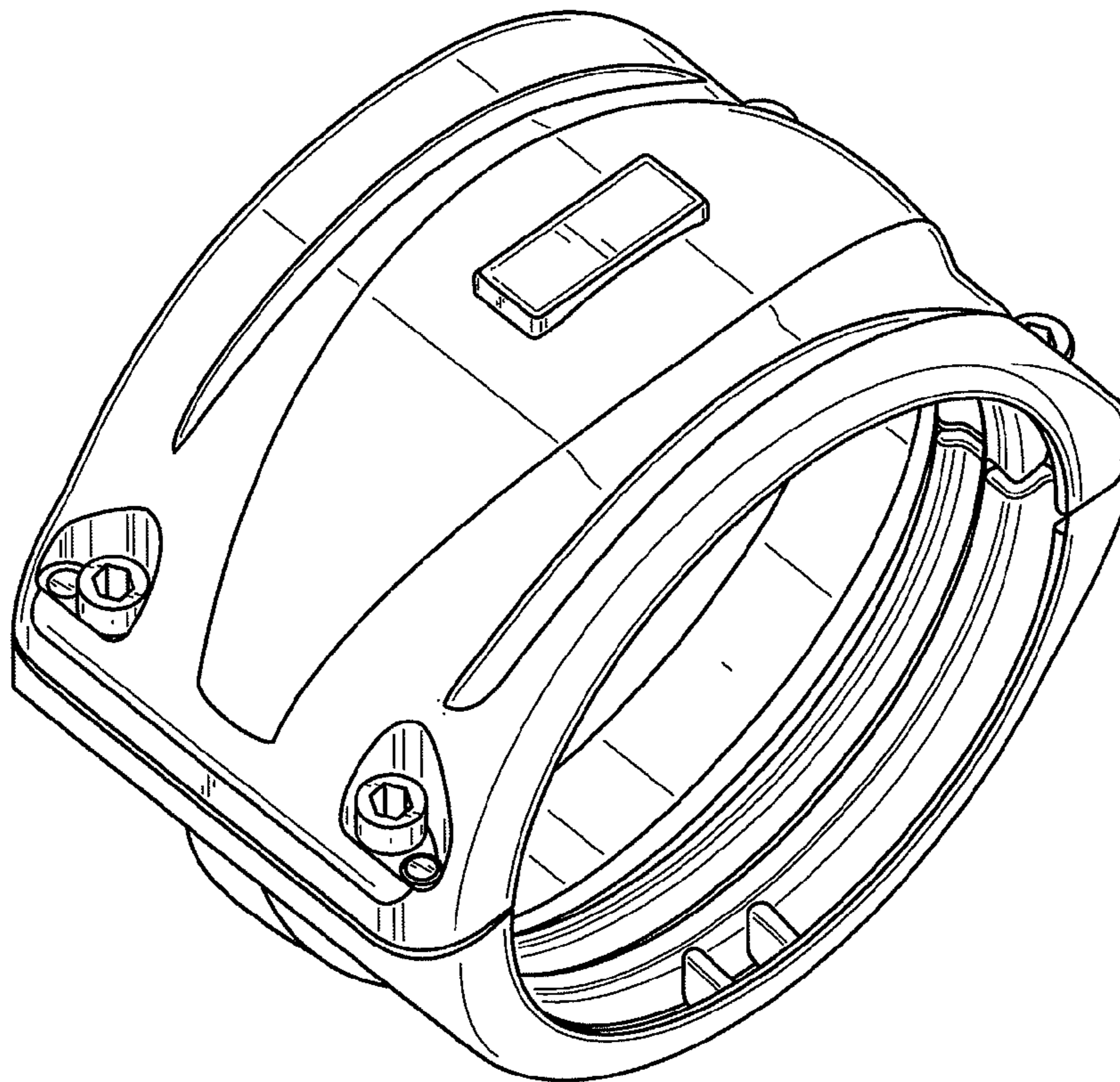
FIG. 4 is a front elevational view of the collar for pipes;

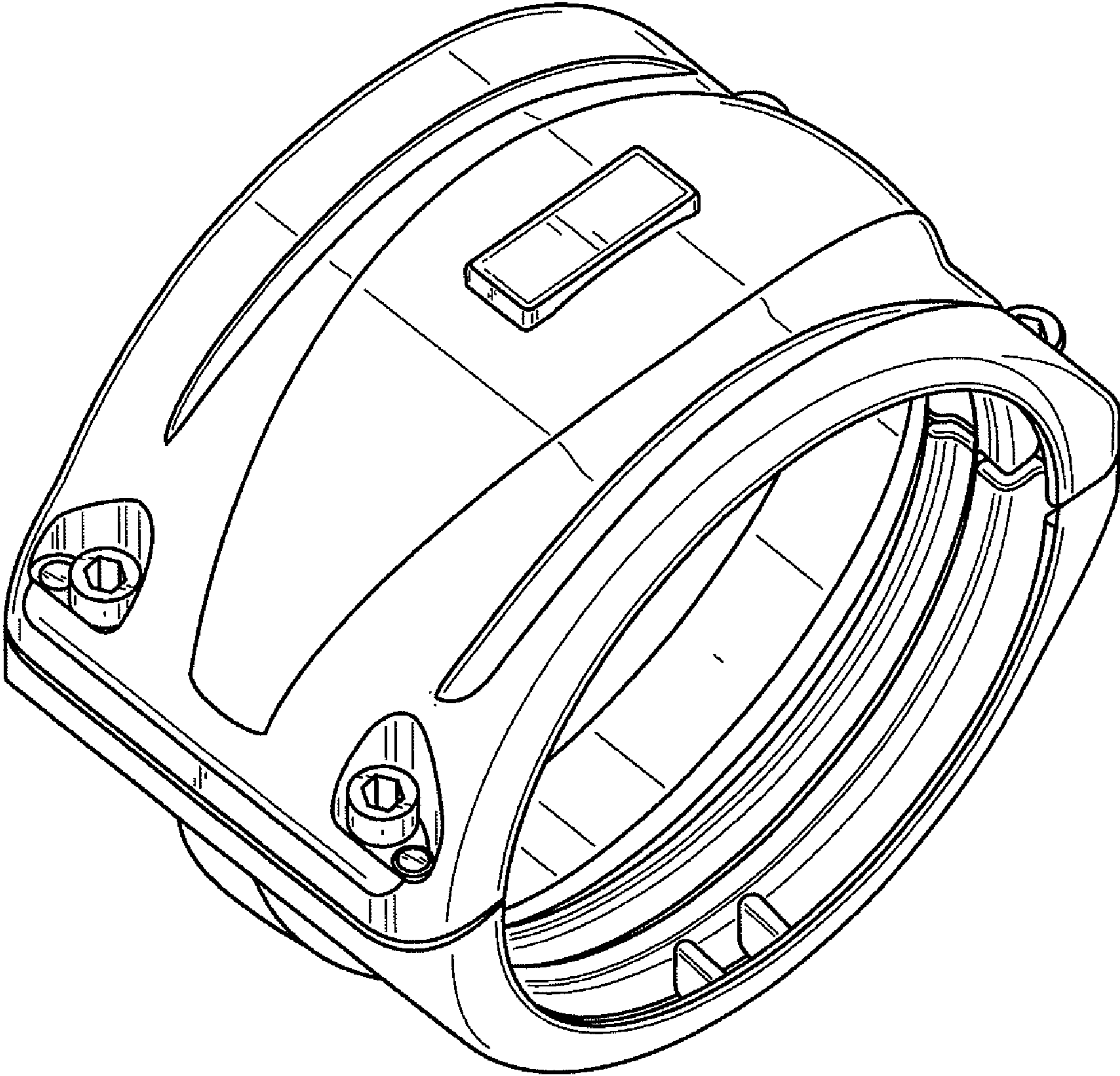

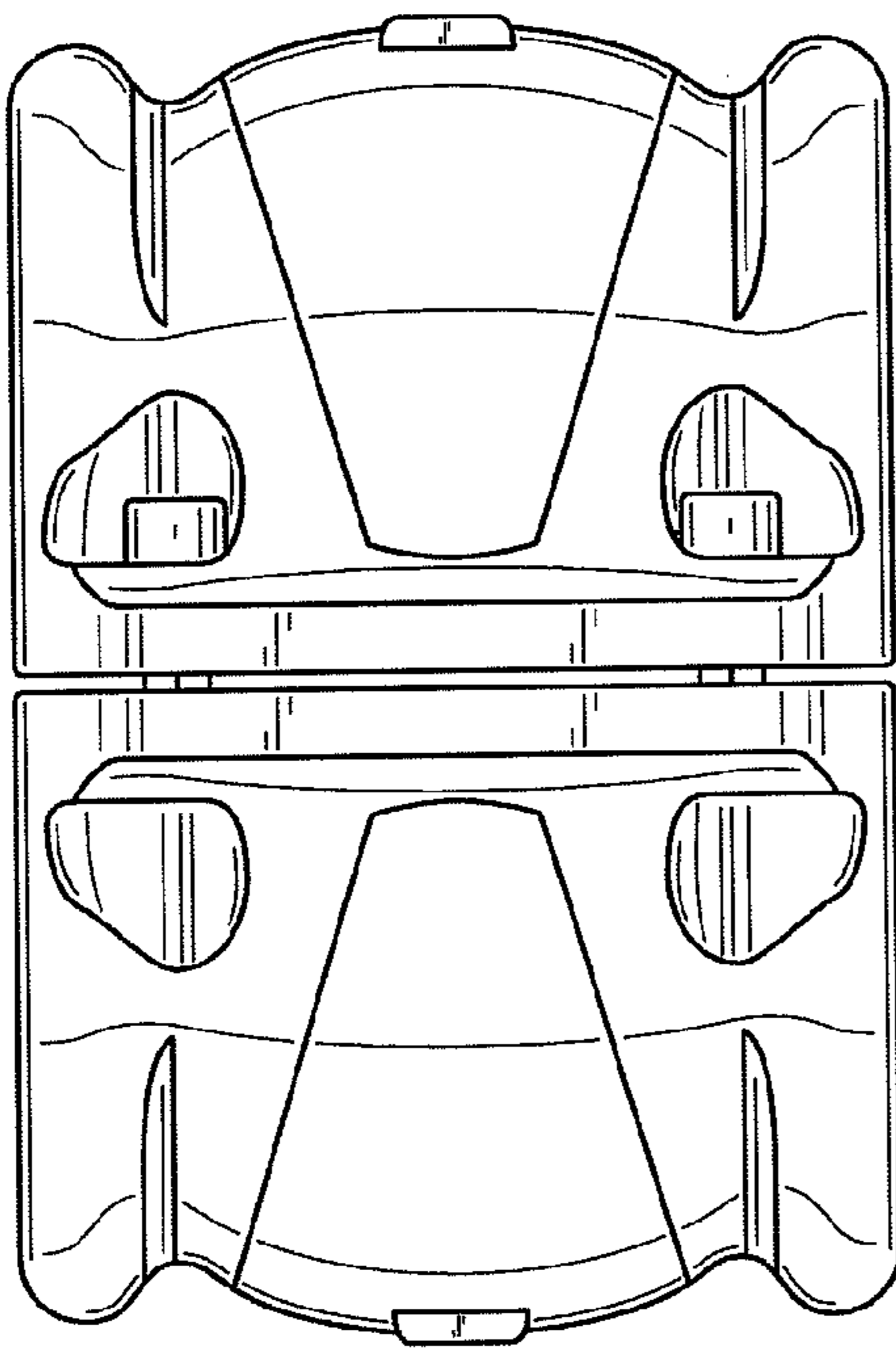

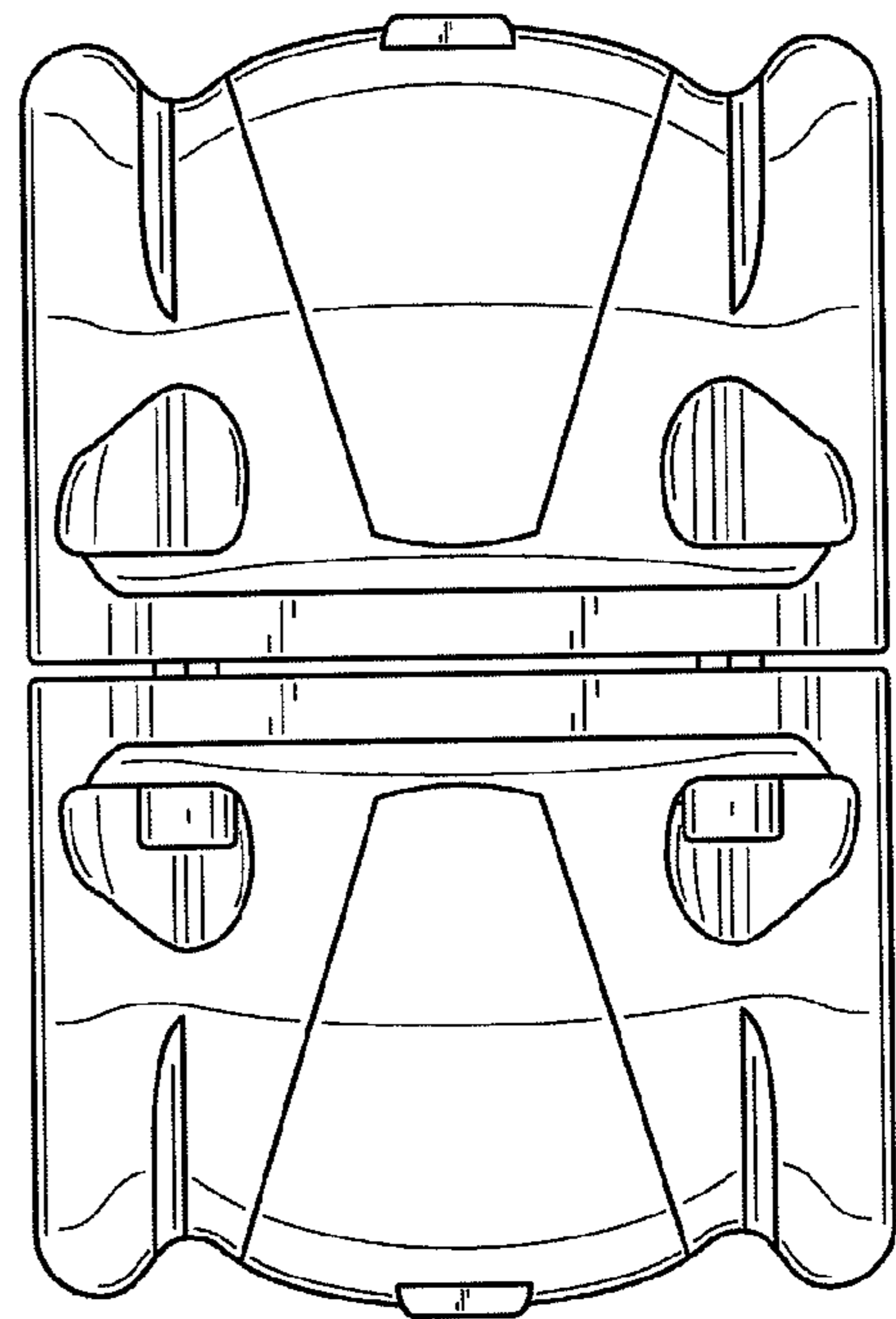

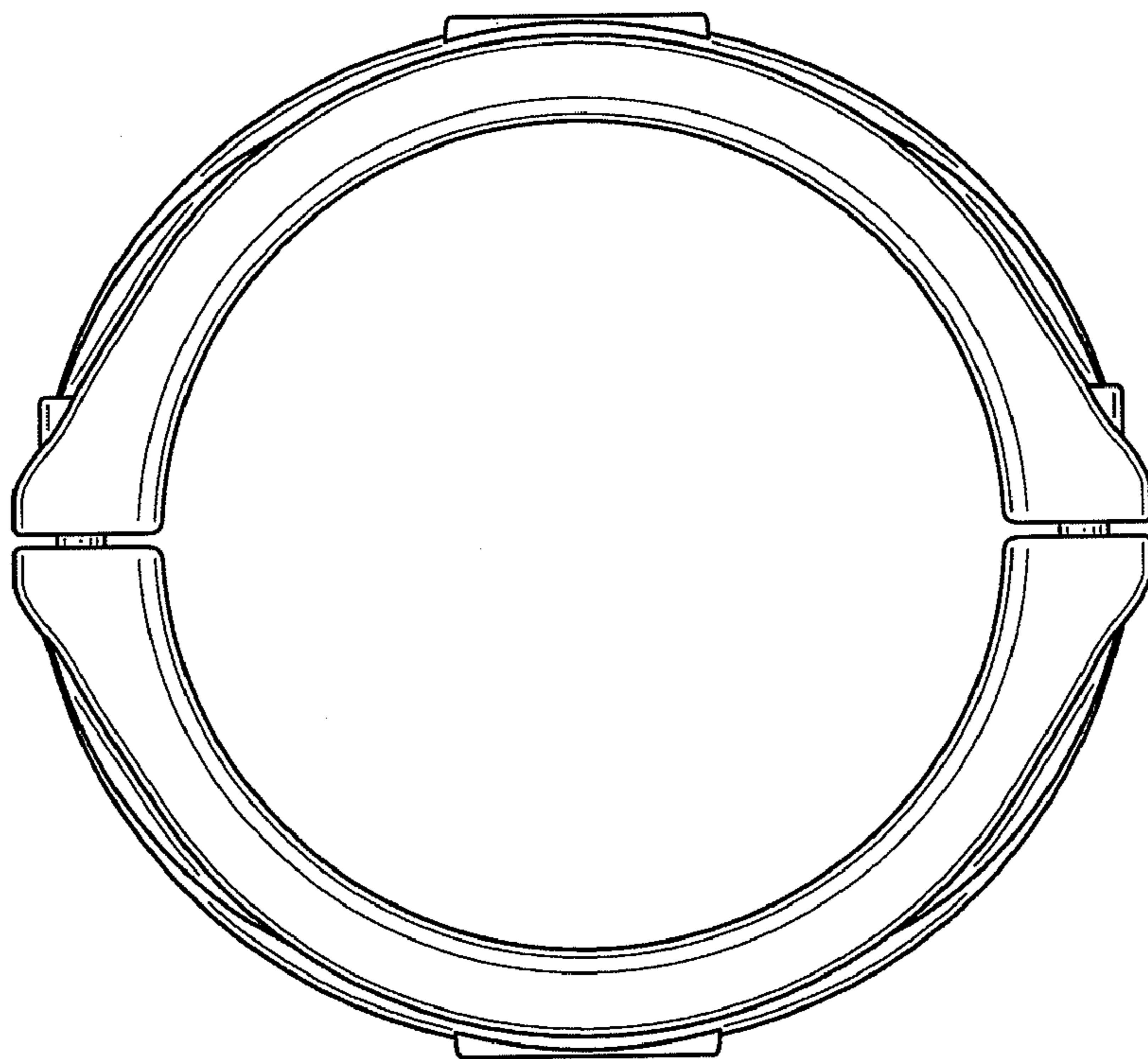

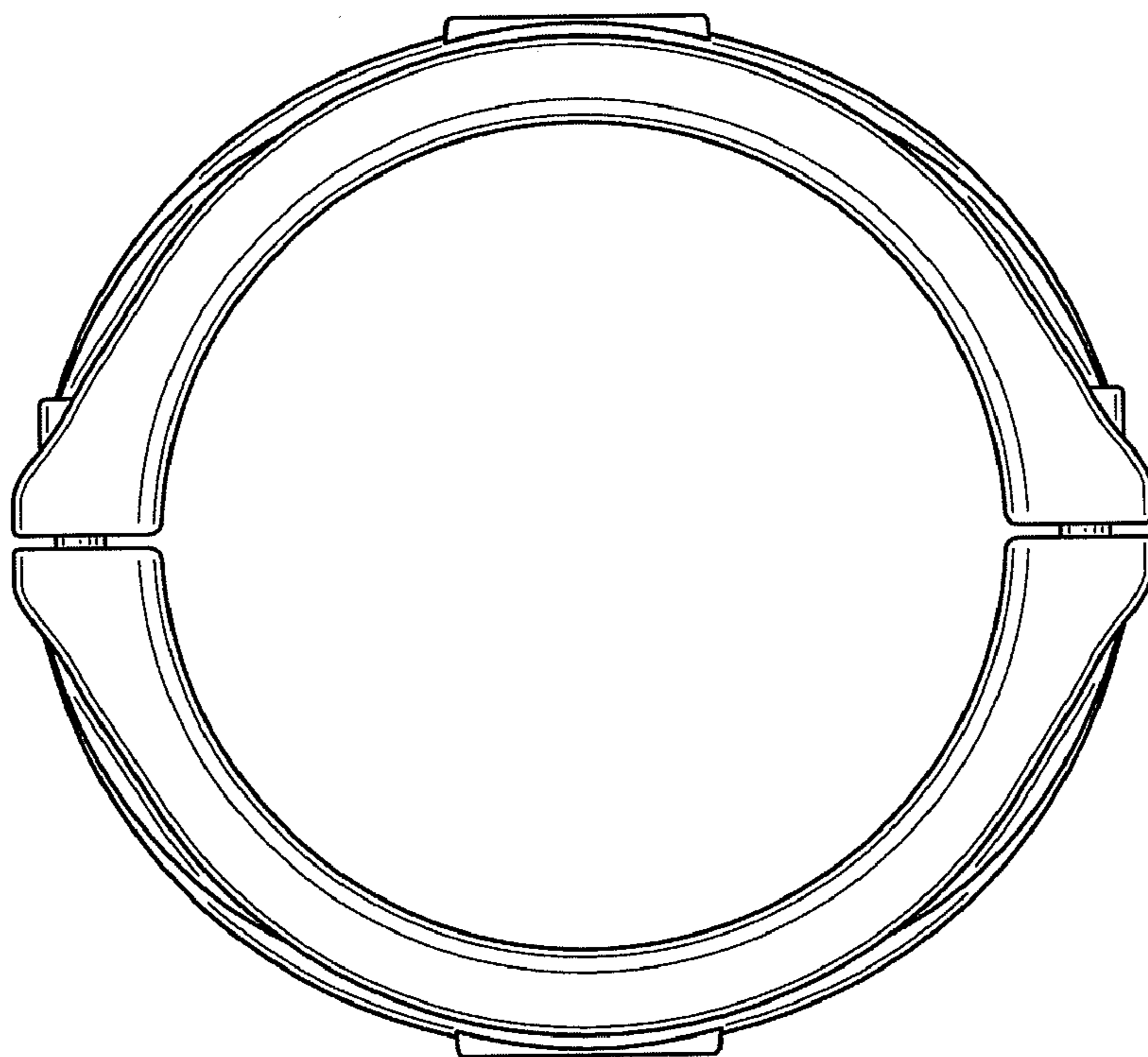

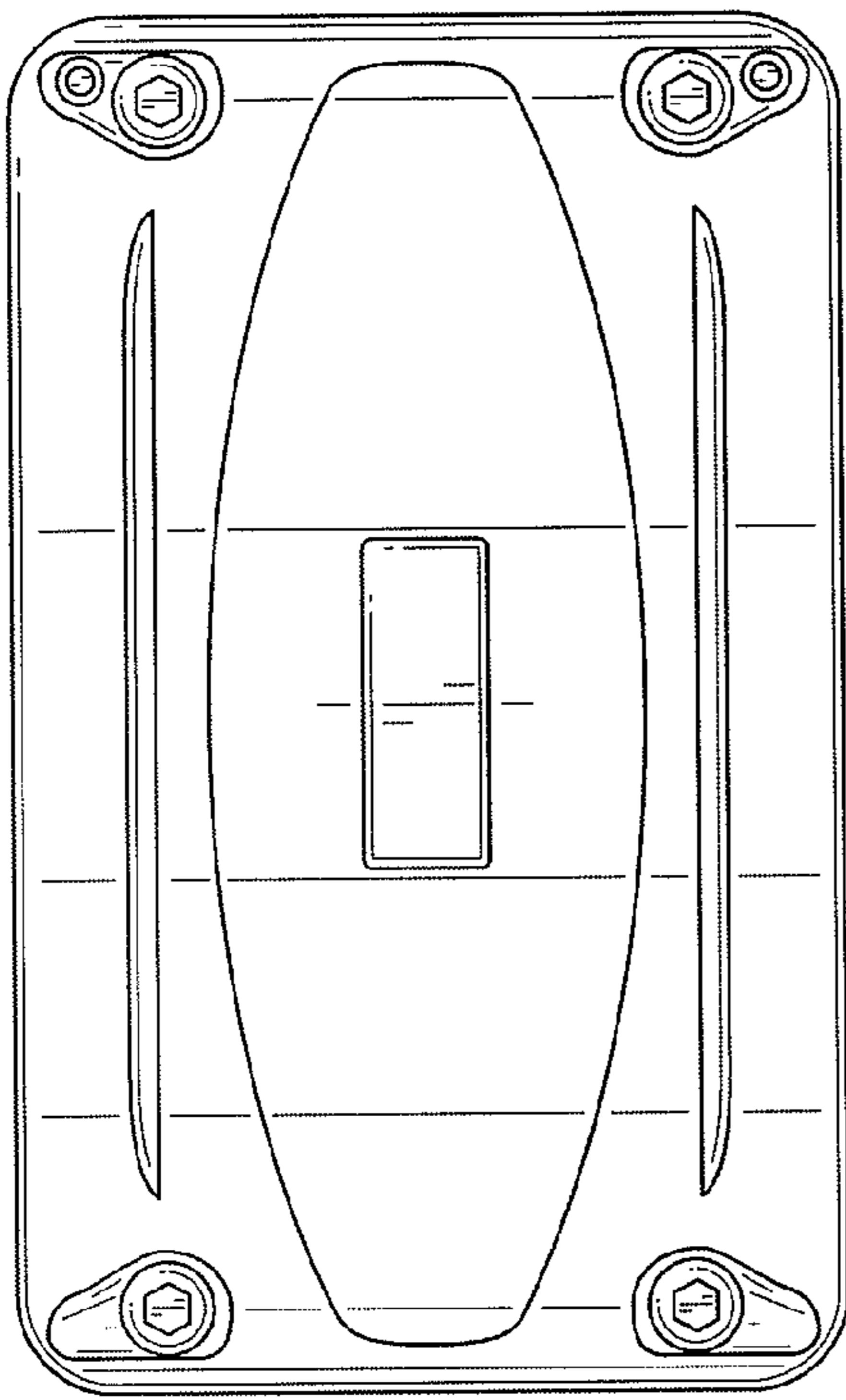

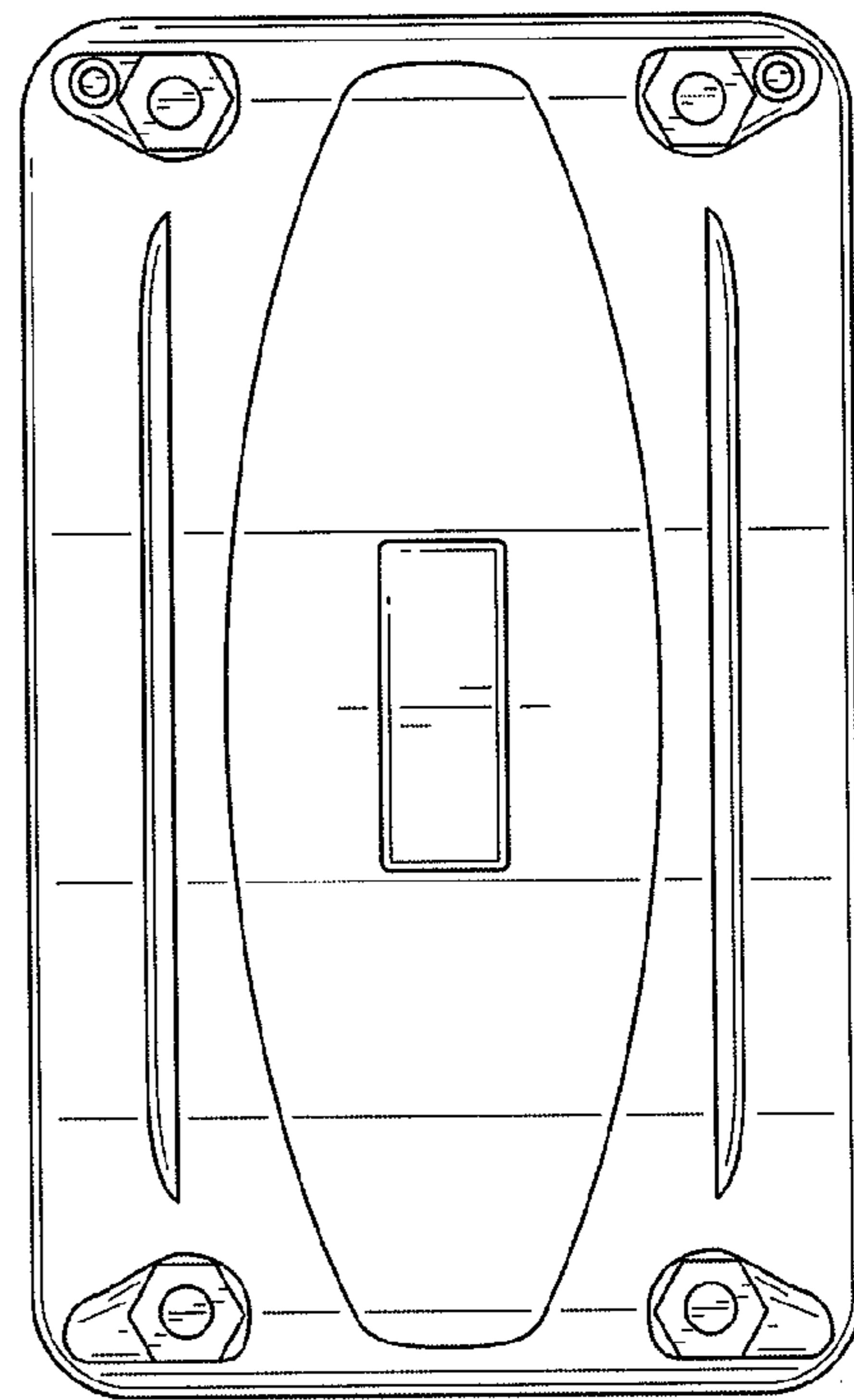
