present design;

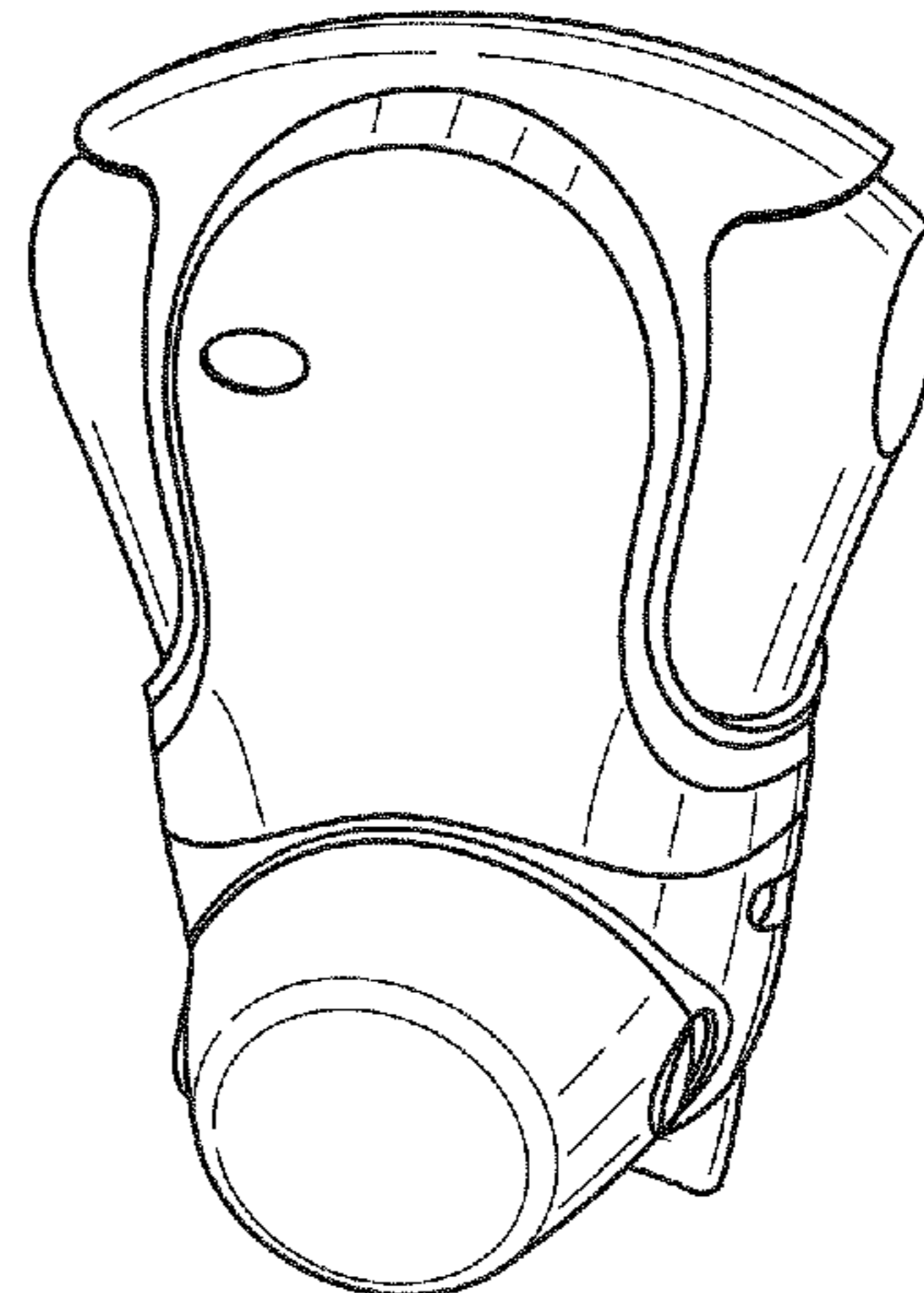
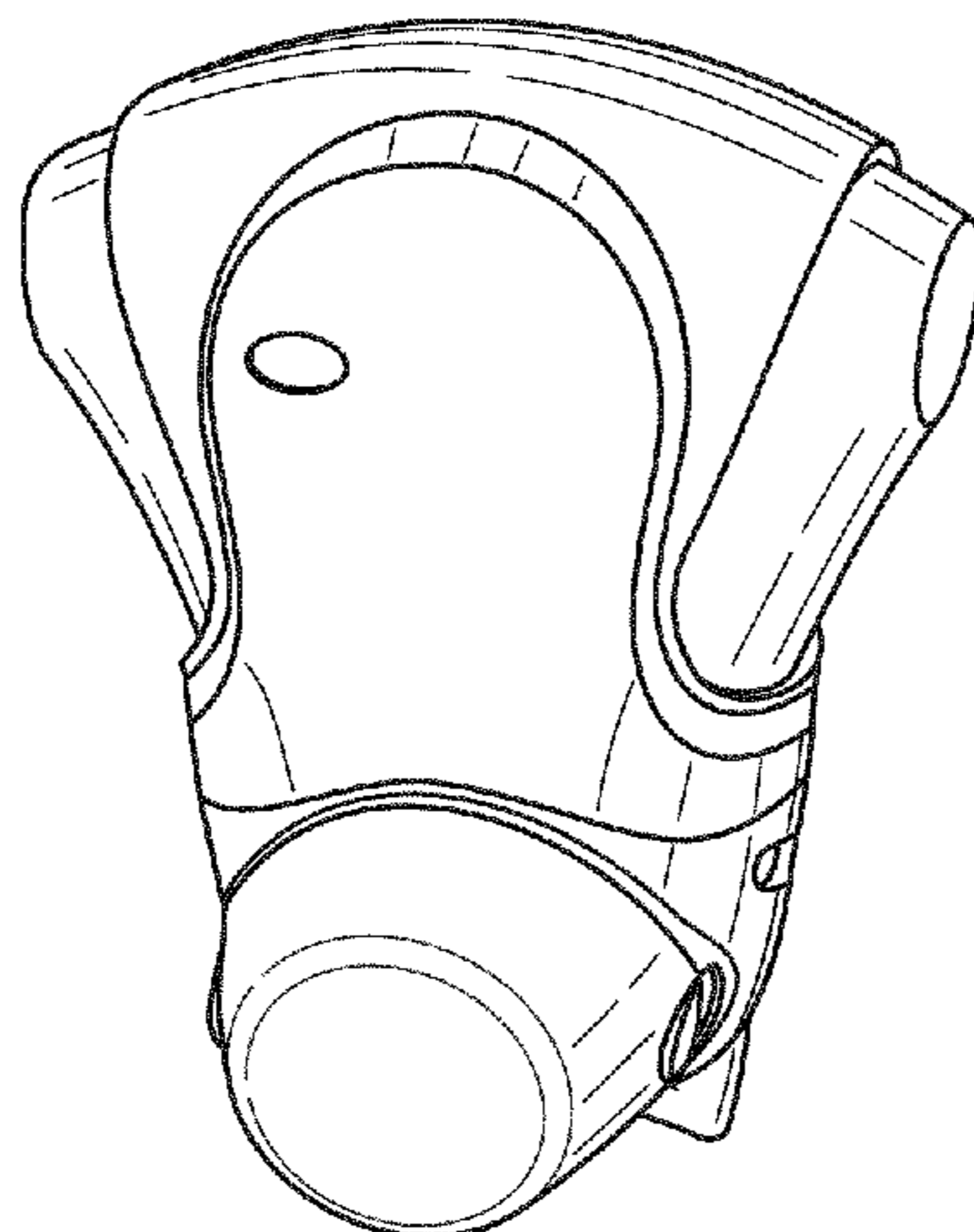
FIG. 11 is a side view of the second embodiment of the

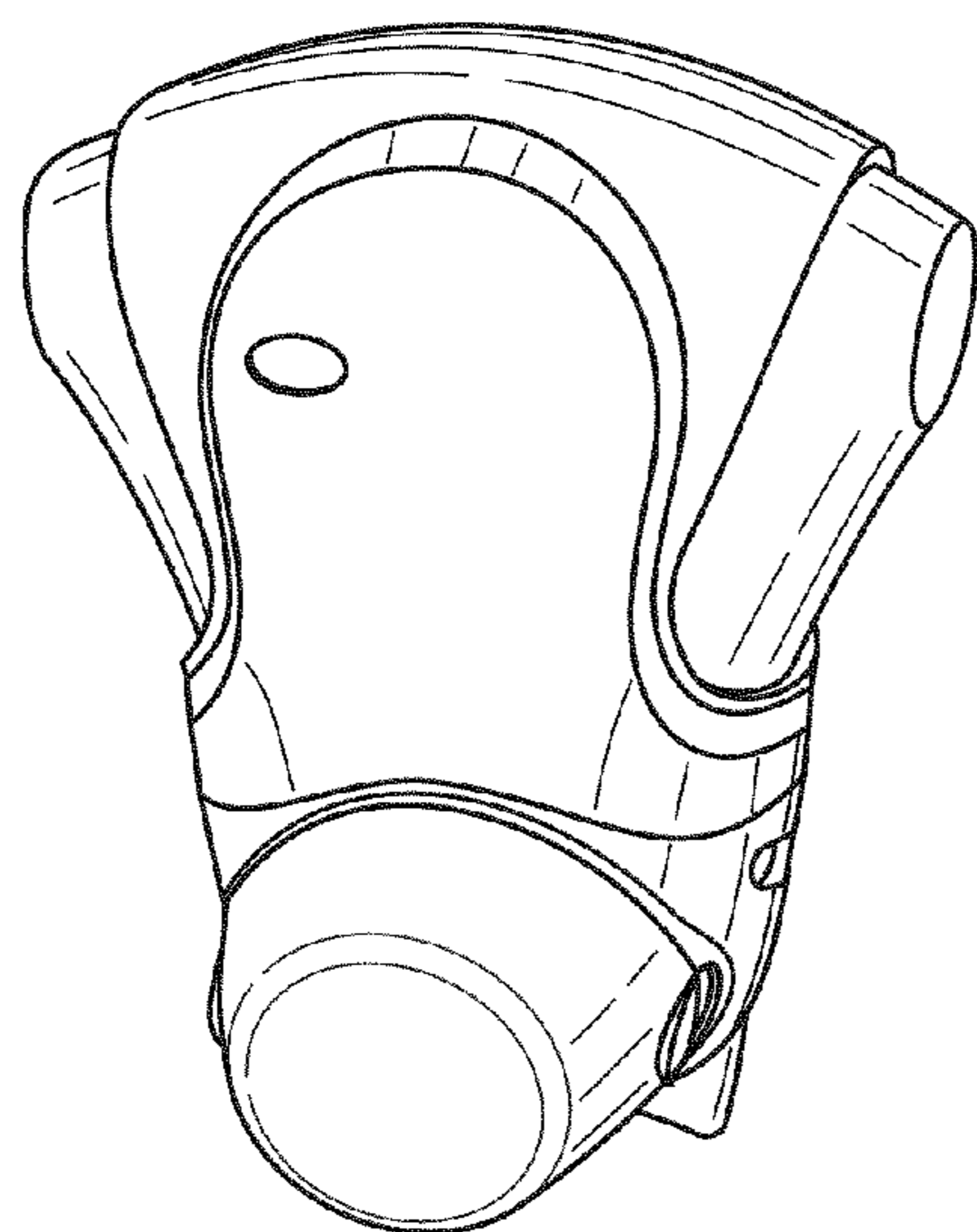

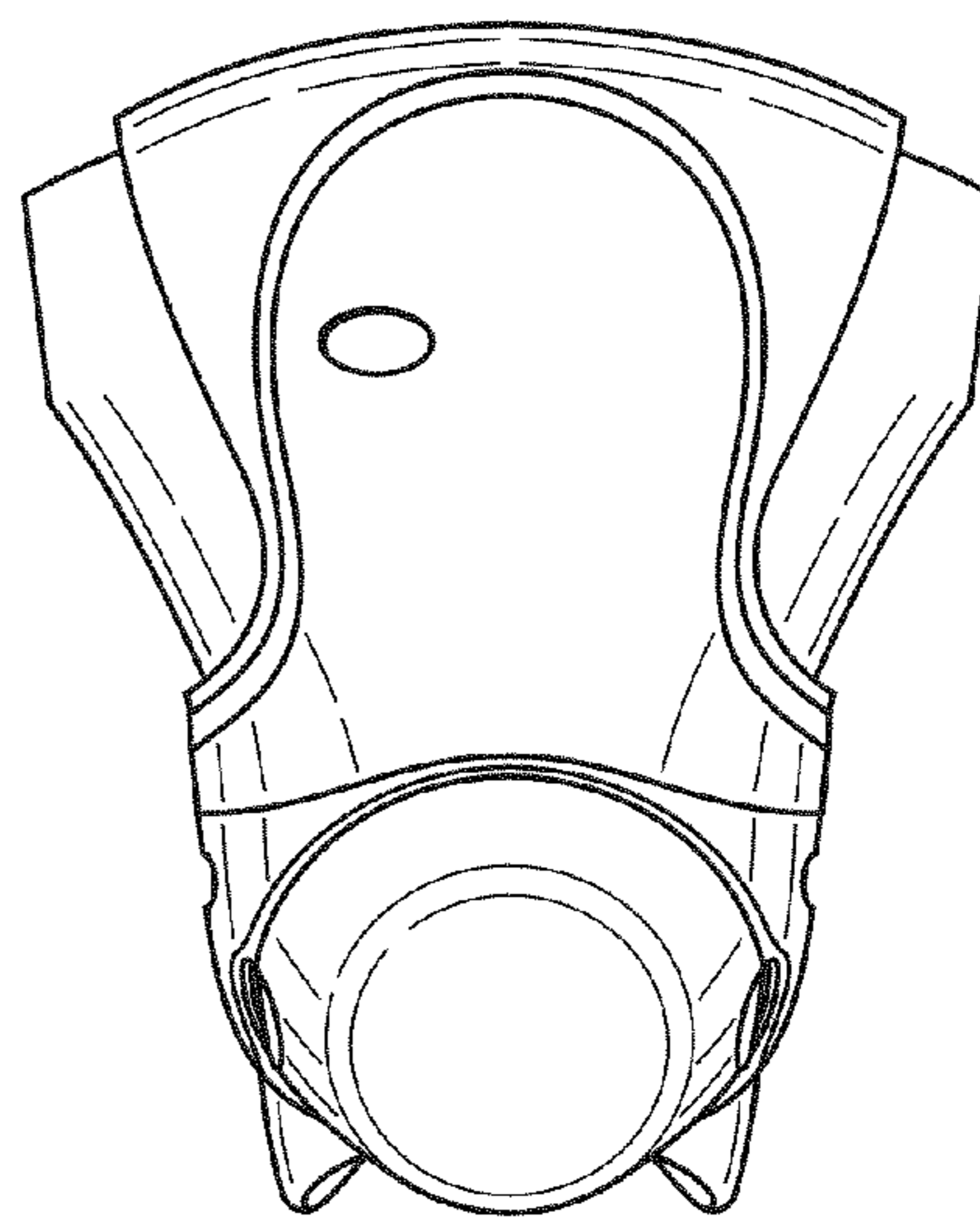

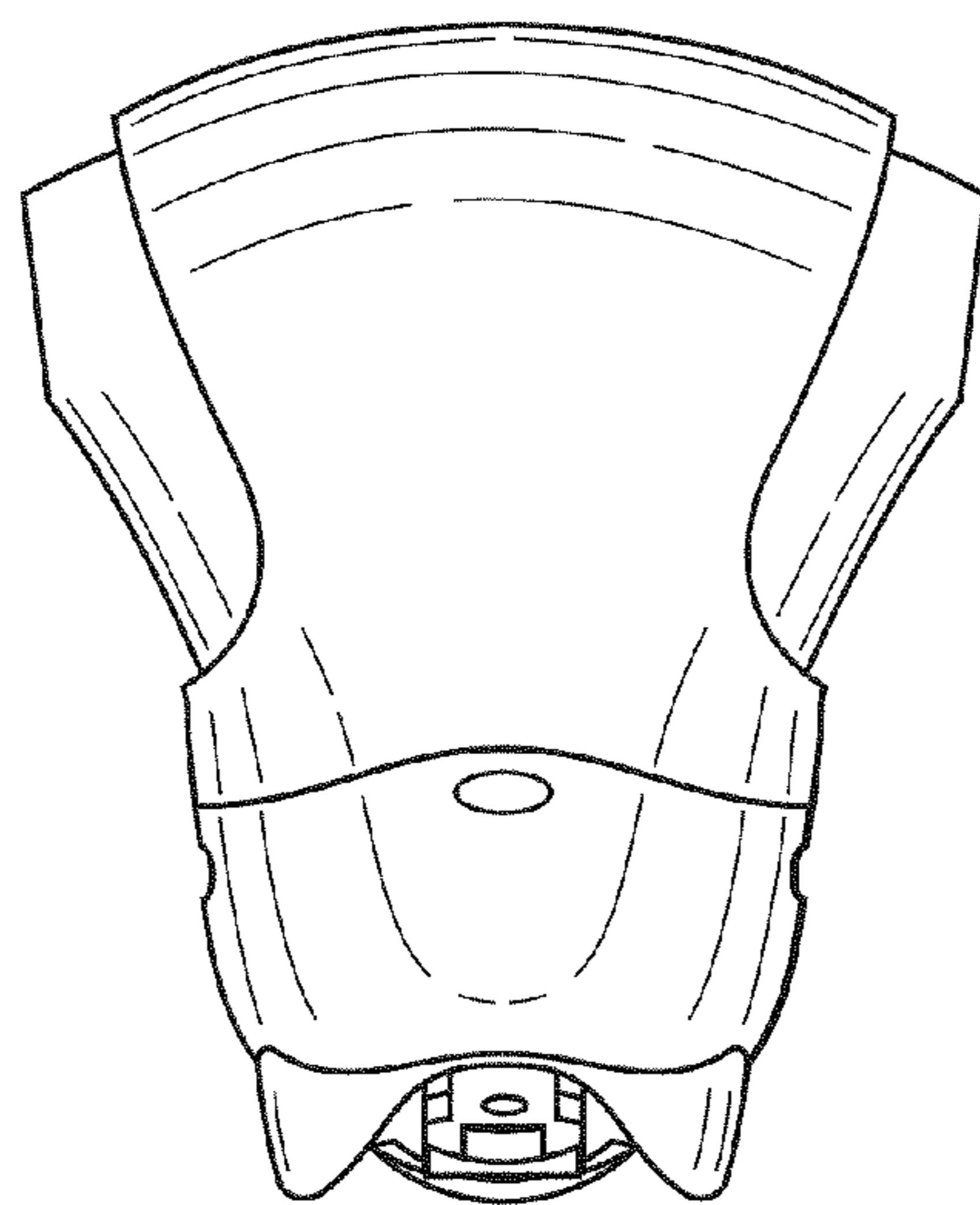

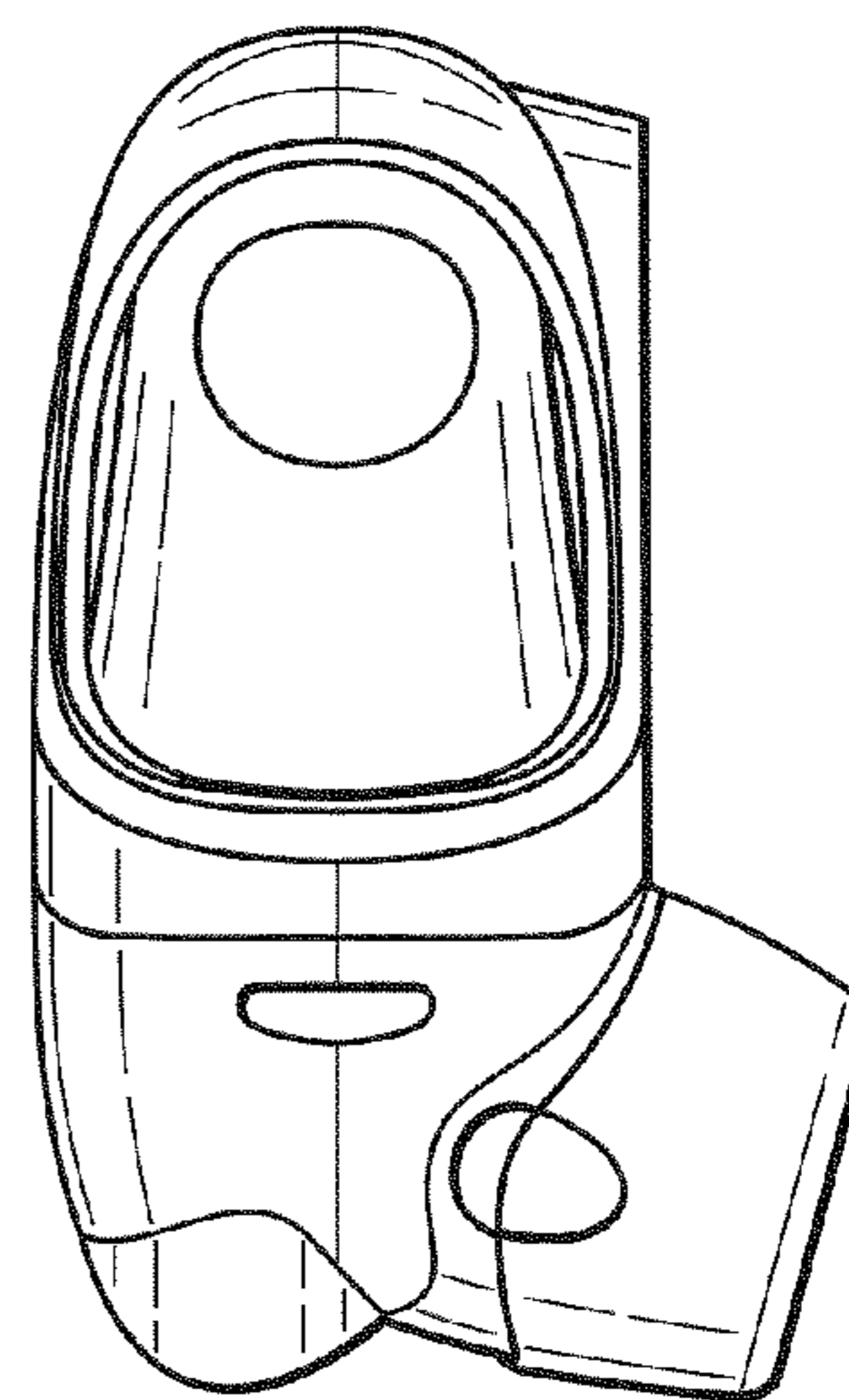

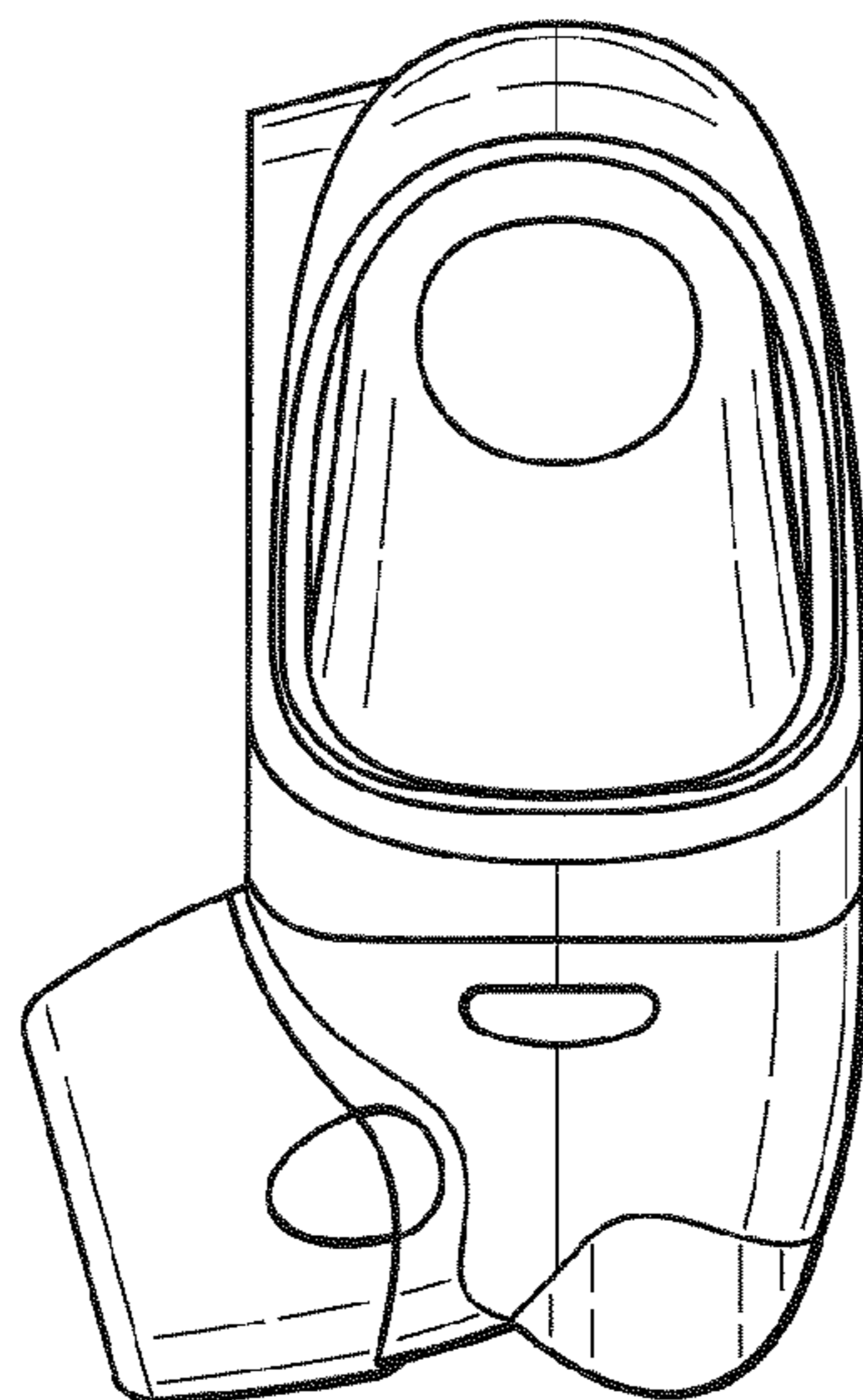

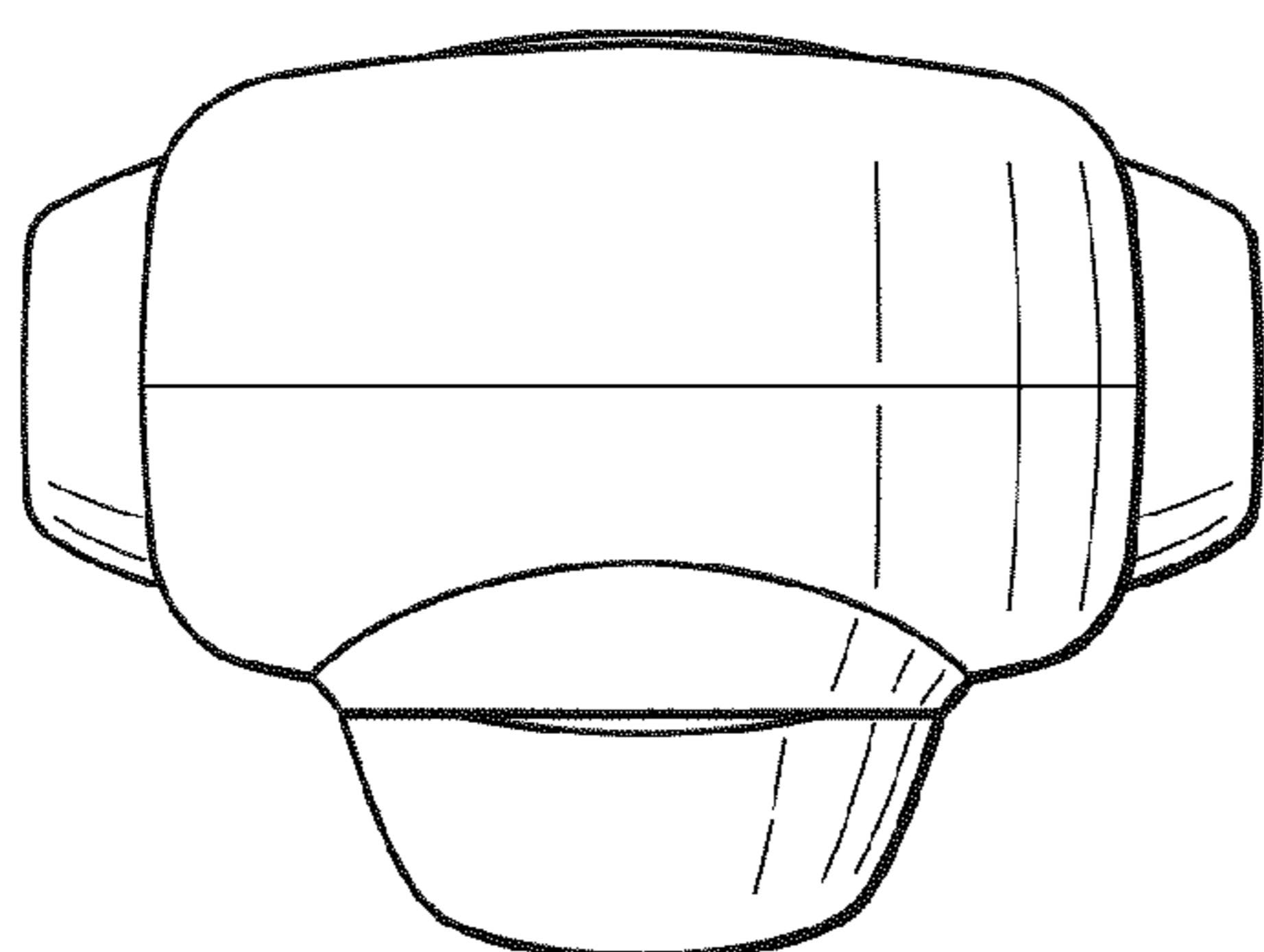

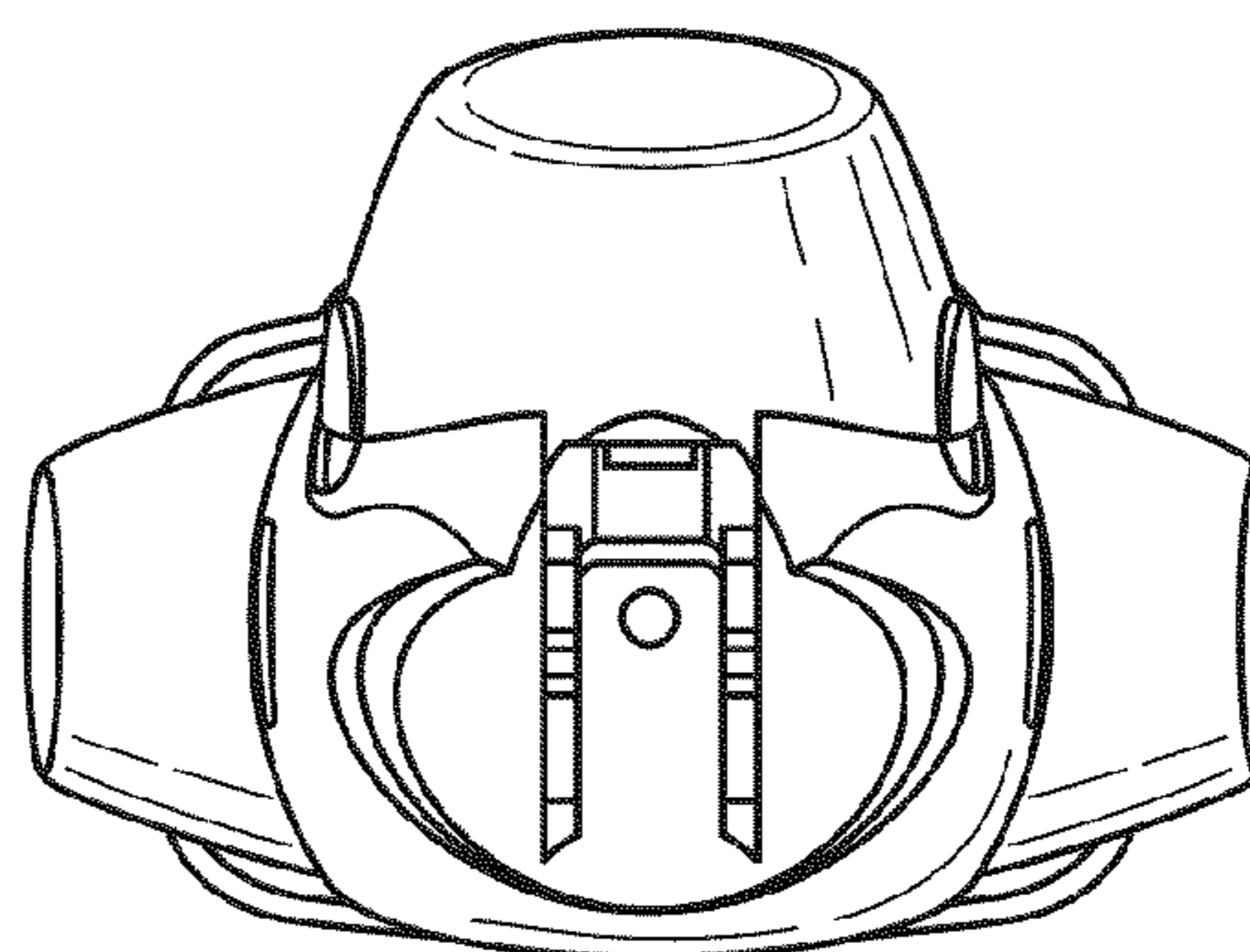

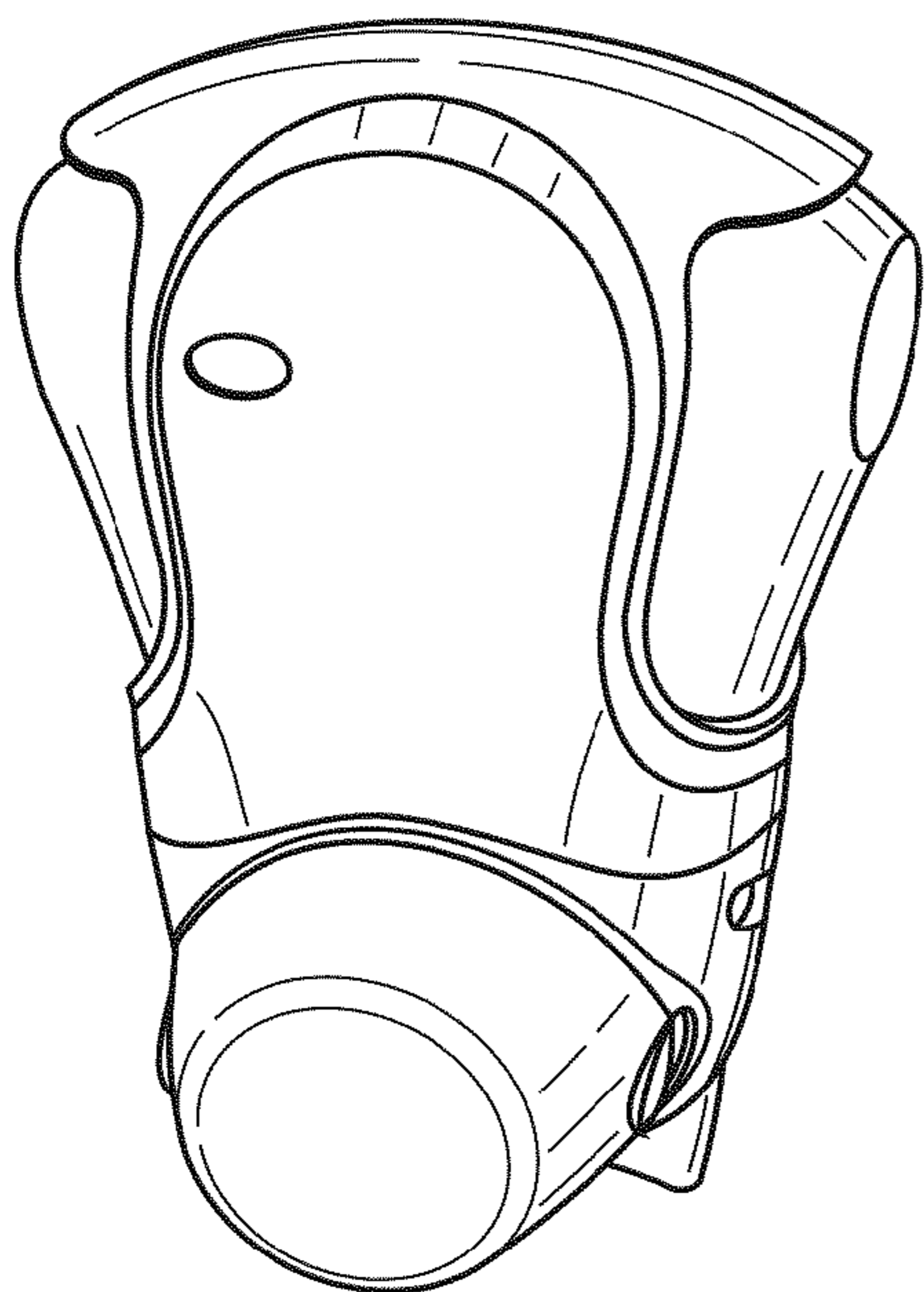

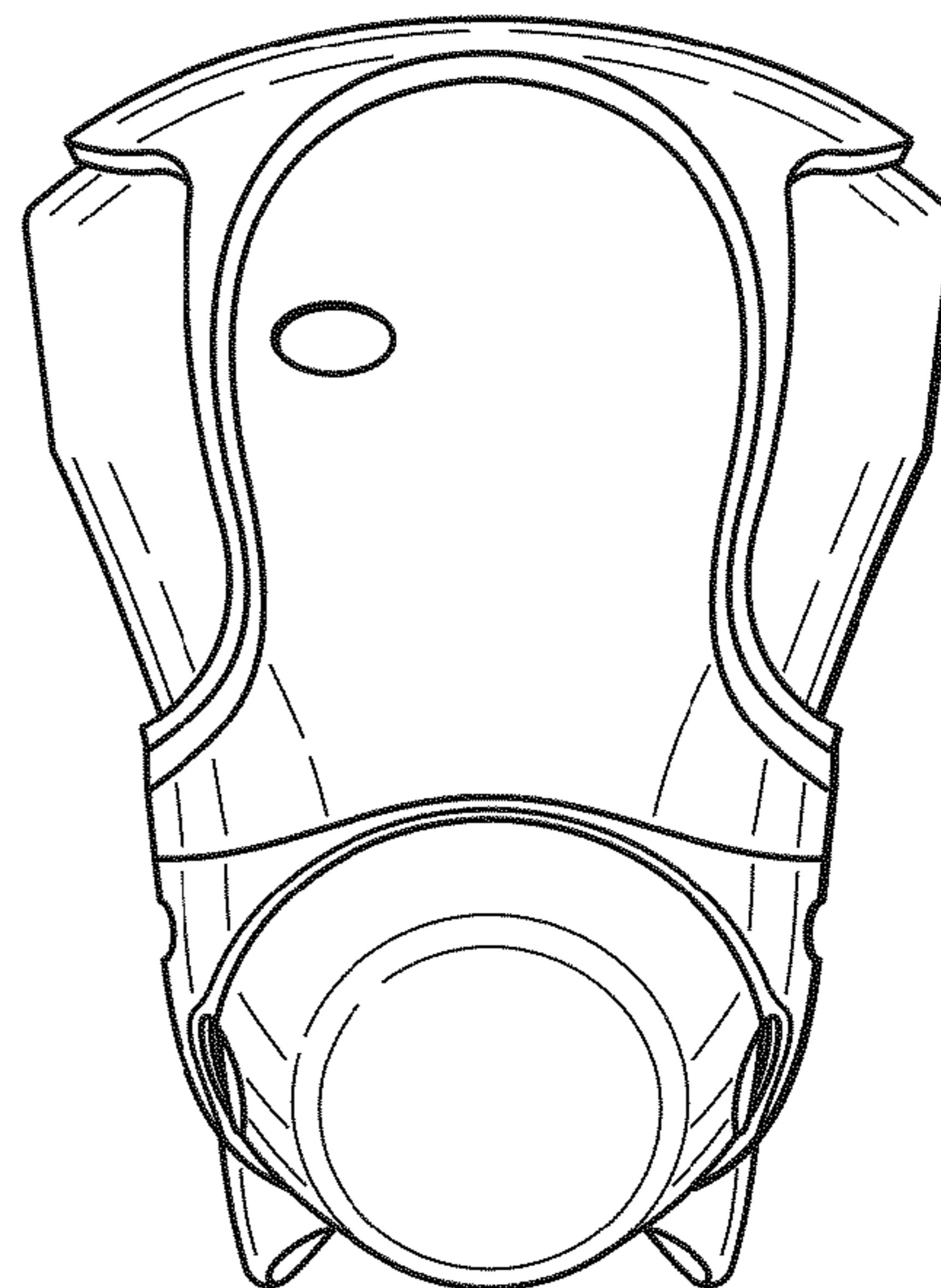

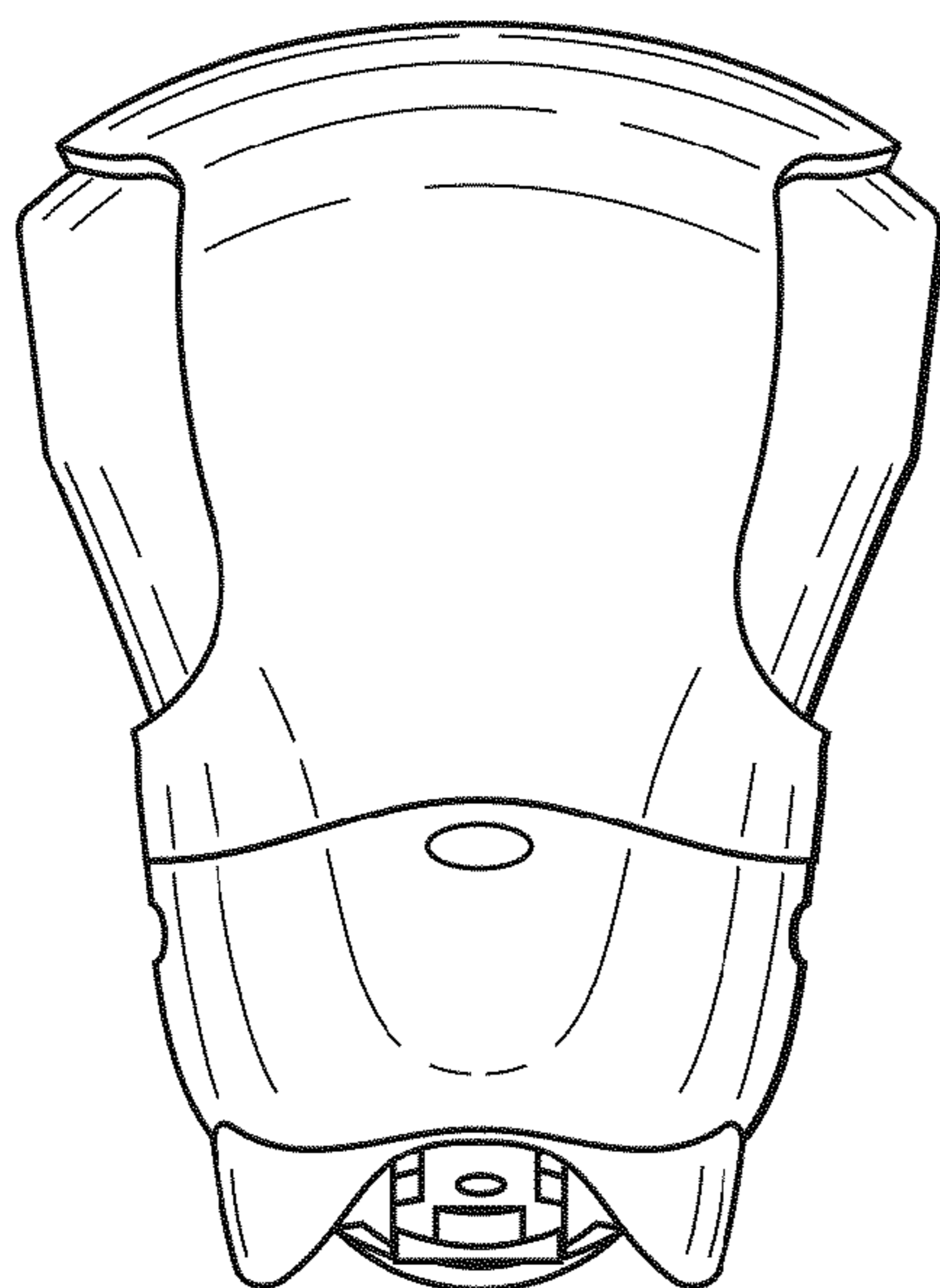

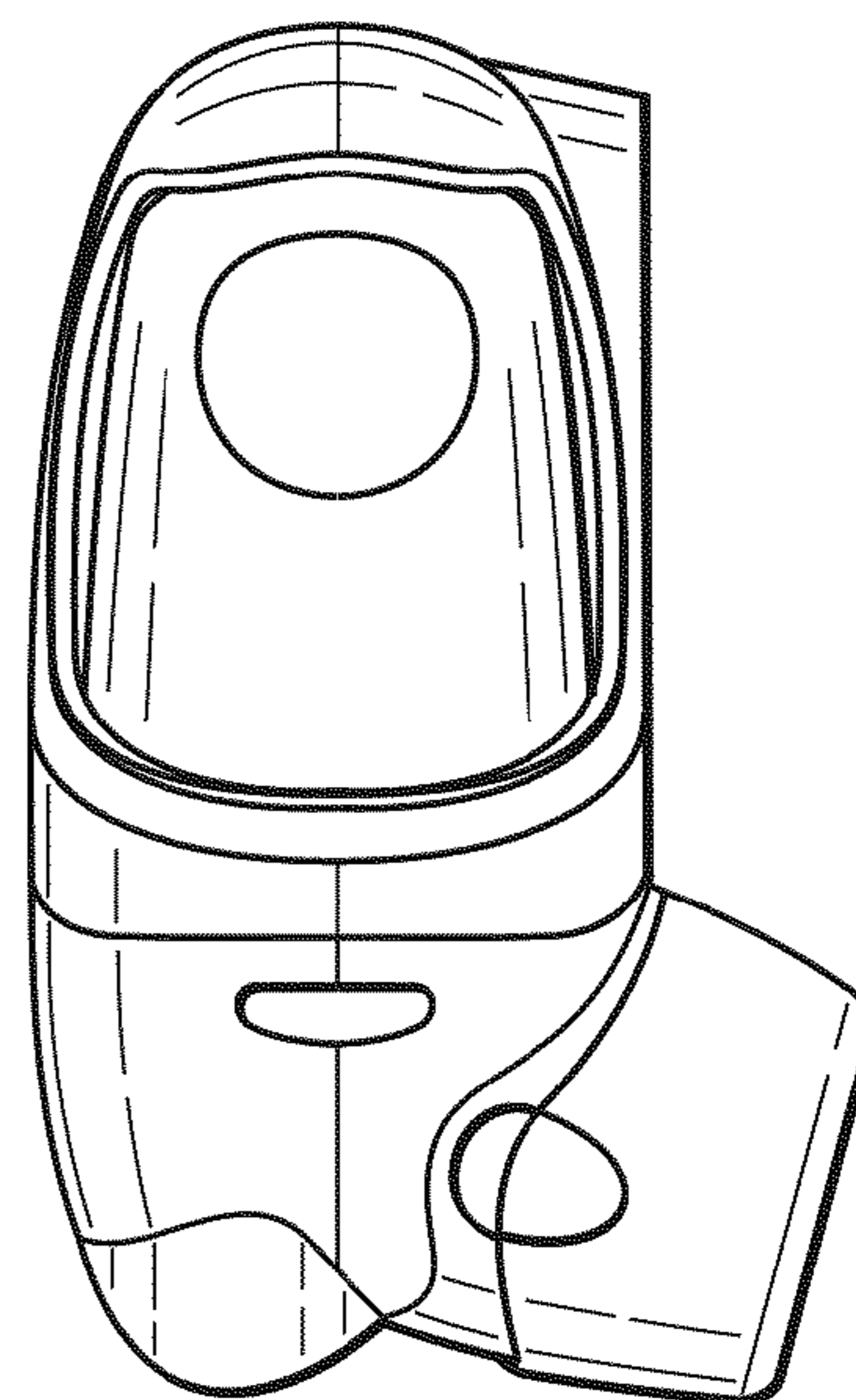

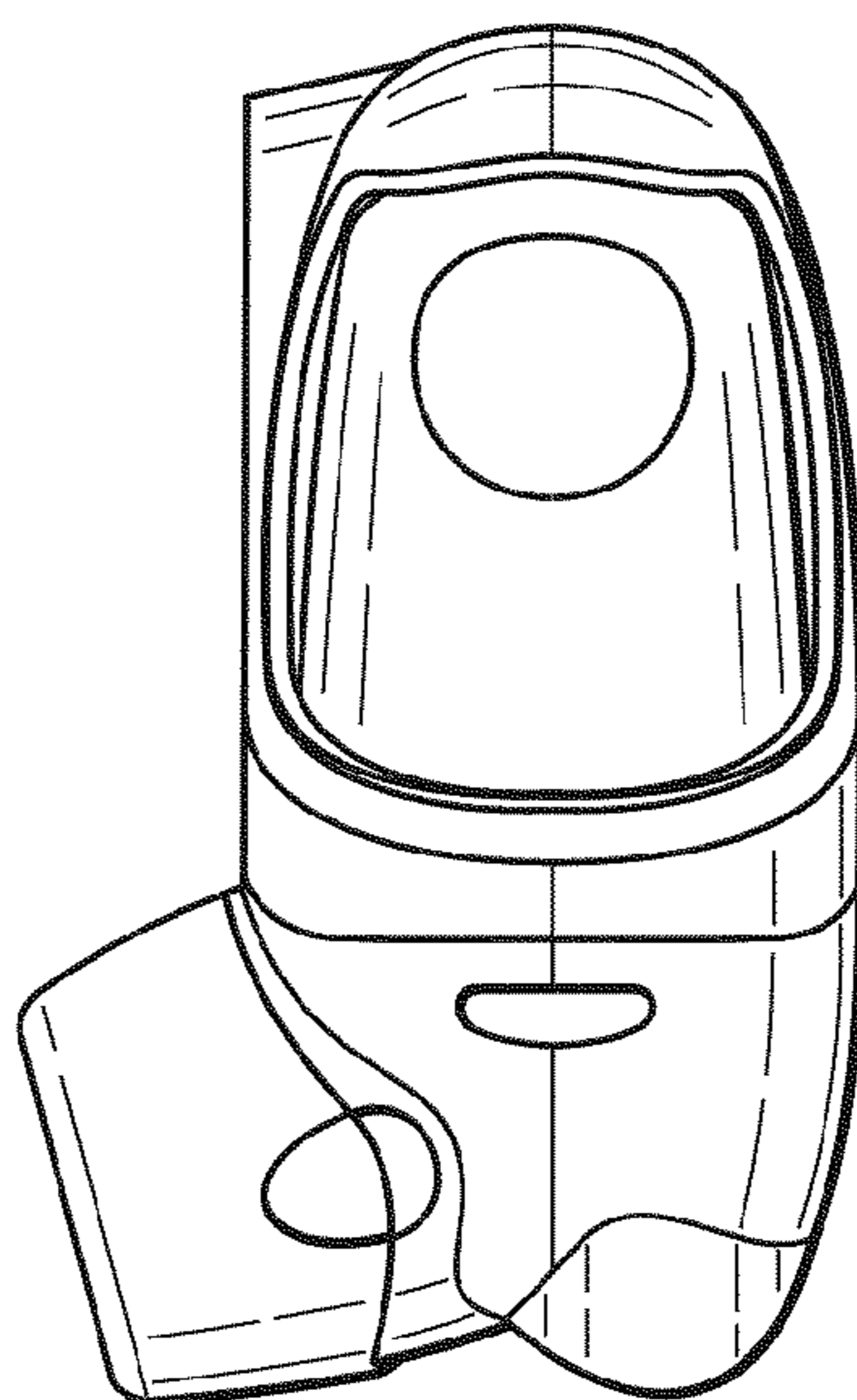

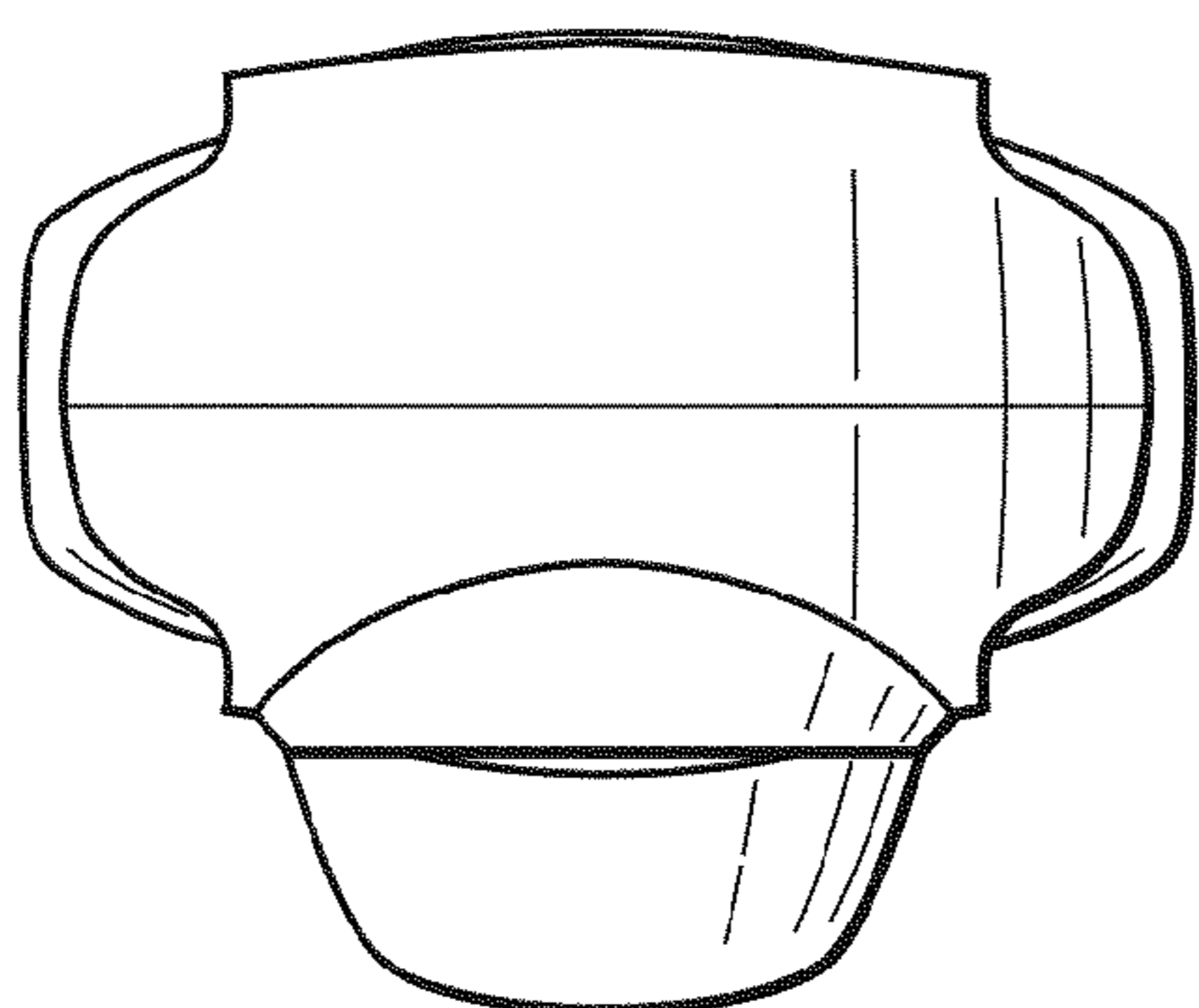

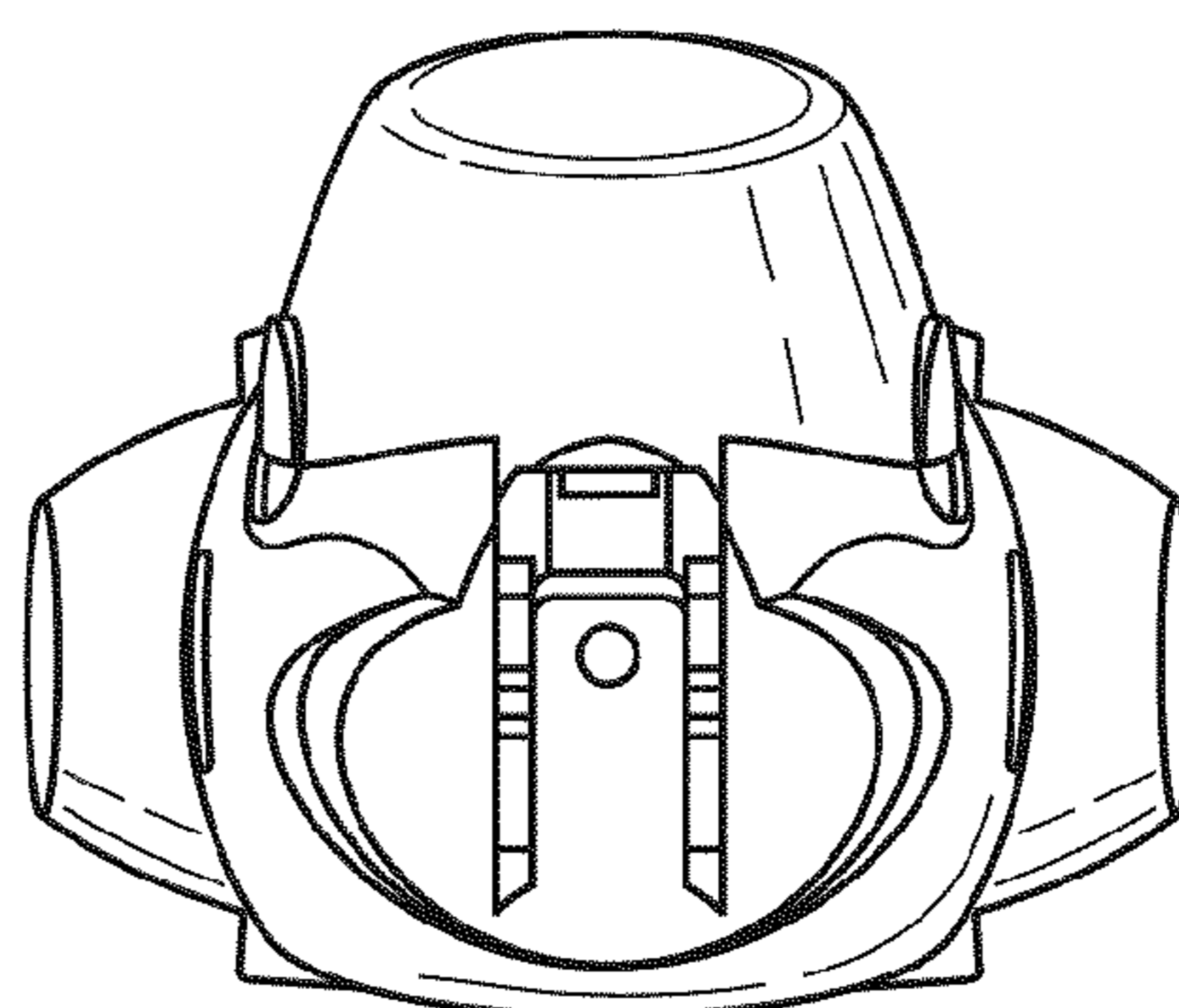
