**DESCRIPTION**

FIG. 1 is a perspective view of an impression coping, showing the new design;

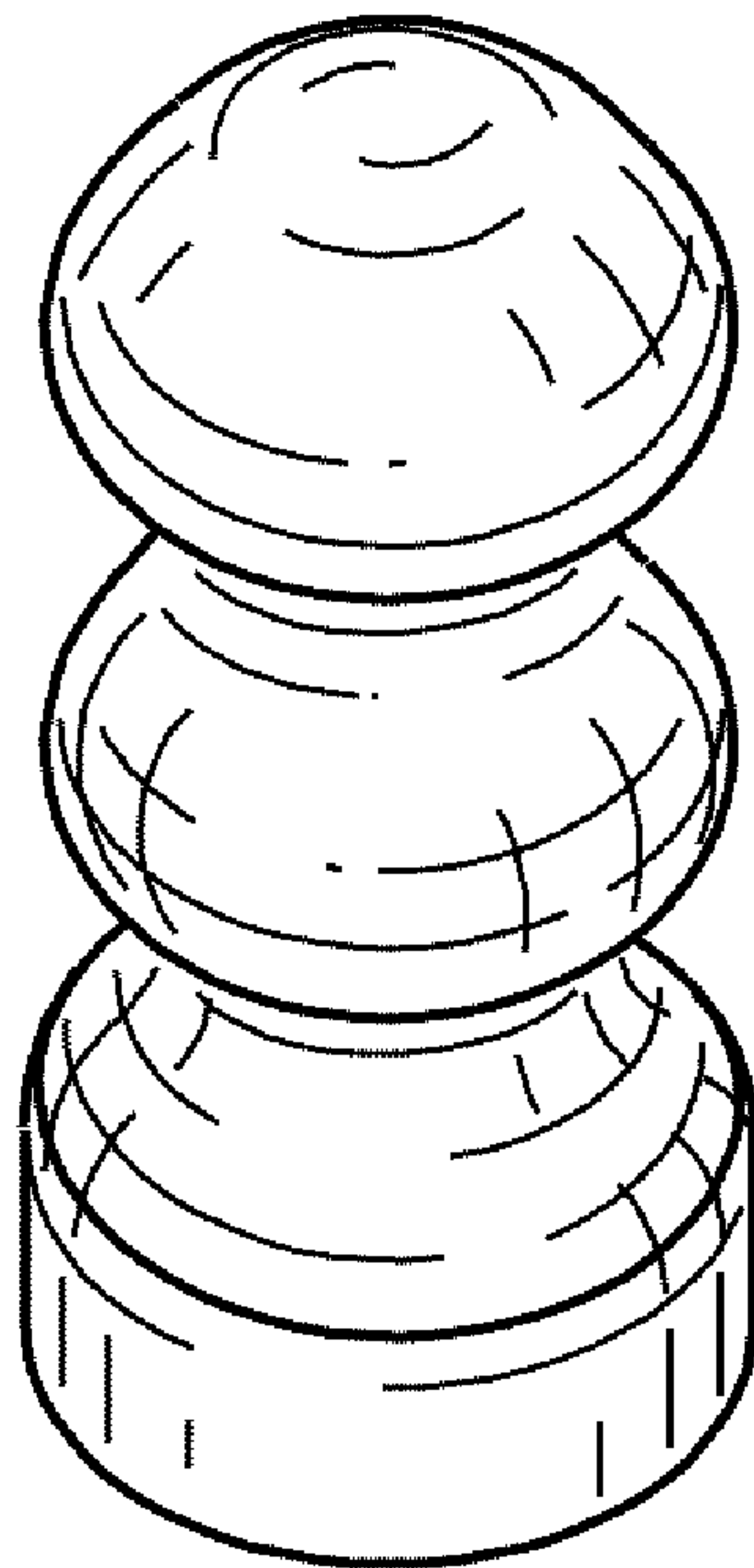
FIG. 2 is a front elevational view thereof, the rear elevational view, left-side elevational view, and right-side elevational view all being a mirror image thereof;

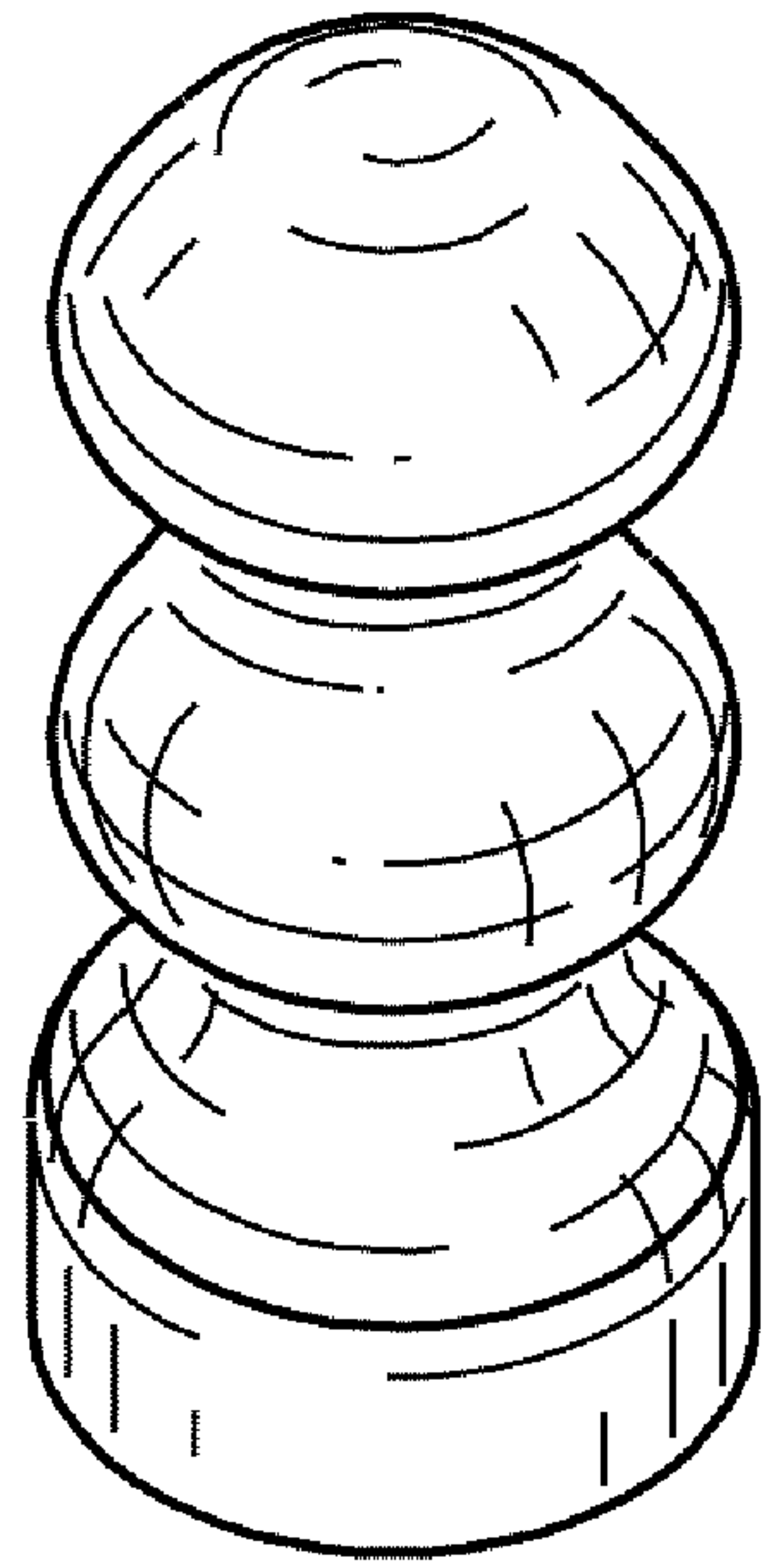

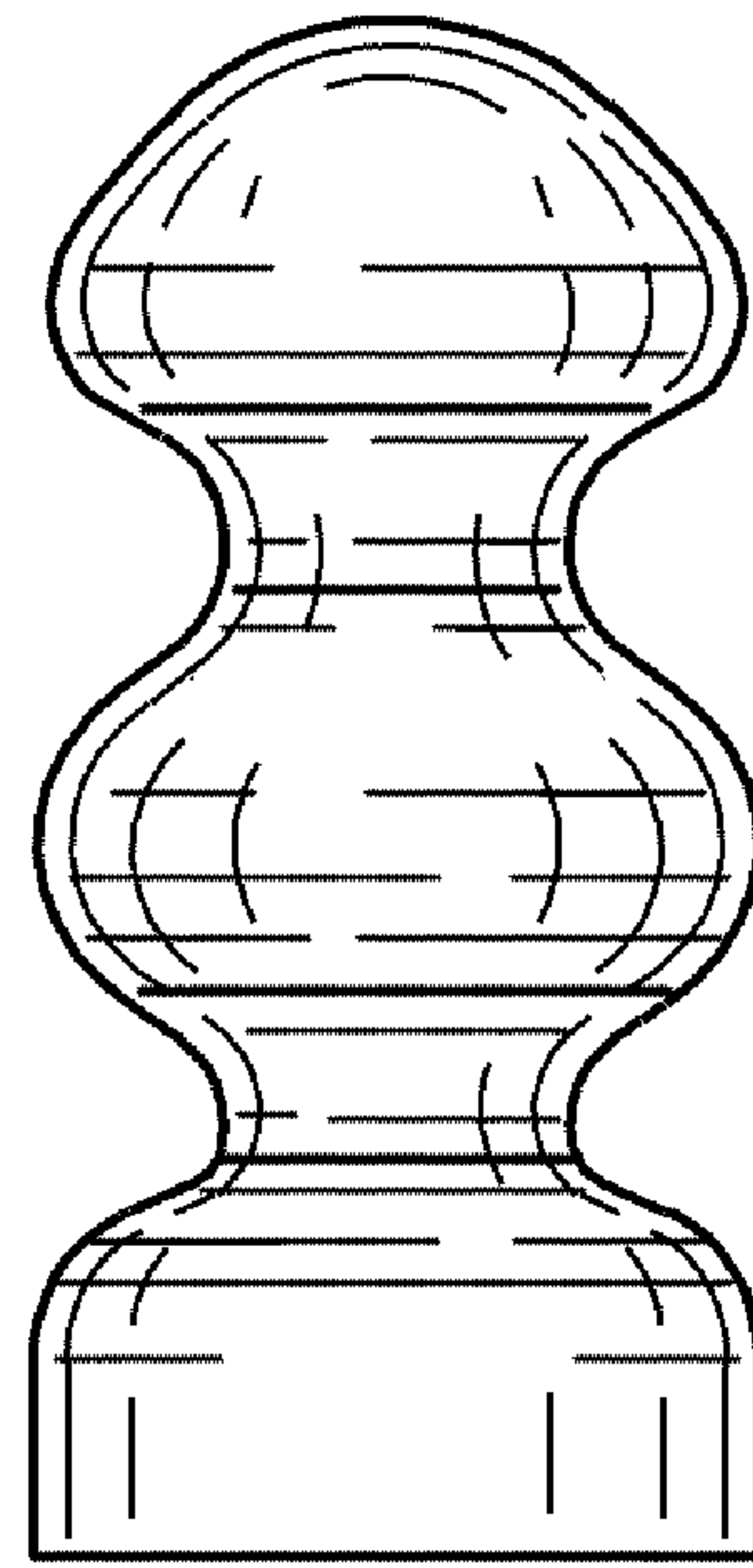

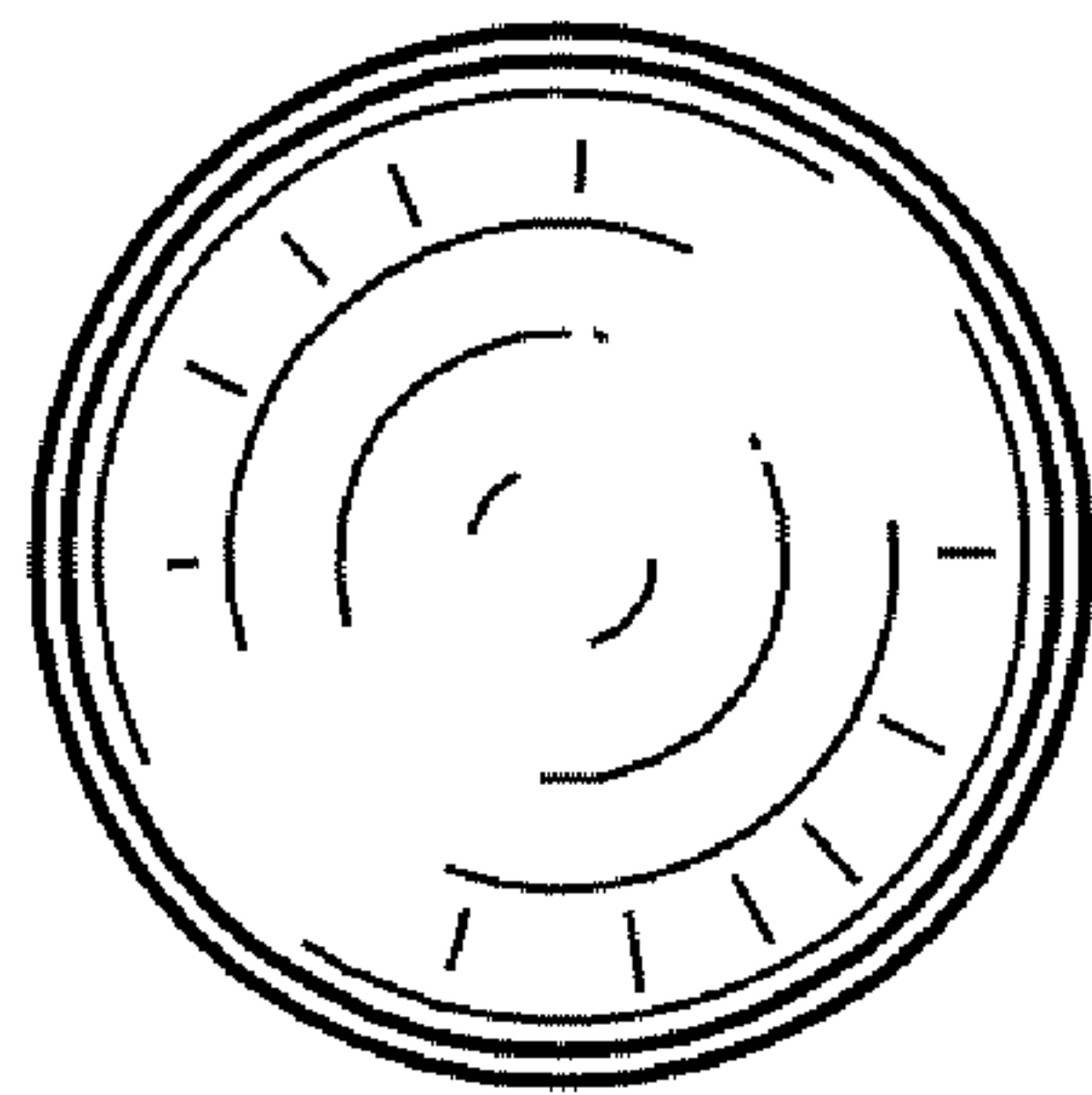

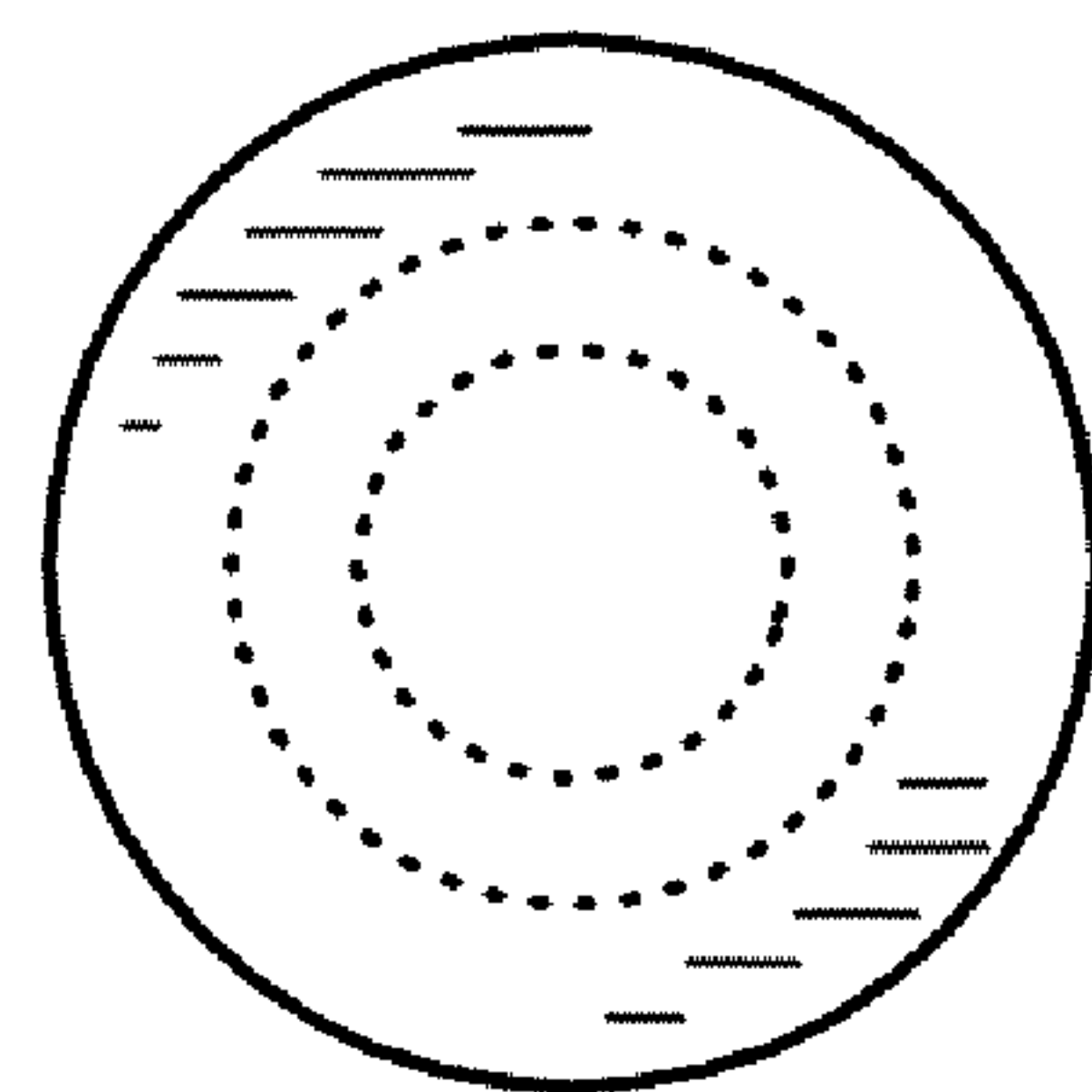
