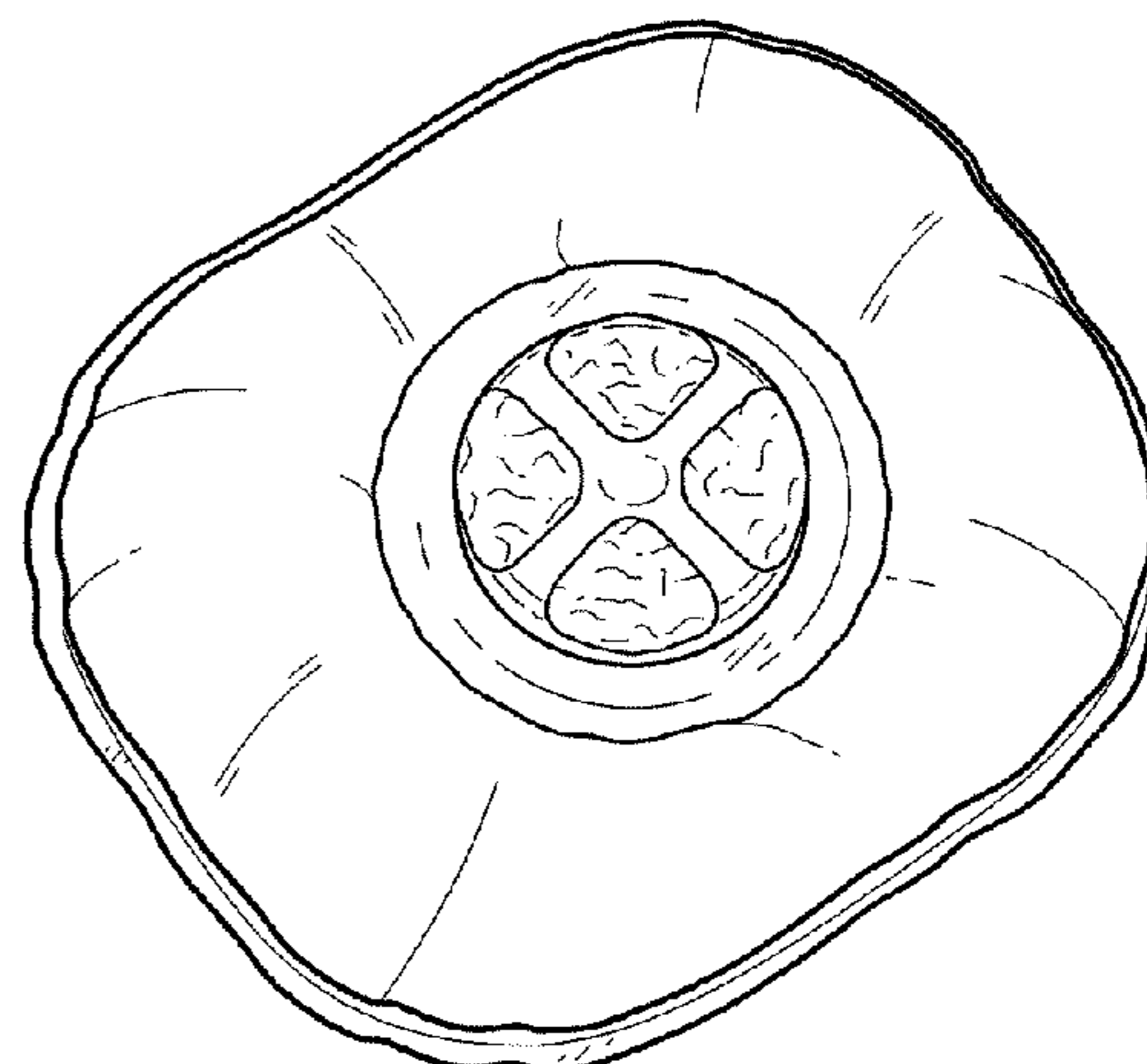
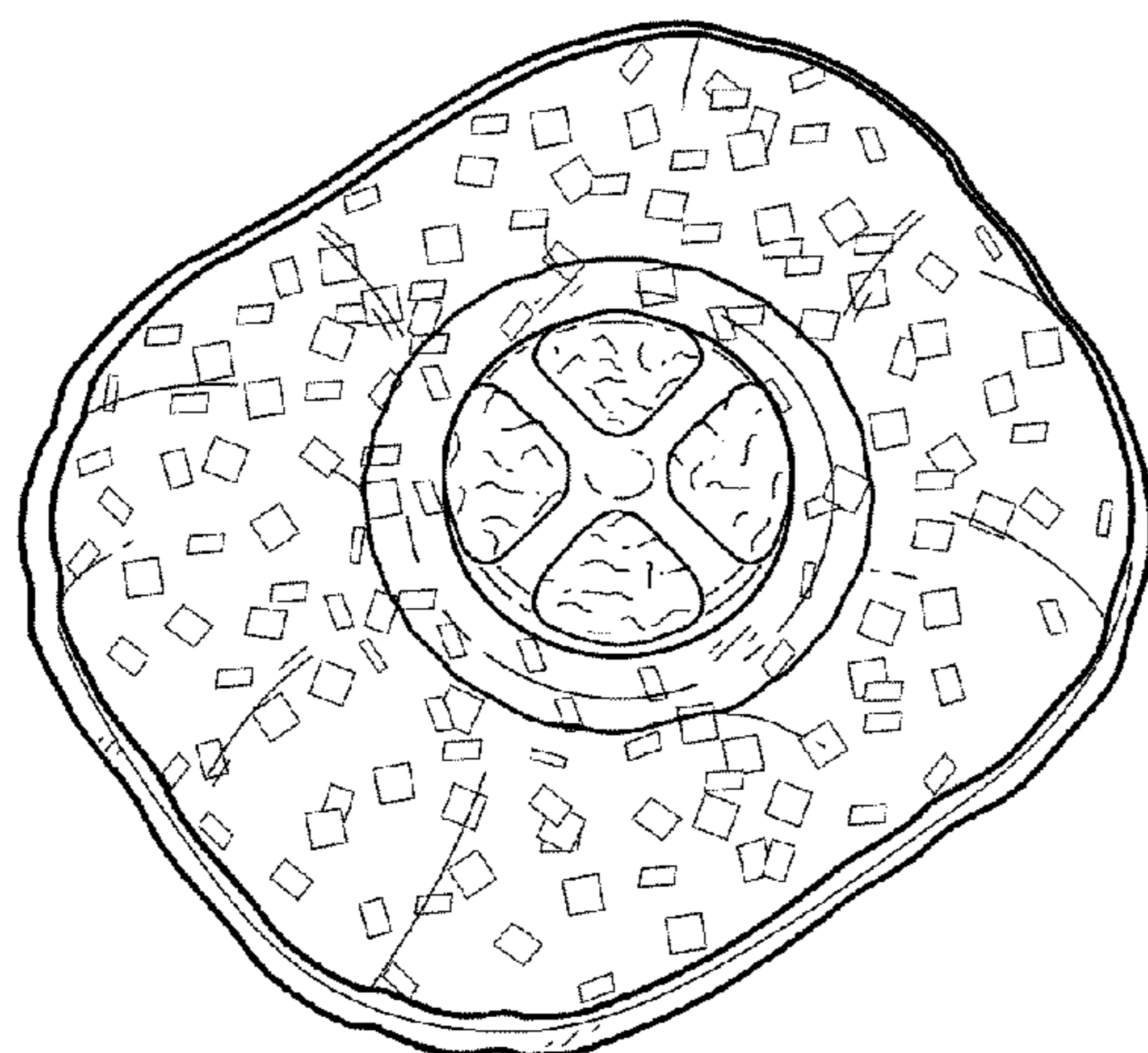
(57) **CLAIM**

The ornamental design for a capsule containing washing products, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of the capsule containing washing products;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is bottom plan view thereof;  
FIG. 4 is an elevation view of the front thereof;  
FIG. 5 is an elevation view of the rear thereof;  
FIG. 6 is an elevation view of the right side thereof;

FIG. 8 is a top perspective view of a second embodiment of the capsule containing washing products;

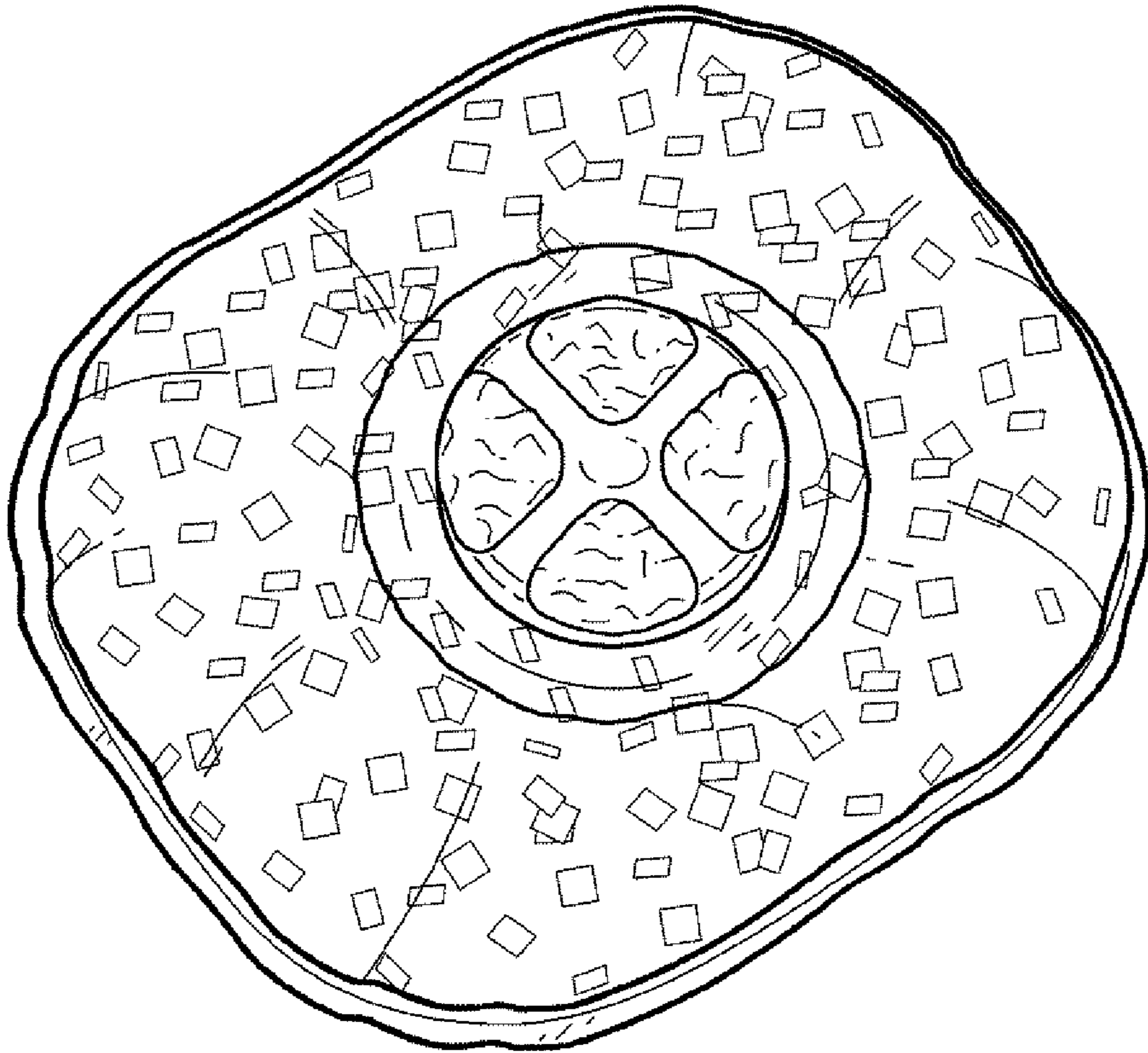

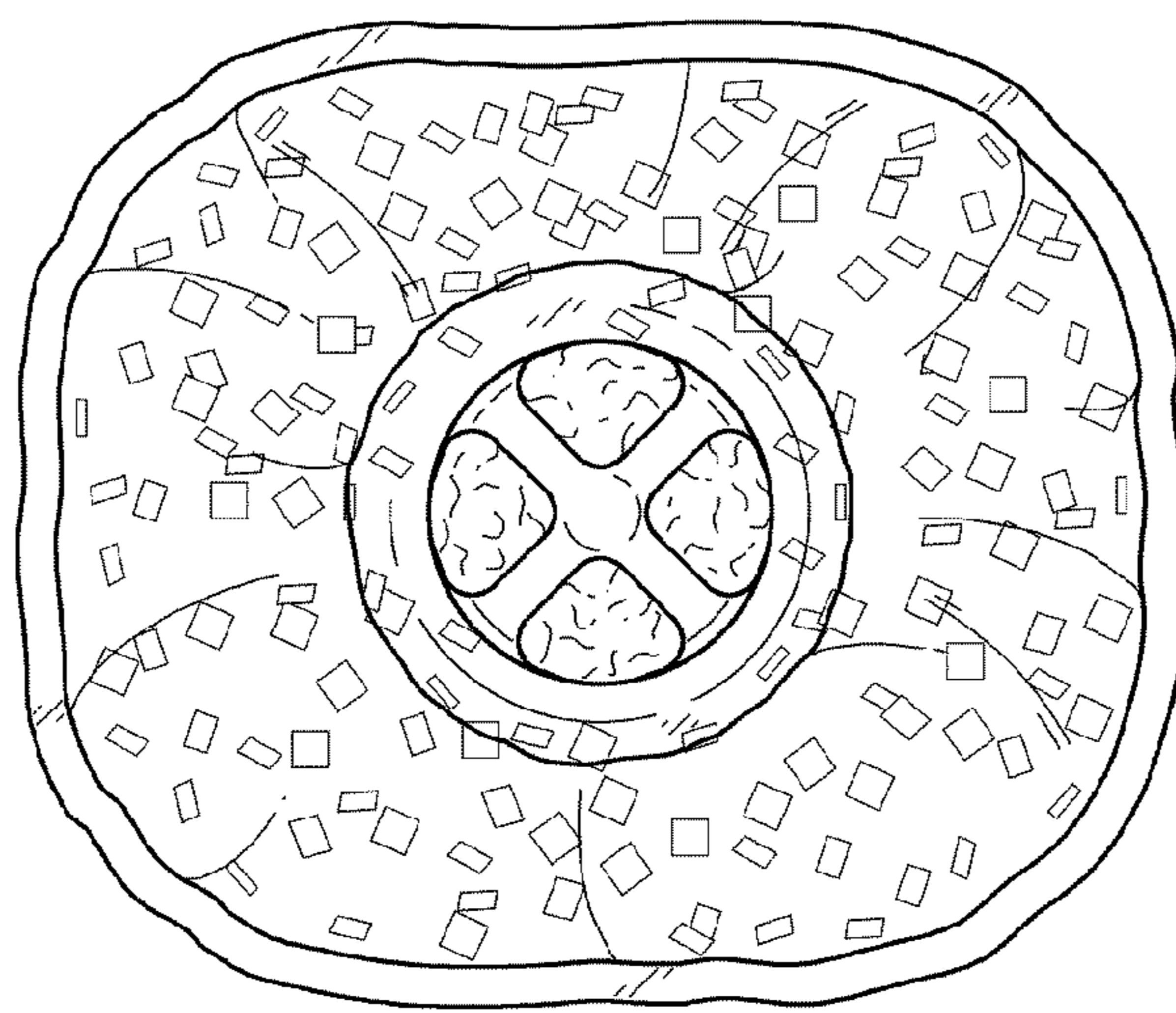

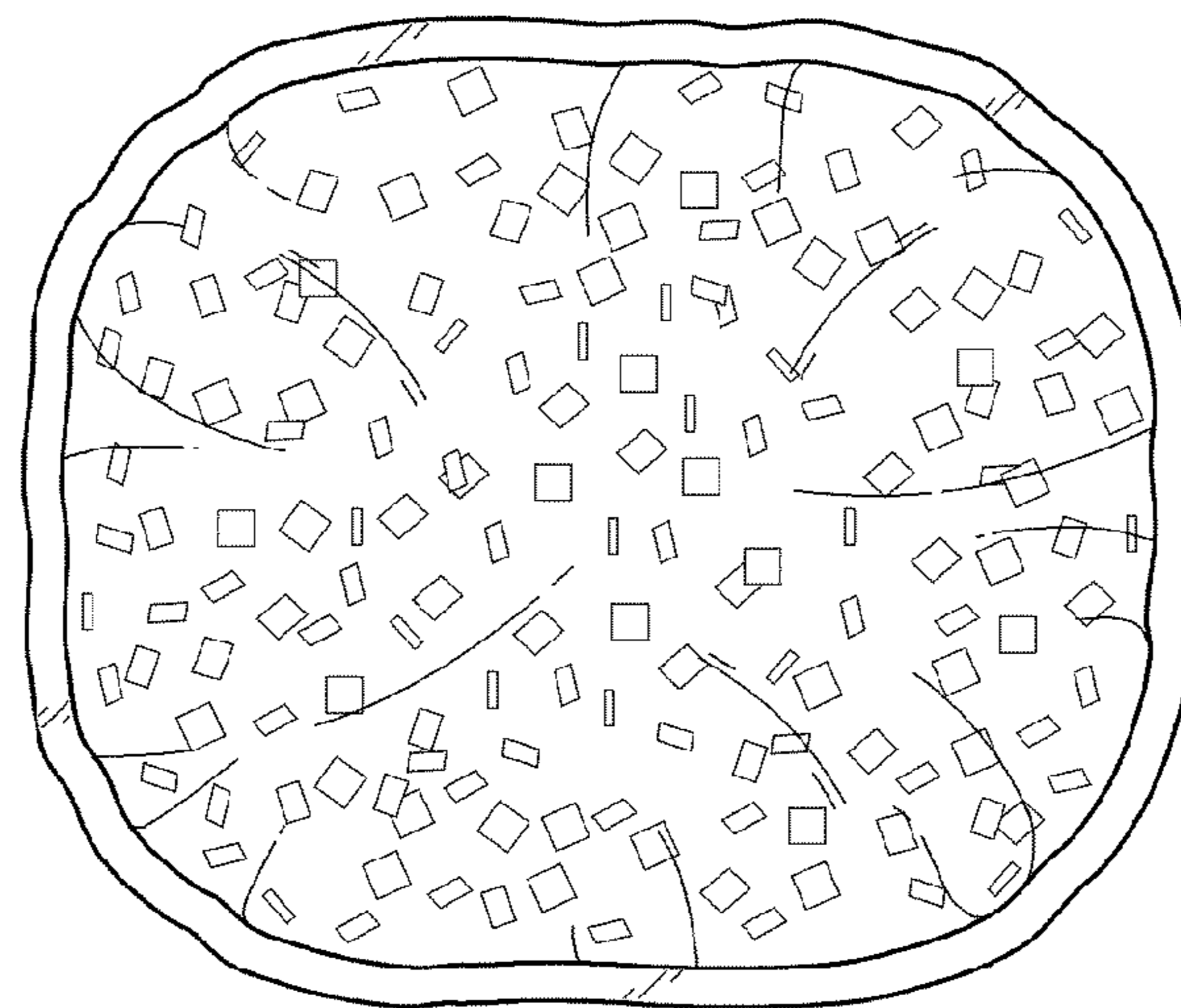

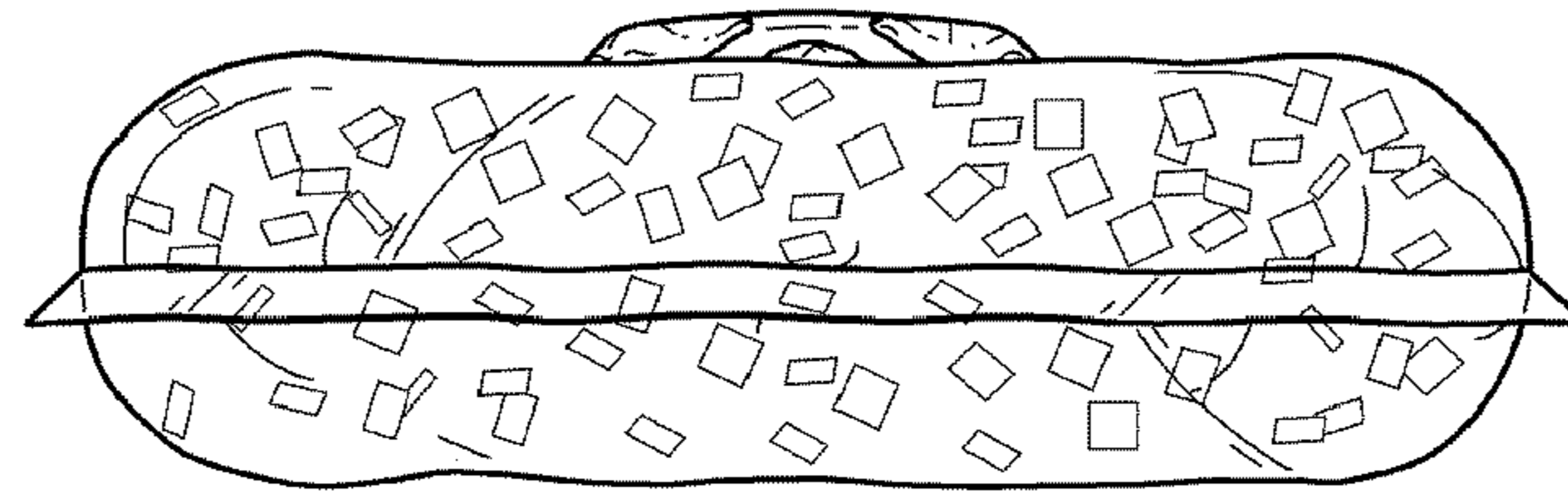

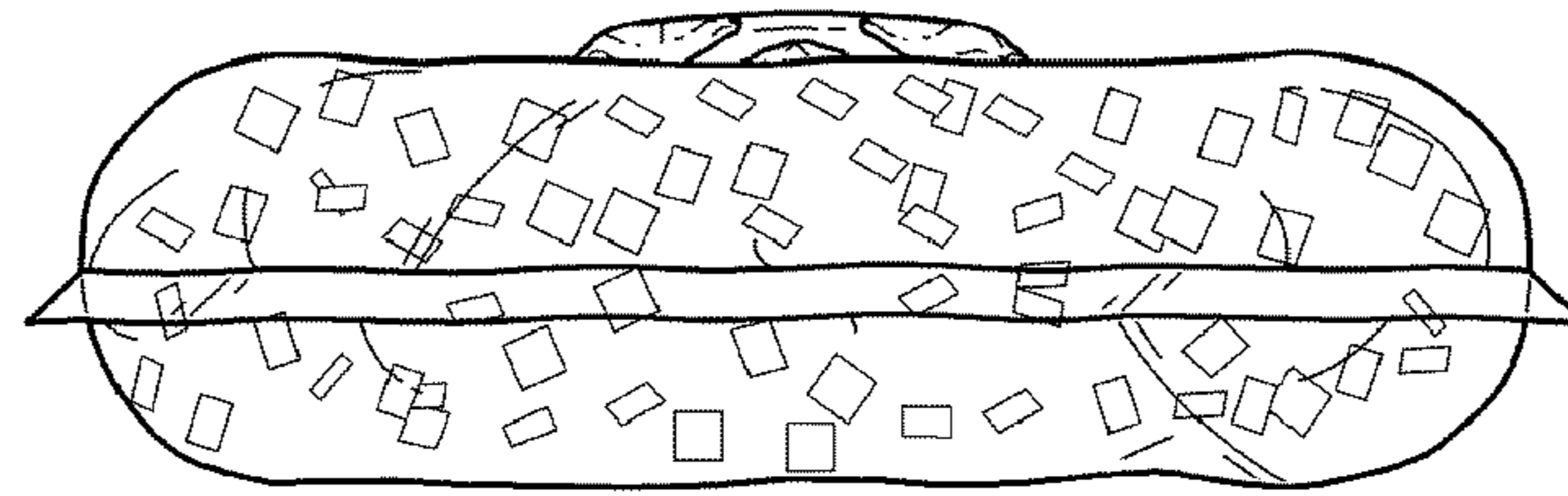

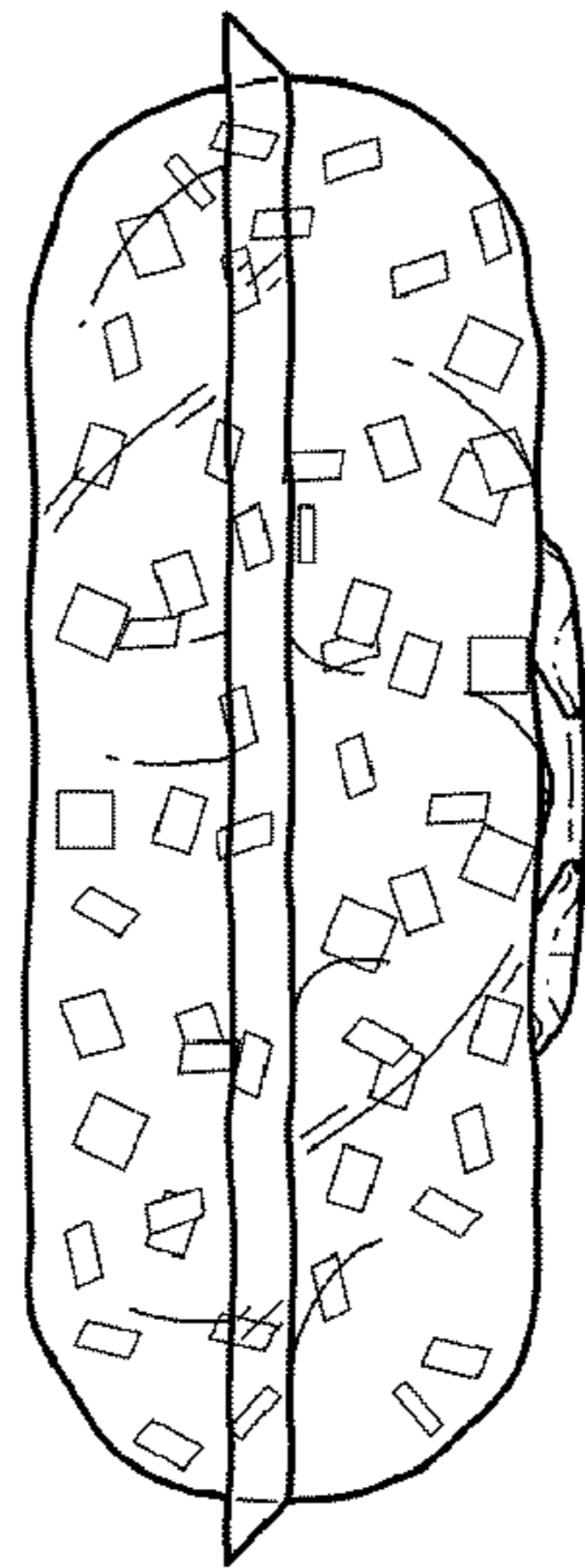

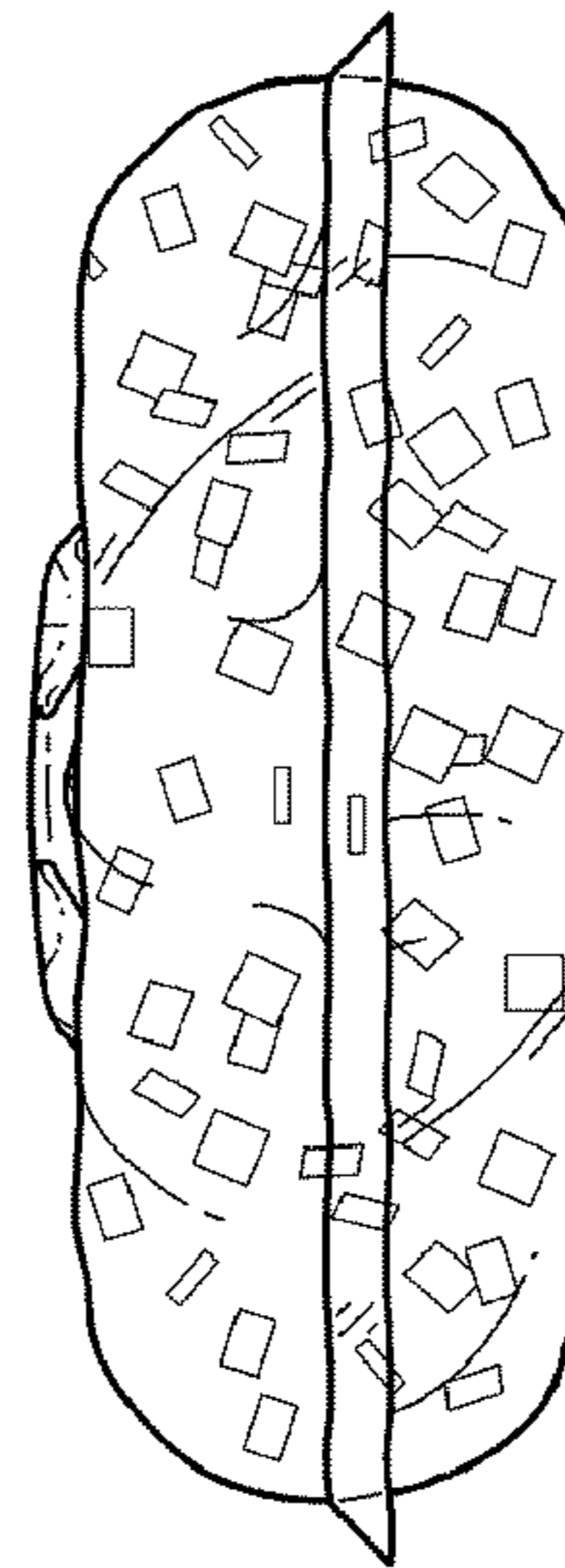

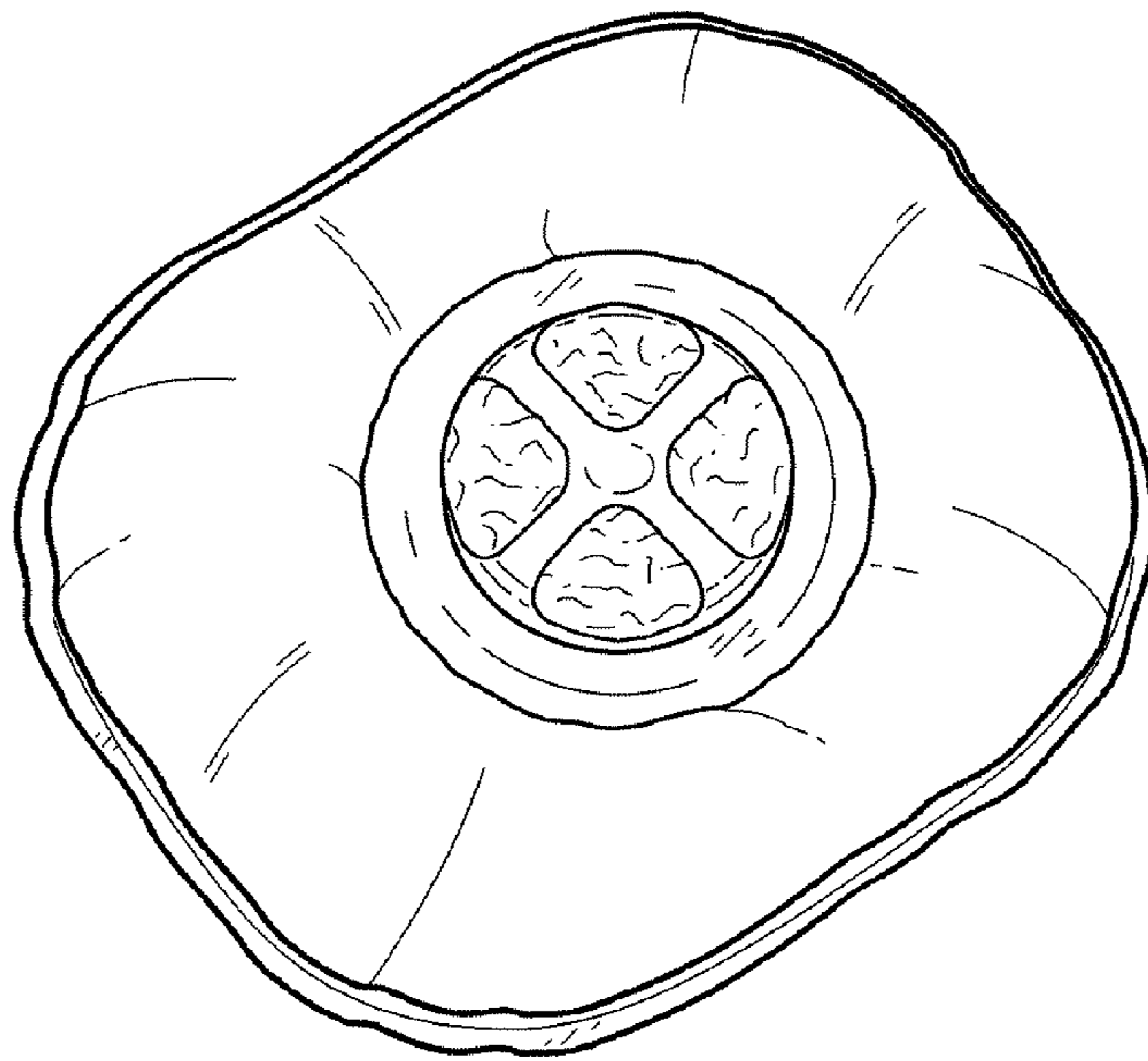

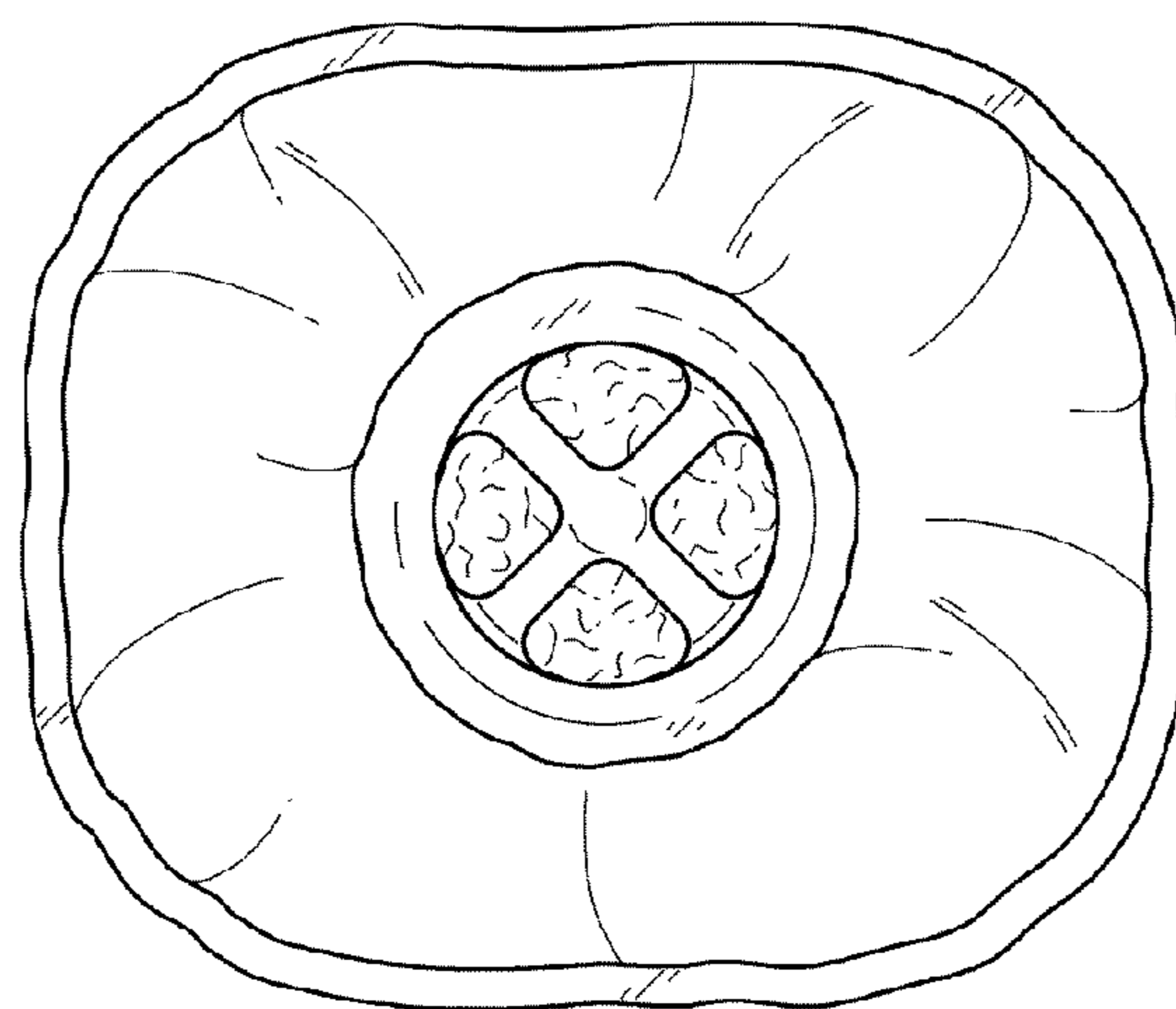

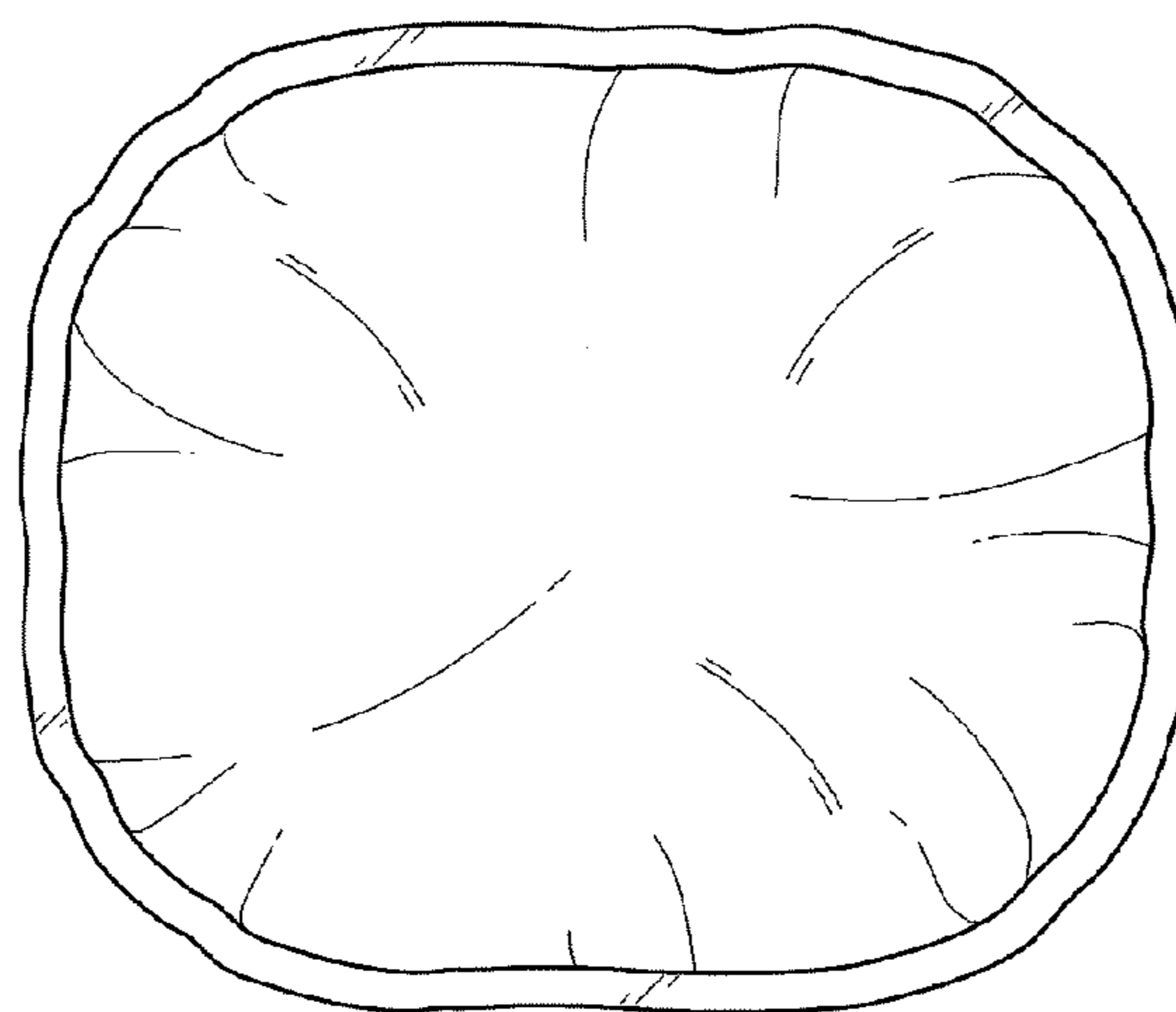

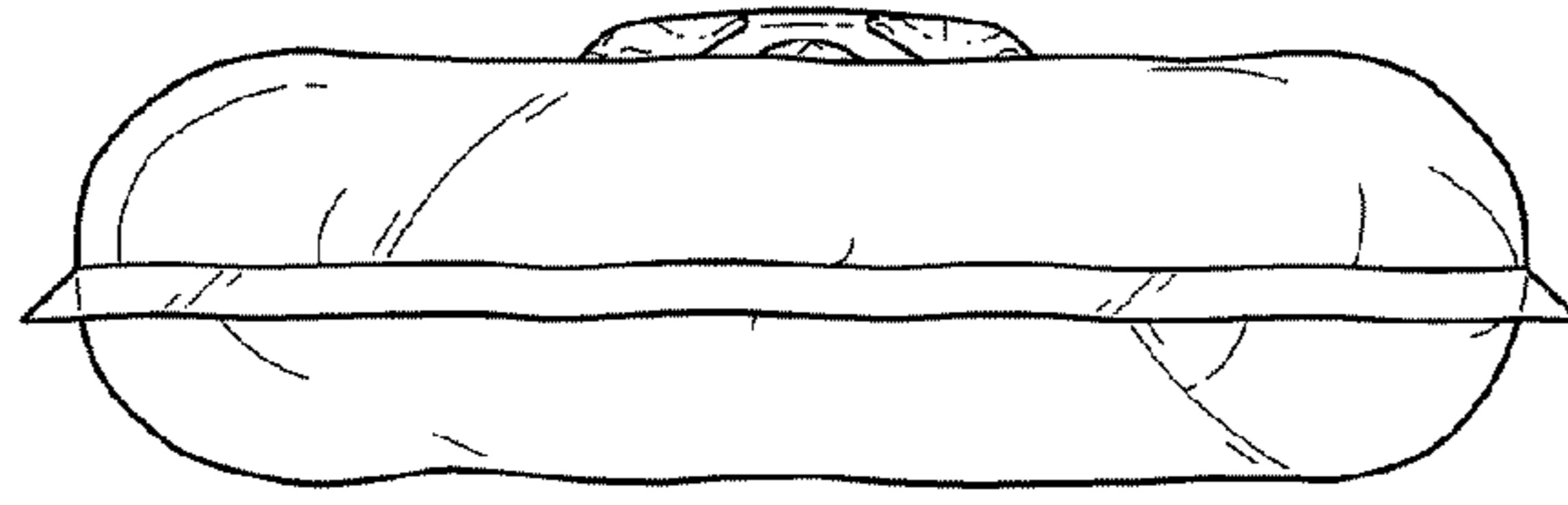

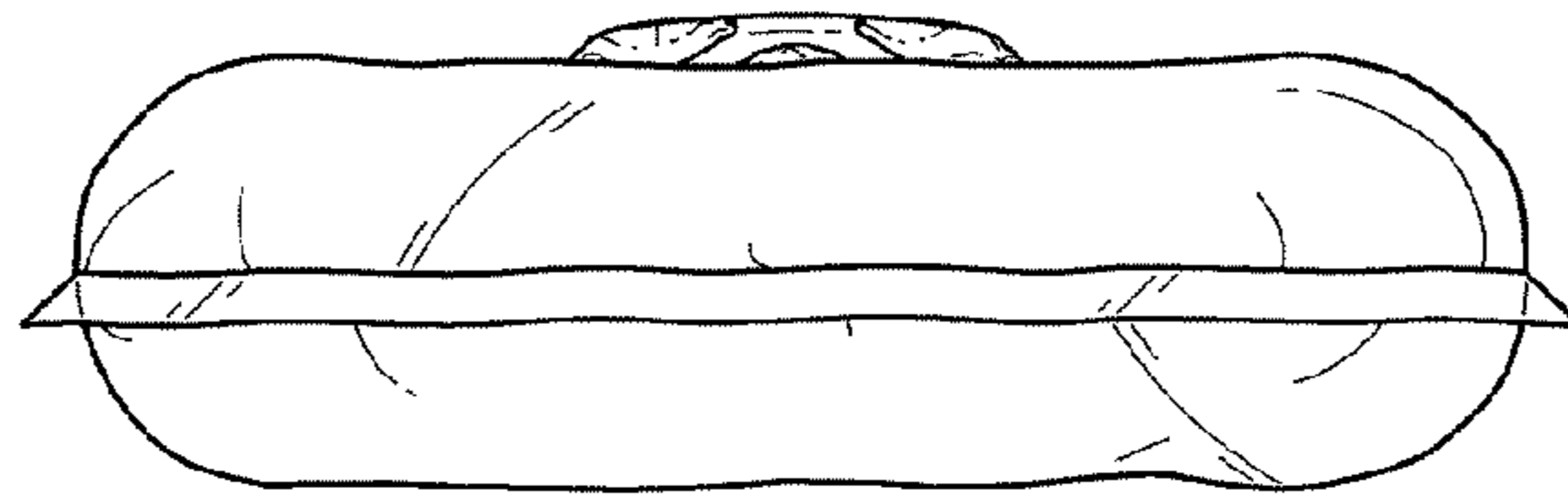

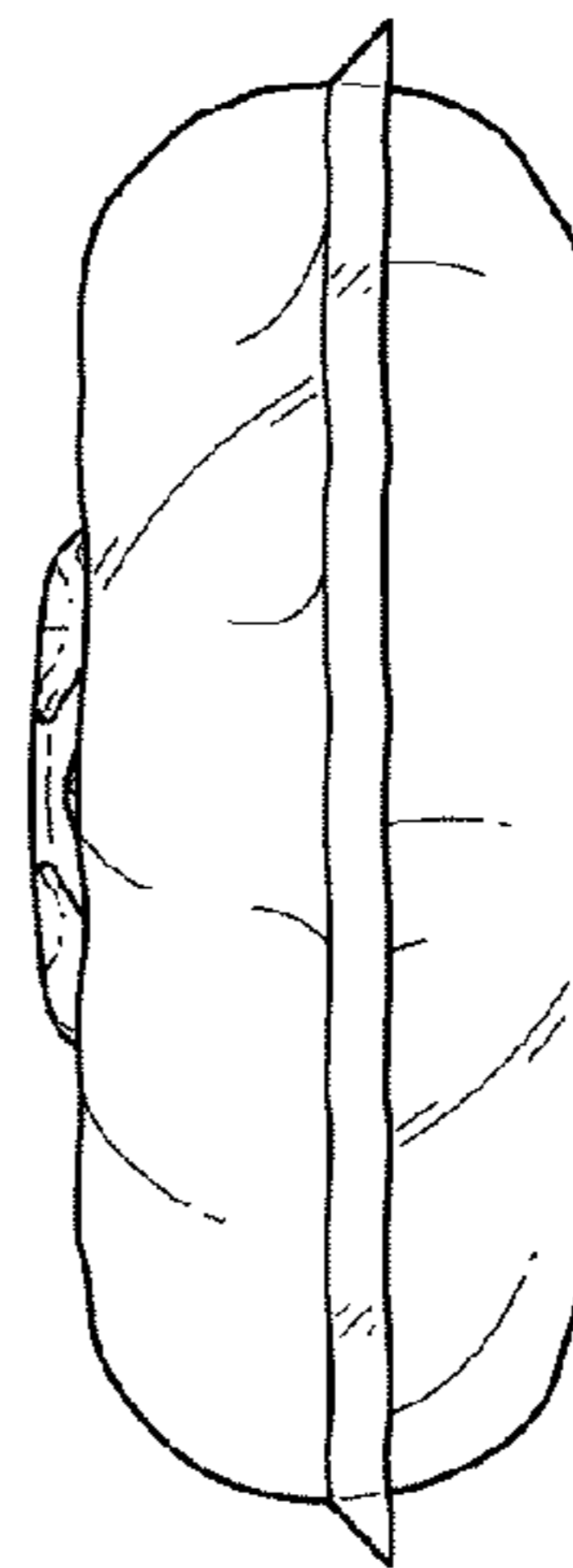
