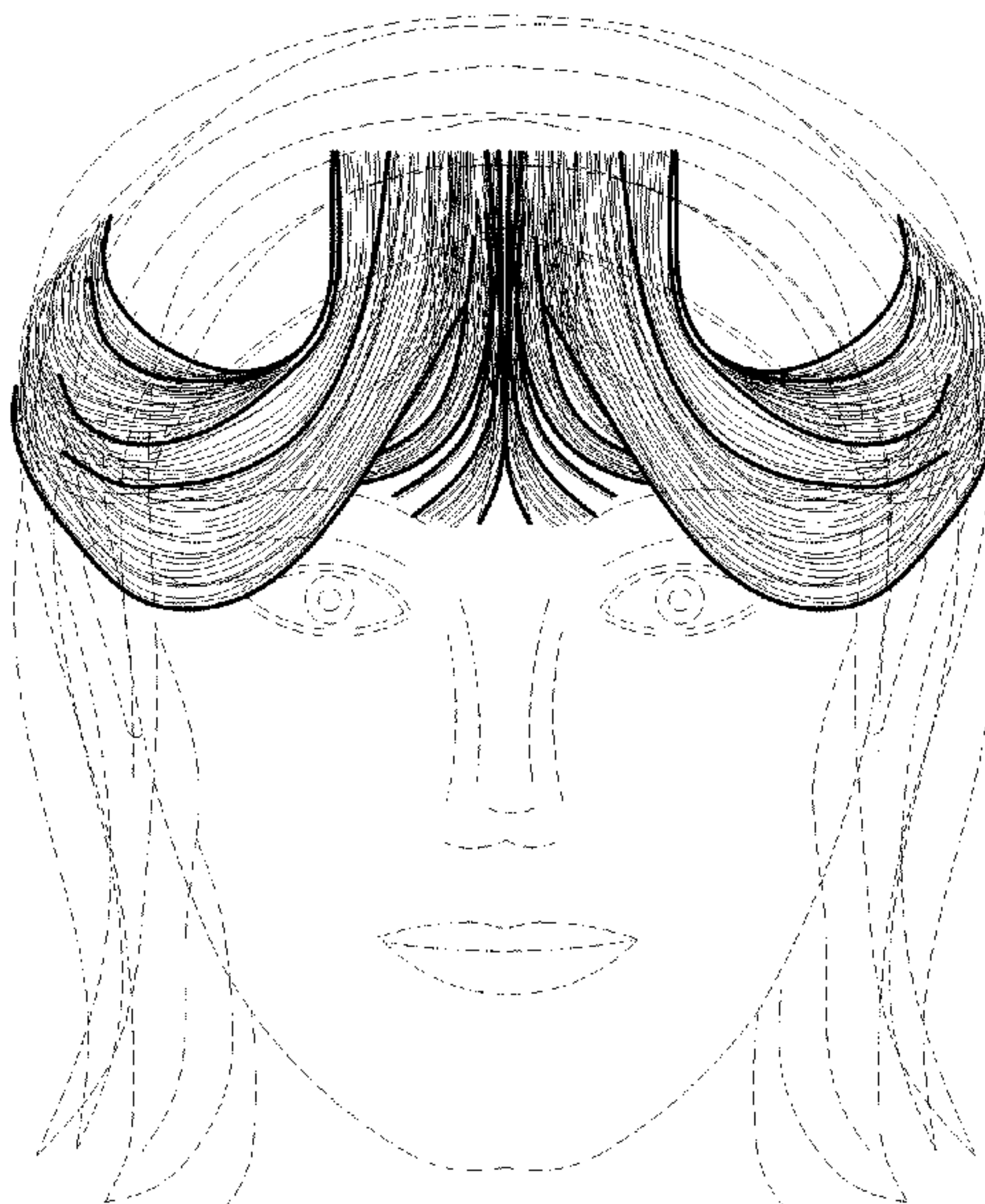
The ornamental design for a hair bang, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational front view of a hair bang;  
 FIG. 2 is a top plan view thereof;

 FIG. 5 is a bottom plan view thereof;

 FIG. 8 is a left side view, the opposed side being a mirror image thereof;  
 FIG. 9 is an elevational rear view thereof;  
 FIG. 10 is a bottom plan view thereof;  
 FIG. 11 is a third embodiment of a front elevational view of a hair bang;  
 FIG. 12 is a top plan view thereof;  
 FIG. 13 is a left side view, the opposed side being a mirror image thereof;  
 FIG. 14 is a rear elevational view thereof;  
 FIG. 15 is a bottom plan view thereof;  
 FIG. 16 is a fourth embodiment of a front elevational view of a hair bang;  
 FIG. 17 is a top plan view thereof;  
 FIG. 18 is a left side view;  
 FIG. 19 is a right side view;  
 FIG. 20 is a rear elevational view thereof; and,  
 FIG. 21 is a bottom plan view.

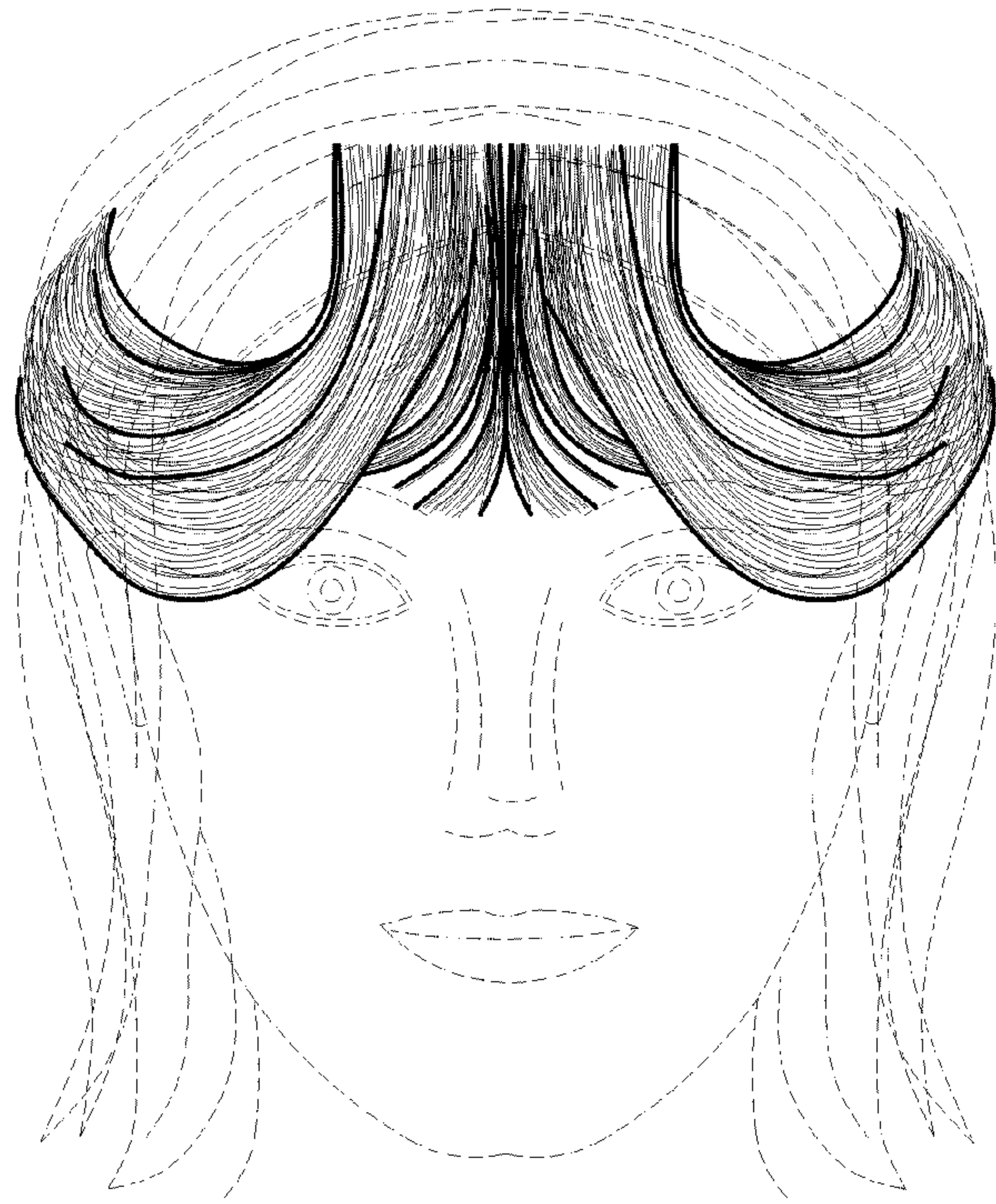

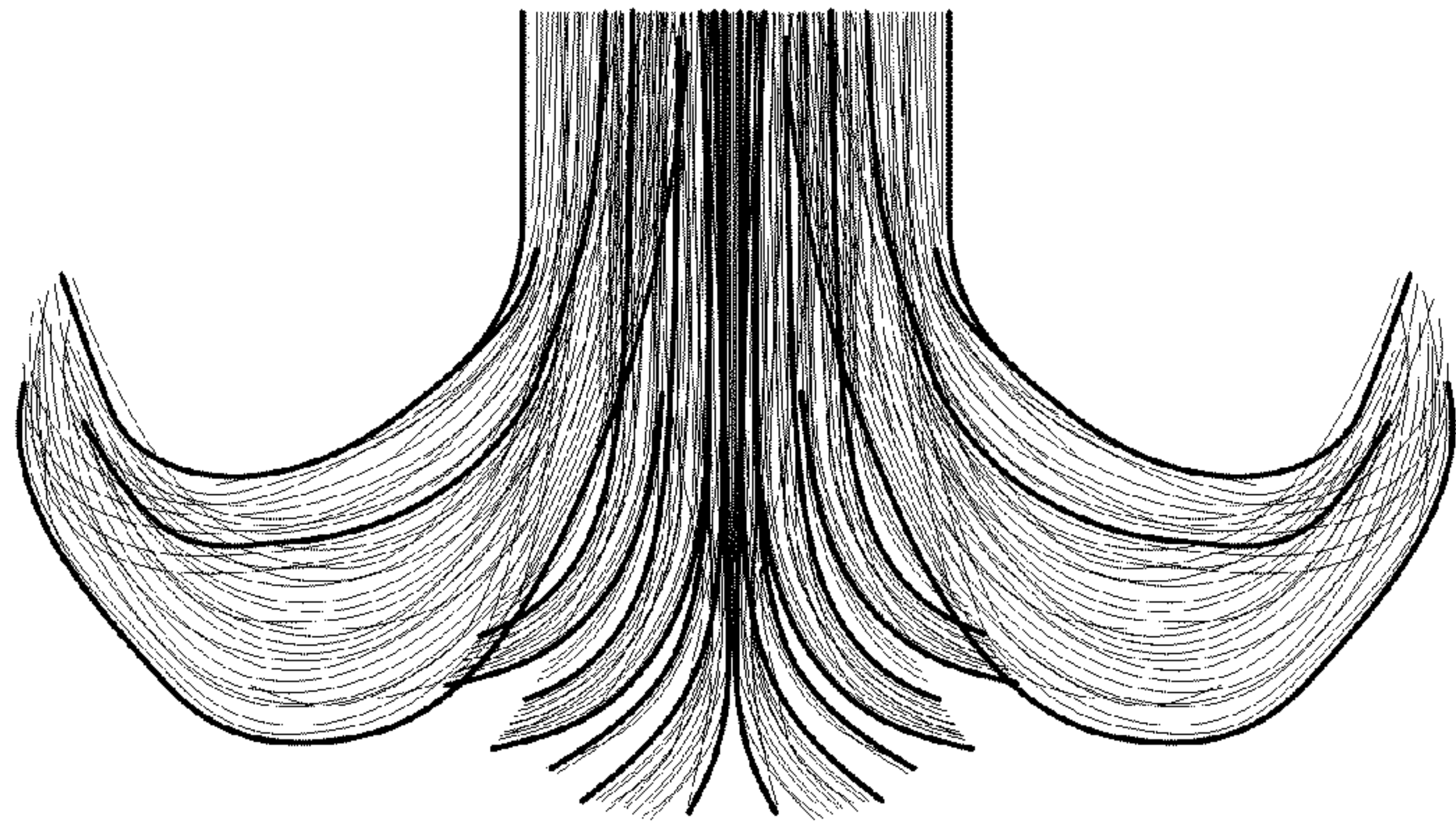

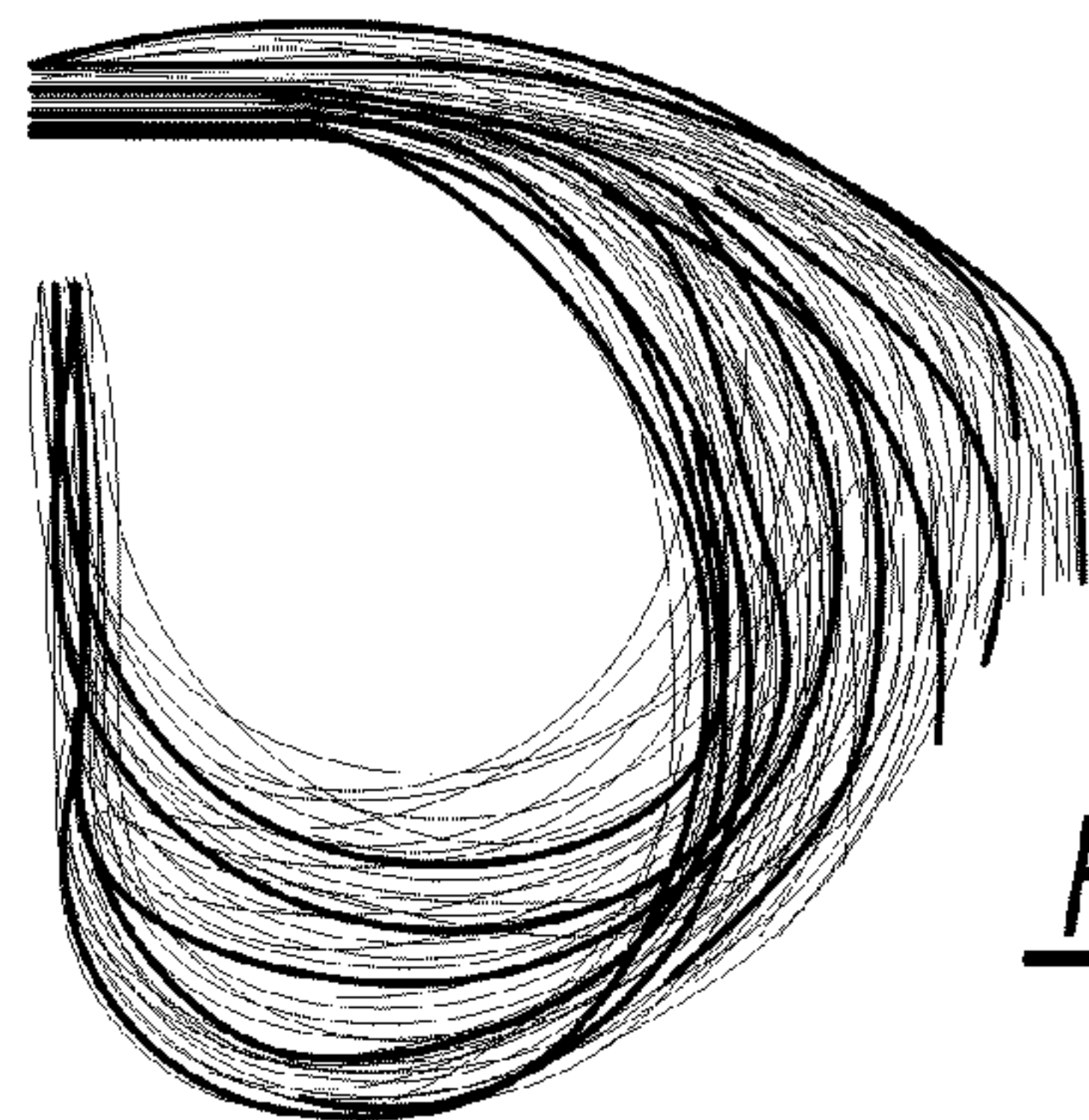

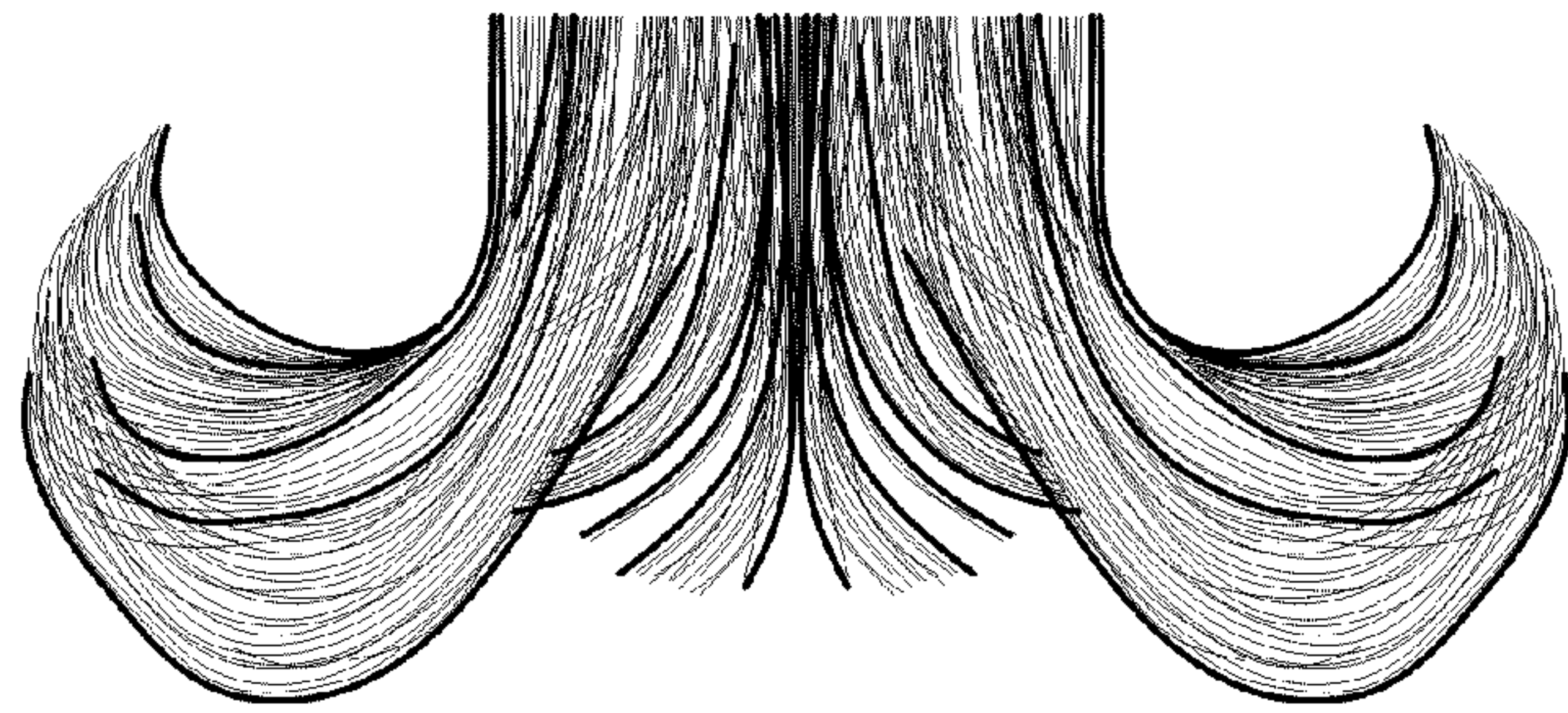

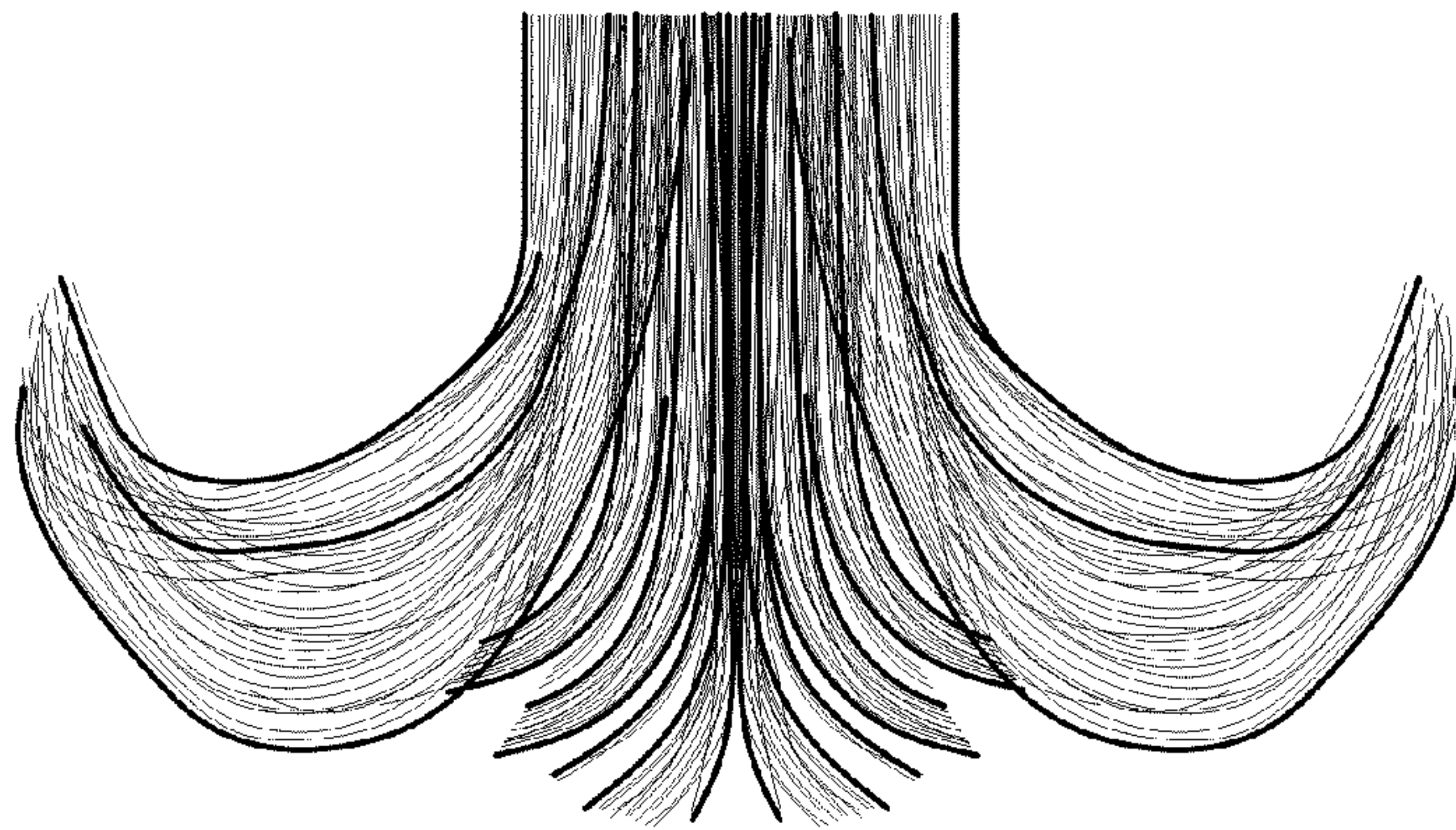

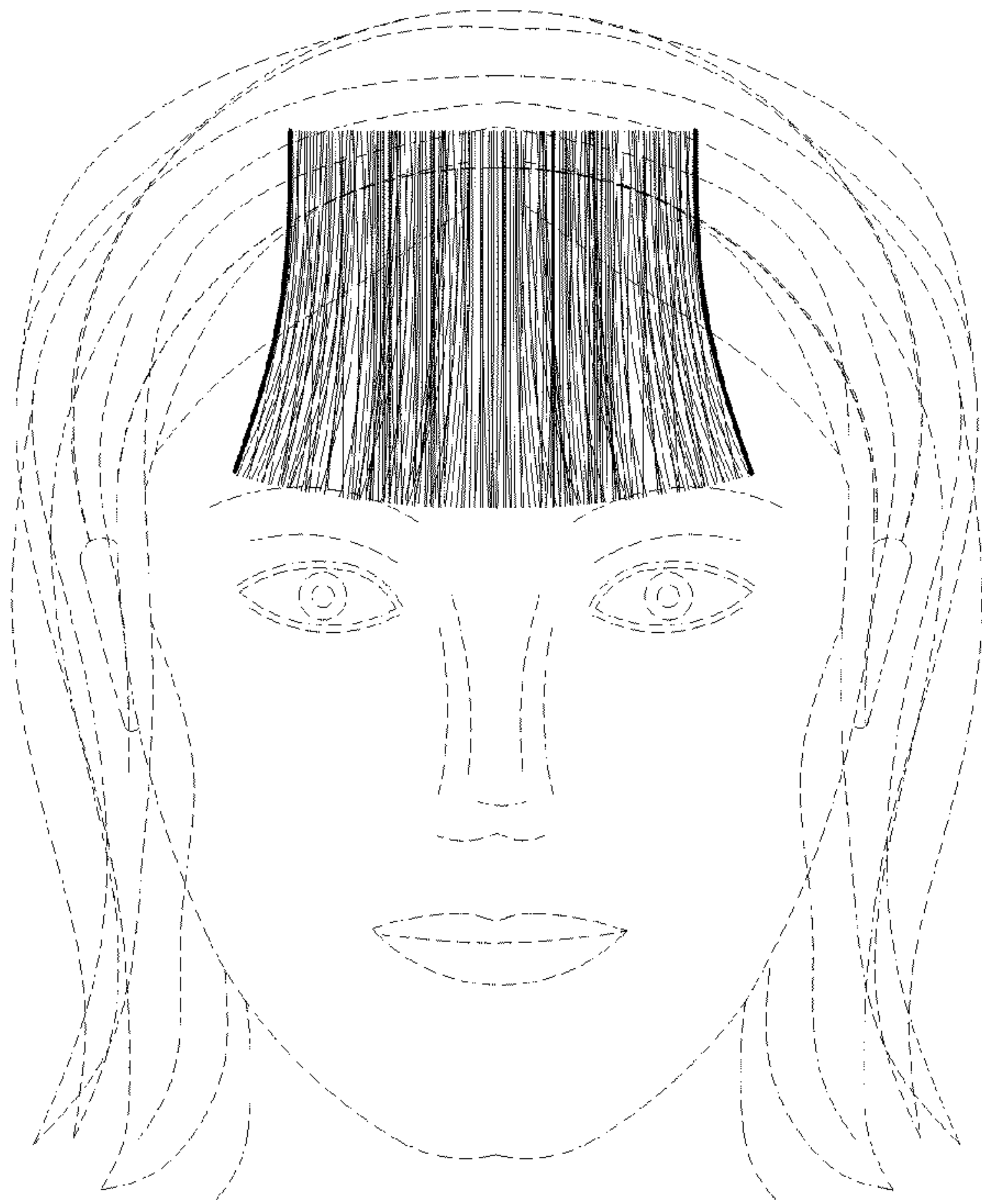

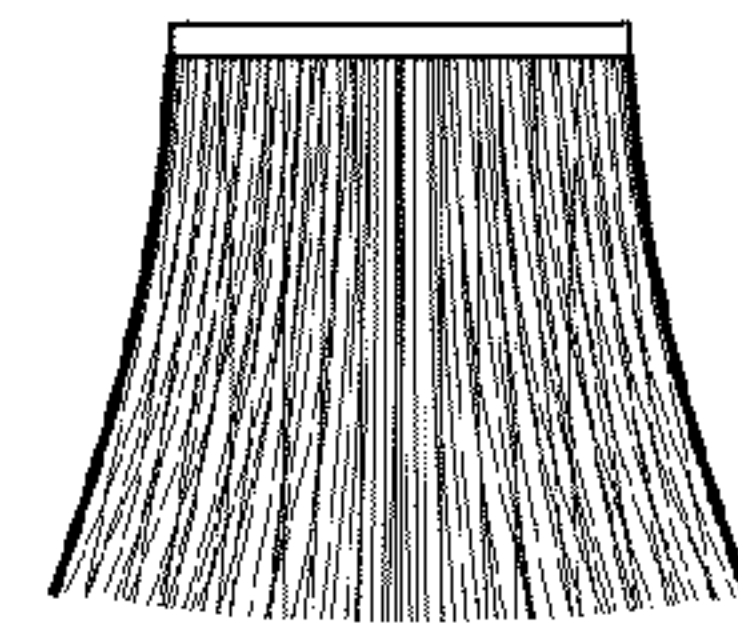

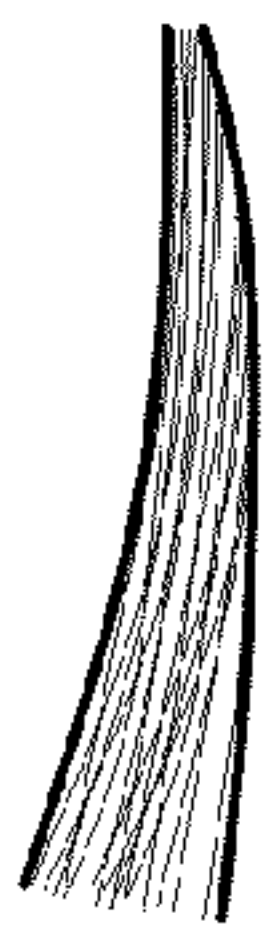

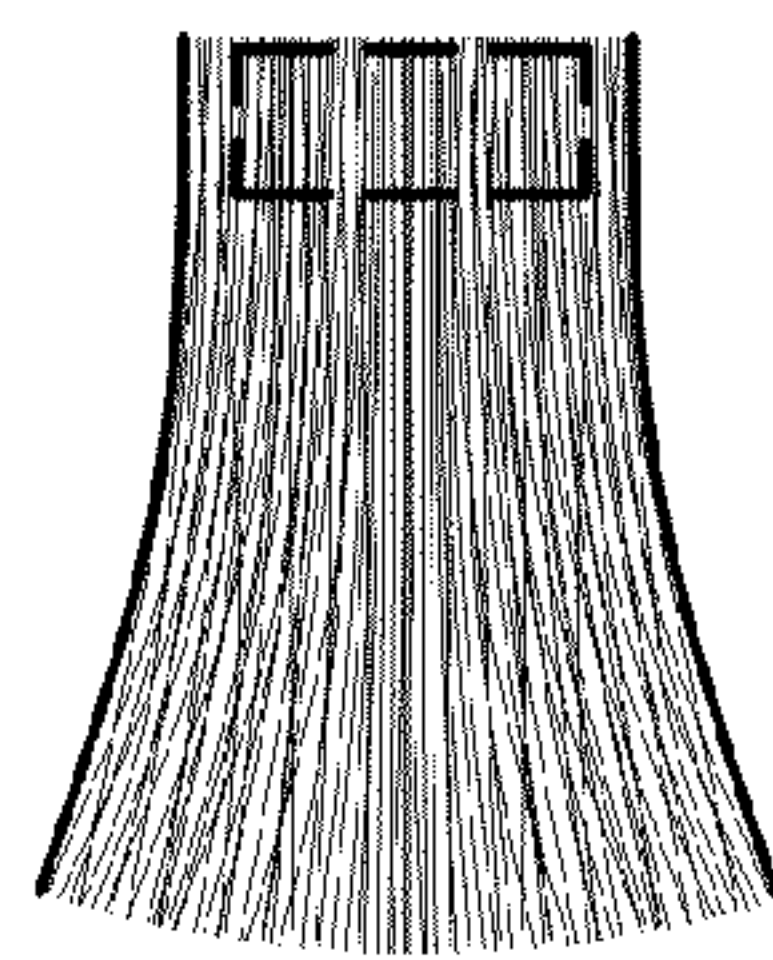

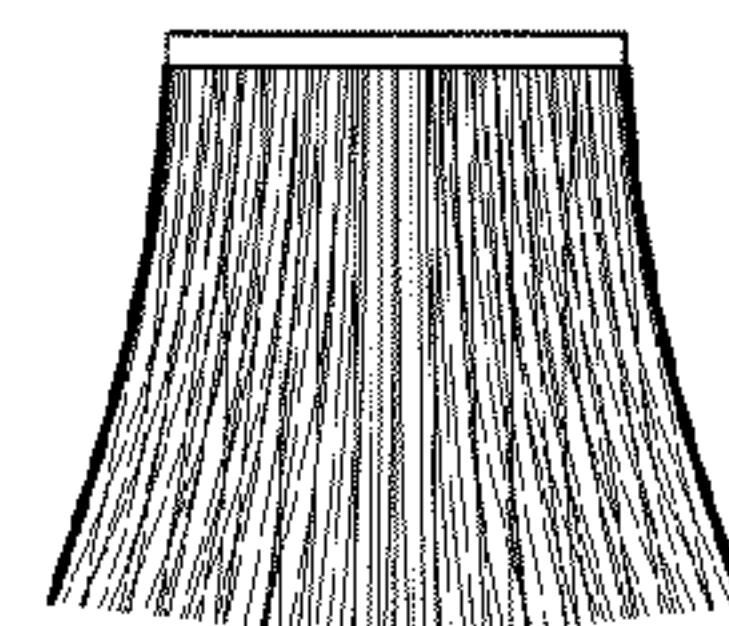

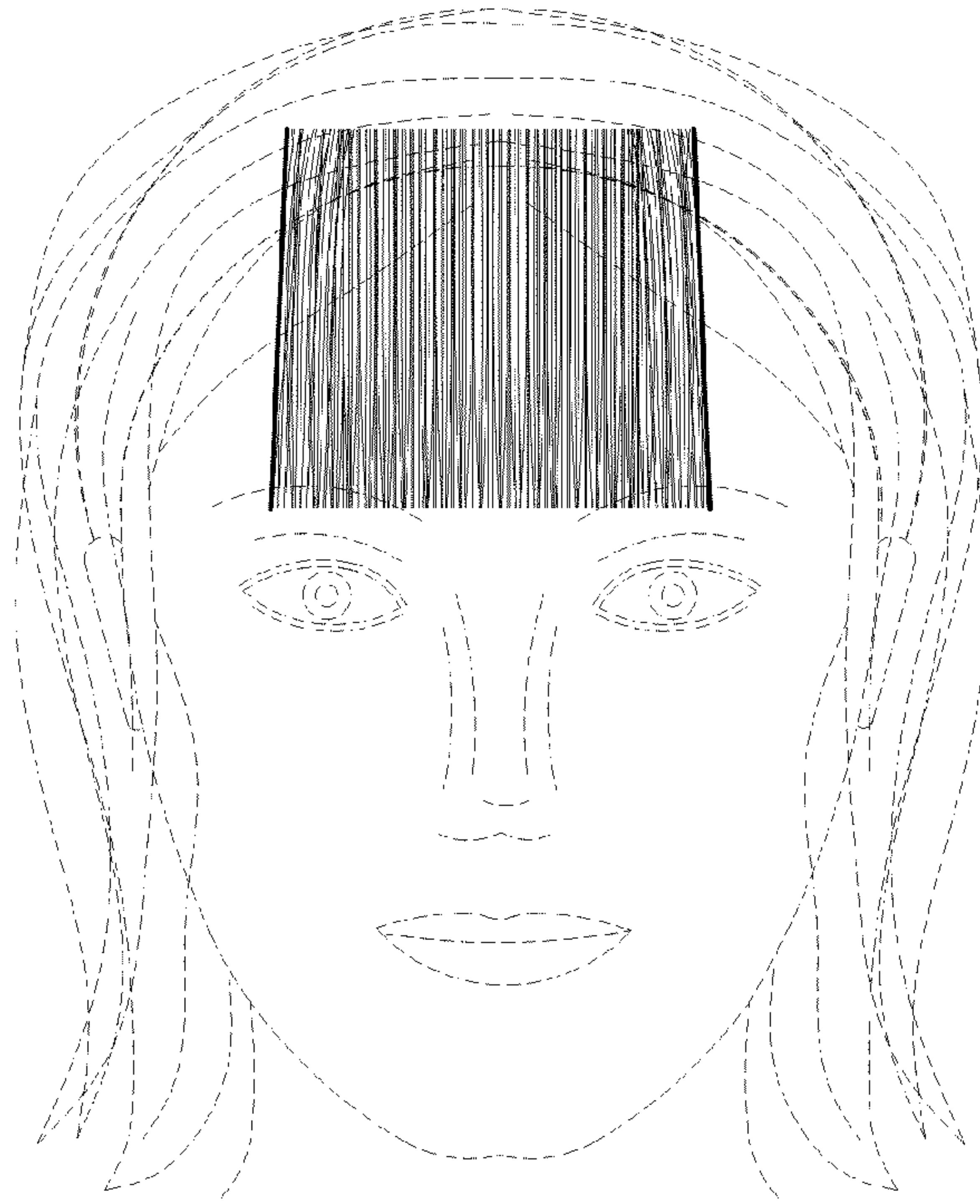

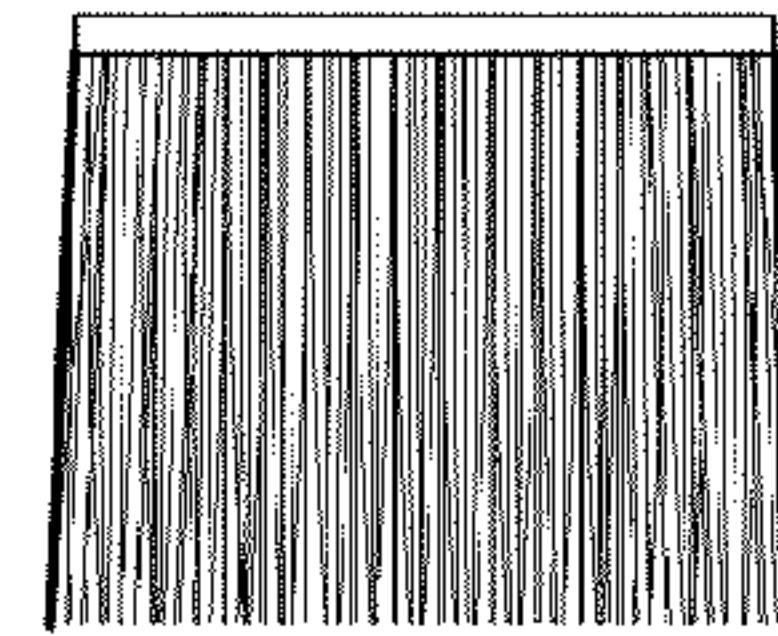

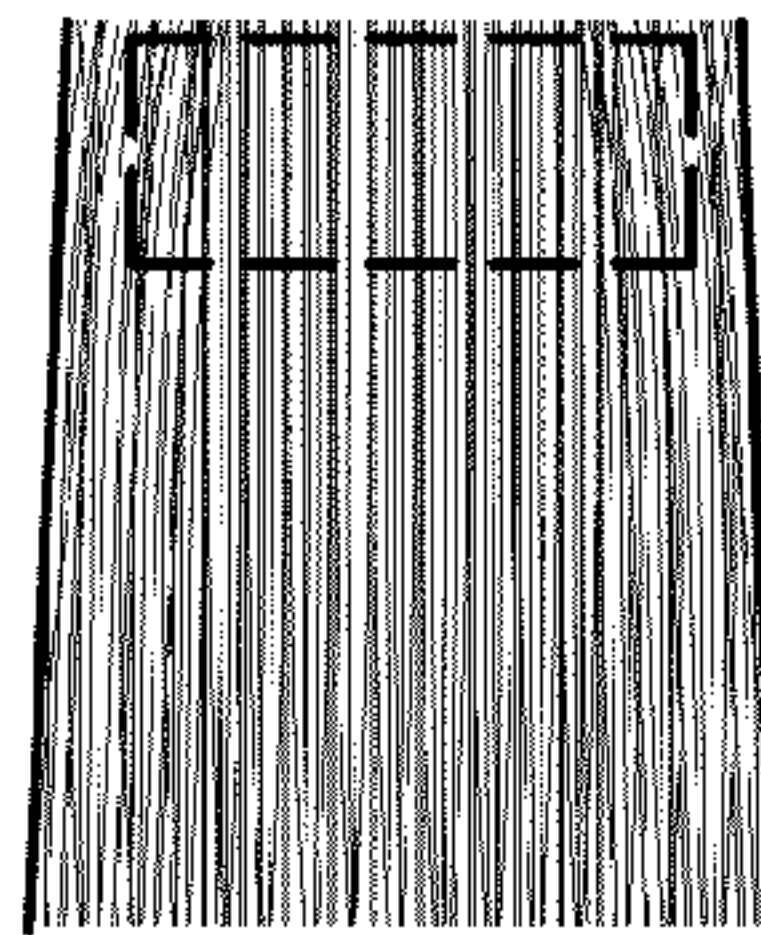

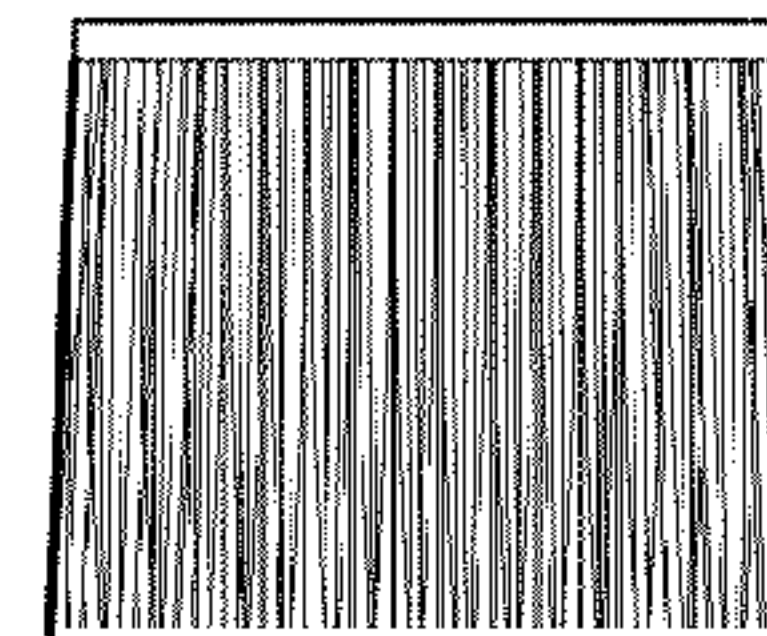

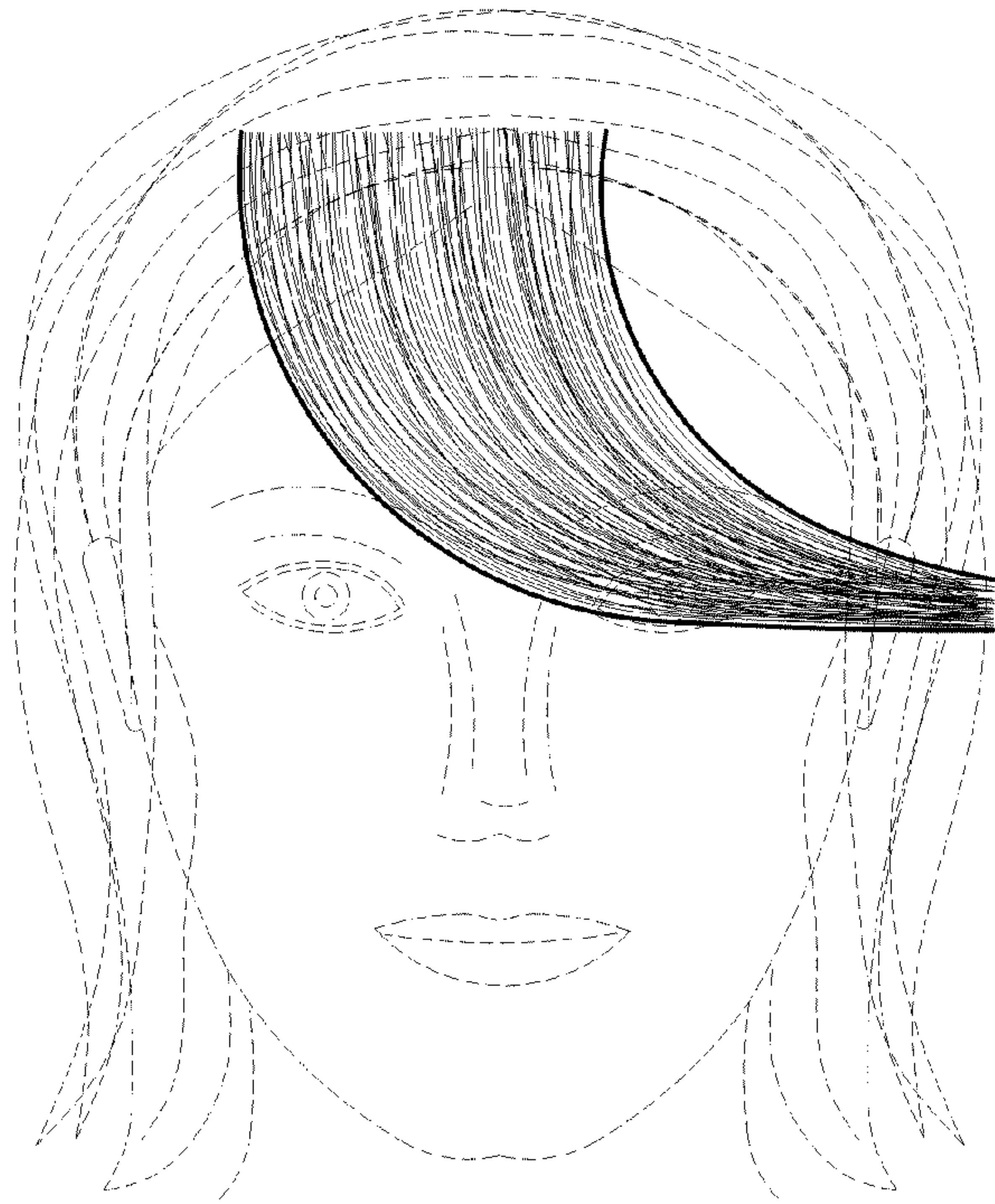

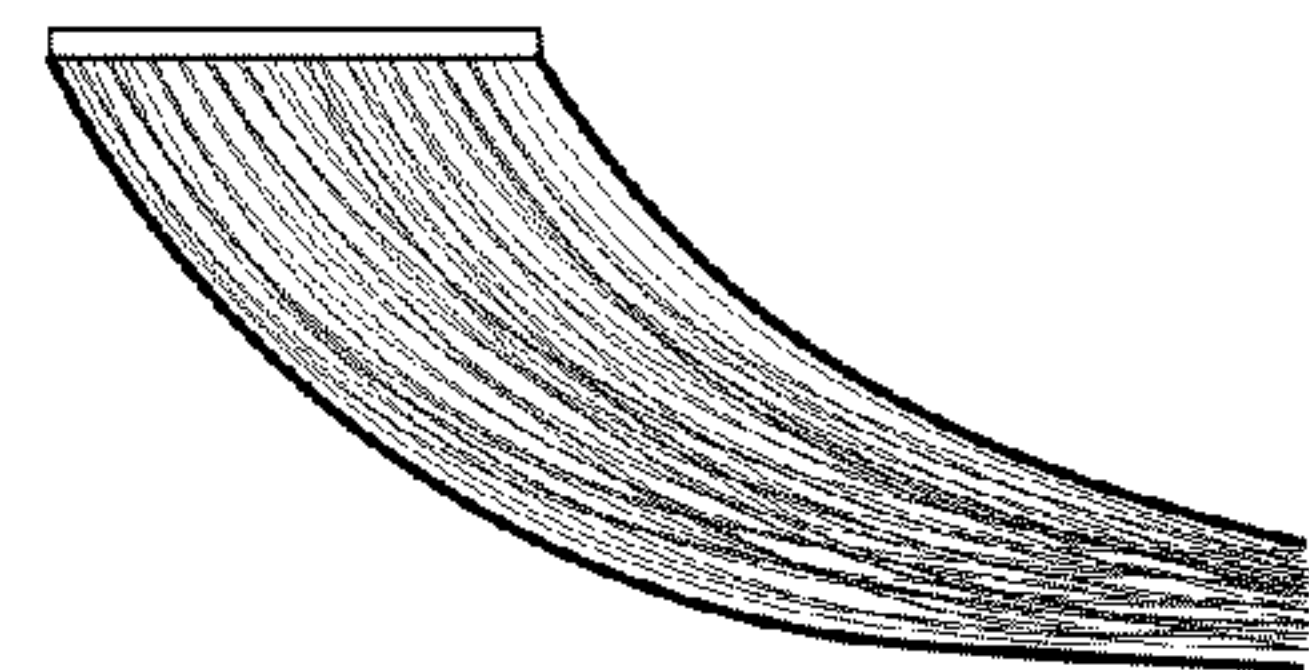

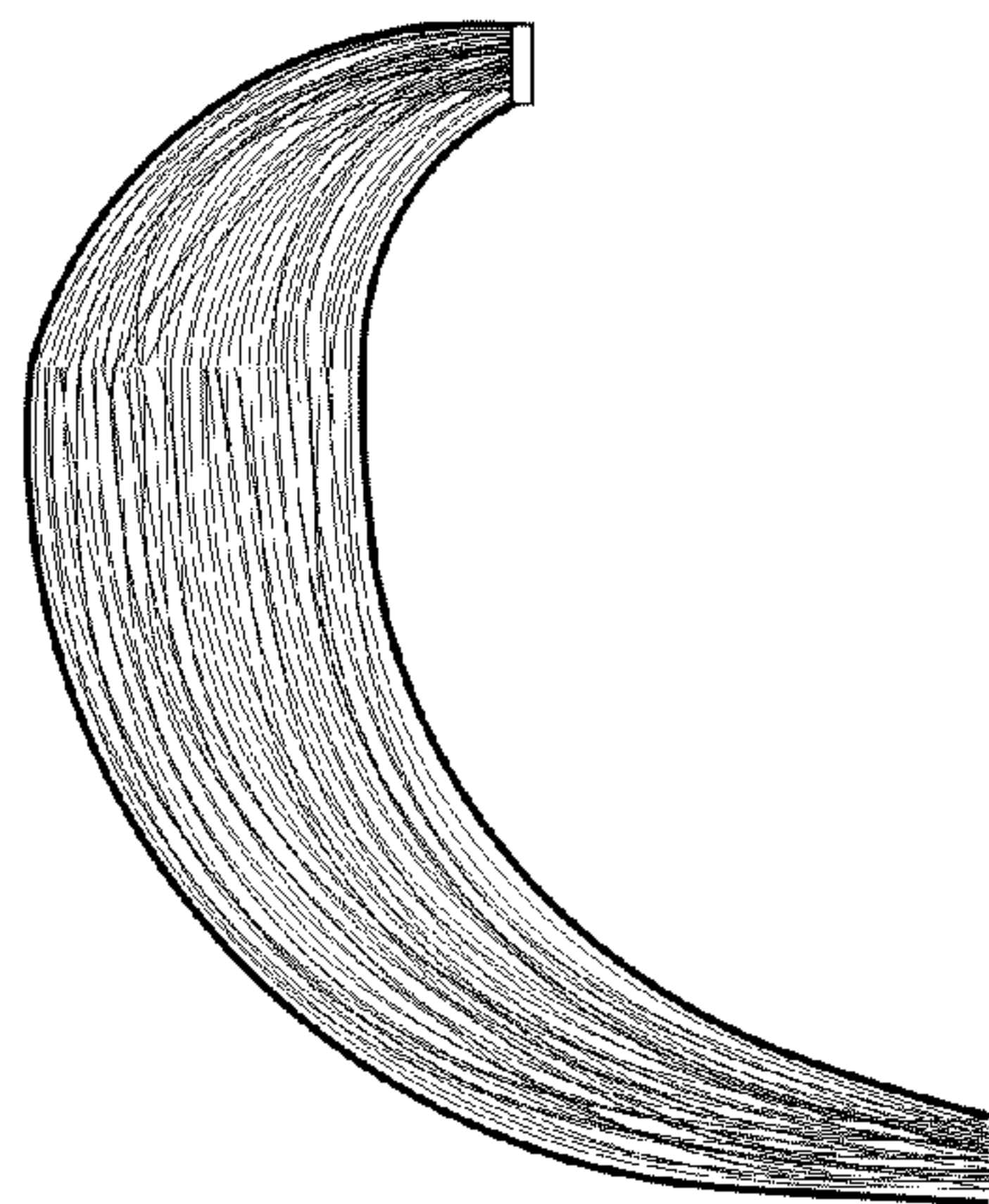

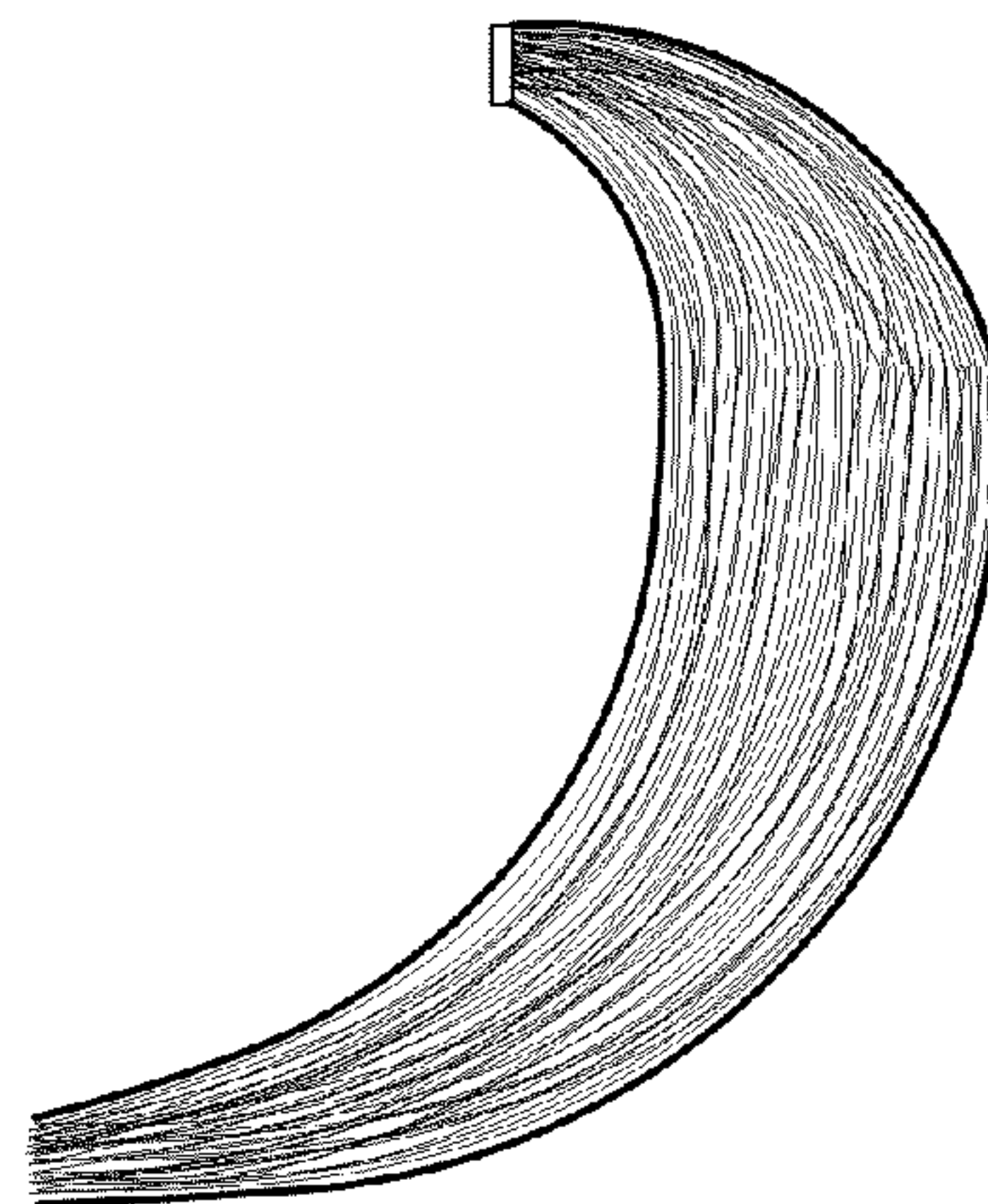

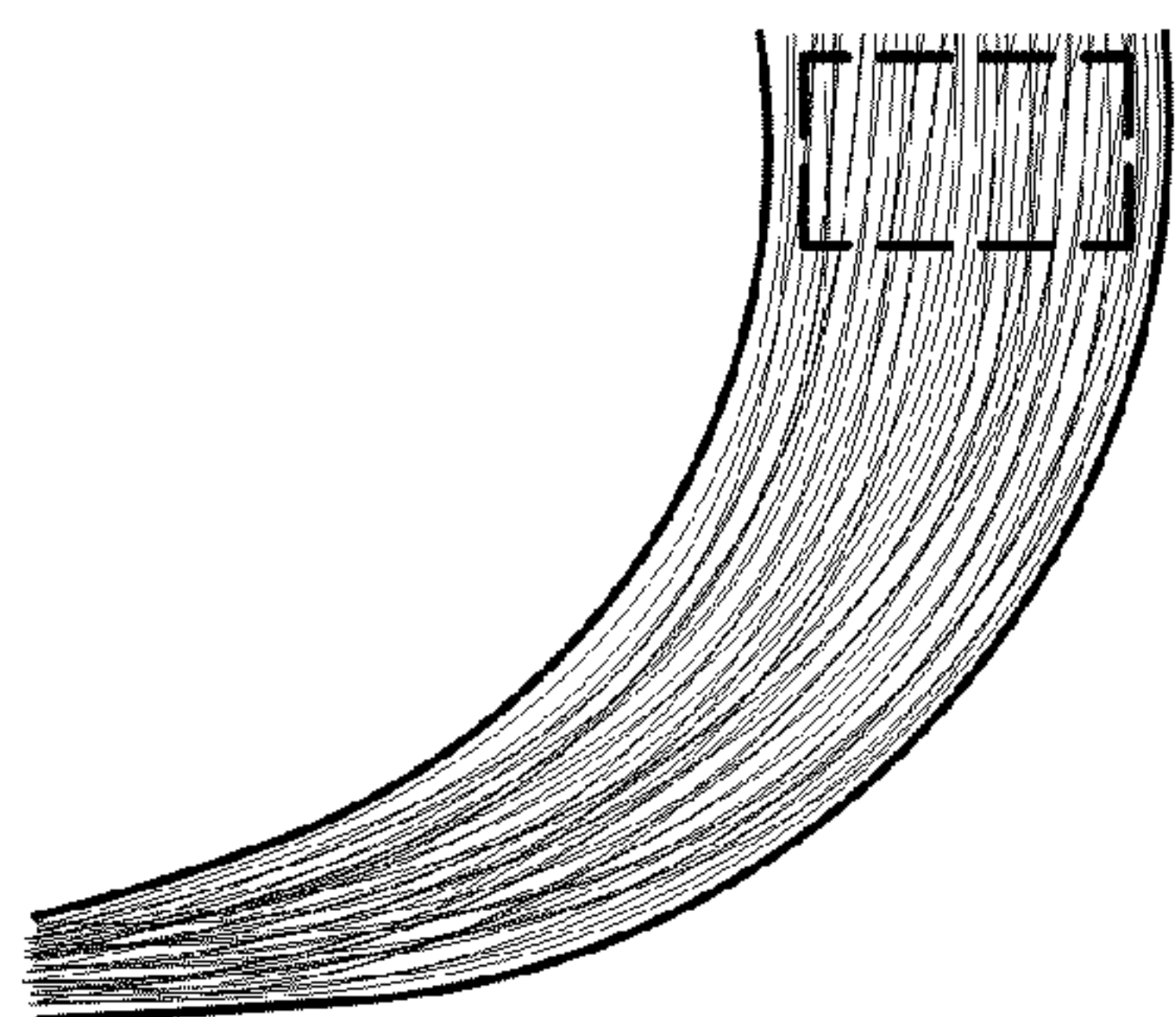

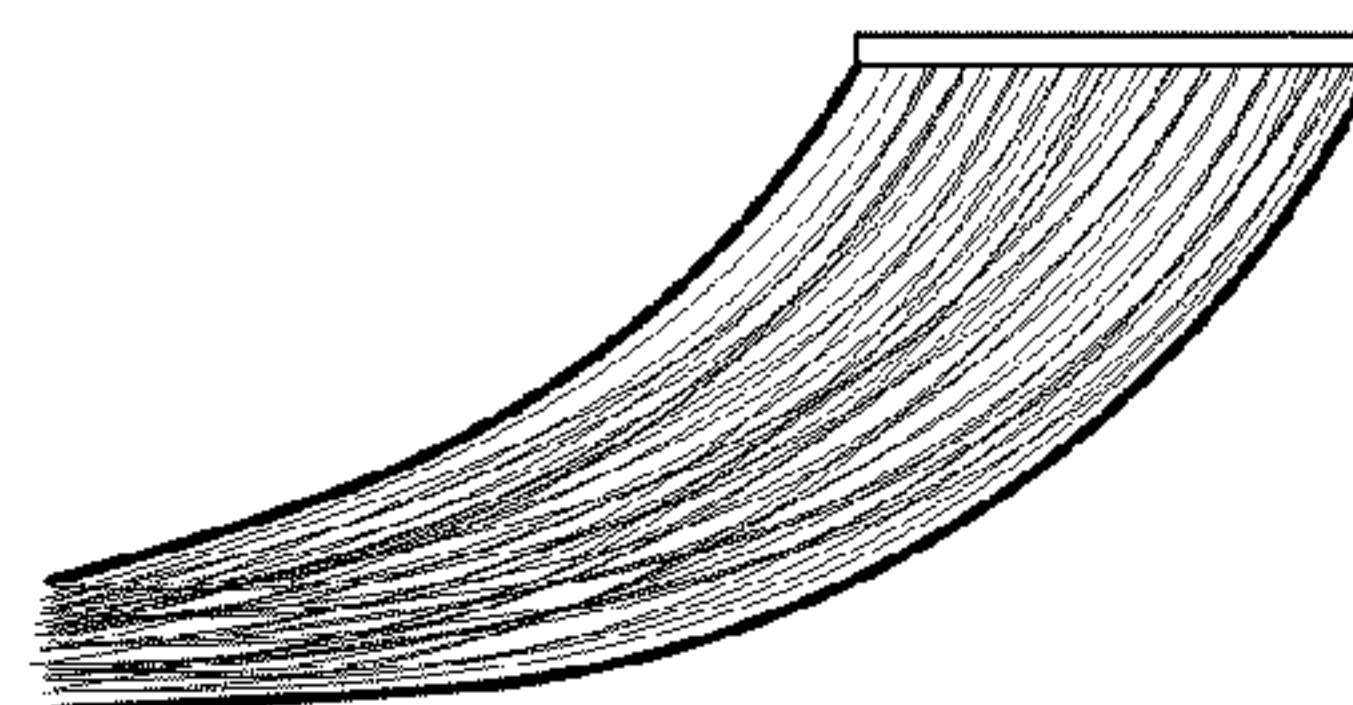
