showing our new design.

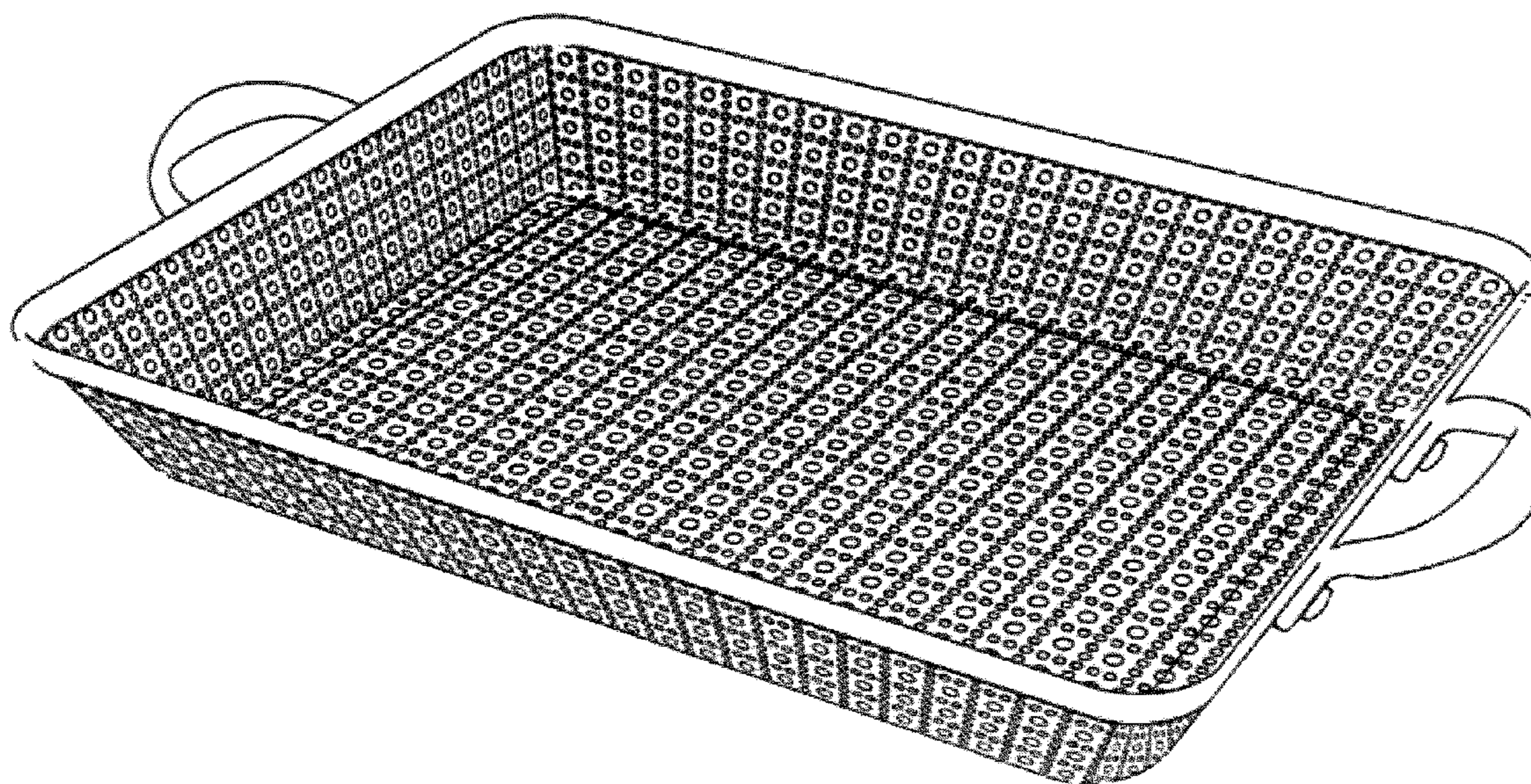
FIG. 2 is a top view thereof.

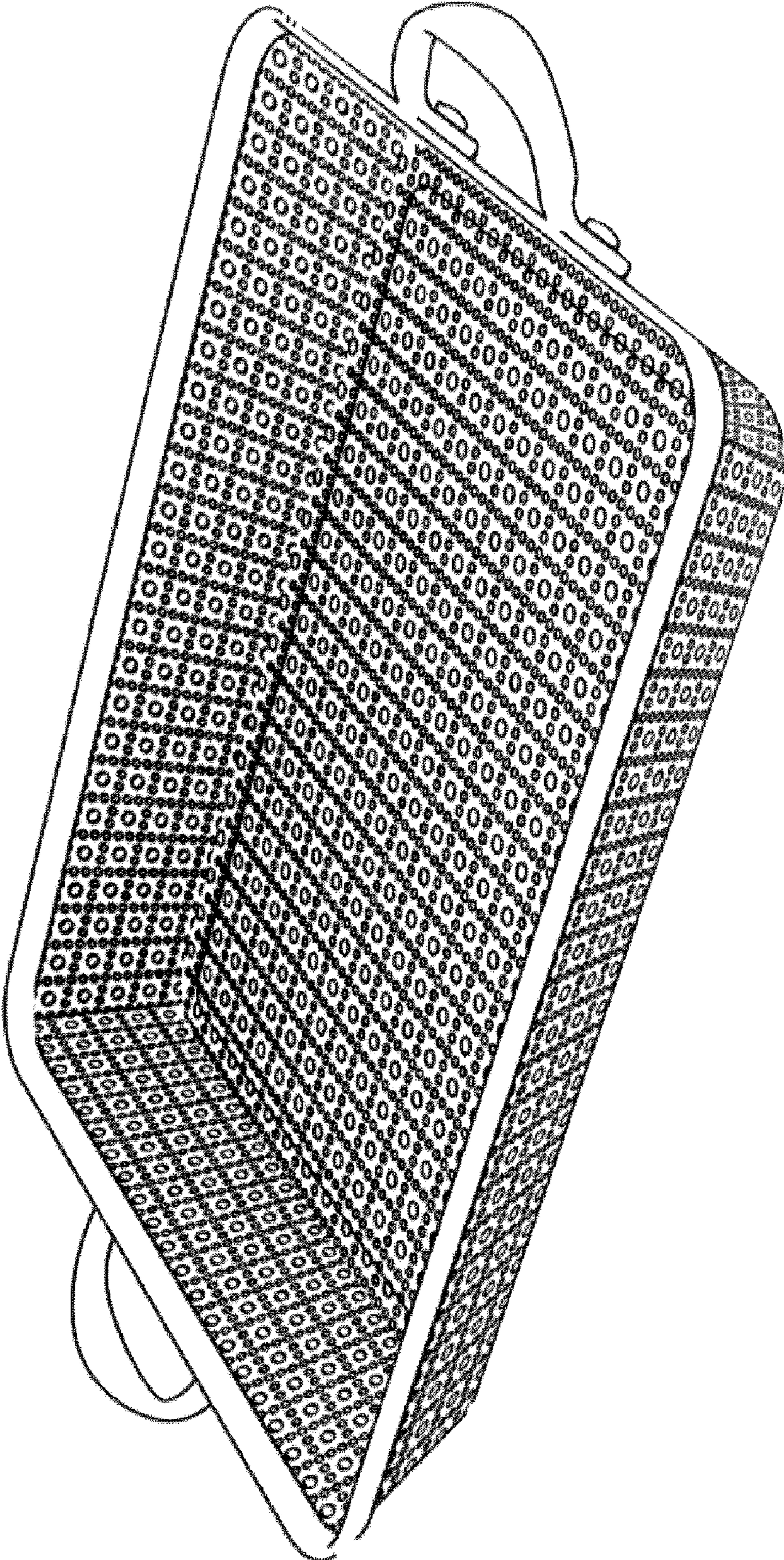

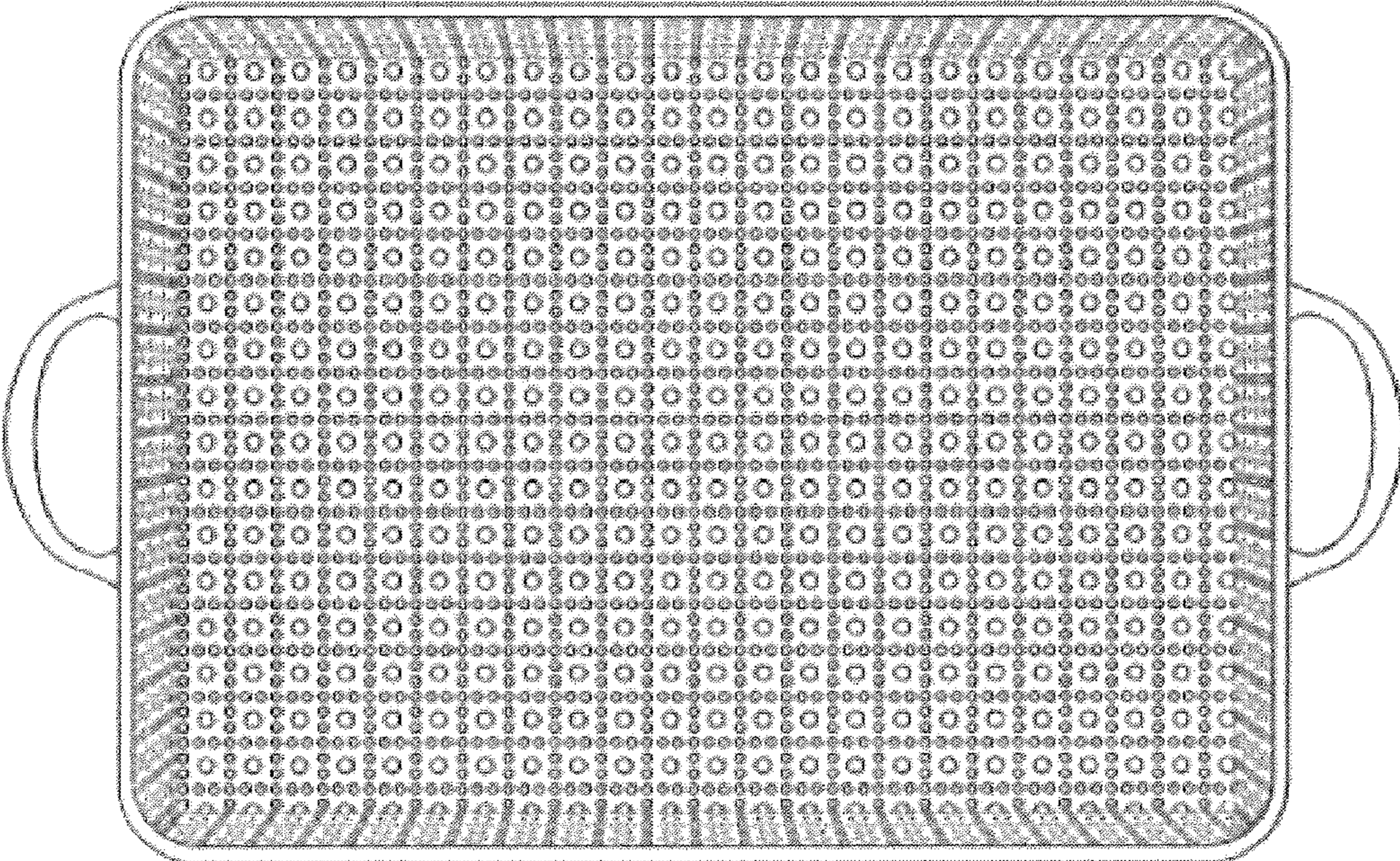

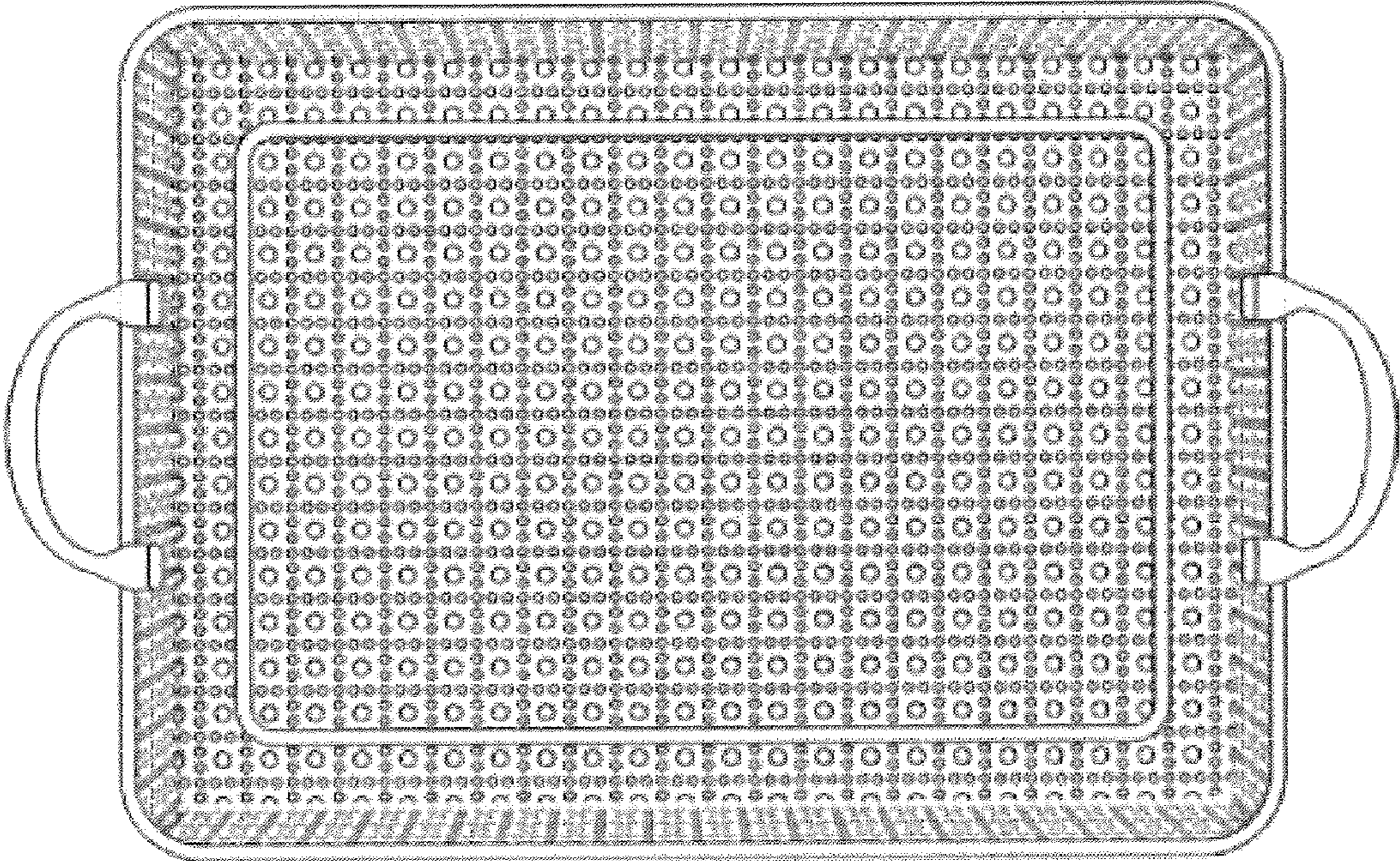

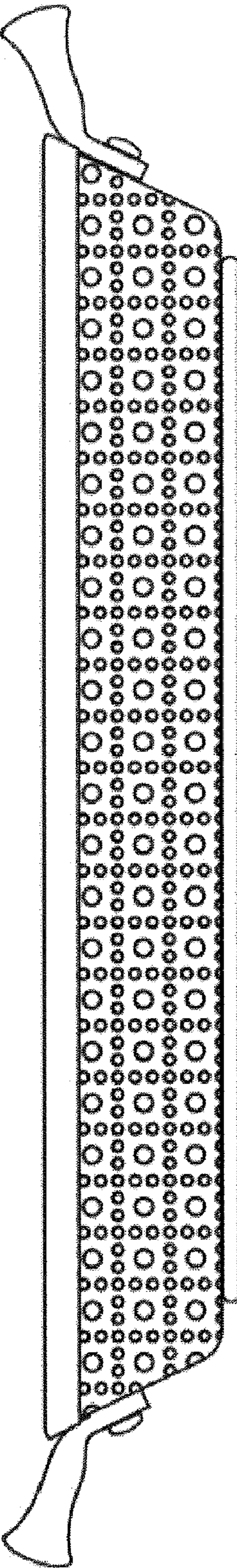

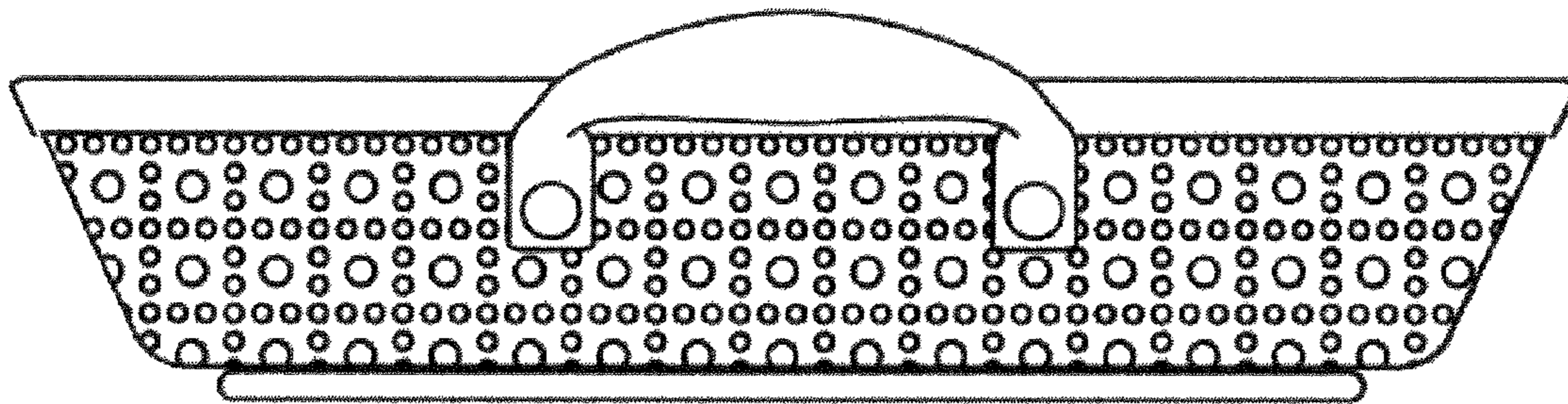
