(57) **CLAIM**

The ornamental design for a beverage holder and bottle insert, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a beverage holder and bottle insert showing my new design;

FIG. 2 is a top plan view thereof, shown at a reduced scale;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top, front perspective view thereof, shown holding a bottle;

FIG. 5 is a top, front perspective view of the beverage holder portion of the claimed design of FIG. 1 shown with the bottle insert removed;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a side elevation view thereof;

FIG. 8 is a front elevation view thereof, shown at a reduced scale and holding a can;

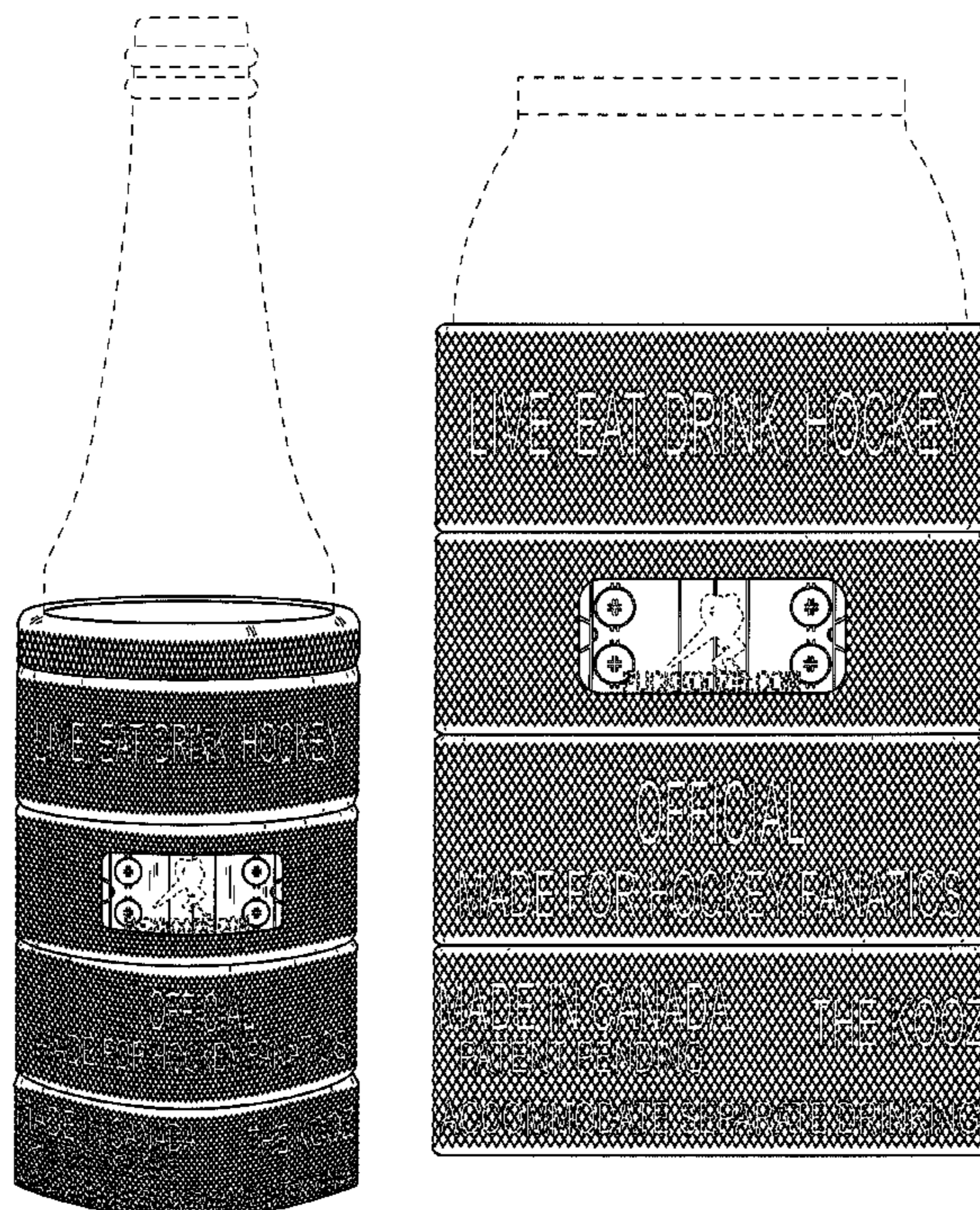
FIG. 9 is a bottom perspective view of the bottle insert element of the claimed design of FIG. 1 shown at a reduced scale;

FIG. 10 is a side elevation view thereof; and,

FIG. 11 is a top plan view thereof.

The broken lines in the drawings showing a bottle (FIG. 4) and a can (FIG. 8) are for the purposes of illustrating environmental structure and form no part of the claim and the broken lines on the beverage holder as shown in FIG. 1 and in FIGS. 4-8 represent portions of the design which form no part of the claim thereof.

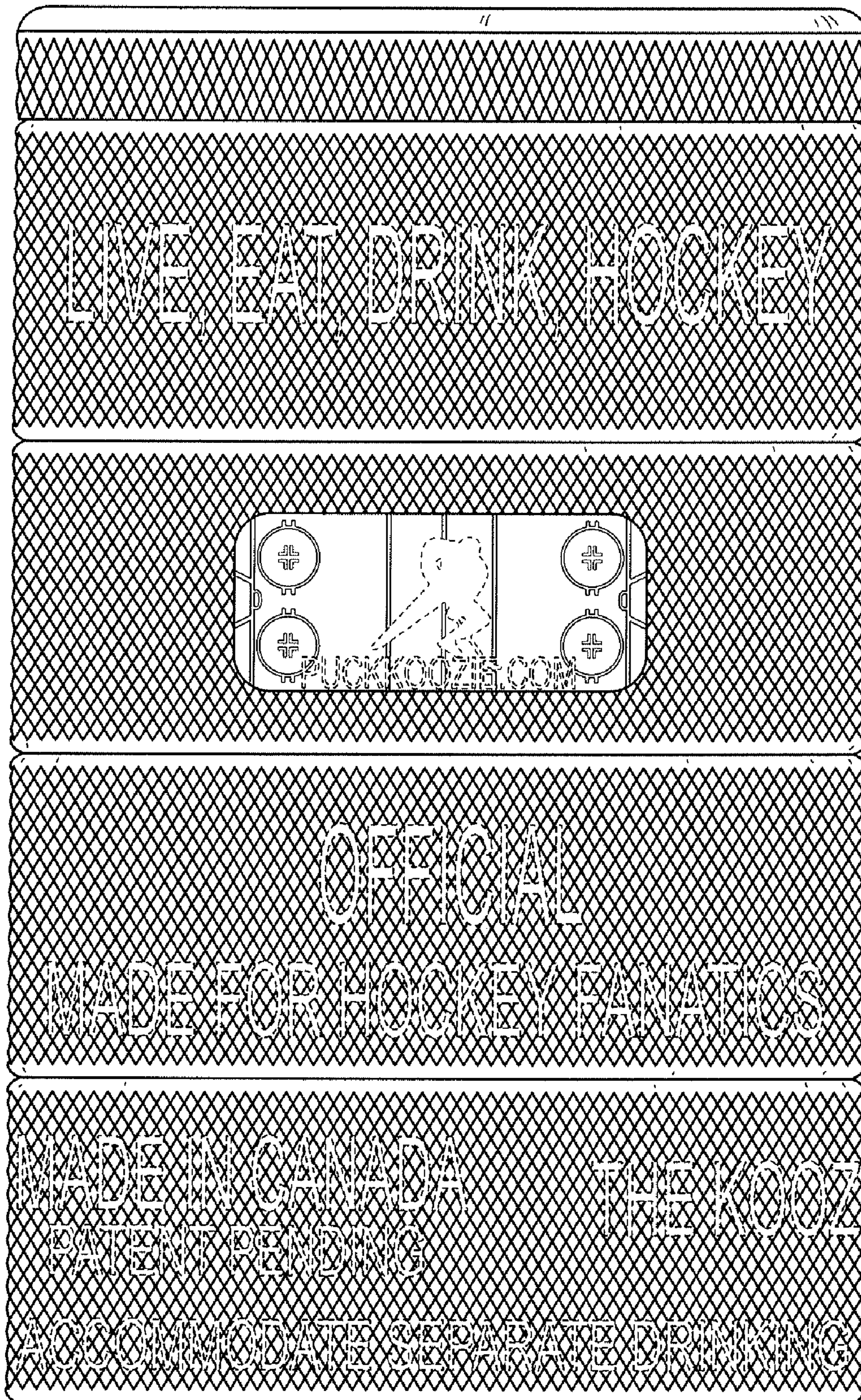

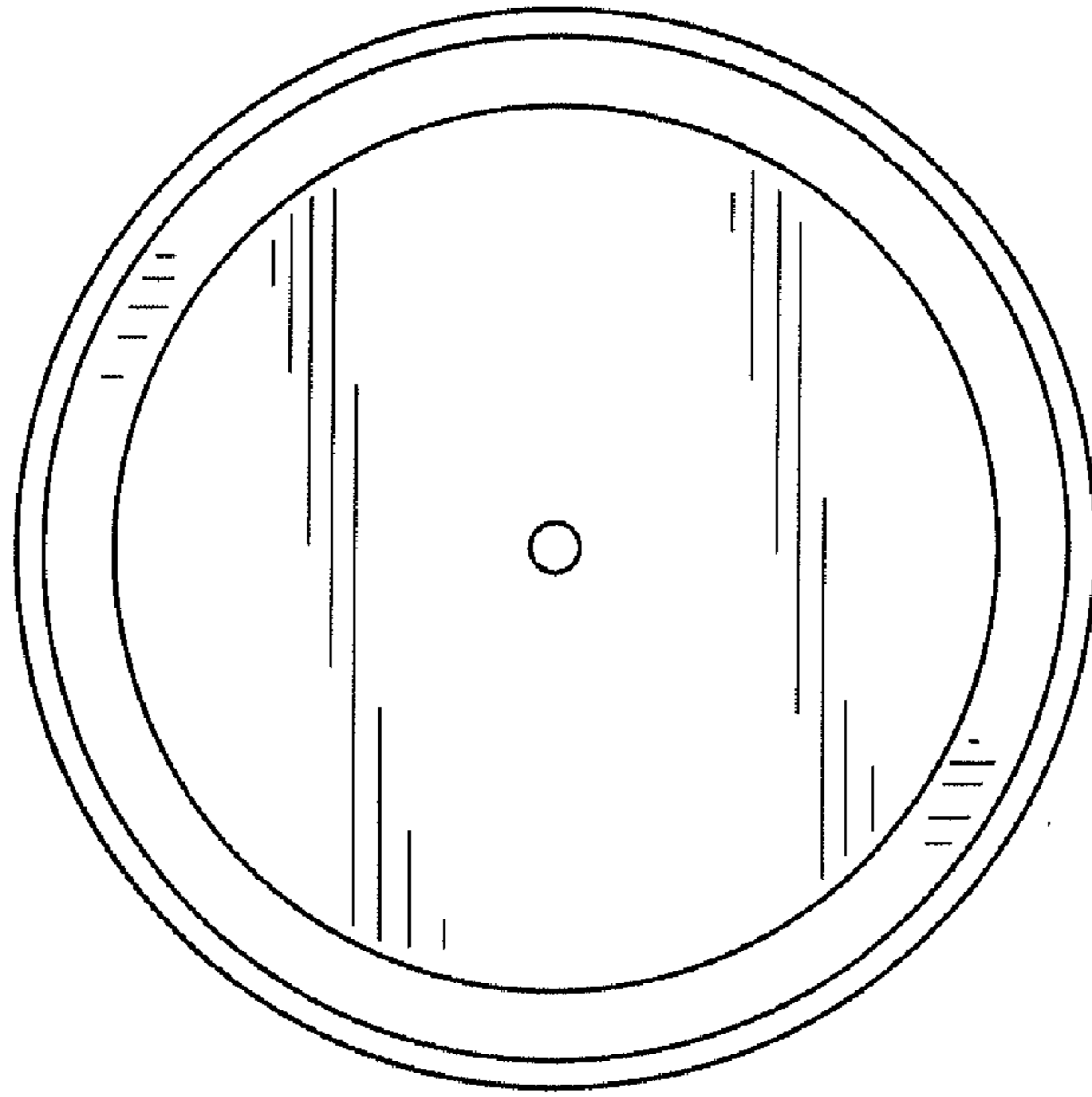

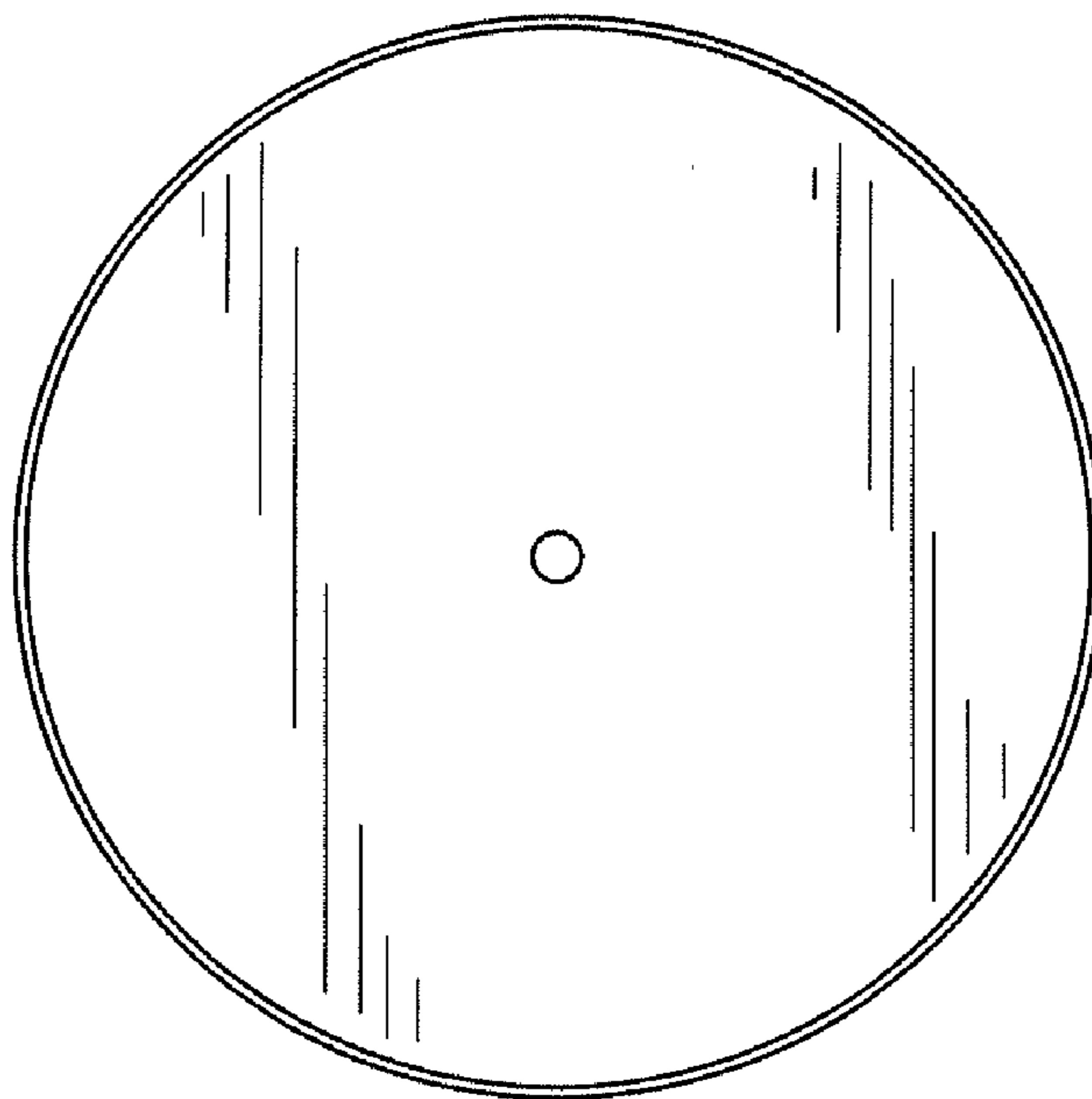

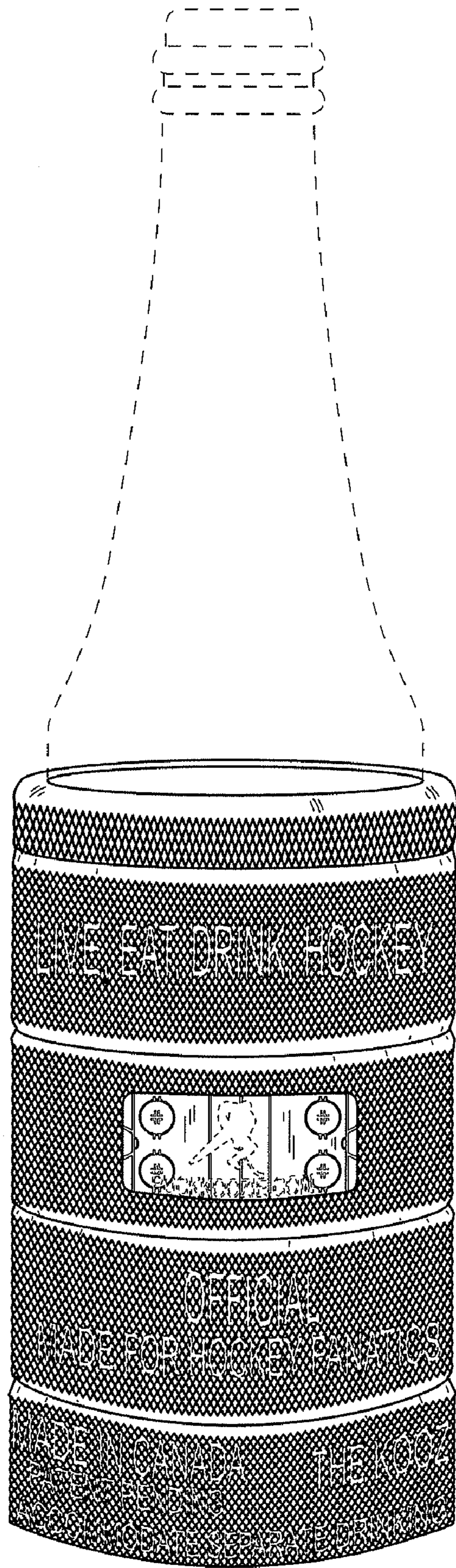

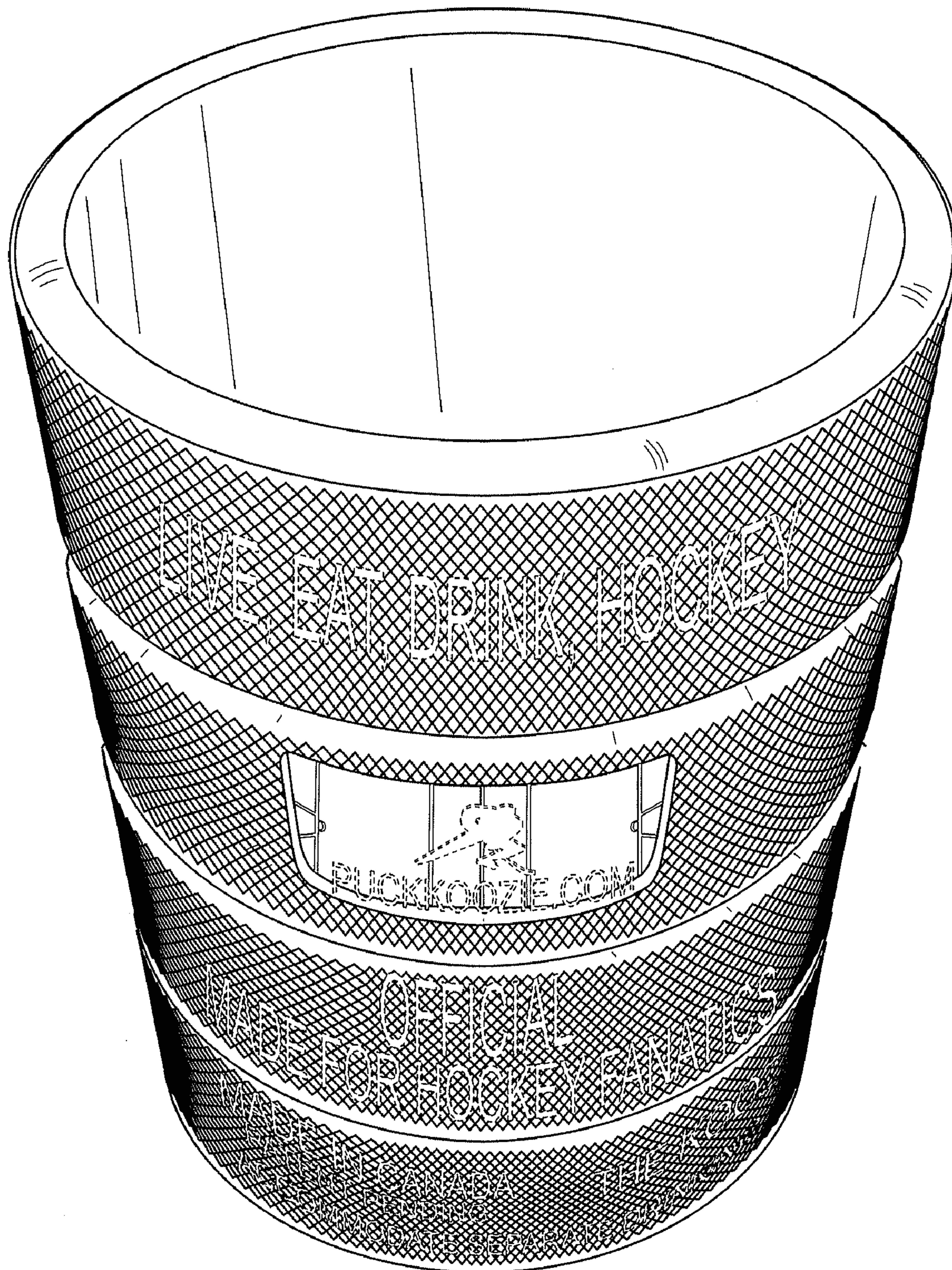

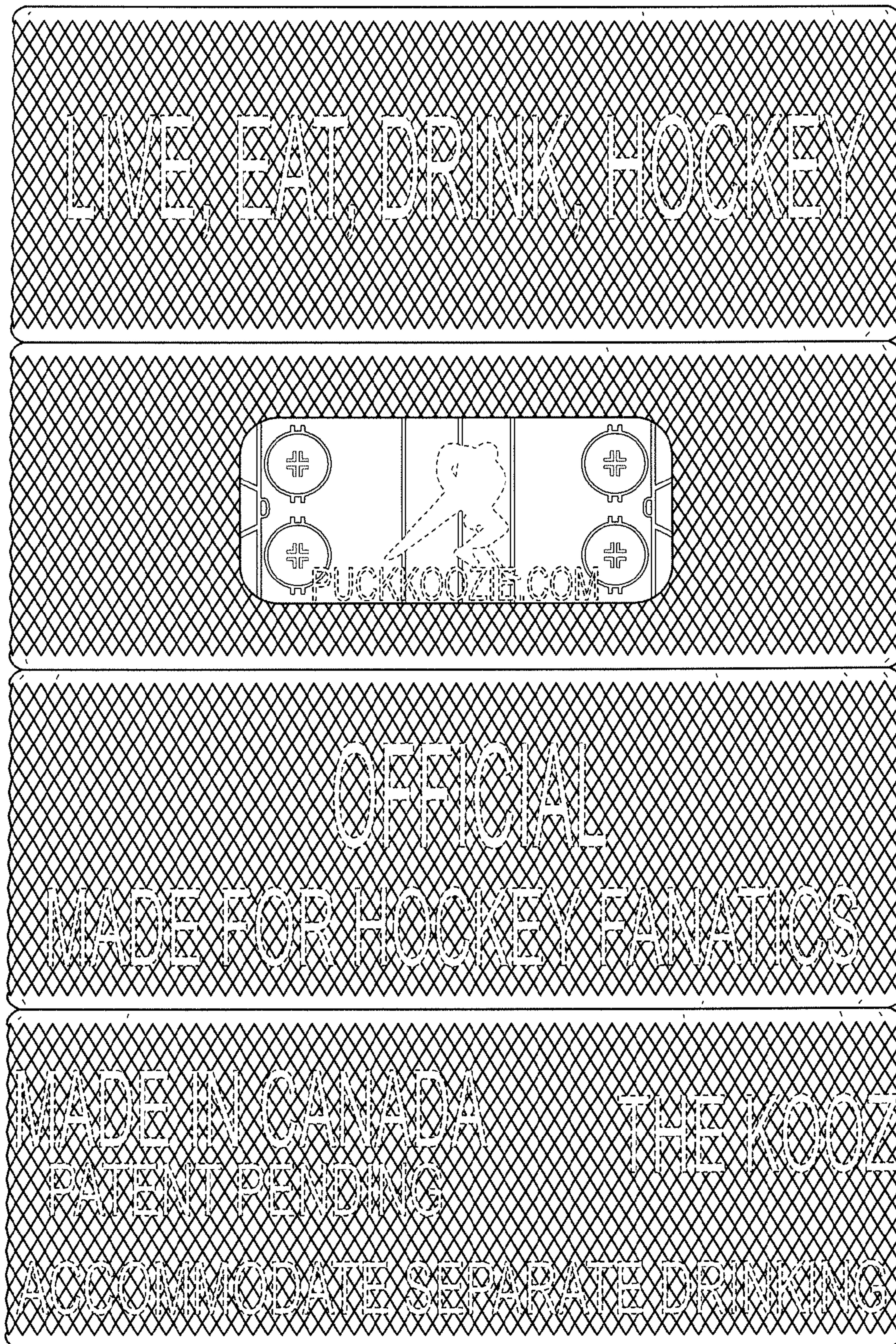

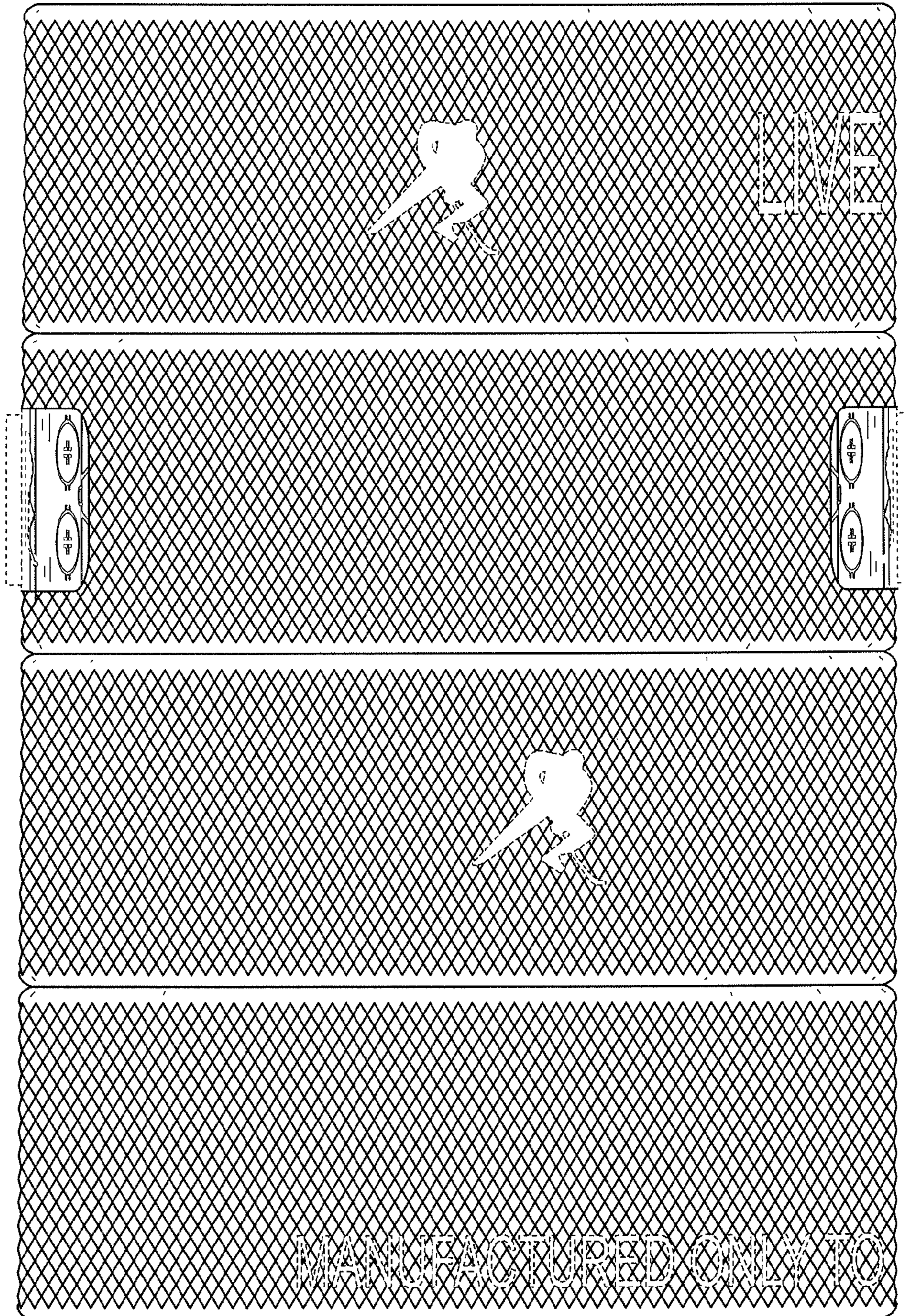

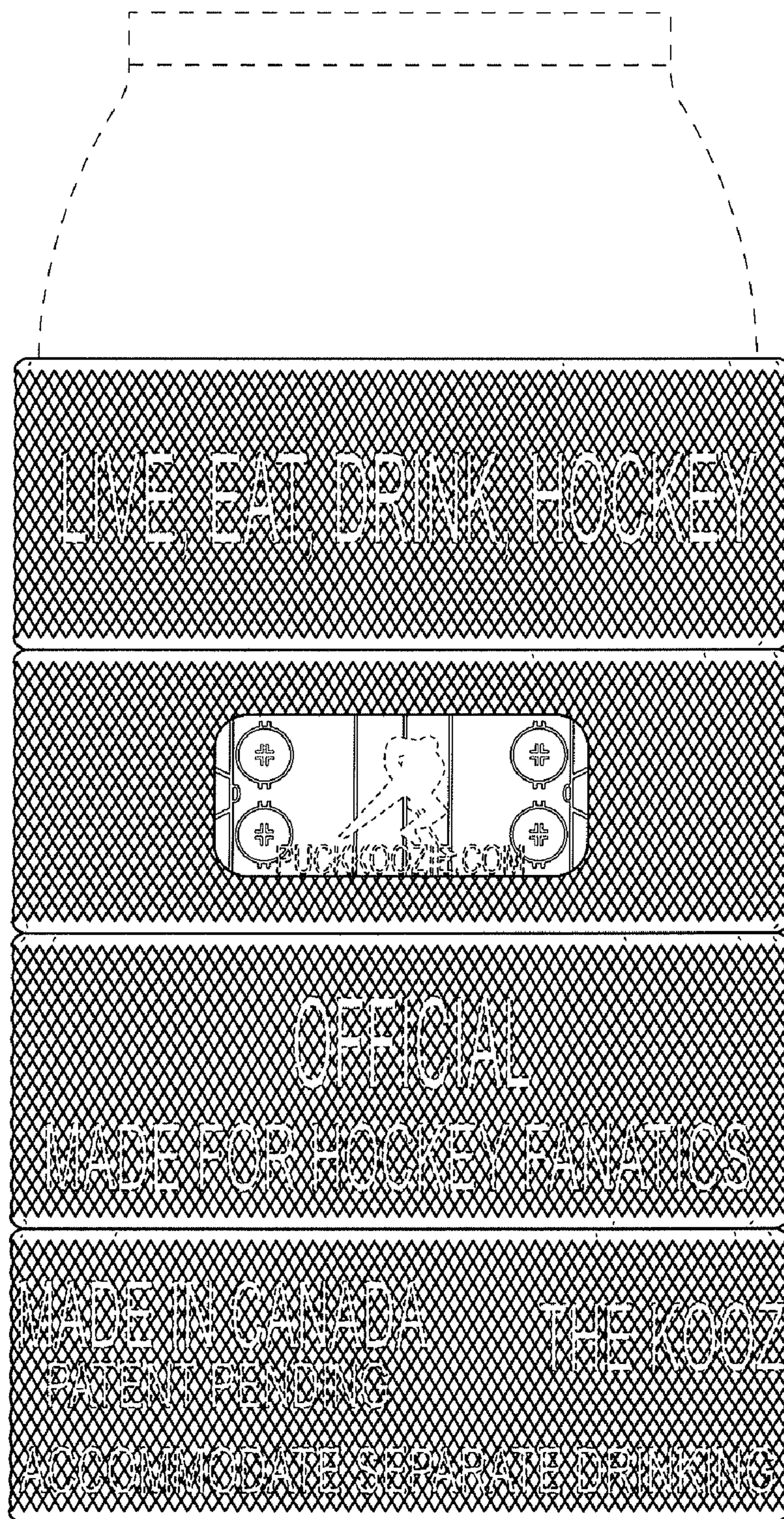

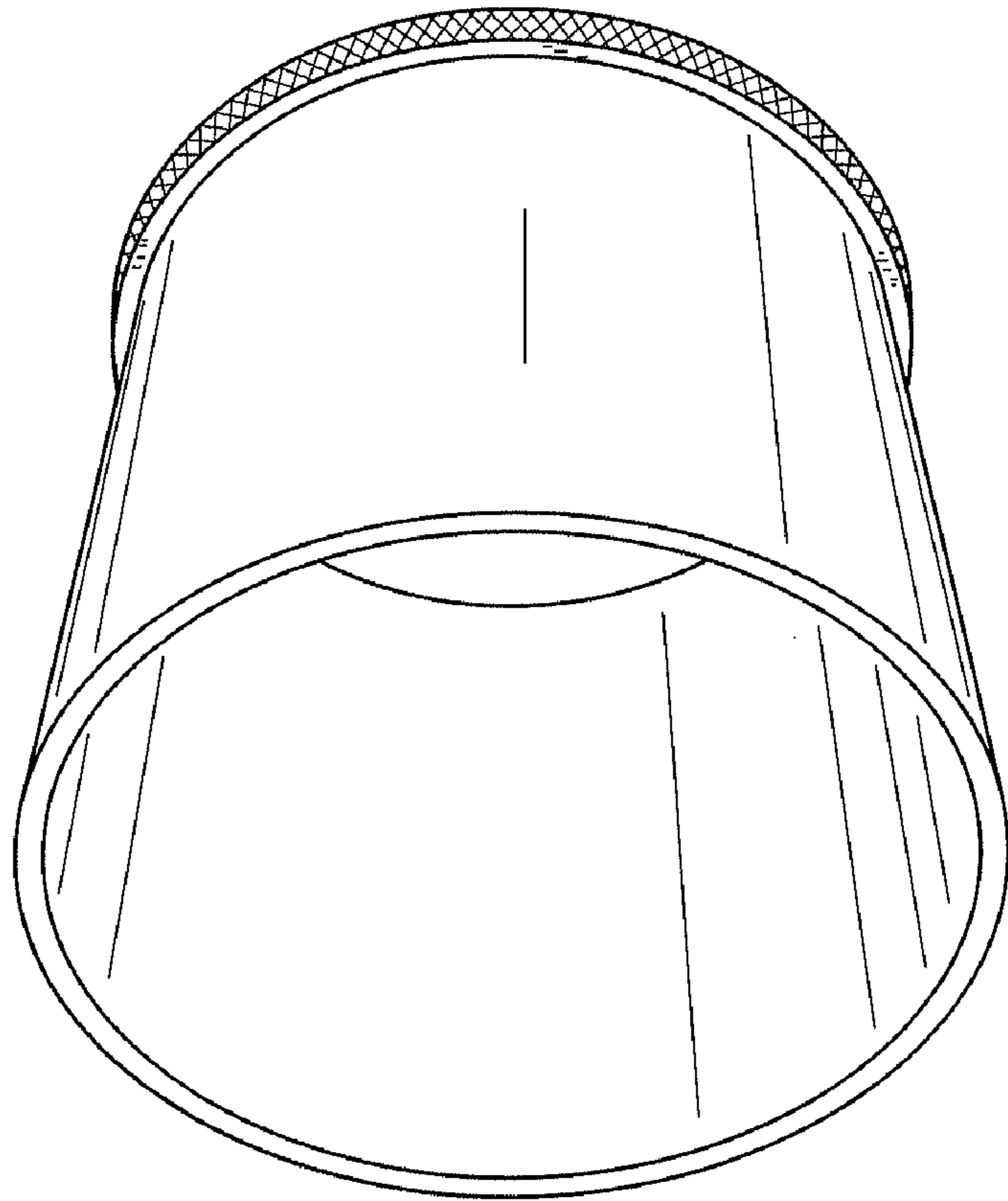

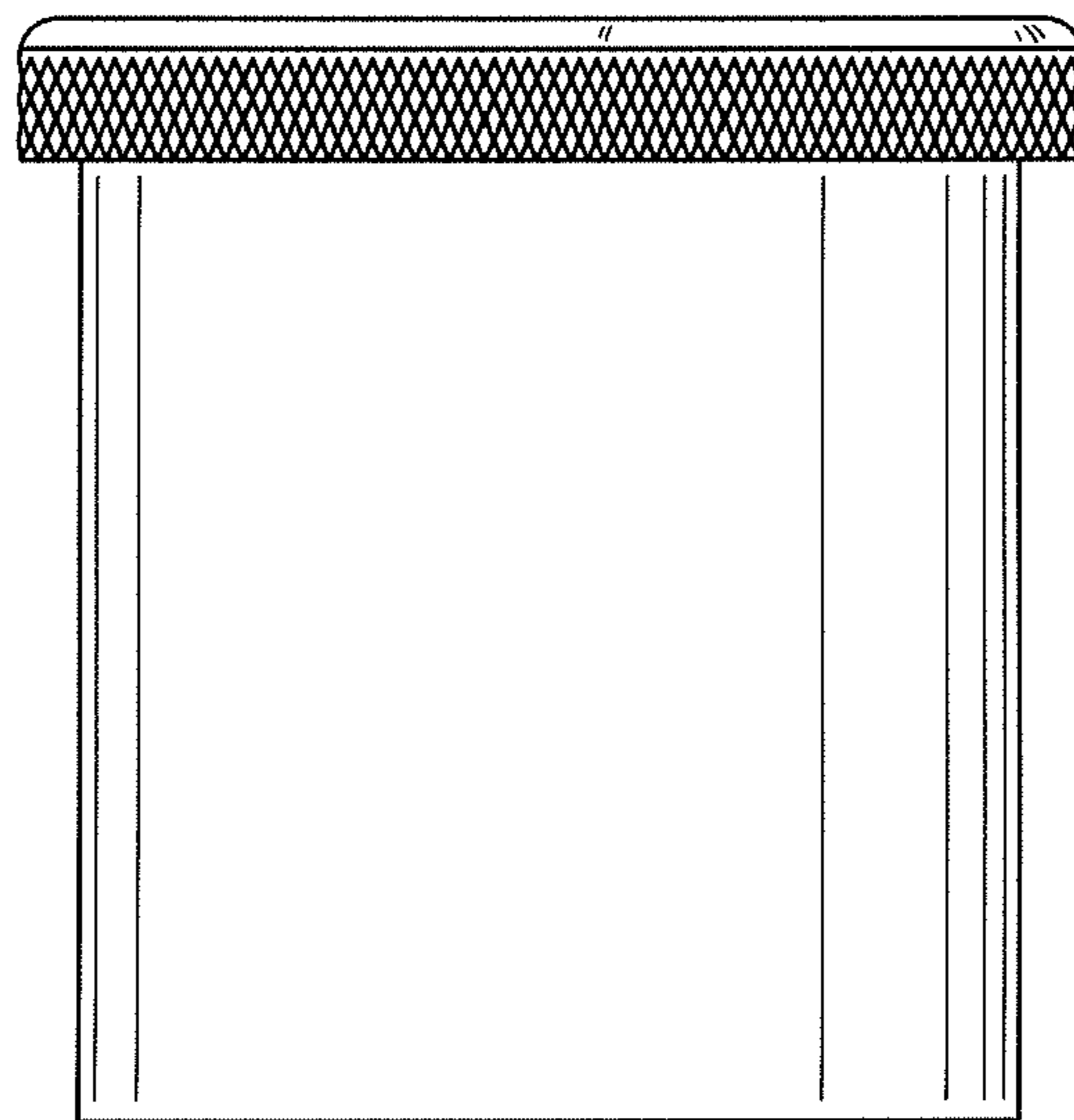

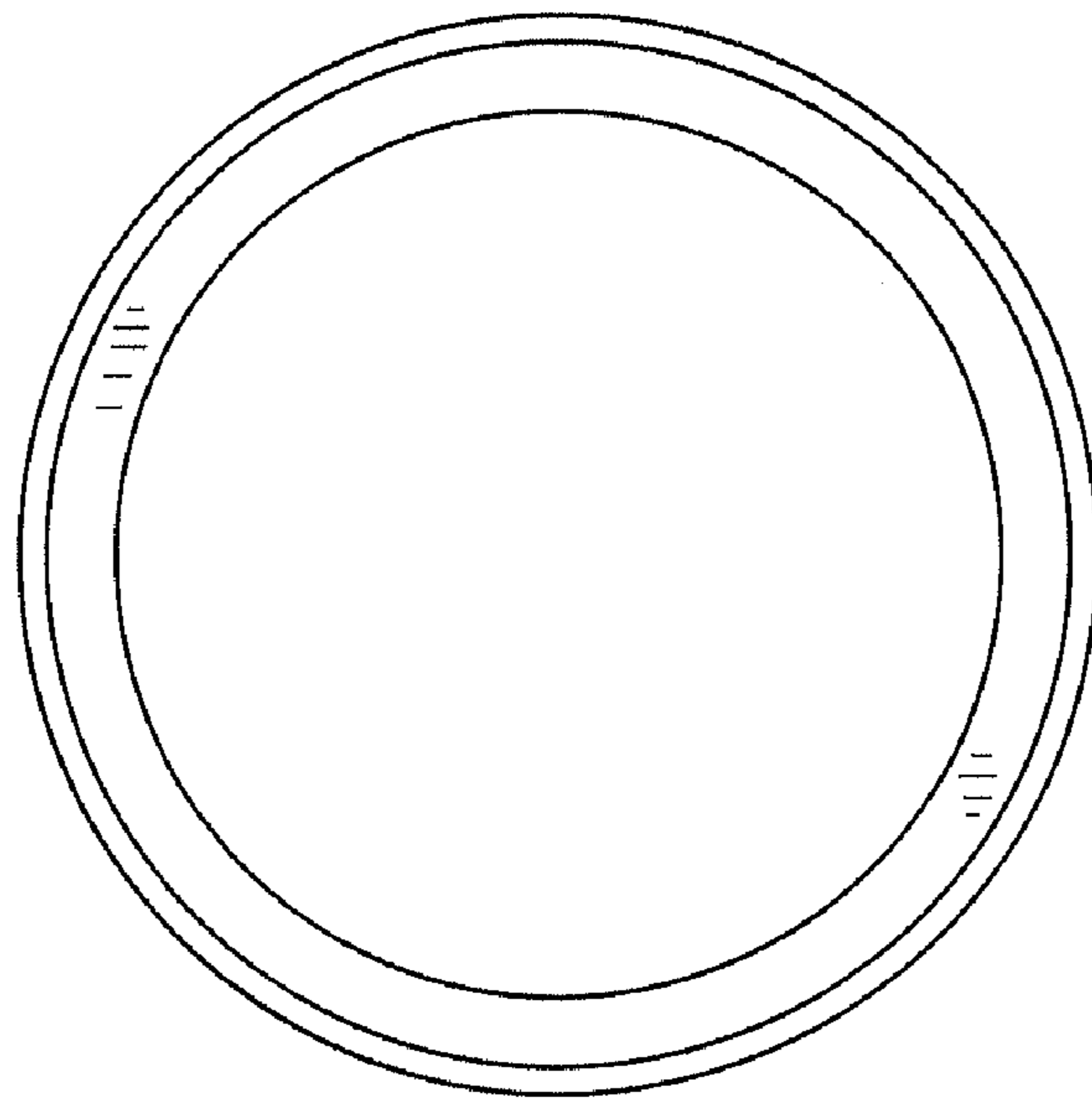
