The ornamental design for a package for food products, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the package for food products of the claimed design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top, front, right side perspective view thereof.

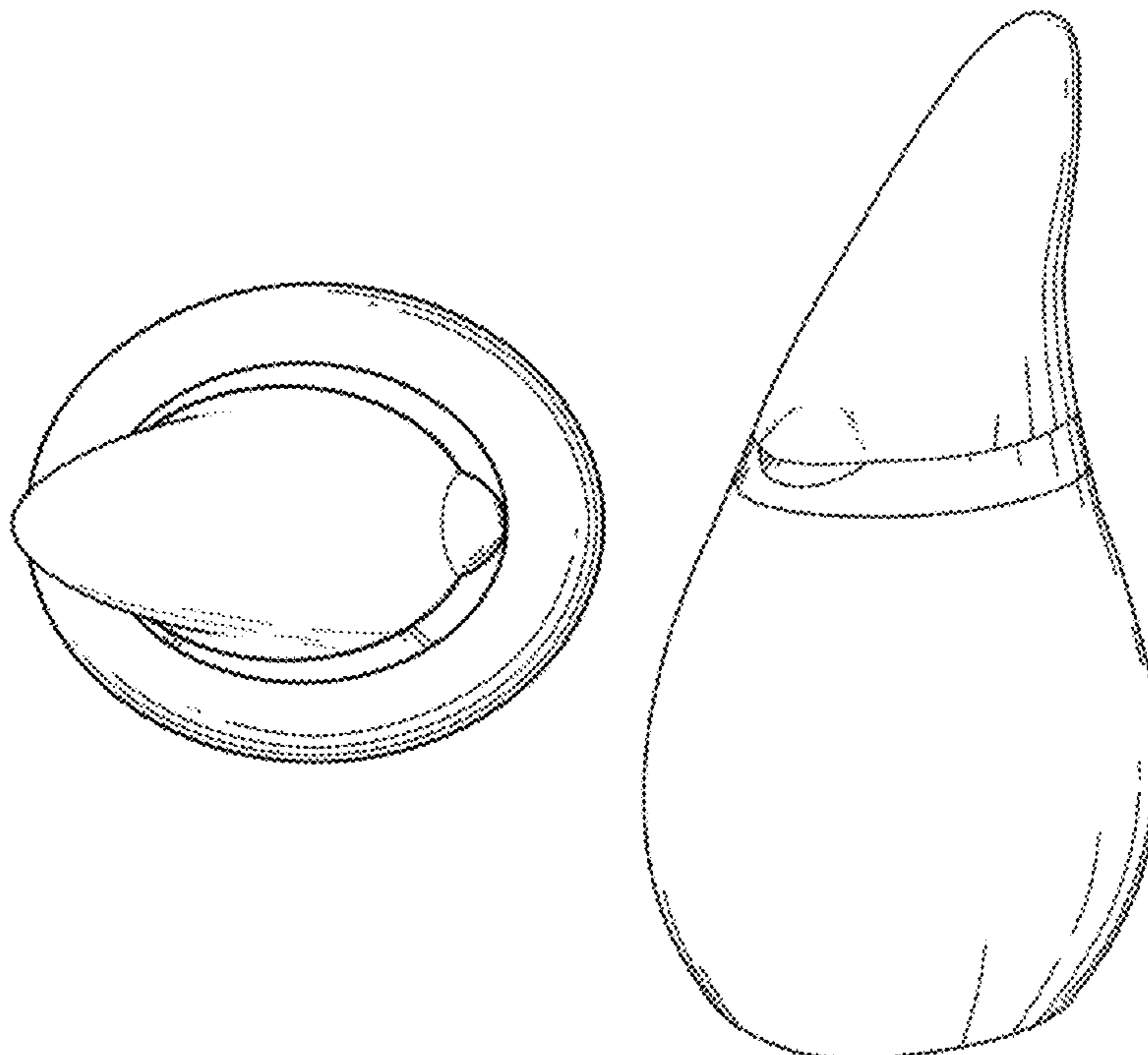

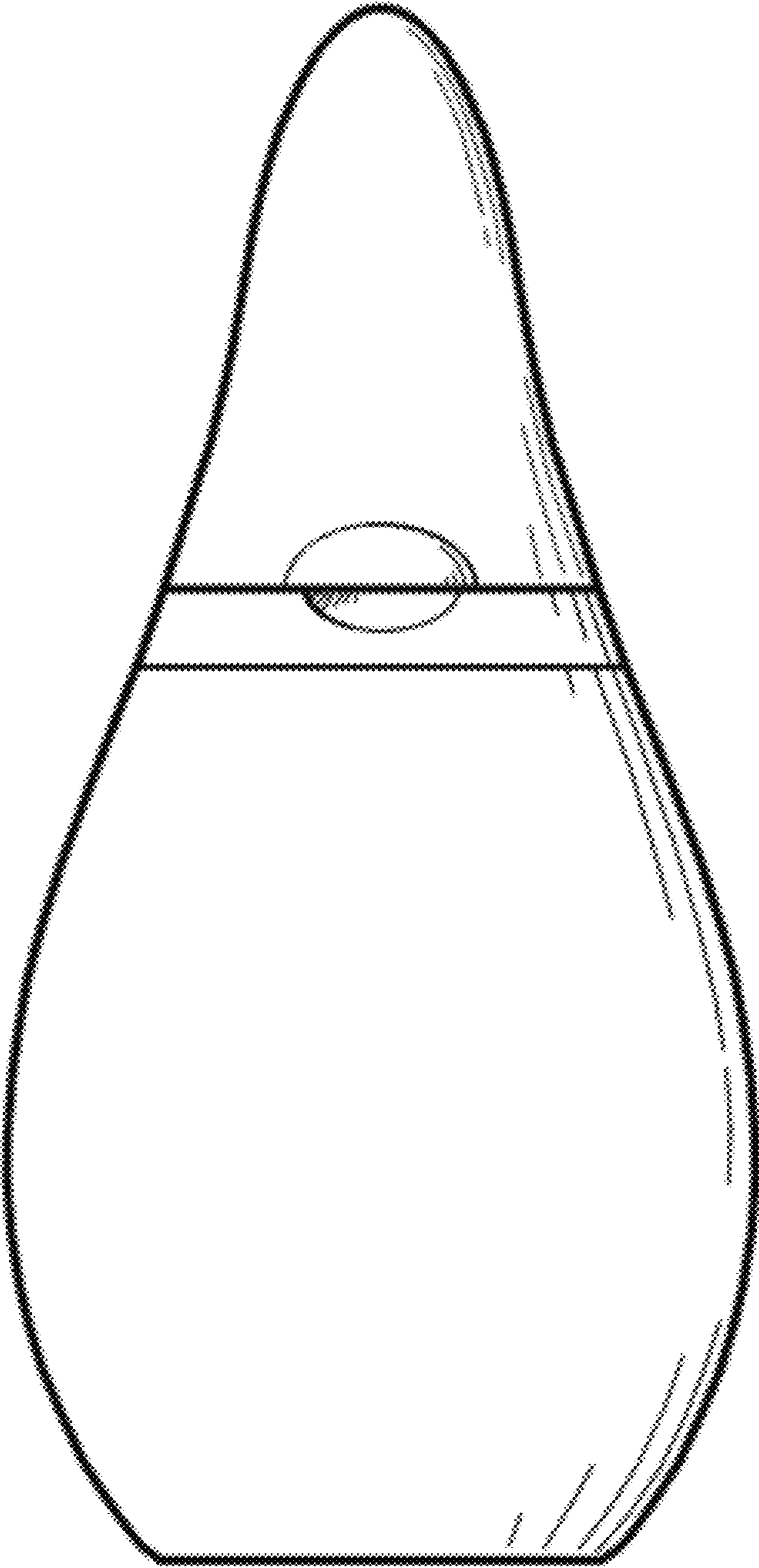

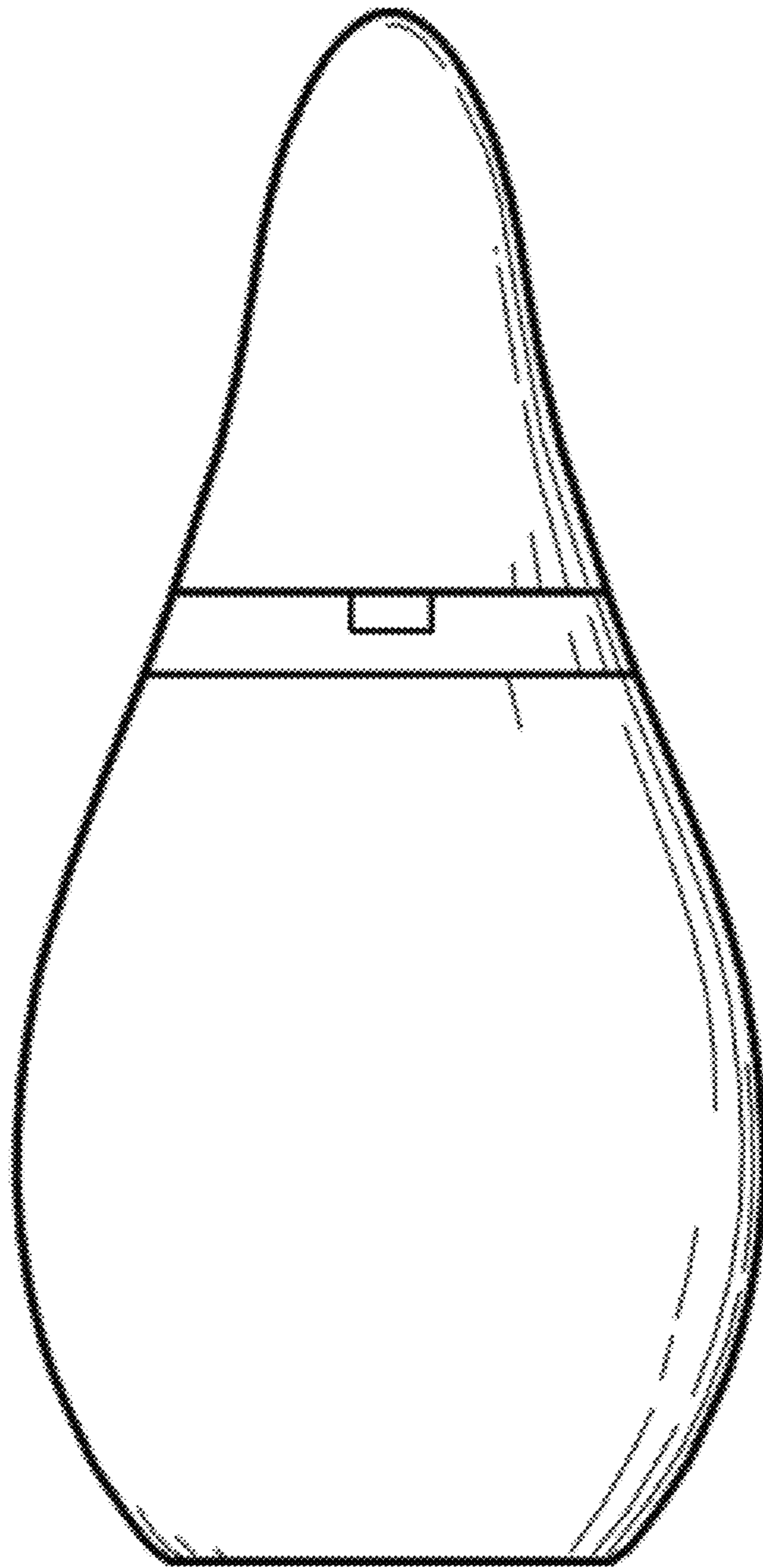

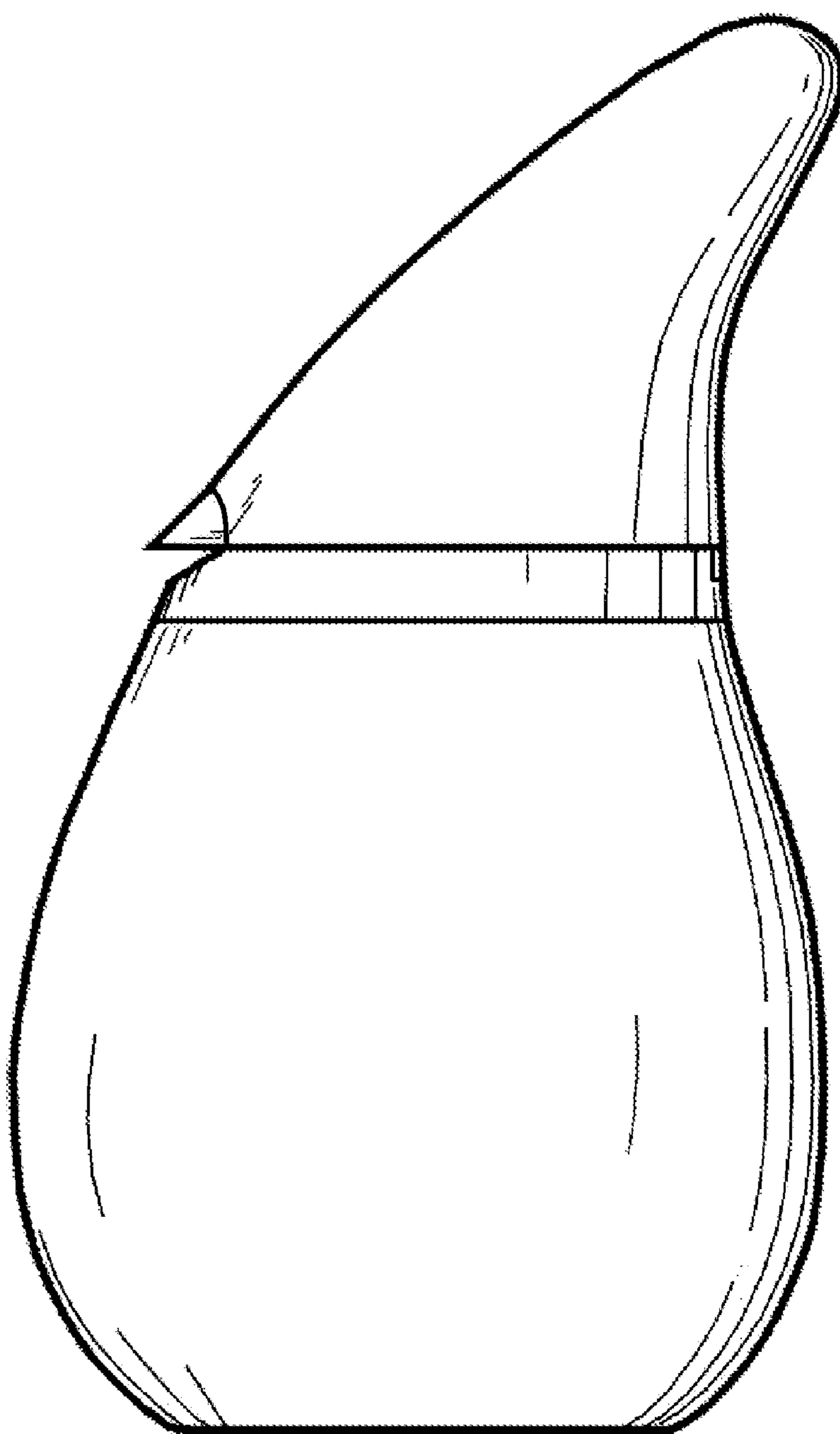

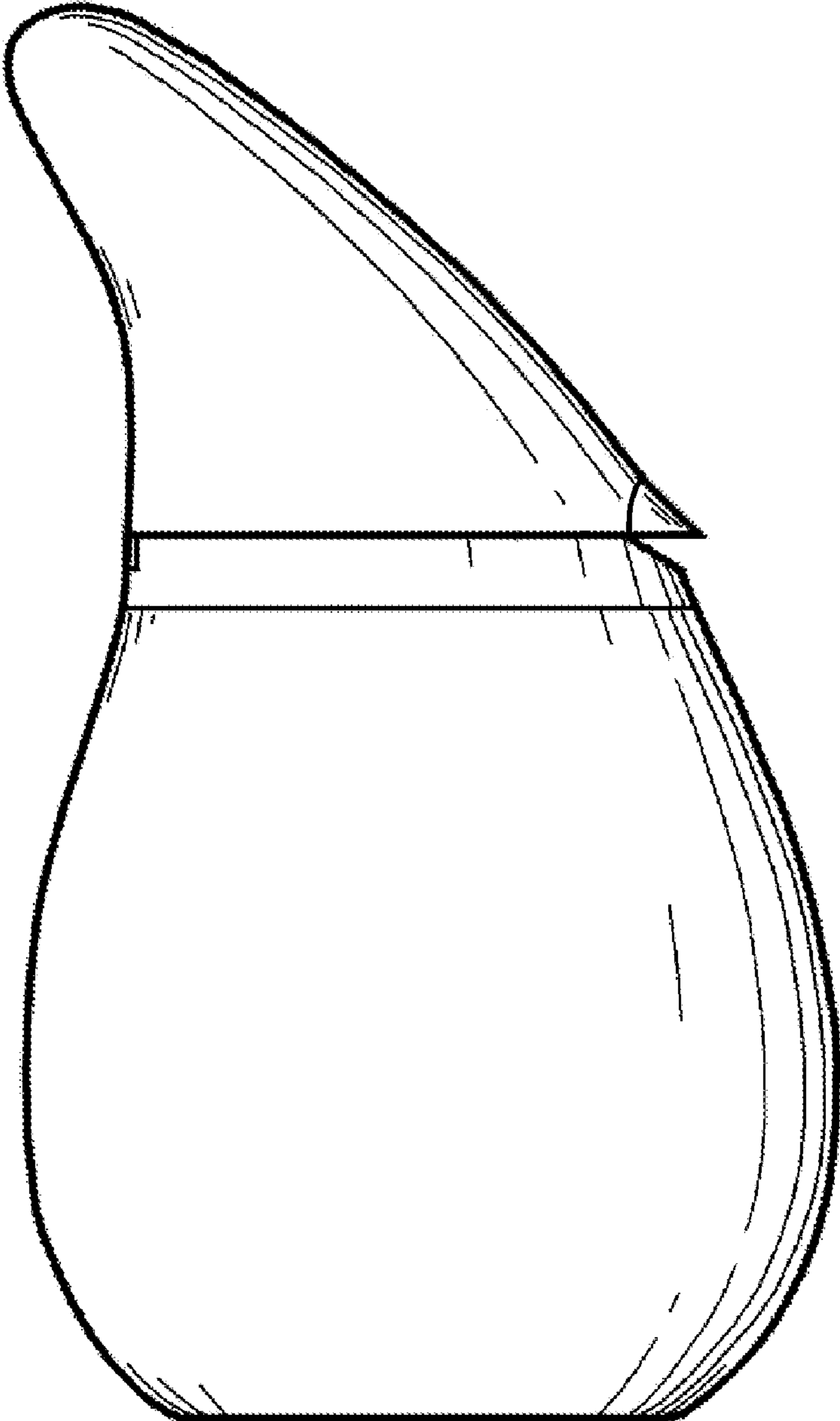

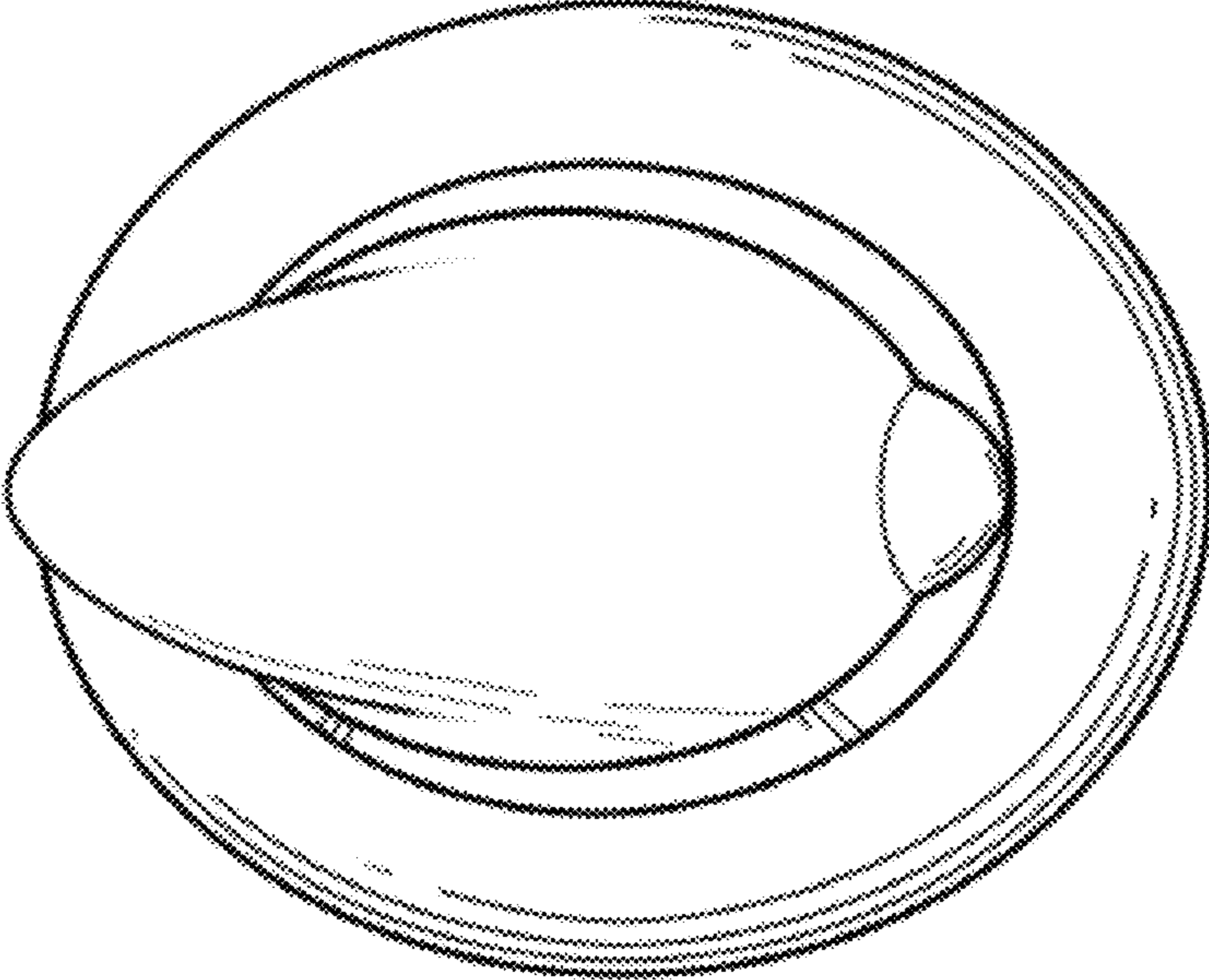

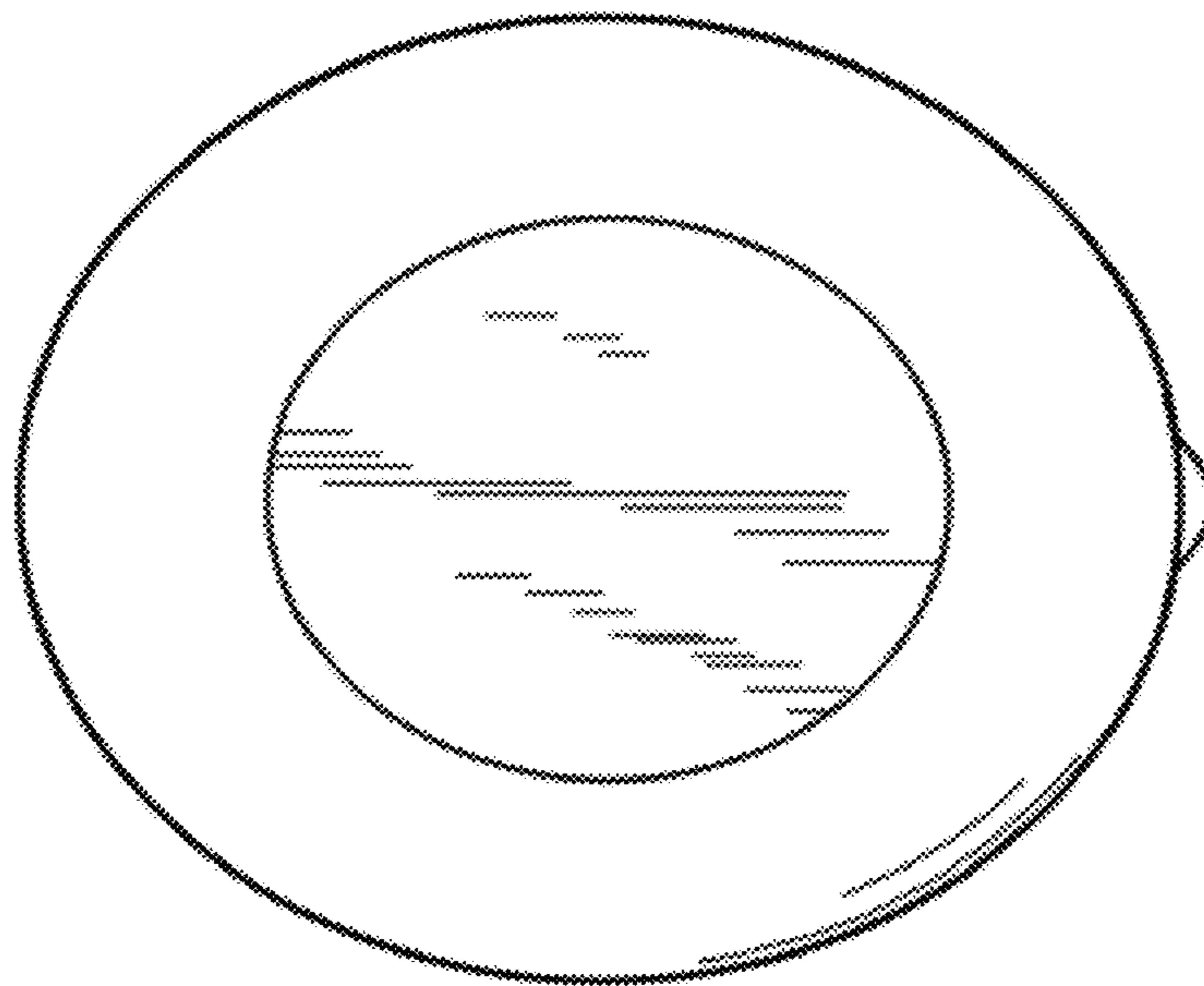
